After 22-year wait, FG approves pensions for ex-Nigeria Airways staff By Friday Omosola

he Federal Government (FG) has given the green light for pension payments to thousands of retired aviation workers, a decision that ends a nearly 22-year struggle for former employees, particularly those from the defunct Nigeria Airways.

The National Orientation Agency (NOA) confirmed on Tuesday via its official X account that the Ministry of Aviation has committed to commencing disbursements transparently and fairly shortly.

This long-awaited approval brings significant relief to individuals who dedicated years to the nation's aviation

The move follows decades of relentless advocacy from various unions pushing for justice for these retirees.

Nigeria Airways, a wholly governmentowned airline, operated from 1958 until its collapse in 2003, a downfall attributed to widespread mismanagement, corruption, and

accumulating debt.

Its closure left over 6,000 former staff members without their full pension and gratuity entitlements, sparking almost two decades of persistent demands for their benefits.

Stakeholders across the industry have largely welcomed this development, seeing it as a crucial step towards restoring faith and dignity within the aviation sector.

The issue has been a recurring point of contention.

In 2018, major aviation unions, including the National Union of Air Transport Employees (NUATE), the Air Transport Senior Staff Services Association of Nigeria (ATSSSAN), and the National Association of Aircraft Pilots and Engineers (NAAPE), even threatened to shut down Nigerian airspace.

Their action was a protest against the government's failure to release N45

billion owed to the retirees.

At the time, they condemned the prolonged delays, warning the then-Minister of Aviation, Hadi Sirika, that they would not tolerate further deaths of retirees without their benefits being paid.

Later that same year, former President Muhammadu Buhari approved a partial payment of N22 billion.

However, union records indicated that a substantial ₹36 billion still remained outstanding, leaving many former workers in severe financial hardship, with some passing away before receiving their dues.

Most recently, in January 2025, the National Assembly Joint Committee on Aviation exerted pressure by threatening to withhold the Ministry of Aviation's budget unless clear provisions were made for the full payment of these lingering entitlements to the former Nigeria Airways personnel.



Amaechi warns Nigerians: "You'll be dead, buried If Tinubu wins in 2027" By Ghenga Olaleye



ormer Minister of Transportation and ex-Governor of Rivers State. Rotimi Amaechi, has issued a stark warning to Nigerians, urging them not to re-elect President Bola Ahmed Tinubu in the 2027 general elections.

Speaking while addressing members of the African Democratic Congress (ADC) coalition in Rivers State. Amaechi claimed that a second term for President Tinubu would be catastrophic for Nigerians.

"Currently, Nigerians are complaining in President Tinubu's first tenure; imagine what the second tenure will be like. Then, you'll be dead and buried," he said.

Amaechi, who recently joined the ADC-led coalition, also criticised the political environment in Rivers State, accusing electoral actors of manipulating results and discouraging public participation.

"Our state is notorious for writing results, and we must stop them," he told the gathering. "When people hear that results are already written, they don't come out to vote. That must change."

He charged ADC members to begin early mobilisation ahead of 2027 and form local committees to assess their political strength across wards and local governments.

"We are new members of the ADC; it's the adopted party of the coalition. Most importantly, have your eyes on 2027, Amaechi said. "Go home and start registration."

He warned that continued rule under the current administration would only worsen the country's growing economic hardship.

"We should encourage people to come out and vote for the removal of the current government—or we will all die of hunger," he concluded.

Amaechi's comments add to growing criticism from opposition voices who accuse the Tinubu administration of failing to address pressing national challenges.

ADC clarifies coalition talks: Not about Atiku,

Obi, but Nigeria's future By Gbenga Olaleye

he African Democratic Congress (ADC) has stated categorically that ongoing coalition negotiations are not centred on any specific presidential aspirant, including former Vice President Atiku Abubakar or former Anambra State Governor Peter Obi. Rather, the talks are focused on forming a robust and inclusive alliance aimed at repositioning Nigeria's political future.

Speaking in an exclusive interview on Tuesday, the ADC's National Publicity Secretary, Bolaji Abdullahi, dismissed widespread speculation that the coalition was a strategic alignment with either Atiku or Obi ahead of the 2027 general elections.

"The coalition has nothing to do with either Peter Obi or Atiku," Abdullahi said. "They are just members like many others. The focus is not on them. And of course, it is within anyone's right to have political ambitions or to run for any position."

He acknowledged that while discussions around potential presidential contenders may be rife on social media, these narratives do not reflect the internal conversations taking place within the coalition.

When asked if the party would eventually have to choose between the two prominent politicians, Abdullahi was firm: "The party cannot align with one person and still call itself a party – that's what happened to most of the other parties in the past. We don't have a preferred candidate. When the time comes, we'll follow a democratic process and allow members to decide."

According to Abdullahi, the ADC is presently focused on strengthening its political structures and increasing its presence across all geopolitical zones



of Nigeria, particularly in the North.

"Nobody is talking about a presidential candidate at the moment. Our focus is on growing the party," he emphasised.

Addressing the party's strategic moves in northern Nigeria, Abdullahi said a growing number of political leaders in the North, disillusioned with the ruling All Progressives Congress (APC), are aligning themselves with the ADC-led coalition.

"All the people who were in APC and are not happy with how things are going are in this coalition now," he noted. "The majority of our leaders are from the North. The North knows it doesn't want this APC government to continue because of how they've been treated."

He was critical of the APC's

governance in recent years, asserting that the ADC represents the only viable alternative for Nigerians seeking change.

"If you look back at the last two years and the way the government has made life hard, you'll see that ADC is the only real alternative," Abdullahi declared.

"The ruling party is punishing the people. ADC wants to free Nigerians from that suffering. No one wants to go through this again for another four years."

As the 2027 elections draw nearer, speculation continues to swirl around major political figures and potential alliances. Yet, the ADC's message remains clear: the coalition is about building institutions and a collective vision—not individual ambitions.

2027: 'I might contest for presidency if...' - Datti Baba-Ahmed

usuf Datti Baba-Ahmed, the former vice-presidential candidate of the Labour Party in the 2023 general elections, has stated that he might consider running for president in 2027—but only under specific circumstances.

Speaking on Arise Television's Prime Time programme on Tuesday, Baba-Ahmed clarified that personal ambition was not his motivation, and that his potential candidacy would only emerge if two prominent figures, including Peter Obi, choose not to run.

"Look at my trajectory," he said. "In 2019, I aspired for the

presidency and I lost, together with 11 others. I religiously supported Peter Obi and I would do so again in 2027, unless certain two people that I have tremendous respect for decide not to take it, and God Almighty in His infinite mercies keeps dropping it for me."

He reiterated his loyalty to Peter Obi, with whom he ran in the 2023 elections under the Labour Party, finishing third according to the Independent National Electoral Commission (INEC).

"Except if that happens, I can tell you Peter will contest for sure because he's in the game, he contested before, I'll support him," he said. "If he doesn't, or another person that I won't call his name from the South, if they don't contest, otherwise I'm not ambitious."

Baba-Ahmed also expressed deep concern for the state of the nation and highlighted the key issues driving his political involvement.

"My key ambition is to stop the killings, stop the stealing, stop the slide," he added.

His comments come amidst rising speculation over who will challenge the ruling party in 2027, and underscore the ongoing internal dynamics of the Labour Party and opposition alliances.

Lamido accuses Tinubu of undermining emocracy

ormer Governor of Jigawa State, Alhaji Sule Lamido, has alleged that President Bola Ahmed Tinubu is systematically dismantling Nigeria's democracy through what he described as "imperial acts" aimed at coercing the opposition into submission.

Speaking to journalists in his Kano office on Tuesday, Lamido claimed that the Federal Government and the ruling All Progressives Congress (APC) are weaponising state institutions to intimidate political opponents, forcing them to join the ruling party under duress.

"Today, Tinubu is using state institutions to crush the opposition through intimidation, blackmail, harassment, and government patronage," Lamido stated.

"A clear example is Okowa, who was the PDP vice presidential candidate. He suddenly faced charges of №1.3 trillion from the EFCC, and after joining the APC, those charges disappeared."

READ ALSO: Sule Lamido vows to join forces to unseat President Tinubu in 2027 Drawing parallels with past comments by former APC Chairman Adams Oshiomhole, Lamido criticised the notion that joining the APC offers blanket immunity from prosecution.

"As Oshiomhole once said, no matter your crime, once you join APC, you will be forgiven. That is why people who feel guilty are joining. It's a serious danger to democracy," he warned.

Lamido lamented the deepening divisions in the country and accused the current administration of deliberately fracturing the federation along regional and ethnic lines.

"Nigeria is no longer a united federation. Tinubu is acting like an emperor, politically deciding who survives and who is crushed," he said. "The government is dividing the North Central from the rest of the North, and stoking tensions between the South East and South South, all for political gain."

On the topic of growing opposition unity talks ahead of 2027, Lamido dismissed the current coalition efforts as lacking substance and historical grounding.

"People are now panicking, and in that panic, there is talk of coalitions. But the one we had in 2014 was organic, built around institutions—CPC, ACN, ANPP—not individuals," he explained.

"What we see today is a loose assembly of individuals—Atiku, Obi, El-Rufai—not functioning political bodies."

Lamido stressed that any credible coalition must be based on shared values, not personal ambitions or vendettas.

"A real coalition must define its purpose: democracy, unity, stability, and national prosperity—not revenge or desperation," he asserted.

He reaffirmed his loyalty to the Peoples Democratic Party (PDP), saying his political identity remains firmly rooted in the party that shaped his career.

"I remain in the PDP. I can't walk out of my skin. PDP made me minister and governor. I was harassed and detained because of my loyalty to the PDP. That legacy matters to me," Lamido said.

While open to any alliance led by or rooted in the PDP, Lamido was unequivocal: "I will support any arrangement that aims to secure Nigeria in 2027, but certainly not one involving Tinubu or the APC.

Baba-Ahmed criticises Tinubu, Buhari, warns against VP pick from Northwest By Ghenga Olaleye By Ghenga Olaleye





ormer presidential adviser Hakeem Baba-Ahmed has delivered a scathing critique of President Bola Tinubu and his predecessor, Muhammadu Buhari, claiming both men pursued the presidency for personal ambitions rather than national interest.

Speaking on Channels Television's Politics Today on Wednesday, Baba-Ahmed alleged that Buhari had no genuine intention of governing Nigeria, stating: "He just wanted to become a president."

He drew parallels between Buhari and Tinubu, suggesting both men were motivated more by personal fulfilment than a desire to improve the country.

"They have laboured in the political process for so long that it became about them. That is the wrong reason to seek political power. You want power so that you can govern people and improve things – it must never be about you," he said.

Baba-Ahmed, a member of the Northern

Elders Forum and former senior adviser to President Tinubu, also revealed that he left the All Progressives Congress (APC) just six months into Buhari's presidency, citing concerns over leadership direction. He is currently a member of the People's Redemption Party (PRP).

He further addressed his recent resignation from Tinubu's administration, saying his departure came as no surprise to the Northern Elders Forum. "Some members of the Northern Elders Forum knew about my feelings about the job, about the administration, about the direction this country was going," he said.

Baba-Ahmed expressed deep dissatisfaction with the state of the nation, citing widespread hunger, insecurity, and violence. "Nobody would tell you that they are entirely happy with the way the country is going. There is too much hunger, insecurity, and bloodshed."

On the political calculations ahead of the 2027 elections, Baba-Ahmed warned President Tinubu against choosing a new

vice president from the Northwest region, describing it as "risky" following Buhari's eight-year tenure.

"The President cannot go to the Northwest because the late Buhari just finished his eight years; going to the Northwest is a bit risky," he said.

However, he suggested Kano could be a possible option, noting that the electoral gap between the APC and the New Nigeria Peoples Party (NNPP) in the state was only about 500,000 votes in 2023.

Speculation has grown that President Tinubu may consider replacing Vice President Kashim Shettima ahead of the next general election.

Former Kano State governor Rabiu Kwankwaso, leader of the NNPP, has been mentioned as a potential replacement. Kwankwaso was recently seen at the Presidential Villa during an event attended by Shettima, though he declined to speak with journalists.

Osun APC rejects Adeleke, labels him 'political liability' By Ghenga Olaleye



he Osun State chapter of the All Progressives Congress (APC) has rejected any attempt by Governor Ademola Adeleke to defect to the party, branding him a political liability whose presence would undermine the integrity of the party.

This was disclosed in a statement issued on Wednesday by the state party's Chairman, Tajudeen Lawal, in reaction to a communiqué released by the state's Peoples Democratic Party (PDP) Leadership Caucus.

The communiqué, signed by Governor Adeleke and 27 other PDP leaders. condemned internal and external opposition to his proposed defection.

According to Lawal, the governor's motive for seeking entry into the APC was purely self-serving, driven by fear of an impending defeat in the 2026 governorship election.

"It was the fear of the impending 2026 election defeat that motivated the governor to desperately seek asylum in our party for his political survival," the statement read.

He described the Osun PDP as a crumbling structure overtaken by corruption and factionalism, allegedly controlled by the Adeleke family. Lawal claimed that well-meaning politicians were leaving the PDP in droves, joining the APC instead.

"From 2023, the party began to morally emaciate and became the war loot of the Adeleke dynasty," Lawal alleged. "Bright minds and people with good names to protect... daily troop out from the tattered umbrella into our party."

While acknowledging that political parties are open to new members, Lawal asserted that Adeleke's proposed defection was intended to create internal discord and tarnish the APC's image.

"A political party is a free-exit-free-entry arrangement," he said. "However, when an entry is suspected to tarnish the party's image and create a public perception crisis, the party is within its rights to block such a move."

He went further to accuse Governor Adeleke of mismanaging nearly №1

trillion in public funds within 30 months and claimed that the governor was seeking refuge in the APC to escape backlash from Osun voters.

"Those who rejected Adeleke's overtures knew his intention was deceptive and tied solely to a troubled re-election bid," he added.

Lawal also criticised what he described as Adeleke's two-faced political strategy condemning President Bola Tinubu on local media platforms while presenting himself as an ally in Abuja.

"You cannot abuse President Bola Ahmed Tinubu in Osun and pretend to support him in Abuja, just to secure your political future," he said.

"A true supporter of Tinubu would prioritise the people's welfare, not hoard public resources."

The statement concludes by reaffirming the APC's stance: Adeleke's entry into the party is neither welcome nor beneficial.

ADC slams Tinubu administration's rebased GDP celebration as 'economic cosmetics' By Friday Omosola

he African Democratic Congress (ADC) has condemned the President Bola Tinubu administration's recent celebration of Nigeria's rebased Gross Domestic Product (GDP).

The party labelled the celebration as a deceptive public relations exercise that masks underlying economic hardship.

In a statement by Bolaji Abdullahi, the party's National Publicity Secretary, dismissed the fanfare surrounding the new GDP figures as mere 'economic cosmetics.'

Abdullahi stated that these rebased statistics do not translate into an improved quality of life for ordinary Nigerians nor do they address the fundamental crises gripping the economy.

"Economic growth is not about dressedup numbers that make the government look good. Economic growth means nothing if it leaves the majority of the people behind and is not felt on the dining table, and in the marketplace," Abdullahi stated.

He added, "You can't rebase hunger because Nigerians cannot eat GDP."

According to him, while government officials highlight new GDP figures, millions of Nigerians continue to grapple with record food inflation, pervasive poverty, and crumbling infrastructure.

Abdullahi argued that the GDP rebasing, ordinarily a neutral statistical tool, has instead become a stark indicator of the All Progressives Congress (APC)'s prolonged economic decay and leadership failures.

Abdullahi pointed to a significant decline in Nigeria's economic standing, noting that the nation's GDP has plummeted from \$509 billion in 2014, following a previous rebasing, to a mere \$244 billion today.



This dramatic drop, he claimed, has seen Nigeria fall from its position as Africa's largest economy to fourth place, now trailing behind South Africa, Egypt, and Algeria.

Abdullahi views this not as a mere technical adjustment, but as a 'blunt indictment of a government that has failed to grow what it inherited, let alone transform it.'

Abdullahi further argued that while Nigeria's nominal GDP in Naira terms has increased to \$\frac{N}{3}73\$ trillion, this figure is largely 'illusory,' being a direct consequence of a 'steep and poorly managed currency devaluation.'

This devaluation, he maintains, has significantly eroded national wealth and stripped Nigerians of their purchasing power, with GDP per capita crashing from \$3,223 in 2014 to barely \$1,000 currently.

Abdullahi cautioned that while rebasing might cosmetically improve the debt-to-GDP ratio on paper, it should not be misinterpreted as an opportunity for 'reckless borrowing'.

He stressed Nigeria's need for fiscal discipline, which he said the current government has allegedly failed to demonstrate through its 'bloated, ill-prioritised budgets and wasteful

spending.'

He also criticised what he called the 'emptiness' of the APC's long-promised economic diversification, alleging that key sectors crucial for future growth, such as agriculture, manufacturing, infrastructure, and innovation, have either stagnated or regressed.

Abdullahi added that the administration has opted for 'statistical cosmetics' and 'deception' over genuine economic reform, leading to a 'structurally weak economy unable to compete or lift millions out of poverty.'

"There is no real increase in industrial output. No boost in agricultural productivity. No rise in real income. No improvement in electricity, health care or security. Just bloated, hollow numbers," Abdullahi stated.p

He said the government is attempting to 'reframe' the economy through 'statistical manipulation' rather than substantive policy changes.

Abdullahi noted that 'Nigerians are not fooled' and that their lives have not improved since Tinubu took office two years ago.

Four senators dump PDP for APC

he Senate has acknowledged the defection of four lawmakers from the opposition Peoples Democratic Party (PDP) to the dominant All Progressives Congress (APC).

This latest political realignment announced on Wednesday solidifies the APC's numerical strength within the upper legislative chamber.

The senators who switched allegiance are Ekong Samson (representing Akwa Ibom South), Etim Bassey (Akwa Ibom North East), Francis Fadahunsi (Osun East), and Olubiyi Fadeyi (Osun Central).

Their move was marked by the Senate temporarily suspending its usual procedures to accommodate a delegation of prominent APC figures.

Among those present to witness the shift were the party's National Secretary, the APC Chairman for Osun State, various members of the House of Representatives, and former



Minister Chris Ngige.

With these new additions, the APC's representation in the 10th Senate has surged to 72 seats, a notable increase from the 50 seats it held when the current Assembly was inaugurated in June 2023.

Conversely, the PDP's presence in the Senate has now dwindled to 26 members, a reduction attributed to a series of defections not only from its own ranks but also from the Labour Party (LP) and the New Nigeria Peoples Party (NNPP).

Commenting on the development, Senate Leader Opeyemi Bamidele characterised the defections as a healthy manifestation of democratic principles at play.

"For us, it is not just about the numbers," Bamidele said, emphasising the APC's ongoing commitment to ensuring its members and stakeholders uphold the party's core ideals.

He underscored the party's dedication to advancing Nigeria's progress and affirmed that the current momentum would not be taken for granted.

Sanwo-Olu launches N500bn food security initiative, 'Produce for Lagos'

overnor Babajide Sanwo-Olu of Lagos State on Wednesday announced the launch of the 'Produce for Lagos' programme, a strategic initiative aimed at bolstering food security and agricultural selfreliance within Lagos State and across Nigeria.

The programme is backed by a substantial N500 billion Offtake Guarantee Fund, signalling a significant push to develop a robust, localised food supply chain.

In a statement posted on his X page, Sanwo-Olu highlighted Lagos's pivotal role as Nigeria's largest food market, consuming over half of the food traded in the South-West region.

He noted the state's food economy is valued at more than №16 trillion. underscoring both existing demand and vast opportunities for local agricultural growth.

The 'Produce for Lagos' program is designed to create direct links between farmers and producers and the expansive Lagos market.

Key components include guaranteed product offtake, simplified access to financing, and crucial logistical support.

The governor emphasised that the initiative is set to boost food production, generate employment, reduce postharvest waste, and enhance livelihoods within the agricultural sector.

This ambitious undertaking is a collaborative effort between the state government and the private sector, implemented through the Lagos Food Systems Infrastructure Company, with additional support from Lagos Bulk Trading Company, Ekolog, and the Produce for Lagos Fund.

To ensure efficient distribution, a fleet of

150 cold and dry trucks, described as the largest of its kind in the country, has been deployed to facilitate safe and timely food transport.

The accompanying ₹500 billion fund is specifically structured to attract private investment, mitigate financial risks for participants, and provide essential financing for traders, transporters, and farmers.

Sanwo-Olu stressed that while effective policy is vital, tangible funding and consistent follow-through are critical for achieving real impact.

Sanwo-Olu extended an invitation to partners, other state governments, investors, banks, and development agencies to collaborate on the initiative.

He urged all stakeholders in the agricultural value chain to join forces to 'feed Lagos and build a food system that truly lasts.'

Why Adeleke's defection to APC was stalled

acts have emerged on why the strident effort by Osun State Governor, Ademola Adeleke to dump the Peoples Democratic Party, PDP, for the All Progressives Congress, APC, hit a brick wall – his demand to be given the governorship ticket of the party next year was flatly rejected.

Because of that, a leader of the APC from Ife area is being tipped to fly the APC flag next year.



Senator Ovie Omo-Agege and Festus Keyamo, who were hitherto nurturing governorship ambitions in Delta, have had to perish the thought.

However, the APC, on Wednesday issued a statement saying it rejected Adeleke because of his poor performance and that he would be a liability to the party.

The APC, in a statement issued by its Director of Media and Information, Kola Olabisi, said moving from one political party to another is not a big deal, but the party rejected Adeleke because of his too much baggage, which makes him a liability to the party.

"Governor Ademola Adeleke was rejected because he was quickly identified as a Trojan horse, a big baggage and liability



that would hurt the integrity of the APC.

"We state first of all that the highly informed Osun State public, who are aware that it was the fear of the impending 2026 election defeat that motivated the governor to desperately seek in our party an asylum for his political survival in 2026, are excited about the measured treatment meted to the Osun State governor and his desperate party men.

"It is no longer news that the Osun PDP has become a leprous house deserted by decent politicians to serve the people.

"From 2023 when the party began to morally emaciate and became a war loot of the Adeleke dynasty, bright minds and people with good names to protect, who could not tolerate the deceit, shenanigans and high-levelled corruption and brigandage the Adeleke government represents, daily troop out from the tattered umbrella into our party, thus leaving the PDP with carcasses and political dregs with no structure and hope to retain power in future elections.

Ondo govt, REA sign MoU to electrify 25 underserved communities By Friday Omosola

he Ondo State Government has signed a Memorandum of Understanding (MoU) with the Federal Government's Rural Electrification Agency (REA) to expand access to electricity across 25 underserved communities in the state.

The agreement was formalised yesterday during a roundtable discussion held in Abuja under the theme 'From Access to Impact: Unlocking Ondo's Renewable Energy Potential for Economic Transformation and Socioeconomic Inclusion.'

Governor Lucky Aiyedatiwa, who led the state delegation, described the partnership as a pivotal step towards delivering sustainable energy solutions that would transform rural communities and stimulate inclusive growth.

"This MoU marks the beginning of a strategic collaboration between Ondo State and the REA," Aiyedatiwa said.

"Our administration has established a legally backed State Rural Electrification Agency that will work in sync with the Federal REA to accelerate project implementation and address local energy needs with greater relevance and urgency."

The governor noted that the state has become an attractive destination for mini-grid and renewable energy developers due to its clear regulatory framework, streamlined approval processes, and investment-friendly incentives.

"Our Electricity Roadmap targets powering agro-processing hubs, healthcare facilities, schools, digital infrastructure, and small businesses, especially in hard-to-reach areas like Ilaje, Bolorunduro, Idanre, Owo, and Akoko," he said.



"Beyond infrastructure, we are exploring smart metering, energy storage, and data-driven energy management to ensure long-term impact."

Why you should never store tomatoes in the fridge By Helen Okechukwu



ith tomato season in full swing, experts are urging Britons to stop storing their tomatoes in the fridge.

While it might seem like a way to preserve freshness, chilling tomatoes at low temperatures destroys both their texture and flavour.

According to Professor Graham Seymour, emeritus professor of plant biotechnology at the University of Nottingham, storing ripe tomatoes at 5°C − the average fridge temperature - significantly reduces the aromatic compounds that give tomatoes their distinct taste.

"If you have a suitable storage area at a temperature of 12.5C-14C, then ripening will be slowed," Professor Seymour says. "Flavour could still be altered somewhat, but it's much better than storing them at 4-5C in the

fridge. I am afraid like most things it's a compromise," he said.

Chilled tomatoes also become "mealy" due to damaged cell membranes, resulting in a grainy

Instead, experts recommend keeping tomatoes at room temperature ideally around 20°C – out of direct sunlight and away from fruits like bananas that emit ethylene gas and speed up ripening.

Supermarket tomatoes are often sold in perforated plastic packaging to reduce condensation, and Waitrose advises keeping them sealed in their original wrap until needed.

For underripe tomatoes, placing them

near ethylene-producing fruits or in a sunny spot can encourage ripening. Overripe ones are perfect for soups or sauces.

While tomatoes can be frozen for later use, they're best reserved for cooking due to their high water content. Cooking methods such as roasting or frying can also bring out the best in underripe or less flavoursome varieties.

To maximise taste and shelf life, experts suggest choosing Britishgrown tomatoes, which are picked ripe and travel shorter distances. These tend to retain flavour better than long-life varieties imported from abroad.

Bottom line? Keep your tomatoes out of the fridge and let them breathe your tastebuds will thank you.

he National Institute for Pharmaceutical Research and Development (NIPRD) is set to kick-start the implementation of an €18 million grant from the European Union (EU), aimed at transforming Nigeria's vaccine landscape.

Speaking in Abuja, NIPRD Director-General, Dr Obi Adigwe, described the grant as a "game-changer" for the country's vaccine independence.

According to News Agency of Nigeria (NAN), the funding supports Nigeria's 10-year plan (2024–2034) to build a self-reliant vaccine ecosystem through research, development, and local production.

While recalling the challenges

Nigeria faced during the COVID-19 period, he said, "We also witnessed vaccine nationalism, where countries hoarded vaccines despite preaching equity and justice. That experience underscored the urgent need to build local capacity for vaccine research and production."

He criticised the vaccine hoarding seen during the pandemic, calling it a wake-up call for the continent to prioritise health sovereignty. The EU grant, he noted, is the largest vaccine-related support received by any African nation to date.

The comprehensive roadmap funded by the grant outlines strategies for vaccine R&D, clinical trials, infrastructure upgrades, technology transfer, and

workforce development.

Key stakeholders—including government ministries, academia, international partners, and the private sector—collaborated on its design.

According to Adigwe, the plan has secured ministerial backing and formal approval from the EU. Implementation has commenced, with teams already deployed to partner agencies like United Nations Children's Fund (UNICEF).

He expressed confidence that within the next decade, Nigeria could be home to multiple vaccine manufacturers, contributing not just to national health security, but also to economic growth and regional resilience.

igerian gospel singer Chidinma Ekile has shared a powerful and deeply personal account of her recent 40-day spiritual

The singer, who rose to fame after winning Project Fame West Africa, described the experience as one of the most intense and life-changing periods of her life.

Then I heard a voice, very strong telling me to jump. It was clear. I was supposed to end it there."

But just as she was about to obey, something unexpected happened.

"When I moved closer, I realised I couldn't jump. It was like something was blocking me. There was an invisible wall, a force I couldn't see." she said.

She described the moment as a spiritual intervention that saved her life.

"It was like I was in a theatre, and God was performing surgery on me. He shredded me. He removed everything. I've seen it all. Material things don't move me anymore."

Following the testimony, many fans and followers took to social media to commend Chidinma's courage and openness. They praised her for sharing such a vulnerable moment and expressed admiration for her spiritual strength.

One follower wrote, "Your story gave me chills. God truly has a purpose for you." Another added, "Thank you for not giving up. This will save someone's life.'

Chidinma, who transitioned from secular music to gospel in 2021, has become a vocal advocate for faith and spiritual growth. Her music and message continue to inspire many, especially young people seeking meaning in a fast-paced world.

She ended her testimony with a message of hope:

"If you ever feel alone, please remember that God is closer than you think. The devil tried to end me, but God said no. And I'm still here for a reason."

Chidinma's story is a reminder of the unseen battles many people fight, and the power of faith to bring healing, purpose, and peace.

CDQ opens up on why he left banking for music

igerian rapper Sodiq Abubakar Yusuf, popularly known as CDQ, has revealed why he walked away from a stable banking career to chase his dream in music.

In a recent interview with Echo Room, the rapper, born Sodiq Abubakar Yusuf, shared a personal story about how he traded the corporate world for the recording studio.

According to him, his decision to become a banker was driven by the desire to honour his late father's wishes. However, he soon realised that the job didn't bring him joy.

"I became a banker because of my dad," CDO said. "He wanted me to wear suits and work in an office, and I wanted to make him proud. But deep inside, I wasn't fulfilled. I was working, but my heart wasn't in it."

While still working at the bank, CDQ said he began to notice his growing distraction. Instead of focusing on his tasks, he found himself scribbling lyrics on paper, thinking about beats and rhymes.

"I would sit in the office and start writing songs instead of handling customer files," he said. "That's when I knew I wasn't where I was supposed to

At the time, CDQ was staying with his close friend and music producer, Masterkraft, who was also supporting him in more ways than one. He revealed that Masterkraft even lent him suits to wear to work because he couldn't afford his own.

Eventually, CDQ made a life-changing decision.

"I quit my bank job," he said. "I didn't



even tell my mum or any member of my family. I just packed my things and went to stay in the studio with Masterkraft. I told him I didn't want to do banking anymore. That was never my passion."

According to CDQ, it was a bold step, but he was convinced it was the right one. Even though music didn't guarantee immediate financial reward, he was more at peace doing what he loved.

"Music gives me joy," he said. "Even if I don't make money from it, I'm still happy. That's how I knew it was the right path."

CDQ said he had a conversation with Masterkraft where he made a promise that if they both focused fully on their craft, success would come within six months. That confidence soon paid off.

"Before six months, we got a record deal," CDQ recalled. "We moved out of the ghetto and into Lekki. That was the beginning of our breakthrough."

The decision marked a turning point in CDQ's life and career. He began to gain recognition in the music industry, and in

2016, he broke through with the hit single Indomie, featuring Masterkraft and Olamide. The track became an instant street anthem, earning him fans across the country.

The remix, which featured music superstar Davido, pushed the song even further and solidified CDQ's place in the Nigerian music scene.

Looking back, CDQ said leaving the bank was one of the hardest decisions he's ever made, but also the most rewarding. His journey highlights the struggles many young Nigerians face in choosing between job security and personal passion.

"I took a risk," he said. "I didn't know if it would work out, but I knew I couldn't keep living a life that didn't make me happy."

Today, CDQ is one of Nigeria's respected rappers, known for his blend of indigenous Yoruba rap and energetic delivery. But behind the fame is a story of courage, faith, and a leap into the unknown, all in pursuit of purpose.

Trump, Japan strike deal to cut tariffs to 15% By Elizabeth Jenrola Oso

resident Donald Trump announced on Tuesday that his administration has reached a sweeping trade agreement with Japan, slashing U.S. tariffs on Japanese imports to 15%. The move marks a dramatic shift from the previously threatened rates of 24% and 25%, and follows months of pressure from the Trump administration on global trading partners.

Taking to Truth Social, Trump described the deal as a "tremendous win" for American trade policy. The new 15% tariff is still significantly higher than the pre-Trump effective rate of under 2%, according to World Bank data, but represents a compromise compared to earlier threats.

Japanese Prime Minister Shigeru Ishiba confirmed the agreement at a press conference in Tokyo on Wednesday, calling it "the lowest rate so far" among countries maintaining a trade surplus with the United States.

"We have exerted all our efforts to protect our national interests," Ishiba stated. "Among the countries that have a trade surplus with the United States, we have achieved the greatest results."

The deal arrives just ahead of Trump's 1 August deadline for countries to reach trade agreements or face increased tariffs. Though previous deadlines have been pushed back, Treasury Secretary Scott Bessent told Fox Business Network that this one is a "pretty hard deadline."

Since what the Trump administration dubbed "Liberation Day" on 2 April, when the president began issuing tariff ultimatums, the U.S. has yet to finalise any formal trade deals. Instead, several framework agreements have been signed, including this latest pact with Japan, which could develop into a fully-fledged agreement.

Japan, the fifth-largest exporter to the United States last year, with nearly



\$150 billion worth of goods sold to American buyers, has worked feverishly to avoid Trump's escalating tariffs. Its lead trade negotiator has reportedly visited Washington eight times in recent months, most recently on Monday, for a two-hour meeting with Commerce Secretary Howard Lutnick.

Under the terms of the agreement, Trump claimed that Japan will "invest, at my direction, \$550 Billion Dollars into the United States, which will receive 90% of the Profits." The specifics of how such an investment would function remain unclear. Japan is already the largest foreign investor in the U.S., with \$754.1 billion in direct investment last year, according to the U.S. Bureau of Economic Analysis.

Speaking later on Tuesday at an event with congressional Republicans, Trump celebrated the agreement, saying: "The tariffs kicked in better than anybody other than me and a few of the people in the room thought could happen."

He also announced that Japan and the

U.S. will form a joint venture focused on liquefied natural gas development in Alaska.

The deal comes during a politically precarious period for Prime Minister Ishiba, whose Liberal Democratic Party recently lost both houses of parliament. Despite this, he has vowed to remain in office to address ongoing economic challenges.

In a surprising shift just weeks ago, Trump had appeared pessimistic about the likelihood of a deal. "The Japanese are tough," he said on 16 June, "but ultimately you have to understand we're just going to send a letter saying, 'This is what you're going to pay, otherwise you don't have to do business with us.' But there's a chance."

In a separate development, Trump recently approved a delayed takeover of U.S. Steel by Japan's Nippon Steel. The agreement includes a \$14 billion investment and the creation of at least 70,000 jobs, a figure later revised to 100,000 to include direct, indirect, and induced employment.

UK aid cuts will hit women, girls, Africa hardest, govt admits By Helen Okechukwu By Helen Okechukwu



The United Kingdom (UK) governmenthas acknowledged that its deep foreign aid cuts will likely lead to more global deaths, disproportionately affecting women, girls, and crisis-hit regions in Africa.

In its latest report, the Foreign, C o m m o n w e a l t h a n d Development Office (FCDO) confirmed a £575 million cut for 2025-26. Overall aid will drop from 0.5% to 0.3% of Gross N a t i o n a l I n c o m e b y 2027—around £6 billion less.

The FCDO's own impact assessment warns that the cuts could increase disease and death, especially among the poorest and most vulnerable, including children and people with disabilities.

Critics say key sectors like education, healthcare, and gender support will suffer most. Labour MP Sarah Champion called the move a blow to "the pillars of healthy and secure societies."

Gideon Rabinowitz of Bond, a network of UK aid organisations, warned that the world's most marginalised communities will "pay the highest price" and urged the UK to fill the gap left by the US retreat from global gender programmes.

Africa is taking the brunt of regional cuts, despite being home to most of the world's poorest people.

Aid to the Americas, Europe, and Indo-Pacific is rising, while support for countries like South Sudan, Ethiopia, and Somalia is falling sharply.

While the UK is still sending £1.8bn to the World Bank's IDA and backing global vaccine efforts like Gavi, direct country-level support is shrinking. Funding for girls' education is set to be halved, and spending on women's health—including family planning—is also being reduced.

Baroness Jenny Chapman, Minister for Development, defended the shift, saying the UK is moving from being an "aid donor" to a partner, focusing on long-term investment and expertise-sharing.

But campaigners say the strategy change comes at a cost: fewer resources for those most in need, especially women and girls in conflict zones.

Home Office partners Deliveroo to curb illegal migrant labour By Fatimah Idera

he Home Office has reached an agreement with food delivery giants Deliveroo, Just Eat, and Uber Eats to share the locations of asylum hotels in an effort to prevent asylum seekers from working illegally in the gig economy.

Under the new partnership, the government will provide these companies with data on hotels in highrisk areas. The goal is to help platforms identify and suspend accounts suspected of being used fraudulently, particularly in cases where legal account holders are believed to be sharing their profiles with individuals not authorised to work in the UK.

The move follows an investigation that uncovered how newly arrived asylum seekers, housed in taxpayer-funded hotels, were delivering food for these platforms within days of arriving by small boat.

However, UK law prohibits asylum seekers from working for at least 12 months after they submit their asylum claim unless a decision is made sooner. Officials say this ban is being routinely circumvented through account sharing, which allows unauthorised individuals to earn income under someone else's name.

Home Secretary Yvette Cooper described the new measures as a vital part of a broader campaign to close loopholes and clamp down on illegal work.

"Illegal working undermines honest businesses, exploits vulnerable individuals, and fuels organised immigration crime," Cooper said. "By enhancing our data sharing with delivery companies, we are taking decisive action to close loopholes and increase enforcement."



The initiative comes alongside an ongoing Plan for Change, which includes a 50% rise in workplace raids and arrests, tougher security measures, and new legislation aimed at curbing illegal employment and deterring irregular migration.

Delivery platforms have already begun tightening identity and right-to-work checks. According to the Home Office, these measures have resulted in the removal of thousands of workers from the apps. In addition, the companies have committed to expanding their use of facial recognition and fraud detection tools to ensure only verified account holders are allowed to work.

Anyone caught sharing their account with someone who lacks legal working status will have their access suspended, the companies said.

Director of Enforcement at the Home Office, Eddy Montgomery praised the collaboration as a necessary step in disrupting illegal activity.

"This next step of coordinated working with delivery firms will help us target

those who seek to work illegally in the gig economy and exploit their status in the UK," Montgomery said. "My teams will continue increased enforcement activity across the country."

The new measures form part of a broader government effort to reduce the perceived pull factors attracting migrants to the UK. That includes a promised "nationwide blitz" on illegal working and a recently agreed bilateral deal between Prime Minister Sir Keir Starmer and French President Emmanuel Macron to return some migrants crossing the Channel back to France.

So far in 2025, over 23,500 migrants have crossed the English Channel to the UK, a record for this point in the year.

The delivery firms involved said in a joint statement that they are fully committed to supporting the government's enforcement efforts and preventing illegal working on their platforms.

Obama rebukes Trump over 'treason'

allegations

Pormer U.S. President Barack Obama's office has issued a rare and scathing rebuke of Donald Trump after the current president accused his predecessor of "treason" and claimed he rigged both the 2016 and 2020 presidential elections.

"Out of respect for the office of the presidency, our office does not normally dignify the constant nonsense and misinformation flowing out of this White House with a response," said Obama spokesperson Patrick Rodenbush. "But these claims are outrageous enough to merit one. These bizarre allegations are ridiculous and a weak attempt at distraction."

Trump, speaking to reporters on Tuesday, pivoted from a question about convicted sex offender Jeffrey Epstein to levelling sweeping accusations against Obama, declaring: "Obama's been caught directly... This was treason. This was every word you can think of. They tried to steal the election."

He added, "After what they did to me, and whether it's right or wrong, it's time to go after people."

Trump cited recent statements made by Director of National Intelligence Tulsi Gabbard and CIA Director John Ratcliffe, who alleged that officials in the Obama administration had manipulated intelligence to undermine Trump's 2016 victory. Gabbard, in a post last week, announced she was making a criminal referral to the Justice Department, accusing former officials of deliberate obstruction.

At a separate event with Republican members of Congress, Trump again praised Gabbard and doubled down on his allegations, calling Obama and others "vicious, horrible people."

Rodenbush countered those claims by pointing to longstanding findings that have withstood bipartisan scrutiny. "Nothing in the document issued last week undercuts the widely accepted conclusion that Russia worked to



influence the 2016 presidential election but did not successfully manipulate any votes," he said, referencing a 2020 Senate Intelligence Committee report led by Republican Chairman Marco Rubio.

White House spokesperson Davis Ingle responded by saying the administration "is appreciative of Director Gabbard's commitment to transparency and effort to end the weaponisation of government against American citizens."

Gabbard argued the intelligence community had withheld an assessment from December 2016 that concluded Russia did not impact the election through cyberattacks, a document she claims was abruptly pulled. However, Obama himself, during a press briefing shortly after the 2016 election, clarified that while Russia did interfere, there was no evidence of tampering with vote counts.

Obama maintains influence of Russia's aim

The Obama administration maintained that Russia's aim was to influence the election through hacked document leaks and a sophisticated disinformation campaign, claims later substantiated by Special Counsel Robert Mueller's investigation and the bipartisan Senate report.

A separate investigation, led by Special Counsel John Durham and championed by Trump's allies, was sharply critical of the FBI's early handling of the Russia probe but did not uncover any criminal conspiracy within the Obama administration.

"The Committee's bipartisan report found that Russia's goal in its unprecedented hack-and-leak operation... was to assist the Trump Campaign. Candidate Trump and his Campaign responded to that threat by embracing, encouraging, and exploiting the Russian effort," the Senate report concluded.

Democratic lawmakers have slammed the renewed accusations as a political distraction.

"This is just another example of the DNI trying to cook the books, rewrite history, and erode trust in the intelligence agencies she's supposed to be leading," said Senator Mark Warner, Democrat of Virginia.

House Democratic Caucus Chair Pete Aguilar added, "It's all a distraction... they'll release anything if it buys them another day or two not talking about Epstein."

Trump, facing pressure from within his MAGA base over the administration's handling of the Epstein case, has reignited several old grievances on social media. On Truth Social, he accused long-time foe Senator Adam Schiff of criminal behaviour and posted AI-generated mugshots of prominent Democrats.

MeToo Movement leaves some men hesitant to mentor women at work By Fatimah Idera

or many male bosses, the sight of Chancellor Rachel Reeves tearing up behind Sir Keir Starmer in the Commons this month hit a nerve. As Starmer pressed ahead with Prime Minister's questions unaware of the emotional moment happening behind him, some in the business world weren't focused on empathy but anxiety.

According to One City Headhunter, many male managers quietly admit they dread the idea of a woman crying at work. So much so that they often hold back on giving honest, constructive feedback they wouldn't he sitate to offer their male colleagues. The worry isn't always rooted in compassion, but fear: of getting it wrong, being misinterpreted, or just facing the discomfort of visible emotion.

It's a dynamic that's persisted for decades. One female banker recalls a top U.S. executive visiting London in the 1990s. "He admitted he avoided giving women tough feedback because he didn't want to make them cry," she said. "He was honest, but that meant those women were less likely to grow. They didn't get the same feedback as men and were more likely to stumble later."

And the problem hasn't gone away. In fact, it worsened after the rise of the MeToo movement. A 2019 Lean In study found that 60% of male managers said they felt uncomfortable mentoring younger women a sharp increase from just a year earlier. The fear of being misunderstood had grown so widespread that it was visibly altering workplace dynamics.

Sheryl Sandberg, then COO of Facebook, captured the tension at the time: "Ugly behaviour that once



was indulged or ignored is finally being called out and condemned," she said. "Now we must go further. Avoiding and isolating women at work... must be unacceptable too."

She was right. While most people today understand the difference between harassment and a normal professional exchange, the lingering discomfort some men feel, especially around emotionally charged moments, continues to disadvantage women.

Because here's the truth: people cry at work. A YouGov poll last year found that more than half of employees have done so. It's human. But if a manager sees tears as a sign to step back rather than step up, they're failing. A good leader doesn't shy away from uncomfortable moments they navigate them with care and confidence.

What's ironic is how much energy is wasted on superficial training. Entire consultancies are built on online courses, teaching grown adults that sexual harassment is wrong or that unwelcome massaging in the office is inappropriate. (Yes, even top lawyers are sent these.)

But while companies box-tick their way through performative compliance, they're overlooking the real issue: a culture that encourages managers often male to treat female colleagues with kid gloves. The result? Women miss out on mentorship, tough feedback, and career-defining conversations.

We don't need more e-learning modules. We need better managers. Ones who are trained not just to avoid lawsuits, but to lead teams, including those moments when emotion shows up. If we want the gender pay gap to close (and at the current rate, PwC says it will take over 40 years), we can't afford to let discomfort hold back half the workforce.

So yes, emotion at work can feel awkward. But dodging it isn't leadership it's weakness in disguise. It's time we stopped treating tears like a crisis and started treating them like what they often are: a normal, human response to a high-pressure job.

They are back now – bigger, stronger and ready to fight again and give something to their fans who have filled the Olympic Stadium to the brim every match day in Rabat.



Venus Williams, 45, makes historic comeback win at DC Open

n a remarkable display of resilience and timeless talent, Venus Williams became the second-oldest woman in professional tennis history to win a tourlevel singles match, defeating Peyton Stearns 6-3, 6-4 at the DC Open on Tuesday night.

At 45, Williams delivered a vintage performance filled with powerful serves and aggressive groundstrokes, triumphing over an opponent 22 years her junior. Her victory marks her first in singles since August 2023 in Cincinnati, and her first competitive singles match since March 2024 in Miami, where she later underwent surgery to remove uterine fibroids.

The only player older than Williams to win a WTA singles match is Martina Navratilova, who accomplished the feat at age 47 in 2004.

Listed as "inactive" by the WTA until this week, Williams returned to the court backed by a passionate Washington crowd. She reminded everyone of her seven Grand Slam singles titles, 14 women's doubles titles alongside sister Serena, and two mixed doubles titles.

The crowd roared as Williams stepped onto the 7,000-seat main stadium, more than double the size of the court where she had won her doubles match the previous day. The applause grew louder when she took part in the coin toss, and reached a crescendo when she fired aces above 110 mph, flashes of the dominant form that once made her world No. 1.

While the rust was evident, she was broken at love in the opening game, Williams quickly settled in. In the second game, she cracked a return winner to start a break of serve, then surged to a 4-2 lead before taking the first set. She chased down drop shots, hit fearless returns, and leaned on her experience when the pressure mounted late in the match.

Closing out the win wasn't straightforward. Williams squandered

multiple match points before finally sealing victory with a 112 mph serve that Stearns could only send into the net. Beaming, Williams jogged to the net, shook hands, and treated fans to her signature post-win pirouette and wave.

She now advances to face fifth seed Magdalena Frech of Poland, aged 27, in the second round.

Elsewhere in the women's draw, former US Open champion Emma Raducanu saw off seventh seed Marta Kostyuk 7-6 (4), 6-4, extending the Ukrainian's losing streak to six matches. Raducanu will next face four-time Grand Slam winner Naomi Osaka, who dispatched Yulia Putintseva 6-2, 7-5.

In men's action, upsets marked the day as Britain's Cam Norrie defeated second seed Lorenzo Musetti 3-6, 6-2, 6-3, while third seed Holger Rune withdrew due to a back injury. Fourth seed Ben Shelton progressed with a confident 6-3, 6-4 win over Mackie McDonald.
