# FG moves to end malnutrition as Shettima inaugurates nutrition 774 strategic board

he Federal Government (FG) has taken a major step to tackle Nigeria's growing malnutrition crisis with the inauguration of the Strategic Board of the Nutrition 774 Initiative by Vice President Kashim Shettima.

Speaking at the inauguration ceremony held yesterday at the Presidential Villa, Abuja, Mr Shettima described the newly formed board as a 'war room' tasked with winning the battle against malnutrition across the country's 774 local government areas.

"This Strategic Board is not a ceremonial committee; it is a war room, assembled to win the battle against malnutrition in every corner of this country," he declared.

He emphasised the urgency of the assignment, warning that malnutrition is a national emergency with dire implications for public health, productivity, and national security.

"This is not a tea-drinking exercise. This is a national call to duty. A race against time. A mission to save lives and safeguard our future," the Mr Shettima said, urging board members to treat their appointments with utmost seriousness.

The Nutrition 774 Initiative, according to Mr Shettima, is a bold response by the Tinubu administration to what he called 'a quiet emergency' affecting families, schools, health centres, and internally displaced persons (IDP) camps nationwide.

"A nation that neglects the physiological needs of its people, particularly the most vulnerable, flirts with instability," he warned.

"A malnourished population is an unproductive one, and an unproductive population drags down the wheels of progress."

Mr Shettima said the initiative aims to harmonise fragmented nutrition efforts, reduce duplication, and foster a unified



framework for action and measurable impact.

More so, the Minister of Budget and Economic Planning, Atiku Bagudu, lauded Shettima's leadership on the issue, saying: "There are issues that ministries and the entire MDAs ought to deal with, but you have elevated them under your supervision. It's commendable, and we pray that God continues to protect and reward you."

Mr Bagudu linked Mr Shettima's commitment to his personal experience of conflict and food insecurity in Borno State, noting that his leadership on nutrition and food security stems from 'a reckoning with history.'

Also speaking, the Minister of Women Affairs, Hajiya Sulaiman-Ibrahim, called for the economic empowerment of women and households headed by children, particularly in areas affected by conflict.

"In homes headed by eleven-year-olds because both parents have been lost, how do they feed? This is an economic issue, and we have to come out strongly. As part of this plan, I would like you to address the economic empowerment of women," she said.

The Chairman of the House Committee on Nutrition and Food Security, Chike Okafor, assured that the National Assembly is fully backing the Nutrition 774 initiative, pledging legislative support to ensure its success.

"This initiative is about taking solutions to the grassroots. You have all the legislative support necessary, and we will ensure everything needed is done," Okafor said.

Earlier, the Senior Special Assistant to the President on Public Health (Office of the Vice President), Uju Anwuka, described the malnutrition crisis as a threat to human capital development, saying the initiative aligns with President Tinubu's Renewed Hope Agenda.

"By addressing malnutrition, the initiative will strengthen educational outcomes, productivity, and health equity across Nigeria," she said, adding that strong leadership, strategic partnerships, and community involvement will be key to achieving its objectives.

The Nutrition 774 Initiative is expected to mobilise national, state, and local efforts to combat malnutrition and improve the health and productivity of Nigerians—particularly the most vulnerable.

#### Tinubu to attend West Africa economic summit in Abuja By Gbenga Olaleye



resident Bola Ahmed Tinubu is set to attend the West Africa Economic Summit (WAES) today, Saturday, 21 June 2025, at the Bola Ahmed Tinubu International Conference Centre in Abuja.

The summit, now in its second and final day, precedes the 67th Ordinary Summit of the Economic Community of West African States (ECOWAS), scheduled for Sunday, 22 June 2025, at the State House Conference Centre, Abuja.

The Special Adviser to the President on Information and Strategy, Bayo Onanuga, disclosed in a statement titled 'President Tinubu To Advance Economic Integration At The West Africa Economic Summit' that the initiative, under President Tinubu's leadership as Chairman of the ECOWAS Authority of Heads of State and Government, marks the first of its kind aimed at deepening regional economic integration.

"WAES strongly focuses on enhancing trade and investment cooperation across the subregion," Onanuga noted.

President Tinubu has extended invitations to Member States of the Alliance of Sahelian States and Mauritania, signalling his commitment to inclusive dialogue and regional cooperation.

Confirmed participants include the Presidents of Ghana, Liberia, Sierra Leone, Senegal, The Gambia, Benin, Togo, and Guinea-Bissau.

The summit is expected to deliver tangible outcomes that will accelerate West Africa's integration agenda, which is crucial for sustainable peace, security, and prosperity in the region.

Ministers of Finance, Trade, Infrastructure, and Foreign Affairs from ECOWAS member states, along with representatives from key regional

economic institutions such as the West African Monetary Agency, West African Monetary Institute, ECOWAS Bank for Investment and Development, West African Economic and Monetary Union, and the African Continental Free Trade Area Secretariat, are also in attendance.

Private sector leaders, development partners, and policy experts form part of the broad spectrum of participants.

Ahead of the summit, President Tinubu deployed a delegation of Special Envoys to deliver formal invitations to Heads of State and Government across the region.

The Minister of State for Foreign Affairs, Bianca Odumegwu-Ojukwu, led the team, accompanied by the Senior Special Assistant to the President on Foreign Affairs and International Relations, Sola Enikanolaiye.

# Akpabio predicts defection of Rivers, By Damilola Olufemi By Damilola Olufemi



enate President Godswill Akpabio has hinted that Governors Siminalayi Fubara of Rivers State and Douye Diri of Bayelsa may soon join the All Progressives Congress (APC), signalling a potential political realignment in the South-South region.

Akpabio made the statement on Saturday during a reception held at the Godswill Akpabio International Stadium in Uyo, Akwa Ibom, to formally welcome Governor Umo Eno into the APC. Eno had earlier announced his defection from the Peoples Democratic Party (PDP) on June 6.

The event attracted key figures in the ruling party, including Vice President Kashim Shettima, APC National Chairman Abdullahi Ganduje, as well as several governors and senators elected on the party's platform.

Describing the occasion as more than a political crossover, Akpabio called it a "reunification of Akwa Ibom with

Nigeria," asserting that recent defections by governors like Eno and Delta State's Sheriff Oborevwori indicate a growing shift of the South-South towards the APC.

"It was a little bit of a surprise when we (South-South) attempted to go different ways in 2023," Akpabio said. "Today, Governor Otu is no longer an orphan. Thank you for being here to welcome your brothers, and you will welcome more brothers."

Acknowledging Oborevwori's alignment with the ruling party, Akpabio continued, "Governor Sheriff of Delta, thank you for joining the progressives' family and moving the South-South in the progressives' direction."

He went on to suggest that the next wave of defections could come from Rivers and Bayelsa. "Governor Umo Eno, after you, who knows? Rivers State will tumble. After Rivers, Bayelsa will join," he predicted.

Akpabio also celebrated the APC's recent electoral gain in Edo State. "Of course, we have won the election in Edo State. We produced our amiable senator, Monday Okpebholo," he said.

Akpabio expresses confidence in South-

Looking ahead to 2027, the Senate President expressed confidence that the entire South-South region would rally behind President Bola Tinubu in his reelection bid.

"Come 2027, South-South will go one way; the South-South will vote for President Bola Tinubu," he declared.

He concluded with a bold forecast, saying, "I see you becoming the first re-elected governor in 2027. I see the president getting 99.9% votes in 2027."

Currently, the APC controls four of the six states in the South-South, with Rivers and Bayelsa still under PDP leadership.

#### COAS vows justice over killings in Benue,

#### Plateau

The Chief of Army Staff (COAS), Lieutenant General Olufemi Oluyede, has assured Nigerians that the military is resolutely committed to bringing to justice those responsible for the recent surge in violence across Benue, Plateau, and other troubled regions.

Speaking on Saturday during the Nigerian Army Headquarters' Second Quarter 2025 Media Chat held in Akure, the COAS reiterated the army's determination to restore peace, particularly in the volatile North-Central states.

The event, organised by the Department of Civil-Military Affairs, was themed 'Military-Media Collaboration: Panacea for Enhanced National Security and Development'.

Represented by Major General Obinna Onubogu, General Officer Commanding (GOC) 2 Division, Nigerian Army, Ibadan, Oluyede emphasised that the



military is fully deployed and acting under presidential directives to tackle the security challenges head-on.

"In Benue especially, expect more elaborate and strategic security arrangements in the coming weeks aimed at ending the violence," he stated.

Oluyede appealed to community leaders and residents to provide timely and reliable intelligence, highlighting that

delayed or inaccurate information often hampers military operations.

"Nigeria is vast, and the army isn't as large in numbers as people may assume. We depend heavily on the support of the people," he said.

He also called on the media to exercise caution by verifying facts before publication, especially amid the prevalence of misinformation and disinformation on social media platforms.

"Sensationalism only worsens public anxiety and undermines national efforts," Oluyede warned.

The COAS's message underscores the critical need for unity between the military, local communities, and the press in combating insecurity and fostering lasting peace in Nigeria.

### Why NNPCL spokesperson, Femi Soneye, resigned By Damilola Olufemi


The Chief Corporate Communications Officer of the Nigerian National Petroleum Company Limited (NNPCL), Femi Soneye, has officially resigned from his position.

## Gov Sani demands arrest of killers of Kaduna indigenes in Plateau By Oluwaotosin Ologun



aduna State Governor, Uba Sani, has condemned the killing of 12 Kaduna State citizens in the Mangu Local Government Area of Plateau State.

The victims were said to be travelling from Zaria in Kaduna State for a wedding in Quan Pan Local Government Area of Plateau State when the mob at Mangun district intercepted them.

The travellers were killed instantly, while several others sustained various degrees of injuries during the attack.

Expressing shock and sadness over such an act of savagery, Governor Sani, in a statement, called on security agencies to immediately arrest and prosecute those behind the attack.

He vowed that the Kaduna State Government would not leave a stone unturned until the criminals were hunted down and brought to justice. The governor said, "We must put a stop to the nefarious activities of non-state actors. There is no justification for anybody to attack any citizen of Nigeria in any part of the country. This madness must stop. Enough is enough".

Governor Sani, therefore, appealed to his Plateau State counterpart, Caleb Mutfwang, to use the unfortunate incident to make a bold statement by taking full charge of the situation and directing the operations of security agencies until the murderers are brought to justice.

The governor promised to personally follow up on the progress made in the investigations and field operations in search of the criminals to send a clear signal that impunity will no longer be tolerated.

He, however, called on the citizens of Kaduna State to remain calm, stating that all hands are on deck to ensure that the victims get justice.

Sani also consoled the families of the victims over the loss of their loved ones.

He said, "We have made remarkable progress in peacebuilding and conflict transformation in Kaduna State. The Kaduna Peace Model is a pointer to the fact that with political will, commitment, and sincerity of purpose, a toxic environment can be turned into an 'oasis of peace'.

"The situation in Plateau State is not irredeemable. The bloodshed must stop. Our deepest condolences to the families of our citizens who lost their precious lives in Mangu Local Government. I am in touch with the families of the victims. We shall do all in our power to lessen their pains. We shall also ensure that the injured victims receive adequate medical attention. May the gentle souls of our departed citizens rest in perfect peace".

agos State First Lady, Ibijoke Sanwo-Olu, led a high-profile campaign against drug abuse and illicit substance use at Lagos State University (LASU), Ojo, in commemoration of the 2025 International Day Against Drug Abuse and Illicit Trafficking.

# APC chieftain slams El-Rufai, accuses him of hypocrisy, division By Ghenga Olaleye



prominent chieftain of the ruling All Progressives Congress (APC) in Kaduna State, Mallam Suleiman Salisu, has voiced strong disapproval over the conduct of certain former public officials who, despite their "woeful" records in office, now openly criticise the current administration.

Speaking in Kaduna, Salisu expressed "great concern" regarding the recent comments made by former Kaduna State Governor, Mallam Nasir El-Rufai, accusing him of hypocrisy and stirring disunity during his tenure.

According to Salisu, El-Rufai, who governed the state for eight years, bears responsibility for the divisions currently plaguing Kaduna.

"Does it mean that Nigerians have forgotten in a hurry what the immediate former governor did while in office for good eight years?" he asked.

"Go to the southern part of Kaduna metropolis, largely inhabited by Christians – El-Rufai completely neglected them. No infrastructure, no roads, no basic amenities, as if they are not part of the state capital."

Salisu also pointed to the alarming insecurity that characterised much of El-Rufai's tenure, particularly the widespread kidnappings and killings. "Are you talking of going to Birnin Gwari, Kafanchan or Abuja? How many lives were lost? How many Nigerians were kidnapped?" he questioned, citing the ongoing violence in areas such as Zangon Kataf Local Government and Atyap Chiefdom.

He lamented that despite what he described as a poor track record, El-Rufai has now taken to public platforms portraying himself as a saint.

"Today, the former governor is

everywhere speaking as a saint, condemning the present administration. And Nigerians believe these are the type of politicians fit to lead the country? What real solutions does El-Rufai have to offer?" he asked.

Salisu called on Nigerians to be more discerning and not be swayed by what he termed as the antics of "selfish politicians" who, after leaving office, contribute little but criticism.

"Nigerians must wake up from their slumber and sincerely seek out leaders who can truly salvage the country from its current state," he urged.

"The challenges we face are serious enough to make us reflect and choose reasonable leaders who can lift us from this quagmire."

The remarks come amidst growing political tension in the state and rising criticism of the federal government's handling of national affairs.

#### Keyamo mocks new ADA coalition, labels it 'pedestrian joke' By Ghenga Olaleye



igeria's Minister of Aviation, Festus Keyamo, has ridiculed the formation of the All Democratic Alliance (ADA), dismissing it as an overhyped political effort lacking genuine coalition strength.

In a statement posted on his official X (formerly Twitter) account on Friday, Keyamo criticised the political buzz surrounding the registration application submitted by ADA to the Independent National Electoral Commission (INEC).

The ADA, reportedly backed by the Nigerian National Coalition Group (NNCG), counts among its key supporters former Vice President Atiku Abubakar and ex-Kaduna State Governor Nasir el-Rufai.

The party's application, dated 19

June, was signed by its National Chairman, Akin Ricketts, and Pro Tem National Secretary, Abdullahi Musa Elayo.

Reacting, Keyamo dismissed the development as an unremarkable attempt to gain attention.

"This is just a simple application for party registration. There is nothing like a 'coalition' here," he wrote.

"It is an unnecessary hype the promoters have been struggling to create all along."

The Aviation Minister argued that unlike the grand political alliance that led to the formation of the All Progressives Congress (APC) in 2013, ADA lacks both scale and substance.

"If they are thinking of recreating what the APC did in 2013, then this is nothing but a pedestrian joke—a complete mockery of that seismic political coalition."

He further accused ADA's promoters of launching psychological warfare against Nigerians, claiming the effort was a "weak attempt at mass appeal" and lacking support from any major political party.

"In the end, it is simply a group of individuals exercising their constitutional right to register a party. Nothing more," Keyamo added.

The ADA's formation has stirred political speculation ahead of the 2027 general elections, but Keyamo's remarks signal the ruling party's dismissive stance on what some are calling a potential third force.

#### Makinde defends N63.4bn govt house renovation, cites dollar-naira fluctuation By Damilola Olufemi



yo State Governor, Seyi Makinde, has defended the controversial №63.4 billion earmarked for the renovation of the Government House, attributing the high cost to Nigeria's volatile exchange rate and broader economic instability.

The figure, which has sparked criticism and debate among citizens and stakeholders, was addressed by the governor during a special session of the State House of Assembly to commemorate its second anniversary.

Governor Makinde explained that the project's cost is a reflection of the current naira-dollar exchange rate, noting that fluctuations in the currency market have significantly impacted financial planning across the board.

He said, "Our economy is bearing the brunt of a weak naira. When we assumed office, monthly repayment on our foreign debt stood at N700 million. Today, we are repaying №3 billion monthly."

He pointed out that a major portion of the state's foreign debt, currently above

№300 billion, stems from a \$200 million World Bank loan inherited from the previous administration under late Governor Abiola Ajimobi. According to Makinde, the loan was secured when the exchange rate was around №350 to a dollar, translating then to roughly  $\Re 70$  billion.

"But due to the depreciation of the naira, that same loan now requires far more in repayment terms," he said.

Makinde speaks further

Lamenting the limited influence of state governments in national monetary policy, Makinde added, "As a sub-national, Oyo State does not influence exchange rate decisions. Yet, we bear the consequences in our fiscal planning."

Amid the economic constraints, the governor also unveiled plans to bolster state security with the procurement of two aircraft for aerial surveillance.

"These aircraft will not only strengthen our security framework, but also mark the 50th anniversary of Oyo State's creation from the old Western Region,"

he said, describing the initiative as part of a broader strategy to protect lives and property.

During the plenary, Speaker of the Oyo State House of Assembly, Adebo Ogundoyin, commended the cooperation between the executive and legislative branches, saying it has been central to the state's progress so far.

"Our achievements are the result of strong collaboration and shared purpose," he said. "The next two years will come with tougher demands, and we must rise to meet them with renewed commitment."

Ogundoyin also announced the recruitment of 181 new staff into the Assembly, emphasising that the process will be transparent and based strictly on merit.

He reaffirmed the Assembly's dedication to enacting impactful laws and conducting effective oversight, saying, "We will continue to ensure that the voices of our people remain at the heart of everything we do."

### Alao-Akala Estate dispute: Daughter wants ex-governor's body exhumed By Alade Adisa

he dispute over how to share the vast estate left behind by former Oyo State Governor, Adebayo Alao-Akala, has escalated, as one of his daughters, Oluwatoyin Alao-Aderinto, is seeking the approval of the court to get the corpse of the deceased exhumed and a Deoxyribonucleic Acid (DNA) test conducted on seven persons claiming to be the deceased's children.

She has therefore filed an application to that effect before an Oyo State High Court sitting in Ibadan.

The court is presided over by Justice Taiwo.

In the case marked I/443/2024, Mrs Alao-Aderinto, through her counsel, Oladipo Olasope, is praying the court to direct that the DNA tests be carried out on herself, Olamide, Adebukola, Olamipo, Olamiju, a serving member of the House of Representatives, Tabitha and Olamikunle, as listed in the motion on notice filed before the court.

She wants the test to be conducted at a court approved, accredited laboratory to determine their true biological relationship with the late governor.

As part of the application, Mrs Alao-Aderinto is also seeking an order of court, directing the exhumation of Otunba Alao-Akala's remains from the mausoleum built in his Ogbomoso country home for the purpose of carrying out the paternity test.

The results of the tests, she pleaded, should be filed under a sealed envelope and delivered directly to the presiding judge for pronouncement in open court.

The fresh application brought before the court is a new twist in what has become a messy and prolonged family feud over the vast estate of the late politician, who died intestate on January 12, 2022.

The crisis, which has been brewing silently since his burial, became public



in October 2022 when one Kemi Alao-Akala and Olamide Alabi, believed to be one of the deceased's daughters, obtained a Letter of Administration from the Oyo State Probate Registry without the knowledge or consent of Mrs Alao-Aderinto, the first child.

This singular act, she contends, is a deliberate and unlawful exclusion that contravenes applicable laws guiding intestate succession in Nigeria.

In her affidavit and accompanying exhibit filed in support of her motion, she accused the duo of manipulating facts to claim sole control over the estate, despite the presence of other biological children and heirs.

The estate in question is said to be massive, including several properties in Ibadan, Lagos, Abuja, United Kingdom and the United States of America.

There is also a five star hotel in Ghana, vehicles and multiple bank accounts containing hundreds of millions of naira, dollars and pounds sterling.

Mrs Alao-Aderinto's position on her deceased father's estate stems from her strong resolve at ensuring that every individual, including nuclear and extended family members, aides of the former governor, who served him meritoriously without blemish and yet to identified children among many others are catered for, as against the winner takes it all approach adopted by the duo of the defendants.

The said administrators listed only seven individuals as legal heirs, but Mrs Alao-Aderinto position, as articulated by her counsel, is that there is no consensus on the paternity of these persons and that the inclusion of some and exclusion of others in the administration of the deceased's estate raises troubling questions of authenticity and equity.

It is on this basis she seeks judicial intervention through scientific means.

It will be recalled that in an August 2023 letter made public, counsel to Mrs Alao-Aderinto, Olasope, warned that the exclusion of the claimant who is the first daughter of the late Alao-Akala, violated both moral norms and legal rights, stressing that unless resolved, the dispute could further polarise the family and damage the late governor's political legacy.

## Ondo govt approves death penalty for kidnappers By Friday Omosola

he Ondo State Government has approved the death penalty for convicted kidnappers as part of sweeping new measures to address rising insecurity and enhance public safety.

The state's Attorney-General and Commissioner for Justice, Olukayode Ajulo, announced the development during a press briefing following the State Executive Council meeting presided over by Governor Lucky Aiyedatiwa in Akure.

Mr Ajulo said the Council resolved to commence the process of amending existing laws on kidnapping to prescribe capital punishment for offenders.

He stressed that kidnapping and cultism had become serious threats to public order, and a stronger legal framework was needed to deter such crimes.

He added that proposals would be forwarded to the Ondo State House of Assembly for necessary legislative action.

In a related development, the Council also approved the construction of two major dual carriageway roads and the installation of 6,000 solar-powered streetlights across the three senatorial districts of the state.

Special Adviser to the governor on infrastructure, lands, and housing, Abiola Olawoye, said the road projects include a 24.75-kilometre dual carriageway from Ugbeyin Junction through Okitipupa Market, OAUSTECH, and Ugbonla Junction to Igbokoda Jetty.

The second project is a 6.7-kilometre dual carriageway connecting Supare Junction to Akungba-Ikare Road in Akoko.



Both roads will feature 9.3-metre wide dual carriageways, 1.2-metre medians, solar streetlights, reinforced concrete drains, walkways, utility corridors, and modern traffic control systems.

They are also designed to withstand heavy vehicular movement.

Mr Olawoye also disclosed that 2,000 standalone solar streetlights would be installed in each of the state's three senatorial districts—Ondo North, Ondo Central, and Ondo South—as part of efforts to improve lighting and safety at night.

In the health sector, Special Adviser to the governor on health, Professor Simidele Odimayo, revealed that the government had adopted a new research-based approach to combat Lassa fever.

He said the strategy had already yielded results in testing, referrals, and surveillance.

Meanwhile, in the area of traditional institutions, Special Adviser on union matters and special duties, Bola Taiwo, announced the appointment of warrant chiefs to begin the process of selecting a new Olu-Oke of Okeigbo in Ile-Oluji/Okeigbo Local Government Area.

This followed a court ruling that nullified the appointment of the late Babajide Lawrence Oluwole prior to his death.

The Council also approved a change in the title of the Yasere of Ilepete (Ugbo) chieftaincy to Yasere of Oriretan in Ilaje Local Government Area, following concerns raised by stakeholders.

Mr Taiwo reaffirmed Mr Aiyedatiwa administration's commitment to strengthening traditional institutions, describing them as vital to grassroots governance and community development.

### 'I was tomboy before my ex-husband changed me', Tiwa Savage reveals By Ifedamola Joseph Fayomi

Savage has opened up about her surprising transformation from a tomboy into one of Afrobeats' most stylish and talked-about female stars.

She revealed that before she became famous, she had no interest in being a "sexy diva" and never saw herself as one.

According to the singer, her journey into stardom began with a major shift in her appearance and image, a change driven by her ex-husband and former manager, Tunji Balogun, popularly known as Teebillz.

How Teebillz rebranded her image Speaking during an episode of the Afrobeats Intelligence podcast hosted by Joey Akan, Tiwa shared how Teebillz played a key role in shaping her brand and public persona.

"I used to wear baggy jeans and T-shirts in the studio. I was just a songwriter then," she said. "When I met Teebillz in L.A., I was nothing like what people see now. He saw something different and thought there was a gap in the market."

She explained that Teebillz convinced her to rebrand completely. He encouraged her to start going to the gym, lose weight, wax her eyebrows, wear wigs, and embrace a more glamorous and bolder image.

"He literally changed my whole appearance," she recalled. "He wanted to give people the African Rihanna or Beyoncé. And I said, okay, let's do it."

Early backlash and cultural resistance The mother of one also revealed that while the new image brought attention, it also drew heavy criticism when she returned to Nigeria to pursue a singing career.

"My fashion sense attracted a lot of backlash," she said. "I would go to

"At the time, the media was saying, 'She's not going to be desirable anymore. Her time is gone. There are new faces now," she recalled. "So I wanted to do something bold. I wanted to prove that I was still here."

Although she described the move as rebellious, Tiwa insisted that she never aimed to be sexy solely for attention. "That's not who I naturally am," she said. "I'm a tomboy at heart. But I had to evolve."


"One thing I wish I had known earlier is that no one is your friend in the [music] industry," Ruger said.

#### One user wrote:


"You're right. Sex does make a woman glow. It's good for the skin and confidence.'

Music, identity, and division Illbliss said he was stunned by the presenter's remarks. The moment left him deeply discouraged, not just as a musician but also as a Nigerian who believed in unity through art.

"The song wasn't even offensive," he explained. "It was about how Igbo people enjoy life and celebrate their culture. Just



looking at that guy made me feel terrible. I realised that no matter how much we pretend to be one Nigeria, the tribal divisions are real and difficult to deal with."

According to Illbliss, the experience served as a painful reminder of the cultural bias that often exists beneath the surface of the country's entertainment industry.

The struggles of regional artists
The rapper's story highlights a larger

languages other than Yoruba or Pidgin

English, both widely spoken in Lagos and the South-West.

Many regional acts from the Southeast and other parts of the country often face silent resistance when they attempt to break into the mainstream music scene in Lagos. This, according to observers, is due to a deep-rooted preference for certain languages and styles.

Despite these challenges, Illbliss persevered. Today, he is one of Nigeria's most respected rappers, known for his lyrical depth and commitment to promoting Igbo identity through his music.

Turning pain into purpose Rather than allowing the experience to

derail his dreams, Illbliss used it as fuel to push forward. He continued creating music in his style, staying true to his roots and defying the odds.

His story has inspired many upcoming artists from minority ethnic groups who now see him as a symbol of resistance against tribal bias in the industry.

Over the years, Illbliss has built a loyal fan base, not just among Igbo listeners, but across Nigeria and beyond. His success, despite the early rejection, stands as proof that talent and authenticity can break boundaries.

A call for inclusiveness

Illbliss's experience has once again opened up conversations about the need for greater inclusion and respect for all Nigerian cultures within the entertainment space.

He believes music should unite, not divide.

"We must do better," he said. "Our diversity should be our strength, not our weakness."

As he continues to use his platform to speak out on social issues, Illbliss remains a powerful voice, not only in music but in the fight for cultural acceptance and national unity.

### Brazil: Eight killed as hot-air balloon catches fire and crashes By Elizabeth Jenrola Oso By Elizabeth Jenrola Oso



In Brazil, at least eight people have died and several others have been injured after a hot-air balloon carrying over 20 passengers caught fire mid-air and crashed in the southern state of Santa Catarina on Saturday morning.

The tragedy unfolded near the tourist town of Praia Grande, in a region famed for its dramatic canyons and dubbed the "Brazilian Cappadocia" due to its popularity with hot-air balloon enthusiasts. The balloon was one of approximately 30 that took flight around 7 a.m. local time.

Dramatic footage shared on social media captured the horrifying final moments of the multi-coloured balloon as it plunged from the sky in flames. Onlookers can be heard gasping in disbelief as passengers are seen falling from the burning basket. "My God!" one witness exclaims as the balloon descends rapidly.

Santa Catarina's governor, Jorginho Mello, confirmed the accident on X (formerly Twitter), stating: "There were 21 people on board, eight fatalities, 13 survivors." Some reports indicated the balloon may have been carrying as many as 22 people.

Brazil's eyewitness speaks

Eyewitnesses described scenes of panic and horror as passengers desperately attempted to escape the blaze. "When the balloon started to catch fire, people hurled themselves out," one witness told local newspaper Jornal Razão. "It was a desperate scene. Some threw themselves out [of the balloon], and others were trapped in the fire."

According to Jornal Razão, the balloon's pilot, who survived the crash, said the fire began inside the basket after a reserve torch ignited.

Upon noticing the flames, the pilot attempted an emergency descent and urged passengers to jump as the balloon neared the ground. While some were able to escape with injuries, others were not so fortunate.

"The atmosphere in the area of the tragedy is one of utter disaster," a reporter at the crash site wrote.

Emergency services responded quickly to the scene, and an investigation into the cause of the fire is underway. Authorities have not yet released the identities of the victims, and officials say a full inquiry will determine whether safety protocols were followed.

The crash has cast a shadow over one of Brazil's most scenic regions, popular with tourists for its breathtaking aerial views and natural beauty.

### Starmer defends activist linked to military aircraft sabotage By Fatimah Idera

he United Kingdom Prime Minister, Sir Keir Starmer, has defended an anti-war protester accused of attempting to sabotage US military aircraft by drawing renewed attention following a similar incident at an RAF base.

On Friday, pro-Palestinian activists allegedly gained access to RAF Brize Norton in Oxfordshire. In footage posted by Palestine Action, two individuals were seen on the base, with one appearing to spray paint into the engine of an Airbus Voyager air-to-air refuelling tanker.

The incident prompted the scrutiny of Sir Keir's legal record, particularly his role in a 2003 case involving anti-war activists who broke into RAF Fairford in Gloucestershire. The group, known as the Fairford Five, had attempted to disrupt the operations of US bombers scheduled to fly missions to Iraq.

At the time, Starmer was a prominent human rights barrister. He represented Josh Richards, who was found near a cut fence at the base in possession of a homemade incendiary mixture. Richards claimed he intended to damage aircraft to prevent what he believed were imminent war crimes.

Starmer argued that while the actions broke the law, they were morally justified in the context of trying to stop unlawful acts of war. "Even if the argument leads to anarchy," he reportedly told the court, "it should be heard." Richards was ultimately cleared after the jury failed to reach a verdict.

Parallels have been drawn between that case and Friday's protest at Brize Norton. Critics, including senior conservatives, seized on the revelation. Business Secretary Kemi Badenoch tweeted:

"Worth noting that Keir Starmer defended an activist who broke into an RAF base to set fire to aircraft. Starmer claimed his client was legally justified because it might stop a war crime. If



he'd won that argument in 2004, what happened at Brize Norton would be perfectly legal."

In response, Downing Street pointed to the legal profession's cab rank rule, which obliges barristers to accept any case within their area of competence. Labour also defended Starmer's record, citing remarks by Lord Wolfson, the shadow attorney general: "Don't judge a surgeon by their patients, a journalist by their interviewees or a lawyer by their clients."

The Fairford case led to six trials. Of the five accused, two were convicted of damaging US military equipment, two were acquitted, and Richards' trial resulted in no verdict.

Starmer argues...

At the time, Starmer also argued that courts should be allowed to examine the legality of the Iraq War, despite its backing by Parliament. He said the government's resolution in support of military action did not preclude legal challenges.

In contrast, Starmer today condemned the Brize Norton protest as disgraceful, stating: "Our Armed Forces represent the very best of Britain and put their lives on the line for us every day. It is our responsibility to support those who defend us."

This is not the first time Starmer has faced political criticism for cases taken during his legal career. In 2001, he defended the right of a protester to deface a US flag outside a Norfolk air base, calling flag burning "a form of protest activity renowned the world over."

He also previously secured the release of convicted arsonist Paul Stellato, who had terrorised a family after arguing his detention was unlawful. Stellato later received compensation and was ultimately jailed for life in 2018 after attempting to purchase hand grenades.

A Conservative Party spokesperson commented:

"There is a reason our PM was chosen to represent people who think nothing of setting fire to RAF jets — as a lawyer, he made a career out of representing these sorts of criminals and anti-British activists. Starmer can act like a statesman now, but we all know that deep down he's still the Leftie liberal."

### Trump to get nomination for Nobel Peace Prize from Pakistan amid mixed reactions By Elizabeth Jenrola Oso By Elizabeth Jenrola Oso



Pakistan has announced plans to recommend U.S. President Donald Trump for the Nobel Peace Prize, citing his role in deescalating a recent armed conflict between nuclear rivals India and Pakistan.

The announcement, made Saturday, praised the U.S president for his "strategic foresight and stellar statesmanship," with Pakistani officials crediting his diplomatic intervention for halting a four-day exchange of hostilities earlier this year. A government statement called the ceasefire a "testament to his role as a genuine peacemaker."

While heads of state and governments are eligible to nominate individuals for the Nobel Peace Prize, there has been no immediate reaction from the White House or the U.S president himself. India, however, rejected the notion of third-party mediation, insisting that the ceasefire was reached independently between its military and Pakistan's.

Indian Foreign Secretary speaks to Trump

India's foreign secretary, Vikram Misri, said Prime Minister Narendra Modi had made it "absolutely clear" to the 79-year-old president during a recent phone call that no external actor was involved in the ceasefire agreement. "Hostilities ceased only after Pakistan requested it," he added.

Trump, meanwhile, has been vocal about his global peacemaking efforts. In a social media post Friday, he listed a series of international conflicts he claims to have helped resolve, including India and Pakistan, the Abraham Accords between Israel and several Muslim-majority countries, and more recently, tensions between Russia and Ukraine. "No, I won't get a Nobel Peace Prize no matter what I do... but the people know, and that's all that matters to me," he wrote.

The announcement of Pakistan's nomination comes shortly after a historic lunch meeting between Trump and Pakistan's army chief, Field

Marshal Asim Munir, marking the first White House invitation extended to a top Pakistani military leader under a civilian government in Islamabad.

Some Pakistani officials defended the decision to back Trump for the prestigious prize. "Trump is good for Pakistan," said Mushahid Hussain, a former chair of the Senate Defence Committee. "If this panders to Trump's ego, so be it. All the European leaders have been sucking up to him big time."

But the move has drawn sharp criticism from within Pakistan, especially given Trump's vocal support for Israel's military campaign in Gaza and his hardline stance on Iran.

"Israel's sugar daddy in Gaza and cheerleader of its attacks on Iran isn't a candidate for any prize," said Talat Hussain, a prominent Pakistani political commentator, on X.

The Nobel Committee has not yet commented on Pakistan's proposed nomination.

### MoD hit by record surge in lost security passes By Fatimah Idera



inistry of Defence staff have lost a record number of security passes, with more than 15,000 reported missing over the past five years and a further 1,000 recorded as stolen, newly released figures reveal.

80 security passes go missing every week On average, nearly 80 security passes go missing every week, prompting security experts to warn of potential risks if the passes were to fall into the wrong hands. The revelations come just days after pro-Palestinian activists infiltrated RAF Brize Norton and damaged two military aircraft, reigniting concerns about security at defence sites.

Figures obtained through Freedom of Information requests show the number of lost passes has nearly doubled in four years, rising from 2,043 in 2020 to more than 3,830 in 2024. Over the same period, the number of stolen passes tripled from 82 to 278. While there was a drop in lost passes during the pandemic, the total surged again as staff returned to offices.

The missing passes grant access to secure areas within key defence buildings. Although MoD procedures require all lost

or stolen passes to be reported and deactivated, experts warn that the sheer volume indicates broader issues in internal security culture.

"This highlights a worrying lack of responsibility," said Col Philip Ingram, a former army intelligence officer. "There should be consequences when passes are lost. If staff are careless with this, what else might they be misplacing?"

John O'Connell of the TaxPayers' Alliance called the situation "ludicrous," adding: "These are people in the very department meant to keep Britain safe."

Admiral Lord West of Spithead, a former First Sea Lord, has previously warned that lost security passes present not just a security risk, but a potential terrorism risk. "It's not something that should be taken lightly," he said.

To reduce risks, many organisations have shifted to "exchange badging," a system where staff carry a blank, unmarked card outside of secure locations, which is then swapped for a named access pass once inside. Security experts say this limits exposure if the outer card is lost.

The incident at RAF Brize Norton on Friday, in which Palestine Action activists breached the perimeter and sprayed paint into the engines of two Airbus Voyager refuelling aircraft, has intensified scrutiny of MoD site security. The breach has led to calls from political figures, including Nigel Farage and Shadow Home Secretary Robert Jenrick to have Palestine Action designated a terrorist organisation.

A Ministry of Defence spokesperson said: "We treat all breaches of security very seriously. Every incident is subjected to a risk assessment, and proportionate action is taken accordingly."

The issue follows past high-profile lapses, including a 2021 breach in which sensitive MoD documents were found at a bus stop in Kent.

As public and political pressure mounts, the MoD is likely to face calls for tighter internal controls, greater accountability, and enhanced training for staff handling secure materials.

### Labour voters say immigration puts most pressure on NHS By Fatimah Idera



mmigration is now seen as the biggest burden on the NHS by Labour voters, according to a new poll, highlighting growing dissatisfaction within the party's support base.

A survey of 2,000 people who backed Labour in the 2024 general election found that 24% believe high levels of immigration are putting the greatest strain on the health service and more than those who cited the ageing population or the mental health crisis. The poll, conducted by Merlin Strategy on behalf of the Adam Smith Institute, found 22% blamed mental health pressures, 13% pointed to a lack of social care, 12% cited junk food and obesity, and 10% blamed vaping.

The results come amid growing concern inside Labour ranks over the Government's handling of immigration and healthcare. Sir Keir Starmer acknowledged in a major speech last month that years of record net migration have stretched public

services, including the NHS.

The poll also revealed increasing voter discontent: one in five Labour voters said they would now consider switching to Reform UK, while 28% said they regret voting Labour at all. Reform, led by Nigel Farage, has surged in the polls with promises to crack down on illegal Channel crossings and freeze most forms of migration.

Maxwell Marlow, Director of Public Affairs at the Adam Smith Institute, said: "The British public clearly feels the effects of mass immigration on healthcare. If the Government doesn't act quickly perhaps by requiring migrants to purchase private health cover for most visas voter dissatisfaction will only grow."

Further research from Merlin Strategy, including a focus group in Runcorn and Helsby formerly a safe Labour seat lost to Reform by just six votes in a recent by-election suggested a broader frustration with

Starmer's leadership. Participants described the Government as "afraid of upsetting people, I don't think they give a toss about us."

Only 51% of Labour voters felt the Government was addressing issues that mattered to them, and just 40% said they approved of Nigel Farage though 41% still disapproved.

Scarlett Maguire, Director of Merlin Strategy, noted: "Labour voters are clear: they want meaningful action on healthcare, immigration, and the cost of living. The Government needs to show it understands these priorities."

Some voters also criticised Starmer's focus on banning disposable vapes and phasing out smoking, questioning the relevance of such measures. One participant asked: "How is that really relatable to the working person? It just feels like something shiny for the media."

#### Universal DNA screening planned for all newborns on the NHS By Fatimah Idera

very baby born in the UK will have their entire DNA mapped ✓under a revolutionary NHS programme aimed at predicting and preventing disease before symptoms even appear.

Health Secretary Wes Streeting unveiled the initiative as part of a wider 10-year health plan expected to launch in early July. At the heart of the strategy is a shift away from treating illness after it arises, toward using cutting-edge genomic science and digital technology to prevent disease entirely.

Within a decade, every newborn in the UK will undergo whole genome sequencing, a process that decodes the complete genetic makeup of a person. This will allow healthcare professionals to assess a child's risk of developing hundreds of diseases, enabling earlier, more personalised interventions.

Mr Streeting described the plan as "a revolution in medical science" that could allow the NHS to leapfrog deadly diseases, from cancer to Alzheimer's, by catching them before they start.

"Our 10-year plan will build on the founding promise of the NHS, so that it provides care free at the point of risk, not just risk," he said.

"With this new technology, patients will receive personalised care to stop illnesses before symptoms begin, relieving pressure on NHS services and helping people live longer, healthier lives."

Currently, newborns undergo a heelprick blood test for nine rare but serious conditions. Under the new system, DNA sequencing will vastly expand this scope. Rather than blanket screening or general health MOTs in later life, people will increasingly receive personalised health checks and targeted treatments.

The strategy will also reduce adverse drug reactions by tailoring prescriptions based on an individual's genetic profile.



Over time, medications may be offered preventively, transforming how treatment is delivered.

Health officials say the approach will change the NHS from a reactive to a proactive service, forecasting risks and intervening early rather than responding to illness after it takes hold.

The government has pledged £650 million to accelerate genomics research as part of its wider life sciences strategy. The NHS's £29 billion annual funding boost will also support major changes in service delivery of Expanding virtual hospitals and remote consultations via an Uber-style app, Using smartwatches and wearable tech to monitor patients in real-time, creating neighbourhood health teams that bring services closer to communities, Greater involvement of private providers to deliver local care.

Mr Streeting also cited Japan's efforts to merge genomics with AI to provide personalised health assessments as inspiration for the UK's plan. While the rollout is widely supported by scientists, patient groups, and charities, it is not without controversy. Ethical concerns are growing over the psychological burden of knowing one's future disease

risk from birth.

For instance, genome sequencing could reveal if a child carries the BRCA1 gene, which significantly increases the likelihood of developing breast cancer, information that could shape decisions decades later.

There are also data protection worries. All DNA records will be stored in the National Genomic Research Library, with strict encryption and security protocols. However, the sensitivity and commercial value of this information make it a target. In 2023, genetic testing company 23 and Me was fined £2.31 million after failing to prevent a largescale cyberattack that compromised UK user data.

Despite the risks, NHS leaders believe the benefits far outweigh the concerns. The upcoming health plan is expected to formalise the shift to genomics, digital health, and preventive care as the core of future NHS services.

As Mr Streeting put it: "Much of what's done in a hospital today will be done on the high street, over the phone, or through an app in a decade."

# UK court to hear Shell oil spill case from Nigerian communities in 2027

wo Nigerian communities, Bille and Ogale, are set to take oil giant Shell and its Nigerian-based subsidiary, now known as Renaissance Africa Energy Company, to trial in the UK High Court in 2027 over long-standing oil pollution claims.

With a combined population of about 50,000, the Niger Delta communities accuse Shell of causing extensive environmental damage through systemic and ongoing oil spills that have polluted their land and drinking water for years. The legal action, which began in 2015, seeks compensation and a full-scale clean-up of the affected areas.

In a ruling on Friday, Mrs Justice May addressed over 20 preliminary issues after a four-week hearing held in London earlier this year. She revealed that approximately 85 oil spills have so far been identified, but emphasised that the case remains "at a very early stage."

Shell may be held held for spills resulting from third-party interference

Crucially, the judge found that Shell could be held liable for spills resulting from third-party interference, such as pipeline vandalism and oil theft, known locally as "bunkering." She also ruled that while legal claims typically face a five-year statute of limitations, a new legal claim arises



each day oil remains on contaminated land.

The full trial is scheduled to begin in March 2027 and is expected to last four months.

Reacting to the ruling, King Bebe Okpabi, leader of the Ogale community, expressed cautious optimism. "It has been 10 years now since we started this case. We hope that now Shell will stop these shenanigans and sit down with us to sort this out. People in Ogale are dying; Shell needs to bring a remedy. We thank the judicial system of the UK for this judgment."

Shell also responded to the judgment, maintaining its stance that it should not be held responsible for damage caused by illegal activities. A company spokesperson

stated:

"For many years, the vast majority of spills in the Niger Delta have been caused by third parties acting unlawfully, such as oil thieves who drill holes in pipelines or saboteurs. This criminality is the cause of the majority of spills in the Bille and Ogale claims, and we maintain that Shell is not liable."

The spokesperson added that the spills were managed by a joint venture, previously operated by Shell's former subsidiary, using its "expertise in spill response and clean-up."

The landmark case is one of the most significant environmental legal battles involving a multinational company and could set a precedent for corporate accountability in the global oil industry.

#### Tobi Amusan hits season's best at Paris Diamond League By New Daily Prime



orld record holder, Tobi Amusan, produced a fantastic performance at the 2025 Diamond League in Paris, clocking a season's best time of 12.24 seconds to finish in second place in the women's 100m hurdles.

The time marks her second-fastest ever, behind only her world record of 12.12 seconds posted in 2022.

Amusan came storming through the final metres, closing rapidly on Grace Stark of the United States, who had burst out of the blocks with intent and held on to win with a personal best and meeting record of 12.21 seconds—a time that makes her the fifth-fastest woman ever over the 100m hurdles.

Jamaica's Ackera Nugent finished third in a quick 12.30 seconds.

This performance represents the latest milestone in a steady and impressive resurgence for the Nigerian throughout the season.

Amusan's campaign began modestly with a fourth-place finish in Xiamen, China, followed by another fourth in Shaoxing, also in China.

However, the 28-year-old bounced back emphatically with a seasonbest and meet record 12.45 seconds to claim her first Diamond League win of the year in Rabat, Morocco, in May.

Paris marked her fourth Diamond League outing of the season as she continues to build form and consistency ahead of major championships.

The 2022 world champion faced an

elite field in the French capital, including world medallist Keni Harrison, rising Jamaican star Nugent, Poland's Pia Skrzyszowska, Dutch champion Nadine Visser, Devynne Charlton of the Bahamas, and current Diamond League leader Stark.

Despite the depth of competition, Amusan's upward trajectory in form and her experience at the top level saw her challenge strongly for maximum points as the race to qualify for the Diamond League finals in Zurich intensifies.

Her consistent performances currently place her fourth in the Diamond League standings with 10 points, behind leaders Stark (23), Danielle Williams (15), and Marione Fourie (12) in the overall standings.

### Ill Mbappe out of second Real Madrid Club World Cup clash By New Daily Prime By New Daily Prime



Il Real Madrid striker Kylian Mbappe did not travel to Charlotte for the team's Club World Cup match against Pachuca, but could be back for the final group stage game, coach Xabi Alonso said on Saturday.

The French superstar was taken to hospital on Thursday for tests and treatment after suffering gastroenteritis, before later being released.

Mbappe is improving "bit by bit" a club source told AFP, but he did not fly with his teammates for Sunday's match against Mexican side Pachuca.

Real coach Xabi Alonso addressed the striker's condition

during his pre-match press conference.

"He's doing better, he's back from the hospital and is recovering. We're optimistic about having him against Salzburg," he said.

Madrid face Salzburg in the final game of Group H on Thursday in Philadelphia.

The 26-year-old missed the opening game with the same illness as Madrid were held 1-1 by Al-Hilal in Xabi Alonso's debut as coach.

Madrid B-team player Gonzalo Garcia, 21, started in Mbappe's stead and opened the scoring for Real Madrid against their Saudi

Arabian opponents.

Alonso indicated that Gonzalo would again deputise for the Frenchman.

"Gonzalo can do what he did the other day. He scored a goal and had three chances. Looking ahead, we'll see what happens. Having players with that sense of smell is very important. He did very well," he said.

Mbappe finished as the European Golden Shoe winner in his first season at Real Madrid with 31 goals in LaLiga and 43 across all competitions, but Los Blancos finished the season without a major trophy.
