## Court forfeits \$2.04m, properties, shares linked to Emefiele

he Federal High Court sitting in Lagos on Friday ordered the final forfeiture of the sum of \$2.045 m, seven choice landed properties and share certificates linked to the former governor of the Central Bank of Nigeria, Godwin Emefiele.

Justice Deinde Dipeolu ordered the permanent forfeiture of the monies and the two share certificates of Queensdorf Global Fund Limited Trust, after holding that the former CBN governor or any other interested party did not contest same after the initial interim forfeiture.

The court also forfeited the seven choice landed properties on the ground that the former CBN Governor, Emefiele, was not able to connect his lawful earnings from Zenith Bank and the Central Bank of Nigeria (CBN) to the acquisition of the properties.

The court held that the former CBN Governor failed to provide documents or links to show that he owned the properties.

Emefiele had denied any connection between him and the companies in whose names the properties were purchased and the companies had also failed to appear before the court to claim the properties. The EFCC had listed the companies as; Amrash Ventures Limited, Modern Hotels Limited, Finebury Properties Limited, Fidelity Express Services Limited, H & Y Business Global Limited and SDEM Erectors Nigeria Limited.

Justice Dipeolu held, "the conclusion that can be deduced is that there must be something dark about the acquisition of the properties which Emefiele and the companies does not want to come to light."

The judge further held "that the interested party has failed to demonstrate any lawful interest in the properties and that they were acquired from his legitimate earnings.

"I therefore order the final forfeiture to the Federal Government of Nigeria of all those properties...which are reasonably suspected to have been acquired with proceeds of unlawful activities."

The properties are: two fully detached duplexes of identical structures, lying being and situated at No. 17b Hakeem Odumosu Street, Lekki Phase 1, Lagos; an undeveloped land, measuring 1919.592sqm with Survey Plan No. DS/LS/340 at Oyinkan Abayomi Drive (Formerly Queens Drive), Ikoyi, Lagos; a bungalow at No. 65a Oyinkan Abayomi Drive, (Formerly Queens Drive), Ikoyi,

and a four-bedroom duplex at 12a Probyn Road, Ikoyi.

Others are an industrial complex under construction on 22 plots of land in Agbor, Delta State; 8 units of an undetached apartment on a plot measuring 2457.60sqm at No. 8a Adekunle Lawal Road, Ikoyi, and a full duplex together with all its appurtenances on a plot of land measuring 2217.87sqm at 2a Bank Road, Ikoyi, Lagos.

On August 15, 2024, the court had a uthorised the EFCC to temporarily take custody of the cash sum of \$2.045 million, seven choice landed properties and shares linked to Emefiele after hearing an Exparte application filed by lead counsel to the Commission, Rotimi Oyedepo (SAN).

The court's ruling followed EFCC assertion that the money and other items sought to be forfeited were reasonably suspected to be proceeds of unlawful activities.

However, counsel to Emefiele, Senior Advocate of Nigeria, Olalekan Ojo had urged the court to stay proceedings and not grant the final forfeiture of the properties.

### #EndBadGovernance protest: Court grants N10m bail each to 67 minors

Justice Obiora Egwuatu of the Federal High Court, Abuja has granted bail to about 67 minors to the tune of N10m each out of the 76 that were arraigned for participating in the August 2024 End Bad Governance protests.

Those granted bail, who are below 15 years, are expected to present one surety who must be a civil servant.

## NLC threatens strike over ruling on Rivers' allocation

he Rivers State chapter of the Nigeria Labour Congress (NLC) has threatened to withdraw services of its members over the court order stopping disbursement of financial allocations to the state.

A federal high court in Abuja, on Wednesday, restrained the Central Bank of Nigeria (CBN) from further disbursing financial allocations to the Rivers State government.

The court held that monies from the federation account should not be released to the state pending the passage of a lawful appropriation act by a validly constituted house of assembly.

Condemning the judgement, Rivers State NLC chairman, Alex Agwanwo, told journalists after an emergency meeting with labour leaders in the state, that the judge did not take the citizens and workers of Rivers State into consideration before issuing the ruling.



He said, "Everybody knows that taking allocation away from a state will put the state into suffering. It will disrupt governance in a state because governance will not take place without funds.

"It will affect the workers in the state and at the local government levels. Even the private sector doing business in the state will also be affected.

"For us as a state council, we will not sit down and watch, so we are calling on the judges that, going forward, they should put the masses into consideration.

"There is no politician in the state that does not have a sister or brother working in the state. If they seize the allocation, are you going to be paying them?

#### 76 Malnourished #EndBadGovernance protesters arraigned

h e d e t a i n e d 7 6 #EndBadGovernance protesters just arrived at the Federal High Court in Abuja for their scheduled arraignment before Justice Obiora Egwuatu.

The protesters, mainly minors, looked malnourished as four of them were hurriedly rushed out of the courtroom as they couldn't stand on their feet.

Looking very sickly, they wriggled in pain in a screeching sound.

They were arrested and detained during the nationwide August 1 to 10 protests which were sparked by widespread economic hardship that led many Nigerians to take to the streets to express their grievances.

The 76 protesters, who were arrested in Abuja, Kaduna, Gombe, Jos, Katsina, and Kano states, are being accused of treason, among other offences.

The protesters include Nura Ibrahim, 24; Abdulbasi Abdusalami, 34; Ahmed Yusuf, 25; Awolu Abdulahi, 21; Umar Musa, 15; Muhammadu Mustapha, 16; among others.

## Tunji-Ojo charges NIS officers to remain committed to service, innovative By Friday Omosola

Interior Minister Olubunmi Tunji-Ojo has urged officers of the Nigeria Immigration Service (NIS) to remain dedicated to their duties and adopt innovative approaches to address emerging challenges.

## We saw hell in DSS hands -#EndBadGovernance protester By Dave Oludare Oso

ne of the participants of the August #EndBadGovernance nationwide protests has rendered a harrowing narration of how operatives of the Department of State Services (DSS) arrested him in Kano, detained and

tortured him for over 60 days.

Khalid Aminu, an engineer by profession, said he was picked up alongside other young demonstrators protesting hunger and bad governance in early August.

Aminu said he was subjected to all forms of dehumanizing torture while in custody and he had no contact with his family for the period of his incarceration at the Kano office of the DSS.

He was a guest on Inside Sources with Laolu Akande, a socio-political programme aired on Channels Television on Friday.

Describing his plight in the hands of the secret police as a "terrible" experience that he won't wish to remember, he said, "They (DSS operatives) blocked all of us at the NEPA Roundabout and packed about 11 of us on the day three of the protests (August 3) and took us to their command."

His face still plastered with after-trauma of the episode, signs that he is still recovering from the "terrible" ordeal in the hands of the secret police, he continued, "They kept me in detention from August 3 to October 17. For the 68 days, I was in the custody of the DSS minus one week when we were taken to the correctional centre after we were taken to court in Kaduna.

He said, "When we were in detention, they kept bringing in more and more people and the number accumulated to about 39 of us.

"What I went through, what we went through was inhuman, I can't even begin to tell you everything.



"On the 3rd (of August), they arrested us at NEPA Roundabout. There and then they started beating us. Boots, kicks, and all that. Then they pushed all of us into their Hilux, some into their SUVs, and then we went down to the Command.

"When we got there, the first thing I received was a strong cane, like an armoured cable that they used. If I pull up my chest, you will see. They started beating me, I was flat down and they were blasting me with all forms of sticks, armoured cables, everything you can think of.

"Then they took me to a garden with a sharp grass carpet. They asked us to pull our shirts and asked us to lie down. They poured water on me while I lay on this sharp grass. They were beating me and told me to roll from one side to another. I rolled from one end to another with water on my body. All sorts of insects were on this grass. So, it was double punishment. It was terrible. That continued for about an hour.

"Then they asked us to crawl in a gutter and we came out and they asked us to be looking into the sun. we were there for another hour. It became different type of torture after that day. From what you eat, psychologically, you cannot be stable."

Aminu and his co-detainees were accused of unlawful assembly and for flying Russian flags but the #EndBadGovernance campaigner denied the allegation.

"There was nothing like the Russian flag in the first five days of the protests when we were arrested," he said.

Also, on the programme, Aminu's lawyer, Ibrahim Wali, said there was no justification for arresting the protesters in the first place because the constitution clearly states that if you arrest someone, you should charge them to court after 48 hours.

"The Administration of Criminal Justice Act goes further to say that when you need to remand further, you can apply for an order to remand further for 14 days but there was no remand order," he said.

"They arraigned them in court on October 10 and they pleaded not guilty and they were now sent to the correctional centre," the lawyer said, adding that the claim by the DSS that the protesters gathered unlawfully was not tenable.

"It is the duty of the police to curb riots during protests and the police failed in this duty but they tried to transfer the responsibility to the protesters."

The police in a statement from the FCT command, which is spearheading the prosecution, condemned VeryDarkMan in the recently released video, where he described himself as CSP VeryDarkMan and Nigeria's "number one online police officer.'

According to the release, the Police say the force place a high premium on maintaining the integrity of its uniforms and preventing unauthorized usage.

The NPF's statement read, "Martins Otse is set to appear in court today following allegations of impersonation related to the unauthorised use of Nigeria Police Force uniforms in a viral social media

"The FCT Police Command is actively handling the case, underscoring the Nigeria Police Force's commitment to upholding the integrity of its symbols and preventing their misuse.

"Interested persons are encouraged to follow up on the proceedings as the case unfolds."

Meanwhile, VeryDarkMan was detained by police on Thursday after responding to an official summons.

Although VDM's offence was not spelt out, his lawyer, Deji Adeyanju, said he was detained in a post on X on Thursday.

#### We won't revoke licence of Oyedepo church's airstrip - Keyamo By Dave Oludare Oso

he Minister of Aviation and Aerospace Development, Festus Keyamo, has said the House of Representatives did not ask him to revoke the airstrip licence for Oyedepo's Living Faith Church or those of other private individuals.

The minister said this in a statement via his official X handle on Friday.

There were reports that the House of Representatives asked the Ministry of Aviation and Aerospace Development to halt the issuance of airstrip licences to private individuals and organizations and to revoke existing licences, including those granted to Living Faith Church, as a measure to safeguard national security.

Reacting to the report, the minister said it was incorrect, saying a motion was moved in the House in that regard and it was unanimously referred to the Aviation Committee to look into it.

According to him, while the intention of the Honourable member who moved the motion was very patriotic, it was based on a complete lack of knowledge of the aviation sector.

The minister said, "By the time we explain to them how private air strips work and the processes they undergo by our agencies before the final approval, they will be satisfied.

"The responsibility of the owners of private air strips is just to build the runway and terminal building. But after they built the control tower in particular, it is completely handed over to the Federal Government through NAMA (Nigerian Airspace Management Agency) which is in complete control of the entire airspace in Nigeria. An MOU is usually signed with NAMA in this regard before the airstrip is approved for operations.

"It is NAMA that provides the Air Traffic Controllers and Engineers in all airports and airstrip in Nigeria. And the private's air strip owners pay the Federal Government handsomely for these services.

"No object flies into Nigeria without the prior clearance by

NAMA and without filing a clear flight plan like where it is taking off from and where it intends to land," he said.

## EFCC transfers Bobrisky to Abuja for interrogation

ontroversial social media personality and crossdresser Idris Okuneye, popularly known as Bobrisky, has been re-arrested and transferred to Abuja for questioning related to allegations of bribery and corruption.

The Economic and Financial Crimes Commission (EFCC) announced that he would be flown to the capital on Friday, November 1.

Bobrisky was detained late Thursday, October 31, night at Murtala Muhammed International Airport in Lagos while attempting to board a KLM flight to Amsterdam, ultimately bound for London.

Reports indicate he was stopped by immigration officers, leading to his subsequent arrest.

The social media star took to Instagram to share his distress, claiming he sustained injuries during the altercation with the officers and alleging that the EFCC was behind his detention.

"Nigerians help me, EFCC just arrested me. I'm badly injured," he wrote.



Sources within the EFCC have indicated that Bobrisky's arrest stems from his failure to respond to multiple invitations from the commission.

This follows accusations made by Bobrisky, captured in a voice note shared by social critic Martins Otse, also known as VeryDarkMan, where he allegedly claimed to have bribed EFCC officials with N15 million to drop money laundering charges against him.

While the EFCC has denied these allegations, they have established a committee to investigate the matter.

During a press briefing on Thursday, October 31, Wilson Uwajaren, Director of Public Affairs for the EFCC, suggested that Bobrisky could face additional charges if his allegations against the commission were found to be unfounded.

Uwajaren stated, "One could be charged for giving false information to the EFCC, let alone making false allegations against the commission." A senior EFCC source revealed that the decision to arrest Bobrisky was necessary to address the serious nature of his claims.

"We have arrested him in Lagos today and will be flown to Abuja today. He accused us of bribery and corruption; we invited him severally, but he did not show up. He who alleges must be ready to prove. Those allegations are too weighty to allow slide," the source explained.

When reached for comment, Dele Oyewale, the EFCC's Head of Media and Publicity, confirmed Bobrisky's transfer, stating, "Bobrisky is on his way to Abuja as we speak."

The ongoing situation continues to draw significant public interest, with many awaiting further developments as the EFCC investigates both the allegations against its officials and Bobrisky's claims.

## Oyo Assembly suspends LG chairman over viral video

hairman of Oyo East Local Government, Olusola Oluokun, has been suspended by Oyo State House of Assembly over a viral video that sparked controversy.

Oluokun was suspended on Thursday after the presentation of a Matter of Urgent Public Importance titled: "Urgent call for full investigation into the indecent attitude of the Chairman, Oyo East Local Government, Mr. Olusola Oluokun, in a viral video online."

The controversial video showed Oluokun eating half-clad and praising a political stalwart, who helped him to become chairman.

The chairman also allegedly rained curses on those perceived as enemies of his benefactor.

Oluokun's actions in the video were deemed unbecoming of an elected local government chairman.

The house, however, set up a committee to investigate the matter, pending which the vice chairman will act as chairman.

The lawmakers condemned the act, describing it as unbecoming of an elected council boss.

The Assembly Speaker, Adebo Ogundoyin said they would not condone such indecent behaviour, adding that the swift action taken by the assembly demonstrated its commitment to maintaining the integrity and dignity of public office.

## Food Security: Shettima urges diversification from crop production to livestock, fishery, others

Shettima has urged the Presidential Food Systems Coordinating Unit (PFSCU) to deliver concrete results in the drive for food security in Nigeria, stressing that Nigerians expect action, not just rhetoric.

He highlighted that while many presidential initiatives have been launched, effective implementation remains a challenge.

Shettima noted that the PFSCU is uniquely positioned to transform Nigeria's food security challenges into real progress.

In a statement by his spokesperson, Stanley Nkwocha, Shettima issued this directive on Thursday during the PFSCU's second meeting, which was convened as part of President Bola Tinubu's administration's efforts to combat hunger and alleviate hardship in Nigeria.

In July, the Vice President inaugurated the PFSCU under the Presidential Economic Coordinating Council after presenting a proposal to President Tinubu to establish a food systems council addressing food insecurity.

During this second meeting, which included representatives from states, development partners, and other key stakeholders, Shettima urged the PFSCU to broaden its focus beyond rural farming by introducing urban agriculture, modelled on systems in advanced countries like Cuba.

He said, "We have to walk the talk. I will be in Calabar, and we will go to northern Cross River to flag off the wet season farming. Nigerians want to see what we are doing. And Hon. Minister, I want you to robustly engage the private sector. I want the Hon. Minister of Agriculture to drive the process.



"So, let's walk the talk. This presidential initiative is a very beautiful one, but we have had a lot of presidential initiatives from time immemorial. It's the implementation that counts, and we are in a unique position to catalyse our challenges into progress."

VShettima expressed optimism that the Presidential Food Security Coordination Unit (PFSCU) would strengthen food security across Nigeria, highlighting that the unit comprises prominent private-sector leaders whose expertise and connections could drive impactful change.

He urged the PFSCU to expand its focus beyond crop production to include areas like livestock and fisheries, noting the importance of these sectors, especially in the South-South and South-East regions.

Shettima also tasked Finance Minister and Coordinating Minister of the Economy, Wale Edun, with devising solutions to improve loan access through credit guarantee schemes, underscoring the need for financial support across the agricultural sector, including for large-scale producers.

During the meeting, several governors echoed the call for a comprehensive shift in food security strategy, stressing the need for stronger collaboration between federal and state levels.

Borno State Governor Babagana Zulum emphasized the importance of food quality, noting that 'food security isn't just about quantity but also quality,' and cited fisheries and livestock as essential but often overlooked areas in agricultural policy.

He called for closer synergy between federal initiatives and state-level capacities.

Cross River State Governor Bassey Otu shared his state's ambitious vision, pledging to make Cross River a leading food supplier within two years.

Ekiti State Governor Biodun Oyebanji emphasised the urgency of immediate action in agriculture, highlighting the sector's timesensitive nature and advocating for enhanced engagement with stakeholders to accelerate implementation.

Ebonyi State Governor Francis Nwifuru advocated for a practical approach to agricultural development, suggesting that leaders' visible involvement in farming could inspire youth participation, as 'agriculture needs practical demonstration, not just talk.'

Finance Minister Wale Edun affirmed the need for better support mechanisms, particularly through credit guarantee schemes, to aid farmers and agricultural stakeholders.

## Food Security: Shettima urges diversification from crop production to livestock, fishery, others

ice President Kashim Shettima announced that the National Economic Council (NEC) is set to implement measures to accelerate the decentralization of Nigeria's national grid.

Speaking during the 145th NEC meeting held on Thursday at the Presidential Villa in Abuja, Shettima emphasised that these steps are necessary to prevent frequent grid collapses, which have left certain northern states in total darkness.

As NEC Chairman, he stressed that the government's commitment to accountability necessitates a proactive response to these persistent energy challenges.

Shettima outlined specific actions to support grid decentralization, including establishing mini-grids and expanding the use of renewable energy sources such as solar photovoltaic systems and wind turbines.

He highlighted the urgency of implementing the Nigeria Energy Sector Implementation Plan (NESIP), noting that the energy sector must harness the potential of renewables and deploy solar and mini-grid solutions tailored to regional electricity needs.

"A robust economy is the backbone of every nation. The recent blackouts caused by the actions of vandals remind us of our urgent need to expand our energy infrastructure. I believe the governors here would agree that the decentralisation of electricity is our path forward.

"We will continue to promote the constitutional framework that empowers constituent states within the Nigerian federation to generate, transmit, and distribute electricity in areas covered by the national grid. Together, we can make instability a relic of the past.



"Furthermore, our energy sector must embrace the potential of renewable energy. We must leverage solar and mini-grid solutions tailored to regional needs. I urge the Council to support the implementation of the Nigeria Energy Sector Implementation Plan (NESIP).

"If we capitalise on our diverse regional energy resources—from northern Nigeria's solar potential to the south's gas reserves—we can build a resilient, decentralised energy system that drives growth and empowers our communities."

The Vice President highlighted that the tax reforms introduced under President Bola Tinubu's Renewed Hope Administration aim to diversify the nation's revenue sources, promote economic stability, and reduce reliance on specific sectors.

"I must admit that the tax reforms initiated at the onset of this administration by His Excellency, President Bola Tinubu, have opened avenues to address stakeholders' concerns, particularly regarding VAT reform and its implications for sub-national revenues.

"As representatives of diverse interests, I do not doubt that you share a common aspiration: to broaden our revenue base, foster economic stability, and diminish our dependency on specific sectors," he noted.

Shettima, addressing Nigeria's low ranking on the Human Capital Index, described it as a critical challenge that demands urgent attention.

"We are confronted with alarming statistics regarding life expectancy, maternal and child mortality, and educational attainment. Today's gathering seeks to transform this grim reality through a series of deliberations and sector-specific recommendations, led by experts from both government and our development partners," he said.

The Vice President also highlighted the progress made toward mitigating flood disasters, emphasising that 'recent months have tested the effectiveness of the solutions' aimed at strengthening flood resilience.

"Although many regions were caught unprepared by the floods, our proactive mitigation efforts have led to sustainable strategies to address the widespread damage, including significant property loss and health risks," he stated.

He commended the Honourable Minister of Water Resources and the Director-General of the National Emergency Management Agency (NEMA) for their foresight and swift response.

FG, Morocco, ECOWAS drive \$26bn African gas

he Federal Government of Nigeria, in collaboration with the Economic Community of West African States (ECOWAS), Morocco, and Mauritania, has reaffirmed its commitment to advancing the African Atlantic Gas Pipeline (AAGP) project, a transformative initiative estimated to cost \$26 billion.

This announcement was made during the ECOWAS Inter-Ministerial Meeting of the Nigeria-Morocco Gas Pipeline Project held on Friday, November 1 in Abuja.

The meeting, attended by Ministers of Hydrocarbons and Energy from ECOWAS member states, focused on advancing the AAGP, which aims to connect at least 13 countries. enhancing economic growth across the region.

The project was initially conceived during King Mohammed VI of Morocco's visit to Nigeria in December 2016.

The AAGP will merge two significant pipeline projects: the \$975 million West African Gas Pipeline Extension, which will extend 678 kilometers, and the 5,669-kilometer Nigeria-Morocco Gas Pipeline, projected to cost around \$25 billion.

The initiative seeks to monetize Nigeria's abundant natural gas resources, generate additional revenue, diversify gas export routes, and eliminate gas flaring.

Furthermore, it aims to supply gas to Morocco, 13 ECOWAS countries, and Europe, thereby fostering regional economic integration.

The total pipeline length will stretch 5,300 kilometers from Nigeria to Dakhla, Morocco, and an additional 1,700 kilometers will connect Dakhla to Northern Morocco.



During the meeting, Mele Kyari, Group Chief Executive Officer of the Nigerian National Petroleum Company Limited (NNPCL), emphasised the significance of the decisions to be made, which will shape the future of the African Atlantic gas project. Represented by Olalekan Ogunleye, NNPCL's Executive Vice President for Gas Power & New Energy, Kyari highlighted the project's potential for shared prosperity among participating nations.

ECOWAS Commissioner for Infrastructure, Energy, and Digitalisation, Sediko Douka, highlighted the importance of collaboration among all parties involved.

## **NAFDAC** raises alarm over fake condoms in circulation

he National Agency for Food and Drug Administration and Control (NAFDAC) has alerted Nigerians to the illegal sale and distribution of an unregistered condom brand in the country.

In a statement issued Thursday, NAFDAC reported that officials from the Post-Marketing Surveillance Directorate recently identified Foula condoms (packaged in sets of three) being sold in Abakaliki, Ebonyi State, and Zango, Katsina State.

The agency highlighted that this condom brand is neither registered with NAFDAC nor labelled in English, raising concerns about its compliance with national safety standards.

"Condoms are a proven effective barrier method that can be used as a dualpurpose method for both prevention of unintended pregnancy and protection against HIV and other sexually transmitted infections. To be most effective, any barrier method used for contraception or preventing infection must be used correctly."

NAFDAC also warned that the illegal distribution and sale of unregistered condoms pose significant risks, as the safety, quality, and efficacy of these products are not assured.

The agency further emphasized that using substandard condoms could undermine efforts to promote condom use for preventing unintended pregnancies, HIV, and other sexually transmitted infections (STIs).



When condoms leak or break, they fail to provide the necessary protection, putting users at serious health risk, according to the agency.

NAFDAC statement read: "All NAFDAC zonal directors and state coordinators have been directed to carry out surveillance and mop up the unregistered products within the zones and states.

mporters, distributors, retailers, healthcare professionals, and consumers are hereby advised to xercise caution and vigilance within the supply chain to avoid importing, distributing, selling, and using illegally distributed products. All medical products/ medical devices must be obtained from authorised/licensed suppliers. The products' authenticity and physical condition should be carefully checked. Healthcare professionals and consumers are advised to report any suspicion of the sale of substandard and falsified medicines or medical devices to the nearest NAFDAC office, NAFDAC on 0800-162-3322 or via email: sf.alert@nafdac.gov.ng.

"Similarly, healthcare professionals and patients are also encouraged to report adverse events or side effects related to the use of medicinal products or devices to the nearest NAFDAC office, or through the use of the E-reporting platforms available on the NAFDAC website www.nafdac.gov.ng or via the Medsafety application available for download on android and IOS stores or via e-mail on pharmacovigilance@nafdac.gov.ng."



## NAFDAC warns Nigerians against use of recalled Nivea Roll-on deodorant

The National Agency for Food and Drug Administration and Control (NAFDAC) has issued a warning to Nigerians regarding the recall of Nivea Black & White Invisible Roll-on deodorant (50ml), which claims to provide 48-hour protection in African climates.

This recall follows an alert from the European Union Rapid Alert System for Dangerous non-food products based in Brussels.

In an official notice released on Thursday, October 31, NAFDAC identified the affected product by its batch number, 93529610.

The agency revealed that the deodorant contains 2-(4-tert-Butylbenzyl) propionaldehyde, a chemical that is prohibited in cosmetic products due to its potential health risks.



Manufactured in Germany, the product carries the Bar Code Number 42299882. NAFDAC has urged importers, distributors, retailers, and consumers to remain vigilant and avoid the importation, distribution, sale, and use of this specific batch of Nivea Roll-on deodorant.

Consumers who possess the recalled product are advised to cease its use immediately and return it to the nearest NAFDAC office.

The agency has also encouraged healthcare professionals and consumers to report any adverse reactions associated with the use of regulated products. Reports can be made through the nearest NAFDAC office, via the pharmacovigilance email at pharmacovigilance@nafdac.gov.ng, on the E-reporting platforms at www.nafdac.gov.ng, or through the Med-safety application available on both Android and iOS.

## Police bust organ harvesting ring In Ebonyi

he Ebonyi State Police Command have announced that they have dismantled an organ harvesting ring responsible for multiple killings in the state.

Disclosing this in Abakaliki on Friday, spokesperson of the Police, Joshua Ukandu said four suspected members of the ring were arrested following painstaking investigation and credible intelligence into the matter.

He said the suspects confessed to being responsible for the murder of Chikezie Idenyi a Dubai-based businessman.

The spokesperson said, "One Mrs. Blessing Chikezie Onyekachi had reported to the command of her missing husband, Mr. Chikezie Idenyi, who left home on 14th September, 2024 on a supposed business trip to Lagos but was not heard from again.

"Police investigation led to the arrest of one Innocent Elebe and Eze Elechi, who made useful statements that led the police to arrest Obinna Nwanguru and Oda Peter.

"They confessed to killing Chikezie Idenyi, Chibu Odii and Eze Fabian on different dates while trying to extract their blood/organs to use it to cure a cognitively impaired person (Down syndrome)."

He noted that the corpses of Chikezie Idenyi and Chibu Odii were subsequently recovered while effort is ongoing to recover the remains of the third victim.

Ukandu stated this while giving update on Police crime fighting activities in October, 2024.

He noted that 162 males and 15 females, totalling 177 suspects were arrested for various offences within the period under review.



According to him, 92 suspects have already been charged in court, while others will be arraigned once investigations are complete.

He said that under the new Commissioner of Police, Anthonia A. Uche-Anya, the Police in the state has employed strategic steps through increased stakeholder engagement to help bring crime to the barest minimum.

"Through this approach, we have been able to reduce the incidence of violent crimes, while operatives of the command are not relenting in our effort to make the state safe for all"

Ukandu revealed that the Police arested one Chukwuebuka Okemiri over alleged murder of a monarch, Ezeogo Ibo Ubani.

The late Ubani was until his death the traditional ruler of Ihie Autonomous community in Akaeze, Ivo LGA of the State.

Ukandu said the monarch was allegedly murdered by a group of gunmen led by the suspect on 3rd May 2024.

He said efforts are ongoing to arrest other members of the group who are still at large.

The Police spokesperson also revealed that the Police freed a kidnap victim, Miss Nwigbo, who was allegedly kidnapped and held hostage in a forest behind Okwagba Primary School by one Ominiyi Friday, Ubochi Ifeanyi and others at large. He said: "The kidnappers raped and held the victim for four days while they collected a ransom of N400,000 before they freed the victim.

"On 22nd October, 2024 operatives of the command who had been on the trail of the kidnappers arrested the two suspects while effort is ongoing to arrest others at large. They will be arraigned in court to answer for their crimes," he said.

Ukandu said the Police recovered a Berretta pistol belonging to a police officer and a single-barrel gun from various parts of the state.

He said operatives of the command attached to the crack unit acting on credible intelligence nabbed one Utobo Onyekachi, AKAAzaman, who is a member of a notorious armed robbery syndicate terrorising citizens within Abakaliki.

"The suspect led the police officers to the syndicate's hideout in Igbeagu Izzi, where his gang members, upon sighting the police officers, took to their heels and abandoned one Berretta pistol, which was recovered.

"Upon investigation, it was found to have been snatched from a police officer.

## **Amnesty International demands immediate** release of minors charged to court

mnesty International, a human rights group, has called on the Federal Government for the immediate release of the detained minors nabbed during the #EndBadGovernance protest held in August.

Recall that protesters gathered on the streets across Nigeria for 10 days between August 1 and August 10, 2024, over the hardship in the land.

During the demonstrations, some protesters were arrested in Abuja, Kaduna, Kano, Katsina, Sokoto, and Gombe, among other states.

The New Daily Prime reported that 79 minors were charged to the Federal High Court in Abuja on Friday with an N10 million bail grant.

At the court, four minors slumped when they were called to take their plea in the dock.

However, the viral video circulated online has sparked a lot of reaction, showing the reaction of social media activist Martins Otse, known as VeryDarkMan, who, too, was recently released from detention.

VeryDarkMan alleged that he and some of the children were locked up in the same cell when he was still in detention.

Being moved by the detention of the minors, Amnesty International described their detention as illegal.

The organization stated, "Amnesty International condemns President Bola Tinubu's government for the continued detention of minors for participating in the August #EndBadGovernance InNigeria protests.

"The attempts to put the minors through a sham trial over alleged 'treason' show the government's utter disregard for the rule of law. The authorities must release them immediately and unconditionally."

"Putting minors through these horrifying detentions for participating in protests against hunger and corruption is — so far — one of the deadliest attempts to suppress freedom of assembly. President Bola Tinubu must unconditionally release minors detained since August.

"In Katsina, at least 12 children under 16 years old were detained. The children ended up in detention for just being on the streets during the #EndBadGovernance protests. Children with their whole lives ahead of them are now at the risk of being tried on trumped-up charges.

"Right now charges of treasonable felony are being read to another group of 43 protesters in the same Federal High Court Abuja. The Nigerian authorities are only escalating attempts to deprive people of the right to peaceful protests through horrifying detentions and sham trials.

"The government of President Bola Tinubu must uphold the constitutionally and internationally guaranteed human rights of everyone in the country — including the rights to freedom of expression and peaceful assembly. All protesters currently on trial or detained must be released.

"The Nigerian authorities detained these minors unlawfully — putting them through horrifying experiences for exercising their right to peaceful protest. The government must release them all - immediately and unconditionally."

The Command strongly condemns this audio, labelling it as misleading and malicious."

Therefore, Ndukwe urged the public to disregard such audio as it does not represent any official communication from the Command, adding that WhatsApp, owned by Meta, is an organization that would not disseminate information using third-party sources.

## Tax review: Presidency mounts defence as 36 governors reject proposal

he 36 state governors of Nigeria have unanimously called for the immediate withdrawal of the National Tax Reforms Bill, a move that challenges the comprehensive efforts of the Presidential Fiscal Policy and Tax Reforms Committee led by Taiwo Oyedele.

The governors made their demands during a meeting of the National Economic Council, Nigeria's highest economic advisory body, on Thursday, October 31.

Oyo State Governor Seyi Makinde announced the decision, stating that the council agreed it was crucial to conduct further consultations before proceeding with the bill.

He emphasised the need for consensusbuilding to ensure that all stakeholders fully understand the proposed reforms.

"The council recommends the withdrawal of the bill currently before the National Assembly to allow for wider consultations and to clarify any misinformation," Makinde stated.

The proposed tax reforms aim to overhaul Nigeria's taxation system, with a focus on fair taxation, responsible borrowing, and sustainable spending.

Despite a presentation by Oyedele detailing the intended benefits of the reforms, which include streamlining tax processes and establishing a unified revenue service, the governors remained unconvinced.

The reforms, stemming from a review of existing tax laws, encompass four executive bills, including the Nigeria Tax Bill and the Nigeria Revenue Service (Establishment) Bill.

These bills seek to simplify tax obligations, harmonize administrative processes, and create a more efficient tax framework across federal and state jurisdictions.

However, the Northern Governors' Forum, representing 19 governors from the northern region, has expressed opposition to the reforms, particularly regarding the proposed derivation-based model for Value-Added Tax (VAT) distribution.

They argue that the new model undermines the interests of northern states, potentially leading to job losses and economic instability.

In response to the governors' concerns, the Presidency defended the tax reforms, asserting that they would not result in job losses and would instead foster economic growth.

Special Adviser to the President on Information and Strategy, Bayo Onanuga, emphasised that the proposed changes are designed to optimize existing tax frameworks without increasing the overall tax burden on citizens.

As the National Assembly considers the governors' request, both the Senate and the House of Representatives unexpectedly adjourned plenary until November 19, complicating the timeline for the proposed reforms.

While the House leadership remains open to discussing the bill on its merits, there is a growing sentiment among lawmakers that the current climate may not be conducive to significant tax reform.

# North Korea pledges to stand by Russia until 'victory' in Ukraine The two did not address.

orth Korea will back Russia until it achieves victory in Ukraine, Foreign Minister, Choe Son Hui said in Moscow as the United States warned thousands of Pyongyang's troops were at the Ukrainian border and could soon be deployed into combat.

In her meeting on Friday with Russian Foreign Minister Sergey Lavrov, Choe also accused the US and South Korea of plotting a nuclear strike against her country.

"Our traditional, historically friendly relations, which have travelled the tested path of history, today ... are rising to a new level of relations of invincible military comradeship," she said, praising the role played in this by North Korean leader Kim Jong Un and Russian President Vladimir Putin.



She said North Korea had no doubt that under Putin's "wise leadership" the Russian army and people would "achieve a great victory in their sacred struggle to protect the sovereign rights and security interests of their state.

"And we also assure that until the day of victory we will firmly stand alongside our Russian comrades," Choe said.

Lavrov spoke of the "very close ties" between the two countries' militaries and said this enabled them to solve important security tasks together.

The two did not address statements by leaders in Ukraine, South Korea and their Western allies that Pyongyang had deployed some 10,000 North Korean soldiers to Russia to fight in Ukraine.

On Thursday, US Secretary of State Antony Blinken said as many as 8,000 North Korean soldiers were in the Kursk region, where Ukrainian troops crossed the border into Russia in a surprise incursion in August, and that he expected them to go into combat against Ukraine in the coming days.

"We are deeply grateful to our Korean friends for their principled position regarding the events that have now unfolded in Ukraine as a result of the West's course of advancing NATO to the east and encouraging an openly racist regime to exterminate everything Russian," Lavrov said.

## Kenyans give President Ruto 48-hour ultimatum to resign

cloud of apprehension and uncertainty currently envelope Kenya as citizens issue President William Ruto a 48-hour ultimatum to step down, with a demand for a new government committed to "transparency, accountability, and good governance."

According to reports, the call for resignation has gained significant traction, with a viral Twitter statement stating, "We no longer recognize William Ruto as the President of Kenya. We recall his presidency and urge him to immediately resign and surrender his office to the Kenyan people."

This statement has generated lots of engagement, reflecting widespread discontent.

Regardless of President Ruto retracting a controversial finance bill that proposed tax increases, public outrage continues to prevail.

The bill, which was intended to address Kenya's debt of approximately 10 trillion shillings (\$78 billion), or roughly 70 percent of GDP, faced fierce opposition.

Ruto highlighted that without the tax increases, there would be a significant funding shortfall for critical development programmes, including those supporting farmers and teachers.

Kenyans are said to have struggled with economic instability, rampant corruption, and governance issues, leading to escalating living costs and high unemployment rates.

The public's frustration has climaxed into protests and a fervent demand for change.

Scores of protesters took to the streets, expressing their dissatisfaction with the administration, which they describe as plagued by "incompetence, mismanagement, and a persistent failure to address the nation's pressing needs."

Kenyan police were said to have fired rubber bullets and tear gas at demonstrators while soldiers were deployed and roads leading to Ruto's office at State House and parliament were blocked by police in anti-riot gear.
