Tinubu congratulates Edo's new governor, Okpebholo

President Bola Tinubu on Tuesday celebrated the triumph of democratic ideals as Monday Okpebholo and Dennis Idahosa were inaugurated as Governor and Deputy Governor, respectively.

Speaking at the ceremony, President Tinubu, represented by Vice President Kashim Shettima, assured Nigerians that the nation's most challenging economic hurdles were now in the past.

In his inspiring address, Tinubu hailed the occasion as a testament to "democracy in its truest form," emphasising the critical role of the people's will in shaping Nigeria's political trajectory.

"This atmosphere of joy and hope resonates with the voice of the people. This joyful cheer, this resounding call for a brighter tomorrow, is what democracy sounds like," the President declared.

He struck an optimistic tone about the nation's economic trajectory, saying Nigeria has already overcome its most challenging period.

"We have weathered the hardest days as a nation. We have pulled back from the brink of economic collapse, and now we step forward into a time of growth," he stated.

President Tinubu urged immediate reconciliation to address potential postelection disputes in the state, stating, "While some may attempt to disrupt peace after the people's will has been expressed, every elected leader has a responsibility to serve all, including those who voted differently or opposed them."

He highlighted Nigeria's democratic progress, remarking, "More than 25 years into our return to democracy, we have grown, and today's inauguration stands as proof that no single vote carries more value than another."

Discussing leadership qualities, Tinubu observed, "An honest leader quickly recognizes the legacy of problems they inherit. However, what truly defines such a leader is their sincerity and

courage to confront these challenges, not their scale."

The President outlined the new administration's inclusive mandate, noting, "Senator Okpebholo has pledged to build the Edo State you envision: a state with abundant jobs, accessible and quality education, modern infrastructure, and healthcare within reach of every citizen."

Connecting state governance to the national economic agenda, Tinubu emphasised, "From the moment we assumed office, we understood that securing our economy's future would require serious reforms—reforms to avert fiscal and monetary threats to the stability of this great nation."

He commended his party's internal cohesion, stating, "No political party has managed its affairs with greater unity and purpose than the APC since we assumed leadership."

The President described Edo State's transition as a "covenant of hope," underlining its importance to Nigeria's economic recovery and growth trajectory.

Trade policies boost Nigeria's export growth to N6.9tn — FG

he Federal Government has announced significant progress in Nigeria's export sector, with trade policies and facilitation programmes leading to a surge in the country's trade balance.

According to government officials, Nigeria's trade surplus reached N6.5 trillion in the second quarter of 2024, driven by strong export performance.

Vice President Kashim Shettima, speaking at the 3rd National Conference on Non-Oil Exports in Abuja on Tuesday, November 12, revealed that exports now make up 60.89% of Nigeria's total trade, amounting to N19.42 trillion.

This marks a slight increase of 1.31% from the first quarter of 2024, and a remarkable 201.76% growth compared to N6.44 trillion in Q2 of 2023.

Shettima attributed the positive trade balance to the successful implementation of the government's trade policies aimed at maximizing economic opportunities.

"For Nigeria to improve its trade balance and reduce reliance on oil and gas, effective trade policy implementation is essential," he said, highlighting that exports now represent a key pillar of the nation's economic diversification efforts.


The National Bureau of Statistics (NBS) confirmed that Nigeria's foreign exchange earnings increased in the second quarter of 2024, thanks to the robust export performance.

The trade surplus reached N6.95 trillion, signaling Nigeria's strengthening position in the global market.

However, Shettima cautioned that Nigeria must avoid becoming a dumping ground for substandard goods.

He emphasised the importance of ensuring that Nigerian exports meet global standards and are competitive in international markets.

"With the global trade market projected to reach \$32 trillion by the



end of 2024, Nigeria and Africa must work to fully capitalize on these opportunities," Shettima said.

"We aim to significantly increase the contribution of the trade sector to GDP and grow Nigeria's share of global trade."

Shettima also outlined the administration's commitment to enhancing trade facilitation for small and medium-sized enterprises (SMEs) through regulatory reforms.

He noted the role of the African Continental Free Trade Area (AfCFTA) in providing access to a 1.4 billion-person market, urging stakeholders to support Nigerian entrepreneurs in overcoming challenges to maximize AfCFTA's potential.

Non-oil export growth was also highlighted by Nonye Ayeni, Executive Director and CEO of the Nigerian Export Promotion Council (NEPC), who reported a 6.7% increase in non-oil exports.

Ayeni stressed that the NEPC is working to improve market access, reduce export costs, and streamline logistics processes for exporters.

"We are focused on eliminating barriers to exports, particularly by mproving logistics and fostering partnerships with key agencies such as the Nigerian Customs Service and Nigerian Ports Authority," Ayeni said. The NEPC has also partnered with the World Trade Organization and the International Trade Centre to enhance the quality of key non-oil exports and address product rejections in international markets.

The conference, themed *"Promoting Non-Oil Exports for Rapid National Economic Growth,"* served as a platform to discuss emerging challenges and opportunities in the export sector, with the goal of further boosting Nigeria's export levels and diversifying its revenue base.

The government remains committed to fostering policies that support locally made products, enhance market access, and create jobs, with a long-term vision of transforming Nigeria into a major global economic

In his closing remarks, Shettima reaffirmed Nigeria's commitment to strengthening trade and investment opportunities through bilateral and multilateral agreements, signaling an optimistic outlook for the country's economic future.

How I turned down N800,000 from MKO Abiola — Sowore

moyele Sowore, the presidential candidate of the African Action Congress (AAC) in the 2023 elections, has shared a fascinating account of his encounter with the late Chief MKO Abiola, the acclaimed winner of Nigeria's annulled 1993 presidential election.

Sowore, in an appearance on the Honest Bunch podcast, revealed how, at the age of 21, he turned down a generous offer of N800,000 from Abiola during a pivotal moment in Nigerian history.


The encounter, which took place in 1993, occurred shortly after General Ibrahim Babangida annulled the June 12 election. At the time, Sowore was the leader of the University of Lagos (UNILAG) Student Union, and he led a delegation to meet Abiola in a bid to understand his commitment to the fight for democracy. Speaking to co-hosts Nedu, Husband Material, Deity Cole, and Ezinne on the Honest Bunch podcast, Sowore recounted the story, reflecting on the broader political atmosphere of the time.

"We started protesting immediately after the annulment, but we were also concerned whether Abiola was strong enough to fight the battle we were ready for—the battle of our lives. This was the year I was supposed to graduate from university," Sowore recalled.

Sowore explained that the student leaders were so determined to speak with Abiola that they drove directly to his house in a Student Union bus, bypassing all formal protocols. Upon arriving, Abiola recognized Sowore, greeting him warmly: "Ah, student union leader, I know you. Good job!"

The conversation quickly turned to the seriousness of the struggle. Sowore asked Abiola, "Are you ready for this battle? Are you ready to die for Nigerians?" Abiola, responding affirmatively, was surrounded by politicians who Sowore claimed were more interested in Abiola's wealth than his political mandate.

"I told him, 'These people don't believe in your mandate. They will eventually



abandon you," Sowore said.

As they entered Abiola's living room, Sowore noticed a duffel bag of cash beside the businessman and politician, and shortly thereafter, Abiola offered N800,000 for transportation.

However, Sowore rejected the money, explaining that it was far too much for what was essentially a short journey from UNILAG to Abiola's house.

"I told him, 'Chief, forget the transportation; how can N800,000 cover transport from UNILAG to here?" Sowore recalled.

Despite Abiola's insistence, Sowore and his colleagues refused the offer. "He had never given money to anyone before, but we rejected it."

Sowore's firm stance caused visible tension in the room, especially among the politicians who were present.

He was, at the time, dressed simply in slippers and his only Ankara outfit, making his rejection of the offer even more symbolic.

Sowore mentioned that Chief Anthony Enahoro, a prominent Nigerian nationalist who was also in the room, supported him.

In an effort to ease the situation, Abiola escorted Sowore and his colleagues out. At that moment, John Momoh—now the owner of Channels Television—and his cameraman were waiting to interview Abiola.

It was during this brief interaction that the now-iconic photograph of Sowore with Abiola was taken.

Sowore explained that he wasn't aware of the photo's existence until 2018. The photograph, which had been taken by a photographer named Tunji Oyelero, was never given to Sowore at the time.

"He passed away before I got it, and one day, someone sent it to me," Sowore said.

The viral image of Sowore and Abiola, standing together in the aftermath of the annulled June 12 election, has since become one of the most enduring symbols of that turbulent period in Nigeria's history.

Reflecting on the encounter, Sowore expressed gratitude for the chance to meet Abiola, but he also stressed the importance of staying true to one's principles.

The moment has remained a powerful part of Sowore's own political journey, serving as a reminder of his commitment to fighting for a better future for Nigeria, free from the corrupting influence of money and power.

Sanwo-Olu mourns victims of Lagos truck accident

agos State Governor Babajide Sanwo-Olu has expressed deep sorrow over the tragic truck accident that occurred in the Aiyetoro area of Epe, Lagos State, on Monday, November 11, which claimed the lives of at least three people and left several others injured.

In a statement posted on X (formerly Twitter) on Tuesday, November 12, Governor Sanwo-Olu extended his condolences to the families of the victims, describing the incident as heartbreaking.

"I wish to extend my heartfelt condolences in light of the tragic traffic accident that occurred in the Aiyetoro area of Epe, Lagos State, yesterday, Monday, 11 November 2024," Sanwo-Olu wrote.

"Reports indicate that a cement truck suffered brake failure, resulting in the unfortunate loss of lives and injuries sustained."

The governor expressed his sympathy for the affected families and prayed for the



repose of the deceased as well as a swift recovery for the injured victims.

"With deep sorrow, I extend my sympathies to the families of those affected. I also pray for the departed souls and for the speedy recovery of those injured. May the families find solace in the love and support surrounding them, and may the cherished memories of their loved ones bring them some comfort as they

navigate their grief."

According to reports, the tragic accident occurred when a cement truck, descending from Ita-Opo, suffered a brake failure.

The truck reportedly collided with a commercial tricycle and a parked Toyota Camry before plowing into a nearby market. The incident has left the community in shock as the truck's uncontrolled descent caused significant damage and loss of life.

The Lagos State Government has vowed to investigate the cause of the accident, with authorities urging greater safety measures for commercial vehicles and improved road conditions to prevent such incidents in the future.

Governor Sanwo-Olu's office has pledged continued support for the affected families, and emergency response teams have been deployed to assist those injured and provide necessary aid.

Police dismiss rumour of bomb explosion in Jos

"At exactly 8:20 a.m., we received a report of a shallow dug hole suspected to be planted with an IED at Murtala Way beside the old site of the Jos University Teaching Hospital (JUTH).

"The rumour created panic among

the residents of the state.

"Upon receipt of the information, the Commissioner of Police, Mr Emmanuel Adesina, immediately

mobilised the Anti-Bomb Squad to the scene to assess the situation and take necessary actions.

"On reaching the scene, the area was immediately cordoned and our t e a m began examination and the hole was found to be safe and free of any explosive devices,"he said.

Alabo, who said that the commissioner of police also visited

scene, thanked residents of Plateau for conducting themselves peacefully, cooperating with its men and being security conscious amid



the rumour.

He called on the residents to go about their usual businesses and other activities without fear, insisting that the area was safe.

n an ambitious move to foster inclusivity, the Church of LEngland has undertaken a sweeping initiative aimed at diversifying traditional images of Jesus and other biblical figures, urging dioceses across the country to reflect a more racially inclusive vision of God and the divine. With the emphatic assertion that "God is not a white man," clergy are reevaluating religious imagery and messaging to address what leaders have described as long-standing racial inequities within the church. This initiative follows a series of reports and recommendations from the Archbishops' Commission for Racial Justice,

which has called out "structural and institutional racism" across congregations, particularly in predominantly white rural areas. The commission's recent report, Behind the Stained Glass, details how cultural biases and preferences for traditional leadership styles contribute to "systemic racism" within church ranks. According to the report, there remains an entrenched preference for white, male leaders who conform to traditional British norms, such as speaking "the Queen's English."

Church leaders, including the Archbishops of Canterbury and York, launched an anti-racism taskforce in 2021 in response to Black Lives Matter and global calls for racial equity. The taskforce set concrete objectives, including the diversification of biblical imagery and a mandate to ensure that leadership recruitment reflects the full diversity of the nation. In a landmark statement at the time, Archbishop of Canterbury Justin Welby admitted the "Church has failed" in addressing racism, calling for deep introspection and proactive reform.

The Diocese of Southwark has taken the



lead, promoting what it terms "correct images" that celebrate diversity. Their update on racial justice efforts highlights an intentional shift to diversify all communications, from sermon imagery to church videos. "God is not a white man; we make sure of the correct images," reads a recent diocesan statement. Meanwhile, the Diocese of Coventry has also launched a "diversity audit," reviewing everything from artwork and sermon content to the diversity of biblical figures portrayed within church services.

The diversity movement has already yielded visible change. The Diocese of Chester hosted a 2021 exhibition featuring a Black Jesus in a reinterpretation of the Last Supper, originally installed at St Albans Cathedral in 2020. In Bristol, a stained glass window depicting slave-trader Edward Colston was replaced with an image of Jesus in a Channel migrant boat in 2022, signaling a conscious effort to rethink longstanding symbols in a racially sensitive light.

Despite the progress, some parishioners, particularly in rural areas, have pushed back, claiming the initiative disrupts tradition. Nonetheless, dioceses nationwide are actively reporting their

diversity efforts to a newly established racial justice unit, sharing best practices and examining what they can do to make worship more inclusive.

The From Lament to Action report from 2021 set the tone for ongoing reform, recommending that dioceses hire full-time racial justice officers and require diversity within hiring pools for clergy, including bishops. Dioceses were invited to report on their progress in 2024, with some emphasizing a move away from "white, normative ways of working." Many

dioceses are now seeking to counter all-white ordained teams by inviting diverse guest preachers and challenging the church's traditional structures.

The Church of England, however, insists that it is not enforcing a "top-down" mandate on diversifying biblical imagery, emphasizing that each diocese is taking the initiative. As debates continue over the best way to embody the values of racial justice in worship, this movement signals a pivotal moment for a centuriesold institution that, according to its leaders, is finally grappling with a commitment to inclusion.

\$25,000 Reward for Arrest of Nigerian Murder Suspect



n a chilling case that has captured national attention, the United States government is offering a reward of \$25,000 for information leading to the arrest of Olalekan Abimbola Olawusi, a Nigerian fugitive accused of the heinous murder of his three-month-old child. According to a statement released by Supervisory Deputy U.S. Marshal Don Freeman, Olawusi has been placed on the U.S. Marshals Service's list of 15 most wanted fugitives. The troubling allegations against Olawusi stem from a harrowing incident that took place on April 3, 2017, in Providence, Rhode Island.

Law enforcement officials and emergency responders were called to a residence where they discovered the infant in a critical condition, bleeding from his mouth and nose. The baby was swiftly transported to a local hospital, arriving in cardiac arrest and requiring immediate resuscitation.

Medical examinations revealed a shocking 18 separate injuries on the child's frail body, indicative of prolonged abuse. These injuries included a skull fracture, serious brain trauma, and multiple broken bones across various regions. Tragically, despite the medical team's efforts, the infant succumbed to his

injuries six months later, leading to an escalation of charges against Olawusi. Freeman noted that on April 20, 2017, Olawusi was formally charged with two counts of first-degree murder and multiple counts of inflicting serious

multiple counts of inflicting serious bodily harm upon a child. However, following his release on that same day, the accused vanished, evading the judicial process.

The dire circumstances surrounding the case compelled authorities to add a murder charge after the infant's death on October 31, 2017, igniting further scrutiny into Olawusi's whereabouts. The U.S. Marshals Service has since launched an extensive manhunt for Olawusi, who reportedly fled the country on June 20, 2017.

Investigative efforts have suggested that he is currently receiving support from family members residing in Nigeria. Deputy Marshal Freeman emphasized the dangers Olawusi poses, not only to children but to the broader community as well.

He stated, "We are committed to utilizing all resources at our disposal to e n s u r e h e i s b r o u g h t t o justice." Freeman further elaborated on the severity of Olawusi's alleged crimes, stating, "Olawusi is wanted for the abuse and murder of an innocent child. The heinous nature of his actions

leaves no doubt as to the threat he poses to the public.

Our commitment to bringing him to justice is unwavering, not only for the sake of the victim's family but for the safety of the entire community." Described as standing approximately 5 feet 8 inches tall and weighing around 185 pounds, Olawusi has black hair and brown eyes.

He is known to also go by the alias Olekun Olawusi. Individuals with any knowledge regarding his whereabouts are urged to contact the U.S. Marshals by calling 1-877-WANTED2 (926-8332) or via the USMS Tips App.

The shocking nature of this case has sent ripples of outrage through the community, raising awareness about domestic violence and child abuse. As the search for Olawusi continues, authorities remain vigilant and hopeful that the public will assist in the pursuit of justice for the young victim and those affected by this tragic incident.

The U.S. Marshals Service is determined to act on any leads that could help resurrect the path of justice that has been marred by Olawusi's flight.

Naira Abuse: EFCC clears Senator Danjuma Goje's daughter

he Economic and Financial Crimes Commission (EFCC) has confirmed that the alleged naira abuse linked to Senator Danjuma Goje's daughter, Mrs. Fauziya Goje, is footage of Hajara Seidu Haruna's daughter, Amina Zannah.

On 25 October, Fauziya and Aliyu Ahmed Abubakar had a grand wedding ceremony with dignitaries such as President Bola Tinubu, Deputy Senate President; Umar Ganduje, and Senate President Godswill Akpabio.

A few days after the ceremony, videos from a wedding reception emerged online showing naira notes on the floor. Netizens insinuated the video clip was from Fauziya's wedding.

However, in a statement disclosed on Monday by the Head of Media and Publicity to EFCC, Dele Oyewale, noted that the alleged money abuse occurred at the wedding dinner of Amina Babagana Zannah.

The statement read, "The attention of the Economic and Financial Crimes Commission, EFCC, has been drawn to a viral video where the nation's currency, Naira, was freely sprayed at a wedding ceremony in Kano, Kano



State, on Friday, October 24, 2024.

"Allegations of the abuse of the Naira were imputed to Mrs. Fauziya Danjuma Goje, daughter of Senator Danjuma Goje, by Nigerians from all walks of life, including an editorial by a leading and respected national newspaper.

"As a responsible and accountable anticorruption agency campaigning against currency mutilation and dollarization of the economy, the EFCC swung into action by analyzing the video, and findings showed that the alleged naira abuse actually happened, but not at the wedding of Goje's daughter but at the wedding dinner of Amina Babagana Zannah held on the aforementioned date.

Oyewale added that "Zannah is the daughter of Hajara Seidu Haruna (a.k.a. Hafsat Gold Nigeria), who is the Chief Executive Officer of Hafsat Jewellery Enterprise with offices in Abuja, Kano, and Dubai (United Arab Emirates).

"Haruna confirmed the viral video. She admitted that the alleged Naira abuse took place at the wedding dinner of her daughter on 24 October 2024.

"The bridegroom, Ibrahim Mohammad, hails from Niger Republic, and those that allegedly sprayed naira notes and dollar bills were from the groom's family in Niger Republic.

"The Commission has invited the Nigerien groom, Mohammad, to report at its national headquarters in Abuja, with everyone that sprayed naira notes at his wedding with Zannah.

"Therefore, as the fight against Naira abuse continues, the commission thanked the public for their efforts, stating that "it will not move against anyone wrongly accused of an alleged crime. The Commission remains steadfast in this crusade and would spare no offender, no matter how highly placed."

Jos explosion shakes community in chaos

powerful explosion shook the city of Jos on Tuesday morning, sending shockwaves through surrounding communities.

Eyewitnesses reported that the blast occurred around 10:30 am near the densely populated Terminus market

"We urge calm and assure the public that we will do everything possible to ensure their safety.

Our correspondent reports that the incident has heightened security concerns in Jos, which has experienced periodic violence and unrest in recent years, with

Defence Minister advocates for leveraging technology to strengthen security

The engagement session with the stakeholders was aimed at tackling impunity for disobeying court judgments on environmental rights in Nigeria.

During the session, SERAP educated the oil and gas communities on the need to demand transparency and accountability as part of the essentials of managing public resources.

As a Non-Governmental Organization (NGO), SERAP is an advocacy organization working to promote transparency, accountability, and respect for socio-economic rights in Nigeria.

Mr. Kolawole Oluwadare, the group Deputy Director, described the interactive session as dynamic and thanked the organisers, the Ford Foundation, for this initiative. According to Mr. Oluwadare, the event focuses on brainstorming and strategizing to ensure that the court decisions are enforced.

Dr. C.A.J. Chinwo, in a paper titled "Public Interest Litigation and Enforcement of Judgment in Environmental Matters in the Niger Delta Region of Nigeria," calls for collaboration to improve the lives of the residents in the Niger Delta region against industrial degradation.

Chinwo emphasized that the pollution from the oil sector has destroyed the flora and fauna, leaving several ill effects on the lives of the residents.

Highlighting the factors that halt the enforcement of court judgment, Chinwo noted they include specific designation of future dates, and order of stay of execution of the judgment by the trial court or an appellate court, among others.

Adaeze Amanda, representing the Federal Ministry of Justice, stressed the need for the call to order, noting that justice was not an aspiration but a reality.

Commending the NGO, Mrs. Rabin Awa, the Director of Legal Services and Enforcement, condemned the negative impacts of oil activities from companies in the Niger Delta on the environment, health, and source of livelihood.

Mores, 16 new volunteer lawyers from Rivers, Edo, Ondo, Bayelsa, and Delta states were inaugurated.

Mr. Kehinde Oyewumi, the legal adviser for SERAP, addressed the participants, urging the volunteers to actively follow up on court cases for the organization, provide legal opinions to support their mission, offer updates on ongoing cases, and ensure the enforcement of court judgments through their efforts.

To this end, he urged community stakeholders present to educate and sensitize their people on the need and efforts to enforce judgment and report cases of human rights violations to SERAP.

Speaking to NEW DAILY PRIME and other media representatives, he appealed to them to continue in their good work to ensure that change occurs in affected communities.

Rivers State: Appeals court appoints special panel for Thursday hearings

In a significant development aimed at addressing the mounting political conflicts in Rivers State, the Court of Appeal in Abuja has appointed three special panels dedicated to handling a myriad of political cases originating from the state.

The panel is set to commence its proceedings on Thursday, November 14, 2024. This decisive action comes in response to an escalating legal confrontation between the current Governor of Rivers State, Siminalayi Fubara, and his predecessor, the incumbent Minister of the Federal Capital Territory, Nyesom Wike. The ongoing rivalry between these two political leaders has sparked a flood of legal challenges, thereby fueling political divisions among various factions in Rivers State.

The situation has led to an alarming trend of conflicting judgments emanating from courts of comparable authority, a situation that has drawn the wrath of judiciary stakeholders as well as the public at large.

To address these pressing concerns and facilitate a more coherent resolution to the disputes, the President of the Court of Appeal, Justice Monica Dongban-Mensem, has taken the proactive step of appointing a specialized panel.

This panel will be responsible for overseeing all appeals connected to the political turmoil currently engulfing Rivers State. Leading this specialized panel is Justice Onyekachi Otisi, who is joined by fellow justices Misitura Bokaji-Yusuf and James Abundaga. Together, they will focus on cases that involve prominent political figures and factions within the state, effectively becoming a crucial arbiter in the ongoing political chaos.

Among the appeals slated for consideration by the newly constituted panel is one filed by Governor Fubara himself, along with the Rivers State House of Assembly. This appeal also encompasses cases involving both the Peoples Democratic Party (PDP) and the All Progressives Congress (APC) concerning allegations of the defection of twenty-seven lawmakers loyal to Wike from the PDP to the APC.

During a session on Monday, a different panel within the court opted to adjourn three appeals, one of which is a case brought forth by the Rivers State Government against the Rivers State House of Assembly.

This particular case is now set to be heard by the newly established special panel. Presiding over the Monday proceedings, Justice Hamma Barka remarked, "The appeal, marked CA/ABJ/PRE/ROA/CV/1211m1/202 4, is among the Rivers matters for which a special panel was constituted." Chief Paul Erokoro, a senior attorney representing the appellant, informed the court of his intentions to ensure that all respondents, who have yet to

receive the necessary documents, would be served before the Thursday session.

He highlighted that he had recently received filings from the respondents and required additional time to adequately prepare his response. Ferdinand Orbih (SAN) and Dr. Joshua Musa (SAN), counsel for the first and second respondents respectively, concurred with the request for adjournment and agreed to the proposed timeline for November 14, allowing for a thorough review of the matters at hand.

Furthermore, two additional cases—one initiated by the Accountant General of Rivers State against the Rivers State House of Assembly, and another by the Action Peoples Party against the Independent National Electoral Commission and other parties—were also postponed to Thursday for hearings by the Justice Otisi-led special panel.

The establishment of this specialized panel marks a pivotal effort to provide a clear and expedited resolution to the prevailing political disputes in Rivers State. This step is seen as a critical move toward restoring order and stability amidst the ongoing political turmoil that has plagued the state in recent months. With the special panel set to begin its work, many are hopeful that a resolution to these contentious issues may soon be on the horizon.



Borno Jailbreak: 278 Convicts still missing two months after flooding

wo months have passed since the devastating flooding that destroyed the medium security custodial centre in Maiduguri, resulting in the escape of 281 prisoners. Despite efforts to recapture the convicts, 278 of these convicts remain unaccounted for. The flooding that happened on the 10th of September brought down the walls of the correctional facilities and staff quarters, forcing the prisoners to flee for their safety.

Abubakar Umar, spokesperson for the Nigeria Correctional Service (NCS), attributed the challenge to the destructive impact of the flood on the

facility.

"We are working tirelessly with sister

security agencies to rearrest the escaped inmates," Umar said.
The state police command has progressed, re-arresting three escapees: A u w a l u A m i n u, A b u b a k a r Mohammed, and Kyari Kur. Kur was apprehended on 10 October in Gubio town following credible intelligence.

The ongoing search has raised concerns about public safety and potential increased crime rates. Residents are urged to remain vigilant and report any suspicious activity.



"The police assure the public of their commitment to ensuring the recapture of the remaining escapees and maintaining law and order," said Nahum Daso, state Police Public Relations Officer.

The Borno jailbreak highlights the need for enhanced security measures to prevent such incidents in the future. Authorities must prioritize infrastructure upgrades and emergency preparedness to mitigate the impact of natural disasters.

As the search continues, the NCS and law enforcement agencies are working to reassure the public of their dedication to maintaining public safety.

Morgan Rogers called up to England squad amid injury crisis for november Nations League matches

ston Villa midfielder Morgan Rogers has earned his first call-up to the England senior squad for the upcoming Nations League games after eight players, including key stars from Manchester City, Arsenal, and Liverpool, were forced to withdraw due to injuries. Rogers, 22, was initially slated to represent England Under-21s but was promoted by interim manager Lee Carsley following an impressive season start at Aston Villa, where he has scored three goals and recorded two assists in 11 appearances. Joining him are new additions to the squad: West Ham's Jarrod Bowen, Everton's Jarrad Branthwaite, Newcastle's Tino Livramento, and Burnley goalkeeper James Trafford.

The withdrawals include several highprofile players: Chelsea's Levi Colwill and Cole Palmer, Arsenal's Declan Rice and Bukayo Saka, Manchester City's Phil Foden and Jack Grealish, Liverpool's Trent Alexander-Arnold, and



Southampton's Aaron Ramsdale. Injuries have decimated the lineup ahead of matches against Greece on 14 November and the Republic of Ireland on 17 November.

Key players face various setbacks: Liverpool's Alexander-Arnold left the field after just 25 minutes in a recent

win over Aston Villa, while Arsenal's Saka and Rice suffered injuries during their club's 1-1 draw with Chelsea. Grealish, recovering from an injury, has not played for Manchester City since 20 October, a point City manager Pep Guardiola recently criticized when Grealish was initially included in Carsley's squad. Ramsdale is reportedly out with a fractured finger sustained in a Southampton match against Wolves.

Details surrounding Foden, Palmer, and Colwill's unavailability remain unclear, although all played full matches for their clubs over the weekend.

The upcoming fixtures will be the last under Carsley's management, as former Bayern Munich and Chelsea manager Thomas Tuchel is set to take over in January 2025.

In addition to van Nistelrooy, assistant coaches Rene Hake, Jelle ten Rouwelaar, and Pieter Morel have also left the club. Former United midfielder Darren Fletcher, however, will remain, maintaining his role as a bridge between the first team and the academy.

Manchester United has announced it will soon reveal the full composition of Amorim's first-team coaching staff as the club enters a new chapter under his leadership.

Premier League referee David Coote suspended over alleged video criticizing Liverpool and Jurgen **Klopp**

he Premier League refereeing body, PGMOL, has suspended top-flight referee David Coote after a video allegedly showing him making disparaging remarks about Liverpool and former manager Jurgen Klopp circulated widely on social media. The video, which has not been verified, features a man believed to be Coote criticizing Klopp's behavior and using profane language in reference to the German coach.

PGMOL, which oversees Premier League referees, confirmed the suspension would take effect immediately, pending a full investigation into the video. While the authenticity and timing of the footage remain uncertain, a source from PGMOL indicated that officials are treating the video as credible. Coote, 42, is one of the Premier League's longest-serving referees, having officiated in the league since 2018.

The footage reportedly references a Liverpool match Coote refereed against



Burnley in July 2020, which ended in a 1-1 draw. Following the game, Klopp publicly criticized Coote for allowing challenges on Liverpool players that he felt warranted fouls. In the video, the man purported to be Coote recounts how Klopp "had a right pop at me" following the Burnley match and goes on to call Klopp "arrogant," while also using expletives.

The video clip, lasting just over a minute, shows Coote with another man in an unidentified setting. The circumstances of the video's emergence online remain unknown.

Liverpool is reportedly aware of the video but has chosen not to comment at this stage. PGMOL has similarly declined to issue further statements until its investigation is complete. English Football League chairman Rick Parry told BBC Sport, "PGMOL is dealing with it—they have suspended him—they've acted quickly and will make sure they handle it thoroughly and professionally." The incident sheds light on the

challenging dynamics between officials and managers in the highstakes world of Premier League football. Coote's suspension comes in the wake of Liverpool's 2-0 victory over Aston Villa, a match he officiated last Saturday. It also brings renewed attention to the historical tension between Klopp and Coote, who clashed after the Burnley game in 2020. In that match, Liverpool—already

Premier League champions—were aiming to become the first team to win every home game in a season and to match Manchester City's 100point record.

He expressed disappointment in players who don't want to play for their national team. Ronaldo believes that Portugal, despite

"I want to say, especially to my teammates, that after playing for so many clubs, winning trophies, Champions Leagues, Ballon d'Ors, FIFA awards... there's nothing greater than representing your country. His remarks come in the wake of a significant shift in the industry, where the emphasis seems to have pivoted towards external appearances rather than genuine creative abilities.

In an insightful and exclusive interview with Pulse Nigeria, Njamah shared his thoughts on the evolving landscape of Nollywood and reflected on the challenges and triumphs that characterize contemporary filmmaking

As a seasoned actor, producer, and director, Njamah brings a wealth of experience to the conversation, having also starred in numerous other television programs including "Tinsel," "Living In Lagos," "Solitaire," "Casino," "Emerald," "Tide," and "My Flatmates."

During the interview, Njamah made a profound statement regarding his motivations within the industry, revealing a deep-rooted passion for storytelling that transcends mere ambition.

"What fuels me is beyond passion," he stated. "There's that knack and need to grow with every month, whatever year. There's that desire to do something different. This industry of ours is a canvas on which you can express yourself, not merely follow the trend set by others. For me, it is all about originality and the inherent need to create something meaningful and right I am driven by the evercreative venture that defines my journey."

A focal point of the discussions revolved around the evolution of African narratives in the film sphere.



Njamah acknowledged that while there have been substantial advancements, both technically and in terms of storytelling, there is an alarming downside.

"There's a positive aspect and a negative aspect to the changes we are witnessing. On the one hand, our technical prowess has improved significantly. We are now narrating our stories with greater finesse and scale. However, this progress comes with a cost we are gradually losing our originality. We find ourselves borrowing from cultures foreign to us, rather than celebrating and amplifying our unique heritage. Our identity is at risk as we stray from our authentic narratives."

Njamah drew distinctions between the casting methods from his era and today's industry practices.

Reflecting on the grassroots approach of "Fuji House," which featured passionate, aspiring actors working with limited resources, he expressed concern over the contemporary trend of prioritizing aesthetics overtalent.

"Back in the day, 'Fuji House' was shot with a single camera and fueled by the ambition of hungry artists," he reminisced. "Now, we see people being cast based on beauty standards and social media clout, rather than their capabilities as performers. Several of us strive to uphold our originality; after all, compelling stories are best told by those with genuine passion."

He further criticized the widespread lack of professionalism and accountability within the industry, stating that there is a need for more robust systems to monitor production qu

"Professionalism is in decline," he remarked. "The industry is riddled with issues such as a lack of respect for those in leadership positions and an absence of humility. We lack the necessary checks and balances. It's become alarmingly easy for anyone to declare themselves a producer without any formal evaluation or standards in place. The guild system that should oversee our creative community is ineffective. As creators, we must be vigilant and responsible in our roles as producers, directors, and actors." Cocluding his reflections, Njamah

emphasized the richness and uniqueness of Nollywood, advocating for the development of indigenous platforms to promote local stories and lessen reliance on foreign streaming services.

"What makes us unique is often seen as a flaw to others," he asserted. "I am frustrated by claims that international collaborators shun our industry because of preconceived notions. Instead of relying on external platforms for our survival, we must cultivate our own spaces to showcase our creativity. If foreign entities hesitate to partner with us for any reason, they are mistaken there are incredible producers here whose work speaks for itself. Collaboration can thrive if we engage with each other on equal terms."

As Njamah continues to advocate for a more authentic and talent-driven Nollywood, his insights serve as a call to action for industry stakeholders to refocus their priorities and embrace the unique stories and perspectives that define Nigeria's vibrant film landscape.


With unapologetic conviction, she concludes with, "With my full chest, I am currently a gold digger!"

"I would like to repeat that our plans to develop our Arctic territories and to increase cargo traffic along the

Northern Sea Route rely on expanding Russia's icebreaker fleet," said Putin.

"We have ambitious plans in this area. There is a great deal to be done. In this context, I suggest holding a special meeting on this subject, thoroughly preparing and comprehensively discussing all aspects of advanced development of the Northern Sea Route, so that we find concrete practical solutions."

Three new-generation nuclearpowered vessels – the Arktika, Sibir, and Ural - have been floated out from the Baltic Shipyard and are now working in the waters of the Northern Sea Route.

The Chukotka icebreaker has joined this group. In the coming weeks, Russia is planning the delivery of another icebreaker, the Yakutia, which is more than 95 percent complete.

Putin pushes to recapture Kursk before U.S. transition

Putin deploys 50,000 Russian and North Korean troops to recapture Kursk before Trump's inauguration, intensifying the Ukraine conflict as Western allies brace for potential escalations.

Russian President Vladimir Putin has reportedly deployed a force of over 50,000 Russian and North Korean troops in an ambitious offensive to seize control of the Kursk region from Ukraine before U.S. President-elect Donald Trump's January inauguration. Western defense officials and Ukrainian military sources warn this could mark a critical escalation in the war as winter sets in, with intensified Russian attacks aimed at shifting power dynamics in anticipated peace negotiations.

The operation, which involves thousands of North Korean conscripts deployed under a Russia-North Korea military pact, represents one of the largest coordinated efforts by Moscow in recent months, NATO intelligence suggests. British defense reports indicate that Russia is bolstering the offensive with kamikaze drone attacks from new launch sites near Ukraine's border, adding urgency to Ukraine's defensive efforts.

General Oleksandr Syrskyi, Ukraine's top military commander, stated that "tens of thousands of enemy soldiers from the best Russian shock units" are advancing on Ukrainian positions, particularly around Kursk and the northeastern Sumy region reported by Telegraph. The Russian force's objective may be to quickly reclaim lost ground and establish stronger territorial leverage before January 20, the date of Trump's planned inauguration.

In response to the escalation, Ukrainian President Volodymyr Zelensky has cautiously acknowledged Trump's election victory and called on him to uphold U.S. military support. Trump, who campaigned on promises to broker peace in Ukraine "within a day," reportedly urged Putin to avoid worsening the conflict in a phone call after the election. Although the Kremlin denies the call took place, U.S. media outlets report that Trump warned Putin against increasing hostilities

Western leaders are rallying to support Ukraine's efforts, with British and French officials meeting in Paris to discuss strategies to strengthen Ukraine's position. Downing Street underscored the need to prepare Kyiv for the approaching winter as the conflict's toll on Ukrainian resources grows. The Biden administration has pledged to expedite the delivery of \$4.3 billion in redirected U.S. weapons and \$2.1 billion in new contracts for supplies to support Ukraine's defenses.

Jhn Healey, the U.K. Defence

Secretary, supported Trump's stance against further escalation but emphasized a continued policy of "security through strength." Meanwhile, concerns mount that Trump's future foreign policy could include reduced aid to Ukraine, with some allies wary that any shift in U.S. support may disadvantage Ukraine in negotiations.

Military analysts note that P u t i n's a p p a r e n t strategy—securing gains around Kursk and advancing t o w a r d t h e e a s t e r n D o n b a s — would bolster Russian positions in case of peace talks where territorial concessions could be on the table. Fighting in Donbas has intensified, with Russian forces bypassing major Ukrainian fortifications to target the town of Pokrovsk, a critical supply hub.

With dwindling manpower and supplies, Ukraine is bracing for what analysts describe as one of the most consequential battles of the conflict, as the Kremlin eyes strategic control in the northeast and U.S. foreign policy faces a transition.
