## EFCC once investigated me for two years – Olukoyede

he Chairman of the Economic and Financial Crimes Commission (EFCC), Ola Olukoyede, has revealed that he was under investigation by the anti-graft agency for two years over allegations of corruption.

He spoke during the opening of the sixth Annual Criminal Law Review Conference organized by the Rule of Law Development Foundation in Abuja on Monday.

Reaffirming his dedication to upholding transparency and accountability within the EFCC, Olukoyede also announced the recent dismissal of two EFCC operatives who were found guilty of corrupt practices.

He said the operatives, dismissed two weeks ago, are now facing prosecution, highlighting the agency's zero-tolerance policy towards corruption within its ranks.

The anti-corruption czar said, "We are preparing the case files of some of the people we have dismissed. If an EFCC staff will not be able to stand publicly with his two hands up and challenge the entire public; whose goat have I

collected? Whose bottle of water have I taken illegitimately?

"I have said this to Nigerians; who has ever given me one kobo in the course of my work, come out and say it. I stand to be challenged. I can't be easily influenced by things like that. Any staff that is corrupt, I will show you the way out.

"Again, there are some people who may want to be overzealous. Out of 12, you must have Judas. I can't stand here and say all is perfect. As many as you see, report them to us, and we will do justice."

Olukoyede said that he was once subjected to investigation for two years as an EFCC secretary.

"I am not just sitting there as chairman of EFCC. I have been on the other side. I have been subjected to investigation myself for two years. So, I know what it means to subject people to investigations. My major objective is to use the instrumentality of this mandate to stimulate the economy and to also



follow the rule of law," he said. He said integrity is needed to survive, even as legal practitioners.

"Integrity is not about law. It is not about your advocacy ability to write beautiful briefs. No. It is about law and morality. Your conscience must tell you to do the right thing. That is what integrity is all about. Finally, ethics, values and standards of legal practice must also be reviewed.

"These are essential to me because the job of EFCC is to ensure that corruption does not find space in our national life," he said.

The EFCC boss said he welcomed constructive criticism of the agency.

Netflix acknowledged the complaints registered on social media, with X users posting heavily pixelated videos professing to be of the match.

"The boxing-mega event dominated social media, shattered records and even had our buffering systems on the ropes," the streaming service posted on X Saturday.

The subscription streaming service also said 50 million households watched Katie Taylor defeat Amanda Serrano in what Netflix said marked the most-watched professional women's sporting event in U.S. history.

Tinubu seeks lawmakers' approval for fresh \$2.2bn loan

he President, Bola Ahmed Tinubu on Tuesday wrote to the National Assembly, seeking the approval of a fresh \$2.2 billion loan as a new external borrowing plan in the 2024 Appropriation Act.

The President's request was contained in a letter read by the Speaker of the House of Representatives, Tajudeen Abbas, during plenary on Tuesday.

The loan, If approved, will be used to finance part of the budget deficit of N9.7 trillion for the 2024 budget.

Tinubu also forwarded the 2025-2027 Medium-Term Expenditure Framework (MTEF) and the Fiscal Strategy Paper (FSP) to the National Assembly for consideration and approval.

Also, the president sent the National Social Investment Programme (NSIP) Establishment Amendment Bill to make the social register the primary tool for the implementation of the Federal Government's social welfare

programmes.

The letter read in parts, "Request for the resolution of the National Assembly for the implementation of the new external borrowing of N1,767,102,179.00, that is about \$2.209bn

already enshrined in the 2024 Appropriation Act.

"In accordance with the provisions of Sections 21 and 27 Subsection 1, the Debt Management Office established Act 2003 and the approval of the Federal Executive Council, I write the request for a resolution of the National Assembly to raise the sum of \$2.2 09bn.

"The new external borrowing enshrined in the 2024 Appropriations Act, part financed the budget to about \$9.17 trillion.

"A Euro bond of about \$1.7bn and

Sukuk financing of another \$500m the actual makeup of the financing."

Similarly, the second letter read, "Please receive the 2025-2027 MTF and FSP approved during the Federal Executive Council meeting on the 10th day of November 2024.

"The Senate is invited to note that as the 2025 budget of the Federal Government of Nigeria will be prepared based on the parameters and fiscal assumptions of the approved 2025-2027 MTF and FSP, it is imperative to seek the National Assembly's expeditious legislative action in this submission.

### DSS arrests ex-Ogun PDP gov candidate, Ladi Adebutu

n Monday evening, the Department of State Services (DSS) in Ogun Statearrested the 2023 governorship candidate of the Peoples Democratic Party (PDP), Oladipupo Adebutu.

NEW DAILY PRIME gathered that Adebutu was arrested in respect of last Saturday's local government election in Ogun State.

He was accused of bringing 40 'illegal policemen' from MOPOL 49 in Lagos to the state on the day of the election and also going about the Ikenne local government area of the state with PDP thugs riding on motorcycles in an attempt to snatch ballot boxes while brandishing guns and other weapons.

The party's publicity secretary, Kayode Adebayo, confirming his arrest to newsmen, saying he (Adebutu) was detained for charges yet unknown.

Adebayo also noted that efforts to secure his bail proved abortive as at 10 pm on Monday.

He said, "The leader of the Peoples Democratic Party has truly been detained by the DSS for charges yet unknown.

"Several efforts have been made to secure his bail as at 10pm on Monday, 18th

November, 2024 either on personal recognition or by a surety but none has yielded any result so far; his lawyers have been informed and they will take it up by tomorrow (Tuesday) morning."

He, however, urged the public and supporters of the party to maintain



calm and peace until the matter is resolved.

"However, our principal has called for calm and directed that all party members, supporters, and wellwishers should be rest assured that this time shall pass, it is one of the prices for our democracy," he added.

Bwala fires back at Ndume, says 'You need prayers'

new presidential aide, Daniel Bwala, on Monday, fired back Lat Senator Ali Ndume, who asked him to apologize for his previous attacks on the ruling All Progressives Congress (APC.)

Bwala was appointed Special Adviser to the President on Media and Public Communication by President Bola Tinubu last Thursday.

Ndume, following the appointment, had in a statement on Sunday, called on Bwala to apologize for his past conduct, particularly his opposition to the choice of Senator Kashim Shettima as Tinubu's running mate in 2023.

However, speaking during his first appearance since his appointment, in a session with State House Correspondents at the Aso Rock Villa on Monday, Bwala dismissed Ndume's advice, saying he enjoys a 'fantastic' relationship with the Vice

He said, "Ordinarily, I would not have

responded to his issue because when I was referred to what he said, I immediately contacted the Vice President. We both cracked jokes about that. I have a very fantastic relationship with the Vice President, which even started before the judgment of the court was delivered regarding the matter.

"The relationship became stronger in the build-up to the emergence of the leadership of the National Assembly. Since then, we've been having a very good relationship.

"But I know that the senator in question is having some troubled times; all I can say is that we need to pray for him, for God to guide and help him. But we are focused on the work of the President. It's not about Bwala. It's about the president."

He said he is replacing Ajuri Ngelale, who took an indefinite leave last September as President Tinubu's official spokesperson.

The appointment of Bwala by President Tinubu has generated intense debate, considering his vocal criticism of the president and the All



Progressives Congress and also his prior position as a spokesperson for Atiku Abubakar's 2023 presidential campaign.

With veteran journalist, Mr Bayo Onanuga serving as Special Adviser on Information and Strategy and former Sports Minister, Sunday Dare as Special Adviser on Public Communication and Orientation, Bwala's appointment also makes him the third Special Adviser to the President on a media-related role.

Fielding questions on concerns about overlap of roles, Bwala said, "There is no issue as to the differences in terms of the responsibility. Everybody knows his responsibility. I am not here to define the responsibility of anybody other than myself because it will amount to gaslighting anybody.

## Sanwo-Olu advocates export-driven economy, lauds FG's efforts

overnor Babajide Sanwo-Olu of Lagos State, has stressed the need for Nigeria to focus more on export-driven economy, to improve the economy of the nation, noting that one of the fundamental issues at the root of the country's lingering economic situation is foreign exchange crisis.

The governor, however, gave kudos to the President Bola Tinubu's administration for laying the foundation to improve the exporting capacity to turn Nigeria's economy round.

Sanwoolu spoke on Tuesday, as the guest lecturer at the 36th Convocation Ceremony of Yaba College of Technology, Yaba, Lagos on the topic: "Developing Exportable Alternatives for Nigeria's Economic Recovery," where he noted sadly that the overdependence on crude oil and gas had done far more harm than good to the economy, and to Nigerians' mindsets.

The governor said, "This crisis takes two main forms: first is the monopoly of crude oil and gas on our foreign exchange earnings. Our overdependence in this way has done far more harm than good to the economy, and to our mindsets as a people.

"As we gradually but steadily make our way into the phase of recovery, one of the most important things we can do as a people and a nation, is to increase the focus on our export capacity and potential."

Governor Sanwo-Olu insisted that Nigeria should rather focus on exporting processed materials and not just raw materials, saying that was the only way it can take better advantage of her exportation.

According to him, countries that prosper from natural resources are the



ones that process and add value to it before exporting it, pointing out that oftentimes these were not even the countries in which those natural resources were to be found most abundantly.

This was just as he noted that President Tinubu had emerged at a most auspicious moment in the nation's journey, when, more than ever before, very tough and difficult decisions needed to be taken to shift the country away from the path of economic underperformance, onto the enduring path of productivity and prosperity.

"Now, a caveat is necessary here. When I speak about agricultural exports, I do not mean raw materials and unprocessed goods. If there is one lesson we have learnt over many decades, it is that there is no value or pride in exporting raw materials to the world.

"The countries that prosper from natural resources are the ones that process and add value to it before exporting it. And oftentimes, these are not even the countries in which those natural resources are to be found most abundantly.

"President Bola Tinubu has emerged at a most auspicious moment in our national journey, a time when, more than ever before, very tough and difficult decisions need to be taken to shift the country away from the path of economic underperformance, onto the enduring path of productivity and prosperity," the governor stated.

Speaking further, Sanwo-Olu explained that for industries in Nigeria to strive, the government needed to put in place all the needed infrastructure to enhance their performance, assuring that his administration was doing that by providing the needed social facilities.

"One of the biggest areas of concentration and intervention for us is in infrastructure, especially transport and logistics. We played a key role in the development of the Lekki Deep Sea Port, Nigeria's first Deep Sea Port, and West Africa's most modern port complex; including holding a 20 percent stake in the transformational project," he said.



### G20 summit: Tinubu endorses global alliance against hunger, poverty

resident Bola Tinubu said on Monday that the creation of the Global Alliance Against Hunger and Poverty, championed by President Luiz Inacio Lula da Silva of Brazil, was pivotal in the global fight against hunger and poverty.

Tinubu said this at the 19th G20 Leaders Summit opening session in Rio de Janeiro, Brazil.

He lauded the initiative and described it as the right step to address one of the world's most significant challenges.

"This bold and visionary step underscores Brazil's leadership in addressing one of the most urgent and persistent challenges facing our world today.

"The creation of this Alliance marks a significant milestone in our global efforts to eradicate hunger and poverty, and it also sends a powerful message of solidarity to vulnerable populations around the globe.

"By fostering collaboration between governments, international organizations, and civil society, this initiative offers a comprehensive approach not only to addressing immediate needs but also tackling the structural causes of hunger and poverty," he said.

Tinubu compared the global initiative to one of the eight priority areas he outlined at his inauguration 18 months ago, expressing Nigeria's eagerness to adopt international best practices to advance its economic development.

According to him, Nigeria's endorsement of the declaration of commitment to join the Global Alliance is a significant step in its efforts to address hunger and poverty by leveraging international cooperation and resources to bolster domestic strategies.

He added that by supporting the initiative, Nigeria also demonstrated a solid commitment to realizing the Sustainable Development Goals (SDGs), particularly SDG 1, which focuses on eradicating poverty, and

SDG 2, which aims to achieve zero hunger.

"These goals are at the core of Nigeria's development agenda, and the Alliance offers a platform to accelerate progress towards them.

"By collaborating with international partners, Nigeria aims to leverage

best practices, innovative solutions, and financial support to enhance its efforts to combat poverty and hunger.

"The endorsement reinforces Nigeria's role as a key player in global efforts to promote sustainable development and improve the quality of life for all its citizens," Tinubu said.

He emphasized the urgent need for the United Nations Security Council reform to ensure its continued relevance in global interventions.

He reiterated Nigeria's readiness and capability to represent Africa within this elite group.

President Tinubu called on the G20 to champion this noble ideal, having admitted the African Union as a group member.

"The Security Council should expand its permanent and non-permanent member categories to reflect the world's diversity and plurality. Africa deserves priority in this.

Tinubu, in a statement read on his behalf by Amb. Yusuf Tuggar, Minister of Foreign Affairs, noted that, "the G20 now wears a toga of a forward-looking international institution that upholds reform-minded multilateralism.'



He commended the decision of the G20 to grant permanent membership to the African Union and for its consistency in sustaining the tradition of inviting guest countries to join the group.

This broad participation, he said, allowed the opportunity for more inclusive and effective discussions to address shared global challenges.

"Some permanent members of the Council have shown promising signs of support for this process, which is a positive development. We welcome this shift in attitude and call for a faster pace to the long overdue change.

"The world faces various challenges, including extreme poverty, inequality, climate change, terrorism, and global conflicts," said the President.

According to him, these issues are exacerbated by longstanding inequities in the global governance system.

He added that they had led to unsustainable sovereign debt and distortions in access to capital markets, trade imbalances, unfair representations and hindered development in the Global South.

"It is our responsibility to find pragmatic solutions to fix these imbalances.

"Particularly pressing is global taxation, which profoundly impacts developing countries.

"The current international tax system, largely shaped by the interests of more affluent nations, often leaves developing countries at a disadvantage, especially in taxing digital economies.

#### Int'l students in US: Nigeria 1st in Africa, 7th globally

he US Embassy in Nigeria, has disclosed that Nigeria ranks first in Africa and seventh globally in international students in the United

The embassy quoted the 2024 Open Doors Report on International Education Exchange, in a statement on Tuesday.

According to the report, for the 2023/2024 academic year, 20,029 Nigerian students enrolled in US colleges and universities, marking a 13.5 per cent increase from the previous

The report, released during International Education Week, revealed that US institutions now host a recordbreaking 1,126,690 international students, the highest in history.

Nigerian students represent a significant share of this population, known for their academic excellence and commitment to higher education.

More than 55 per cent of Nigerian students in the US are pursuing graduate-level studies, enriching the academic and cultural environment of American universities.

The statement further highlighted that, "The report reveals that US colleges and

universities host a record-breaking 1 , 1 2 6 , 6 9 0 international students this year, marking an all-time high for international enrolment.

"This milestone aligns with the 75th anniversary of the

Open Doors Report, the leading benchmark for international educational exchange in the United States.

"Notably, Nigeria, with 20,029 students, reinforces its position as the top sending country from Africa and the seventh largest globally,"

The steady growth in Nigerian student enrolment reflects the high demand for US education and the strong ties between the two nations.

These connections are further strengthened by educational exchanges, which promote mutual understanding and global collaboration, the statement added. Sub-Saharan Africa remains the fastestgrowing region for international education, with a 13 per cent increase in student mobility this year, following an 18 percent rise in 2022/2023.



"Sub-Saharan Africa's student mobility grew by 13 per cent in 2023/24, maintaining its position as the fastest-growing region for the second year, following an 18 per cent increase in 2022/23.

"The influx of Nigerian students is a testament to the robust educational ties between the US and Nigeria," it added.

The Open Doors Report, published by the Institute of International Education in collaboration with the US Department of State, serves as a benchmark for global educational exchange.

It was unveiled as part of International Education Week, an initiative aimed at fostering crosscultural learning and inspiring future leaders to pursue studies in the United States.

32 saved by whiskers in Lagos-Ibadan Expressway nine-vehicle collisions

he Ogun State Traffic Compliance and Enforcement Agency (TRACE) has disclosed that about 32 persons were saved from death following the collisions of nine vehicles along the Danco area of the Lagos-Ibadan Expressway on Monday.

TRACE Commandant, Seni Ogunyemi, in a traffic update on Monday, said the accident occurred due to excessive speeding and loss of control on the part of one of the drivers which resulted in multiple collisions with other vehicles.

The TRACE boss noted that 32 persons were involved in the accident including 20 adult males and 12 adult females.

According to the traffic report, a Scania truck loaded with perishable items had fallen on the expressway after losing control due to speeding and thereby obstructing a section of the highway.

Ogunyemi said another driver who was not driving with caution had rammed into the fallen truck from the rear thereby leading to collisions with other vehicles. He said, "According to an eyewitness, excessive speed, loss of control by the driver of the Scania truck loaded with perishable goods and fell on the road. Also, excessive speed, and impatient by the Sino truck driver loaded with granites hit the Sienna from the rear which



affected the other mentioned vehicles. He identified the vehicles Involved as "a Ford jeep (KTU 980 FP), a Nissan jeep (GGE 440XP), a Sienna (AAA 609 LA), a Toyota Highlander (WDE 831AAA), and a Mazda bus (GNN 860 XB).

### Police, Osun Park Management clash over shooting of chairman

he Osun State Park Management System has accused the police of shooting its chairman, Nurudeen Iyanda, also known as Alowonle, while he was in custody.

The accusation followed Iyanda's arrest in connection with a domestic issue on Tuesday, November 19 morning.

In a statement issued by the group's Secretary, Mukaila Popoola, the Park Management System alleged that Iyanda was shot in the early hours of Tuesday under circumstances that warrant a full investigation.

Popoola urged members to remain calm and avoid taking the law into their own hands, assuring them that the matter would be pursued through the appropriate legal channels.

"We assert that our chairman was shot while in police custody, and we demand a thorough investigation into the matter," the statement read.

However, the police have responded to these allegations, with the acting Police Public Relations Officer for the Osun Command, Emmanuel Giwa-Alade, offering a different version of events. Giwa-Alade claimed that Iyanda was shot while attempting to escape custody.

According to the police account, Iyanda had been arrested on Monday, alongside several associates, on charges of murder, attempted murder, unlawful possession of firearms, and malicious damage.

The arrest followed a petition filed by the complainant, which led to an investigation by the Anti-Kidnapping Unit of the Osun State Police Command.

Giwa-Alade explained that the police had acted on credible intelligence, which led them to a location on Ring Road, Osogbo, where Iyanda and his associates were allegedly planning to attack the complainant. When the police arrived, the suspects reportedly opened fire but were subdued, with nine individuals, including Iyanda, taken into custody.

As the suspects were being transported, the police claimed they were ambushed by a group of Iyanda's supporters, who forcibly freed him and four other detainees, all while still in handcuffs.

Following this escape, police traced Iyanda and his associates to a hideout in the Susi area of Oke Baale, Osogbo, where Iyanda was rearrested. During a search of his vehicle, the police recovered a Barrett pistol, six rounds of 9mm ammunition, and an expanded empty shell. Giwa-Alade stated that Iyanda attempted to escape again during the search, prompting the officers to shoot him in the process.

He confirmed that Iyanda was now receiving medical treatment and was in stableondition.

In response to growing tensions, the military has deployed soldiers to the Ilesa Garage area of Osogbo to maintain order and prevent any further unrest. Armed soldiers have temporarily halted passenger boarding activities in the area, effectively restricting movement around the motor park.

The situation remains tense, with both the police and the Park Management System accusing each other over the circumstances of Iyanda's arrest and shooting.

### FRSC moves against fake diplomatic, unauthorized number plates

he Corps Marshal, Federal Road Safety Corps (FRSC), Malam Shehu Mohammed has directed the immediate clampdown on the proliferation of fake diplomatic and other unauthorised number plates, as seen on some vehicles plying Nigerian roads.

Mohammed said this in a statement issued by the Corps Public Education Officer (CPEO) Mr Olusegun Ogungbemide on Tuesday in Abuja.

The FRSC boss said that the directive had become necessary in line with his administration's proactive approach towards contributing to enhancing national security.

He said that these identified number plates were fraudulently produced by suspected criminals, as they were neither produced by any of the production plants of the FRSC in the country nor issued by the Motor Licencing Authorities of states.

"The identified fake and unauthorized number plates include, but not limited to those with the following inscriptions:

"DIPLOMATIC NUMBER PLATES. NYCN, PEACE AMBASSADOR, NAUS, CYMS, UN-UNITY 01, UN-AMB, NANS among others," he said.

The FRSC Corps Marshal therefore approved immediate commencement of tactical enforcement across all formations of the Corps.

This, he said, was to ensure speedy arrest and impoundment of all vehicles on Nigerian roads with the above identified fake number plates or any other of its kind.

"By this notice, the public is hereby cautioned that these fake and unauthorized number plates are mostly used for nefarious and criminal activities.

"Pursuant to the foregoing, members of the public are advised to report anyone using such number plates to law enforcement

"Members of the public who are presently using such vehicle identifications are by this publication warned to immediately discontinue the use of these fake and unauthorised plates as defaulters will be prosecuted,"he said.

The FRSC boss said that the corps would collaborate with other security agencies to uncover the sources of the fake number plates for necessary apprehension and prosecution.

"To achieve maximum impact in the aggressive enforcement, the Corps Owners of such vehicles shall be prosecuted along as accomplices.

"The Corps is committed to this action and will ensure that not even one of these nefarious individuals who are only driven by pecuniary gains to compromise the security architecture of the country will be left unarrested," he assured.

**Alleged Corruption: EFCC dismisses** two staff members

he Economic and Financial Crimes Commission (EFCC) has dismissed two of its staff members over allegations of corruption, with plans for their prosecution now underway.

EFCC Chairman, Mr. Ola Olukoyede, made the disclosure on Monday, November 18, at the opening of the 6th Annual Criminal Law Review Conference organised by the Rule of Law Development Foundation in Abuja.

Olukoyede revealed that the two staff members were dismissed two weeks ago for misconduct, emphasising that such actions are in line with ongoing reforms within the commission.

"We cannot be fighting corruption with dirty hands," Olukoyede stated.

"Those who come to equity must have clean hands." He further confirmed that, beyond dismissal, the commission would prosecute any staff found guilty of corrupt practices, as they would be held to the same standards as the individuals the EFCC prosecutes. "Just two weeks ago, I caused the

dismissal of two staff members," he



said.

"I will not only be dismissing them, but I will also be prosecuting them. We are already preparing case files for some of those dismissed."

Olukoyede also shared a personal experience, revealing that during his tenure as EFCC secretary, he was investigated for two years, underscoring the importance of integrity in the fight against corruption.

He stressed that legal practitioners, in particular, must maintain high ethical standards to survive in the profession.

Additionally, Olukoyede confirmed that he had issued a directive to streamline EFCC prosecutions, specifying that no case should exceed a 15-count charge to improve efficiency in the commission's operations.

Sampson 'King Sax' Udo raped a girl and got away with it

n October 6, Sampson Udo, a Lagos-based saxophonist known popularly as King Sax, was at the Elegushi Beach to attend an event his acquaintance invited him to. While there, he lured this lady to his car and raped her. When her sister went public with it a month later, he got her arrested and then raped her as well, as confirmed by voice notes listened to by FIJ.

When 27-year-old Destiny Ameh (not real name) invited Sampson Udo to attend an event she organized at Elegushi Beach, Lagos, she had no idea he would rape her.

Ameh and Udo had met each other online a while ago, and while she would not describe him as a friend, she says she extended him an invitation to support her event which brought her from Akwa-Ibom to Lagos.

Grace, Destiny's younger sister, told FIJ and the police that when Udo arrived at the beach on October 6, he called Destiny, saying he needed help locating her. She met him a while after, and then followed him outside the beach to where he parked.

There, Udo convinced her to get into the backseat of his car, "saying they should catch up, since the last time he saw her was on January 8, 2022 when he played his saxophone for her 25th birthday."

"While in his car, he locked the doors, got on top of Destiny and forcefully raped her. He covered her mouth and put his weight on her," Grace said.

She said Destiny left after the incident and then sent cuss words to him when she got home, but never filed a report as she was too stunned. Two weeks later, the victim opened up to Grace, and the matter took a new turn.

"Without mentioning to me or anyone about the incident, my sister went back to Akwa-Ibom where she is based," Grace added.

"Two weeks after the incident, she told me. I then called his number. He claimed the sex was consensual, so I



asked why my sister would slam his car door if it was consensual and why she would send him those messages after. He went mute and dropped the call. I then called him multiple times after but he did not pick. I sent him WhatsApp messages, but he did not reply, so I took to X to call him out."

This callout gained some online traction and forced Udo's hand. What followed was a public statement, police report and monetary demand.

#### UDO, POLICE CONSPIRE

On October 25, Udo took to his social media handles on X, Facebook and Instagram to accuse Grace of falsely alleging rape.

He wrote: "My attention has been drawn to a post on Twitter (sic) by (redacted), with the username (redacted) already going viral. The post is to the effect that I had forceful carnal knowledge with someone she claims to be her sister.

"I am innocent of this accusation. The publication was made to malign and ridicule my fast-growing personality and brand. I have consulted my legal team '

Udo then called Destiny, asking why she allowed Grace to put out the X post. Soon after, the police invited Grace to the State Criminal Investigation Department (SCID), Panti, Lagos.

On October 30, she showed up.

"There were four male policemen interrogating me, and I felt uncomfortable," Grace said. "I thought there would be at least one woman. Those policemen started mocking my sister and I. One said, 'Does this fresh boy look like someone that can rape somebody?'

"Udo and his lawyer then said I must pay N15 million and retract my X post, and then publish an apology on two national dailies. I agreed to delete the post but refused the monetary demand. Then the policemen said I would be detained since I could not settle Udo monetarily."

The police held her in detention for two days, demanded two sureties and a N1 million payment for what they described as bail. Grace managed to part with N450,000 to secure her freedom. On November 11, she returned to the station where Udo dropped his monetary demand to N7 million and threatened a lawsuit if she did not pay the first installment of N2 million before 9 pm that day.

#### A SECOND RAPE

When Grace and her lawyer made to leave the station, Udo offered to drop her off at her location. She said she declined, but seeing that her lawyer would be in the vehicle, she obliged.

"He dropped my lawyer off first, and then began taking me through my route when I told him to drop me halfway as I was not comfortable with him knowing where I lived," Grace continued.

She said he asked her to be comfortable and said he would take care of her.

"He then drove to a restaurant and ordered alcohol but I declined. Soon after, I asked to leave as I needed to raise N2 million before the day ended to avoid a defamation lawsuit, but before I could get into the Uber I ordered, he asked me to give him my body in exchange for the money. I left.

"The next day, he sent his address and kept calling my phone, so I finally picked. He sounded angry, said I was not serious and he was going to take me to court if I didn't give him what he wanted in exchange for his withdrawal of the case. His lawyer was also calling and harassing me. I then thought to see him to beg so he could consider dropping the case, but when I got there, he pounced on me, ripped my gown apart and raped me."

### THE RECORDINGS THAT WILL SEND SAX TO JAIL

The day before, Grace made a phone recording of Udo making advances to her, and when she asked why he was approaching her after raping his sister, he laughed and said he could be interested in sisters.

Believing she could obtain evidence by speaking with him, she again recorded the call they both had on the morning of November 12. When he refused to say much on the phone, she visited him and began recording. What her device would capture was more horror than had already happened.

FIJ listened to both audios but cannot publish them due to their mental horror

content.

As she fought him off, she ordered an Uber, and when the driver called, Udo yelled at him to wait. This Uber driver would later serve as a witness to the saxophonist's crime.

"I ran out half naked and into the vehicle so the driver could take me straight to the police," Grace told FIJ. "The Uber driver gave a statement, too and relayed all that he witnessed."

On Thursday morning, the SCID police arrested Udo and have remanded him pending when they would charge the matter to court. The police also returned Grace's N450,000.

Meanwhile, FIJ learnt from Serah Ibrahim, an activist, that Udo's lawyer and girlfriend have been soliciting an out-of-court settlement since the police arrested him.

Ibrahim and Inibehe Effiong; a lawyer, and others had been following the case closely since Grace was first arrested.

## Property owners on Kuje-Airport road corridor to get N1.1bn compensation

ederal Capital Territory (FCT), Nyesom Wike, has earmarked N1.1 billion as compensation to owners whose properties are to be affected by the ongoing expansion of Kuje-Airport road.

The Minister disclosed this to newsmen on Tuesday during an inspection tour of the road in Kuje to ascertain the pace of work.

He said: "I have come here to see for myself the report on the valuation of what we are supposed to pay. When I got the files for approval, I said, look, it would be proper for me to see for myself the kind of structures that we are going to pay for.

"Well, if I remember vividly, the entire estimate they gave is about 1.1 billion Naira, and to pay for those whose properties are affected, like some of

these buildings you have seen here, down to the community.

"So it's about 1.1 billion and we are going to make it available so that the contractor will not find any excuse for delay."

Speaking on the approved 70.000 Naira minimum wage and three months arrears for Federal Capital Territory Administration (FCTA) staff, Wike who reaffirmed Federal Government's commitment under the Renewed Hope

Agenda, said the move was aimed at increased staff productivity to drive city development.

"Wel, first of all, it is the commitment made by the federal government under the Renewed Hope Agenda that workers' wages should be increased,



and in line with that, we have also adopted it and have also approved for the payment of the arrears as agreed with the labour.

"I expect that the workers will also see this as a boost and be more committed for us to achieve the development that is required in the city."

## Businessman jailed 21 years for fraud in Lagos

An Ikeja Special Offences Court on Monday, sentenced Philips Fatuyi, exchairman of the Natural Oil and Gas Suppliers Association of Nigeria (NOGASA), to 21 years imprisonment for N43.5 million fraud.

Justice Mojisola Dada, in her judgment, held that the Economic and Financial Crimes Commission (EFCC) proved the two-count charge of obtaining money by false pretences and stealing against Fatuyi beyond reasonable doubt.

The anti-graft agency had charged Mr Fatuyi alongside his company, Oceanview Oil and Gas Ltd.

Fatuyi, who was first arraigned on 7 April 2022, had pleaded not guilty to the charge.

But Justice Dada held that the prosecution proved the charge against him beyond reasonable doubt and found him culpable on all counts.

The court also held that the convict failed to pay the naira equivalent of the funds to the nominal complainant, saying that the case could not be further prolonged.

She held that though \$8,000 (the equivalent of N12.8 million) had been

recovered from the defendant during the investigation, Fatuyi had remained unrepentant.

"The first defendant never had the intention of giving the nominal complainant the naira equivalent of the dollar," the judge said.

She, thereafter, sentenced the convict to 14 years imprisonment on count one, and seven years imprisonment on count two.

The judge sentenced Mr Fatuyi without an option of a fine and held that the sentence would run concurrently.

The court further ordered the convict to pay back the full sum of N43.5 million to the nominal complainant within 90 days of the judgment.

The judge directed the convict's company to pay a fine of N500,000 on count one and an additional fine of N250,000, on count two.

She directed the company to pay the fine within 30 days of the judgment or the face winding up.

Earlier, the EFCC Prosecutor, Spiff Owede, told the court that the convict committed the offences on 28 September 2016, in Lagos.

The prosecutor stated that the convict, with the intent to defraud, obtained the aggregate sum of N43.5 million from

one Elochukwu Okoye and Elebana Unique Ventures Nigeria Ltd on behalf of WAPCIL Nigeria Ltd under the false representation that he would sell to WAPCIL Nigeria Ltd \$98,870, a representation he knew to be false.

EFCC submitted that the convict stole the sum of N43.5 million, property of WAPCIL Nigeria Ltd.

The prosecutor said the offences contravened Section 1(3) of the Advance Fee Fraud Act 2006, and Section 285 (1) Criminal Law of Lagos State 2011.

After EFCC presented its fifth and final witness on March 30, 2023, the prosecution closed its case.

Fatuyi thereafter opened his defence on 16 June 2023.

He told the court that he had given \$100,000 (equivalent of N160 million) to one Olumide Adegbite to convert to naira.

According to him, Mr Adegbite told him he had connections with the Central Bank of Nigeria and could secure a preferential exchange rate. Source: NAN

The bill has now been sent to the that all Nigerians National Assembly.

Fredrick Nwabufo, Senior Special Assistant to President Bola Tinubu on Public Engagement, revealed this on Tuesday, stating that the proposed bill, titled National Social Housing Fund (NSHF), seeks to ensure all Nigerians, regardless of income level, have access to decent housing.

According to Nwabufo, a memo on the bill will be submitted to the Federal Executive Council (FEC) for review. He added that funding for the project will come from budgetary allocations and donations.

"Progress has been made to establish a

Fund (NSHF) in line with the President's Renewed Hope Agenda to ensure including the low and no income, vulnerable and underprivileged groups have access to decent and dignifi accommodation.

"A memo to the Federal

Executive Council (FEC) and an Executive Bill to the National Assembly is underway for the creation of a National Social Housing Fund. Potential sources of funding include budgetary provision, donations from philanthropic organizations, corporate social responsibility, and voluntary donations from Nigerians.

## Over half of Nigerian Startups face funding challenges – Report Reveals

new report by TLP Advisory, a Nigerian venture law firm, reveals that 51% of startups in Nigeria face significant challenges in securing funding, with currency volatility and limited access to investors cited as the primary barriers.

The report, titled "A Decade of the Nigerian Venture Ecosystem: Numbers, Insights & Stories," was launched on Tuesday, November 19, offering a detailed analysis of Nigeria's startup landscape over the past ten years. It highlights the growth of the ecosystem, as well as the ongoing challenges, especially amid the country's economic instability.

Despite a record \$3 billion in venture capital investments in 2021, over half of the startups surveyed reported that securing funding remains a major obstacle. According to the report, "51% of startups surveyed reported difficulties in securing funding, largely due to currency volatility and limited access to investors. Angel investors have proven essential during this period."

In addition to funding challenges, the report identifies other key obstacles for Nigerian startups, including regulatory hurdles and difficulties in talent retention.

TLP Advisory, which has been involved in some of the continent's largest tech deals, called for deeper collaboration between startups and corporations, increased investment in talent development, and more active engagement with policymakers to create a supportive business environment.

She emphasized the importance of a supportive policy framework to unlock the full potential of Nigerian startups.

Kola Aina, Founder of Ventures Platform, echoed this sentiment, stressing the need for more proactive policy engagement.

"The ecosystem must become more deliberate in engaging in government policy design, ensuring we shape the policies that govern our industry," Aina said.

The report's findings underline the resilience and adaptability of Nigerian startups, even as they face a range of challenges. However, it also points to the need for continued investment, collaboration, and policy reform to help these businesses thrive in a competitive global market.

### Shettima urges governors to step up efforts in ending open defecation

Shettima has called on governors of Nigeria's 36 states to intensify efforts in the national campaign to end open defecation, aiming for a clean, open defecation-free Nigeria by 2025.

Shettima's spokesperson, Stanley Nkwocha in a statement said he made the call during the 5th anniversary celebration of the "Clean Nigeria: Use the Toilet" campaign, where he also officially launched a new Strategic Plan for the initiative.

Speaking at the event held at the Banquet Hall of the Presidential Villa in Abuja, the Vice President, represented by Deputy Chief of Staff to the President, Ibrahim Hassan Hadejia, emphasised the significant health, economic, and social benefits of eradicating open defecation.


Shettima noted that tackling this issue would improve public health, enhance productivity, and restore dignity and safety to Nigerians.

The Vice President urged state governments to actively mobilize political support for the campaign, particularly at the sub-national level.

He stressed that the sanitation sector presents enormous economic opportunities, which, if aligned with the government's renewed hope agenda, could drive job creation, energy solutions, and biological fertilizer production.

"It is against this backdrop that we must re-strategize and increase our advocacy to achieve the goal of reasonable access to toilets by 2030," Shettima stated.

"I urge governors to provide the necessary support to drive this campaign at the state and local government levels to ensure Nigeria is open defecation-free within the next



five years."

He also highlighted the dangers posed by open defecation, including contamination of water sources, disease spread, and adverse effects on education, economic productivity, and quality of life.

Shettima noted the disproportionate impact on women, girls, and vulnerable communities, and reassured Nigerians that the current administration is fully committed to ending open defecation as part of its commitment to achieving the United Nations' Sustainable Development Goal 6.2 by 2030.

Shettima reiterated the federal government's determination to ensure that all Nigerians have access to clean sanitation facilities, promising that the Tinubu administration will remain dedicated to this cause.

Minister of Water Resources and Sanitation, Joseph Utsev, echoed these sentiments, recalling that the campaign was launched in 2019 under Presidential Executive Order 009.

He revealed that Nigeria currently has one of the highest rates of open defecation globally, with an estimated 48 million people practising it.

However, he celebrated the progress

made, including 135 local government areas (LGAs) achieving Open Defection Free (ODF) status and over 30,000 communities being certified ODF.

Despite these accomplishments, Utsev acknowledged that progress has been slower than expected, with the nationwide target of 2025 still a challenge.

He called for continued efforts to meet the goal of an open defecation-free Nigeria.

Eze Kenneth Emeka, Chairman of the Senate Committee on Water Resources, also commended the government's efforts, emphasising the importance of staying focused on the 2025 deadline for eliminating open defecation.

The event coincided with World Toilet Day, which is recognised globally by the United Nations to accelerate efforts toward ending open defecation worldwide.

The "Clean Nigeria: Use the Toilet" campaign continues to gain momentum, with increasing collaboration from state governments, local governments, international partners, the private sector, civil society, and the media.

### Adebutu released from DSS custody

on. Ladi Adebutu, the 2023 gubernatorial candidate for the People's Democratic Party (PDP) in Ogun State, has been released from the custody of the Department of State Services (DSS).

Adebutu was detained earlier this week in connection with alleged security breaches during the local government elections held in Ogun State on Saturday, November 16, 2024.

Adebutu, a former lawmaker, was released at around 7 a.m. on Tuesday, November 19, after being invited by the DSS for questioning over his alleged involvement in the disturbances in Iperu, Ikenne Local Government Area, during the election.

In a statement he personally signed, titled "My Experience and Release from the DSS," Adebutu denounced the allegations against him, calling them "baseless" and accusing the authorities of attempting to silence him as an opposition voice.

He reiterated his stance on the need for financial autonomy for local governments, which he believes can only be achieved through free and fair elections.

"I was released by the DSS in Abeokuta following an invitation to answer to various spurious accusations related to the November 16 Local Government election in Ogun State. The allegations were so baseless that it became clear their purpose was to silence me as a voice of the opposition," Adebutu said in his statement.

He went on to emphasise that his belief in the importance of local government autonomy and his advocacy for free and fair elections were not partisan issues but were rooted in national development. Adebutu also noted that President Bola Tinubu shares his view on the matter, indicating that this was a national concern and not a political one.

"Desperation has set in to emasculate the third tier of government completely; this is the struggle for our development," Adebutu added, alluding to the political dynamics in Ogun State over the past five years, which he said would soon be made public.

Despite the ature of his detention, Adebutu expressed appreciation for the professionalism and fairness with which the DSS handled his case during his detention.

He also thanked the judiciary for the favorable ruling obtained in a recent case, which sought to exclude the PDP from participating in the local government elections.

"I must say I am pleasantly surprised at the professionalism and fairness the DSS has treated this matter till date, particularly during my stay in their office," he acknowledged.

Adebutu concluded by thanking all stakeholders, including both supporters and critics, and urged everyone to continue working toward advancing good governance in the state.

The release of Adebutu comes amidst growing political tensions in Ogun State following the controversial local government elections.

"The North cannot progress in isolation, and Nigeria cannot prosper unless every part of this nation thrives," he stated, underscoring that regional development is integral to national growth.


The President further warned that disruptions in one region's growth can impede the entire nation's progress, pointing to the alarming statistics of Nigeria's large number of out-of-school children.


He urged the government to act on the recommendations discussed at the event, stressing the importance of youth in driving the nation's development.

### Hong Kong jails 45 pro-democracy campaigners, earns international condemnation

In the city's largest national security trial, a Hong Kong court on Tuesday, sentenced 45 prodemocracy activists under its national security laws, with former law professor, "mastermind" Benny Tai receiving the longest term of 10 years.

The defendants were charged with subversion for holding an unauthorised primary election in 2020 aimed at selecting pro-democracy candidates.

International condemnation was swift, with Western countries and rights groups slamming the sentencing as evidence of the erosion of political freedoms in the city since Beijing imposed a security law in 2020.

Tai's sentence was the longest yet handed out under the security law, which was brought in to quash dissent after massive, sometimes violent prodemocracy protests in 2019.

His 44 co-defendants were sentenced to shorter terms beginning from four years and two months.

All were charged with subversion after holding an informal poll in 2020 as part of a strategy to win a pro-democracy electoral majority.

The group includes some of the most prominent figures of Hong Kong's once-diverse political opposition.

After Tai, the second-longest sentence of seven years and nine months was handed to young activist Owen Chow.

In a Facebook post before the sentencing, Chow had said he was "absolutely not optimistic".

"But I see hope because even (if) I am far from the day of release, we have now seen the end point," he wrote.

'Gravely concerned'

O Tuesday, the 45 were crammed into the defendant's dock, from where they occasionally waved to the public.

Many have already spent more than 1,300 days in jail.

Pro-democracy politicians Au Nokhin, Andrew Chiu and Ben Chung were singled out as organizers, but received lesser sentences after testifying against Tai.

"Long Hair" Leung Kwok-hung, the 68-year-old co-founder of the city's last standing opposition party, received a term of six years and nine months.



His wife and party leader Chan Po-ying told AFP that the term was "within our expectations".

"Itis what it is – no matter (whether) I laugh or I cry, so I choose to laugh a bit," she said. After the sentencing, the mother of defendant Hendrick Lui silently took out a placard reading "The righteous shall live, the wicked shall perish".

She was taken away in a police van within seconds, according to video footage from Hong Kong media.

'Refused to be tamed'

Leticia Wong, a former district councillor, told AFP that she found the terms were "encouraging people to plead guilty and testify against their peers".

"For those who refused to be tamed, punishment is obviously heavier," Wong said.

Western countries and international rights groups have condemned the trial as evidence of Hong Kong's increased authoritarianism.

Australia's government said it was "gravely concerned" after dual citizen Gordon Ng received a sentence of seven years and three months, and said it would continue to advocate for his "best interests".

A spokesperson for the US consulate in Hong Kong said the United States "strongly condemns" the sentencing.

China on Tuesday said such Western criticism "seriously desecrates and tramples on the spirit of the rule of law", and warned against interference.

Taiwan's presidential office said "democracy is not a crime" and condemned the "use of judicial measures and unfair procedures" to curtail political

participation and freedom of speech.

The sentences show "how fast Hong Kong's civil liberties and judicial independence have nosedived", international NGO Human Rights Watch said.

China and Hong Kong have repeatedly pushed back against criticisms, saying the security law restored order following the 2019 protests.

Hong Kong's security minister Chris Tang said Tuesday's sentences "reflected the severity of the crime", but added the government would study the ruling on individual sentences and decide whether to appeal them.

'Constitutional crisis'

Forty-seven people were initially charged after they were arrested in January 2021.

Thirty-one pleaded guilty, and 16 stood a 118-day trial last year, with 14 convicted and two acquitted in May.

The aim of the election primary, which took place in July 2020, was to pick a cross-party shortlist of prodemocracy candidates to increase their electoral prospects.

If a majority was achieved, the plan was to force the government to meet the 2019 protesters' demands – including universal suffrage – by threatening to indiscriminately veto the budget.

## Hush money trial: Prosecutors urge judge to postpone Trump's sentencing

President-elect Donald Trump's six-year New York criminal odyssey might need to continue for at least another four, prosecutors said Tuesday.

Lawyers for Manhattan District Attorney, Alvin Bragg wrote in a letter to Justice Juan Merchan that Trump should not be sentenced for his crimes until after he completes his second term in office. That would be the year 2029, more than a decade after the investigation into Trump's coverup of a "hush money" payment began.

"Consideration must be given to various non-dismissal options that may address any concerns raised by the pendency of a post-trial criminal proceeding during the presidency, such as deferral of all remaining criminal proceedings until after the end of defendant's upcoming presidential term," the filing said.

Merchan had been slated to rule on Nov. 12 on whether presidential immunity should have prevented jurors from seeing certain evidence at Trump's trial this spring, but he postponed his decision.

Merchan said he wanted to hear from prosecutors about how to proceed with the case, which entered uncharted terrain when Trump was reelected president.

Prosecutors said in their filings that they intend to oppose any effort by Trump to dismiss his case outright.

Trump's lawyers said in a previous letter that they would do so, claiming his election meant the case might cause "unconstitutional impediments to President Trump's ability to govern."

Prosecutors said in the short term, they are also unopposed to delaying Trump's sentencing, currently on the schedule for Nov. 26, while his attorneys awaiting and responding to his motion to dismiss.

Trump is the first person in American history to win the presidency after being convicted of crimes. He was



also the first former president to face trial for crimes.

Trump promised minutes after a unanimous jury found him guilty of felonies in May to fight his conviction. Weeks later, the Supreme Court ruled former presidents are immune from prosecution for official acts and that evidence related to Trump's work as president could not be used at trial.

Trump's lawyers argued the Supreme Court's ruling meant the conviction should be set aside, and his sentencing canceled. They said jurors heard testimony from former White House staff that should have been out of bounds during the trial.

The legal team was led by Todd Blanche and Emil Bove, who Trump has said he will appoint next year to senior posts in the U.S. Department of Justice.

Bragg's office has argued that the material protested by Trump's team was "a sliver of the mountains" of evidence the jury considered – so small it shouldn't mean tossing aside the jury's decision.

The jury found that Trump committed 34 felonies, largely by authorizing a plan to conceal reimbursements to Michael Cohen, his former attorney and fixer.

Cohen paid \$130,000 to adult film star Stormy Daniels, days before the 2016 presidential election, in exchange for her silence about an alleged sexual encounter with Trump. The payment has often been referred to as a "hush money" payment.

Trump insists he is not guilty of

falsifying business records — the charge he was convicted on — and has vehemently denied Daniels' story.

The Manhattan District Attorney's Office, then led by Cyrus Vance Jr., began investigating the "hush money" deal in 2018. It soon widened into an expansive probe into Trump's finances.

Trump assailed the investigation during his first presidency, fighting a subpoena to the Supreme Court, which in a landmark 2020 decision allowed the office to get Trump's tax returns.

When Bragg took office in 2022, he pared down the investigation, refocusing it on the "hush money" deal. A grand jury indicted Trump on March 31, 2023 and his trial began in April of this year.

The seven-week trial ended with his conviction. The jury deliberated for less than two days.

After hearing guilty 34 times, Trump turned around, clasped his son Eric's hand for a moment, and walked out of the courtroom.

Prosecutors were still packing their briefcases as Trump's voice could be heard from just beyond the doors

He was decrying the case, and campaigning for a return to the White House.

### **UK sanctions Russians over 'forcible** deportation' of Ukrainian kids

he UK on Tuesday slapped sanctions against 10 people and entities behind Russia's "forcible deportation and attempted indoctrination of Ukrainian children", 1,000 days after Moscow's full-scale invasion of Ukraine. The curbs target "those who prop up this insidious programme", the foreign ministry said, and follow similar sanctions in 2022 and 2023 against individuals and bodies involved in the alleged forced deportations.

They include several Russian officials and the All-Russian Young Army Military Patriotic Social Movement, a paramilitary organization that London said is "central" to the effort.

The sanctions are the latest imposed by Britain and Western allies in response to Russian President Vladimir Putin ordering troops into Ukraine in February 2022.

The measures have primarily targeted the Russian economy, aiming to reduce its ability to fund the war, but have also been

aimed at those accused of rights abuses.

"As Ukraine reaches the grim milestone of 1,000 days of bravely defending against Putin's illegal invasion, the UK's support is iron-clad," Foreign Secretary David Lammy said in a statement.

"With our international partners, we stand with Ukraine to confront Russian aggression

and fight for freedom, liberty and victory." Britain claims more than 19,500 Ukrainian children have been forcibly transferred or deported by the Russian authorities to Russia and temporarily occupied territories in Ukraine.

An estimated 6,000 Ukrainian children have been relocated to a network of reeducation camps, according to the Foreign Commonwealth and Development Office. Once there, they are subjected to indoctrination efforts which "seek to erode their Ukrainian identity and instil pro-Russian sentiments", it said.

The strategy dates back to Russia's illegal



annexation of Crimea in 2014, the ministry added.

"No child should ever be used as a pawn in war, yet President Putin's targeting of Ukrainian children shows the depths he will go to in his mission to erase Ukraine and its people from the map," said Lammy. Among those sanctioned by Britain on Tuesday was Tetiana Zavalska, the Russian-appointed head of Kherson Children's Home, from where London said 46 children were forcibly removed to Russia for adoption.

### Saudi Arabia executes over 100 foreigners in 2024 - Report

audi Arabia has executed more than 100 foreigners this year, according to an AFP tally.

The latest execut!on, on Saturday November 16, in the southwestern region of Najran, was of a Yemeni national convicted of smuggling drugs into the Gulf kingdom, the official Saudi Press Agency reported.

That brought to 101 the number of foreigners executed so far in 2024, according to the tally which is compiled from state media reports.

This is almost triple the figures for 2023 and 2022, when Saudi authorities had put to death 34 foreigners each year, according to AFP tallies.

The Berlin-based European-Saudi Organization for Human Rights (ESOHR) said this year's execut!ons had already broken a record.

"This is the largest number of executions India and Afghanistan, and one each of foreigners in one year. Saudi Arabia has from Sri Lanka, Eritrea and the never executed 100 foreigners in a year," Philippines. said Taha al-Hajji, the group's legal Saudi Arabia in 2022 ended a threedirector.

## Ukraine fires US-supplied long range missiles into Russia

ussia says Ukraine has fired USsupplied long-range missiles into the country, a day after Washington gave its permission for such attacks.

Ukraine used the Army Tactical Missile System (Atacms) in a strike on Russia's Bryansk region this morning (Tuesday), the ministry of defence in Moscow said.

Five missiles were shot down and one damaged, with its fragments causing a fire at a military facility in the region, it said.

The strike represents the first time the long-range missiles have been used on Russia's internationally-recognized territory after Washington signalled Ukraine had permission to do so. Russia has vowed to "react accordingly."

On Tuesday, Russia's foreign minister Sergey Lavrov said Russia would "proceed from the understanding" that the missiles were operated by "American military experts".

RUSSIA VOWS PROMPT RESPONSE "We will be taking this as a renewed face

of the western war against Russia and we will react accordingly," he told a press conference at the G20 in Rio de Janeiro.

Moscow said on Monday that any strikes inside its territory with the US missiles would prompt an "appropriate and tangible response".

Ukraine has already been using Atacms in Russian-occupied areas of its own territory for more than a year.

The missiles can hit targets at a range of up to 300km (186 miles) and are difficult to intercept.

Kyiv is now able to strike deeper into Russia using the missiles, including around the Kursk region, where Ukrainian forces hold over 1,000 sq km of territory. Ukrainian and US officials reportedly expect a counter-offensive in the region.

**EARLY MORNING STRIKE** 

In a statement, Russia's defence ministry said the strike was launched at 03:25 (00:25 GMT).

A fire caused by fallen debris from one of the missiles was quickly extinguished and there were no casualties, it said.

Ukraine's military earlier confirmed that it



had struck an ammunition warehouse in the Russian region of Bryansk, but it did not specify whether Atacms were used.

It said the attack, on a depot around 100km from the border near the town of Karachev, caused 12 secondary explosions.

## Doctor walks around hospital naked, performs sexual acts in front of workers

northeast Arkansas doctor's licence has been suspended after allegations he performed a sex act with a staff member as other workers watched.

Dr. David Diffine's licence was suspended on an emergency basis Oct. 14, according to records from the Arkansas State Medical Board.

The board found that Diffine's actions "exhibit an ongoing danger to the public in his continued practice of medicine."

Diffine operates three family practice clinics – the Diffiner Family Practice – in Blytheville, Paragould and Bono, according to his website.

The medical board says it received a complaint on July 17 that Diffine engaged in sexual contact with his staff, who are also his patients, and sexually

harassed those staff members.

The complaint was accompanied by a video from a security camera inside the clinic that allegedly showed Diffine "performing a sexual act with a staff member while other staff members were present and watching. The video also shows Diffine walking throughout the clinic naked," the records state.

Dr. Bradley Diner with the Arkansas Medical Foundation reviewed the video, according to records. He called the behavior "perverse" and recommended a formal professional evaluation.

The video, which has now been released to the public, shows Diffine walking around naked, including in the hallway between patients' rooms.

Diffine faces a disciplinary hearing



before the state medical board on Dec. 6.

In 2017, Diffine was under investigation after being accused of prescribing "excessive amounts of controlled substances." Those charges were dropped due to a lack of evidence, records show.

### Hezbollah agrees to ceasefire with Israel

ezbollah and Lebanon have reportedly agreed to a ceasefire with Israel, subject to a number of comments in the agreement as the US envoy to the issue, Amos Hochstein arrives in Lebanon.

Reuters reported on Monday night that Ali Hassan Khalil, an aide to Parliament Speaker Nabih Berri, announced that Lebanon and the Hezbollah terrorist organization have agreed to a ceasefire with Israel subject to several comments in the agreement.

"Lebanon presented its comments about the potential deal in a positive atmosphere," Khalil said, declining to provide further details. "The success of the initiative now depends on Israel," he added.

"The comments we made are fully based on UN Resolution 1701," he said. Khalil also referred to the Israeli air

strikes in Beirut, saying Israel was trying to "negotiate under fire."

He added that "the airstrikes do not affect Lebanon's position."

The US envoy to the issue, Amos Hochstein, made his way to Lebanon tonight, and according to reports in Lebanon, he is indeed there this morning (Tuesday).

Hochstein made the journey only after having understood from the Lebanese that the chances of an agreement are over 50 percent, since, according to Wint, without this he would not have come to the region, because he does not come to negotiations. He is expected to arrive in Israel this weekend.

US National Security Adviser, Jake Sullivan also addressed talks for a ceasefire tonight and expressed optimism that an agreement can be reached.

Sullivan told PBS, "There is no agreement yet, but we believe there is



progress, but we think both sides, both the Lebanese side and the Israeli side, have shown a willingness to do it and get it done in a short time."

### Hamas executes dozens of Palestinians accused of stealing aid

amas-controlled Interior Ministry officials in Gaza confirmed that over 20 local residents were killed by Palestinian security forces for allegedly stealing humanitarian aid.

The operation, carried out with the assistance of tribal committees, targeted individuals suspected of hijacking aid trucks entering the Gaza Strip.

According to reports, the victims were part of organized gangs that had taken control of aid shipments.

In a statement on Hamas's Al-Aqsa channel, officials declared that the operation was the start of a larger security crackdown aimed at eradicating theft from aid trucks, a crime that has caused widespread hunger in southern Gaza.

"These security actions will continue until the gangs behind the thefts are

e l i m i n a t e d, "officials said.

They also emphasized that the operation was not directed against the tribes themselves, but specifically focused on those involved in the theft of aid.

Despite the

involvement of some tribal members in the theft operations, Hamas officials defended the tribes' long-standing history of sacrifice, claiming that their involvement in the thefts would not tarnish their reputation.

The Ministry also reported that the security forces had intercepted communications between the thieves and Israeli forces, alleging that the latter had provided cover for the criminal



activities. The operation received support from Palestinian factions, who endorsed the crackdown as part of a broader national effort.

In recnt months, disturbing videos have surfaced showing Hamas militants torturing suspected aid thieves, with reports indicating that some victims were executed or left severely wounded.

### Harry Kane eyes future beyond 2026 World Cup, unveils statue at childhood club


moment."

Kane emphasized his commitment to short-term goals while expressing enthusiasm for the 2026 World Cup in the United States, Canada, and Mexico.

We'll see where we are and what to improve on, but I don't like to look too far ahead." Kane's journey from aspiring five-year-old to international star was celebrated with the unveiling of a statue and mural at the Peter May Sports Centre in east London, where he first played for Ridgeway Rovers.

"It's pretty special," Kane told BBC Newsround. "I played on these pitches as a five-year-old with dreams of playing for England, and I've been lucky enough to achieve that."

The England captain hopes the tribute will inspire the next generation of footballers.



"Hopefully, the boys and girls walking past will be inspired by the story of my journey, my life, and hard work."

Kane joked that securing a statue at Wembley Stadium would require winning a major international tournament. With the appointment of Thomas Tuchel as England's new manager starting January 1, Kane believes this is a realistic goal.

## NBA fines LaMelo Ball \$100,000 for homophobic remark

harlotte Hornets guard LaMelo Ball has been fined \$100,000 (£79,000) by the NBA for making what the league deemed an "offensive and derogatory" homophobic comment during a courtside interview.

The 23-year-old's remark came after the Hornets' narrow 115-114 win over the Milwaukee Bucks on Saturday. Ball was discussing his team's defensive strategy during the game's final moments, which saw Milwaukee's Giannis Antetokounmpo miss a crucial last-second attempt.

The specifics of the comment have not been disclosed, but the NBA deemed it in violation of its policies promoting inclusivity and respect.

Following the incident, Ball addressed the media after scoring 31 points in Sunday's 128-114 loss to the Cleveland Cavaliers.

"I really didn't mean anything and don't want to offend anybody. I've got love for everybody, and I don't discriminate," he said.

The \$100,000 fine is the maximum penalty

the NBA can impose for such conduct under its guidelines. The league has been consistent in penalizing players for discriminatory language, emphasizing its commitment to fostering an inclusive environment.

Ball's fine follows other recent sanctions by the NBA:

Anthony Edwards (Minnesota

Timberwolves): Fined \$35,000 (£28,000) for an obscene gesture towards fans during Friday's 130-126 overtime win against the Sacramento Kings.

Past Offenses: Edwards was previously fined \$40,000 in 2022 for using homophobic language on Instagram.

Kevin Durant (Brooklyn Nets, 2021): Fined \$50,000 for using homophobic and misogynistic language in private messages later made public.

The NBA continues to reinforce its zero-tolerance policy toward discriminatory behavior. By issuing

significant fines, the league aims to underline the importance of respect and inclusivity within the sport.

Fans and advocacy groups have expressed mixed reactions. Some applaud the NBA's firm stance, while others argue for more educational initiatives alongside punitive measures to promote understanding and prevent future incidents.

As the league navigates these challenges, the hope remains that players and teams will lead by example, fostering a culture of inclusivity both on and off the court.
