LAWMA seals office, cracks down on illegal waste disposal practices

he Lagos Waste Management Authority (LAWMA) has ramped up enforcement across the state, sealing off Ile Iyan, a business place located on Herbert Macaulay Way, Sabo, Yaba, for violating waste disposal rules.

The agency has also launched a major crackdown on illegal cart pushers to address growing environmental concerns.

Speaking on the action via their X page on Wednesday, LAWMA's Managing Director and CEO, Dr. Muyiwa Gbadegesin, revealed that the facility was shut down due to reckless waste disposal practices.

Gbadegesin said, "Our operatives discovered evidence of Ile Iyan's waste disposal at an illegal dumpsite near Aje Comprehensive High School's fence in Sabo, Yaba. Although the facility claimed to have enlisted with LAWMA, they were unable to provide any proof of registration or documentation. This left us with no choice but to seal off their premises to compel compliance."

Gbadegesin stressed LAWMA's commitment to strict enforcement, insisting that all businesses in Lagos must adhere to waste management

regulations to ensure a cleaner, healthier environment for residents.

"Every business operating in Lagos must be registered with LAWMA and comply with approved waste management guidelines. Defaulters will face strict penalties, including the sealing of their premises. This will help us safeguard our environment, making it livable for all residents."

Also, the agency also extended its crackdown to illegal cart pushers operating in areas like Ejigbo, Isolo, and Somolu. Gbadegesin described these cart pushers as a significant threat to LAWMA's efforts, accusing them of indiscriminate waste dumping that harms the environment and endangers public health.

"These illegal cart pushers are sabotaging our work. They dump waste carelessly, degrading the environment and putting residents at risk of serious health problems. We urge Lagosians to stop patronizing them. Anyone caught will face arrest and prosecution. Instead, residents should use assigned PSP operators for proper waste disposal," he said.

Referring to the legal basis for LAWMA's actions, Gbadegesin highlighted the Lagos State



Environmental Management and Protection Law.\

"Section 82 (1) of the law clearly states that dumping waste in unauthorised locations, such as road medians, is illegal. Offenders risk fines of not less than N25,000 and potential jail term under Section 109. These regulations exist to protect our environment and the health of Lagosians," Gbadegesin noted.

LAWMA is working closely with other state agencies, including the Lagos State Environmental Sanitation Corps (LAGESC), to prosecute violators and uphold environmental standards.

Moreso, Gbadegesin highlighted, "There is no hiding place for defaulters. With the support of sister agencies, we will continue to arrest and prosecute those who flout waste management laws. Our goal is to make Lagos cleaner, safer, and more sustainable for everyone."

120 Afghan couples marry in mass wedding ceremony

The Afghan caretaker government



has repeatedly called on people to prevent irrational marriage customs and avoid wasting money on wedding ceremonies.

Stranded Zamfara students in Cyprus: Parents seek Lawal's intervention

he parents and guardians of the Zamfara students stranded in . Cyprus have called for Governor Dauda Lawal's urgent intervention.

The Chairman of the parent's association, Ibrahim Tudu, made the appeal while addressing newsmen in Gusau on Wednesday.

Tudu called on the state government to take tentative measures to rescue their children.

He said, "This is to highlight our concern about the condition of our 88 children sent on scholarship by the Zamfara Government studying various courses at Cyprus International University Nicosia, facing numerous problems currently.

"We would like to clear that the affected students are bonafide indigenes and citizens of Zamfara from decent backgrounds and families.

"They secured the offer of

scholarships to study in Cyprus based on their academic performances, competency examinations and screening interviews, all conducted by the State Scholarship Board under the previous administration," he said.

"I would like to use this medium to inform the state government based on our daily communication with all the 88 students currently in Cyprus that they are facing numerous problems.

"They are facing lack of feeding, accommodation, upkeep allowances, their safety, studies and serious state of mental health as a result of the nonpayment of registration, tuition and students' allowances."

Tudu added that the students were now in great pain and encountering a lot of hardship as they were ejected from theirschool accommodation.

"They are now living in a Mosque and rented houses where they are being harassed for non-payment of rent.

"In fact, the female students among



them are facing multiple problems," he lamented.

According to Tudu, the student's International Passports and Cyprus resident permits had since expired and they were at the risk of being caught at the other side of the law of foreign land.

"Thy are facing various challenges that may lead to their detention, imprisonment, and deportation to Nigeria as well as risking their lives.

'F**k you' - Brazil's first lady swears at Elon Musk at G20 event

block accounts accused of spreading "fake news" and hate messages.

X was cleared to resume service in Brazil last month, after it reversed course and started complying with the court rulings.

I-G sues Andy Uba, others over alleged N400m fraud

he Inspector-General (IG) of Police, Mr Kayode Egbetokun, has sued former Senator representing Anambra South, Andy Uba, and two others, for alleged fraud The IG, in a two-count charge marked: FHC/ABJ/CR/538/2024 filed before Justice Inyang Ekwo of a Federal High Court in Abuja, joined Crystal Uba and Benjamin Etu as 2nd and 3rd defendants respectively.

The charge, dated Oct. 8, was filed on Oct. 10 by Abdulrashid Sidi in the Legal/Prosecution Section at the Police Force Headquarters, Abuja.

In count one, Uba, Crystal, Etu and Hajiya Fatima now at large, sometimes in 2022, were alleged to have conspired amongst themselves to commit the offence.

Una and others were accused of obtaining by false pretence, by making a presentation to George Uboh that they had perfected ways for the appointment of the Managing Director of Niger Delta Development Commission (NDDC) to any

interested persons who could afford N400 million.

"A presentation which you know is not true and thereby committed an offence contrary to Section 8 and punishable under Section 1 (3) of the Advance Fee Fraud and other Fraud Related offences Act, 2006."

In count two, the defendants and Fatima, who is at large, in 2022 within the jurisdiction of the court, were alleged to have conspired amongst themselves with intention to defraud and induced George Uboh by making a presentation to him that they had perfected way to give an appointment of the post of Managing Directorship of NDDC to any interested person who could afford the sum of N400

"A presentation which you know is not true. You obtained the money and converted it into your own personal use and thereby committed an offence contrary to Section 1 (2) and punishable under Section 1 (3) of the Advance Fee Fraud and other Fraud Related offences Act, 2006," the count



read in part.

Uboh, in a letter dated April 5, 2023, and addressed to the I-G, said the petition was based on documentary and voice recording.

According to Uboh, the evidence is overwhelming and irrefutable.

No fewer than six witnesses had been listed to testify against the exlawmaker and others.

Justice Ekwo adjourned their arraignment until Feb. 18, 2025.

The adjournment followed a complaint by M.L. Anthony, who appeared for the I-G on Nov. 13, that the defendants had been evading the service of the court documents despite being given administrative bail.

Anthony told the court that they had been on the matter since 2023.

Man to sweep court premises for 3 weeks over tiles theft

Kaduna Chief Magistrates' Court on Wednesday, ordered an unemployed man, Vincent Danladi, to sweep the court premises for three weeks for stealing one carton of floor tiles and other items worth N130,000.

The police had earlier charged Danladi, 30, of Ungwan Pama in Kaduna, with

Powerful people outside N'Delta behing oil theft – Tompolo

ormer Niger Delta militant leader and founder of Tantita Security Services Nigeria Limited, Government Ekpemupolo, alias Tompolo, has said he has become a target of attack by the powerful people behind oil theft in the country.

The Gbaramatu king insisted that the oil thieves are powerful people outside of the Niger Delta.

Speaking at Oporoza, the headquarters of the Gbaramatu Kingdom, on Monday, Tompolo, alleged that some naval personnel, a few days ago, forcefully attacked operatives of the private outfit during the arrest of some suspected oil thieves along the Port-Harcourt creeks.

Speaking during a working visit of the Nigerian Bar Association national executive, led by its President, Afam Osigwe (SAN), to the oil-bearing community, Tompolo called for synergy between the Navy and other security outfits.

Tompolo noted that in the course of the surveillance operations to round up crude oil barons, Tantita had stepped on toes and had become the target of revenge missions.

He said, "While doing this work, we have stepped on a lot of toes of people over there in Lagos and Abuja. We have stepped on a lot of toes. As I am here, after my court cases, I cannot travel anywhere because of me and the key people (barons) fighting this battle.

"If I want to travel to Abuja to visit you, I must go with security. Even with two or three security personnel, none of them are happy with me, and they are now collaborating with top players involved in oil theft.

"Most times, you see that Tantita Security now has confrontations with the Navy and every well-meaning Nigerian knows the function of the Nigerian Navy and Tantita, but nobody wants to come out to face the truth.

"If we happen to arrest anybody now,



we would get a lawyer from Abuja, Lagos or Ibadan to do the case very well."

The former warlord expressed worry that efforts to checkmate crude oil theft were being sabotaged in some quarters.

"Some few days back, our people intercepted a vessel in Port Harcourt, where the Nigerian Navy was shooting at Tantita Security, with police, Department of State Services and Nigeria Security and Civil Defence Corps.

"We want to implore and beg you (NBA). You must play in this present situation, because if we are not careful in this country, maybe we will not have money to do any reasonable thing.

"All of us here know that Nigeria is facing hardship. A bag of rice is over N100,000.

"We are going to do our part locally. But you (NBA) are there at the top. If we make arrest today, lawyers would stand on the other side and this side.

"Can somebody come to load a vessel of 500 metric tonnes in this community? Nobody has that capacity; the person comes from Lagos, Abuja, or neighbouring countries.

"The man here would be a water boy for the people in charge. That is the one we would arrest," he said.

Efforts by NEW DAILY PRIME to reach the Nigerian Navy spokesman, Commodore Aiwuyor Adams-Aliu, for comments on the issue, were

unsuccessful at the time of filing this report.

A unidentified female official in the Naval Public Relations Office said she "had been transferred to Lagos," just as she maintained that "Commodore Adams-Aliu is in the best position to react to the issue." Speaking earlier during a courtesy call on the Pere of Gbaramatu kingdom, Oboro-Gbaraun II, in his palace, the NBA President expressed delight over the recent announcement from the Nigerian National Petroleum Company Limited that oil production had risen to 1.8 million barrels per day, with a promise to increase it up to 2 million bpd by the end of this year. "If the oil production keeps going

up, it will benefit all of us and the government will be able to provide for the needs of the people," he

Consequently, the NBA president maintained that "there is a need to stem the theft of our commonwealth.

"The fight against oil theft is more desirable now, more than ever before, because Nigeria is borrowing so much to fund its budget and cannot meet the needs of Nigerians."

Senate sacks Code of Conduct Tribunal chairman, Umar over misconduct

he Senate, citing Section 157 (1) of the 1999 Nigerian Constitution (as amended), has removed Yakubu Danladi Umar from his position as Chairman of the Code of Conduct Tribunal (CCT) over alleged gross misconduct.

Senators deemed Umar's actions as incompatible with the responsibilities of his office, describing his behaviour as unacceptable for such a sensitive position.

The decision to remove Umar was supported by an overwhelming majority, with 74 senators signing the motion and 10 others present, bringing the total to 84 in favour.

Deliberations on the matter began during a closed-door session at 1:17 PM on Wednesday. The session, which lasted until 2:36 PM, culminated in a motion to sack Umar, led by Senate Leader Opeyemi Bamidele (APC, Ekiti Central) and seconded by Senate Whip Mohammed Tahir Monguno (APC, Borno North).

It was titled, "Invocation of the provision of Section 157 (1) of the Constitution of the Federal Republic of Nigeria 1999, as amended for the removal of the Chairman of the Code of Conduct Tribunal."

According to Bamidele, 'The Senate notes that the Code of Conduct Tribunal is one of the key components of Federal Institutions in the country, saddled with the sacred statutory responsibilities of maintaining high standard of morality in the conduct of government business and to ensure that the actions and behaviours of public officers conform to the highest standard of public morality



and accountability;

"Also notes that a statutory institution of such magnitude is expected to be an epitome of moral rectitude and should be seen to uphold the virtues of integrity, probity and accountability. However, the conduct of Mr. Yakubu Danladi Umar, who is the Chairman of the Tribunal has fallen short of the requisite standard of a public officer to conduct the affairs of such Tribunal;

"Concerned that the Senate has been inundated with series of petitions and allegations corruption/misconduct against the Chairman, a situation that necessitated the 9th Senate, through the Senate Committee on Ethics, Code of Conduct and Public Petitions to invite him to series of its investigative hearings in order to unravel the circumstances surrounding those allegations."

"However, he appeared before the Committee only once and thereafter avoided subsequent invitations;

"Also concerned about his alleged

absenteeism from office for more than one month, without permission and recuse to his position, coupled with preponderance of corruption allegation, misappropriation, and physical street brawl with a security man in the FCT vis-à-vis his current investigation by the EFCC, ICPC and the DSS. All these are tantamount to acts of negligence and gross misconduct, unbecoming of a Chairman of such a reputable Tribunal:

"Aware of the series of overwhelming allegations against the Chairman, Mr. President, Senator Bola Ahmed Tinubu. GCFR, forwarded the name of Mr. Abdullahi Usman Bello to the Senate for confirmation as the new Chairman of the Tribunal, and at the Plenary Sitting of the Senate on Thursday, 4th July 2024, his appointment was duly confirmed, hence the need for the erstwhile Chairman to vacate the office for the substantive Chairman resume office officially."to

Weapons from Libyan stockpiles flow to terror groups in Nigeria

errorists that plague northern Nigeria are arming themselves with weapons that originated in Libya, according to Nigerian defence officials.

Weapons traffickers in Nigeria are benefiting from instability across the Sahel, particularly in Niger, which has become a key transit point for weapons taken from Libyan stockpiles. Those weapons have moved into other Sahel countries as well as Nigeria, according to the Small Arms Survey.

"When we talk about the proliferation of arms, first, you have to look at what happened in Libya years ago and in the Sahel," Nigerian Maj. Gen. Edward Buba said during a recent briefing.

"Now, this gave the opportunity for arms to get into the wrong hands and then filtered into our country, which worsened the issue of insurgency and terrorism that we were faced with in the country."

In late October, Nigeria's National Centre for the Control of Small Arms and Light Weapons destroyed 2,400 weapons confiscated from criminals across the country. Johnson Kokumo, the center's director-general, said Nigeria would not tolerate the illegal trafficking of weapons into the country.

"These frameworks underscore the importance of transparent documentation and the responsible disposal of recovered arms, ensuring that they do not find their way back into the hands of criminal elements," Kokumo said during the destruction ceremony in Abuja.

The volume of illicit weapons into Nigeria has been described as "like rice on the market," with much of that traffic being traced back to Libya.

"This unlimited and unchecked proliferation of illegal arms has reached an epidemic level in Nigeria in recent times with attendant



national security implications," analyst Dakuku Peterside wrote for The Cable. The flow of weapons contributes to violence, crime and insecurity in the country.

The 2011 collapse of the Libyan government under former dictator Muammar Gadhafi left the country's massive weapons arsenals largely unguarded. The United Nations estimated in 2020 that Libya had as much as 200,000 tons of weapons at the time of its collapse. The subsequent civil wars made the security of Libya's weapons stockpiles even worse.

"Those weapons were sitting virtually unguarded, destined for markets in the Sahel down south," Defence News Nigeria wrote on X.

"At the apex of its power the Boko Haram campaign was being fueled by large scale heavy weapons supplies from [Gadhafi's] looted vast arms stockpile."

Beyond its own stockpiles, Libya has also become a source of foreign weapons — many of them made in Russia and brought to the country by mercenaries connected to the former Wagner Group, now known as Africa Corps. Russia also uses Libyan ports to supply weapons to military juntas ruling Burkina Faso, Mali and Niger.

Many of those weapons ultimately end up in the hands of terrorists in northern Nigeria, threatening civilians and Soldiers alike. Experts say terrorists have also captured weapons during raids on military outposts.

In 2020, the Small Arms Survey estimated that Nigeria had 6.2 million small arms in the hands of civilians compared to about 580,000 in the hands of security forces.

The presence of illicit weapons creates a vicious cycle of instability as local communities arm themselves to defend against terrorists and criminals, according to experts. That's especially true in communities that feel ignored or overlooked by government security forces

"Surging illicit arms flows have increased the availability of firearms in many communities," researchers with the Small Arms Survey wrote in a study

"Formerly low-level local conflicts thus risk violent escalation as traditional weapons — or, indeed, peaceful means of dispute settlement — are replaced with modern firearms."

Police rescue kidnap victim, recover vehicle in Rivers

peratives of the Rivers State Police Command have rescued a kidnap victim and recovered an operational vehicle in Oyigbo, Rivers State.

According to a press release from the Command's spokesperson, Grace Iringe-Koko, the incident occurred on November 17 at about 8:23 p.m.

Iringe-Koko said a distress call was received indicating that four armed men, operating in a black Toyota Corolla kidnapped one Madabuchi Julius at Sabbath Filling Station in Oyigbo, after firing sporadically to scare off bystanders.

Iringe-Koko noted that Police operatives were immediately mobilized to the scene.

The police spokesperson added that on sighting the officers, the kidnappers attempted to escape in their vehicle.

Iringe-Koko noted that a high-speed chase ensued, culminating in a gunfight along Egbu Street, Oyigbo.

"Overpowered by the police's superior firepower, the kidnappers abandoned their victim and the operational vehicle, fleeing the scene. The victim was rescued unharmed, and the vehicle, with registration number RIVERS PHC 938 AH. was recovered", Iringe-Koko said.

Iringe-Koko said investigations are ongoing, with efforts intensified to apprehend the fleeing suspects and recover their weapons.

In a related development, on November 18 at about 10:48 p.m., police operatives carried out a covert operation on St. Lorinta Street, Oyigbo, acting on credible intelligence.

During the operation, Iringe-Koko said a 25-year-old Gabriel Morris, a resident of Mercy Ground, Kom-Kom, Oyigbo LGA, was apprehended.

During interrogation, Morris confessed to being a member of a criminal syndicate that has been terrorizing Oyigbo and its environs. Items recovered from him include a locally made pistol and a quantity of weeds suspected to be Indian hemp.

The Rivers State Police reiterated its commitment to combating kidnapping

and other crimes across the state.

Iringe-Koko said efforts are ongoing to apprehend Morris's accomplices and dismantle the syndicate.

Iringe-Koko commended the swift and coordinated efforts of the operatives, emphasizing the Command's dedication to ensuring safety and security in Rivers State.

Rumors online suggested that Adenuga, 71, had died, prompting widespread reactions.

However, in a post on X (formerly

He disclosed that he had a phone conversation with Adenuga, who confirmed he remains an active contributor to Nigeria's economy.

Oil Revenue: Governor Bala Mohammed calls for transparency

Bauchi State Governor, Bala Mohammed, has raised concerns over the failure of state governments to benefit from the improved revenue generated by Nigeria's oil sector.

Despite the rise in oil revenue, the governor claims that funds are not being properly credited to the Federation Account for distribution a mong the three tiers of government.

The governor, who also serves as the Chairman of the People's Democratic Party (PDP) Governors Forum, made these comments during a visit by the Minister of Finance and Coordinating Minister of the Economy, Wale Edun, ahead of the 2024 Conference for the National Council on Finance and Economic Development held in Bauchi State.

He urged the Federal Government to provide a clear explanation to the public about why oil revenues have not been adequately remitted for distribution, as mandated by law.

"It's a miracle that we are one of the biggest oil-producing nations, but we have not benefited for some time since you came on board," Mohammed said.

"You have to explain that this is what you are going through. That is inclusion. And if you don't say it, nobody will know. But some of us know. We call this leadership and responsibility."

He emphasised the importance of ensuring that the country's oil and gas sector not only produces but also contributes significantly to the national Treasury for equitable sharing among federal, state, and local governments.

"You must provide financial services to us at the subnational level. Financial services that will help us enhance our productivity," he added.



Governor Mohammed's remarks come amid ongoing concerns over the state of revenue generation and distribution, particularly in the oil sector.

The Nigerian National Petroleum Corporation Limited (NNPCL), the country's key revenue-generating agency, has faced challenges in remitting funds to the Federation Account, especially during the period when fuel subsidies were in place.

In recent years, NNPCL struggled to contribute to the Federation Account, with no remittances made in 2022. This was largely due to the massive subsidies on Premium Motor Spirit (PMS), which drained much of the oil revenue.

However, following the removal of fuel subsidies, the NNPCL has been able to start remitting funds again, contributing N4.5 trillion between January and September 2023.

Despite this, Governor Mohammed expressed frustration that the expected improvements in disbursement have not yet been felt at the state level. He urged the Federal Government to ensure more transparency in the process, as stakeholders anticipated better distribution after subsidy removal and the deregulation of the sector, which led to an increase in petrol prices.

In response to the governor's

remarks, the ruling All Progressives Congress (APC) criticised PDP governors, including Mohammed, for making claims without providing concrete evidence. Nze Chidi Duru, Deputy National Organizing Secretary of the APC, urged the Bauchi governor to offer specific details to substantiate his claims.

"Senator Mohammed must put down those evidence on the table for further elaboration. It is only at that point that we can then, as a political party, venture to take on the issues in a very objective manner," Duru stated.

He also emphasised that under the current administration, the distribution of revenue has improved significantly, benefiting states and local governments more than ever before.

Duru noted that state governments should focus on identifying and addressing any inefficiencies in the system to ensure that all funds are properly accounted for and used effectively.

The debate highlights ongoing tensions between the federal government and state leaders regarding the management and allocation of Nigeria's oil wealth, with both sides calling for greater transparency and accountability in the system.

Dangote refinery's fuel export to W'African countries begins

fter a long wait, the Dangote Petroleum Refinery has flagged off exporting refined petroleum products to neighbouring West African countries.

According to a report by Bloomberg on Tuesday, quoting data sourced from Vortexa, Kpler, Precise Intelligence, and ship-tracking platform, a tanker has hauled a shipment of gasoline from the Dangote Petroleum Refinery to waters off the coast of Togo, a neighbouring country.

The report said a CL Jane Austen recently loaded more than 300,000 barrels from Dangote and sailed west. Last month, the chairman of the Ghana National Petroleum Authority, Mustapha Abdul-Hamid, said the country is considering buying petroleum products from the Dangote refinery to help the country cut more expensive exports from Europe which cost the country about \$400m monthly.

Abdul-Hamid, who spoke at the OTL Africa Downstream Oil Conference in Lagos, said importing from Nigeria rather than Europe would reduce the prices of other goods and services by removing freight costs.

He said, "If the refinery reaches 650,000bpd a day capacity, all that volume cannot be consumed by Nigeria alone, so instead of us importing as we do right now from Rotterdam, it will be much easier for us to import from Nigeria and I believe that will bring down our prices."

Reports had it two weeks ago, the refinery was set to begin fuel exports to South Africa, Angola, and Namibia.

It added that four other African countries – Niger Republic, Chad, Burkina Faso, and Central Africa Republic – had also started negotiations with the refinery.

A hihly credible source, who confirmed the development, said the management of the 650,000bpd capacity refinery was at the advanced stages of talks with the countries to start lifting fuel.

"I can confirm to you that talks are actually at the advanced stage with Ghana, Angola, Namibia, and South Africa, while the initial discussion is coming up with Niger, Chad, Burkina Faso, and the Central African Republic," the source said.

The report further stated that the

petroleum product shipment is now floating off the coast of Lome, a popular area for ship-to-ship transfers. However, it not also not certain where the CL Jane Austen's cargo will ultimately end up.

Although it's off Togo, the area is often used for Ship-to-ship transfers, meaning the fuel could subsequently be taken elsewhere.

aid, "While the shipment is tiny in the context of the global gasoline market, it signals the ramp-up of Dangote's production and the potential to export significant volumes of gasoline beyond Nigeria, which could upend regional markets."

The refinery last month shipped its first seaborne gasoline cargo to the nearby commercial hub of Lagos.

Whether large amounts of Dangote's gasoline output end up being exported remains o be seen.

Last month, the Federal Government ended its state-owned oil company's monopoly on buying the fuel from the plant for domestic use but has allowed the continued importation of fuel from Europe and the US in line with the regulatory act.

Five soldiers, 30 terrorists killed as B/Haram attacks troops in Borno

he Defence Headquarters has confirmed a surprise attack by Boko Haram/ISWAP terrorists targeting troops engaged in stabilisation operations in Gubio Local Government Area (LGA) of Borno State.

Major General Edward Buba, the Director of Defence Media Operations, in a statement, said five soldiers were killed, ten wounded, and four declared missing during the assault.

He, however, said the troops eliminated several terrorists and recovered weapons.

"The attack resulted in the destruction of equipment, including one gun truck, three TCVs, and an excavator," the statement said.

He said a reinforcement team, supported by an air component, was dispatched to pursue the attackers.

A military source told journalists that the insurgents launched multiple assaults in an attempt to overrun a special military force stationed in the Kareto community of Gubio LGA.

"Yesterday, five soldiers were killed in another attack, while over 30 terrorists were eliminated in subsequent engagements today without further casalties on our side," the source said.

The special forces had recently arrived in Kareto and begun preparations, such as digging trenches, to facilitate the return of displaced villagers when the insurgents launched their attacks.

These incidents are part of a resurgence of violence in the Lake Chad region, where insurgents have launched frequent assaults despite recent successful operations by the Multi-National Joint Task Force (MNJTF). Last month, 40 soldiers were killed during an attack on a military base, prompting Chadian President Mahamat Déby Itno to initiate an operation that neutralised many terrorists and forced their remnants to retreat into Niger Republic.

Meanwhile, the Borno State Government has expressed its condolences to the military following the loss of soldiers during the Boko Haram attack in Kareto, Gubio LGA. In a statement by the Commissioner for Information and Internal Security, Usman Tar, the government described the incident as a painful reminder of the cruelty of Boko Haram terrorists.

"On behalf of the government and good people of Borno, I convey our heartfelt condolences to the armed forces and families of the deceased over the demise of our fellow compatriots. May Allah rest their souls and grant fortitude to the affected families," the statement read. The government reaffirmed its solidarity with the armed forces and its commitment to supporting efforts to end insurgency in the region.

CAC partners with Indian professionals, business community to enhance company registration

Teenager brutalized, locked inside cage for visiting female classmate in Delta

Samuel Onyeme, aged 17, was allegedly beaten and locked inside a dog cage for visiting a female classmate, Miss Anastasia Celestine on Sunday.

According to Punch, the incident happened when Onyeme visited his female classmate in her residence around 6:pm.

On Monday, Mrs Onyeme, the victim's mother, narated the unsavoury experience she received at Mr Celestine's house.

Part of her statement read, "My son, Samuel, a 17-year-old Senior Secondary student of Redeemers International High School, Asaba, Delta State, on Sunday, visited his classmate, Anastasia Celestine, at her residence after she invited him.

"My son said they were having a discussion outside the house of Mr Celestine when he was brutally assaulted by her father and his two sons.

"They attacked him on the street, dragged him into their compound, and inflicted severe physical injuries on him. You see his head, he said they used wooden planks and locked him inside a dog cage.

"During the assault, they confiscated his mobile phone and called me, deceiving me into coming to the scene. Upon my arrival, I was deprived of seeing him for two hours." She said her daughter, Jessica, who was outside attempting to seek help, was also assaulted by members of the Celestine family when she tried to reenter the compound.

"The situation escalated when Ben, the other of my sons, who is the elder brother to Samuel, contacted a family friend, who then reached out to a human rights organization before they mobilized police, officers were mobilized to rescue Samuel from the dog cage around 10:00 pm that night." Speaking further, a human rights activist, Mr Victor Ojei, who reported the incident to the Delta State Police



Command, on Tuesday said he mobilized the police before Samuel was rescued from the dog cage, and described the act as barbaric and inhumane.

Ojei, in a petition addressed to the Commissioner of Police, Delta State Police Command, demanded the immediate investigation and prosecution of Mr Celestine and his sons for kidnapping, unlawful detention, assault, and attempted murder in line with the provisions of Nigerian Criminal Law and the Violence Against Persons (Prohibition) Laws.

The petition, copied the Attorney General, Ministry of Justice, Asaba, Delta State and the State Coordinator, National Human Rights Commission, Asaba, Delta State, called for justice.

"One Onyeme Ben contacted a family friend, who then reached out to our organisation. Following our report to the Delta State Police, officers were mobilised, and Master Onyeme Samuel was rescued from the dog cage around 10:00 pm that night.

"Based on the above facts, Mr Celestine

and his sons have committed criminal offences which include unlawful detention of Mrs. Onyeme Onome for two hours against her will, and the forcible confinement of Master Onyeme Samuel in a dog cage from 6:00 pm to 10:00 pm.which contravenes Section 364 of the Criminal Code Act.

"The brutal assault on Master Onyeme Samuel using wooden planks, resulting in multiple injuries and psychological trauma, is a violation of Section 355 of the Criminal Code Act. "Attempted murder; threats to pour fuel and set Master Onyeme Samuel

"Attempted murder; threats to pour fuel and set Master Onyeme Samuel ablaze amount to attempted murder under Section 320 of the Criminal Code Act."

It was learnt that the victim, Samuel, is currently receiving treatment at the Asaba Specialist Hospital as a result of physical injuries and psychological suffered during the incident.

When contacted, the Police Public Relations Officer in the state, SP Bright Edafe, said he hadn't received the report of the incident as of the time of filling this report.

N4.6bn unapproved spending uncovered in Works ministry – Report

inancial irregularities totalling over N4.64bn in the Federal Ministry of Works (Housing Sector) were discovered after an audit report, raising concerns about systemic non-compliance with financial regulations and procurement laws

This development was revealed in the Auditor-General for the Federation's (AGF's) Annual Report, which covers activities between 2020 and 2021 and reveals significant lapses in internal controls under Babatunde Fashola, the former Minister of Works and Housing.

The report details several issues, including payments made without proper documentation, extrabudgetary expenditures, mobilization fees exceeding approved thresholds, and contracts awarded without following due process.

According to the report, N1.08bn was paid from the Government Integrated Financial Management Information System account without the requisite payment vouchers, violating Paragraph 601 of the Financial Regulations, 2009.

Also, N546m was transferred to project accounts without adequate documentation or budgetary provision.

The Auditor-General's report attributed these anomalies to weak internal control mechanisms in the Ministry and warned of risks such as fund misappropriation and loss.

Despite queries, the ministry failed to respond to these issues.

The Auditor-General recommended that the Permanent Secretary justify the payments, recover the funds, and remit them to the Treasury.

The audit report also recommended that evidence of compliance should be submitted to the National Assembly's Public Accounts Committees, failing which sanctions under Paragraph 3106 of the Financial Regulations should apply.

The audit unearthed extra-budgetary expenditures amounting to N2.89bn, including N1.88bn spent without legislative appropriation.

Also, over N1bn was paid to contractors for road projects in Katsina State, which were only included in the 2017 Appropriation Act.

These expenditures contravene Section 80(4) of the 1999 Constitution, which mandates legislative approval for all withdrawals from public funds.

The audit report read, "The sum of N1,883,795,670.51 (One billion, eight hundred and eighty-three million, seven hundred and ninety-five thousand, six hundred and seventy naira, fifty-one kobo) was expended by the Ministry without evidence of appropriation.

"The sum of N1,003,039,708.79 (One billion, three million, thirty-nine thousand, seven hundred and eight naira, seventy-nine kobo) was paid to four contractors for the construction of roads in Daura, Katsina State. The project was budgeted for in the 2017 Appropriation Act, and;

"Approval for the extra-budgetary expenditures in (i) and (ii) above, totalling N2,886,835,379.30 (Two billion, eight hundred and eighty-six million, eight hundred and thirty-five thousand, three hundred and seventynine naira, thirty kobo) by the National Assembly was not presented for audit.

"The above anomalies could be attributed to weaknesses in the internal control system at the Federal Ministry of Works (Housing Sector)."

The lack of adherence to financial accountability standards raises concerns about the potential diversion of public funds.

No response was provided by the Ministry to clarify these expenditures. The report called for the recovery of the unauthorised funds and recommended sanctions for those responsible under

relevant financial regulations.



companies not registered with the Corporate Affairs Commission.

Of this amount, N170.36m was paid to unregistered entities, and a company awarded a contract in 2016 was only registered in 2019, contravening the Public Procurement Act, 2007, and the Companies and Allied Matters Act, 2020.

The absence of legal registration increases the risk of contract non-execution, fund mismanagement, and payment to ghost entities.

The audit report noted, "Payment for Contracts totalling N493,967,484.24 (Four hundred and ninety-three million, nine hundred and sixty-seven thousand, four hundred and eighty-four naira, twenty-four kobo) were made to non-existing companies.

"The sum of N5,825,989.28 (Five million, eight hundred and twenty-five thousand, nine hundred and eightynine naira, twenty-eight kobo) was paid to a contractor vide payment voucher with Ref. No PROC/PBHD/CAP1345/2020 dated 30th December, 2020, out of the total contract sum of N493,967,484.24 without the company being incorporated

"Three contractors were paid a total of N170,355,961.05 without evidence of incorporation with the Corporate Affairs Commission (CAC).

"A company that was awarded a contract on the 25th of November, 2016 was incorporated with CAC on the 16th of August, 2019.

Senate set to approve Tinubu's \$2.2bn loan request

he Nigerian Senate is expected to approve President Bola Tinubu's \$2.2 billion loan request today, Wednesday, November 20, as part of the government's strategy to address the N9.7 trillion deficit in the 2024 fiscal year budget. The loan is a crucial component of the

The loan is a crucial component of the external borrowing plan tied to the N28.7 trillion budget proposal for the upcoming year.

President Tinubu formally submitted the loan request to the Senate and House of Representatives in separate letters read during the plenary sessions on Tuesday, November 19.

The funds will contribute to financing a portion of the budget deficit, which the government has outlined as a priority for the fiscal year 2024.

Senate President Godswill Akpabio promptly tasked the Senate Committee on Local and Foreign Debts to review the loan request and submit a report within 24 hours.

Akpabio emphasised the need for swift approval, stating, "The Presidential request for \$2.2 billion, equivalent to N1.77 trillion, is already enshrined in the external borrowing plan for the 2024 fiscal year."

The Senate is expected to consider the request with urgency, paving the way

for approval of the much-needed loan. The loan is part of a broader strategy to address Nigeria's growing fiscal deficit, as the government aims to balance its budget and stimulate economic growth in the face of rising expenditures.

In addition to the loan request, President Tinubu also submitted the Medium-Term Expenditure Framework (MTEF) and Fiscal Strategy Paper (FSP) for the period 2025–2027.

The MTEF/FSP documents, which include key parameters for the country's future economic planning, will be examined by the Senate Committee on Finance, National Planning, and Economic Affairs. A report on these documents is expected within one week.

The proposed framework includes a \$75 oil price benchmark per barrel, a daily oil production target of 2.06 million barrels, and an exchange rate of N1,400 to \$1.

The government is also targeting a GDP growth rate of 6.4 percent, which forms the foundation for the proposed N47.9 trillion budget for 2025.

In related news, President Tinubu forwarded the Social Investment Programme Amendment Bill to the National Assembly. The bill aims to strengthen the framework for social welfare programs in Nigeria, promoting greater transparency and efficiency in the delivery of social protection to vulnerable citizens.

The proposed amendment seeks to establish the National Investment Register as the primary tool for targeting beneficiaries of these welfare programs.

"The amendment will make our social and welfare programs more transparent, efficient, and impactful in addressing the needs of vulnerable Nigerians," President Tinubu said in his submission.

If approved, the bill is expected to enhance the effectiveness of the country's social welfare initiatives, helping to alleviate poverty and reduce inequality across the nation.

The Senate has referred the bill to the relevant committees for further review, with deliberations expected in subsequent sessions.

This series of legislative moves highlights President Tinubu's administration's focus on fiscal responsibility, social welfare reform, and economic growth as it moves to address the country's financial challenges in the coming years.

Body autonomy as a fundamental human right



NBA YoungBoy pleads guilty in major fraud case

S rapper NBA YoungBoy, whose real name is Kentrell Gaulden, has entered a guilty plea in a case involving serious charges of drug

Ukraine criticizes closure of Western embassies

kraine has urged Western embassies, which closed today over fears of Russian shelling, not to stoke tensions, stressing that since Russia's invasion began, the threat of Russian strikes it is "everyday" in the country, France Press reported, BTA reported.

At least five Western embassies – of the US, Spain, Italy, Hungary and Greece announced they were temporarily closing today due to the threat of an air strike amid increasingly harsh rhetoric from Russia.

The air raid warning system sounded in Kiev several times last night and today during the day. Russian drones were shot down and there were no reports of casualties, AFP notes.

The closure of diplomatic missions today followed a US embassy warning of a "possible significant air attack" against Ukraine.

"The threat of strikes [...], unfortunately, has been a daily reality for Ukrainians for more than a thousand days," said a spokesman for the Ukrainian Foreign Ministry.

The ministry urged the West not to fuel the "tensions" maintained by Moscow for several days. Russia once again resorted to its nuclear rhetoric after Kiev received a "green light" to use American long-range missiles to strike deep into Russian territory

Ukrainian military intelligence said Russia was carrying out a "massive psychological and information attack" against Ukraine through false messages circulating on social networks warning of impending bombings.

The latest massive strikes against Ukraine four days ago again targeted the country's energy system, causing blackouts. Since then, across Ukraine, several



residential buildings have also been hit, causing many deaths.

Ukraine's first long-range US missile attack was a strike on a military facility in Russia's Bryansk region, using US ATAKMS missiles with a range of 300 kilometers, Moscow and Kiev confirmed.

Also, the administration of American President Joe Biden, which in January will pass the baton to that of Donald Trump, announced today that it intends to supply Ukraine with anti-personnel mines – a weapon that has been heavily criticized for the number of civilian casualties it causes, including long after the conflict has ended. However, this weapon could help slow the Russian troop advance, which is accelerating.

The United States "is fully committed to prolonging the war in Ukraine and is doing everything possible to that end," Kremlin spokesman Dmitry Peskov said.

According to a US official, the mines supplied to Ukraine will be "unsustainable", i.e. equipped with a self-destruct or self-disabling device. They aim to bolster Ukraine's defenses at a time when its troops are on the retreat

In response to this US support for Kiev, Russia again issued warnings about using nuclear weapons, while accusing the West of "seeking escalation". According to the new Russian doctrine on the use of nuclear weapons, officially announced yesterday, Russia can now use them in the event of a "massive" an attack by a non-nuclear state but backed by a nuclear power.

This change "de facto precludes the possibility of defeating the Russian armed forces on the battlefield," Russian foreign intelligence chief Sergei Naryshkin said today, hinting that Russia would resort to a nuclear bomb rather than risk defeat in a conventional war.

Washington, Paris, London and the European Union condemned the "irresponsible" attitude of Moscow. Ukraine called on its allies "not to give in to fear".

China, a key partner of Moscow, called on "all countries" to "calm down" and "contain".

The Russian army continues to advance on land, saying today that it has captured a new town on the eastern front, near Kurakhovo.

Russia itself has been accused by Kiev and the West of escalating the conflict after receiving the support of at least 10,000 North Korean troops. In addition, North Korea is accused of supplying large quantities of shells and missiles to Moscow.

Migrant who raped, impregnated 15yo virgin jailed 10 years in UK

41-year-old migrant, Anicet Mayela, who sexually defiled a 15-year-old girl in a drunken attack and impregnated her has been sentenced to ten years and ten months imprisonment.

Mayela had been granted asylum in the UK after repeated attempts to deport him reportedly failed.

A court on Tuesday heard how he forced the girl to remove her clothes before launching the assault.

Judge Maria Lamb was told an investigation began when a 'pregnancy termination note' was discovered, and the victim eventually revealed what had happened to her.

Prosecutor Edward Lucas said that Mayela initially 'made admissions' as to what he had done and went on to plead guilty to the offence. But the barrister said 'matters took a different course thereafter when the defendant started to deny that he was guilty'.

The court heard an application to vacate his guilty plea was rejected by a judge in September, and Mayela 'continues to deny his guilt'.

Mr Lucas said aggravating features of the case included the victim's age and the fact that she became pregnant as a result of the attack.

In a brief extract from a victim impact statement read out by the prosecutor, the girl said: 'I know you're getting sentenced today...I'm so ready for it.' Oxford Crown Court heard a report into the Congolese national—who had no previous convictions—judged that he posed a risk of serious harm to pubescent girls.

Lucas told Judge Lamb: 'I submit the defendant is dangerous, for sentencing purposes'.

Peter Du Feu, defending, said Mayela had 'spiralled into alcohol abuse and depression' following the death of his wife from cancer. He described the December 2023 rape as a 'one-off'.

Sentencing Mayela for what she said was a 'terrible offence committed in guilt', Judge Lamb told him: 'It was her (the victim's) first sexual

experience and the misery you caused that child, who became pregnant as a result, must have been extreme.

'You continued to deny your offence. Your sentence will be no longer for that, but you don't have the benefit of remorse, and she doesn't have the support and assistance of k n o w i n g t h a t y o u acknowledge your guilt.'

Judge Lamb, commenting on the victim impact statement, added: 'She is a remarkable young woman who, despite everything that has happened to her and everything that you did to her, has found it possible to forgive you.'

The judge told him the victim 'does not have the succour of knowing that you acknowledge your guilt'.

Mayela sobbed in the dock as the sentence was handed down.

He admitted to a single count of rape in April and will serve two-thirds of his sentence before being released on licence.

He will be on the sex offenders' register for life and was also ordered to comply with requirements of the Sexual Offences Act for life. Mayela, of Oxford, was joined in the dock today by a French interpreter. He will also be barred from working with children.

At the hearing in September, Judge Nigel Daly said Mayela had made an 'unequivocal plea of guilty' at the previous hearing which he could 'see no reason to vacate'.

After his initial court appearance earlier this year, The Sun reported several unsuccessful attempts had previously been made to remove him from the UK before he was given permission to stay in the country.

It is understood the Home Office initially refused Mayela's asylum claim in 2004 but he successfully challenged the decision in the courts and was eventually granted leave to remain on appeal in



2010

According to an article published by the Institute of Race Relations (IRR), which has described itself as an 'anti-racist think tank', he was served three removal notices and left with a broken hand during one deportation attempt.

The IRR report, from 2005, said Mayela paid an agent to help him flee his home country in 2004 because his life was in danger. He settled in Plymouth, South Devon, where his initial asylum claim was considered and refused. An appeal was dismissed by the courts later that year.

Mayela was then held at Campsfield House Detention Centre in Kidlington, Oxfordshire. But a planned deportation flight back to the Congo capital Brazzaville in May 2005 was grounded after Air France cabin crew refused to carry him

A month later, he won leave to remain after lawyers said that deportation would be against his human rights while police were investigating an alleged assault on him by immigration handlers

Trump appoints former wrestler, Linda McMahon as education secretary

S President-elect, Donald Trump has picked World Wrestling Entertainment (WWE) co-founder and his transition co-chair, Linda McMahon as his nominee for education secretary.

McMahon, a retired professioner wrestler, led the Small Business Administration during Trump's first presidency and donated millions of dollars to his presidential campaign.

Announcing his pick on Truth Social, Trump said McMahon would "use her decades of leadership experience, and deep understanding of both Education and Business, to empower the next generation of American Students and Workers."

"For the past four years, as the Chair of the Board at the America First Policy Institute, Linda has been a fierce advocate for Parents' Rights," Trump said in his statement.

He said McMahon would "spearhead" the effort to "send Education back to the States", in reference to his pledge to close the department.

Earlier, Trump criticized the Department of Education and has promised to close it down, a job McMahon could be tasked with.

Her nomination came shortly after Trump chose Mehmet Oz, a celebrity doctor and former television host, to lead the Centers for Medicare and Medicaid Services.

The two selections on Tuesday, along with Trump's choice of Howard

Lutnick for commerce secretary, follow a pattern of the president-elect nominating loyal supporters to top roles in his cabinet.

McMahon has a long history with the WWE and Trump, who used to make occasional appearances at wrestling matches. She co-founded the wrestling league with her husband in 1980, resigning as CEO in 2009 to undertake a failed bid to run for the Senate.

She has little background in education but did serve on Connecticut State's Board of Education from 2009 until 2010.

She is the board chair of the pro-Trump think tank the America First Policy Institute, meaning her confirmation in the Republicanmajority Senate is likely.

our Nigerian students have been jailed in the United Kingdom (UK) over a violent street brawl in Leicester City centre.

Destiny Ojo, Joshua Davies-Ero, Ridwanulahi Raheem, and Habib Lawal, all aged 21, used knives, a baseball bat, and a crutch as weapons during the fight that took place at about 03:00 GMT on November 4, 2021.

The defendants were found guilty of various offences at the Leicester Crown court on Thursday after a six-week trial. "A man, who was 18 at the time, suffered stab wound injuries in the incident requiring hospital treatment," the Leicestershire police said in a statement on Monday.

"After the suspects left the scene, police enquiries carried out over the following few months included CCTV analysis, phone work, and public appeals which led to identifications being made."

The Leicestershire police said CCTV

footage showed that the men, all from London, were spotted with several weapons.

"Davies-Ero was seen carrying a crutch and Ojo a baseball bat, while Lawal was seen with what was believed to be a large knife. Raheem carried a large knife," the police said.

The court sentenced Ojo to seven years in prison for violent disorder, attempted grievous bodily harm, and committing grievous bodily harm with intent.

Lawal was jailed for five years for



violent disorder, attempted grievous bodily harm, and committing grievous bodily harm with intent.

The court also sentenced Raheem to a three-year prison sentence for violent disorder and possession of a bladed article.

The fifth person, who was identified as Asamoah, who in the past pleaded guilty to possession of a bladed article, is due to be sentenced on Friday.

Russia arrests German citizen on sabotage allegations

he Russian domestic intelligence service, the FSB, has reportedly arrested a German citizen in Kaliningrad on Wednesday for allegedly planning acts of sabotage.

Upon entering the Russian Baltic Sea exclave from Poland, 50 grams of liquid explosives were allegedly seized in his car, which he had driven from his home in Hamburg.

According to the Russian news agency, the FSB alleged that the man had received orders from a Ukrainian man who also lives in Hamburg to carry out some sort of attack. Russian authorities also suspect the German man of having carried out an explosives attack on a gas distribution station in the Kaliningrad region in March. According to Russian media reports, the FSB alleges that the man again intended to

damage Russian energy facilities when he re-entered Russia.

He has been remanded in custody on charges of terrorism and smuggling explosives, and Russian authorities are searching for suspected accomplices in the alleged plot.

However, there was no

independent confirmation of these accusations by the Russian intelligence service.

Russian news agencies reported that the man in question is a German national who was born in 1967 in Hamburg.

The German Foreign Office in Berlin said it is keeping itself informed of the case but did not have immediate comment on the allegations and the man's arrest.

Relations between Russia and NATO countries, including Germany, have been



at their worst point in decades since Russia's full-scale invasion of Ukraine in February 2022.

During the conflict, Russian authorities have repeatedly arrested foreign citizens on hotly disputed charges, including in several incidents which Western governments have denounced as false or trumped-up cases.

Russia has been accused of trying to use foreign citizens as bargaining chips for possible prisoner exchanges.

Brazil hands over G20 leadership to South Africa

he leadership of the G20 has changed with South Africa taking over from Brazil during a handover ceremony at the Rio de Janeiro summit in Brazil.

President Luiz Lula da Silva of Brazilian handed over the reins of leadership to South African president, Cyril Ramaphosa, on Tuesday.

South Africa is the only African country in the G20 and will be the host of the 2025 summit.

Ramaphosa told his counterparts at the summit, "We will use this moment to bring the development priorities of the African continent and the Global South more firmly onto the agenda of the G20."

The South African president said his administration would prioritize inclusive economic growth, industrialisation, employment, and inequality.

Ramaphosa added, "The second priority is food security. The third priority is

artificial intelligence and innovation for sustainable development.

"At South Africa, we undertake to advance the work of the G20 towards achieving greater global economic growth and sustainable development. We will work to ensure that no one is left behind."

Ramaphosa said he is looking forward to welcoming global leaders to South Africa next year.

WHO IS IN THE G20?

The G20, originally a collection of 20 of the world's largest economies, was conceived as a bloc that would bring the most important industrialized and developing economies together to discuss international economic and financial stability.

Since 2008, the G20's annual summit has evolved into a major forum for discussing economics as well as other pressing global issues.



Bilateral meetings on the summit's sidelines have occasionally led to major international agreements.

The forum comprises 19 countries,

the European Union (EU) and, as of 2023, the African Union (AU). Member countries include Argentina, Australia, Brazil, Canada, China, France, Germany, India, Indonesia, Italy, Japan, Mexico, Russia, Saudi Arabia, South Africa, South Korea, Turkey, the United Kingdom (UK), and the United States.

Spain is invited as a permanent guest.

Osimhen hails Rashidi Yekini as Nigeria's G.O.A.T.

alatasaray striker Victor Osimhen has hailed the late Rashidi Yekini as Nigeria's greatest striker, despite being on the verge of breaking the legendary forward's long-standing goalscoring record for the Super Eagles.

Osimhen recently equaled Segun Odegbami as Nigeria's joint secondhighest goalscorer with 23 goals, following his strike in the 1-1 draw against Benin Republic last Thursday.

However, the 25-year-old still trails Yekini's impressive tally of 37 goals from 62 appearances for Nigeria, a record that has stood for nearly three decades.

In a video posted on social media, Osimhen made it clear that surpassing Yekini's record would not diminish the former Olympiakos star's legacy.

"No, no. I really don't care about this. I just want to do my job and try to win games, score goals, and provide a lot of assists for my team," Osimhen said.

"Then if I equal it, I equal it, if I surpass it, I surpass it, but that doesn't take away the fact that Rashidi Yekini is the greatest striker the Super Eagles have ever had. This record stood for a very, very long time and it still stands, so I think we should give him his flowers and also celebrate him."

Yekini, who etched his name in Nigerian football history by scoring the country's first-ever World Cup goal in 1994, dominated African football in his prime. He won the Africa Cup of Nations top scorer award in consecutive tournaments in 1992 and 1994, establishing himself as one of the continent's all-time greats. His 37-goal tally has remained untouched for nearly 30 years, underscoring the magnitude of his achievement.

Osimhen, who has become one of Africa's most feared strikers, has scored the majority of his 23 international goals in AFCON qualification matches, highlighting



his key role in Nigeria's national team success.

Despite his rising profile, Osimhen's attempt to close the gap on Yekini's record suffered a setback when he failed to find the net in Nigeria's surprise 2-1 defeat to Rwanda in Uyo on Monday, after coming on as a 77thminute substitute.
