Russia threatens to attack US base in Poland with 'advanced weapons'

ussia has threatened to attack a new US defence base in Poland with "advanced weapons" — just hours after reportedly launching an intercontinental ballistic missile at Ukraine on Thursday.

Moscow leveled the warning after saying the opening of the ballistic missile defence base, located in the town of Redzikowo near the Baltic coast, would lead to an increase in

overall nuclear danger.

"Given the nature and level of threats posed by such Western military facilities, the missile defense base in Poland has long been added to the list of priority targets for potential destruction, which, if necessary, can be executed with a wide range of advanced weapons," Russian Foreign Ministry spokesperson, Maria Zakharova said.

The US base at Redzikowo, which opened November 13, is part of a broader NATO missile shield known as "Aegis Ashore" — that can intercept short- to intermediate-range ballistic missiles, according to the alliance.

"This is another frankly provocative step in a series of deeply destabilizing actions by the Americans and their allies in the North Atlantic Alliance in the strategic sphere," Zakharova said of the base's opening.

"This leads to undermining strategic stability, increasing strategic risks and, as a result, to an increase in the overall level of nuclear danger."

Poland stressed that the base does not pose a threat and does not hold nuclear

"It is a base that serves the purpose of defence, not attack," said Pawel Wronski, Poland's foreign ministry spokesperson.

"Such threats will certainly serve as an argument to strengthen Poland's and NATO's air defenses, and should also be considered by the United States."

The Kremlin's warning came after Kyiv's air force said Russian forces launched an intercontinental ballistic missile during an attack on the Ukrainian city of Dnipro earlier

The Ukrainian air force said the missile was fired from the Russian region of Astrakhan — some 435 miles from Dnipro in east-central Ukraine.



"Today there was a new Russian missile. All the characteristics speed, altitude — are (of an) intercontinental ballistic (missile). An expert (investigation) is currently underway," Ukrainian President Volodymyr Zelensky said in a video statement.

Moscow said the ballistic missile defense base would lead to an increase in overall nuclear danger.

Asked about the Ukrainian statement, Kremlin spokesman Dmitry Peskov told reporters to contact the Russian military for comment.

The launch, if confirmed, adds to the rapidly rising tensions after Ukraine fired US missiles at targets inside Russia this week — despite Moscow warning it would see such action as a major escalation and Russian officials saying it could lead to World War III.

Pope Francis refuses glitzy burial, opts for wooden casket

pope Francis has opted to be buried in a wooden casket when he is laid to rest – amending a centuries-old tradition of a decorated send off as he works to simplify papal customs

The 87-year-old pontiff—who turns 88 next month—enacted a new set of liturgical rites aimed at modernizing the Catholic Church that scraps lengthy, garish funeral practices his predecessors observed upon their deaths, Reuters reported.

When he dies, Francis will now be immediately placed in a single wooden casket lined with zinc, rather than the three interlocking caskets made of cypress, lead and oak.

Prior tradition laid the pontiff's body within the airtight caskets and would allow for objects, such as coins and papers issued by the pope during his reign, to be buried with him The open coffin will then sit at St. Peter's Basilica for mourners to pay their respects—nixing a funeral custom of the papal body being displayed on a raised platform propped up by decoration, Reuters reported.

Francis opted to be laid to rest at Rome's Basilica of St. Mary Major, a church he frequently visits during international trips, and not

alongside his immediate predecessors.

The new rites will scrap lengthy, garish funeral practices his predecessors observed upon their deaths.

than 100 years to be buried outside the Vatican — a title held by Leo XIII, who was entombed at Rome's Basilica of St. John Lateran in 1903, Reuters reported. Francis, who announced last year his desire to modify the intricate and lengthy funeral rites, has been open about his health challenges, including knee and back pain that now requires him to use a wheelchair.

Senate confirms Omolola Oloworaran as DG, PENCOM

Thursday, November 21 has confirmed the nomination of Omolola Oloworaran for appointment as the new Director-General of the National Pension Commission (PENCOM). The confirmation followed a request from President Bola Tinubu, who had written to the Senate seeking approval for the nominee.

The Senate's decision came after it considered and adopted the report from the Senate Committee on Establishment and Public Service during plenary.

Senator Cyril Fasuyi, the committee chairman and member representing the Ekiti North Senatorial District, explained that the committee had thoroughly reviewed the nominee's qualifications.

According to Fasuyi, Oloworaran met all the legal requirements specified under sections 19 (2), (5), (6), and 26 of the Pension Reform Act 2014, which governs the appointment of the PENCOM Director-General.

Fasuyi further emphasized that the committee had determined Oloworaran to be "a qualified, fit, and proper person" for the role.

Following the committee's recommendation, Deputy Senate President Barau Jibrin, who presided over the

session, called for a voice vote, and the nomination was approved without opposition.



This marks the next step in the leadership of PENCOM as Oloworaran is set to take charge of overseeing Nigeria's pension system.

Simon Ekpa'll be extradited to face charges in Nigeria – DHQ

he Nigerian Defence Headquarters (DHQ) has announced plans to extradite Simon Ekpa, the self-proclaimed Prime Minister of the Indigenous People of Biafra (IPOB), to Nigeria to face charges.

In a statement released to journalists on Thursday, the Director of Defence Information, Brigadier General Tukur Gusau, revealed that Chief of Defence Staff General Chris Musa expressed satisfaction with Ekpa's recent arrest

Gusau stated, "The CDS is happy with his arrest in Finland, with the hope this will be a step towards his extradition to Nigeria so that he will face justice." Ekpa is accused of promoting separatist propaganda linked to IPOB through social media, inciting violence, and supporting activities that have reportedly led to civilian and security personnel casualties in southeastern Nigeria.

His offences allegedly date back to August 23, 2021.

The Finland district court in Lahti recently ordered Ekpa's remand on probable cause for public incitement to commit a crime with terrorist intent.

Finnish authorities are also investigating him for financial crimes, including raising funds through questionable means.

Crime Commissioner, Otto Hiltunen of Finland's Central Criminal Police stated that Ekpa's activities had led to crimes and unrest in Nigeria, primarily orchestrated from his residence in Lahti via social media.

Ekpa, a local politician in Finland, previously served as a deputy councillor with the National Coalition Party and represented

Lahti's public transport board. Despite his political affiliations in Finland, he has used his platform to advocate for Biafra's independence and call for election boycotts in Nigeria.

Finnish police arrested Ekpa in February 2023 for similar allegations but released him after questioning.



Authorities have confirmed ongoing investigations into his activities and those of four other suspects arrested on allegations of financing terrorism.

The DHQ's assurance of extradition highlights the Nigerian government's determination to address what it deems a critical threat to national unity and stability.

ormer Minister of Petroleum, Diezani Alison-Madueke, on Thursday, sought to amend her suit challenging the order obtained by the EFCC for final forfeiture of her seized assets.

Alison-Madueke, through her lawyer, Godwin Iyinbor, told Justice Inyang of a Federal High Court in Abuja upon resumed hearing in the suit.

When the matter was called, no counsel appeared for the EFCC.

Justice Ekwo then asked Iyinbor if he had received processes from the antigraft agency and he responded in the affirmative.

"Yes, my lord. We received a counter affidavit to our originating process and we have filed a further affidavit in response," Iyinbor responded.

The lawyer, however, informed the court that they had filed a motion to amend their processes and that the commission had been duly served.

The judge consequently adjourned the matter until Feb. 17, 2025, for hearing the motion to amend their originating

The ex-minister had, through his counsel, Chief Mike Ozekhome, SAN, sued the anti-graft agency as sole respondent.

Alison-Madueke, in the suit marked: FHC/ABJ/CS/21/2023, sought an order extending the time to seek leave to apply to the court for an order to set aside the EFCC's public notice issued to conduct a public sale on her property.

In the motion dated and filed on Jan. 6, 2023 by her lawyer, the former minister sought five orders from the court.

The former minister, who argued that the various orders were made without jurisdiction, said these "ought to be set aside ex debito justitiae."

She said she was not given a fair hearing in all the proceedings leading to the orders.

"The various court orders issued in favour of the respondent and upon which the respondent issued the public notice were issued in breach of the applicant's right to fair hearing as guaranteed by Section 36 (1) of the 1999 Constitution, as altered, and other similar constitutional provisions," she said.

She argued that she was neither served with the charge sheet and proof of evidence in any of the charges nor any other summons regarding the criminal charges pending against her before the

She further argued that the courts were misled into making several final forfeiture orders against her assets through suppression or non-disclosure of material facts.

"The several applications upon which the courts made the final order of forfeiture against the applicant were obtained upon gross misstatements, misrepresentations, non-disclosure, concealment and suppression of material facts.


"This honourable court has the power to set aside same ex debito justitiae, as a void order is as good as if it was never made at all.

"The orders were made without recourse to the constitutional right to fair hearing and right to property accorded the applicant by the constitution.

"The applicant was never served with the processes of court in all the proceedings that led to the order of final forfeiture," she said, among other grounds given.

But the EFCC, in a counter-affidavit deposed to by Rufai Zaki, a detective with the commission, urged the court to dismiss her application.

Mr Zaki, a member of the team that investigated a case of criminal conspiracy, official corruption and money laundering against the ex-minister and some other persons involved in the case, said the investigation had clearly shown that she was involved in some acts of criminality.



"We hereby rely on the charge FHC/ABJ/CR/208/2018 dated 14 November 2018 filed before this honourable court and also attached as Exhibit C in the applicant's affidavit," he said.

The EFCC operative said most of the depositions in Mrs Alison-Madueke's suit were untrue.

He said contrary to her deposition in the affidavit filed in support of the suit, most of the cases which led to the final forfeiture of the contested property "were action in rem, same was heard at various times and determined by this honourable court."

He said the courts ordered the commission to do a newspaper publication inviting parties to show cause why the said property should not be forfeited to the federal government before final orders were made.

Mr Zaki argued that one Nnamdi Awa Kalu represented the exminister in reaction to one of the forfeiture applications.

"We humbly rely on the judgment of Hon. Justice I.LN. Oweibo dated 10th September, 2019 shown in Exhibit C of the applicant's affidavit," he said.

The officer said contrary to her, the final forfeiture of the assets, which were subject to the present application, was ordered by the court in 2017 and that this was not set aside or upturned on appeal.

Makinde flags off Eruwa farm settlement redevelopment

overnor Seyi Makinde of Oyo State has performed the ground-breaking ceremony for the upgrade of the moribund 3,250 hectares Eruwa Farm Settlement to an agribusiness industrial hub.

The governor said that the project, once completed, would put Ibarapaland on the global agricultural map and create thousands of jobs for youths in the zone and across the state.

Governor Makinde, who stated this on Thursday at the Old Farm Settlement, Eruwa, Oyo State, added that his administration would also complete the Ido-Eruwa Road within the next one year, charging residents of Ibarapa zone to make investors feel welcome when the new agribusiness hub is completed.

He noted that the government recently approved the release of a tranche of N2 billion to the contractor handling the road project to fast-track its progress.

According to the governor, the administration established the Oyo State Agribusiness Development Agency (OYSADA) as a specialpurpose vehicle to drive agribusiness in the state and so far, the state has achieved great successes and gone ahead to become a model for other states, and even some African countries, in the area of agribusiness. He equally expressed confidence that the new Agribusiness Hub in Eruwa would also be a success story like the Fasola Agribusiness Hub, as, according to him, development partners and investors, who have already committed to bringing in their money to the facility, were present at

the ground-breaking ceremony. He said: "About five years ago, we started what I will call the journey to make agribusiness the driver of Oyo State's economy. Immediately we came into office, we got access to a N7.6 billion loan facility taken by the previous administration and our plan was to use this loan to ensure that two of our moribund farm settlements are

converted to agribusiness hubs.

"So, we started a pilot project at the moribund Fasola Farm Settlement, which we picked to serve as a prototype. It was an ambitious project, because no state in Nigeria had ever done that.

"At first, we thought it would take like a year to complete the pilot project at

Fasola, which is about 1,000 hectares. By calculation, it is bigger than Victoria Island in Lagos. Eruwa Farm Settlement is three times bigger than Fasola and what you see in the new Fasola Agribusiness Hub today is what we are putting up here.

"Fasola has taught us a very big lesson and we know that we have the capacity to take on this project and to see it to completion.

"As of today, it is not only that all states in Nigeria have come to inspect Fasola; we have had officials from Ogun, Ekiti, Cross River, Borno, Plateau, Delta, Bayelsa and Gombe states. We have also had visitors from outside Nigeria, including Ghana, Democratic Republic of Congo, Cote d'Ivoire, Mozambique and Kenya.

"So, I want to say to the people of Ibarapaland that you should be ready, because Ibarapaland is now on the agriculture map.

"We are quite happy and, as for me, I feel fulfilled that this journey to develop this farm estate is getting done. "I am happy to be joined on this journey by development partners and the private sector. Some of the people seated here today have committed to bring their money to invest in this environment.

"My people in Ibarapa; what you can do for me is to make the investors feel welcome. Support them and they will create jobs for our youths."

Speaking earlier, the Director-General of OYSADA, Dr Debo Akande, said that the Eruwa Agribusiness Hub is expected to be a 40-million-dollar public-private development investment that will change the agricultural landscape of Eruwa,



Ibarapa, and Oyo State.

"This facility will include a crop and livestock production centre, 15-20 processing centres, a state-of-the-art agribusiness training centre, a mechanisation and equipment leasing centre, an early-generation seed production centre, and, the icing on the cake will be an eco-resort centre that will put Eruwa on the world map.

"I thank His Excellency for his visionary leadership, the citizens of Oyo State, the good people of Ibarapa, and particularly Eruwa, the private investors, and AfDB for believing in this.'

Explaining how Fasola Hub has become a success story, Akande maintained that the Hub has seen an influx of 12 medium to large national and international private companies occupying the 1,150 hectares of land for crop production, livestock rearing, and processing for domestic consumption and export.

He added that these companies have been contributing to supporting smallholder farmers in the state through training, taking their crops for processing and development of early generation seeds that will help yields across the state.

In his special remarks, Director-General, Nigeria, African Development Bank (AfDB), Dr Abdul Kamara, lauded Governor Makinde for resuscitating moribund farm settlements and putting the state on the path of agribusiness, which he described as consistent with AfDB's approach to rural and economic transformation and aligns with its focus to feed Africa, guarantee food security, nutrition, agro-processing, agricultural transformations, industrialisation and improving the quality of lives for Africans.

Governors pledge support for constitutional amendment

Federal High Court in Abuja, presided over by Justice Inyang Ekwo, has adjourned the hearing of a motion filed by former Petroleum Minister, Diezani Alison-Madueke, seeking to amend the originating process in her ongoing legal dispute with the Economic and Financial Crimes Commission (EFCC).

She contends that the orders for the forfeiture of her assets were made without jurisdiction and that she was denied a fair hearing in the proceedings leading to those orders.

In her application, Alison-Madueke argued that she was not served with the charge sheet, proof of evidence, or any summons concerning the



charges against her. She further claimed that the forfeiture orders issued in favor of the EFCC were made in violation of her constitutional right to a fair hearing, as guaranteed by Section 36(1) of the 1999 Constitution. She also accused the courts of being misled due to the suppression or non-disclosure of critical information, which she asserts resulted in the violation of her right to property.

In response, the EFCC, represented by Detective Rufai Zaki, opposed Alison-Madueke's application. Zaki argued that the assets were lawfully forfeited in accordance with a 2017 court order and that the agency had followed all legal procedures in its efforts to auction the properties as part of its efforts to recover proceeds of crime. The EFCC

also insisted that the application for the final forfeiture of Alison-Madueke's assets was properly instituted and had not been overturned on appeal.At Thursday's proceedings, Alison-Madueke's counsel informed the court of their intention to amend their application challenging the final forfeiture of the seized assets. However, no legal representative from the EFCC was present in court.After confirming that the EFCC had served the necessary documents to Alison-Madueke's legal team, Justice Ekwo adjourned the matter until February 17, 2025, for the hearing of the motion to amend the originating summons.

Kwara workers told to register with KWASRRA

The Kwara State Government has directed all staff under its local government payroll to register with the Kwara State Residents Registration Agency (KWASRRA) at designated centrer across the 16 local government Council secretariats. The statement was shared on Thursday via the Facebook page of the state government.

In a statement signed by Alhaji Umar Danladi Shero, the Executive Chairman of the Kwara State Local Government Service Commission and the Local Government Pension Board, he clarified that the exercise is not aimed at targeting or punishing any staff member.

Instead, it is intended to accurately document staff numbers and gather necessary information to support effective policy-making.

Alhaji Shero assured that all arrangements have been made to ensure a smooth registration process, with prior notifications sent to all 16 local government councils.

He, however, cautioned that any staff member who fails to participate in the exercise will be deemed illegitimate and will face consequences. The Chairman reiterated the state government's new policy of "No Registration, No Salary or Bonus," emphasizing that it will be strictly enforced.

"Alhaji Umar however said any staff who decides



to make his or herself unavailable for the exercise will be considered as an illegitimate officer of the council.

Reiterating this, he noted that the new policy by the state government of 'No Registration No Salary and Bonus' will not be hesitated to be applied," the statement noted.

In response, the EFCC, represented by Detective Rufai Zaki, opposed Alison-Madueke's application. Zaki argued that the assets were lawfully forfeited in accordance with a 2017

court order and that the agency had followed all legal procedures in its efforts to auction the properties as part of its efforts to recover proceeds of crime. The EFCC also insisted that the application for the final forfeiture of Alison-Madueke's assets was properly instituted and had not been overturned on appeal.

At Thursday's proceedings, Alison-Madueke's counsel informed the court of their intention to amend their application



challenging the final forfeiture of the seized assets. However, no legal representative from the EFCC was present in court.

After confirming that the EFCC had served the necessary documents to Alison-Madueke's legal team, Justice Ekwo adjourned the matter until February 17, 2025, for the hearing of the motion to amend the originating summons.

Bauchi gov presents \$465b budget proposal for 2025

Reps reject 6-year single tenure for elected oifficials

bill seeking to amend the 1999 constitution to **L**provide for a single term of six years for the offices of the president, governors and local government chairmen was rejected by the House of Representatives on Wednesday.

The bill, sponsored by the member representing Ideato North, South federal constituency of Imo State, Ikenga Ugochinyere and 33 other lawmakers, also seeks zonal rotation of presidential and governorship seats, as well as holding of elections into the offices in one day.

The proposed legislation seeks to alter Sections 76, 116, 132, 136, and some others of the 1999 Constitution (as amended).

According to the general principles of the bill, "these amendments are to ensure inclusive governance and curb wastages, occasioned by fouryear periodic elections.

"The bill, among others, seeks amendment of Section 132 of the Principal Act by inserting a new subsection (2), deleting the extant subsection (4) and renumbering the entire section accordingly to provide that an election to the office of President of the Federal Republic of Nigeria shall be rotated between the north and the south regions of the country every six years.

"Other amendments include, Section 76 of the Principal Act is altered by inserting a new subsection (3) as follows; (3) For the Purposes of Section (1) of this section, all elections into the offices of President, Governors, National Assembly and State Houses of Assembly shall hold simultaneously on the same date to be determined by the Independent National Electoral Commission in consultation with the National Assembly and in accordance with the Electoral Act.

"Section 116 of the Principal Act is amended by inserting a n e w subsection (3) as follows: For the purposes of subsection (1) of this section,

all elections into the offices of President, Governors, National Assembly, State Houses of Assembly and Local Government Councils shall be held simultaneously on the same date to be determined by the Independent National Electoral Commission, INEC, in consultation with the National Assembly and in accordance with the Electoral Act.

"Section 132 of the Principal Act is amended by inserting a new subsection (2), deleting the extant subsection (4) and renumbering the entire section accordingly: An election to the office of President of the Federal Republic of Nigeria shall be rotated between the north and the south regions of the country every six years, provided that where it is the turn of the north or south to present a candidate for election into the office of President, it shall be rotated among the three geo-political zones that constitutes

"The extant subsection (2) becomes subsection (3) The extant subsection (3) becomes subsection (4) The extant subsection (4) is hereby deleted. The extant subsection (5) remains subsection (5).

"Section 136 of the Principal Act is amended by deleting the extant subsections 1 & 2 and replacing them with new subsections I, 2 and 3 as follows: If a person duly elected as President dies before taking and subscribing to the oath of allegiance and oath of office. or is for any reason whatsoever, unable to be sworn in, the person elected with him as First Vice President shall be sworn in as President and he shall appoint a new First Vice President with the approval by a simple majority of the National Assembly at a joint sitting.

"A person who was sworn in as governor to complete the term for which another person was elected as governor shall not be elected to such office for another term. The Principal Act is altered by inserting a new Section 188 immediately after the extant 187 and immediately before the extant 188 and renumbering accordingly as follows; 188(1)

"Notwithstanding any other provision, the governor shall present a mid-term account of stewardship performance report to the State House of Assembly at the end of the third year of the six-year term.

"The State House of Assembly shall determine by a resolution supported by not less than two-third majority of members, whether the governor has, by the account of stewardship report, justified his continuous stay in office.

"Where, upon the consideration of the mid-term report under subsection (1) of this section, the state House of Assembly is not satisfied with the performance of the governor for the period he has been in office, the State House of Assembly shall pass a vote of no confidence on the governor.

"The State House of Assembly shall immediately commence the process for the impeachment of the governor from office."

Thereafter, the bill was put to a voice vote by the speaker who presided over the plenary and the nays had it.

NEC moves to address power grid failures, launches committee on national electrification

he National Economic Council (NEC) has taken decisive steps to tackle the ongoing issues plaguing Nigeria's power sector, including the recent power grid collapses, by establishing a committee to implement the National Electrification Strategy.

This initiative is aimed at ensuring reliable and affordable electricity access across the country.

At the 146th meeting of NEC held on Thursday at the Presidential Villa, Abuja, Vice President Kashim Shettima, who chairs the Council, underscored that access to electricity is a fundamental right, essential for economic growth.

He emphasised that 'electricity is the oxygen of economic growth' and must be treated as a basic necessity rather than a luxury.

In a bid to address the challenges of electricity access, the Council constituted a new committee led by Cross River State Governor, Bassey Otu.

This committee will focus on deepening states' involvement in the implementation of the Electricity Reform Act 2023 and the National Electrification Strategy.

The group includes governors from Katsina, Gombe, Osun, Imo, and Plateau states, along with key federal officials such as the Ministers of Finance, Power, and Budget, as well as the Managing Directors of the Rural Electrification Agency (REA) and the Niger Delta Power Holding Company.

During the meeting, the Council recognised the need for a reformed and diversified electricity system to empower regional needs and ensure equitable access to energy.

rural areas.

Shettima also highlighted other critical sectors needing urgent attention, including energy infrastructure, human capital development, and Nigeria's creative industries, which he said could significantly boost the nation's economic future.

Other key highlights included a presentation on the Special Agro-Industrial Processing Zones (SAPZ), with states urged to support the initiative, which aims to stimulate agricultural and industrial

development across the country.

The Council also approved key governance appointments for the Nigeria Sovereign Investment Authority (NSIA), aiming to strengthen the country's investment strategy for critical sectors.

Atiku slams Tinubu's new loan proposal amid Nigeria's rising debt

Abubakar has expressed deep concern over Nigeria's escalating debt crisis, following a recent World Bank report that ranks the country as the third most indebted nation to the International Development Association (IDA).

In a statement released on his social media platform, Atiku criticised President Bola Tinubu's intention to borrow an additional N1.7 trillion to cover a shortfall in the 2024 budget through Euro Bonds.

He described the move as alarming, particularly because the proposed loan is benchmarked at an exchange rate of N800 to 1 USD, while the current Central Bank of Nigeria exchange rate has soared beyond N1,600 to 1 USD.

"Nigeria is sinking further into debt, and the National Assembly has become an accomplice once more," he said.

He questioned President Tinubu's administration, citing earlier claims of record-breaking revenue collections by the Federal Inland Revenue Service (FIRS) and Nigeria Customs Service.

"Why are they still borrowing? There is something they are not telling Nigerians, even as

they are being crushed by a combination of failed trial-and-error policies and loan rackets," he added.

The former Vice President accused Tinubu's administration of mismanaging loans, asserting that they have become a tool for corruption rather than serving infrastructure and developmental needs..

Citing a recent report by BudgIT, a budget transparency organisation, he lamented the poor allocation of funds in the 2024 budget, which he described as riddled with "pork projects.

"Reflecting on Nigeria's debt history, Atiku expressed dismay over the reversal of gains made during former President Olusegun Obasanjo's administration,

which had successfully cleared the country's foreign debt.

"I feel a sense of personal agony seeing that just a few years after the administration of President Obasanjo took our country out of foreign indebtedness, we are today back at the top spot in the same conundrum," he said.

Atiku called for greater caution and financial prudence, urging the government to adopt a more calculated approach to borrowing. "It is time to apply more caution and arithmetic to the loan frenzy," he said.

FAAC distributes N1.411trn to federal, state, local governments

he Federation Account Allocation Committee (FAAC) has disbursed N1.411 trillion to the three tiers of government for October 2024, reflecting an increase in revenue compared to the previous month.

The funds, derived from statutory revenue, Value Added Tax (VAT), Electronic Money Transfer Levy (EMTL), and Exchange Difference, were shared at the FAAC meeting in Bauchi, chaired by the Accountant General of the Federation, Dr Oluwatoyin S. Madein.

According to the FAAC communiqué, the federal government received N433.021 billion, states got N490.696

billion, and local government councils were allocated N355.621 billion.

FAAC

Additionally, oil-producing states received N132.404 billion as derivation revenue (13% of

mineral revenue). The report highlighted significant increases in VAT and statutory revenue.

Gross VAT for October amounted to N668.291 billion, up by N84.616 billion from the previous month.

Statutory revenue also rose to N1.336 trillion, reflecting a N293.009 billion increase.

The FAAC also distributed N646 billion

from Exchange Difference, with the federal government receiving N259.545 billion, states N131.644 billion, and local councils N101.493 billion.

The remaining amount was allocated to derivation revenue and interventions.

Dr Madein commended the improved revenue performance, attributing it to increased collections from oil royalties, import duties, and company taxes.

Tinubu advocates military unity at Africa Games kickoff in Abuja

FG seeks unified action to tackle healthcare challenges

he Federal Government has called for collective action to address healthcare challenges, especially women and children's problems.

The Minister of Health and Social Welfare, Prof. Muhammad Pate, made the call during a side event hosted by the Association of Local Governments of Nigeria (ALGON) at the 65th National Council on Health (NCH) in Maiduguri on Thursday.

The event, titled "ALGON Mission, Mandate, and Priority for Health 2024-2030," focused on the role of local governments in shaping health policy and improving health outcomes in Nigeria.

The minister stressed the need for collaboration across all sectors, including government, healthcare providers and Civil Society Organizations (CSOs) "to tackle systemic barriers in healthcare, particularly in maternal health."

He shared a personal account of a pregnant woman suffering from eclampsia, highlighting the risks faced by many Nigerians due to lack of access to essential healthcare services.

Eclampsia is a rare but serious condition that occurs in the second half of pregnancy, causing seizures, high blood pressure, headaches, blurry vision and convulsion, which usually occurs in pregnant women with preeclampsia.

The minister said "this is a true story; external support was the only reason the woman and her child survived.

He used this example to stress the importance of building systems that provide affordable and timely interventions for all Nigerians, especially the most vulnerable.

"We must act with urgency," he declared, urging national effort to address the root causes of preventable deaths, particularly among women and children.

He called for unified approach across



federal, state and local levels, stressing the importance of the National Health Act, which aims to provide universal access to healthcare services.

Pate also emphasized the need for improved healthcare infrastructure, especially in rural areas, where limited access to services and resources remained a significant challenge.

He added that "it is not just about building more hospitals or clinics, but ensuring healthcare workers are trained, supported, and equipped to deliver the best care."

He also called on the private sector to contribute to the national health agenda, aligning with government efforts to improve healthcare outcomes.

He highlighted the long-term benefits of improving women's health, suggesting that solving maternal health challenges would create ripple effects, enhancing overall health outcomes for families and communities.

Bello Lawal, National President of ALGON, reiterated the organisation's commitment to reposition local governments to effectively deliver services and

enhanced governance, saying "Our goal is to build the capacity of local government councils to provide essential services to citizens."

Dr Aminu Hassan, the ALGON Chairman in Taraba, presented the ALGON PHC Revitalisation and Operationalization Programme (APH-ROP), which seeks to strengthen primary healthcare delivery across Nigeria's 774 local government areas.

"This initiative aligns with national programmes like the Basic Health Care Provision Fund (BHCPF) 2.0 and aims to achieve Universal Health Coverage (UHC) and the UN Sustainable Development Goals by 2030," Hassan said.

Dr Walter Kazadi Mulombo, the Head of WHO Nigeria, highlighted the importance of global partnerships in advancing health and education.

Mulombo praised the ongoing technical support efforts to strengthen health systems across the region and expressed optimism about the future impact of the initiatives.

Dr Pamela Ajayi, the President of the Healthcare Federation of Nigeria (HFN), emphasised the role of the private sector in healthcare delivery, underscoring two key initiatives – the GDP and the New World Initiative – which use telecommunications and mobile health technology to improve primary healthcare in underserved areas.

Dr Garfa Alawode, the Co-convener of the UHC2023 Forum, also called for united efforts to reduce preventable deaths, improve healthcare infrastructure, and support healthcare workers.

"Addressing Nigeria's healthcare challenges requires collective will and action," Alawode added.



NAFDAC seizes N2bn fake drinks in Lagos market raid

he National Agency for Food and Drug Administration and Control (NAFDAC) on Thursday announced the uncovering of illegal alcohol packaging operators at Article Market in Abule-Osun, Lagos State.

The regulatory body revealed that during raiding, about 50,000 counterfeit branded labels and packaging materials for fake alcoholic beverages were seized.

The information disclosed that approximately N2 billion worth of goods were confiscated.

The anti-food agency said the seized items in the shared documents was used for the production of unapproved and hazardous alcoholic products for the public.

"During the raid, over 50,000 counterfeit branded labels and



packaging materials for fake alcoholic beverages, valued at approximately \$2 billion, were confiscated. These items were being used to produce unapproved and hazardous alcoholic products," NAFDAC X handle revealed.

Addressing this, NAFDAC issued a warning as they highlighted the health risk involved in consuming fake alcohols, which can lead to severe health damage, including poisoning and organ damage.

The health agency advised consumers to

purchase alcoholic beverages from trusted vendors, urging them to report any suspicious activities to the nearest NAFDAC office.

"NAFDAC warns about the severe health risks of counterfeit alcohol, including poisoning and organ damage. Consumers are advised to purchase alcoholic beverages only from trusted vendors and report any suspicious activities to the nearest NAFDAC office."

UHC: Borno govt seeks wide coverage for Nigerians accelerate progress, tackle barriers to

Mitigating Bird Strike: Strategy for Nigeria airport wildlife management

Bird strike is a collision between an aircraft and a bird or other wildlife, such as bats or small animals

It can pose a significant threat to aviation safety.

Causes of bird strikes include birds attracted to airport surroundings by things such as food, waste and water; and habitat encroachment whereby airports built near wetlands.

Others are weather conditions which includes like storms, turbulence and aircraft flight path.

The effects of bird strikes are huge and can be catastrophic. They include engine failure or damage, windshield damage, air frame damage, loss of control and emergency landings or crashes.

The consequences of bird strike consist of safety risks to passengers and crew, aircraft damage or loss, flight delays or cancellations.

There are also economic costs in terms of repairs, lost revenue; and environmental concerns like bird habitat disruption.

Aviation experts say Nigerian airports recorded over 93 bird strike incidents in the first half of 2022.

According to them, the Murtala Muhammed Airport (MMA) in Lagos is as a high-risk area for bird strikes with 54 incidents out of 93 bird strike incidents recorded.

According to a report from the Federal Airports Authority (FAAN), 134 bird strike incidents occurred in the country between 2015 and 2020.

Recently, Nigeria's Air Peace airline confirmed that its early morning flight from Abuja to Lagos was forcefully aborted due to a bird strike incident.

A statement issued by the airline's Head of Corporate Communications, Dr Ejike Ndiulo, informed that Abuja-Lagos flight experienced a bird strike before take-off, prompting a ramp return as a safety measure.

"All passengers disembarked normally. We have deployed a replacement aircraft for the affected flight to minimize disruptions and ensure that passengers continue their journeys promptly.

"We appeal for the understanding of our



valued passengers impacted by this development, as well as those on other flights that may experience delays.

"At Air Peace, we are committed to providing safe, comfortable, and reliable air travel for all our passengers, "he said.

Worried by the huge losses incurred by airlines as a result of bird strikes, FAAN said it would acquire "Phonic Bird Wailers" which would help in combating wildlife and bird strikes in the country.

Capt. Muktar Muye, former FAAN Director, Airport Operation, said the equipment was already being shipped into the country.

Furthermore, FAAN took delivery of bird strike fighting equipment from Canada on October 4, 2024 to support airline operators.

FAAN Managing Director, Mrs Olubunmi Kuku, is confident that the equipment would drastically to promote safety at nation's airports.

Kuku said that the achievement would ultimately increase Nigeria's rating in the International Civil Aviation Organisation (ICAO).

According to her, FAAN also received wildlife hazard control equipment from ICAO to enhance safety and mitigate wildlife hazards at various airports in the nation for effective utilization.

The managing director said this demonstrated FAAN's commitment toward confronting bird strike incidents and ensuring airport safety.

Kuku, however, said that she regretted the menace of bird strike incidents on the operations of the airline operators in the country. The delivery of bird strike fighting equipment from Canada was well lauded by the Airline Operators of Nigeria (AON) as a proactive measure to address infrastructure challenges at the nation's airports.

Nevertheless, retired Group Capt. John Ojikutu, an Aviation Security Consultant, told the newsmen recently that the nation would not make much progress in air safety unless the nation purged itself of issues that trigger air mishaps.

According to him, FAAN bought the appropriate equipment and recruited specialists from the universities with offices in the FAAN headquarters and at Abuja Airport.

"The sooner the ICAO Audits and the US FAA Audits were completed and Category One was bestowed on us, every ladder that took us up was destroyed including the human capital skills.

"The results are not only FAAN, so it is for the Airlines without skilled manpower such as pilot, engineers, in sufficient numbers.

"So it is with NAMA without sufficient Air Traffic Controllers and also in FAAN without sufficient skilled manpower in its various operations and support services.

"The general problems have to do with the oversight and enforcement Authority, NCAA which also lacks skilled manpower for the periodic inspections, checks, audits, survey, among others on all the Aviation Operators, "he said.

My husband ruined my career- Olajumoke Bread seller-turned-model

Popular model and former bread seller, Olajumoke Orisaguna, famously known as Olajumoke Onibread, has come forward with serious allegations against her exhusband, Sunday Orisaguna, accusing him of physical abuse during their marriage.

This announcement marks a critical moment in her life as she recounts her harrowing experiences of domestic violence, shedding light on the oftenhidden struggles faced by many.

During a candid interview with City FM, Olajumoke opened up about the toll that her marriage took not only on her well-being but also on her burgeoning career.

She recalled the trials and tribulations she endured while residing in her husband's family home located in Iree, Osun State.

This environment, she explained, was far from conducive to a peaceful domestic life, and the tension within the household was palpable.

Living in a household dominated by her mother-in-law's hostility, Olajumoke found herself in a situation that felt increasingly suffocating.

"There is no way you stay in such a place that you would not encounter problems," she expressed, highlighting the fraught dynamics that pervaded her life at the time.

She often found herself closing her hairdressing shop early each day, hurriedly preparing dinner in a bid to appease her mother-in-law, who wielded significant influence over her husband's actions and decisions.

As Olajumoke described, "It was whatever she told her son that he listened to. He would not hear my own side of the story before beating me."

This troubling pattern of violence revealed itself in moments of conflict, particularly when misunderstandings arose between her and her mother-inlaw

Regrettably, Sunday would resort to severe physical violence, leaving Olajumoke with battered faces and bruised bodies, and in some instances, resorting to beating her with a belt.

With her dignity at stake, Olajumoke kept her suffering largely concealed,



terrified of burdening her mother, who lived nearby.

"I didn't want my mother to hear," she shared, noting, "Whenever I reported incidents to her, she would say she didn't give me out in marriage to anyone."

Olajumoke further revealed that even her aunt had been sceptical about her marriage to Sunday, cautioning her against the arrangement based on her own experiences living in Iree.

Unfortunately, when the pregnancy issue arose, it left her with little choice, as societal pressures and familial expectations began to loom over her.

Feeling trapped in an oppressive environment, she noted, "Only those who lived with us knew about the beating. I didn't tell anyone."

The gravity of her situation escalated in January 2016, when an argument erupted while frying akara in remembrance of her father-in-law.

An altercation with Sunday's elder sister spiralled into yet another episode of violence, prompting Olajumoke to make a life-altering decision she would leave her husband and relocate to Lagos to reclaim her life.

As she packed her belongings with her two children in tow, Olajumoke felt a glimmer of hope.

"I decided that I was going to leave, move to Lagos, and start working at the bakery because I had been there before," she recounted, reflecting on her past experiences and the strength she had built over the years. Upon arriving in Lagos, she felt a weight lifted from her shoulders as she confided in a close friend who celebrated her newfound freedom, recognizing the oppressive toll that her marriage had taken on her spirit.



"I was enduring all of it," Olajumoke recalled, detailing her relentless hustle to provide for her family while Sunday remained unemployed.

Unfortunately, after their separation, things took a turn for the worse. The aftermath of their split witnessed Sunday tarnishing her reputation, further complicating her journey as she attempted to navigate her career in the aftermath of personal upheaval.

"Everything started going down the drain after separation because he started spoiling my name," she lamented.

New Daily Prime takes a reflective glance back at Olajumoke's rise to fame, which catapulted her into the public eye in 2016 when she inadvertently walked into a photoshoot with British rapper Tinie Tempah, her image captured by renowned photographer TY Bello.

This serendipitous moment helped transform her life, turning her into a sought-after model and symbol of resilience.

Today, Olajumoke Orisaguna stands as a beacon of hope for many, as she fearlessly recounts her story in the hope of inspiring others to break free from the shackles of abuse.

Diddy accused of sexually assaulting 39-year-old man in new lawsuit

ean "Diddy" Combs is accused of sexually assaulting a then-39-year-old man who attended a 2022 house party hosted by Combs "in a large, glamorous home in New York City," according to a new lawsuit filed Tuesday night.

The anonymous plaintiff, who now lives in Georgia, said he attended the party with friends and consumed alcohol that had been provided to him by other individuals at the party.

"After consuming the drink, Plaintiff began to feel disoriented and began to lose control of his body and to lose consciousness," the lawsuit said, mirroring a fact pattern by other anonymous accusers represented by personal injury attorneys who have filed numerous other lawsuits against Combs.

One of those attorneys, Tony Buzbee, was sued this week by an anonymous plaintiff somehow linked to Combs who accused Buzbee and his firm of extortion.

According to the new Combs accuser, when he regained consciousness, "he was in a dark bedroom with black walls, on a bed with black sheets

Everything around him was dark. Plaintiff was horrified to find Combs on top of him, sodomizing him."

Another new accuser said he was an

actor in the late 1990s and early 2000s when Combs and others sexually assaulted him after luring him to New York for a possible role in a music video.

"Plaintiff heard Combs say 'he'll do.' Combs then told Plaintiff he could sit back down," the lawsuit said.

The man said he was given a soda spiked with something that caused him to pass out. "His vision was blurry, but he recognized Combs' chest tattoo and the large gold chain with a jeweled cross on it that Combs wore during the interview. Plaintiff tried to fight him off, but felt dizzy and sick whenever he tried to move. Additionally, Combs' bodyguard was holding Plaintiff down by the arms," the lawsuit said.

A third new accuser said she was 17 years old in 2004 when Combs sexually assaulted her at a Fourth of July party in the Hamptons.

"Combs and two of his bodyguards approached Plaintiff and threatened her. Combs told Plaintiff that she would be in danger if she spoke about what had occurred, stating that he 'ran New York and would ruin her.' At this point, Plaintiff recognized that at least Combs had sexually assaulted her while she was unconscious. She feared for her life," her lawsuit said.

In a statement to ABC News on Tuesday, Combs' attorneys addressed the filing



against Buzbee, saying, "The extortion lawsuit against Mr. Buzbee exposes his barrage of lawsuits against Mr. Combs for what they are: shameless publicity stunts, designed to extract payments from celebrities who fear having lies spread about them, just as lies have been spread about Mr. Combs."

In regard to the sexual assault filings, Combs' attorneys said, "Mr. Combs has full confidence in the facts and the integrity of the judicial process. In court, the truth will prevail: that Mr. Combs never sexually assaulted or trafficked anyone — man or woman, adult or minor."



With two months left in office, lameduck US President Biden made a major policy change that yields to a long-standing request from Ukraine as it fights the Russian invasion, now in its third year.

The new policy and Biden's pledge to speed up military aid to Ukraine come as the United States prepares for Trump to take over as president in January, having questioned US assistance throughout the war.

Trump has repeatedly promised to end the war, but has not provided details of how he would do so.

With Russia gaining ground and increasing talk of negotiations, Ukraine is wary of being at a disadvantage when it comes to hashing out a peace settlement.

Moscow has pledged an "appropriate" response if the US-supplied missiles are in fact used against Russia, and Trump's team accused Biden of escalating the war for political reasons.

At a daily briefing, US State Department spokesman Matthew Miller accused Russia of escalation by accepting a deployment of North Korean soldiers to fight Ukrainian forces.

Miller noted that Biden, not Trump, was still the US president — for now.

Biden's move, however, complicates things for Trump's incoming administration.

'A whole new war'-

"It's another step up the escalation ladder and nobody knows where this is going," Mike Waltz, Trump's choice to be national security





adviser, told Fox News.

"No one anticipated that Joe Biden would ESCALATE the war in Ukraine during the transition period. This is as if he is launching a whole new war," Richard Grenell, who was acting Director of National Intelligence during Trump's first term, wrote on X.

All has changed now — all previous calculations are null and void. And all for politics," Grenell said.

For now, Grenell does not have a job in the incoming administration but his name had come up as a possible Secretary of State before Trump finally decided to go with Senator Marco Rubio.

Ahead of Trump's return to power, Biden appears to be attempting to ringfence support for Ukraine.

And as the war hits 1,000 days, Ukraine's Foreign Minister Andriy Sybiga will visit the US Congress on Tuesday seeking to drum up support.

Trump, who takes office on January 20, has said he could end the war "in 24 hours" and has questioned the more than \$60 billion in military aid that the United States has given Ukraine since the war started.

"How do we get both sides to the table to end this war? What's the framework for a deal and who is sitting at that table?" said Waltz.

"Those are the things that I and President Trump, of course, will be working with."

Shortly after his election victory on November 5 over Kamala Harris, Trump spoke with Ukrainian President Volodymyr Zelensky, who called the conversation "constructive."

Canadian billionaire accused of sexually abusing underage girls in prostitution ring

Canadian billionaire is f a c i n g allegations he sexually abused more than five dozen women when they were children—with the victims alleging they were recruited and paid to participate in his chilling sex ring.

Robert Miller, the founder of Future Electronics, is

accused of repeatedly giving underage girls money and gifts in exchange for sex between 1994 and 2016, Canadian outlets reported, citing that the alleged abuse happened in hotels throughout Montreal.

Miller was ordered on Tuesday to fork over two of his million-dollar Montreal homes as part of a lawsuit filed by four of his accusers, who feared the 81-year-old would try to hide his assets as his legal woes worsened.

Robert Miller is accused of repeatedly giving underage girls money and gifts for sex.

The four victims, who are suing for millions, challenged that the two homes — worth more than \$2 million each — were listed under the names of lawyers for several years, according to The Canadian Press.

"It is troubling to note that Miller, a billionaire, has no bank account in his name," Justice Serge Gaudet said in Quebec Superior Court, noting a "persistent" pattern of listing his fortune and valuables under other people's names, the outlet reported.

The women accused the alleged





predator

of recruiting them as high school students to have sex in exchange for money, describing his prostitution scheme as a "planned system of sexual exploitation" of girls and teens, according to court documents, obtained by Canadian outlets.

One victim alleged she had sex with Miller more than 30 times over two years starting in 1999 when she was 14 years old, according to court documents.

On one occasion, she was given \$1,000 to have sex with Miller—who allegedly refused to wear a condom due to a latex allergy—at the Queen Elizabeth Hotel after being pampered with steak and champagne by one of his employees.

The victim said the alleged sexual abuse left her suicidal as she struggled with alcohol and drugs.

Miller, who has denied the allegations, is also facing a separate proposed lawsuit by more than 50 women who reported that he gave them money and gifts in exchange for sex between 1996 and 2006, CBC reported.

He was also arrested in May on sexual abuse and exploitation charges involving 10 victims, some of whom were minors at the time of the alleged offenses, which occurred between 1994 and 2016.

A Canadian radio exposed his alleged prostitution ring in 2023, resulting in him stepping down from his company.

Miller stepped down from his tech company following a Radio-Canada Enquête report that exposed him for paying minors between the ages of 14 and 17 cash and gifts in exchange for sex between 1994 and 2006, according to CBC.

The report resulted in dozens of women coming forward to report the abuse they sustained as minors.

Lawyers for the accused, who is bedridden with Parkinson's disease, have attempted to delay the criminal case due to his health, according to Canadian outlets.

His cases will continue in December.

Dozens more were killed in another strike at around midnight in northern Gaza, medical sources said. The civil defence has yet to announce a death toll from that strike.

Dozens were killed and wounded in Israeli air strikes on several houses in Beit lahiya in northern Gaza Strip, medics told Reuters on early on Thursday.

The US Senate on Wednesday blocked legislation that would have halted the sale of some US weapons to Israel, which had been introduced out of concern about the human rights catastrophe faced by Palestinians in Gaza.

79 of the 100 senators opposed a resolution that would have blocked sales of tank rounds to Israel, while 18 approved it and one voted present.

Seventy-eight opposed a second measure, which would have stopped the shipment of mortar rounds, while 19 supported it and one voted present. The Senate was to vote later on Wednesday on a third resolution that would stop shipments of a GPS guidance system for bombs.

All of the votes in favor of the measures came from the Democratic caucus, while "no" votes came from both Democrats and Republicans. The protect civilians in Gaza.



"resolutions of disapproval" were filed by Senator Bernie Sanders, an independent who caucuses with Democrats, and co-sponsored by a handful of Democrats.

Strong bipartisan support for Israel in Congress meant the resolutions were never likely to pass, but backers hoped significant support in the Senate would encourage Israel's government and President Joe Biden's administration to do more to protect civilians in Gaza.

68 pro-Iran fighters killed as Israel attacks Syrian town

sixty-eight pro-Iran militants were killed in Israeli air strikes on the Syrian city of Palmyra, the Britain-based Syrian Observatory for Human Rights war monitor said on Thursday.

Those killed in Wednesday's strikes included 42 fighters from pro-Iran Syrian groups, 26 foreign fighters, most of them from the Iraqi Al-Nujaba movement, and four from Lebanon's Hezbollah armed group, the monitor said.

The Syrian Observatory for Human Rights said "Israeli strikes targeted two positions of pro-Iran groups in the Homs region," including "a Hezbollah site in the Qusair area" near the border where "six Iran-backed fighters were killed."

It did not specify their nationalities.

The Observatory, which is based in the UK and whose sources of funding are unclear, has been accused of exaggerating the effectiveness of Israeli strikes in the past.

A Hezbollah source told AFP that at least one fighter from the group was killed in Israeli strikes in the Qusayr area.

Israel rarely comments on individual strikes in Syria but has repeatedly said it will not allow Iran to expand its presence there.



On Saturday, the Observatory said an Israeli drone strike near the Lebanese border targeted a vehicle carrying "a Hezbollah commander and his companion," without reporting casualties.

Hezbollah did not announce any deaths among its ranks on Saturday.

Woman charged for killing 15-yr-old adopted daughter in Florida

former Florida Department of Children and Families employee has been arrested for allegedly abusing her 13-year-old adopted daughter, who was later found dead.

According to the Highland County Sheriff's Office, Diane Natasha Mack, 34, a former guardian ad litem (GAL) and employee of the Florida Department of Children and Families, called police to report the death of her adopted daughter, 13, after discovering her "lying unresponsive" on a floor at their home in the Sun 'n Lake of Sebring golf and recreation community early Tuesday at 12:19 a.m.

Highlands County Sheriff Paul Blackman said the authorities will not quickly forget what they found there.

"This is one of the most disturbing crime scenes I have encountered in more than 30 years of law enforcement," Blackman said Wednesday in a sheriff's office video

announcing Mack's arrest on murder and child abuse charges.

"There are no words I can say that can truly convey the nightmare that this child's life must have been."


According to Blackman, deputies allegedly discovered Mack's daughter dead inside her house, only wearing a diaper and displaying "clear" symptoms of abuse and neglect.

According to the sheriff, Mack revised her time of finding from Tuesday morning, when she first informed authorities she had

located the girl, to approximately 3 p.m. "She was extremely emaciated and obviously malnourished," Blackman said of Mack's daughter.

"Her body was covered in wounds in all stages of healing, including open lacerations that were clearly recently suffered."

The sheriff's office said that once deputies looked into the matter further, they discovered evidence that the homeschooled child had been locked up



in the garage before she died.

"It looks like she was strapped to the garage door and watched from inside the house by a security camera that was installed inside the garage, but we don't know how long she had been there yet," Blackman said.

Before dialing 911, police claim Mack tried to destroy evidence in the garage with pool chlorine while her child was "lying dead on the floor," according to Blackman.

John Prescott, Former Deputy Prime Minister, Dies at 86

ohn Prescott, the former British Deputy Prime Minister who played a pivotal role in the transformation of the Labour Party alongside Tony Blair, has passed away at the age of 86, his family confirmed on Thursday, November 21.

Prescott's death on Wednesday was described as "peaceful," and he was surrounded by his wife Pauline, his two sons, and the music of jazz artist Marian Montgomery.

"We are deeply saddened to inform you that our beloved husband, father, and grandfather,

John Prescott, passed away yesterday at the age of 86," the family statement read.

Prescott, a former merchant seaman, trade union activist, and Member of Parliament (MP) for Hull in northern England for 40 years, was one of the most recognizable figures of British politics in the late 20th century.

Despite his absence, Maresca will have several key players available, including Cole Palmer, Levi Colwill, Wesley Fofana, Malo Gusto, and Romeo Lavia, all of whom missed international duty but have recovered in time for the trip to Leicester.

Maresca also highlighted concerns about players returning from international duty, particularly those traveling from South America. Moises Caicedo and Enzo Fernandez only returned to training on Friday and are unlikely to be at full fitness for Saturday's game.

"The team will not be at 100%," Maresca admitted. "The players who traveled long distances have only had one training session. We'll assess them carefully before making decisions."



James' absence is a significant blow for Chelsea as they aim to build momentum after a mixed start to the season. The Blues will need to rely on depth in their squad, with Malo Gusto likely to step in at right-back during James' recovery.

Chelsea currently sit mid-table in the Premier League and are looking to secure a vital win against Leicester as the season progresses. Balancing league commitments with their UEFA Conference League campaign adds to the challenge, especially with the ongoing injury concerns surrounding their captain.

Germany, unbeaten in the Nations League group phase, now await a quarter-final clash in March against one of Croatia, Italy, or Denmark.

Hungary, finishing third in Group A3, will enter a two-legged relegation play-off in March to retain their place in the top tier of the Nations League. Despite the draw, their spirited performance in Leipzig showcased resilience, with efforts from Andras Schafer, Zsolt Nagy, and Barnabas Varga testing Nubel early on.

Szoboszlai's late heroics will serve as a morale boost for Hungary as they prepare for the play-offs.

Elsewhere in Group A3, the



Netherlands concluded their campaign with a 1-1 draw against Bosnia-Herzegovina. Brian Brobbey opened the scoring for the Dutch, but Ermedin Demirovic equalized to secure a point for Bosnia, who were coming off a humiliating 7-0 defeat to Germany.
