Court strikes out charges against 119 #Endbadgovernance protesters

he Federal High Court in Abuja struck out all charges a g a i n s t 1 1 9 #EndBadGovernance protesters on Tuesday, November 5.

The protesters had been facing serious allegations, including treason felony and incitement to mutiny, following their participation in nationwide protests against perceived corruption and poor governance in the country.

The defendants were initially arraigned on Friday, November 1, in two separate batches.

The first batch consisted of 76 individuals, including 32 minors, while the second batch comprised 43 protesters.

The charges levied against them were in connection with their involvement in the ongoing #EndBadGovernance movement, which has gained significant traction across the country.

The trial judge, Justice Obiora Egwuatu, struck out the case following an application by the Attorney General of the Federation's counsel, M. D. Abubakar, to discontinue the proceedings.

This move has been widely seen as a reprieve for the activists and has sparked a range of reactions from legal experts, human rights advocates, and political observers.

The decision to drop the charges comes amid mounting pressure from both domestic and international human rights organisations, which had condemned the arrest and detention of the protesters as politically motivated.

The #EndBadGovernance protests, which have been taking place across various

officials.

Details of the court's ruling and the motivations behind the decision to discontinue the case are still emerging.

However, the legal team representing the protesters welcomed the court's decision, which they described as a victory for free speech and the right to peaceful assembly.

The case had drawn significant attention, with many seeing the charges as an overreach by the government in stifling dissent.

It remains to be seen whether the #EndBadGovernance movement will gain further momentum following this legal victory, or whether the government will continue to take a hard stance against protests.

IGP to investigate, address concerns over detained minors

Inspector-General of Police (IGP) Kayode Egbetokun has pledged a thorough review and necessary action to address any procedural lapses concerning the detention of minors involved in the EndBadGovernance protest.

After the recent remand and subsequent arraignment of several young individuals on November 1, Mr Egbetokun, who was attending the African Union Mechanism for Police Cooperation committee meeting in Algiers, Algeria, ordered an investigation into the care and welfare of these youths while held in Police detention facilities.



The IGP received the investigative report on Monday while in Glasgow, where he is currently participating in the Interpol General Assembly.

To further promote professionalism in investigations, with a focus on child-friendly approaches, the IGP has summoned all Deputy Commissioners of the Criminal Investigation Department (DCs CID) and Heads of Investigation Units to a conference and workshop on November 7 at the Police Resource Center, Jabi.

The Nigeria Police Force reaffirms its dedication to upholding legal standards, ensuring fairness, and maintaining accountability, particularly in the treatment of vulnerable groups.

Police rescue 14 kidnapped victims, arrest five suspects

Asarawa State Police Command has announced the arrest of five alleged kidnappers and the rescue of fourteen victims held captive in Achido village in the forest bothering Abuja and Kogi State.

The document shared with The New Daily Prime on November 5 noted that with the collaboration of Toto Division security operatives, five arrested suspects in connection to the evil activity have confessed to partake in the crime.

The suspects apprehended are Shuaibu Garba, Umar Mohammed, Yakubu Kasim. Mustapha Adamu and Abdul Mohammed.

According to the notice shared by the force spokesman, Ramhan Nansel, Deputy Superintendent of Police (DSP), the suspect confessed to be supplying food to the kidnappers in the forest.



Nansel stated, "Police operatives attached to Toto Division, in collaboration with community youths on 4/11/2024, burst a kidnappers hideout located at Achido village, a deeply forested terrain bordering FCT and Kogi state."

The names of the rescued victims in Kuje FCT, Rubuchi area, and Tanshi village in Kuje Area Council, Abuja, include Adamu Abdullahi, Musa Ahmed, Auwal Tashai, Kabiru Iliya, Sabo Yakubu, Sagir Iliya, and Yunusa Danladi. Hussaini Yakubu, Haruna Usman, Jibrin Bature, Isyaka Yakubu, Sule Bello, and Yusuf Yusuf, all males, were rescued from Lapai, Niger State.

Addressing this situation, the Commissioner of Police (CP), Umar Nadada, reaffirms his commitment to working together with the residents of the community with the aim to eradicate evil crime.

Also, he pleaded with the members of the public to report suspected movement notices around their neighbourhood to the security force.

Petrol Price: Marketers set to import cheaper products

The Petroleum Products Retail Outlets Owners Association of Nigeria (PETROAN) has confirmed plans to import premium motor spirit (PMS), commonly known as petrol, at a price lower than the current market rate in Nigeria.

In a statement issued on Monday, November 4, PETROAN emphasised that the move is part of its commitment to fostering competition in Nigeria's deregulated petroleum market.

Dr. Joseph Obele, PETROAN's National Public Relations Officer, stated that the group has set up a business unit that will facilitate the importation of cheaper petrol before December.

He stressed that competition is vital for ensuring fair pricing and enhancing the value consumers receive for their money.

"Intensive or aggressive competition in any market brings the best value for money exchange for a commodity. Consumers get the best value for pricing when competition is at its peak," Obele said.

He added that any attempt to limit competition leads to exploitative pricing and profiteering.

The announcement comes as the association faces allegations from Dangote Refinery regarding the quality of products PETROAN plans to import.

Dangote Refinery had accused the marketers of intending to import substandard petrol at a cheaper rate, a claim that PETROAN strongly disputed. Obele dismissed these allegations as "typical" of the refinery's strategy to maintain its market monopoly.

"The publication by Dangote Refinery that PETROAN will import



substandard petroleum products is not coming as a surprise to stakeholders, because such is his usual gimmick for maintaining a monopoly," Obele continued.

"PETROAN has concluded plans with its foreign refinery counterparts and financial partners to import the best quality of PMS and sell it at a far lower price than the current market rate."

Pinnacle Oil Responds to Allegations of Blending Substandard Petrol

Meanwhile, Pinnacle Oil and Gas Limited, a key player in Nigeria's downstream petroleum sector, has issued a response to accusations from Dangote Refinery that it, along with other entities, is involved in blending substandard petrol.

Anthony Chiejina, Group Chief Branding and Communications Officer at Dangote Group, recently claimed that an international trading company had hired a depot facility near the Dangote Refinery with plans to blend lowerquality products and flood the market with them to compete against Dangote's higherquality output.

He argued that this move could harm the growth of domestic refining in Nigeria.

In response, Pinnacle Oil, which operates a facility near D a n g o t e R e fi n e r y, categorically denied these allegations. Bob Dickerman, CEO of Pinnacle Oil, stressed that his company does not engage in the blending of substandard products.

Gov Aiyedatiwa signs N96b 2024 supplementary budget into law

ndo State Governor, Lucky Aiyedatiwa, has s i g n e d the 2024 supplementary budget into law to address the state government's new financial commitments.

In a statement, Chief Press Secretary Ebenezer Adeniyan announced that the N96.788 billion supplementary budget, approved by the State House of Assembly, was signed by the Governor on Tuesday at the Executive Council Chambers of the Governor's Office.

With this addition, the total budget for 2024 stands at N492.045 billion, comprising a recurrent expenditure of N246.728 billion and a capital expenditure of N245.317 billion.

The supplementary budget includes provisions for the recently approved N73,000 minimum wage for workers and the salaries of newly recruited employees across various sectors.

Governor Aiyedatiwa stated that the supplementary budget underscores his administration's commitment to employee welfare and the state's overall development.

Additionally, he signed a bill expanding the board of the Ondo State Oil Producing Areas Development Commission (OSOPADEC), aimed at



fostering inclusivity and enhancing equitable representation for mandate areas.

The governor also signed an amendment to the Ondo State House of Assembly Service Commission Law, expressing appreciation to the Assembly's leadership and members for their dedication to these legislative efforts.

Speaking at the event, Speaker of the House of Assembly, Olamide Oladiji, praised the governor's leadership and recognised the numerous achievements he has realized since assuming office. Oladiji said: "These giant strides have not only transformed the State in all facets but have demonstrated your vision, capacity, intellectual ability, zeal, passion, direction and a clear understanding of the enormous job ahead.

Kwara State Government demolishes LGEA Primary School for reconstruction

The Kwara State Government has taken a bold step to reconstruct the dilapidated Adeta B- Local Government Education (LGEA) Primary School in Adeta into a standard structure.

Governor Abdulrahman Abdulrazaq, in a statement signed by his Senior Special Assistant (SSA) and New Media, Olayinka Fafoluyi, said the demolished school is set to join the ranks of wellstructured educational facilities in Kwara State.

Describing the state of the school, Fafoluyi revealed that most of the classrooms at primary school have "fallen into disrepair, failing to provide a conducive learning environment for students."

He further noted in the document that severely affected classrooms have been pulled down for upgrading.

Acknowledging the move as the first of



its kind, the state government aims to prioritise education, along with other investments across the state.

Recounting his achievement, Governor Abdulrazaq has focused on constructing and renovating hundreds of dilapidated school facilities and recruited more than 5,000 qualified teachers. Additionally, he announced that the e-learning platform known as the KwaraLearn initiative has equipped teachers with tablets with educational programme noting the drastic improvement among Kwara students.

Highlighting the benefit of the elearning platform, Fafoluyi said most students have benefitted from the platform and participated in international competitions.

"The KwaraLearn initiative which equips teachers with tablets containing standardized curricula, along with other educational programs, has not only enhanced the state's educational system but has also led to Kwara students representing the country in international competitions, " Fafoluyi said.

Ekiti CJ, Justice Adeyeye dies at age 64

Justice Oyewole Adeyeye, the Chief Judge of Ekiti State passes on at age 64 after a brief illness.

It was gathered that the late Adeyeye died on 4 November 2024 at tertiary hospital in Ekiti State.

Information relating to his passing away was not made known to the public, however the Hope Newspaper reported that a close source revealed that the deceased died after a short stay in the hospital.

Confirming his death, the International Federation of Women Lawyers (FIDA) in Ekiti State extended their condolences messages to his family, praying that late Justice Adeyeye "finds rest with his maker" for the irreparable loss.

"With deep sorrow in our hearts and in total submission to the will of God, FIDA Ekiti consoles with the family of



the Chief Judge of Ekiti State, Hon Adeyeye on his call to glory. May He find rest with his maker. I pray that God grants the family, the Judiciary and the people of Ekiti State, the grace to bear this irreparable loss. Adieu, great one," the statement read.

Chairperson Oyinade Olatunbosun of FIDA Ekiti noted that further official notice would be disclosed in due time.

However, as of press time, the late Adeyeye family is yet to disclose the cause of his death.

Biography of Justice Adeyeye

Mr Adeyeye was born in 1960 in Araromi Ugbesi, Ekiti East Local Government Area. In 1986, the deceased began practicing after being called to the bar.

He became one of the members of the state counsel in the civil service of the former Ondo State as he kicked started his career. As he began to develop himself and gain experience, in 1996, after the establishment of Ekiti State, he joined the Judiciary Service Commission.

In 2002, he was promoted as judge in the Ekiti State High Court after showing commitment and dedication. Then on 11 October 2021, Mr Adeyeye was appointed as the Chief Judge by then Governor Kayode Fayemi.

Yinka Oyebode, the Special Adviser on Media to the Governor disclosed this in a statement on Tuesday.


Earlier, The New Daily Prime reported that the state Chief Judge, Justice John Adeyeye appointed on 11 October 2021 died on Monday at the age of 64.

"I was really looking forward to being there, but due to ongoing injury I won't be playing next week," Djokovic wrote. "Apologies to those who were planning to see me. Wishing all the players a great tournament. See you soon."

Mourinho regrets not signing Nigeria star

José Mourinho has revealed that he had the opportunity to sign in-form Nigerian star Ademola Lookman.

The Fenerbahce manager recounted how he was prevented from recruiting the Atalanta forward during his tenure at Italian side AS Roma in 2022.

The Nigerian international was recently voted 14th in the Ballon d'Or and remains the favorite in the race for the African Player of the Year Award.

According to Mourinho, the head scout at Roma during the period José Fontes, recommended that Lookman, then at RB Leipzig, not be signed by the Roman side.

Fontes' report painted a negative outlook on Lookman, criticizing his positional sense and decision-making ability on the ball.

He stated further in the report, "In the defensive phase, he is elementary



in terms of understanding the game. A player I have reservations about about his competitive mentality, his confidence and ability to perform under pressure. He is very inconsistent in his performances. There are better solutions available to us and I would not recommend hiring him." Roma, newly crowned Europa Conference League champions at the time, passed on the opportunity to sign the Nigerian as recommended by their chief scout. The forward then went on to join Atalanta under manager Gian Piero Gasperini.

His record at the Bergamo side has served to prove Fontes wrong, much to Mourinho's regret. Lookman has netted 39 goals for Gasperini's side while providing 23 assists in 90 games. He also reached an iconic status among the club's faithfuls with his performance at the 2024 Europa League final where he scored a hat-trick in Atalanta's three-nil battering of German champions Bayer Leverkusen.

Guardiola retains belief in his team despite dip in form

A anchester City manager Pep Guardiola has acknowledge the recent struggles of his team, following their 2-1 loss over the weekend at Bournemouth.

He maintained, however, that they will contest for trophies by the end of the season. Several injuries have hit the City squad, compounding their woes as they suffered their first Premier League loss of the season over the weekend, ending their unbeaten streak from last season.

He pointed out the challenge of playing teams like Fulham and Brentford, added to the existing powerhouses like Arsenal, Liverpool, and Manchester United.

The manager finds it impressive that his side remains in ahead in the contention for trophies despite these challenges.

Arsenal Captain Martin Ødegaard returns to training ahead of Champions League clash with Inter Milan

Neymar Injured Again in Return for Al Hilal

Brazilian star Neymar Jr has picked up another injury following his recent return from a knee injury that sidelined him for more than a year.

The former Barcelona man was brought on for Abdullah Al Hamdan in the 57th minute of Al Hilal's three-nil victory over Esteghlal in the AFC Champions League. He was forced to leave the game after playing for less than 30 minutes, however.

The Brazil captain appeared to have injured his left thigh as the game entered stoppage time, and got a quick medical attention on the sideline before returning to action. He wasn't able to continue, however, leaving the pitch visibly upset.



The midfielder's latest injury is a major setback blow for him and his club after recently returning to action following a surgery for a ruptured ACL.

The Saudi club are hoping to challenge for the AFC Champions League, needing his crucial presence to boost their chances of success. Since Neymar has not been registered to play in the domestic league and will not be eligible until January, his presence in the Champions League has become important for the club which spent a fortune to bring him from PSG.

His meteoric rise has drawn interest from Premier League clubs, particularly Manchester United, as rumors swirl following Sporting manager Ruben Amorim's recent move to Old Trafford.

Yet, Gyökeres's path has been anything but easy. His journey began in Sweden with IF Brommapojkarna, where he was initially doubted. David Eklund, an academy scout at the club, recalls the challenges Gyökeres faced. "When I took him to Bromma, he was 14, and the head of the academy said he wasn't good enough," Eklund told BBC Sport. "But I told him, 'He will score goals.'

Indeed, Gyökeres was no early prodigy,

yet he had the skills—shooting, heading, and finishing—that would later define his career. Despite skepticism, he broke into Brommapojkarna's first team as a teenager, scoring 20 goals in 56 games and impressing coaches with his physicality and perseverance.

Gyökeres moved to Brighton in 2017 but struggled to secure a regular spot, making only four appearances and spending time on loan at Swansea City, St. Pauli in Germany, and Coventry City. It was at Coventry, however, that Gyökeres finally found his stride. Joining the Sky Blues on loan in 2021, he went on to score 39 goals, earning a permanent transfer and emerging as one of the Championship's standout players.

BBC CWR's Clive Eakin notes how Gyökeres transformed Coventry's attack with his unique ability to "run at and through defenders," often surging forward from midfield to threaten the opposition. While some fans were initially hesitant about his return, manager Mark Robins saw Gyökeres's potential and helped him develop his confidence in front of goal.

In 2023, Sporting director Hugo Viana recognized the striker's promise and secured him for the Portuguese side, where he has since flourished. With Sporting, Gyökeres has become one of Europe's most prolific forwards, consistently delivering against toptier competition.

David Eklund, who has tracked Gyökeres's career from its early days, attributes his success to mental resilience and a supportive family environment. "He had a strong mentality, a good family backing him, and he always wanted to prove people wrong," Eklund says. "We never thought he'd reach the highest level, but his work ethic is unmatched."

Gyökeres's rise is now celebrated back at Brommapojkarna, a club with a track record of developing top players like Dejan Kulusevski, John Guidetti, and Albin Ekdal.



US Election 2024: How the presidential voting process works

mericans are heading to the polls today to vote in the highly anticipated 2024 US presidential election, with Democrat Kamala Harris and Republican Donald Trump facing off in a battle for the White House.

The election, closely monitored around the world, not only determines the next president but also elects members of Congress, who will play a key role in shaping US law for the next several years.

The Candidates

In the Republican Party, former President Donald Trump emerged as the candidate after winning the nomination in a hardfought contest against his party rivals.

His running mate is Ohio Senator JD Vance. Trump, who served as president from 2017 to 2021, seeks to return to office after losing to Joe Biden in 2020.

Kamala Harris, the current Vice President, is now leading the Democratic ticket after President Joe Biden chose not to run for a second term. Harris, who made history as the first woman, first Black woman, and first South Asian woman to serve as vice president, has selected Minnesota Governor Tim Walz as her vice-presidential running mate.

While the major parties dominate the field, there are also independent candidates, such as Robert F. Kennedy Jr., though he withdrew from the race in August 2024 and endorsed Trump.

How the Election Works

The US presidential election follows an Electoral College system, meaning that a candidate does not need to win the national popular vote to become president. Instead, the election is determined by winning electoral votes, allocated to each state based on its representation in Congress.

There are 538 total electoral votes, and a



candidate needs at least 270 to win the presidency.

The system is largely a winner-takesall approach, where the candidate with the most votes in a state wins all of its electoral votes except in Maine and Nebraska, which allocate their electoral votes based on individual congressional districts.

Battleground States

While many states consistently vote for either the Republican or Democratic candidate, some states known as swing or battleground states are more evenly divided and can swing either way.

These states are often crucial in determining the overall outcome of the election.

In the 2024 race, Arizona, Georgia, Michigan, Nevada, North Carolina, Pennsylvania, and Wisconsin are considered key battlegrounds by CBS News. Candidates focus much of their campaigning on these states, seeking to win over undecided voters and and secure critical electoral votes.

The Electoral College and the Popular Vote

It's possible for a candidate to win the Electoral College but lose the national popular vote. This happened in 2016, when Donald Trump won the presidency despite Hillary Clinton receiving more votes nationwide. Since 1824, only five presidents have been elected without winning the popular vote.

Rare Scenarios: Faithless Electors and Contingent Elections

In rare instances, an elector a member of the Electoral College might choose to vote for someone other than the candidate who won the popular vote in their state. These individuals are called faithless electors, and while their votes rarely alter the outcome of an election, they represent an unpredictable element in the process.

UK to create 'smoke-free generation' with new tobacco law

The UK is set to introduce a pioneering piece of public health legislation aimed at creating the world's first "smoke-free generation," with a new tobacco law to be presented in Parliament on Tuesday, November 5.

The move comes as part of the government's broader strategy to curb smoking rates and reduce the long-term health burden on the National Health Service (NHS).

Under the new proposals, anyone born after January 1, 2009, will be prohibited from purchasing tobacco products, effectively making them the first generation in the UK who will never legally be able to buy cigarettes.

This gradual increase in the legal age to buy tobacco is a cornerstone of the Tobacco and Vapes Bill, which Health Secretary Wes Streeting described as a "groundbreaking" initiative.

"This is a groundbreaking piece of public health legislation," Streeting said.

"It will mean that we are creating the first-ever smoke-free generation in our country. Children growing up in our country today will never, never legally be able to buy cigarettes."

National and swing state polls have tightened in the weeks leading to the election, so there could be very narrow margins of victory in several places, which may require votes to be recounted.

The bill, which mirrors proposals from the previous Conservative administration, aims to reduce smoking rates across the UK, following the failure of New Zealand's similar plans to introduce a "generational smoking ban."

New Zealand's government reversed

its decision last year under the leadership of Prime Minister Christopher Luxon, citing other economic priorities.

In addition to the age restrictions on tobacco, the UK's Tobacco and Vapes Bill will introduce a series of measures aimed at curbing the appeal of e-cigarettes,

particularly among young people.



The UK government's new law marks a significant step in the global fight against tobacco-related diseases.

Smoking rates have steadily declined in the UK over the past few decades, following landmark bans on smoking in enclosed public spaces and workplaces in 2007.

Research has shown that the smoking ban in England led to a 2.4% reduction in hospital admissions for heart attacks in the year following its implementation, saving the NHS millions of pounds.

The Tobacco and Vapes Bill is expected to play a key role in achieving the UK's ambition to reduce smoking rates even further, helping to prevent future generations from becoming addicted to nicotine and easing the long-term burden on the state healthcare system.

As the UK pushes ahead with its ambitious public health goals, it remains to be seen whether other countries, including New Zealand, will revisit similar measures in the future.

With the UK setting the pace, the idea of a "smoke-free generation" may soon be a reality elsewhere in the world.

The legislation will place strict limits on the advertising and sponsorship of vapes, as well as impose restrictions on vape packaging, flavours, and displays that may attract children and teenagers.

The government has also pledged to ban disposable vapes starting in 2025, a move designed to reduce the accessibility and appeal of single-use vaping products, which have become increasingly popular in the UK.

The proposed bill will also extend smoking bans to more public spaces, including outdoor areas such as playgrounds and hospital grounds. However, one notable exclusion is smoking in pub gardens.

Despite earlier leaks suggesting a potential ban on smoking in outdoor hospitality areas, Streeting confirmed that the legislation will not include pub gardens, citing concerns over the impact on the hospitality industry.

"The UK hospitality sector has taken a battering in recent years, and we don't want to add to their pressure, so we're not proposing to go ahead with an outdoor hospitality ban at this time," Streeting said.

Equatorial Guinea restricts WhatsApp amid sex scandal

The Government of Equatorial Guinea has imposed new restrictions on WhatsApp, limiting citizens' ability to download and share multimedia files using mobile data.

This move follows a controversial sex scandal involving Baltasar Engonga, the Director General of the National Financial Investigation Agency (ANIF), which has sparked outrage and debate across the country.

According to local reports, the government has instructed telecommunications providers to implement measures that restrict access to inappropriate content, a decision believed to be linked to the scandal. Engonga, a 54-year-old economist, has found himself at the center of a highprofile fraud investigation, during which authorities uncovered hundreds of explicit videos on his office computer.

The footage allegedly depicts Engonga's sexual encounters with the wives of prominent individuals, including political figures and ministers.

Among the women involved are the wives of his brother, his cousin, the sister of President Teodoro Obiang Nguema, the Director General of Police's wife, and around 20 other ministers' wives.

The scandal has caused a media storm, especially after the videos, which were reportedly recorded with consent, leaked online.

The leaked content has sparked public outrage and has raised serious concerns about privacy and governance in the country.

In response to the scandal, the government of Equatorial Guinea has taken drastic steps to limit the dissemination of such content, including the restriction of multimedia file-sharing on WhatsApp over mobile data connections.



Citizens have been forced to rely exclusively on WiFi networks to share photos, videos, and audio, which many have criticised as a disproportionate response that curtails essential communication functions.

Local news platform Ahora EG reported that many users have expressed frustration over the measure, with some questioning the fairness of penalizing the entire population for the actions of a few.

"Should an entire country pay for the actions of a few?" one anonymous source told the platform.

"The likely decision to restrict access to essential communication functions seems disproportionate and punitive, affecting thousands of users who rely on WhatsApp for work, education, and personal communication."

Another source pointed out the growing dependence on digital platforms in today's world.

"In a world where digitalisation is becoming more and more important,

The report also noted that the government has yet to clarify the reasons behind the restriction or provide any details on how long the measure will last, further stoking public concern.

The WhatsApp restrictions are not the only significant government action being implemented in response to the scandal.

Earlier this week, Vice President Teddy Nguema announced plans to install surveillance cameras in all state offices as part of a broader initiative to ensure greater accountability and prevent misconduct among public officials.

This measure is seen as part of an ongoing push to tighten control over the public sector, but it has raised concerns about the erosion of privacy and the extent of government oversight.
