# Gunmen abduct 25 people, mostly women in Katsina

unmen suspected to be terrorists attacked Batsari Local Government Area of Katsina State and abducted at least 25 people consisting mostly of women and children.

Several homes were ransacked by the hoodlums in the incident that occurred late Sunday night.

According to a resident of the community who asked not to be named, the gunmen stormed the community in their numbers, shooting sporadically to announce their presence.

He said the hoodlums did not kill anyone but abducted the said number of people and moved them into the forest.

He said the gunmen operated without restraints as security operatives did not come to the area till hours after the hoodlums had left the community.

He lamented that the cold weather caused by harmattan winds would adversely affect the victims in the forest as some of them were little



children and babies.

The source, however, said that the gunmen were yet to contact the community on the abducted persons, as such was their mode of operation in past incidents.

He called on the government to boost security presence in the area, as communities within the axis had been victims of such attacks in recent times.

He cited the example of an attack some four days ago, on a village neighbouring Ajasa where an attack by gunmen left one person dead while

another victim sustained injuries.

He lamented that the attack occurred in broad daylight when some farmers were reaping harvests from their farmland.

When contacted, a spokesperson for the police command in the state, ASP Abubakar Aliyu, said he would make inquiries on the matter and revert with details.

Aliyu has not provided additional details on the incident as of the time of this report.

# Nigeria to benefit from \$1.65bn W'Bank loan in 2025

ligeria is set to benefit from three major loan projects totalling \$1.65 billion in 2025, courtesy of the global financial institution, the World Bank.

According to information obtained from the World Bank's website, it (World Bank) is set to decide on three major loan projects for Nigeria in 2025, as part of efforts to address critical developmental challenges in the country.

The loans, currently in the pipeline, will focus on internally displaced persons, education, and nutrition enhancement.

According to reports, the loans are designed to support Nigeria's social and economic recovery, particularly in vulnerable sectors requiring urgent intervention.

The first project, titled Solutions for the Internally Displaced and Host Communities Project, has a commitment amount of \$300m and is scheduled for approval on April 8, 2025.

The project, which remains at the concept review stage, seeks to provide sustainable solutions for internally displaced persons and their host communities, addressing their social and economic challenges.

The second project, HOPE for Quality Basic Education for All, is expected to receive \$553.8m in financing.

Its approval is slated for March 20, 2025, and it also remains in the concept review phase.



The third project, Accelerating Nutrition Results in Nigeria 2.0, involves the largest share of the proposed loans, with a commitment of \$800m.

The Bretton Woods Institution is expected to hold a decision meeting on the project by February 20, 2025.

The \$1.65bn financing package reflects the World Bank's continued commitment to supporting Nigeria's ongoing reforms.

The World Bank's schedule indicates that decisions on these loans will be made in early 2025, with Nigeria's ability to meet project prerequisites and demonstrate accountability in implementation likely to play a key role in getting the funds.

It was further observed that the Federal Government, under the leadership of President Bola Tinubu, has secured loans worth \$6.95bn from the World Bank in about 18 months. The amount increased to the new figure following the latest approval of a new \$500m loan from the World Bank for a project in Nigeria.

The Board of the World Bank Group approved a \$500m loan to Nigeria last

week Friday (December 13, 2024) to boost rural access and agricultural marketing in the country.

According to information obtained from the Washington-based institution, the loan is for the Rural Access and Agricultural Marketing Project—Scale Up.

It is designed to bridge the gap between rural communities and the broader marketplace, facilitating smoother access to agricultural markets, schools, and hospitals and promoting social cohesion among rural populations.

This was the 10th loan project from the World Bank under the administration of President Bola Tinubu.

The first project approved under Tinubu's administration was the \$750m Power Sector Recovery Performance-Based Operation.

This loan is designated as additional financing for the power sector recovery performance-based operation, a crucial component of Nigeria's broader strategy to stabilize and enhance its power sector.

# Nigeria's First Lady disburses N1.9bn to senior citizens nationwide

I igeria's First Lady, Senator Oluremi Tinubu on Tuesday disbursed the sum of N1.9nbillion to the elderly across 36 states and Federal Capital Territory through her Renewed Hope Initiative programme.

Beneficiaries of the donation aged 65 and above got N200,000 each tagged, Renewed Hope Initiative Elderly Support Scheme (RHIESS).

Mrs Tinubu, who was represented by the First Lady of Lagos, Dr Ibijoke Sanwo-Olu at the State House, Alausa, gave N50 million to 250 beneficiaries in Lagos.

The donation was increased to N200,000 this year from N100,000 that was provided last year for the elderly citizens during this festive season.

At the short ceremony, there were three leaders from each Senatorial Districts which included, Lagos West, Alhaja Mojisola Alabi, Lagos West, Mr Adebayo Adeoye and Lagos East, Mrs Esther Mamora.

The First Lady said, "I am delighted to join you all today at the 2nd edition of the Renewed Hope Initiative Elderly Support Scheme (RHIESS) with the theme: TOTAL WELLNESS: Happy, Healthy and Prosperous Lifestyle.

"This programme is designed to support the welfare of our elderly citizens annually. Two Hundred and Fifty (250) elderly citizens, aged 65 and above in all 36 States of the federation, the Federal Capital Territory and veterans from the Defence and Police Officers' Wives



Association (DEPOWA) will be benefiting from this scheme.

"The Governing Board of the Renewed Hope Initiative has decided to increase the grant from N100,000 to N200,000 this year to provide further support to our elderly citizens during this festive season.

"A total of One Billion, Nine Hundred Million Naira (N1,900,000,000) will be disbursed across the nation. The RHI Coordinators in the 36 States of the federation, the FCT and DEPOWA have received Fifty Million Naira (N50,000,000) each, out of which N200,000 will be distributed today to each beneficiary.

"In addition to this, free medical check-ups and other sundry items will be provided. I commend all our State First Ladies/RHI State Coordinators and partners for their efforts in making this day a reality.

"I congratulate all our senior citizens who have been selected as beneficiaries. I urge you to remember to prioritise your health even as we all enjoy and celebrate in the festive season. Eat well, stay hydrated, do little exercise – like walking and getting adequate rest. Spend quality time with loved ones, and do what you enjoy and makes you happy."

I confirm that I got the N50,000. This will be used to purchase foodstuffs and take care of my children. May Gid bless Oluremi and her husband," she prayed.

# NYSC member slumps, dies at Kebbi orientation camp

National Youth Service Corps (NYSC) member deployed to Kebbi State, Tayachibiyacha Ebal, has tragically passed away after collapsing at the Dakin Gari Orientation Camp.

Reports indicate that Ebal suddenly slumped and was immediately rushed to the camp clinic for urgent medical attention. She was later transferred to the Federal Medical Centre in Birnin-Kebbi for advanced treatment. Despite efforts by medical professionals to revive her, she was pronounced dead.

Fingila, confirmed the incident to journalists in Birnin-Kebbi.

He described the event as unfortunate and expressed condolences to the deceased's family on behalf of the state government. He also revealed that her remains had been sent to her home state, Adamawa, for burial.

Efforts to obtain a statement from the Kebbi State NYSC office were unsuccessful, as their spokesperson, Mrs. Hadiza, did not respond to calls or messages.

### Reckless driver kills traffic officer in Ibadan

he Oyo State Government has pledged to prosecute a reckless driver responsible for the death of Kehinde Fabunmi, an officer of the Oyo State Road Traffic Management Authority (OYRTMA). Fabunmi was fatally struck on Saturday in the Agbowo area of Ibadan North Local Government while on duty.

The incident occurred when a Black Mercedes-Benz 4MATIC with registration number LSD862JS reportedly ignored a traffic light and was subsequently stopped by OYRTMA officers. In a desperate attempt to escape, the driver reversed the vehicle and, while trying to speed away, fatally hit Fabunmi, who had approached the car from the front.

The officer sustained severe head injuries and was rushed to a nearby hospital in Orogun. He was later transferred to another facility within Ibadan, where he was pronounced dead.

Speaking on the matter on Monday, the OYRTMA Chairman, Adekoya Adesagba, condemned the tragic



incident, emphasizing that Fabunmi was performing his lawful duty of ensuring road safety when he was killed.

"OYRTMA officers are dedicated to safeguarding lives and property on our roads. Anyone who assaults or disrespects these officers will face the full wrath of the law," Adesagba said.

He praised the swift action of the police and OYRTMA officers, who apprehended the suspect near the University of Ibadan area shortly after the incident. Adesagba also expressed his condolences to the family of the

deceased officer.

"The suspect has been arraigned at the Magistrate Court, Iyaganku, today (Monday). However, due to the court's weekday break, the case has been adjourned until Thursday. The suspect will remain in police custody," he stated.

Adesagba described the incident as a stark reminder of the dangers faced by traffic management officers daily and reiterated the need for drivers to exercise caution and obey traffic laws.

"The killing of our officer is a serious offence, and justice will be served. No one who disrespects or endangers our officers will go unpunished," he added.

The government has assured the public that the prosecution of the suspect will be pursued vigorously to serve as a deterrent to others.

# Aba market, fake drinks, beverages production hub – NAFDAC

he National Agency for Food and Drug Administration and Control (NAFDAC) has declared Eziukwu Market, also known as Cemetery Market in Aba, Abia State as the centre for the production and distribution of fake and substandard drinks and beverages.

NAFDAC Director, South-East Zone, Martins Iluyomade made the declaration during an operation at the market on Tuesday.

Iluyomade described the market as a centre for mass production and distribution of fake and substandard products, likening the situation to weapons of mass destruction.

The director said in spite of previous crackdowns, including a major operation in December 2023, illegal activities persisted in the market.

He said it was baffling that individuals



remained recalcitrant and determined to make money at the expense of the lives of their fellow citizens.

"During the last operation the leadership of the market signed an undertaking with NAFDAC to identify and expose those involved in the production and sale of fake goods," he said.

According to him, the agency will revisit the agreement as market leaders now have serious questions to answer.

Iluyomade said the volume of expired products being re-validated was deeply troubling.

He advised consumers to remain vigilant about the products they purchase to avoid endangering their health.

Meanwhile, the raid uncovered an alarming range of fake and adulterated products, including wines, whiskey, yogurt, carbonated drinks, chips, dry gin and other beverages.

The items were found either being produced in unsanitary conditions within the market or stored in sections where expired products were relabelled with new dates.

## Army releases detained Okuama leader, Okungbaye to Sen Dafinone

a Dennis Okugbaye, one of the detained Okuama leaders, has been released to Senator Ede Dafinone, contrary to earlier reports that he had died in Nigerian Army detention.

Okugbaye was released on bail following Senator Dafinone's intervention and is expected to be produced on demand.

Currently, Pa Okugbaye is receiving medical attention at the University of Port Harcourt Teaching Hospital, where he is being cared for by family members.



His release comes after Senator Dafinone called for the unconditional release of Okugbaye and other detained Okuama leaders or for them to be charged to a civil court.

## ICPC recovers N52bn, \$966,900.83, intercepts N5.9bn diverted funds

Aliyu (SAN), disclosed this, on Tuesday at an event to mark his one year anniversary as the Chairman of ICPC in Abuja.

The ICPC boss added that the commission also intercepted and stopped the diversion of N5.882 billion in 323 Ministries, Departments, and Agencies (MDAs) within the same period.

He attributed the significant milestone achievement to the steadfast commitment to the rule of law, adaptation to evolving trends and equipping its workforce with ICT capacity in the fight against corruption.

"The current administration's anticorruption agenda and my own policy thrust encapsulated in the acronym "CARE" for impact, have further motivated the Commission to enhance its tools, approaches, and engagements.

"I am therefore bold and proud to reflect on the modest progress we have made and the challenges we have overcome so far.

"These accomplishments include notable asset recoveries, enforcement actions, and initiatives promoting transparency and good governance.

"For instance, through its Constituency and Executive Projects Tracking Initiative (CEPTI), the Commission continues to ensure accountability in government funds and delivery of tangible benefits of



democracy to citizens across Nigeria," he said.

Aliyu said that in the area of asset recovery, №29.70 billion in cash was recovered and presently domiciled in ICPC recovery accounts.

He said that in the same vein ₹10.98 billion in VAT was recovered and remitted to FIRS, while N10 billion COVID-19 vaccine fund meant for production of vaccine was remitted to the treasury.

The ICPC chairman further stated that the commission also recovered value of assets to the tune of N2.5 billion through various courts' order of final forfeiture.

Aliyu added that \$966,900.83, was also retrieved and kept secured in the ICPC-CBN account balance brought forward.

He explained that the commission intercepted over N5 billion while conducting Systems Study and Review (SSR) of the MDAs through its Ethics and Integrity Compliance Scorecard (EICS).

"As part of its commitment to institutional accountability, the Commission assessed 323 Ministries, Departments, and Agencies (MDAs) through its Ethics and Integrity Compliance Scorecard (EICS).

"It also established 80 Anti-Corruption and Transparency Units (ACTUs) across MDAs to reinforce its anti-corruption efforts.

"While doing these, the Commission stopped the diversion of public funds to the tune of N5.882 billion," he said.

Aliyu disclosed that the report of the EICS exercise conducted in the middle of this year was ready and would also be released to the public through the media.

Aliyu said the commission had just completed the tracking of 1,500 projects nationwide, valued at N610 billion, under CEPTI Phase 7.

"Upon completion of tracking field work last week, follow-up activities are ongoing and the report is being collated.

"However, the report of the Phase 6 exercise conducted about this same time last year is ready and will be released to the public today," he added.

# Google, Facebook, other foreign firms pay N3.85tn in taxes to Nigerian government – Report

In a significant development for Nigeria's tax revenue, foreign companies operating in the country, including tech giants such as Google, Netflix, and Facebook, have remitted a total of N3.85 trillion in taxes to the Federal Government in the first nine months of 2024.

This represents an impressive 68.12 per cent increase from the N2.29 trillion collected in the same period in 2023.

The revenue, which includes Company Income Tax (CIT) and Value Added Tax (VAT), was revealed in a report issued by the National Bureau of Statistics on Tuesday.

According to the data, tax collections surged steadily throughout the year. In the first quarter of 2024, Nigeria earned N1.03 trillion, which rose to N1.52 trillion in the second quarter, and further increased to N1.30 trillion in the third quarter.

A significant portion of this revenue came from CIT, which accounted for N2.57 trillion—up by 43.65 per cent compared to the N1.79 trillion collected in the same period of 2023.

VAT collections also saw substantial growth, reaching N1.28 trillion, an increase of 157.03 per cent from the N498.34 billion collected in 2023. This jump reflects the success of Nigeria's improved tax collection efforts.

The Federal Inland Revenue Service (FIRS) explained that CIT is a 30 per cent tax on companies' profits, while VAT is a 7.5 per cent consumption tax paid by the final consumer when goods are purchased or services are rendered.

On a quarterly basis, CIT earnings showed a marked improvement, climbing 42.49 per cent from N598.13 billion in Q1 to N1.12 trillion in Q2,





before slightly dipping to N852.29 billion in Q3. VAT collection was more stable, earning N435.73 billion in Q1, N395.74 billion in Q2, and N448.85 billion in Q3, a 3.01 per cent increase.

The report highlights the growing importance of tax revenue in Nigeria's economy. Since 2020, the Federal Government has been focusing on collecting taxes from foreign digital service providers operating in the country. These companies, such as Netflix, Facebook, and Twitter, have benefited from Nigeria's large and growing digital market but had previously avoided tax obligations due to their lack of physical offices in the country.

As part of the tax collection drive, the government began imposing a digital tax on companies offering video streaming, social media platforms, and digital content services. This tax is expected to increase further once more foreign firms comply with the regulatory framework.

Despite some platforms, like TikTok and X (formerly Twitter), failing to meet tax filing requirements, others, including Google, LinkedIn, and Meta, have fully complied with the tax obligations as per Nigeria's Code of Practice for Interactive Computer Service Platforms and Internet Intermediaries.





This growth in tax collections is particularly significant in light of earlier statements from former Accountant-General of the Federation, Oluwatoyin Madein, who revealed that tax revenues have now become the nation's highest source of income.

As a result, members of the Federation Account Allocation Committee eagerly anticipate the monthly revenue reports from the FIRS, as these funds are essential for distribution among the federal, state, and local governments.

In line with its ambitious revenue goals, the government set a tax collection target of N19.4 trillion for 2024, with the FIRS already having exceeded N18.5 trillion in remittances for the year.

The substantial growth in tax revenue underscores Nigeria's efforts to improve its fiscal health through increased tax compliance, especially from foreign digital service providers.

This is expected to provide further stability and growth for the country's economy in the years to come.

### MTN contributes over N200bn monthly in VAT - Tax committee

aiwo Oyedele, Chairman of the Presidential Fiscal Policy and Tax Reforms Committee, has revealed that MTN Nigeria is the largest contributor to the nation's Value Added Tax (VAT) pool, paying over N200 billion every month.

This makes t h e telecommunications giant the single biggest contributor to the country's VAT revenue, with a significant gap between it and the second-largest contributor.

Oyedele shared this information during a recent appearance as a panellist on Channels Television's Town Hall on Tax Reforms.

He also took the opportunity to highlight disparities in the current VAT distribution system and discussed ongoing reforms designed to address these issues.

The current VAT distribution system attributes all of MTN's VAT payments to Lagos State, where the company's headquarters is located. However, Oyedele pointed out that the services generating this VAT revenue are consumed nationwide, not just in Lagos.

"MTN is the largest contributor to VAT in Nigeria. They pay over N200 billion every month, and the gap between them and the secondhighest contributor is huge," Oyedele explained.

"Today, all the VAT paid by MTN is credited and attributed to Lagos State, even though calls are made in Kano, the FCT, Ekiti, Edo, or Kebbi."



One of the key proposals in the tax reform bill is a change in the VAT allocation process. The aim is to ensure a more equitable distribution of VAT revenues based on actual consumption, rather than the location of a company's headquarters.

To illustrate the potential impact of the reforms, Oyedele presented a hypothetical model for redistributing MTN's VAT contributions. Under this model, Lagos State would receive approximately 20 per cent of the VAT paid by MTN, with the remainder shared more fairly among other states across Nigeria.

"This adjustment ensures that states where the VAT is generated get their fair share," Oyedele said.

"When you analyse the data, you see Lagos State's share reduces slightly, but every other state gains."

The tax reform bill, which has been under discussion recently, aims to

address longstanding challenges in Nigeria's fiscal policies. It includes provisions for more balanced revenue redistribution, addressing inefficiencies in the system, and promoting fairness in how VAT is allocated across the country.

The proposal has sparked some debate, with critics arguing that it could have negative consequences for certain parties.

However, Oyedele defended the proposed reforms, stressing that the current system is flawed and unfair. "If you're doing the wrong thing, how can Lagos State disagree with us when we propose to fix it?" he said.

The proposed changes to Nigeria's VAT distribution system are expected to have significant implications for the country's fiscal landscape, ensuring a fairer allocation of tax revenues across states.

# Nigerians paid over N2tn in ransom amid growing kidnapping crisis – NBS report

he National Bureau of Statistics (NBS) has revealed that Nigerians paid a staggering N2.23 trillion as ransom over a 12-month period between May 2023 and April 2024.

This amount was paid by households affected by kidnapping incidents, underscoring the increasing threat posed by criminal activities across the country.

The NBS's latest Crime Experience and Security Perception Survey report shows that a total of 51.89 million crime incidents were recorded across Nigerian households during the reference period.

The North-West region reported the highest number of crimes, with 14.4 million cases, followed by the North-Central region with 8.8 million incidents. In contrast, the South-East had the lowest crime rate, with 6.18 million incidents.

The findings also indicated that rural areas were more affected by crime than urban centres, with rural households experiencing 26.53 million incidents, compared to 25.36 million in urban areas.

Kidnapping was identified as a particularly severe issue, with 4.14 million households reporting home robberies.

Of the households affected by kidnapping, 65% were forced to pay ransom to secure the release of victims. The average ransom paid amounted to N2.67 million, which contributed to the total N2.23 trillion paid by Nigerians to criminals over the 12 months.



Despite the high number of crimes, only 36.3% of households that experienced home robberies reported the incidents to the police, and the reporting rate for kidnappings was similarly low. Many victims cited a lack of confidence in law enforcement, believing that police intervention would not result in meaningful action.

The survey also found that 21.4% of Nigerians were victims of crime at the individual level, with phone theft being the most common offence, affecting 13.8% of the population. While 90% of phone theft victims reported the crime to the police, only half were satisfied with the police's response.

In terms of sexual offences, an estimated 1.4 million Nigerians were victims, with most incidents occurring in either the victim's residence or someone else's home. Only 22.7% of victims reported the crime to the police.

Public perception of safety remains concerning, with 9.6% of Nigerians

believing they are at risk of becoming crime victims in the next 12 months. The fear of crime was higher in rural areas, where 13% of the population felt vulnerable, compared to just 7% in urban areas.

The survey also raised concerns about the effectiveness of Nigeria's security agencies, particularly the police, in responding to emergencies. Only 33.1% of Nigerians reported that security agencies responded to emergency calls within 30 minutes.

Satisfaction with police responses was notably low, especially in cases involving livestock and crop theft, where less than half of victims expressed satisfaction. In many rural areas, local vigilante groups were seen as more reliable sources of security.

The findings paint a troubling picture of the state of crime and security in Nigeria, highlighting the need for greater accountability and efficiency in law enforcement.

## Oyo state to implement N80,000 minimum wage from January 2025

overnment workers in Oyo State will begin receiving the newly agreed N80,000 minimum wage from January 2025.

According to the statement, the Oyo State government and labour unions reached a consensus on the new wage structure, which includes consequential adjustments.

The agreement was signed by the Secretary to the State Government, Prof. Olanike Adeyemo, and the Head of Service, Mrs. Olubunmi Oni, representing the government.

Kayode Martins of the Nigeria Labour Congress (NLC) and Bosun Olabiyi of the Trade Union Congress (TUC), along with other labour leaders, signed on behalf of the unions.

Although the new minimum wage structure was initially agreed to take effect from July 1, 2024, the financial implementation will begin on



January 1, 2025.

that workers who retire between July 1 and December 31, 2024, will have their retirement new wage structure.

The statement further called on all ministries and extraministerial departments in the 2019. state to intensify efforts in boosting the state's Internally Generated Revenue (IGR), in order to improve the state's fiscal standing.

## **Bovi: Child beating wrong**

igerian comedian Bovi Ugboma emphasizes empathy, understanding over corporal punishment in his parenting approach, advocating for a more thoughtful approach.

During a recent interview on The Honest Bunch podcast, aired on Monday, Bovi shared personal experiences as a father, explaining his approach to handling difficult situations with his children.

Bovi recalled instances when his child would become upset and resort to throwing objects, including breaking family items like the television.

"I don't advocate for beating children. You should let children be. My son would break the television just for fun. If he got upset, he would throw things and break them," Bovi said.

"When you follow our educational system, a 16-year-old is often in SS3. What does a 16-year-old truly understand about authority? It's wrong," he said. "This creates a culture of abuse and hierarchy. It has to stop."

He questioned the practice of enforcing respect through fear, asking whether anyone would accept a 16-year-old punishing their child. "Would you let a 16-year-old flog your child because they believe they're the senior?" he asked.

He further criticized the broader culture that prioritizes respect through fear, arguing that it begins in secondary school. "The white man left us and created a system for us to colonize ourselves. Now, everyone is waiting to climb to the top to assert their authority," he explained.

"That's why you hear people say, 'Do

you know who I am?' It starts with a glorified form of torture where older students punish younger ones."

On the topic of parenting, He emphasized the importance of recognizing that each child is unique.

"That's why you'll find some children saying, 'I love my dad,' while others may say, 'I hate my dad.' It's because the father used the same approach for all of them."

# Primary pupils able to view porn on school computer

Chool children in Edinburgh have a c c e s s e d v i o l e n t a n d pornographic images on iPads provided by the city council, raising significant concerns about inadequate security systems. Devices distributed by the Labour-led Edinburgh City Council to thousands of 10- and 11-year-old pupils were intended to enhance learning, but reports have emerged that children bypassed security controls using simple methods.

The primary school pupils discovered ways to manipulate internet search engines by deliberately misspelling explicit terms or inserting spaces into blocked words. By clicking on the images tab, children were able to bypass safeguards, triggering warnings of adult content that included prompts to disable "safe search" filters. A concerned parent, who documented the loopholes in a video, revealed that explicit content such as erotic hanging, strangulation, drowning, and graphic executions was accessible on their 10-year-old's device.

In response, Edinburgh City Council issued a statement acknowledging the problem and confirming it had taken "immediate steps" to prevent further incidents. The council also suspended access to Wikipedia, citing concerns that some of its content might not be suitable for all age groups. An "urgent review" has been launched to address the security flaws.

However, parents remain alarmed. One parent expressed frustration that such critical flaws existed, while others highlighted the ease with which children had bypassed the controls. The council's statement, which contained no formal apology, argued that "no technical solution can ever guarantee full safety" for children using digital devices.

Miles Briggs, a Conservative MSP for Lothian, condemned the council's failure, stating, "It's deeply concerning. The council has failed to put in place the safety systems needed to control what children can access – and that's

something they need to answer questions on." Mr. Briggs also confirmed plans to seek assurances from Jenny Gilruth, Scotland's Education Secretary, that similar security vulnerabilities are not present on digital devices distributed across the country.

Alex Cole-Hamilton, leader of the Scottish Liberal Democrats and an Edinburgh MSP, added: "The online battle to keep our kids safe is neverending. As the father of a Primary 6 daughter who enjoys her iPad very much, this concerns me deeply."

The controversy underscores a broader challenge in managing digital safety for children while balancing access to educational resources. The Edinburgh City Council now faces mounting pressure to reassure parents and strengthen its digital safeguarding measures to prevent further incidents.



# NY Judge upholds Trump's hush money conviction, rejects immunity claim

New York judge has ruled Donald Trump's hush money conviction is valid, rejecting the president-elect's argument that it should be dismissed in the wake of a landmark immunity ruling from the US Supreme Court.

In July, the country's top court ruled that presidents have broad immunity from criminal prosecution for "official actions" they take while in office.

But on Monday, Manhattan Judge Juan Merchan who presided over Trump's trial this past spring sided with prosecutors, saying the convictions on 34 felony counts centred on "unofficial conduct."

The decision preserves Trump's historic conviction which, if upheld, would make Trump the first felon to serve in the White House.

In his 41-page ruling, Justice Merchan pushed back on Trump's argument that the government's case relied on evidence related to his official work as president, which would be covered by immunity.

The evidence shown at trial pertained "entirely to unofficial conduct," he wrote. The judge noted that in its own ruling the Supreme Court had found that "not everything the president does is official," even if done from the Oval Office.

In a statement to US media, Trump spokesman Steven Cheung criticised the ruling, calling it "a direct violation of the Supreme Court's decision on immunity."

"This lawless case should have never been brought, and the Constitution demands that it be immediately dismissed,"Mr Cheung said.

In May, a New York jury found Trump guilty of falsifying business records.

The conviction stemmed from Trump's attempt to cover up reimbursements to his ex-lawyer, Michael Cohen, who in 2016 paid off an adult film star to remain silent about an alleged sexual encounter with Trump.

Trump has denied all wrongdoing.

Justice Merchan had been scheduled to rule on the conviction on 12 November, but he postponed the decision, saying he wanted to hear from prosecutors on how to move forward with the case following Trump's re-election.

In the days since, Trump filed another motion to dismiss the case, arguing that his forthcoming return to the White House required the case to be tossed.

Now, following Justice Merchan's ruling, Trump's team is almost certain to seek further delays and appeals. The judge is still yet to decide whether to issue a sentence before Trump assumes office in January, after his term ends in 2029 or not at all.

# Assad breaks silence, claims he was forced to flee Syria

ormer Syrian President, Bashar al-Assad has broken his silence since the fall of his regime, claiming he never intentionally fled to Russia — and blaming his troops for the stunning collapse.

A post Monday on Assad's former Telegram channel claims he merely left the capital on Dec. 8 to meet with Russian forces in the Latakia province "to oversee combat operations" as Syrian rebels stormed Damascus.

Amid the assault, Assad said, he was forced to evacuate among the Russian troops, who took him to Moscow, from where he allegedly still planned to lead.

Assad was allegedly forced to evacuate from a Russian base in Latakia, where he claimed to be assessing the military situation. AP

"At no point during these events did I consider stepping down or seeking refuge, nor was such a proposal made

by any individual or party," Assad wrote.

"When the state falls into the hands of terrorism and the ability to make a meaningful contribution is lost, any position becomes void of purpose," he said of his fallen regime.

It remains unclear if the post on Telegram was made by Assad himself or if someone else is in control of it.

The message appears to be a response to reports over the weekend that the former president was well aware of his crumbling empire and kept hidden the fact that Russian troops were not coming to his aid.

The night before his departure, Assad allegedly met with about 30 of his military chiefs to report that Moscow was sending troops to support his regime, asking that his generals hold out until then, sources who were in that meeting told Reuters.

Hours later, Assad was in a plane with

his wife and kids bound for Moscow, abandoning his generals, including his own brother, Maher al-Assad, who fled via helicopter to Iraq.

Reports also claimed that before leaving for Moscow, Assad allegedly reached out to the United Arab Emirates for help, with the UAE allegedly refusing out of fear over the potential international backlash.

With Assad gone, the Syrian rebel group is forming a transitional government led by the Hayat Tahrir al-Sham terrorist group.

Group leader and former al Qaeda member Abu Mohammed al-Jolani has disavowed his extremist past and has called for a new era of tolerance in Syria, in what experts say is a means to distance himself from Assad and appeal to the West.

## DR Congo files criminal case against Apple over Illegal mineral exploitation

he Democratic Republic of the Congo (DRC) has initiated criminal proceedings against European subsidiaries of Apple, accusing the tech giant of incorporating illegally mined "blood minerals" into its global supply chain.

The complaints, filed in Paris and Brussels, allege that Apple procured minerals sourced from conflict-stricken eastern DRC and Rwanda, where materials are reportedly mined illicitly and subsequently integrated into tech devices.

The filings further claim Apple's French and Belgian units misled consumers regarding the integrity of its supply chains.

Lawyers representing the DRC stated the case encompasses war crimes, money laundering, forgery, and consumer deception.

Paris-based lawyer, William Bourdon described the legal action as "a first step towards holding one of the largest global tech players accountable for profiting at the expense of grave crimes tainting African mineral supply chains."

Robert Amsterdam, the DRC's Washington-based lawyer, described the lawsuit as a "first salvo" in broader legal efforts. "Apple cannot continue to hide behind its narrative of supply chain transparency. It is time for accountability," he said.

Apple has denied the allegations, asserting it has "no reasonable basis for concluding" that its products contain minerals illegally sourced from conflict zones.

The company maintains its supply chain is rigorously verified to exclude minerals linked to violence and exploitation.



The DRC's mineral-rich east has been plagued by militia violence for decades, exacerbated by illicit mining activities that fuel armed conflicts and severe human rights abuses, including child labor and environmental devastation.

The legal team cited findings from the United Nations, the U.S. State Department, and NGOs such as Global Witness to substantiate claims of widespread harm.

The lawyers have also written to European Commission President Ursula von der Leyen, urging the EU to engage in dialogue to strengthen accountability and halt armed violence linked to mineral supply chains.

What to know

The tensions are rooted in decades of conflict in the DRC's east, exacerbated by the resurgence of M23 rebels—widely believed to be backed by Rwanda—since late 2021.

Congress passed the bipartisan CARES Act in March 2020, at the beginning of the pandemic, which, among other things, paved the way for the federal government to move about 12,000 inmates from federal prisons into home confinement. "Many people who were sent home were convicted of white-collar or nonviolent offenses and were considered safe bets to behave in the community," Love said, adding that she believed the decision-making was tainted by racial discrimination.

And to those upset that Biden let these criminals out of house arrest early, "you should have complained four years ago when they were released from prison," Love said.

# Father, stepmother jailed for daughter's murder life over UK

K court sentenced Urfan Sharif, 43, and Beinash Batool, 30, to life imprisonment for the brutal murder of 10-year-old British Pakistani Sara Sharif, who died after enduring a prolonged campaign of "torture" and "despicable abuse."

The pair will serve minimum terms of 40 and 33 years respectively, as ruled by Judge John Cavanagh at London's Old Bailey.

The court heard harrowing details of Sara's suffering, with her body found covered in bruises, bite marks, burns from an electric iron, and multiple broken bones.

Describing the acts as "extreme cruelty," the judge condemned the lack of remorse shown by Sharif and Batool.

"The pain and trauma Sara endured during this campaign of violence are unimaginable," he said. "This poor child was battered with great force repeatedly." Sara's final moments were marked by unimaginable brutality. The judge recounted how she had been beaten with a metal pole and cricket bat, and bound with parcel tape, rope, and a plastic bag over her head. A post-mortem revealed 71 fresh injuries and at least 25 broken bones.

In August 2023, Sara was found dead in her bed at the family's empty Woking home. On the day of her death, Sharif struck her twice in the stomach with the metal leg of a high chair as she lay unconscious, accusing her of pretending.

The trio fled to Pakistan the day after Sara's death, taking five other children with them. Sharif later called UK police from Pakistan to report Sara's death, leaving behind a note claiming he did not intend to kill her. After a month on the run, they returned to the UK and were arrested upon landing.

The court also sentenced Faisal Malik, 29, Sara's uncle, to 16 years in prison for



causing or allowing her death. The five surviving children remain in Pakistan.

Sara's murder has sparked outrage over the failure of UK social services to protect her. Her father had withdrawn her from school four months before her death, despite prior allegations of abuse.

A teacher testified that Sara had worn a hijab to conceal injuries and refused to explain the marks on her body.

# Russian soldiers killed in friendly fire attack by North Koreans By Elizabeth Jenrola Oso

orth Korean troops accidentally killed eight Russian paramilitary soldiers in a "friendly fire" attack as they tried to take back Kursk from Ukraine, Kyiv officials said.

A Monday skirmish along the frontlines in the Kursk Oblast saw a group of North Korean troops target and fire at the Chechen Akhmat unit, killing eight of their allies, according to Ukraine's military intelligence agency (GUR).

The friendly fire incident allegedly occurred due to the "language barrier" between Moscow and Pyongyang's troops, as the more than 11,000 North Korean soldiers in Russia struggle to adapt to their new environment.

"When using the DPRK troops on the battlefield, the language barrier remains problematic to control and coordinate actions," the GUR said in a statement.

"Because of this problem, North Korean soldiers opened 'friendly fire' on the vehicles of the so-called Akhmat battalion," the agency added. "As a result, they killed eight Kadyrovite soldiers."

The GUR's assessment could not be immediately verified by independent reports.

The incident comes as Ukrainian President Volodymyr Zelensky reported a "significant number" of North Korean casualties in Kursk, where Kyiv has managed to hold onto a vast stretch of land following their surprise incursion over the summer.

At least 30 North Korean soldiers were killed and wounded in the weekend battles, forcing Moscow to deploy additional Pyongyang's fighters in Kursk, according to the GUR.

The Defense Intelligence of Ukraine (DIU) detailed how Democratic People's



Republic of Korea (DPRK) soldiers have recently assisted Russian troops in the Kursk Oblast, which is currently occupied by Ukrainian forces.

"The North Korean troops suffer sanitary and irreversible losses as a result of a successful fire attack by the Ukrainian Security and Defense Forces," the GUR said of the battles.

# South Africa still 'divided' years after independence — Ramaphosa

espite achievements made by South Africa in the past 30 years, it continues to face significant challenges on its journey toward reconciliation, President Cyril Ramaphosa said on Monday.

"Our country is still divided by poverty and unemployment," Ramaphosa said at an event marking National Reconciliation Day.

The day is celebrated to foster reconciliation and national unity following the end of apartheid in 1994.

"Reconciliation is not a symbolic act," Ramaphosa said, adding it requires a fundamental transformation of society to create a fair and just nation.

#### 'DEEPSCARS'

"The past may be behind us but we are left with its wounds. We have deep scars as a reminder of our painful experiences," he added.

He said his government is taking action to build an inclusive economy and create jobs, and also investing in social and economic infrastructure.

"As part of the work to reduce poverty, we continue to support poor households through free basic services, fee-free schools, subsidised housing opportunities and financial aid to tertiary students from poor and working-class families," he said. Ramaphosa announced that the country will hold a national dialogue next year to enable a conversation among citizens on shaping the country's future developmental path.

### PRESS CHALLENGES

He said the national dialogue will seek to build on the achievements of 30 years of democracy and address the challenges the country has been facing for the past 15 years which include, low growth, unemployment, poverty and hunger, poor governance, slow land reform and corruption among others.

"We will also want the national dialogue to address pressing challenges such as gender-based violence and femicide, social fragmentation, racism, and sexism,



violence and instability," Ramaphosa said. In March 2023, the school reported visible injuries on Sara's face to social services, but no action was taken. A month later, Sharif informed the school she would be homeschooled.

# Bomb kills head of Russia's nuclear defence forces, assistant in Moscow By Dave Oludare Oso

n explosive device planted close to a residential apartment block in Moscow killed the head of Russia's Nuclear, Biological, and Chemical Defence Forces, Lt. General Igor Kirillov, early Tuesday, Russia's Investigative Committee said.

Kirillov's assistant also died in the blast, triggered by the device which was placed in a scooter, officials said.

The bomb was triggered remotely, Russian state news agency Tass reported, citing unnamed sources in the emergency services.

Russian investigators have opened a case into the two deaths, according to the committee's spokesperson Svetlana Petrenko.

"Investigators, forensic experts and operational services are working at the scene," she said in a statement.

"Investigative and search activities are being carried out to establish all the circumstances around this crime."

Ukraine's Security Services on Dec. 16 charged Kirillov with the use of banned chemical weapons during Russia's military operation in Ukraine that started in Feb. 2022.

Ukraine's Security Service, the SBU, said that they had recorded more than 4,800 uses of chemical weapons on the battlefield since February 2022, particularly K-1 combat grenades.

Kirillov, who was named the head of Russia's nuclear defense forces in April 2017, was under sanctions from several countries including the UK and Canada for his role in Ukraine.

## Ukraine claims it killed senior Russian general in Moscow scooter blast

Russian Lieutenant General Igor Kirillov was killed this morning after a device hidden in a scooter was detonated, according to the Russian TASS news agency, citing Moscow's investigative committee.

The e-scooter, which Data and Forensics team has geolocated to the scene outside a residential building in Moscow, is from KugooKirin.

The brand was founded in China but has multiple overseas warehouses across Europe including in Russia. Russia is also one of its main exporting countries, according to the company's website.

UKRAINE CLAIMS IT KILLED KIRILLOV – REPORTS

Ukraine's security services (SBU) were responsible for the killing of Igor Kirillov, a source at the agency has told Reuters.

The source said Kyiv regarded Kirillov as a war criminal and an "absolutely legitimate target". The source accused him of ordering the use of banned chemical weapons against Ukrainian forces in the war.

Yesterday, the SBU charged Igor Kirillov in absentia for the use of banned chemical weapons during Russia's invasion of the country.

Igor Kirillov had been the head of Russia's nuclear, biological and chemical defence forces since 2017.

Here's a look at what else we know about him:

The 54-year-old was born on 13 July 1970 in Kostroma, a riverside city in western Russia. He went on to attend Kostroma Higher Military Command School of Chemical Defence, graduating in 2007.

During his time there, between 1991 and 1995, he served as a platoon commander in the Western Group of Forces in Germany and the Moscow Military District.

After graduating, he occupied various posts in Russia's nuclear, biological and chemical defence forces, eventually becoming the chief there in 2017.

Throughout his military career, he was known for helping to develop the TOS-2 Tosochka heavy flamethrower system.

He has been accused of using banned chemical weapons during the war in Ukraine as well as the toxic choking agent chloropicrin.

The UK government had sanctioned him for "helping deploy these barbaric weapons" and for being a "significant mouthpiece for Kremlin disinformation".

The death of Igor Kirillov in Moscow will result in a "major retaliation" from Russia, says the former Tory MP and security analyst Tobias Ellwood.

# China says spying claims involving UK's Prince Andrew 'preposterous' By Agency Reporter

hina said Tuesday that claims that a businessman had used his links with Britain's Prince Andrew to spy for Beijing were "preposterous", after the UK government voiced mounting concerns over the allegations.

Details emerged last week about Andrew's relationship with Yang Tengbo, a businessman and alleged spy, who had been banned from Britain.

Asked about the case while on a visit to Norway, Prime Minister Keir Starmer said Britain was "concerned about the challenge that China poses" but defended his approach of "engagement" with Beijing.

A spokesman for Beijing's foreign ministry said on Tuesday that the "accusations of so-called Chinese espionage are preposterous".

"The development of China-UK relations is in the common interests of both countries and is also conducive to promoting world economic growth and responding to global challenges," Lin Jian said.

"It is hoped that the United Kingdom will work with China to accumulate more positive factors and demonstrate the two countries' innate character of cooperation, mutual benefits and common wins," he added.

Yang, who was reportedly once invited to Andrew's birthday party, said in a statement on Monday that he had "done nothing wrong or unlawful", and had "fallen victim" to a changing "political climate".

Starmer said at a news conference in Bergen, Norway, that Britain's approach towards China involved "cooperating where we need to cooperate, particularly, for example, on issues like climate change, to challenge where we must and where we should."

Along with the dead and injured, at least three North Korean troops have gone missing around the village of Kurilovka, Ukraine officials added.

## How Lookman went from 'failure' to Africa's best

**6** To the youth of Africa I say: Never give up. Turn pain to power."

Ademola Lookman's journey to being voted the men's African footballer of the year has been full of ups and downs, yet the Nigeria international knows his recent success provides inspiration.

After failing to impose himself following a big-money move to the Premier League as a teenager, the forward had several loan spells before his rebirth in Italy since joining Atalanta in August 2022.

"Four years ago my career felt down but now I'm here as the best player in Africa," Lookman, 27, said on stage when collecting his award in Marrakesh on Monday.

"Don't let your failures stop your dreams."

Wearing a traditional Nigerian robe, he even had a special message in Yoruba for fans back in West Africa.

BBC Sport Africa examines Lookman's unconventional route to becoming the sixth Nigerian man to be named the continent's top player, joining stellar names Rashidi Yekini, Victor Ikpeba, Emmanuel Amuneke, Nwankwo Kanu and Victor Osimhen.

Early breakthroughs

Born in south London to Nigerian parents, Lookman's passion for the game was evident at an early age.

"My first memory is rolling up my socks in the house and kicking them around," he told BBC Sport.

He signed for Charlton Athletic, then playing in England's second tier, in 2014 – but rates passing his school exams aged 16 as a bigger achievement.

"My mum has always been big on education, but being Nigerian it is a bit more intense," he explained. "The pressure is definitely different."

Lookman made his senior debut for Charlton in November 2015, scored his



first senior goal on his fifth appearance and eventually caught the eye of top-flight clubs with his performances for a struggling side.

When Everton snapped up a 19-year-old Lookman for a fee of £11m (\$14m) in January 2017, he was hailed by then-Toffees boss Ronald Koeman as "a player for the future".

"We expect a lot from the boy," the Dutchman added. "I think he is one who can reach a high level if he develops well and improves."

Lookman scored on his debut as a late substitute in a 4-0 win over Manchester City but rarely hit those heights again during his time at Goodison Park.

Some of that could be down to churn in the managerial dugout, given he appeared under six different managers (including caretakers) over the course of two and a half years at the club.

New beginnings

Away from Merseyside, Lookman played a major role in England's Under-20 World Cup triumph in June 2017, scoring three times at the tournament in South Korea.

He enjoyed a successful loan spell with RB Leipzig in the first half of 2018 and moved permanently to Germany in July 2019 for a fee of £22.5m (\$28.6m).

"I had an opportunity to stay in England but at the time I was like 'why not?" Lookman said.

"You have got to make decisions as to what you are really looking for. It always comes

down to playing football."

However, his first full season with Leipzig was a disappointment as he made just one Bundesliga start during a campaign disrupted by the coronavirus pandemic.

He spent two seasons back on loan in the Premier League, first with Fulham and then Leicester City.

Brendan Rodgers, who was Foxes coach at the time, said Lookman's dedication showed in training, even if he again struggled to hold down a starting place.

"He would be out with a bag of balls, doing shooting exercises long after other ones had gone in, working on his right foot, left foot," Rodgers said.

"He's so balanced. Everything is geared towards being the best he could.'

A player transformed

Nigeria had been keen on Lookman since his early days at Everton, but it was not until late 2021 that he switched international allegiance.

He experienced deep disappointment on just his second outing when the West Africans were beaten on away goals in a play-off for the 2022 World Cup by fierce rivals Ghana.

Then came Atalanta, and a move to what Lookman describes as the "chilled" city of Bergamo.

"When I first signed I had food in a restaurant. It was a nice summer's night," he said.

### Man Utd renew interest in Osimhen deal

nglish Premier League giants Manchester United have reportedly reignited their pursuit of Super Eagles striker Victor Osimhen as they seek to address their attacking woes.

News360 Nigeria reports that the Nigerian international has emerged as a top target for United's new manager, Ruben Amorim, following the struggles of Marcus Rashford and Joshua Zirkzee.

Osimhen, currently on loan at Galatasaray from Napoli, has been in exceptional form in Turkey, scoring 10 goals and providing five assists in just 13 appearances across all competitions.

Amorim's decision to exclude Rashford and Alejandro Garnacho from the squad for Sunday's Manchester derby highlights his determination to reshape United's attacking options.

Despite United's interest, Juventus are reportedly leading the race to sign Osimhen as they look to replace Dusan Vlahovic. The Serie A giants could be Osimhen's preferred destination, given his previous success in Italy.

Osimhen's impressive performances have made him a hot commodity in the transfer market, with several top European clubs



vying for his signature. United's ability to secure the forward may depend on their ability to fend off stiff competition from Juventus.

United face more competition from Premier League rivals Arsenal, with former Gunners midfielder Emmanuel Petit backing his old club to make a January move for the Nigerian.

The striker's situation is further complicated by his €75m release clause, with Napoli director Giovanni Manna recently dismissing speculation about a January

"I already said many times that nobody has talked to us. Victor is owned by Napoli and currently playing for Galatasaray. I think a lot has been said about this; nothing is happening," Manna told DAZN.

Paris Saint-Germain are also monitoring the situation and could move for the Nigerian if Rashford, who has emerged as a target for the French champions, joins them from United.

Chelsea have also entered the race for Osimhen, with sources suggesting the London club could be a more attractive destination than United given their current trajectory.

The striker's loan deal with Turkish league leaders Galatasaray includes a January break clause that could facilitate a mid-season move, though his next destination remains uncertain amid interest from several European giants.

This marks the third instance of Nigerian players winning the CAF Player of the Year award back-to-back. Rashidi Yekini became the first Nigerian to win in 1993, followed by Emmanuel Amuneke in 1994. Nwankwo Kanu won in 1996 and was succeeded by Victor Ikpeba in 1997. Kanu went on to win the award again in 1999, making him the only Nigerian to claim the honour twice.

# Mykhailo Mudryk provisionally suspended over adverse drug test By Timi-Zacchaeus Oluwaferanmi

helsea forward Mykhailo Mudryk has been provisionally suspended by the Football Association (FA) following an "adverse finding" in a routine urine test. The Premier League club and the player insist the 23-year-old has never knowingly used banned substances, and an investigation is underway.

The FA's notification of the adverse finding came as a shock to both Chelsea and Mudryk. The Ukrainian international, who has not featured in Chelsea's squad for the past four games, last appeared as an unused substitute against Aston Villa on December 1.

### Chelsea and Mudryk Respond

Chelsea released a statement affirming their support for the FA's anti-doping programme and backing Mudryk as they work to understand the cause of the test result. "Mykhailo has categorically confirmed he has never knowingly used any banned substances," the statement said.



Mudryk also took to social media to express his disbelief, stating, "This has come as a complete shock. I have never knowingly used any banned substances or broken any rules. I am working closely with my team to investigate how this could have happened."

### A High-Profile Signing

Mudryk joined Chelsea in January 2023 from Ukrainian side Shakhtar Donetsk for a significant £88.5m fee. While his tenure

at Stamford Bridge has been marked by flashes of brilliance, this suspension adds an unexpected challenge to his career.

### Investigation Underway

Both the player and the club have committed to cooperating fully with the FA and relevant authorities. While the exact substance in question remains confidential, Chelsea and Mudryk have refrained from further comment, respecting the integrity of the ongoing process.

### Looking Ahead

Mudryk's suspension leaves questions about his immediate future at Chelsea, though the player has expressed hope of returning to the pitch soon. The outcome of the investigation will determine the next steps, as both Mudryk and Chelsea await clarity on the matter.

For now, the footballing world watches closely as the young Ukrainian forward works to clear his name.

Nwankwo Kanu won in 1996 and was succeeded by Victor Ikpeba in 1997. Kanu went on to win the award again in 1999, making him the only Nigerian to claim the honour twice.
