## Tinubu assures on reuniting Mali, Niger, Burkina Faso into ECOWAS

resident Bola Tinubu has assured that the reintegration of Mali, Burkina Faso, and Niger into the Economic Community of West African States (ECOWAS) will be guided by diplomacy and wisdom, prioritising the welfare of their citizens.

This was disclosed by Bayo Onanuga, Tinubu's Special Adviser on Information and Strategy in a statement on Wednesday.

He added that President Tinubu spoke during a state visit by German President Frank-Walter Steinmeier to the Presidential Villa, Abuja.

Tinubu emphasised that ECOWAS remains committed to fostering democracy and safeguarding the interests of innocent civilians in the affected countries.

"The leadership of these countries has been reluctant in presenting transition programmes with clear dates.

"What I can assure is that we will not give tolerance to unconstitutional governments. However, we will explore diplomatic channels to ensure that innocent citizens are not punished for the actions of their leaders," Tinubu said.

As Chairman of ECOWAS, Tinubu reiterated the regional body's commitment to keeping its doors open for dialogue and collaboration.

He stressed that ECOWAS would uphold free movement and trade across the region while encouraging the three nations to embrace democratic norms.

"This is what ECOWAS stands for. Whatever is happening in these countries, we remain mindful of the wellbeing of their citizens. We will not abandon them," the president said.

Meanwhile, President Steinmeier acknowledged the critical role of ECOWAS in promoting stability in West Africa.

He highlighted the economic and security implications of the ongoing crisis in Mali, Niger, and Burkina Faso, urging continued diplomatic efforts to resolve the impasse.

"Reintegration of these countries will have a significant impact on the region's economy and security. We understand why ECOWAS is insisting on diplomacy, and while it is not an easy task, we believe it is necessary to keep the region united," Steinmeier said.

The German president also suggested the need for contingency plans to ensure economic cooperation during the transitional period.

The visit underscored the shared commitment of Nigeria and Germany to regional stability and democratic governance in West Africa.

# National grid down again

igeria's power grid has once again collapsed, making it the 12th time in 2024.

A message by Head of Corporate Communication of Transmission Commission of Nigeria (TCN), Dr Friday Adakole Elijah on Wednesday announced that the national grid, for the umpteenth time, has collapsed.

A grid collapse, which is the breakdown of transmission lines due to over or under-frequency, is said to be responsible for this outage.

Electricity distribution companies announced a system outage around 1:32 p.m. on Wednesday.

The latest development is coming a month after the national grid collapsed in November.

Confirming the development, Jos

Electricity Distribution Company (Jos DisCos) in a statement by its Head, Corporate Communication, Friday Elijah said: "Dear esteemed customers, The current outage being experienced within our franchise states is a result of loss of power supply from the national grid.

"The loss of power supply from the national grid occurred this afternoon at about 13:33 hours of today, 11 Wednesday, December 2024, hence the loss of power supply on all our

"We hope to restore normal power supply to our esteemed customers as soon as the grid supply is restored back to normalcy. Thank you for your patience and understanding as we strive to serve you better."

Eko Electricity Distribution

Company (EKEDC) said: "Dear valued customer, Kindly be informed there was a reported case of system disturbance on 11 December 2024 at 13:32 hrs which has resulted in a loss of power supply across our network.

"We are currently working with our partners as we hope for speedy restoration of the grid. We will keep you updated as soon as power is restored. Kindly bear with us," it said.

The Abuja Electricity Distribution Company (AEDC), in a statement posted on its X handle, said: "Dear valued customer, please be informed that a system disturbance occurred on the national grid at 1:32 p.m. today, causing a power outage across our franchise areas.

"If they (government) want others to contribute, let us know how much that is going to cost and ask people to donate, to bear the cost.

"We will be sending a lot of messages of happiness across the tribes and homes.

"Everybody in Nigeria will be happy because it will positively impact on this period of the year. It is a challenge and he (Tinubu) can do it.

"We need this in this December and January to put smiles on the faces of Nigerians," George, a PDP Board of Trustees (BOT) life member, said.

Advising the President to take further measures to bring relief to the people, he said that the gesture would crash prices of essential commodities and services for the benefit of all.

He said that government's efforts should be concentrated on reducing high inflation rate, unemployment, poverty and youth restlessness in order to create a better future for Nigerians.

Speaking on the recent presidential election in Ghana, George noted that Nigeria's electoral system needed reforms to guard against electoral frauds and manipulations.

## Senate, House of Assembly declare Okpebholo, Idahosa seats vacant

ollowing their elections as Edo State Governor and Deputy, the Senate and the State's House of Assembly, yesterday declared Monday Okpebholo and Dennis Idahosa's seats vacant respectively.

The Senate President, Godswill Akpabio, declared the Edo Central Senatorial seat formerly occupied by Okpebholo vacant following a formal request by the Minority Leader, Abba Moro.

The announcement was made during plenary after Akpabio read Moro's letter, which called for the seat to be declared vacant due to its occupant's inauguration as governor.

Meanwhile, the Speaker of the Edo State House of Assembly Abbas Tajudeen today declared the Idahosa's vacant. In his letter, Moro, representing Benue South Senatorial District, urged the Senate leadership to act per Paragraph D of Section 68 of the Nigerian Constitution, which mandates the declaration of a legislative seat vacant when its occupant assumes an executive role.

The Minority Leader urged the Independent National Electoral Commission (INEC) to promptly organise a by-election for the Edo Central Senatorial District to fill the vacant seat.

"In line with your letter and constitutional provisions, the seat of the Edo Central Senatorial District is hereby declared vacant. INEC is hereby invited to conduct fresh elections to fill the position previously occupied by Senator Monday Okpebholo," Akpabio declared.

Reacting, Okpebholo, in a statement on his X page today, described it as an honour to serve as a Senator and a privilege to work alongside exceptional colleagues in the chamber.

He expressed deep gratitude for the support and camaraderie of his colleagues, the guidance of their leaders, and the trust of the people who made it all possible.

Meanwhile, the Speaker of the Edo State House of Assembly Abbas Tajudeen today declared the seat of Dennis Idahosa vacant.

Idahosa represented Ovia North East/Ovia South West Federal Constituency of Edo State before he was sworn in as deputy governor.

# Court orders halt to distribution of Farotimi's book

he Federal High Court in Abuja has issued an order halting the production and distribution of Nigeria and Its Criminal Justice System, a book authored by embattled human rights lawyer Dele Farotimi.

The book, which has sparked heated debates due to its controversial allegations of judicial manipulation, was recently ranked as a global bestseller in the politics category on Amazon.


The order, sought by prominent legal figure Afe Babalola, demands the cessation of both physical and digital sales and distribution of the book.

Additionally, the court's injunction includes a directive for the seizure of royalties generated from the book's sales.

The application, filed under suit number CV/5372/24 by Kehinde Ogunwumiju, SAN, the Head of Afe Babalola's law firm, was dated December 6, 2024. The court granted an interlocutory injunction, restraining Farotimi and all parties associated with the book from further distribution.

This includes publishers, distributors, sellers, and various bookstores such as Amazon Online Bookstore, Rovingheights Bookstore, Jazzhole Lagos Bookstore, Glendora Bookshop, Quintessence Lagos Bookstore, and Patabah Books Limited.

The injunction reads: "An order of interlocutory injunction restraining



the defendant/respondent, whether acting by himself, his staff, employees, servants, privies, representatives, agents, publishers, distributors, sellers, re-publishers, re-sellers, or any other person however described including Amazon Online Bookstore, Rovingheights Bookstore, Booksellers Bookstore, Jazzhole Lagos Bookstore, Glendora Bookshop, Quintessence Lagos Bookstore and Patabah Books Limited from further publishing, selling, circulating, advertising, or distributing physical/hard/digital/soft copies of the book authored by the defendant/respondent titled: 'Nigeria and Its Criminal Justice System', online."

The book accuses Afe Babalola of manipulating the judiciary to secure favorable rulings for his clients. These allegations have caused a stir, bringing Babalola, a respected legal icon, into the public eye.

The legal move to block the book's distribution comes amidst its global

rise in popularity.

Critics and readers have lauded Farotimi for his bold exposé on Nigeria's criminal justice system, with many considering it a critical work in uncovering the flaws and corruption within the legal and judicial systems of the country.

However, Farotimi's supporters argue that the injunction represents an attack on free speech, with some viewing it as an attempt to suppress accountability within the judiciary.

As the legal battle continues, the issue of freedom of expression and the limits of judicial authority in Nigeria remains a central point of contention.

This case has ignited broader debates about censorship, accountability, and the role of the judiciary in upholding democratic principles and the right to free expression.

## Bills to amend UBEC, ICPC Acts pass 2nd reading in N' Assembly

### House to probe Customs officials

ills seeking amendments to the Universal Basic Education Commission (UBEC) Act and the Corrupt Practices and Other Related Offences Act (ICPC), 2000, have scaled second reading in the National Assembly.

The amendments aim to strengthen basic education and introduce mandatory counselling and training for corruption-related offenders.

The UBEC amendment bill, sponsored by Senator Adamu Usman (Kaduna Central), passed its second reading in the Senate.

Meanwhile, in the House of Representatives, the bill to amend the ICPC passed its second reading.

Similarly, the lawmakers have agreed to investigate the alleged smuggling activities of some Customs officials at the Badagry axis.

The proposed changes, affecting Sections 2, 3, 7, 9, 11, and 16 of the Act, focus on improving early

childhood education, regulating the appointment of commission members, and ensuring adherence to implementation guidelines.

Moreover, the bill proposes an increase in UBEC funding from two to five per centt and mandates the direct allocation of intervention funds to local government education sectors.

The bill has been referred to the Senate Committee on Secondary and Basic Education for further review.

Sponsored by Moshood Kayode (Lagos Island), the bill seeks to amend Section 67 of the Principal Act to include mandatory counselling and training for individuals convicted of corruption-related offences.

Leading the debate during plenary, Kayode explained that the proposed amendment recognises. the link between mental disposition and the tendency for wealth accumulation through corrupt practices.

The bill mandates that magistrates and

judges, in addition to imposing prison sentences or fines, must include anticorruption counselling and training in the sentencing of convicts.

The House's decision followed a motion of urgent public importance raised by Hon. Oluwaseun Whingan, representing Badagry Federal Constituency in Lagos State.

Whingan highlighted an incident earlier this month where a journalist in Badagry was allegedly assaulted while attempting to record activities at a location he described as a 'smuggling zone.'

The lawmaker expressed concerns over the conduct of Customs officers and called for an investigation into the legal framework and operational activities of the NCS.

The motion has been referred to the Committee on Customs and Excise for further legislative action.



# Benue to build 534km of rural roads to boost agriculture

he Rural Access and Mobility Project, a World Bank-funded initiative, is set to construct 534 kilometers of rural roads across Benue State to enhance the transportation of agricultural produce.

Mr. Stephen Numbeve, the State Project Coordinator, provided these details in an interview with the News Agency of Nigeria (NAN) on Wednesday in Makurdi.

Numbeve explained that the project would prioritize the construction of roads that connect farms to markets. thereby making it easier for farmers to transport their produce.

He also revealed plans to build warehouses across the state for the secure storage of both fresh and dry agricultural products.

He further clarified that the roads would span all local governments in the state, with no specific sequence for construction.

These roads are categorized as trunk C or D roads, which are designed to provide direct access for farmers to markets. unlike trunk A or B roads,



which are federal and state highways, respectively.

The project has made significant progress, including the completion of engineering road designs, surveys, and geophysical studies. However, Numbeve acknowledged a slight delay due to the nonpayment of counterpart funding by the previous administration.

While other states had already made their payments, Benue's new administration has since addressed the issue, allowing progress to resume.

Numbere also mentioned the challenges of accessing funds from both the World Bank and the European Investment Bank, noting that such international funding requires meeting certain statutory prerequisites, including the payment of counterpart funds.

Once the funds are available. the focus will be on building the roads and markets to support agricultural growth in the region.

Additionally, Numbeve shared that there were initial issues with office accommodation when he assumed office, as the previous setup did not meet the standards required by the International Technological Association, necessitating a dedicated office space to avoid political interference.



# Opposition parties blast INEC chair over praise for Ghana's election

he Peoples Democratic Party (PDP) and the Labour Party (LP) have sharply criticised the Chairman of the Independent National Electoral Commission (INEC), Prof. Mahmood Yakubu, following his recent comments on the conduct of Ghana's presidential election.

Yakubu had praised the peaceful and transparent nature of the Ghanaian election, advising Nigerian politicians to learn from it.

In the Ghanaian election, former President John Mahama, the opposition candidate, defeated the ruling party's candidate, Vice President Mahamudu Bawumia. Yakubu, in a video message, commended Ghana's electoral process, emphasising its smooth and rancor-free nature, and suggested that Nigeria could draw valuable lessons from it.

However, opposition parties in Nigeria, particularly the LP and PDP, were quick to criticise Yakubu's remarks, accusing him of poor handling of the 2023 presidential election in Nigeria.

In particular, the LP, whose candidate Peter Obi came third in the race, alleged that Yakubu had manipulated the election in favor of President Bola Tinubu of the All Progressives Congress (APC).

They called on Yakubu to apologise to Nigerians for his role in what they claimed was a flawed electoral process.

The LP, through its National Publicity Secretary, Obiora Ifoh, reacted by condemning Yakubu's praise of the Ghanaian election. Ifoh stated that although the LP had moved on from the events of the 2023 election, it was "shameful" for Yakubu to be offering advice on electoral conduct when, in



their view, he was responsible for the electoral issues that Nigeria was still grappling with.

"It is a shame that the INEC Chairman should be talking when, in this case, he should be the one to learn from Ghana. He was the architect of exactly what Nigerians are suffering today," Ifoh said, adding that Yakubu owed Nigerians an apology.

The Labour Party spokesman also pointed out the absence of electoral violence, ballot box snatching, and technical glitches in Ghana's election, contrasting it with what they described as a chaotic and flawed process in Nigeria in 2023.

He noted that in Ghana, the people's votes were counted fairly, and the process reflected the true will of the electorate.

The PDP also weighed in, with its Deputy National Youth Leader, Timothy Osadolor, calling Yakubu's praise of Ghana's election an "aberration."

Osadolor emphasised that Yakubu had mishandled the 2023 elections and owed Nigerians not only an apology but also a resignation. He suggested that Yakubu's actions in Nigeria's elections made him unfit to comment

on or praise other countries' processes.

"If I were to be him, I would apologize to Nigerians and resign. Let him borrow a leaf from people of integrity. And when the issues of credibility are being discussed, he should keep quiet and listen," Osadolor said.

He also questioned whether Yakubu could, in good conscience, support the way the 2023 presidential elections were handled, particularly in states like Edo and Ondo.

The criticisms come in the wake of ongoing disputes over the legitimacy of the 2023 presidential elections, where both Obi and PDP candidate Atiku Abubakar contested the outcome in court, though they were unsuccessful.

Despite the court ruling, opposition parties continue to insist that the election was marred by irregularities.

In their statements, both the PDP and the LP implied that Yakubu should refrain from making public remarks about electoral processes in other countries while Nigerians continue to question the integrity of their own elections.

# US offers \$10M reward for Chinese hacker's arrest

he United States has announced a \$10 million reward for information leading to the arrest of Guan Tianfeng, a 30-year-old Chinese national accused of orchestrating global cyberattacks. The U.S. Department of State revealed on Tuesday that Guan believed to be residing in China's Sichuan Province, is wanted for hacking computer firewalls and compromising critical systems worldwide.

An indictment unsealed the same day charges Guan with conspiracy to commit computer fraud and wire fraud. His alleged activities have also drawn sanctions from the U.S. Treasury Department against his employer, Sichuan Silence Information Technology Co. Limited.

According to the indictment, Guan and his co-conspirators exploited a vulnerability in firewalls manufactured by Sophos Limited, a UK-based cybersecurity firm. These firewalls are widely used by businesses and institutions to protect their networks. Deputy Attorney-General Lisa Monaco highlighted the scope of the attacks, stating, "The defendant and his co-conspirators exploited a vulnerability in tens of thousands of network security devices, infecting them with malware designed to steal information from victims around the world."

In April 2020, the hackers launched a massive coordinated attack on approximately 81,000 firewall devices worldwide. Their goal was to steal sensitive data, including usernames and passwords, while simultaneously attempting to install ransomware on the compromised systems.

The indictment revealed that more than 23,000 of the targeted firewalls













were located in the United States. Among these, 36 belonged to companies classified as critical infrastructure, underscoring the potential threat to national security. The U.S. Treasury Department emphasized that the attackers exploited a zero-day vulnerability, a previously unknown software flaw, to breach the systems.

Herbert Stapleton, an FBI cybersecurity expert, acknowledged Sophos' swift response in mitigating the damage. "If Sophos had not rapidly identified the vulnerability and deployed a comprehensive response, the damage could have been far more severe," he said.

The indictment further alleges that Sichuan Silence Information Technology Co. Limited, where Guan worked, monetized the stolen data by selling it to Chinese businesses and government entities, including the Ministry of Public Security. The company also allegedly offered hacking services to clients.

The U.S. government has since imposed sanctions on Sichuan Silence, restricting its ability to engage in international business and financial transactions.

The case of Guan Tianfeng underscores growing concerns about state-sponsored cybercrime and the role of private companies in facilitating such activities. By offering a significant financial reward, the United States aims to pressure Guan and his associates while sending a clear message about its commitment to combating global cyber threats.

The reward is part of the State Department's Rewards for Justice Program, which has been instrumental in tracking down international criminals. This case is expected to serve as a warning to other entities engaged in similar activities, with the United States signalling its determination to protect its digital infrastructure and hold perpetrators accountable.

# Tears, hope as Syrians return home from Turkey

la Jabeer cried as he prepared to cross from Turkey into Syria with his 10-year-old daughter on Tuesday, thirteen years after the war forced him to flee his home.

He returns without his wife and three of his children who died in devastating earthquakes that struck Turkey and Syria last year.

Father and daughter left days after Syrian rebels ousted Bashar al-Assad from Damascus, and a day after President Tayyip Erdogan said Turkey was opening its Yayladagi border gate to manage the return of some of the more than three million Syrian migrants it hosts.

"Just as I cried for the children I lost in the earthquake, I am crying today because I am leaving Hatay and Turkey behind," said Jabeer, a former shipworker who arrived in Turkey's Hatay province in 2011.

Dual earthquakes in early 2023 killed more than 50,000 people in southern Turkey, with the city of Antakya where Jabeer and his family lived among the hardest hit. The region is still recovering from the widespread destruction.

Over the weekend, rebels seized Damascus and Assad fled to Russia following 13 years of civil war. Turkey has said it gave no support and had no involvement in the offensive by the Syrian opposition forces it has backed for years against Assad.

Yet Syrians in Turkey have been excited by the prospect of returning



home since the rebellion.

Jabeer was hopeful for the future as he completed paperwork for him and his daughter Sirin at a mobile service unit at the border in Yayladagi, which was quiet despite Erdogan's move to reopen it to ease pressure on another crossing in the area.

"God willing, things will be better than under Assad's government. We've already seen that his oppression is over. We are going back because now we think that the ones who took over are already doing things to end oppression," he said.

"The most important reason for me to return is that my mother lives in Latakia. She can take care of my daughter, so I can work," Jabeer said, adding that he was grateful to Turkey for taking care of them with health services, shelter and jobs.

On Monday, Erdogan highlighted the goal of "voluntary, safe, dignified, and regular returns" as Syria stabilizes.

The Yayladagi crossing close to the northwest edge of Syria had been closed since 2013 due to nearby fighting.

NATO member Turkey controls swathes of land in northern Syria after several cross-border incursions against the Syrian Kurdish YPG militia, which Ankara sees as a terrorist group tied to PKK militants who have fought the Turkish state for 40 years.

Turkey said on Sunday that it wanted the new Syrian administration to be inclusive and for Syrians to determine their own future.

## Chelsea face travel challenge ahead of Conference League match and Premier League fixture

helsea manager Enzo Maresca has expressed concerns about the demanding schedule his team faces, with a grueling 16-hour round trip to Kazakhstan followed by a Premier League match just days later.

The Blues will travel to Almaty for their UEFA Conference League clash with Astana on Thursday. Due to ongoing stadium renovations in Kazakhstan's capital, the team must make the 3,700-mile journey, which includes an eight-hour flight each way. The flight route has been altered to avoid conflict zones in Ukraine, Russia, and Syria, adding to the travel time.

Once they arrive in Almaty, temperatures are expected to plummet to -11°C, posing further challenges for the squad. Despite the extreme cold, Chelsea's players have been advised to prepare for the match by bringing extra layers and remaining mentally focused. Defender Axel Disasi summed up the situation, saying, "We just have to put on two pairs of gloves and be ready to compete."

Chelsea will return to London early Friday morning, leaving just over 48 hours to prepare for their Premier League match against Brentford on Sunday evening at 19:00 GMT. This compressed turnaround has led Maresca to rest several key players for the Conference League match,



including England winger Noni Madueke, while Portugal's Pedro Neto will be absent due to suspension.

In addition to first-team absences, a handful of youth players will be included in the travelling squad. Ato Ampah, Shumaira Mheuka, and Kaiden Wilson are among the leaders Liverpool. promising talents set to travel, while 18-year-old Josh Acheampong is expected to make young defender is also close to signing a new contract with the club.

Maresca acknowledged the immense toll this travel would take on his squad, admitting, "Eight they are going to make the effort." hours [one way] is not a normal time [to travel] for a game, but we have to go there, we have to play and we want to try to do our best, thinking also about the next game."

Despite the challenges, Chelsea remain in a strong position. With a perfect record of four wins from four in the Conference League, they have already secured at least a place in the play-off stage. In the Premier League, they are currently second, just four points behind



### FA expected to back Saudi Arabia's 2034 World Cup Bid

he Football Association (FA) is set to support Saudi Arabia's bid to host the 2034 FIFA World Cup, alongside backing the multi-nation hosting of the 2030 tournament. The FA's stance is expected to be confirmed during Wednesday's online FIFA Congress, where both bids will likely be ratified.

Saudi Arabia is the sole contender for the 2034 World Cup, while the 2030 edition is poised to be awarded to unopposed co-hosts Spain, Morocco, and Portugal, with early matches in Uruguay, Argentina, and Paraguay.

Although Saudi Arabia's hosting appears certain, the FA's endorsement has sparked controversy due to the kingdom's human rights record. Critics have raised concerns about discriminatory laws, with some accusing the FA of hypocrisy for potentially endorsing the bid while advocating for inclusivity in football.



Rather than a traditional vote, FIFA plans to confirm the hosts via acclamation, where federations show support by applauding. Delegates must vote on both bids simultaneously, with no separate decision for each tournament.

Germany's DFB announced its support last Friday, emphasizing its

intention to engage in dialogue to address human rights concerns. Norway's football federation, however, plans to abstain, arguing the process undermines FIFA's governance reforms. The FA is expected to issue a statement following the Congress, explaining its position and commitment to addressing related issues.

# Cyclist Rohan Dennis pleads guilty in wife Melissa Hoskins' death

romer world champion cyclist Rohan Dennis has pleaded guilty in connection with the death of his wife, fellow Olympian Melissa Hoskins.

Hoskins, 31, was struck by a vehicle driven by Dennis outside their Adelaide home on 30 December 2023, and later died in hospital.

Dennis, who was initially charged with dangerous driving causing death and driving without due care, admitted to a lesser charge of aggravated dangerous driving, creating the likelihood of harm.



His plea means he acknowledged driving a vehicle in close proximity to Hoskins, knowing it was likely to cause harm or showing reckless disregard for her safety.

Dennis's lawyer clarified that the charge did not imply he intended to harm Hoskins or was responsible for her death.

Hoskins, a world champion in team pursuit in 2015 and two-time Olympian, tragically passed away, leading to tributes from around the world.

Dennis, a decorated cyclist, retired in 2023 after an illustrious career. The couple married in 2018 and had two children together. Dennis will be sentenced at a later date.



# Uefa unconcerned about Euro 2025 clash with Club World Cup

Tefa has played down concerns over potential scheduling conflicts between the 2025 Women's European Championship and the expanded FIFA Men's Club World Cup. The men's tournament, taking place from 15 June to 13 July 2025 in the United States, will feature 32 teams, including Chelsea and Manchester City. Meanwhile, Euro 2025 is set to run from 2 to 27 July in Switzerland, meaning that some matches could overlap.

Despite this, Uefa managing director Nadine Kessler is not concerned, stating, "We're talking about two tournaments, in two different countries, with two different timezones." Kessler emphasized that Uefa's broadcasting agreements



differ from FIFA's, and while exclusivity for women's football tournaments is ideal, it is increasingly challenging to secure.

FIFA, which rejected claims from Fifpro and the World Leagues Association about lack of consultation, defended the clash, stating the 2025-2030 match calendar was approved by its Council in 2023 as a balanced solution.
