Tinubu to present N47.9trn 2025 budget to National Assembly Dec 17

resident Bola Tinubu is set to present the N47.9 trillion 2025 budget to the national assembly on December 17.

Senate President Godswill Akpabio announced the development at a plenary on Thursday.

"The president has made his intention known to the National Assembly to present the 2025 budget to the joint session of the National Assembly on the 17th of December, 2024," Akpabio said.

On November 14, the federal government proposed N47.9 trillion as the total expenditure in the 2025 budget.

Tinubu later submitted the medium-term expenditure framework and fiscal strategy paper (MTEF/FSP) for 2025–2027 to both the senate and the house of



representatives on November 19.

The MTEF/FSP are parameters any budget of the country is premised on and also serve as a projection of a three-year spending plan of the federal government.

On December 3, the senate approved the MTEF/FSP ahead of the consideration of the 2025 budget proposal.

In the MTEF/FSP, the key parameters include a \$75 oil price benchmark per barrel, daily oil production of 2.06 million barrels per day (bpd), an exchange rate of N1,400 to \$1, and a targeted gross domestic product (GDP) growth rate of 6.4 percent.

The expenditure framework also has a new borrowing plan of N9.22 trillion, constituting domestic and foreign borrowings.

ECOWAS finalises \$75m renewable energy facility to boost clean energy in West Africa By Ghenga Oluranti OLALEYE

he Economic Community of West African States (ECOWAS) has finalised the framework for a \$75 million Renewable Energy and Energy Efficiency Facility, aimed at driving clean energy solutions across the region.

Dr. Omar Touray, President of ECOWAS, made the announcement on Thursday during the 93rd Ordinary Session of the ECOWAS Council of Ministers in Abuja.

He explained that the facility will provide grants, loans, and guarantees through competitive calls for proposals, focusing on advancing renewable energy initiatives throughout West Africa.

"The Framework Document for the Establishment of an ECOWAS Renewable Energy and Energy Efficiency Facility has been finalised by the Ministers," Touray stated.

"This is a new blended finance facility with an initial amount of USD 75 million, whose objective is to provide grants, loans, and guarantees through regular demand-driven competitive calls for proposals, offering clean energy solutions for the ECOWAS region."

The initiative marks a significant step towards ECOWAS's broader goals of promoting sustainable energy solutions and tackling climate change. The facility is expected to play a key role in enhancing the region's energy security while reducing dependence on nonrenewable sources.

In addition to the renewable energy facility, Touray highlighted progress in other important regional projects. One such initiative is the "Rice Offensive," a project launched by



ECOWAS in 2014 aimed at achieving self-sufficiency in rice production by 2035. The project's second cycle, which runs from 2025 to 2035, seeks to produce 33 million tonnes of milled rice to meet the region's consumption needs. To achieve this, an estimated \$15-\$19 billion in investments is required to improve storage facilities, milling operations, and mechanisation of paddy production.

Touray also drew attention to the strategic importance of the Nigeria-Morocco Gas Pipeline, a major infrastructure project designed to enhance regional energy integration. The 6,800-kilometre pipeline, including 5,100 kilometres offshore, will transport 30 billion cubic feet of natural gas annually, connecting Nigeria to Morocco and extending the supply to ECOWAS member states, Mauritania, and Europe.

"This regional integrative project aims to build a gas pipeline linking Nigeria to Morocco, feeding ECOWAS member states and Mauritania, with future extensions to Europe," Touray explained.

Furthermore, ECOWAS is making strides in regional integration projects, including the phased implementation of affordable roaming tariffs, now operational in six member states, and plans to harmonise aviation charges to reduce passenger and security fees by 25%.

Touray also highlighted efforts to improve the management of shared water resources and develop infrastructure in the water sector, all aimed at reducing poverty and safeguarding the environment.

Despite these advancements, challenges remain. Touray noted that by October 2024, only 40 percent of the Community Levy for the year had been received, which has hindered the implementation of ECOWAS programmes. He urged member states to fulfil their financial commitments to support regional development.

Security concerns, particularly terrorism, violent extremism, and organised crime, continue to be a significant focus for ECOWAS. Touray expressed hope that countries such as Mali, Burkina Faso, and Niger, which have recently withdrawn from the organisation, would reconsider their decisions and rejoin the collective efforts to address regional security challenges.

he Minister of Solid Minerals Development, Dele Alake, has hailed African Natural Resources and Mines Limited (ANRML) as a key partner in the Nigerian government's efforts to enhance local value addition within the mining sector.

He pledged the support of the Federal Government for investments that would generate employment for the country's youth.

NAFDAC probes suspected fake Amoxycillin capsules

he National Agency for Food and Drug Administration and Control (NAFDAC) it has commenced an investigation into reports of suspected substandard Deekins Amoxycillin 500mg Capsules, Lot Number 4C639001.

Mojisola Adeyeye, NAFDAC Director-General/CEO in a statement on Thursday, said the product, manufactured by Ecomed Pharma Ltd and marketed by Devine Kings Pharmaceutical Ltd, has been linked to serious adverse drug reactions nationwide.

The agency added that preliminary findings have raised questions about the authenticity of the batch in question.

More so, NAFDAC said that Ecomed Pharma Ltd claims it produced only 20 packets of Lot 4C639001 for registration renewal purposes and 1,961 packets of a different batch, Lot 4C639002.

However, NAFDAC noted that 7 9 0 p a c k s o f L o t 4 C 6 3 9 0 0 1 — b e a r i n g a manufacturing date of March 2024 and expiry date of February 2027—have reportedly been recalled.

According to NAFDAC, the manufacturer denies producing the recalled packs, suggesting



possible falsification.

"Key suspects, including Pharm. Ekene Christopher of Ecomed Pharma Ltd and Kingsley Ekeanyanwu of Devine Kings Pharmaceutical Ltd, are currently under investigation.

Samples of the product have been collected for laboratory analysis, with further inquiries being conducted in collaboration with the Pharmacy Council of Nigeria", NAFDAC added.

In response to the potential health risk, NAFDAC advised the public to immediately cease the use, sale, or distribution of Deekins Amoxycillin 500mg Capsules from the affected lot.

The agency further called on healthcare providers, distributors, and patients to source medicines only from authorised suppliers and to inspect products for authenticity and integrity.

"Reports of adverse reactions or suspicious activities related to the product can be submitted to NAFDAC via 0800-162-3322, sf.alert@nafdac.gov.ng, or the Med Safety mobile application."

Reiterating its commitment to public safety, NAFDAC assured the public of its resolve to eliminate substandard and falsified medicines from the supply chain.

"We will continue to work with stakeholders to uphold regulatory standards and ensure the safety of medicines in Nigeria," said NAFDAC.

The agency added that further updates on the investigation will be provided once they are available.



Similarly, on December 6, Adejobi stated that police operatives in Anambra State apprehended a suspected armed robber, Miracle Mwakaloi, in Awka.

He noted that the suspect later led officers to his residence, where three AK-47 rifles were recovered.

Adejobi emphasised police

dedication to creating a safe environment throughout and beyond the festive season.

"Ongoing measures include increased patrols, community engagement, and focused efforts on public safety. Citizens are urged to cooperate with law enforcement officials, who will maintain professionalism and respect for human rights", he said.

According to him, the IGP also encouraged Nigerians to remain vigilant and report any suspicious activities to the police or other security agencies.

Adejobi reiterated the police's commitment to ensuring a crime-free yuletide celebration.

Lagos Court Hands Down 10-Year Sentence for Sexual Assault of Minor

n a significant ruling, a Lagos State Sexual Offences and Domestic Violence Court in Ikeja has convicted and sentenced Bamidele Folorunsho to 10 years imprisonment for the indecent treatment and sexual assault of a minor. The court's verdict marks a major milestone in the ongoing efforts to combat sexual and domestic violence in Nigeria.

Folorunsho's journey to conviction began in February 2018, when he was initially charged with the defilement of a 12-year-old girl. However, it wasn't until October 2021 that he was arraigned and pleaded not guilty to the charge. In a surprising turn of events, Folorunsho opted for a plea bargain, leading to his rearraignment on amended charges.

During the re-arraignment, Folorunsho pleaded guilty to two amended counts of indecent treatment and sexual assault. The charges specifically stated that he rubbed the victim's anus and fondled her breasts with his hands. The prosecution, led by O. Aluko, informed the court that both parties had entered a



plea and sentence agreement dated December 12, 2024.

Justice Rahman Oshodi, who presided over the case, carefully considered the plea bargain agreement and Folorunsho's show of remorse before delivering the verdict. In his ruling, Justice Oshodi stated, "I have found you guilty based on your plea in the amended information dated December 11, 2024. I have carefully considered the plea bargain agreement and your show of remorse."

The sentence, which will commence from March 22, 2018, also includes the registration of Folorunsho's name as a sex offender. This move is seen as a significant step towards ensuring public safety and preventing future instances of sexual violence.

The offences committed by Folorunsho contravened Sections 135 and 263 of the Criminal Law of Lagos State 2015. The Lagos State Government has been vocal about its commitment to combating domestic and sexual violence, establishing the Domestic and Sexual Violence Agency in September 2021.

This verdict serves as a testament to the government's efforts to bring perpetrators to justice and protect vulnerable members of society. As the fight against sexual and domestic violence continues, this ruling sends a strong message that such crimes will not be tolerated in Lagos State.

Two feared dead, 20 others injured in Borno varsity auto crash

wo students of the Borno State University, Maiduguri, were yesterday feared dead as the school's Staff bus and a truck collided on Njimtilo Road in the state capital.

Also,no fewer than 20 other students were seriously injured in the accident. According to the Borno State Police Command, a truck collided with the university's bus, causing significant damage and loss of lives.

The Borno State Police Command spokesperson, Nahum Kenneth, confirmed the accident, stating that a male and female students lost their lives, while three others were currently unconscious and receiving medical care at the Umaru Shehu Specialist Hospital.



He further disclosed that the bus was conveying 30 students at the time of the accident.

However, 20 of the injured student were still receiving treatment, while the other 10 were unburt.

. Meanwhile, the university's community is still in shock and mourning, with students, faculty and

staff expressing their condolences to the families of the deceased.

The school's management has also promised to provide necessary support and assistance to the affected families.

The cause of the accident is still under investigation, but eyewitness reports said, that the truck's driver lost control before colliding with the bus. The police are working hard to determine the circumstances surrounding the accident.

Moreover, the State Police Command has urged motorists to exercise caution and adhere to traffic rules to prevent accidents. The command also appealed to the public to provide any information that may aid in their investigation.

Ekiti airport gets NCAA's approval to begin operations this month

he Ekiti Agro-Allied International Cargo Airport (EAICA) in Ado-Ekiti to received the Nigeria Civil Aviation Authority's (NCAA) approval to begin non-scheduled flight operations on December 15, 2024.

In a letter dated December 11, 2024, addressed to the Ekiti State Governor, Biodun Oyebanji, the NCAA granted the airport permission to operate under Visual Flight Rules (VFR) for six months, from December 15, 2024, to June 15, 2025.

The approval, signed by the Acting Director General of Civil Aviation, Capt. Chris Najomo was in response to the state government's application for a flight operational permit.

The NCAA noted that the six-month approval would allow the state government to address pending



corrective action items identified during its last inspection. It also provides a window for validating the implementation of its findings.

To ensure compliance, the airport's non-scheduled operations will be coordinated with relevant agencies for essential services, including Air Traffic Services, Aerodrome Rescue and Fire Fighting Services, Aviation Security, and Meteorological services.

Ekiti State had earlier signed Memorandums of Understanding (MoUs) and Service Level Agreements with these federal aviation bodies in preparation for the airport's operations.

Governor Oyebanji described the approval as a significant milestone and a testament to the state's investment in the airport project.

He emphasised that the project aims to enhance Ekiti State's socio-economic development by improving accessibility and attracting investment.

"This approval is a welcome development and a clear justification of our commitment to boosting Ekiti's economy. The airport will enhance trade, tourism, and overall development in our state," the governor said.

Nigeria seeks deeper collaboration with France to boost space technology, says **NIGCOMSAT MD**

igeria's Communications Satellite Limited (NIGCOMSAT), the country's satellite operator, is seeking enhanced collaboration with France to advance its space technology capabilities, Managing Director Jane Egerton-Idehen announced on Thursday, December 12.

In a statement posted on Facebook, Egerton-Idehen highlighted the recent visit of French Ambassador to Nigeria, Marc Fonbaustier, as a pivotal step in fostering deeper bilateral cooperation in satellite technology.

Though the visit was described as a formal courtesy, it was viewed as a significant symbol of the growing opportunities for collaboration between the two nations in the field of space exploration and technology.

"Although this visit was primarily a formal courtesy, it symbolised something much larger: the increasing opportunities for Nigeria and France to collaborate in the field of space technology," Egerton-Idehen remarked.

The discussions during the ambassador's visit focused on potential partnerships with major French space firms such as Eutelsat Group and Thales. These companies, renowned for their leadership in space innovation, were identified as key players in the



expansion of Nigeria's satellite ambitions.

"Sharing expertise allows us to learn from global leaders, which in turn accelerates innovation," Egerton-Idehen added, emphasising the importance of these collaborations in advancing Nigeria's space capabilities.

Egerton-Idehen further highlighted the immense economic potential of satellite technology, explaining that it could significantly impact industries such as agriculture, education, and healthcare.

"Advancements in space technology improve connectivity and sustainability for everyone," she noted.

At NIGCOMSAT, the vision is to establish an innovative space economy that benefits Nigerian citizens and raises the country's global standing.

"Collaborations like these bring us closer to realising that vision," Egerton-Idehen declared.

The Managing Director also referenced a report by Morgan Stanley, which predicts that the global space economy will grow to \$1.1 trillion by 2040, up from \$350 billion today.

"This growth is not happening because of isolated efforts," she said.

"Rather, it is happening because countries and organisations are working together."

Nigeria's November inflation rate projected to reach 34.03%

APE Economic Research & Consulting has projected that Nigeria's headline inflation rate will reach 34.03 per cent in November 2024, ahead of the official release of November's inflation data by the National Bureau of Statistics (NBS).

It said headline inflation will rise to 34.03 per cent, food inflation will reach 40.13 per cent, and core inflation will hit 28.12 per cent in the month.

In its latest publication, the firm said its forecast is predicated on the persistent increase in food prices, fluctuations in the exchange rate, housing, and utility costs, which contributed 4.70 per cent, 0.38 per cent, and 0.31 per cent, respectively, to the inflation rate in November.

CAPE stated, "Inflation is expected to heighten in November 2024. Our forecast showed that inflationary pressure would heighten as the headline, food and core inflation are expected to rise to 34.03, 40.13 and 28.12 per cent, respectively.

"The principal drivers shaping the forecast for headline inflation persist in food prices, the exchange rate, housing, and utility costs, contributing 4.70 per cent, 0.38 per cent, and 0.31 per cent, respectively.

"Our analysis underscores the significant influence of food prices,



exchange rate fluctuations, and housing and utility costs on headline inflation."

Fuel subsidy removal, forex volatility are biggest pressures The firm further noted that fuel subsidy removal, which has led to fuel price increases, foreign exchange rate volatility as a result of naira floating, and expanded fiscal deficit, continues to exert pressure on inflation.

It added that core inflation remains largely driven by increases in transportation, education, clothing, housing, utilities, and healthcare costs.

CAPE stated, "Inflationary risks are further compounded by the expanding fiscal deficit, the removal of fuel subsidies, and sustained exchange rate pressures, all of which contribute to significant pass-through effects on consumer prices."

Inflation rate reached 33.88 per cent in October

The NBS recently released the Consumer Price Index (CPI), which revealed that Nigeria's inflation rate reached 33.88 per cent in October 2024.

The rate is a 1.18 per cent increase from the 32.7 per cent recorded in September 2024, attributed to high energy prices, currency depreciation, and supply chain disruptions, exacerbated by floods, infrastructural deficits, and insecurity, among others.

Nigeria's inflation rate soared from 22.4 per cent in May 2023 to a new 28-year all-time high of 34.19 per cent in June. After 19 months of increase, it decelerated to 33.40 per cent in July and declined further for the second consecutive month in August to 32.15 per cent.

Nigeria begins anti-malaria vaccination to check infant mortality

o check malaria scourge in Nigeria, the Federal Government in partnership with some states has commenced has the first roll out of the anti-malaria vaccine.

Nigeria is rated as one of the countries globally with the highest numbers of malaria deaths.

The newly approved R21/Matrix-M vaccine by the World Health Organisation (WHO) aims to protect children between the ages of 5 to 15 months.

Data revealed that malaria claims the lives of a large population of Nigerians annually, which is a factor in its rise, placing the disease at the third global death record.

The two states in Nigeria, Bayelsa and Kebbi, heavily hit by the rise of malaria, have started their vaccinatiion programmes.

Prof. Seiyefa Brisibe, Bayelsa's Health Commissioner, asserted that the health campaign will be promoted using local language.

The malaria vaccine, reported to have a 75% effectiveness rate, is being introduced alongside other preventive measures like mosquito nets and insecticides to enhance its impact.

Happiness Idia-Wilson, whose 11-month-old son was the first



recipient of the vaccine in a public event, expressed her motivation for participating: "I'm doing this for my child's safety." She encouraged other mothers to embrace the initiative.

Malaria remains a major public health issue in Nigeria, which accounted for 31% of global malaria-related deaths in 2022, according to World Health Organisation (WHO) data.

Developed by the Jenner Institute at Oxford University, the vaccine requires three initial doses followed by a booster shot after a year.

Nigerian health authorities are optimistic that this new measure, combined with ongoing prevention strategies, will significantly alleviate the

country's malaria burden.

Malaria's economic toll is also substantial, with Nigeria losing an estimated \$1.1 billion annually due to healthcare costs and reduced productivity.

This vaccine rollout, therefore, marks an essential addition to efforts aimed at minimising malaria's effects.

Other African countries, including Ivory Coast and the Democratic Republic of Congo, have also started deploying the vaccine.

Nigeria aims to expand its distribution nationwide by 2025, further strengthening the continent's fight against malaria.

COVID-19: FG orders compulsory health declaration for inbound passengers

o prevent the outbreak of the COVID-19 variant in Nigeria, the Federal Government (FG) has ordered for mandatory health declaration from inbound passengers over new COVID-19 XEC

The disease was recently reported in Australia and 22 other countries.

The Ministry of Health and Social Welfare gave a directive to the Committee of Chief Medical Directors and Medical Directors to activate alert systems in all hospitals over high index suspicion of COVID-like symptoms in patients.

In a report, the Nigeria Centre

for Disease Control and Prevention confirms that filling out health declaration forms is mandatory to tackle this COVID-19 variant.

Also, the Head of the Teaching Hospitals Division, the Department of Hospital Services of the Federal Ministry of Health and Social Welfare, Dr. O.N. Anuma, on December 5,2024 issued a warning notice to CMD-MD over the new variant.

The notice calls for collaboration from important stakeholders to share adequate data for effective monitoring of the COVID-19 XEC variant.

"They are filling the form; this

is a strategy to know if they have any symptoms relating to SARs," the Director, Special Duties, Office of the Director General of the NCDC, Dr. John Oladejo, stated in an interview.

NCDC noted the National COVID-19 Technical Working Group will be monitoring the situation to prevent an outbreak and acknowledged the level of their readiness.

In the last 28 days of the outbreak in the affected countries, WHO disclosed that 180,907 cases of COVID-19 and 2,665 deaths have been recorded globally to 24 November, 2024.

Nigeria, US partner over HIV/AIDS, healthcare

he Federal Ministry of Health is partnering the United States (US) to halt the spread of Human Immunodeficiency Virus (HIV) and Acquired Immunodeficiency Syndrome (AIDS) among citizens, particularly in mothers and children.

The planned partnership was sealed yesterday after a meeting in Abuja, The joint meeting highlighted the steps to eradicate HIV/AIDS targeting 2030 and achieve sustainable Nigeria healthcare service delivery.

The outcome of the meeting focuses on sustainability and the 95-95-95 of people living with HIV knowing their status, those diagnosed receiving treatment, and on treatment achieving viral suppression goals.

Also,highlighting the progress as the fight against HIV/AIDs continues in Nigeria, the Coordinating Minister of Health and Social Welfare, Dr. Muhammad Pate, said the progress stems from political will, enhanced funding, and the integration of the Sector-Wide Approach (SWAp).

Other progress beams from initiatives such as the implementation of zero VAT on pharmaceuticals, primary healthcare strengthening, and job creation via local pharmaceutical manufacturing.

Acknowledging that 3 out of 4 Basic Healthcare Provision Fund (BHCPF) primary health centres now provide HIV care along with a robust adolescent and youth HIV strategy is in place.

To this end, the CDC Director, Dr. Mandy Cohen, lauded the progress



witnessed in Nigeria as they aligned with the target globally.

Partners of the eradication process include the U.S. Embassy, Global Health Security and Diplomacy (GHSD)/PEPFAR, U.S. Department of Defence (DoD), United States Agency for International Development (USAID), Centres for Disease Control and Prevention (CDC), and Federal Ministry of Health and Social Welfare.

Others include the National Assembly HIV, TB, and Malaria Committee; the Federal Ministry of Finance and Economy; the Federal Ministry of Budget and Economic Planning; the Federal Ministry of Defence; and the Special Adviser to the President on Health.

Pate, advocates the inclusion and signing of Nigeria's SWAp for effective outcomes with a deadline with the aim to reduce transmission rates between mother and child, establish adequate data systems, and prioritise sustainable funding.

Also, Dr. John Nkengasong, representing GHSD and PEPFAR, recommended sustainable funding, incorporating the SWAp approach, and improving the value chain in health sectors.

While representative of USAID, Dr. Atul Gawande hailed the efforts of Nigeria connecting HIV response to Universal Health Coverage (UHC) goals and primary health centres improvement.

Speaking further, the US government advised the Nigerian government to maintain momentum, protect vulnerable populations, and continue removing barriers in supply chains and data infrastructure.

Looking ahead, the meeting addresses the paediatric AIDS treatment gap, the development of a Technical Working Group (TWG) for a strategic action plan, accurate data for decision-making, and prioritises the recommendation of sustainable healthcare systems.

What to know about Nigeria's frequent electricity blackouts

i geria suffered a widespread electricity blackout on Wednesday, the 12th time in 2024, after its national grid collapsed.

The country's national power grid is prone to frequent collapses, with the resulting power shortages proving an obstacle to economic growth and investment in Africa's most populous nation.

The World Bank estimates that the Nigerian economy loses \$29 billion a year due to its unstable power supply, which causes electricity blackouts across the country.

Here is why Nigeria's grid is failing.

WHAT CAUSES BLACKOUTS?

Nigeria's aging power infrastructure is at the heart of the crisis. Transmis sion lines and substations, some of which are more than 40 years old, are prone to frequent failures.

The government-owned Transmission Company of Nigeria (TCN) reports average transmission losses of 7.79 megawatts for every 100 megawatts injected into the grid.

Years of under-investment have left the grid susceptible to tripping when demand fluctuates unexpectedly, said Lagos-based energy lawyer Ayodele Oni.

Compounding this is vandalism and attacks on transmission infrastructure, especially in



Nigeria's north. In the last two years, TCN recorded 108 attacks on its towers and lines.

GENERATION GAP

Another major factor is that Nigeria, with a population of more than 200 million people, only generates and distributes a third of its installed generation capacity of 13,500 megawatts.

And despite having the world's seventh-largest gas reserves, Nigeria produces less than 10% of the electricity generated by South Africa, a country with a population a third the size.

More than 75% of Nigeria's electricity comes from gas-fired power plants, primarily located in its southern region. The remainder is generated by hydroelectric stations in the north.

Power generation firms feed electricity into the national grid, controlled by the federal government, which distributes it through 11 regional distribution companies to consumers.

ISTHEREAFIX?

More than a decade after Nigeria privatised its electricity sector, Nigeria's grid has barely improved.


But last year the government allowed its 36 states to generate and transmit their own power. States like Lagos, the nation's commercial hub, and five others have already begun developing independent power markets.

The government is also working with the World Bank to build 1,000 mini solar grids to expand power access in rural areas.

"A more resilient approach is needed in Nigeria to incorporate decentralised energy sources, such as solar power paired with storage, to complement the national grid," said Sherisse Alexander, chief business officer at independent power producer WATT Renewable Corporation.

The incident occurred on Wednesday when Portable criticised Damilola for being online late at night. He also accused her of engaging in "polygamy and prostitution".

"What are you doing online at this time? Do you want to be practicing polygamy. Do I not tell you not to be coming online at this time?" he asked.

"Are you a prostitute? What is a housewife doing online at the time? Are you a prostitute?"

Reacting via an Instagram post, Damilola expressed her frustration and



humiliation, stating that she was "done" with the relationship.

"I'm done. This is too much for me. I can't take this embarrassment again. Oloriburuku somebody," she wrote.

"I'm gone for good. Go and eat your house."

Confirming their split in a video post on Instagram, the singer revealed that Damilola has left his house.

"Thank God, she has left. I was taking care of the child she had for Alaafin because of the respect I have for him," he said.

Damilola was one of the wives of Lamidi Adeyemi, the late Alaafin of Oyo.

In August 2023, Portable and Damilola sparked dating rumours on social media. Addressing their rumour, the singer said Damilola has been "my fan from day one."

The 'Zazoo Zeh' hitmaker added that he would not have been close to the entrepreneur if the monarch was alive.

Donald Trump named TIME Person of the Year again By Dave Oludare Oso

IME Magazine has named incoming US President, Donald Trump as its person of the year for the second time.

"For marshaling a comeback of historic proportions, for driving a once-in-a- generation political realignment, for reshaping the American presidency and altering America's role in the world, Donald Trump is TIME'S 2024 Person of the Year," Time Editor-in-Chief Sam Jacobs said in a letter to readers.

The Republican president-elect is set to ring the opening bell at the New York Stock Exchange on Thursday to commemorate the honour alongside several of his family members.

Trump was first named person of the year in 2016 after winning the US presidential election.

The magazine's tradition – which started in 1927 as "Man of the Year" – recognises a person or movement that "for better or for worse... has done the most to influence the events of the year."

Other previous winners include climate change activist Greta Thunberg, former President Barack Obama, Meta CEO Mark Zuckerberg, Pope Francis and Ukrainian President Volodymyr Zelensky.

Time Magazine editors ultimately decide who wins the award.

The outlet was considering 10 people for the person of the year award, including Vice-President Kamala Harris, the Princess of Wales and Tesla CEO Elon Musk, now a close



confidante of Trump set to lead an advisory board called the Department of Government Efficiency.

In a description of Trump for the list of finalists, Time said he had won the 2024 election "in a stunning political comeback."

"He has reshaped the American electorate, activating young male voters who propelled him to a decisive victory that saw him win the popular vote for the first time and turn every swing state red," the outlet said.

"His 2024 win is history-making in multiple ways: he will be the oldest President in U.S. history, and he was convicted earlier this year by a New York jury of 34 counts of fraud, making him the first convicted felon to be elected President."

Trump sat for interviews with the magazine in April this year during the

campaign season. During the wideranging discussions, Trump talked about his plans for a second term, including his goals of reforming the US immigration system and deporting millions of people.

Trump complained in 2015 when he was not chosen for the magazine cover during his first run for office, when the award went to former German Chancellor Angela Merkel.

But after he was named person of the year following his election win, he called it a "great honor."

"It means a lot, especially me growing up reading Time magazine. And, you know, it's a very important magazine," he said at the time.

He has, however, continued to criticize the magazine's choices since winning, including the selection of Taylor Swift as Time's person of the year in 2024.

Trump invites China's Xi Jinping to inauguration

resident-elect Donald Trump has invited Chinese President Xi Jinping to attend his inauguration next month, multiple sources told CBS News, and inauguration officials are making plans for additional foreign dignitaries to attend the swearing-in ceremony.

Trump invited Xi in early November, shortly after the election, sources said, but it was not clear whether he has accepted the invitation. A spokesperson for the Chinese embassy in Washington did not immediately comment.

Transition spokesperson, Karoline Leavitt told CBS News on Thursday that Trump invited Xi to the inauguration. She told Fox News on Thursday that it is an example of Trump "creating an open dialogue with leaders of countries that are not just our allies but our adversaries and our competitors too."

In addition to Xi, the presidentelect's team has raised the possibility of hosting other leaders at the Capitol on Jan. 20. Hungary's far-right leader, Prime Minister Viktor Orbán, who has a warm relationship with Trump and visited him at Mar-a-Lago this week, is "still considering" whether to attend, according to a source familiar with Orbán's plans.

"World leaders are lining up to meet with President Trump because they know he will soon return to power and restore peace through American strength around the globe," Trump transition spokesperson Karoline Leavitt said.



Ambassadors and other diplomats are typically invited to inaugurations, but State Department records dating back to 1874 show that a foreign leader has never attended a transfer-of-power ceremony.

Members of Trump's inner circle remain sharp critics of Xi's government, including Sen. Marco Rubio, his pick to be secretary of state, and incoming national security adviser Mike Waltz.

Trump himself has threatened to increase tariffs on goods from China. The U.S. has imposed a deadline of Jan. 19, the eve of the inauguration, for TikTok's Chinese parent company ByteDance to sell the social media app or face a ban in the U.S. TikTok is fighting the ban in court—it lost a bid last week to block the ban but is appealing the case to the Supreme Court.

But Trump has also long believed that close leader-to-leader relationships are key to international deal-making. Since Election Day, world leaders have trekked to Mar-a-Lago to meet with Trump, including Canadian Prime Minister Justin Trudeau. Argentina's president, Javier Milei, has also been granted private audiences with the president-elect.

Emmanuel Macron, the president of France, was the first world leader to host Trump overseas since he won the 2024 election. Also in attendance at the Paris reopening of the Notre Dame Cathedral were Italian Prime Minister Georgia Meloni, Ukrainian President Volodomyr Zelensky and Prince William.

Trump was mostly unknown on the world stage at his first inauguration in 2017. This time, world leaders are treating Trump essentially as an incumbent.

Ashworth's departure, "doesn't change anything"- Amorim

hough Manchester United Manager, Ruben Amorim admits Dan Ashworth's exit is "not the best situation" but he believes the exit of Manchester United's sporting director "doesn't change" anything.

Sunday morning brought the stunning announcement that the 53-year-old sporting director was leaving Old Trafford just 159 days after arriving from Newcastle.

Manchester United spent several months negotiating Ashworth's appointment, with Ashworth – who also worked for the FA and Brighton – spending a period of time on gardening leave from St James' Park.

Amorim faced the media for the first time since the sporting director's abrupt exit ahead of Thursday's Europa League group game at Viktoria Plzen, where the

first questions focused on that development.

"The first thing I want to say is that since the first day I felt great support from the ownership," Amorim said.

"From Omar [Berrada, chief executive], from Dan, from Jason (Wilcox, technical director). Dan was part of that and I really felt support from Dan.

"But this is football and sometimes these things happen. It happens with players, with coaches.

"I know that it's not the best situation but the important thing is we continue in our way. The path is really clear for everybody and I think this can happen in football."

Asked if he is concerned that United were more unstable than when he first arrived a month ago, Amorim said: "I don't think so.

"Like I said, I've felt since day one the support from everybody, so one person leaving doesn't change nothing.

"Of course it's a bad situation because we are talking about a human being, a professional, that supports us as a team.

"But I think the most important thing is that your vision is really clear and that vision doesn't change if only one person leaves."
