#### N150m fine awaits banks issuing new notes to hawkers – CBN

The Central Bank of Nigeria (CBN), has disclosed that any Deposit Money Banks found culpable of issuing illegal flow of mint naira notes to currency hawkers across the country will be fined N150 million.

A statement by the acting Director of Corporate Communications of the apex bank, Sidi Ali Hakama disclosed this information in Abuja.

This development comes amidst the misinformation about the validity of the old N1000, N500, and N200 banknotes still in circulation.

According to the apex bank, the denominations remained valid legal tender in line with a Supreme Court ruling issued on November 29, 2023, and warned against hoarding.

Following the clarification, CBN in a circular signed by the Acting Director of the Currency Operations Department, Mohammed Olayemi on Friday, said it was concerned about the increasing prevalence of mint naira notes being traded by hawkers.

The apex bank described the practice as impeding efficient and effective cash distribution to customers and the general public.

The circular, which referred to an earlier directive dated November 13, 2024, highlighted CBN's determination to address the commodification of the naira.

According to the directive, any branch of a financial institution



found guilty will face a penalty of N150m for the first violation.

The apex bank warned that any subsequent infractions would attract stricter sanctions under the provisions of the Banks and Other Financial Institutions Act, BOFIA, 2020.

To ensure compliance, the apex bank stated that it would increase periodic spot checks in banking halls and ATMs while deploying mystery shoppers to uncover illicit cash hawking spots across the country.

The circular read, "The CBN has noted with dismay the prevalence of illicit flow of mint banknotes to currency hawkers and other unscrupulous economic agents that commodify Naira banknotes, thus impeding efficient and effective cash distribution to banks' customers and the general public. "CBN will continue to intensify the periodic spot checks to the banking halls/ATMs to review cash payouts to banks' customers, as well as mystery shopping to all identified cash hawking spots across the country.

"In this regard, any erring deposit money banks or financial institutions that are culpable of facilitating, aiding, or abetting, by direct actions or inactions, the illicit flow of mint banknotes to currency hawkers and unscrupulous economic agents that commodify Naira banknotes shall be penalised at first instance N150,000,000.00, One hundred and fifty million Naira, only, per erring branch, and at later instances, apply the full weight of relevant provisions of BOFIA 2020," the statement read.

## Terrorism: Finland freezes Simon Ekpa's assets

The Finnish government has frozen the assets of Simon Ekpa, the self-acclaimed Prime Minister of the Biafra Republic Government In-Exile facing allegations of terrorismrelated activities.

According to Yle, a local newspaper, the Finnish authorities also froze the assets of companies associated with Ekpa and four of his accomplices, who are also in remand.

The report said Ekpa is being held in the Kylmäkoski vankila, (Kylmäkoski prison), which is reputed to be one of the world's toughest prisons. On November 21, Ekpa was sent to prison for spreading terrorist propaganda on social media.

A district court of Päijät-Häme remanded him after the Finnish National Bureau of Investigation (NBI) arrested him alongside four other men over alleged terrorist offences.

The self-declared Prime Minister of the Biafra Republic Government In-Exile was said to have committed the crime in 2021 in Lahti municipality.

He is accused of instigating violence and inciting terror in the south-east of Nigeria through his social media pages.

There have been calls for the arrest of the separatist following his alleged involvement in the Sit-At-Home that has relatively crippled economic activities in the South East.

The authorities in Finland had stated that Ekpa's offence is not bailable.

His trial is expected to commence in May 2025.

## BRICS: Nigeria ignores Trump' threat, says it'll decide alliances

The Federal Government has said it would continue to push for membership of international bodies to advance its economy, adding that the country reserved the right to align with any country it deems fit.

This comes on the backdrop of the recent threat by the President-elect of the United States of America, Donald Trump, to sanction countries that embraced BRICS.

BRICS, originally an acronym for Brazil, Russia, India, and China, expanded in 2010 to include South Africa.

Nigeria emerged as a partner country of BRICS in October, a move towards becoming a full member in the next two years.

The group added Egypt, Ethiopia, Iran, and the United Arab Emirates as full members, all of whom attended this year's summit in Kazan, Russia, as full participants.

The alliance has been moving towards the development of a new currency to challenge the dominance of the US dollar in global trade. This effort, often referred to as the 'BRICS currency project' is not expected to be implemented until 2025.

Trump had, in a tweet, threatened to impose 100 per cent tariffs on countries in the group if they created a new currency to rival the US dollar.

"The idea that the BRICS countries are trying to move away from the dollar while we stand by and watch is over.



We require a commitment from these countries that they will neither create a new BRICS currency, nor back any other currency to replace the mighty U.S. Dollar or, they will face 100 per cent tariffs, and should expect to say goodbye to selling into the wonderful U.S. economy," Trump posted on Truth Social.

Reacting, a source in the presidency who did not want his name in print because he was not authorised to speak on the issue, said Nigeria did not feel threatened by Trump's outburst.

The source said, "Nigeria is a sovereign nation that can decide its alliances."

Also speaking on the matter, Alkasim Abdulkadir, the Special Assistant on Media Communication and Strategy to the Minister of Foreign Affairs, Yusuf Tuggar, said Nigeria would continue to push for membership of international bodies to advance its economy, adding that the country reserved the right to align with any country it deemed fit.

"Nigeria continues to explore and

advocate the democratization of global institutions including the United Nations Security Council and G20, ultimately by becoming a member state.

"Nigeria is a country in a multipolar world and we have a history of nonalignment. Our strategic autonomy is sacrosanct," Abdulkadir said.

Commenting on the issue, a retired career diplomat, Sola Abolurin, urged Nigeria to dismiss Trump's outburst, describing it as an empty threat.

Abolurin said, "Trump has threatened so many countries, not only BRICS. He threatened Canada and China, so Nigeria should not allow any country to dictate for it. It will pay Nigeria more to be a member of BRICS.

"Russia has been surviving without the support of America and many other Western countries. When the Russia-Ukraine war started, Russia decided to do away with all the major currencies and started trading its goods in ruble and nothing has happened."

## Shettima commissions \$315m vessel in Dubai, to boost Nigeria's oil production

In a major milestone for Nigeria's oil and gas sector, Vice President Kashim Shettima today in Dubai, commissioned a \$315 million Floating Production, Storage, and Offloading (FPSO) vessel built by Oriental Energy Resources Limited.

In a statement posted on his X ,Stanley Nkwocha, Shettima's spokesperson ,said the Vice President who represented President Bola Tinubu presided over the commissioning held at Drydocks World Dubai Shipyard in the United Arab Emirates(UAE).

The Vice President hailed the project, describing it as a testament to Nigeria's oil sector reforms.

The FPSO, named ENEM, boasts a storage capacity of one million barrels and will begin production at the Okwok Oil Field in the first quarter of next year.

The facility will take off with an initial production of 17,000 barrels per day (bpd) before scaling up to 30,000 bpd, thereby remarkably enhancing Nigeria's oil production capacity.

Shettima described the vessel as a symbol of Nigeria's ambition and readiness to meet global energy demands under President Tinubuled administration.

"This FPSO is more than a technological achievement; it embodies Nigeria's transformation in the oil and gas sector, central to our economic revitalization efforts,"he stated.

Highlighting the importance of the



facility, Shettima noted that it is a crucial link in Nigeria's quest to optimize productivity and establish itself as a hydrocarbon hub.

He lauded Alhaji Muhammadu Indimi, Executive Chairman of Oriental Energy Resources, for his vision and dedication, which he said have positioned the company as a global force in the oil and gas industry.

"Alhaji Indimi's achievements prove what is possible when ambition meets perseverance and expertise. His contributions reflect Nigeria's potential as a land of opportunity," the Vice President added.

In the same vein, the Borno State Governor, Babagana Zulum, commended the project, noting that the vessel's development was fully funded by an indigenous Nigerian company—a first in the nation's history. Zulum highlighted the vessel's capacity to drive economic growth and job creation while ensuring steady national development.

Similarly, Nasarawa State Governor, Abdullahi Sule, commended Alhaji Indimi's investment, emphasising his belief in Nigeria's potential.

"Alhaji Indimi stands out as a true patriot, investing in projects that will contribute to Nigeria's development and self-reliance," Sule noted.

Indimi also expressed gratitude to the Federal government and its agencies for fostering an enabling environment for the investment.

He revealed that ENEM is the first FPSO fully funded by a Nigerian company and emphasised its role in achieving the company's long-term goal of producing 100,000 barrels of oil per day.

### FG, states, LGs share N1.727trn for November

The Federation Account Allocation Committee (FAAC) has distributed a whopping sum of N1.727 trillion to the Federal Government, states, and local government councils (LGCs) as Federation Allocation for November 2024.

This was disclosed during FAAC's December 2024 meeting, chaired by Wale Edun, the Minister of Finance and Coordinating Minister of the Economy.

The allocation, drawn from a gross total revenue of N3.143 trillion, included contributions from Gross Statutory Revenue, Value Added Tax (VAT), Electronic Money Transfer Levy (EMTL), and Exchange Difference (ED).

The Federal Government received N581.856 billion, states were allocated N549.792 billion, and local government councils received N402.553 billion. Oil-producing states received an additional N193.291 billion as derivation revenue, representing 13 pet cent of mineral revenue.

A breakdown of the revenue shows that N103.307 billion was allocated for collection costs, while N1.312 trillion was earmarked for transfers, interventions, and refunds.

The gross revenue from VAT for November 2024 totaled N628.972 billion, reflecting a decrease of N39.318 billion compared to October's figure of N668.291 billion.

Of the VAT revenue, N25.159 billion was allocated for collection



costs, and N18.114 billion for transfers, interventions, and refunds. The remaining N628.973 billion was distributed as follows, federal government got N87.855 billion, state, N292.850 billion, local government councils received N204.995 billion.

Statutory revenue for November 2024 stood at N1.827 trillion, an increase of N490.339 billion from the previous month's N1.336 trillion.

After deducting collection costs of N77.521 billion and allocating N1.294 trillion for transfers, interventions, and refunds, the remaining N455.354 billion was distributed as follows: N175.690 billion to the FG, N89.113 billion to the states, N68.702 billion to local government councils, and N121.849 billion to oil-producing states as 13 per cent derivation revenue.

A total of N15.046 billion from the EMTL was distributed among the three tiers of government, with the FG receiving N2.257 billion, states

allocated N7.523 billion, and local government councils receiving N5.266 billion.

Moreover, N671.392 billion from Exchange Difference was shared, with the Federal Government receiving N316.054 billion, states allocated N160.306 billion, local government councils receiving N123.590 billion, and oilproducing states (13% derivation) getting N71.442 billion.

While oil and gas royalties and CET levies recorded significant increases, other revenue streams such as VAT, Import Duty, Petroleum Profit Tax (PPT), Companies Income Tax (CIT), and EMTL saw considerable declines.

The total distributable revenue for November 2024 comprised N455.354 billion from statutory revenue, N585.700 billion from VAT, N15.046 billion from EMTL, and N671.392 billion from Exchange Difference, culminating in the N1.727 trillion shared for the month.

According to a statement signed by the EFCC's Head of Media and Publicity, Dele Oyewale on Friday, Otukpa used five names which are Ford Thompson, Oscar Tyler, Michael Haye, Jose Vitto, and Kristin Davidson, to scam the victims.

He added that the suspect lured his victims on social media to invest in his rogue cryptocurrency investment



platform, Liquid Asset Group.

Oyewale said, "Operatives of EFCC have arrested a suspected online fraudster, Osang Usie Otukpa, for allegedly duping 139 Australians to the tune of \$AUD8,000,000.

"He was picked up in a stake out at the Murtala Mohammed International Airport, Ikeja, Lagos upon arrival from the United States of America on Friday, December 6, 2024.

"Otukpa, who goes by five aliases, namely: Ford Thompson, Oscar Donald Tyler, Michael Haye, Jose Vitto and Kristin Davidson scammed the victims by luring them on the social media to invest in his rogue cryptocurrency investment platform, Liquid Asset Group.

"The proceeds of the alleged crimes were routed to his bank accounts through a global cryptocurrency exchange platform."

Oyewale said the suspect would be charged to court upon conclusion of investigations.

## Old, new Naira notes remain valid,

**CBN insists** By Dave Oludare Oso

Following rumours of a December 31 deadline for the phasing out of the old notes, the Central Bank of Nigeria (CBN) has reiterated that both the old and redesigned Naira notes of N1,000, N500, and N200 denominations will remain legal tender indefinitely.

The apex bank's Acting Director of Corporate Communications, Hakama Ali, in a statement issued on Friday by, cited a Supreme Court ruling delivered on 29 November 2023, which permits the concurrent circulation of all versions of the affected denominations without any deadline.

It said the clarification follows widespread misinformation regarding the validity of the old notes.

The statement read, "The Central Bank of



Nigeria (CBN) has observed the misinformation regarding the validity of the old N1000, N500, and N200 banknotes currently in circulation.

"In line with the Bank's previous clarifications and to offer further assurance, the CBN wishes to reiterate that the subsisting Supreme Court ruling granted on 29 November 2023 permits the concurrent circulation of all versions of the N1000, N500, and N200 denominations of the Naira indefinitely.

"For the avoidance of doubt, all versions of the naira, including the old and new designs of N1000, N500, and N200 denominations, as well as the commemorative and previous designs of the N100 denomination, remain valid and continue to be legal tender without any deadlines."

The CBN urged the public to disregard claims suggesting the old series of these denominations would cease to be valid at the end of this year.

"The Agency's response team and LRUPre-Hospital Care Unit gave the victim immediate treatment at the incident scene to stabilize his condition, before being transported to Federal Medical Centre, FMC, Yaba for further treatment," Oke-Osanyintolu added.

## **NNPC reduces fuel price in FCT**

he Nigerian National Petroleum Company Limited (NNPCL) has reduced the price of Premium Motor Spirit (petrol) across its retail outlets in the Federal Capital Territory.

A visit to NNPCL retail outlets showed that the petrol pump price was reduced from N1,060 to N1,040 per litre, representing a reduction of N20.

According to a filling station attendant at the NNPCL retail outlet along Kubwa expressway, "The price was reduced to N1,040 per litre from N1,060 on Saturday morning,

Also, a motorist, Ezekiel Njoku, confirmed the development, saying, "The reduction of N20 is significant. We need further fuel price reductions in the coming days."



With the price cut, Nigerians will now buy petrol at N1,040 per litre at NNPCL filling stations, while prices remain within N1,115 per litre at other filling stations, depending on the location.

This comes barely three weeks after the state-owned Port Harcourt refinery began producing petroleum products in November 2024.

Prof. Billy Okoye, former Managing Director of NNPCL Retail had earlier speculated that a fuel price reduction w a s i m m i n e n t w i t h t h e commencement of production at the Port Harcourt refinery.

The Independent Petroleum Marketers Association of Nigeria (IPMAN), and the Petroleum Products Retail Outlets Owners Association (PETROAN), had also hinted that the deregulation of the sector, coupled with the operations of Dangote and Port Harcourt refineries would lead to a drop in petrol prices.

### 2027: PDP woos Jonathan to run against Tinubu

he Peoples Democratic Party (PDP) has asked former President Dr. Goodluck Jonathan to enter the fray and contest the 2027 presidential election on its platform.

According to Saturday PUNCH, the party is desperate to secure the candidacy of the former university don, fearing he could be snapped up by another party to run for the presidency in 2027.

It (Punch) further said PDP's Deputy National Publicity Secretary, Ibrahim Abdullahi, emphasized that it would be a regrettable development if Jonathan chose another party for his presidential bid.

He revealed that the PDP had been eagerly awaiting the former president's return for a second term, stressing the party's continued connection to Jonathan's political rise.

Abdullahi highlighted the party's historical role in shaping Nigeria's leadership, citing several notable figures who had emerged from the party.

"We've said this about Jonathan and our governors. Even the FCT minister, is arguably the best performer in his role and he is a product of PDP. El-Rufai, Okonjo-Iweala, Dora Akunyili, Obi Ezekwesili, Akinwunmi Adesina, Amina Mohammed... these are the pride of this country, and they are all products of the PDP," he added.

The PDP chieftain urged Jonathan to heed the call to finish what he started within the party, and warned against the "hypocrisy of the All Progressives Congress."

"If Goodluck Jonathan is seriously considering running, we have been



calling him to come back and complete his term. It will not be out of place, but if he runs with another political party, it will expose the hypocrisy within the APC," he added.

Abdullahi also advised the former president to remain cautious of the recent praise from individuals and groups who previously criticised him.

"It's crucial for him to remember how he was derided, criticized and reduced to nothing by these same people. Now that they are suddenly calling him the messiah, he must not be swayed by their sudden affection. That would be unfortunate," Abdullahi stated.

The recent sighting of Jonathan's presidential posters for the 2027 elections across major streets in Kano sparked speculations about his possible return to the political arena and intensified conversations about other prominent figures like Peter Obi and Atiku Abubakar.

The posters, which were seen at strategic locations such as Gyadi-Gyadi/Zoo Road flyover, Kofar Nasarawa, and State Road, featured messages like, 'Team New Nigeria 2027; The Goodluck Nigeria Needs—Dr Goodluck Jonathan.' The recent campaign posters, our correspondents gathered, were masterminded by a political movement known as 'Team New Nigeria', which has been promoting its activities across Nigeria.

The emergence of the posters is similar to a development before the 2023 elections when supporters purchased nomination forms for Jonathan under the APC, but the former president distanced himself from the move.

Another permutation that raised discussions about Jonathan's possible interest in the 2027 presidential election was the report that key political figures from northern Nigeria had begun efforts to draft Jonathan into the race.

It was reported that the move is based on the belief that Jonathan is eligible to serve another four-year term, having already served as president from 2011 to 2015.

Meanwhile, sources within the PDP have predicted that the future of the party would be determined at its upcoming National Executive Committee meeting, scheduled for February, 2025.

#### **12 drug peddlers convicted in Kano**

The Kano State Command of the National Drug Law Enforcement Agency (NDLEA), has secured the conviction of 12 drug peddlers in the state.

The spokesman of the agency, Sadiq Maigatari, disclosed this in a statement issued to newsmen in Kano on Saturday.

Maigatari said the conviction was a significant milestone in the agency's relentless fight against drug-related offences under the leadership of the state Commander Abubakar Ahmad.

According to him, the agency secured multiple convictions in one day, demonstrating its unwavering commitment to upholding the rule of law and maintaining a zero-tolerance policy towards corruption.

Maigatari said the convicts were found guilty of orchestrating drug trafficking



activities at the notorious Filin Idi drug den.

He said, "Each of the 12 individuals received a three-year prison sentence, with no option of fine, underscoring the severity of their crimes.

"One of the drug peddlers, Lawan Sani, was convicted following a 10-month manhunt that ensued after attacking an NDLEA officer; he was given an additional two-year sentence, totalling five years of imprisonment."

Maigatari said the landmark conviction was a robust deterrent to drug traffickers who have been exploiting the Filin Idi area for their illicit operations.

He further explained that the NDLEA Kano State Command remained resolute in its mission to bring drug offenders to justice and combat the scourge of substance abuse in the region.

He urged the public to stay alert and report any suspicious activities related to illicit drug activity.

"Together, we can foster a safer and healthier environment for all residents of Kano State," he added.

E xcel Ihekweme, wife of the former Commissioner for Foreign and International Affairs in Imo State, Dr Fabian Ihekweme, has petitioned President Bola Tinubu over the unlawful arrest and detention of her husband.

Excel, in two letters dated December 13 and written on her behalf by a rights group, Initiative Against Human Right Abuse and Torture, also sought the intervention of the Attorney-General of the Federation and Minster of Justice, Lateef Fagbemi, SAN.

Ihekweme was a commissioner in the first term of Governor Hope Uzodinma of Imo.

The petitions were signed by the Executive Director of the group, Comrade Gerald Katchy on behalf of the complainant.

They were titled: "Complaint of Abuse of Power and Office by Security and



Enforcement Agencies and Disregard to the Rule of Law: A Menace to the Renewed Hope Agenda of His Excellency."

Excel alleged that her husband was forcefully arrested on November 27 in his Abuja residence by the police without an arrest warrant and had since been in detention.

She said her husband's plight began when he (Fabian) urged the governor of Imo State to prioritize the needs of the citizens of the state and to deliver on his campaign promises.

According to her, this demand of accountability by Dr Fabian Ihekweme, regrettably led to his persecution.

In two other letters she personally signed and addressed to the Executive Secretary, National Human Right Commission, and President, Nigerian Bar Association, Excel equally sought their intervention.

She said she wrote the letters over the alleged misconduct involving the Nigerian police.

# WHO lists dangers of nations' low spending on health care

The World Health Organisation (WHO) has raised fears that governments' less spending on health care has severe consequences for people's finances, which could lead to increased hardship.

A recent WHO's report which covered two years(2020-2021), explained the influence of the average per capita government spending on health sector across countries' income groups during the years under review.

The published report titled, "Global Spending on Health: Emerging from the Pandemic," aligns with the Universal Health Coverage (UHC) Day campaign held yearly on December 12.

This year's campaign centred on improving financial protection for people everywhere to access the health services they need.

Explaining its importance on delivery UCH, WHO cautions that, "Its deprioritization can have dire consequences in a context where 4.5 billion people worldwide lack access to basic health services and 2 billion people face financial hardship due to health costs."

Also, the WHO Director-General Dr. Tedros Ghebreyesus stressed that, access to health has significantly increased globally, but acknowledged the effect of the services on people, leading to financial hardship or poverty.

"Universal Health Coverage Day is a reminder that health for all means everyone can access the health services they need, without financial



hardship," Ghebreyesus said.

expenses, targeting 2030.

To prevent financial burden on people, the WHO stated that recognising out-of-pocket spending will help achieve UHC.

The report further indicated, "that out-of-pocket spending remained the main source of health financing in 30 low- and lower middle-income countries."

While, 'In 20 of these countries, more than half of total health spending in the country was paid for by patients out of their pocket, which contributes to the cycle of poverty and vulnerability,"the report added.

Furthermore, a recent data shows that over a third of high-income countries, and more than 20% of total health spending were paid outof-pocket.

The global health organisation ,therefore urged world leaders to prioritise UHC and tackle health Among the effective strategies outlined by WHO to strengthen financial protection include, minimizing or removing user charges for those most in need, particularly people with low incomes or chronic condition.

The organisation also urged the adopting of laws to protect people from impoverishing health costs and establishing health financing mechanisms through public funding to cover the larger population.

The report also noted that, "Public funding needs to budget for an affordable package of essential health services – from health promotion to prevention, treatment, rehabilitation and palliative care – using a primary health care approach."

Tonto Dikeh's warning comes with a clear call to action. She urged people to stay vigilant and prepare themselves to handle such situations calmly and effectively. Here are a few practical tips to help avoid falling for this scam:

Stay calm and collected: If you're falsely accused, avoid reacting emotionally. Keeping calm can prevent the situation from escalating further.

Demand proof: Politely but firmly ask the accuser to provide evidence, such as transaction records or receipts, to substantiate their claims.

Involve authorities: If the situation begins to escalate, seek the help of nearby security personnel or contact law enforcement.

#### Allu Arjun detained over stampede death at film screening

Ilu Arjun arrested after deadly stampede at Pushpa 2 screening in Hyderabad, India. One woman died, child injured. The incident occurred on December 4th.

Arjun was taken into custody on charges of three offences, including "voluntarily causing hurt by dangerous weapons or means," according to a police officer who spoke on the condition of anonymity. Seven others, including members of his security team and theater staff, were already arrested in connection with the incident.

Video footage shared by broadcaster TV9 showed Arjun holding a coffee mug and speaking to police officers as they arrived at his residence to make the arrest. Later that day, Arjun was granted interim bail for four weeks, as reported by local media.

The victim of the stampede was a woman in her 30s, who had attended the screening with her son. The child sustained serious injuries in the chaos.

The woman's family has filed a formal complaint against Arjun, his security team, and the theater management, alleging negligence in crowd control and event organization.

Two days after the incident, Arjun expressed his deep sorrow on social media platform X (formerly Twitter), stating, "I am deeply heartbroken. While respecting their need for space to grieve, I stand committed to extending every possible assistance to help them navigate through this challenging journey."

Allu Arjun is a prominent figure in Indian cinema, particularly in southern



India, where he enjoys a massive fan base. The Pushpa film series has been a massive success, generating millions at the box office. Arjun won the Best Actor award at India's National Film Awards for his performance in the first installment of the series.

The ongoing investigation has raised serious questions about crowd management, security protocols, and the responsibilities of actors and event organizers in ensuring public safety during such high-profile events.

Fan gatherings have always carried the potential for chaos, but this incident highlights critical flaws in ensuring the safety of attendees.

The incident at Hyderabad's theater marks a stark reminder of the dangers posed by unregulated public gatherings, particularly when fans' enthusiasm is unchecked. The crowd at the screening reportedly swelled beyond the theater's capacity, leading to panic and chaos.

#### **Macron appoints François Bayrou** as new PM

rench President, Emmanuel Macron has appointed François Bayrou as Prime Minister.

This comes after an unprecedented parliamentary vote to depose the previous government last week.

Bayrou, 73, is a well-known personality in French politics and an important member of Macron's centrist alliance.

His political background is regarded as important in efforts to restore stability in a split National Assembly.

Bayrou, who was recently cleared of allegations of misappropriation of European Parliament funds, now has the difficulty of guiding the country through a divided parliament.

He is anticipated to reveal his selection of ministers in the coming days.

The appointment of Bayrou comes in the backdrop of political chaos and instability in France.

The country recently voted on a no-confidence motion against Prime Minister Michel



Barnier that ended his threemonth term and further deepened the political crisis.

The motion was backed by both the left and the far-right. It followed Barnier's controversial use of Article 49.3 of the French Constitution to pass the 2025 social security budget bill without a parliamentary vote. The move triggered noconfidence motions from both **Opposition blocs.** 

Although Barnier, who headed Macron's minority government was hopeful that his administration would survive the vote.

Barnier emerged as the shortest-serving prime minister in modern French history. The motion against him marked the first successful no-confidence motion since 1962.

Barnier's appointment as prime minister in September 2024 came after Macron's centrist alliance suffered a major defeat in the legislative assembly elections.

In the wake of a landslide victory by Marine Le Pen's far-right National Rally in the June European Union elections, Macron dissolved the National Assembly and called for snap elections.

Following Barnier's removal, his 2025 budget proposal, which includes \$60 billion in tax increases and spending cuts, is expected to undergo significant revisions.

## South Korean President, Yeol impeached over martial law

South Korea's parliament has voted to impeach President Yoon Suk Yeol over his short-lived attempt to impose martial law earlier this month.

On Saturday, the country's National Assembly voted by 204 to 85 to impeach Yoon and suspend his powers and duties, the Associated Press reported.

The motion required the support of two-thirds of lawmakers to pass. Yoon had survived a first impeachment vote last Saturday after most of his ruling People Power Party (PPP) boycotted it.

Yoon issued a martial law decree on December 3, which caused political turmoil across the country. It lasted only six hours as the country's parliament voted to block the decree. South Korea's Constitutional Court has 180 days to decide whether to dismiss Yoon as president or restore his powers. If he is forced out, an election to choose his successor must be held within 60 days.

Yoon's refusal to resign and his insistence that he was right to declare martial law convinced some lawmakers from his own party to cross the aisle and meet the two-thirds majority, or 200 votes, required to oust him, The Washington Post reported.

Yoon justified the martial law declaration as a move to thwart "anti-state" activities by the opposition parities controlling the



National Assembly.

He sent hundreds of troops and police officers to the parliament in a bid to block its vote on the decree.

He said on Thursday that his decision was an act of governance, and accused the main liberal opposition Democratic Party of being a "monster" that had tried to impeach officials and undermine the government's budget bill.

Korean democracy has survived a close call, and other democracies with a presidential form of government should take heed of the lessons from this episode," said Tom Pepinsky, government and public policy professor at Cornell University.

"President Yoon's attempt to declare martial law reveals the fragility of the rule of law in divided societies, especially those with presidential governments in which the chief executive cannot be easily dismissed by the legislature," he told Newsweek.

Pepinsky said it was fortunate that the martial law declaration was decisively opposed by the country's National Assembly, as well as the media, civil society, and the rank-and-file members of the military who opted not to use violence against protesters and lawmakers.

Most importantly, no members of President Yoon's own party were willing to defend his actions in public, nor did any vote in defense of his martial law declaration," he added.

Prime Minister Han Duck-soo will serve as interim president as South Korea enters a period of uncertainty.

Dec. 31, 2006.

Cops said the suspect jumped into the driver's seat of his car and drove up on the curb to hit the men with whom he had been arguing.

Instead, Kolenovic, who was not even involved in the dispute, was struck and launched into a tree, hitting his head. He was later pronounced dead at a nearby hospital.

Kolenovic was a professional welterweight boxer.

The driver of the car fled and eluded retribution for the heinous act.

Police officers initially wanted to question Gashi in connection to the death, but the suspect fled into the



Balkans and disappeared for the last 18 years.

Gashi was picked up by Serbian police earlier this year and was then transferred to the ward of the US Marshals, according to ABC7.

He arrived at Central Booking in the Bronx on Friday night.
