FG plans to reduce cost of cooking gas

stensibly to alleviate the suffering of Nigerians ,the federal government has announced measures to reduce the cost of cooking gas via a zero import duty on machinery, equipment, and spare parts for gas utilisation in the country.

The announcement was made in a statement issued by Nigerian Customs Service(NCS) Spokesman Abdullahi Maiwada on Wednesday in Abuja.

The initiative is part of the Presidential Gas for Growth Initiative, which aims to foster the development of the nation's gas sector.

The Presidential Gas for Growth Initiative was conceived to leverage Nigeria's vast natural gas resources to boost economic growth, create jobs, and reduce energy poverty.

Maiwada explained that the plan aligned with President Bola Tinubu's commitment to enhancing Nigeria's investment climate and increasing domestic gas utilisation.

"Pursuant to Part 1, Section 5 of the Customs and Excise Tariff Act, machinery, equipment, and spare parts imported for Nigerian gas utilisation are now subject to a zero per cent import duty rate.

"The exemption applies to all equipment related to Compressed Natural Gas (CNG) and Liquefied Petroleum Gas



(LPG) imported into Nigeria

"In addition, several items have been zero-rated for Value Added Tax (VAT), including feed gas for all processed gas, CNG, imported LPG, CNG equipment components, conversion and installation services, LPG equipment components, and all infrastructure related to CNG, LPG, and the Presidential CNG Initiative.

However, Maiwada stated that importers seeking to benefit from these incentives must obtain an Import Duty Exemption Certificate (IDEC) from the Federal Ministry of Finance and a letter of support from the Office of the Special Adviser to the President on Energy.

He also announced the exemption of import duty and VAT on LPG imported into Nigeria under specific Harmonised System (HS) codes, including HS Codes 2711.12.00.00, 2711.13.00.00, and 2711.19.00.00.

According to him, this exemption is expected to reduce the cost of importing LPG, making it more affordable for businesses and consumers.

Maiwada further stated that all Debit Notes issued to petroleum marketers who imported LPG using these codes from August 26, 2019, to the present would be withdrawn by the NCS, in line with previous approvals.

He further stressed that these measures were designed to reduce the cost of living, strengthen energy security, and accelerate Nigeria's transition to cleaner energy sources.



Certificates of Occupancy (C of O)fees, the Minister of the Federal Capital Territory (FCT), Nyesom Wike, has revoked the allocation of lands in Abuja belonging to former President Muhammadu Buhari, the Speaker of the House of Representatives, Tajudeen Abbas, and the Secretary to the Government of the Federation, George Akume.

In its today's report, Channels TV said the land's revocation was disclosed in a publication by the FCT Administration and shared by the Minister's Special Adviser, Lere Olayinka.

In addition to these high-profile individuals, Wike revoked lands allocated to 759 other prominent personalities and organisations in Maitama II, Abuja.

Wike also called on several other landowners, including the Minority Leader of the House of



Representatives, Kingsley Chinda; former Senate Presidents Iyorchia Ayu and Ameh Ebute; the Chief Whip of the Senate, Tahir Monguno; and 610 others to pay all theiry outstanding fees.

He demanded payment of outstanding fees within two weeks, threatening to revoke their land rights if they failed to comply. This action follows months of warnings from Wike urging residents of the FCT, particularly those in highend areas, to settle outstanding fees owed to the FCTA or face consequences, including the loss of their land.

FG shifts focus to renewable energy to enhance key sectors

The Federal Government has announced a strategic shift towards the renewable energy sector to address energy access challenges and enhance supply to critical sectors such as education, health, agriculture, rural communities, and transportation.

The move is part of efforts to meet the energy needs of millions of Nigerians, particularly in rural areas.

A key component of this initiative is the deployment of mini-grids through the e-HEART project, which aims to solve energy access issues in rural communities.

The project is expected to benefit over 80 million Nigerians, who are currently without electricity, and help in creating sustainable local economies while reducing the rural-urban migration.

In addition, the government has secured \$700 million from the African Development Bank (AfDB) for the "Desert to Power" project, aimed at harnessing the abundant sunlight in northern Nigeria to generate renewable energy for communities in the region.

Speaking at a stakeholder engagement workshop hosted by the Rural Electrification Agency (REA) in Abuja on Wednesday, December 18, the Minister of Power, Chief Adebayo Adelabu, underscored that off-grid electricity solutions have become essential in bridging the electricity supply gap in the country.

Adelabu, who was represented by Dr Sunday Owolabi, the Director of Renewable and Rural Power Access, expressed optimism that these projects will positively impact at least 13 million



Nigerians.

Adelabu highlighted the importance of both on-grid and off-grid solutions, stating that they should be viewed as complementary elements of a comprehensive energy strategy.

He noted that although Nigeria continues to face significant challenges with the national grid, the government has been actively working to transform these challenges into growth opportunities.

"At the recent Federal Executive Council meeting, €161 million worth of contracts were approved for the upgrade of power substations under the Presidential Power Initiative. We are confident that we are on track to deliver an additional 150MW to the grid, impacting 14 existing substations and establishing 21 new ones," Adelabu said.

The Minister also touched upon the World Bank's \$750 million investment in the Distributed Access through Renewable Energy Scale-up (DARES) programme, which is set to impact millions of Nigerians. The REA Managing Director/CEO, Engr. Abba Aliyu, gave an overview of the agency's achievements, including the deployment of 124 mini-grids and 25,580 solar home systems, providing a combined capacity of 16.6MW.

He added that 195,198 connections have been made to 183 communities and 12 markets.

Aliyu also shared the agency's plans to provide uninterrupted power supply to 3,700 primary healthcare centres, 25 schools per state and the Federal Capital Territory (FCT), 25 communities in each state and the FCT, as well as solarpowered tricycles and charging stations across the country.

"We have never seen the level of attention and support for renewable energy that we are getting from this government," Aliyu stated, emphasising that the newly signed Electricity Act is key to the government's commitment to improving energy access.

He urged sub-national governments and the private sector to actively participate in these initiatives to ensure the provision of sustainable power supply.

State house allocates N15.09bn for vehicle tyres, office complex in 2025 budget

The State House has earmarked a significant portion of the 2025 budget for various expenditures, including N15.09 billion for the purchase of tyres for bulletproof vehicles, Sport Utility Vehicles (SUVs), operational vehicles, and plain cars.

Additionally, N5.49 billion has been proposed for the annual maintenance of the Presidential Villa.

These details were made public in the newly released 2025 Appropriation Bill, presented by the Budget Office of the Federation on Thursday, December 19.

The bill was introduced by President Bola Tinubu on Wednesday as part of his administration's ambitious N49.70 trillion spending plan, titled the "Budget of Restoration: Securing Peace, Rebuilding Prosperity."

As part of the allocation, N164 million will be spent on tyres for various vehicles including bulletproof ones, SUVs, and operational vehicles, while N1.1 billion is set aside for the replacement of SUVs.

Additionally, N3.66 billion is allocated for the purchase of operational vehicles for the State House.

The budget also outlines



N127.86 million for the procurement of SUVs for the President and Vice President, under the Office of the President.

The Chief of Staff will receive N285 million for the purchase of motor vehicles, and the Chief Security Officer to the President has been allocated N179.63 million for security and operational vehicles.

Further allocations in the budget include N2.12 billion for honorarium and sitting allowances, and N1.83 billion for the construction of an office complex for Special Advisers and Senior Special Assistants.

In line with its priorities, the 2025 budget places a strong emphasis on defence, infrastructure, and human capital development, with a projected N13.39 trillion deficit to be financed through borrowing.

Tinubu's administration has promised significant investments in these areas, as well as in education and healthcare, which are allocated N3.52 trillion and N2.48 trillion, respectively.

The defence sector is set to receive N4.91 trillion, with N4.06 trillion allocated to infrastructure projects, including the Lagos-Calabar Coastal Highway and the Sokoto-Badagry Highway.

This budget is based on key economic assumptions, including a projected decline in inflation from 34.6% to 15%, and an improvement in the naira exchange rate from N1,700 per dollar to N1,500 per dollar.

Tinubu's reforms will drive economic growth – Speaker

The Speaker of the House of Representatives, Tajudeen Abbas, has expressed confidence that Nigeria's ongoing reforms under President Bola Tinubu -led administration will spur economic growth, alleviate poverty, and ensure long-term prosperity for the country.

In a statement shared on his X page yesterday, Abbas commended the administration for implementing bold reforms over the past eighteen months.

He highlighted measures such as the removal of fuel subsidies, the unification of foreign exchange rates, and the introduction of innovative economic policies, which he described as laying the groundwork for sustainable growth and development.

"While these reforms have required short-term sacrifices, they reflect courage and patriotism. History teaches us that transformative progress often stems from difficult decisions, as seen in the market reforms of China, India's liberalisation, and South Korea's industrialisation,"Abbas said.

He acknowledged the resistance these reforms have triggered from vested interests but lauded President Tinubu's resolve to prioritise Nigerians' welfare.

Abbas further noted that the National Assembly remains committed to supporting these



reforms through legislative backing and public engagement to enhance understanding and acceptance.

The Speaker outlined the economic progress recorded in 2024, citing a 3.46 per cent GDP growth in the third quarter, up from 3.19 per cent in the second quarter, driven largely by the services sector.

He also explained the critical contribution of agriculture, which accounted for 17.22 per cent of nominal GDP in the first quarter and 22.61 per cent in the second quarter, despite challenges such as climate change and insecurity.

However, he expressed concerns over rising inflation, which reached 33.88 per cent in October, along with escalating food and energy costs that have strained households.

Despite these challenges, Abbas pointed to the International Monetary Fund's projection of a 3.2 per cent growth rate for 2025 as an indication of a positive trajectory, provided reforms are sustained and structural issues addressed.

On the global stage, Abbas commended President Tinubu's international engagements, noting that agreements from his visit to China in September 2024 are expected to transform rail transport, boost agriculture, enhance digital literacy, and strengthen national security.

Nigeria customs removes VAT, zero import duty on LPG, CNG products

he Nigeria Customs Service (NCS) has announced the removal of Value Added Tax (VAT) on Liquefied Petroleum Gas (LPG), also known as cooking gas, and Compressed Natural Gas (CNG). Additionally, the service has introduced zero per cent import duty on these products.

This decision is in line with President Bola Ahmed Tinubu's commitment to improving Nigeria's investment climate and increasing domestic gas utilization.

The announcement was made by the NCS's National Public Relations Officer, Mr. Abdullahi Maiwada, in a statement issued on Wednesday.

In the statement, the NCS explained that, under the Presidential Gas for Growth Initiative, fiscal incentives were being introduced to support the gas sector.

According to Part 1, Section 5 of the Customs and Excise Tariff Act, machinery, equipment, and spare parts imported for Nigerian gas utilization will now be subject to a zero per cent import duty rate. This exemption covers all equipment related to both Compressed Natural Gas (CNG) and Liquefied Petroleum Gas (LPG) imported into Nigeria.

Furthermore, the following items are now exempted from VAT: feed gas for all processed gas, Compressed Natural Gas, imported Liquefied Petroleum Gas, CNG equipment components, conversion and installation services, LPG equipment



components, and all equipment and infrastructure related to the expansion of CNG and LPG, including conversion kits.

The NCS also highlighted that importers who wish to benefit from these incentives must obtain an Import Duty Exemption Certificate (IDEC) from the Federal Ministry of Finance and a letter of support from the Office of the Special Adviser to the President on Energy.

Additionally, the NCS clarified that importation of LPG under HS Codes 2711.12.00.00, 2711.13.00.00, and 2711.19.00.00 is exempted from both Import Duty and VAT.

The Customs service also stated that all Debit Notes issued to petroleum marketers who have imported LPG under these codes from August 26, 2019, to the present will be withdrawn in line with prior approvals.

Meanwhile, the Presidential Compressed Natural Gas Initiative (P-CNGI) expressed optimism about its progress. The initiative, which aims to expand the use of CNG in the country, has seen the establishment of 170 CNG conversion centres across Nigeria.

Michael Oluwagbemi, the CEO of P-CNGI, confirmed that this number would increase to 200 by the end of the year, doubling their target. He added that the initiative plans to expand to 500 conversion centres in the coming year.

Oluwagbemi also emphasized the success of the initiative in meeting its targets, noting that the goal for this time last year was 100 centres, but they had exceeded this figure.

The P-CNGI aims to continue growing the number of CNG conversion centres to further reduce fuel dependency and promote the use of natural gas as a cleaner, alternative energy source.

Court grants Yahaya Bello N500m bail

Federal Capital Territory High Court has granted bail to Yahaya Bello, the immediate past governor of Kogi State, in the sum of N500 million.

Justice Maryanne Anenih, who delivered the ruling, ordered Bello to produce three sureties of the same amount.

The sureties must be prominent Nigerians with landed properties in Maitama, Jabi, Utako, Apo, Guzape, Garki, or Asokoro.

Bello was also required to surrender his international passport and other travel documents to the court.

The court ruled that Bello would remain at the Kuje Correctional Centre until he fulfills the bail conditions.

The former governor, alongside two others, is facing trial over alleged money laundering to the tune of N110 billion.

He pleaded not guilty to the 16count charges brought against him by the Economic and **Financial Crimes Commission** (EFCC).

The New Daily Prime earlier reported that Justice Anenih had rejected Bello's bail



application on December 10, citing that it was filed prematurely as Bello was neither in custody nor before the court at the time.

However, the defence later filed a fresh application for bail.

At today's hearing, Bello's counsel, Joseph Daudu, informed the court that discussions with the prosecution team led to an agreement to expedite the trial.

He urged the court to consider granting bail and requested the conditions be broadened to include properties across the Federal Capital Territory, rather than limiting them to Maitama.

Prosecution counsel Olukayode Enitan confirmed these discussions, assuring the court of the EFCC's cooperation in ensuring a speedy trial.

"We have decided not to make this contentious, leaving the matter to your lordship's discretion," Enitan said.

In her ruling, Justice Anenih stated that the charges against Bello were bailable and exercised her discretion to grant his application.

The court emphasised strict compliance with the bail conditions, warning against any delay in their fulfillment.

World Bank urges People-Centered action to tackle poverty, climate change

he World Bank has called for urgent, people-centred action to address the intertwined challenges of poverty and climate change.

The institution stressed the need for countries to prioritise investments in resilience, adaptation, and lowemission development to mitigate the impacts of these crises.

This recommendation was outlined in the bank's latest report, People in a Changing Climate: From Vulnerability to Action, released on Wednesday, December 18.

The report summarises the findings from the first three years of Country Climate and Development Reports (CCDRs), focusing on the importance of placing people at the heart of climate policy.

The World Bank's findings cover 72 countries and economies and highlight that while climate change poses a threat to all nations, it is poorer populations that are most at risk of long-term, irreversible damage.

According to the report, lowerincome countries could face labour productivity losses of up to 6 per cent by 2050 due to the impacts of climate change, compared to just 0.2 per cent in higher-income nations.

"People are both the most vulnerable to climate change and the most essential in driving solutions," the report states, underscoring the crucial role that individuals and communities must play in mitigating and adapting to climate impacts.



The World Bank advocates for increased investments in education, health, reskilling, labour markets, and social protection to help vulnerable populations adapt to the changing climate.

These investments, the bank argues, will be key in enhancing the resilience of people, communities, and economies. "Placing people at the center of climate-development policies enhances policy effectiveness and fosters more inclusive growth," the report highlights.

The CCDRs also stress the importance of developing resilient infrastructure systems—including power, water, transport, and digital networks—which are essential for both well-being and economic productivity.

Notably, the report identifies significant benefits from improving access to electricity, expanding renewable energy sources, and enhancing public transportation systems. The bank asserts that every dollar invested in resilient infrastructure could yield benefits worth twice the original investment.

The World Bank also pointed to rapid urbanisation as an opportunity to build resilient, low-emission cities capable of driving economic growth. However, the report warned that delaying action on this front could lock countries into unsustainable development pathways.

Despite the urgency for climate action, the report noted that poorer nations are especially vulnerable due to limited capacity for adaptation. For every \$1,000 increase in GDP per capita, climate-induced GDP losses in 2050 could be reduced by 0.5 to 0.7 percentage points.

However, small island nations remain particularly exposed due to their geographic and economic constraints.

In terms of emission reductions, the World Bank maintains that cutting greenhouse gas emissions remains a global priority, particularly for highincome nations and major emitters.

Buhari not owner of seized land by FCT Minister – Aide

ormer President Muhammadu Buhari, through his aide, has reacted to the recent revocation of lands by the Minister of the Federal Capital Territory (FCT), Nyesom Wike, clarifying that the affected land does not belong to him.

The New Daily Prime earlier reported that parcels of land linked to Buhari, the Speaker of the House of Representatives, Tajudeen Abbas, the Secretary to the Government of the Federation, George Akume, and others, were seized due to non-payment for Certificates of Occupancy (CofO).

In a statement released today, Garba Shehu, Buhari's aide, stated that the land in question is not owned by the former president.

He noted that the plot was allocated in the name of the "Muhammadu Buhari Foundation" and not to Buhari personally.



"As with anything Buhari—and there is no surprise in this at all—there is a lot of buzz in the media on the reported seizure of a piece of land by the authorities of the Federal Capital Territory Abuja, FCTA, allegedly belonging to former President Muhammadu Buhari", he said.

Shehu stated that the Foundation was established by some practical-minded individuals around him who, he emphasised, followed lawful procedures with the backing of several well-meaning supporters.

He highlighted that the Foundation faced a major hurdle in the FCDA's land department, which issued them an excessively high bill for the certificate of occupancy—far greater than what was charged to similar organisations.

"It may have been that this was not erroneous, but a deliberate mistake, making the revocation of the land no surprise to anyone.

"As a person, the former President has a plot of land to his name in Abuja. When he and his cabinet members were invited to fill the forms and obtain land during his tenure in office, he returned the form without filling it, saying that he already had a plot of land in the FCT, that those who did not have should be given. He, therefore, turned down the offer."

Shehu encouraged the public to seek accurate information and cautioned against spreading what he described as falsehoods in the digital space.

Ibadan funfair tragedy: police arrest former queen of Ife, others as death toll hits 35

The Oyo State Police Command has confirmed the arrest of former Ooni of Ife's ex-wife, Naomi Silekunola; the Principal of Islamic High School, Ibadan, Fasasi Abdulahi; and six others in connection with the tragic stampede that claimed multiple young lives during a funfair in Ibadan on Wednesday.

Silekunola, identified as the primary sponsor of the event, is among those under investigation.

According to a statement issued on Thursday by the Police Public



Relations Officer, Adewale Osifeso, the death toll from the incident has

risen to 35, with six other children critically injured.

The event, hosted at Islamic High School, Basorun, Ibadan, was reportedly intended for 5,000 children. However, investigations by NEW DAILY PRIME revealed that over 7,500 attendees overwhelmed the venue, leading to the chaotic stampede.

Christmas decorations now luxuries, buyers, sellers lament

the mood at some decorations and gift items stores in Ibadan ,yesterday cannot be described as encouraging.

Basic Christmas decorations have become very expensive as sellers complain of low patronage while buyers lament their reduced purchasing power.

At the popular Dugbe Market, middle aged lady, who identified herself as Ashabi, and sells Christmas decorations, said she now begs and uses various wooing tactics to persuade prospective buyers to purchase even a product.

"The prices of items make people turn their back and walk away. Three or four years ago, I would have been very busy attending to my customers would have had time to be talking to a journalist," she said.

Ashabi said the Christmas trees which is usually in high demand, are now being avoided this season.

"Every year, what we sell the most are Christmas trees and their decorations; by now, we would have lost count of sales recorded. This year, without checking the records, I can give the exact number of Christmas trees we've sold because people are not buying.

"They are not buying because the price has doubled compared to last year," she said.

According to her, a Christmas tree of four feet, which cost N12, 000 in 2023, is now N25,000; while a six-foot tree at N30,000 in 2023, is now N70,000.

"A seven-foot Christmas tree was N40, 000 in 2023, but now, it is N100,



000," she said.

She added that it was sad to see the business she started many years back with Christmas greeting cards struggling to survive.

"We started here by selling all kinds of greeting cards with the whole shop and outside always filled with cards.

"The decline in the purchase of cards made us deviate into other things that have to do with decorations.

"People no longer buy cards as before, which explain why we only have one rack left with greeting cards.

"Major buyers of cards this season are corporate organisations and businesses that want to include the cards in hampers for their customers," she said.

Meanwhile, a seller of hampers, Mrs Ayinke Akinbuola described patronage as 90 per cent less than in 2023.

She added that with the high cost of items put together in the hampers, they have become unaffordable for many.

"A hamper of N5, 000 is now N8, 000 and this is the cheapest you can get; the one of N8, 000 last year is now N12,000.

"The plastic and wooden baskets we use are also now expensive.

"Our profit margin has shrunk because all we make goes back into purchasing the various items making up a hamper," said Bassey.

A customer, Mrs Uche Ibe said she came to buy Christmas hats for her ttwo children to attend their church's Christmas carol.

According to her, she will use the decorations she acquired over the years to decorate her house this season.

"My children insisted on me getting them caps; that's why I'm here today and I'm even surprised that Christmas caps cost as much as N4,000 per one.

"Our government needs to do something about the exchange rate because the prices of items in the market make you question your income and existence," said Bakare.

Meanwhile, Governor Seyi

He disclosed that the primary organisers of the event responsible for the stampede have been taken into custody.

NAFDAC shut down 150 shops, destroy goods worth N5b

In a major crackdown, the National Agency for Food and Drug Administration and Control (NAFDAC) has shut down 150 shops and destroyed fake and expired products worth N5 billion at Eziukwu Market, Aba, Abia State.

The agency disclosed this via its social media page yesterday, stating that the operation was carried out from December 16 to 17,2024.

According to the anti-drug agency, its team discovered large-scale production and distribution of fake and expired goods, terming the market as a hub for counterfeit and substandard products.

The uncovered items are beverages, carbonated drinks, wines, spirits,



vegetable oils, and revalidated food items such as noodles, powdered milk, and yoghurt.

Despite their previous visit to the market leader, who signed an undertaking in 2023, the Director of the South-East Zone, Dr. Martins Iluyomade, expressed shock at illegal activities still going on there. Meanwhile, the Director-General of NAFDAC, Prof. Mojisola Adeyeye, has vowed to continue the fight against illegal activities on public health and provide a permanent solution as the agency reaffirms its zero tolerance to fake and substandard products.

UK supply £225M military aid to Ukraine

Britain on Thursday unveiled a package of £225 million (\$286 million) in new military aid to Ukraine for next year, including drones, boats, and air defence systems.

The move came after the UK's Defence Secretary John Healey visited Kyiv on Wednesday, holding talks with his Ukrainian counterpart Rustem Umerov and vowing to step up British support to Ukraine in 2025.

Three years since Russian President Vladimir Putin ordered the invasion of Ukraine, "the depths of his miscalculation are clearer than ever, as the brave people of Ukraine continue to defy all expectations with their unbreakable spirit," Healey said.

"But they cannot go it alone," Healey added, vowing the UK's support for Kyiv was "ironclad" and Britain would always stand "shoulder to shoulder to ensure Putin cannot win".

In July, the new Labour government vowed to commit £3 billion a year in military aid to Ukraine until 2030-2031.

The new package will include £92 million for equipment to bolster Ukraine's navy, including small boats, reconnaissance drones, and uncrewed surface vessels, the defence ministry said in a statement.

A further £68 million will be used for air defence equipment, including radars, and 1,000 counter-drone electronic warfare systems at a cost of £39 million would be supplied to the Ukrainian army.

Healey said the UK would also boost a training programme for Ukrainian soldiers run with key allies on British



soil known as Operation Interflex, under which 51,000 recruits have been trained since mid-2022.

"With Putin resorting to sending as many as 2,000 Russian soldiers to their deaths on the battlefield each day, it is critical that Ukraine is supported with a supply of properly trained and equipped soldiers," the ministry statement said.

Healey suggested to The Times Daily that UK troops could also be sent to the country to help train Ukrainian forces. Britain needed to "make the training a better fit for what the Ukrainians need," he said, raising the possibility of training to take place in Ukraine rather than Britain as previously.

Asked directly if this meant training Ukrainian troops in Ukraine, he said, "We will look wherever we can to respond to what the Ukrainians want. They are the ones fighting." Umerov thanked the UK for its new package of support and said in a statement that the "stable delivery of ammunition, especially for artillery, is critically important for our defence efforts."

He added the two men had reviewed the results of the use of Storm Shadow missiles without providing details.

London gave Kyiv the green light to launch the UK-supplied, long-range missiles into Russia for the first time in November. Ukrainian President Volodymyr Zelensky was due to meet NATO chief Mark Rutte and key European leaders in Brussels late Wednesday to strategise over Russia's war ahead of Donald Trump's return to power in the United States.

Western backers are seeking to shore up Ukraine's forces as Kyiv's fatigued troops are losing ground across the frontline, and Moscow has deployed North Koreans to the battlefield

Israeli military strikes Yemen hours after Houthi attack targets Israel

srael's military yesterday launched deadly strikes on Houthi targets in Yemen j,ust hours after the Iran-backed militant group's latest attack on Israel.

Nine people were killed and three others injured in Israeli airstrikes on a port and oil facility near the capital Sanaa, said Nasruddin Amer, deputy head of the Houthi media office, in a post on X.

Earlier, Houthi-run Al-Masirah TV said the Israeli strikes targeted the Heyzaz and Dhahban power stations near the capital, and the Hodeidah port and Ras Isa oil facility.

Israel's military said the airstrikes were retaliation for Houthi missile and drone attacks on Israel over the past year, most of which were intercepted.

"Israel's long hand will reach you as well," Israeli Defense Minister Israel Katz said in a warning to Houthi leaders following the strikes.

"Whoever raises a hand against the State of Israel – his hand will be cut off, whoever harms us – will be harmed sevenfold."

Tensions between Israel and the Houthis have escalated for months as Israel wages its war on Hamas in Gaza following the Palestinian militant group's October 7 attacks – with world leaders warning of the potential for a wider Middle East conflict.

Earlier Thursday, sirens were heard in central Israel after the Israeli military intercepted a missile launched from Yemen, the Israel Defense Forces (IDF) said. A school was damaged and no injuries were



reported, the IDF said.

The Houthis later claimed they had achieved their goals in twin missile attacks on Israeli military targets in the Tel Aviv area.

The Houthis have attacked Israel, its allies and vital Red Sea shipping lines in rejection of Israel's military campaign in Gaza that has killed more than 45,000 Palestinians.

The group, which controls Yemen's most populous regions, say they won't stop striking Israel and its allies until a ceasefire is reached in the Palestinian enclave.

In July, the Houthis claimed responsibility for a deadly drone attack in Tel Aviv, Israel's commercial center – the first such strike on the city by the group.

Israel hit back the next day with deadly airstrikes on a Yemeni port in the first such Israeli strike on Yemen, according to Israeli officials.

In September, the Houthis fired a missile deep into Israel, and earlier this month, they claimed to have fired a drone that hit a building in central Israel. No injuries were reported in either attack.

Israel's key ally, the United States has also struck Houthi targets in Yemen multiple times over the past year, including consecutive nights of strikes last month.

Tottenham 4 -3 Man Utd: Spurs secure semi-finals sport in Carabao Cup

Tottenham Hotspur has secured a semi-finals spot in the Carabao Cup after surviving a furious Manchester United comeback with a 4-3 victory in a chaotic tie.

Jonny Evans ensured a nervy finish by heading a third goal for the visitors in stoppage time but Spurs clung on.

Former Tottenham midfielder and now Sky Sports pundit Jamie Redknapp described it as a "masterclass on how not to see a game out" from Spurs.

"I do not know how the manager does it at times, he must be pulling his hair out, but some of the things are his fault, like passing the ball back to the goalkeeper - Forster is the worst player on the pitch with



the ball, so stop giving it to him," Redknapp said.

"Absolute madness at times, but the chaos was so enjoyable."

As for who Tottenham plays in its two-legged semi-final next month, the draw took place shortly after Friday's game, with Spurs to play Liverpool and Arsenal to face Newcastle.

The League Cup semi-final ties will take place over two legs across the week commencing 6 January and the week commencing 3 February.

The big news before kick-off was that Marcus Rashford was not in the United squad just days after he gave an interview saying he is ready for a "new challenge" away from the club.

Amorim dropped Rashford and

Alejandro Garnacho from his squad to face Manchester City last weekend and although Garnacho appeared from the bench against Spurs, Rashford didn't travel to London for the clash.

Tottenham now prepare for this weekend's Premier League fixtures where they welcome Liverpool to North London.

Having drawn each other in the Carabao Cup, it looks like this pair are guaranteed at least four games against each other this season.

This will be a tough test for Ange Postecoglou as he looks to derail the fantastic start Arne Slot has made to life at Anfield.
