Don't link stampede deaths to Tinubu reforms - FG

he Federal Government has warned Nigerians and politicians against politicising and linking stampedes that occurred during food distributions in Oyo, Anambra and Abuja to President Bola Tinubu's economic reforms.

Making the call, the minister Minister of Information and National Orientation. Mohammed Idris, in a statement signed by his media Senior Special Assistant, Rabiu Ibrahim on Monday, said the tragedies underscored the importance of ensuring proper crowd management during such charitable activities, especially in the festive season.

The minister, however, sympathised with the families of those who lost their lives in the tragic incidents which claimed over 70 lives, including about 40 children.

A number of Nigerians, most notably the Labour Party presidential candidate in the 2023 general elections, Peter Obi, had blamed the stampedes on the systemic failures in Nigeria amid widespread hardship in the country.

While acknowledging the



noble intentions of organisers seeking to bring relief to vulnerable members of society, the information minister admonished all individuals and organisations planning similar events to comply with the directive of the Inspector-General of Police, Kayode Egbetokun on liaising with the police formations for effective crowd control and security measures.

He emphasised that collaboration with the police and the National Emergency Management Agency (NEMA) was crucial to safeguarding lives and ensuring that such efforts to assist those in need do not inadvertently lead to further distress.

Idris appealed to politicians and other stakeholders to refrain

from politicising the unfortunate incidents, stressing that those tragic events were in no way connected to President Tinubu's administration's economic reforms.

"It is worth noting that similar unfortunate occurrences have been recorded in the past, before the current administration, as such, making any attempt to link these tragedies to the President's reforms is unfounded and disingenuous," he said.

Idris said the reforms, while repositioning the Nigerian economy for sustainable growth, were designed to uplift the lives of all Nigerians, particularly the vulnerable without causing distress.

Tinubu stands firm on tax reform, says 'no going back'

resident Bola Tinubu has doubled down on his administration's controversial tax reform bills. declaring that there will be no reversal despite widespread opposition.

Speaking during his maiden presidential media chat on Monday night, Tinubu defended the reforms as essential for Nigeria's economic revival, asserting that the nation cannot rely on outdated systems.

"Tax reform is here to stay. We cannot continue with the practices of the past in today's economy. Revitalizing this economy requires abandoning old, broken methods," Tinubu stated.

"I believe I have the capacity to lead this change—that's why I ran for office. This is not about instant gratification, but a new dawn for Nigeria, and I am fully



committed to it."

The reforms, introduced on October 3, were submitted to the National Assembly as four separate bills. However, they have sparked heated debates, particularly in the Northern region, where resistance has been strongest.

Despite calls from the National Economic Council (NEC) for Tinubu to withdraw the bills to allow for further consultations, the president remains resolute, insisting that the legislative process must proceed

uninterrupted.

"This is about what Nigeria needs, not about short-term comfort," Tinubu emphasised during the broadcast.

The reforms mark a significant step in Tinubu's broader economic agenda, which has already drawn both praise and criticism, particularly following his controversial removal of the petrol subsidy earlier this year.

Restrictions on palliatives distribution will discourage charity, says Obi

ormer Anambra State Governor Mr Peter Obi has faulted the Inspector General of Police (IGP), Kayode Egbetokun, for imposing restrictions on the distribution of palliatives to the lessprivileged.

The New Daily Prime earlier reported that Egbetokun directed palliative distribution organisers to involve security agencies and strictly adhere to crowd and safety management protocols.

This directive came in response to multiple stampedes during the distribution of food items in Oyo, Anambra, and Abuja, which led to several deaths and injuries.

In a statement shared on his X page today, Obi expressed concern over the directive, describing it as disturbing despite being a timely response to recent tragedies across the country.

The 2023 presidential candidate of the Labour Party (LP), further



noted that while the IG's reaction acknowledges the challenges posed by the prevailing economic hardship, the directive is prone to abuse.

Obi cautioned that Egbetokun's actions could discourage citizens from assisting the hungry and distressed Nigerians.

"While I understand the need for better organization and more attention to public safety, it is important to clarify that acts of goodwill should not be hindered by excessive bureaucracy.

"Rather than requiring people to seek permission to assist those in need, we should encourage them to find better, more organized ways to offer such help. The focus should be on promoting coordination, not imposing barriers that could deter muchneeded acts of kindness in a time of widespread hunger, pain, and anger", Obi added.

Also, Obi stressed that this was not the time to suppress the spirit of compassion and generosity among Nigerians.

He stressed that the government must take more decisive action to address the root causes of this hardship, offering lasting solutions instead of hindering those who are stepping in to bridge the gaps caused by its insensitive policies.

"Instead, let us channel these efforts constructively, ensuring that help reaches the most vulnerable safely and efficiently.

Finance Minister unveils anti-poverty plans

o drive Nigeria's economic growth and reduce poverty, the Minister of Finance and Coordinating Minister of the Economy, Wale Edun, has introduced an ambitious economic plan for sustainable development.

In a statement issued by the Ministry's Director of Information and Public Relations, Mohammed Manga, the Minister announced a №50 trillion budget for 2025, focused on strategic investments and extensive reforms.

Speaking during the Citizen and Stakeholder Engagement session held at the Ministry's Auditorium in Abuja, Edun underscored President Bola Tinubu's dedication to economic reforms aimed at achieving sustained and inclusive growth.

The overarching goal, he emphasised, is to lift millions of Nigerians out of poverty.

To achieve this, the government has implemented subsidy reforms that have



stabilized the macroeconomic environment, reducing the fiscal deficit to 4.4 per cent and the debt service-to-revenue ratio from 149 per cent in 2023 to 67 per cent.

Edun also highlighted a significant boost in Nigeria's foreign reserves, which have grown to \$42 billion.

The plan focuses on key sectors such as Energy, Agriculture, Industry, and Social Protection. Investments in compressed natural gas, LPG, and renewable energy are advancing, while large-scale farming programs aim to enhance food security.

Moreover, Nigeria is

capitalising on its thriving digital economy, with local startups dominating Africa's unicorn landscape.

Looking forward, the government projects a №50 trillion budget for 2025, with anticipated revenue of №35 trillion—nearly double the 2024 figures. To drive economic growth, the government is targeting \$20 billion in investments by 2027.

This robust economic plan positions Nigeria to achieve sustainable growth, reduce poverty, and significantly improve the quality of life for its citizens.

Switch off to save, Tinubu calls for smarter energy use By Friday Omosola

President Bola Tinubu has encouraged Nigerians to adopt better energy management practices to reduce their rising electricity bills.

"It's not a negative thing to learn to manage resources. Control your electricity bill by switching off lights when not in use. Let's embrace a culture of prudent management," Tinubu stated during a conversation with reporters on Monday.

The president, who is also a prominent figure in the All Progressives Congress (APC), dismissed the idea of implementing price controls to ease economic pressure.

"I don't believe in price control. Instead, we will focus on increasing supply to meet market demands," he added.



Since Tinubu's inauguration in May 2023, Nigerians have faced escalating energy costs due to the removal of petrol subsidies and significant electricity tariff hikes. Petrol prices have surged from under N200 per litre

to over N1,100 in several areas, while the naira has plummeted from approximately N700/\$ to N1,600.

In April 2024, the Nigerian Electricity Regulatory Commission (NERC) raised tariffs for Band A customers from N66 to N225 per kilowatt-hour, a move that sparked widespread criticism given the economic strain on citizens.

Coupled with soaring food and commodity prices, these developments have plunged the country into what many describe as the worst cost-of-living crisis since independence.

However, Tinubu maintains that these reforms are essential to laying the foundation for long-term economic prosperity.

Hunger epidemic sparks stampedes, LP tells Tinubu

he Labour Party (LP) has expressed serious concern over the recent stampedes that claimed many lives in separate incidents in Oyo, Anambra, and the Federal Capital Territory (FCT), Abuja.

Umar Farouk, LP National Secretary described the tragic events as a grim reminder of the hunger crisis ravaging the country, calling it "a silent epidemic more devastating than any natural disaster."

"These stampedes highlight the extreme hunger and desperation gripping Nigerians. Hunger is proving to be the deadliest epidemic we face, more so than any natural calamity," Farouk lamented.

He referenced recent data from the World Bank and the National Bureau of Statistics(NBS) to illustrate the dire situation.

According to him, the data stated that Nigeria's poverty rate has risen to 40.7 per cent, with an estimated 87 million Nigerians living below the poverty line—making the country home to the secondlargest poor population globally after India.

Farouk added that rising inflation, poor economic management, and recent economic reforms under the



President Bola Tinubu -led administration have exacerbated the crisis.

He further pointed out that hunger-driven tragedies extend beyond stampedes.

"Desperate Nigerians have been scooping fuel from accident sites, leading to deadly infernos, and resorting to crime, including kidnapping.

"A survey revealed over 2 million Nigerians were kidnapped in the last year, with \$1.42 billion paid in ransom—a stark indication of worsening socioeconomic conditions."

Farouk urged the government to prioritise food production, utilize Nigeria's vast arable land, and revive the aquatic economy.



"We implore the government to scale down its 2025 agenda and redirect resources towards addressing hunger and poverty. Over 70 per cent of Nigeria's land remains underutilized, and our agricultural and fisheries sectors are in shambles," Farouk stated.

He also reminded the government of its constitutional duty to protect lives and property.

"The daily survival struggle of Nigerians has become a matter of life and death. While kidnappers claim lives with impunity, others perish while scrambling for food to survive. The government must act decisively to end this crisis. Enough is enough."

Peter Obi criticises IG's directive on palliative distribution

ormer presidential candidate Peter Obi has voiced strong concerns over the recent directive from the Inspector General of Police (IGP) that imposes restrictions on the distribution of palliatives to the less privileged. Obi described the move as "disturbing" and warned it could hinder acts of generosity and exacerbate the suffering of vulnerable Nigerians.

In a statement shared on X.com (formerly Twitter) on Monday, Obi acknowledged that the directive aimed to address safety issues following tragic incidents linked to the distribution of palliatives.

He went on to argue that the directive could stifle goodwill, stating, "It is capable of discouraging citizens



from helping the hungry and distressed among us."

While Obi expressed understanding of the need for better organisation and attention to public safety, he cautioned against excessive bureaucracy that could impede the willingness of Nigerians to offer help.

"Rather than requiring people to seek permission to assist those in need, we should encourage them to find better, more organized ways to offer such help," he suggested.

Obi stressed the importance of promoting coordination and collaboration rather than imposing barriers, urging the government to focus on addressing the root causes of Nigeria's economic hardship.

He added, "This is not the time to stifle the spirit of compassion and generosity among our people. Instead, let us channel these efforts constructively, ensuring that help reaches the most vulnerable safely and efficiently."

In his statement, Obi also called on the government to provide lasting solutions to the economic crisis. rather than creating obstacles for those attempting to alleviate the suffering caused by government policies. He urged the IGP to reconsider the directive and work with the public to alleviate the hardships Nigerians are facing.

"The government must also do more to address the root causes of this hardship, providing lasting solutions rather than creating obstacles for those stepping in to fill the gaps created by the government's insensitive policies," Obi concluded.

Tinubu attributes stampedes to lack of organisation, discipline

President Bola Tinubu has attributed the recent deadly stampedes in Oyo, Anambra, and Abuja to poor organisation and indiscipline during palliative distributions.

During his inaugural media chat on Monday, Tinubu stressed the importance of better organisation during such events and called for greater discipline within society.

"It is truly unfortunate that events like these are poorly organized. We must adopt a more disciplined approach in our society. My condolences to those who have lost loved ones," Tinubu said, expressing sorrow over the tragic incidents that claimed multiple lives.



While acknowledging the importance of charity, the president shared his long history of charitable acts, highlighting that he had never encountered such tragedies due to careful planning.

"It's important to give back, and I've been distributing food and goods for over 25 years. But I've never faced such an incident because everything was organized and disciplined. If you don't have enough to give, it's better not to publicize it," Tinubu remarked.

The stampedes in Anambra and the Federal Capital Territory (FCT) on Saturday resulted in several deaths and injuries, prompting the Inspector General of Police to urge organisers of similar events to collaborate with security agencies and adhere strictly to crowd and safety management guidelines.

The tragic events followed another devastating stampede in Ibadan, where 35 children lost their lives during a funfair just days earlier.

Ibadan Stampede: Obi urges release of ex-queen Naomi

eter Obi, the 2023 presidential candidate of the Labour Party (LP), has called for the release of Naomi Silekunola, the former queen of the Ooni of Ife and organiser of the funfair that led to the stampede in Ibadan, Oyo State.

Earlier, The New Daily Prime reported that Naomi, along with seven others, was arrested following the stampede at a funfair held at Basorun Islamic High School in Ibadan.

The incident resulted in the death of 35 children. Naomi was hospitalised after her arrest.

In a statement shared on his X page yesterday, Obi expressed that the exqueen should not be vilified for her humanitarian efforts, even if the funfair unintentionally led to the unfortunate incident.

He emphasised that the event was



initiated to ease the hardships faced by the people and provide relief.

The 63-year-old further stated that accountability for such tragedies should start with the leaders and policymakers whose collective actions—or inactions—have exacerbated the suffering and hardship in society.

"It is the systemic failure of governance, not the efforts of wellmeaning individuals, that should be scrutinized", the Anambra-born politician said.

Obi stressed that Nigerian leaders must come together to reassess the nation's direction and prioritise policies and actions that improve citizens' lives.

He also called for a shift in focus toward building a system where no citizen is left struggling for necessities.

"In doing so, we can begin to rebuild trust and ensure that tragedies like these are not repeated. While still in mourning mood over the precious lives lost due to tragic incidents stemming from the distribution of palliatives.

"I am deeply pained that such occurrences are a reflection of the severe hunger and poverty currently ravaging our nation. My heartfelt condolences go to the affected families, communities, and states."

Governance costs won't shrink my cabinet, says Tinubu

President Bola Tinubu has ruled out reducing the size of his cabinet as part of efforts to lower the cost of governance.

Speaking during his inaugural Presidential Media Chat on Monday, the president defended his decision to maintain over 40 ministers along with several advisers and assistants.

"I am not ready to reduce the size of my cabinet," Tinubu stated when asked about possible measures to cut governance expenses, emphasizing the necessity of his extensive team.

Furthermore, he declared that he sees no need to investigate military operations across the country.



Tinubu acknowledged the possibility of financial leakages but expressed confidence in the military's prudent use of allocated funds.

Currently, Nigerian troops are deployed in over 30 states to tackle various security challenges.

Additionally, President Tinubu signalled his readiness to make concessions to resolve issues surrounding the contentious tax bills before the National Assembly.

Tinubu acknowledged the need for negotiations, particularly regarding concerns over the VAT component.

"Tax amendments require discussions and concessions, and I am open to that," Tinubu said, addressing the controversies that have drawn criticism, especially from northern leaders, including members of his party.

The proposed tax bills, currently under review, have sparked significant debate nationwide.

Bayelsa gov signed N689.4bn 2025 budget into law

Bayelsa State Governor, Douye Diri, has signed the 2025 budget of N689.4 billion, titled the "Budget of ASSURED Prosperity," into law.

In October, The New Daily Prime reported that Mr Diri presented the budget to the State House of Assembly, highlighting his administration's plans for enhanced socio-economic and infrastructural development.

The governor announced the signing in a statement shared on his X (formerly Twitter) page, noting that his deputy, Lawrence Ewhrudjakpo, and other top government officials were present at the signing ceremony.

Bayelsa State Governor, Douye Diri sogning into law the 2025 budget of N689.4 billion, titled the "Budget of ASSURED Prosperity."

"This afternoon, I signed into law a budget of six hundred and ninety nine billion, five hundred and seventy three



million, one hundred and sixty seven thousand, five hundred and ninety two Naira (N699, 573,167,592.00) only for 2025 as passed by the Bayelsa State House of Assembly.

"I wish to appreciate Mr. Speaker, Rt. Hon. Abraham Ingobere, the Principal Officers and other members of the State House of Assembly for their diligence in the timely passage of the Appropriation

bill", said the governor.

Diri further emphasised his administration's dedication to transparently implementing the budget to drive economic growth, create jobs, generate power, and complete ongoing legacy projects across the state.

SERAP criticises N8.7bn travel budget for Tinubu, Shettima in 2025

he Socio-Economic Rights and Accountability Project (SERAP) has condemned the proposed N8.7 billion travel budget for President Bola Tinubu and Vice President Kashim Shettima for the year 2025, calling for a reduction in the budgets for both the Presidency and the National Assembly.

SERAP has urged Senate President Godswill Akpabio and House of Representatives Speaker Tajudeen Abbas to slash the allocations, which amount to N9.4 billion for the Presidency's travel, meals, and catering expenses, as well as N344.85 billion for lawmakers.

In a letter dated 21st December 2024, signed by Deputy Director Kolawole Oluwadare, SERAP requested that the National Assembly ask President Tinubu to submit a new supplementary appropriation bill that reflects lower allocations for the Presidency and the legislature, in light of Nigeria's current economic challenges.

The organisation warned that any unnecessary expenditure by both the Presidency and the National Assembly would violate the Nigerian Constitution (1999, as amended).

SERAP also stressed that it would be a serious breach of public trust for lawmakers to approve such lavish spending for themselves and the Presidency amid the country's growing budget deficit.

"Any proposed unnecessary spending by the Presidency and the National Assembly would amount to a fundamental breach of the Nigerian Constitution," the letter stated.

"It would be a grave violation of the public trust and constitutional oath of office for the members of the National Assembly to approve unnecessary spending for themselves and the Presidency."

SERAP also demanded a detailed breakdown of the National Assembly's proposed N344.85 billion budget, asking for clarity on personnel costs, salaries, and



allowances. The group further urged lawmakers to summon heads of ministries, departments, and agencies (MDAs) identified in the 2021 audit report by the Office of the Auditor-General for the mismanagement of public funds.

The group criticised the proposed N8.7 billion allocated for the travel expenses of President Tinubu and Vice President Shettima, with the Office of the President requesting N7 billion for travel and transport, while the Vice President's office allocated N1.73 billion.

The proposed budget also includes N546.2 million for catering materials and refreshments, N87.5 million for honoraria and sitting allowances, and N79.6 million for drugs and medical supplies.

Highlighting the increased expenditure, SERAP pointed out that the Presidency's budget for "rehabilitation and repairs of fixed assets" had increased sharply from N14 billion in 2024 to N26 billion in 2025.

The group expressed concern that many Nigerians would find such spending "odd, unfair, and unjust," particularly in the midst of a public borrowing crisis.

"Many Nigerians will find it quite odd, unfair, and unjust that the government and lawmakers are spending so much money on many of these items in the middle of a public borrowing crisis," SERAP remarked.

The organisation reiterated the need for

greater transparency in the National Assembly's proposed budget and urged lawmakers to demand accountability from MDAs linked to the mismanagement of public funds.

SERAP stressed that holding these bodies accountable for the reported mismanagement of billions of naira would help tackle corruption within the public sector.

In its letter, SERAP reminded lawmakers of their constitutional responsibility to prioritise the welfare of citizens, emphasising that the National Assembly must ensure responsible spending of public funds.

"The proposed spending figures by both the Presidency and the National Assembly highlight the lack of political will to cut the cost of governance," the group stated.

SERAP concluded by calling on Akpabio and Abbas to set an example by cutting unnecessary spending and acting in the best interest of Nigerians, arguing that reducing wasteful expenditures would help address the country's budget deficit and mounting debt issues.

"Cutting waste and apparently unnecessary spending would go a long way in addressing the budget deficit and debt problems," the organisation affirmed.

Tanker drivers decry poor road conditions, exclusion from CNG Scheme By Gbenga Oluranti OLALEYE

he Petroleum Tanker Drivers (PTD) branch of the Nigeria Union of Petroleum and Natural Gas Workers (NUPENG) has called on the Federal Government to address the poor state of federal highways and its exclusion from the ongoing Compressed Natural Gas (CNG) scheme.


In a communiqué issued after their quarterly National Executive Committee meeting in Benin City, Edo State, the union expressed frustration over the continued delays in critical road repairs, despite significant budget allocations.

They also criticised their exclusion from the CNG initiative, which aims to provide affordable fuel alternatives to reduce costs for transporters.

The communiqué, signed by National Chairman Augustine Egbon and National Secretary Oluchi Chinagorom, acknowledged the government's commitment to road repairs but urged for immediate action to mobilise contractors before the peak of the rainy season.

"We commend the Federal Government for prioritising the repair of federal highways to make them safer and reduce the burden on transporters. However, we urge immediate action to ensure contractors are mobilised before the peak of the rainy season," the statement read.

The union highlighted key budget allocations, including N42.4 billion



approved in June for road variations and N740 billion approved in October for the repair of the Berger stretch of the Abuja-Kano route.

They also referenced N621.2 billion allocated in 2021 under the Road Infrastructure Tax Credit Scheme.

"Having shown a commitment to fixing roads, unlike its predecessor, we urge the Federal Government to walk its talk. Unnecessary delays could lead to complications during the rainy season. A stitch in time saves nine," the communiqué emphasised.

The PTD-NUPENG also listed several critical federal roads in urgent need of attention, including the Shagamu-Benin road, Makurdi-Katsina-Ala road, Kachako-Dambazua road in Kano, Yola-Hong-Mubi road in Adamawa, Okene-Auchi-Benin road, Lanai-Agai-Bida road, and the East-West road from Benin-Warri to Port Harcourt.

In addition to road issues, the union

expressed concern over its exclusion from the CNG scheme, which aims to provide affordable fuel alternatives for vehicles.

"Tanker drivers, as key players in the downstream oil and gas sector, have been excluded from the CNG scheme.

CNG kits are not just for smaller vehicles; tankers also require cheaper fuel alternatives to operate efficiently," the communiqué stated.

The PTD-NUPENG concluded with a call for the Federal Government to fulfil its commitments to road rehabilitation and integrate tanker drivers into the CNG scheme, stressing the vital role of tanker drivers in the nation's petroleum product distribution network.

The union's demands reflect the sector's ongoing struggles with poor infrastructure and rising operational costs, which they argue could be mitigated with the right interventions.

Troops neutralise 13 IPOB members, nab three kidnappers in Southeast

In a decisive operation aimed at curbing insecurity, soldiers in Southeast Nigeria successfully neutralised 13 members of the proscribed Indigenous People of Biafra (IPOB) and apprehended three suspected kidnappers during a series of tactical operations across the region.





TikToker SeaKing granted bail

agos State Magistrate Court sitting in Ogba today granted bail to popular TikToker, Olumide Ogunsanwo, known as SeaKing.

The New Daily Prime earlier reported that the social media influencer was accused of treason, cyberstalking, conduct likely to cause a breach of peace, and provoking a breach of peace.

The charges stemmed from claims that SeaKing called on Nigerian youths to "wage war" against the police.

The Nigeria Police, through its remand application, sought to keep SeaKing in custody for 30 days pending advice from the Directorate of Public Prosecutions (DPP).

In an X post on Monday, Counsel to the defendant, Inibehe Effiong disclosed that the court ruled

against the application, citing insufficient probable cause.

The proceedings took an unexpected turn earlier in the day when SeaKing's lawyer, Effiong, and his colleague, Jeremiah Okoro accompanied the social media influencer's wife, and their six-month-old baby, visited the State Police Command in Ikeja.

Despite their visit, they were denied access to him.

While waiting to meet the Commissioner of Police to raise their grievances, they discovered that SeaKing had been secretly transferred to Ogba Magistrate Court for remand proceedings.

Acting swiftly, the legal team proceeded to the court, where they opposed the police's remand application and argued for his release on bail.

They relied on Section 264 (5) of the Administration of Criminal Justice Law of Lagos State, which allows for bail under such circumstances.


The magistrate upheld the defence's argument and admitted SeaKing to bail on liberal terms.

He is to provide a bond of N500,000 with two sureties of the same amount. One of the sureties must be a family member, while both must reside in Lagos State and be gainfully employed.

The case has been adjourned to January 16, 2025, for the DPP's report.

SeaKing's legal team has expressed confidence in proving his innocence as the matter progresses.

"I don't care what anyone thinks. See, talking about the fear part of it – you

can't talk like that and win Oscars. You can't talk like that and party. You can't say that in this town," Washington added.

he founder of the Salvation Proclaimers Anointed Church (SPAC Nation), Pastor Tobi Adegboyega, has caused a stir by referring to Nigerian music sensation David Adeleke, better known as Davido, as a "gospel artist."

During a recent appearance on the Off The Record podcast, which began trending on Monday, Adegboyega explained that the term "gospel" simply means "good news," and he believes Davido exemplifies this with his music.

The flamboyant pastor's comments were made in response to the criticism he faced over his decision to invite secular musicians to perform at his recent birthday celebration, instead of gospel artists.

The pastor further clarified his stance, asserting that, in his view, everyone in attendance at his events, including Davido, is a "gospel artiste." "Gospel means

In his response to critics within the gospel music community, Adegboyega expressed frustration with those who were quick to judge his decisions. "If gospel artists aren't my friends and are instead joining the bandwagon to criticise me by asking, 'Is that a church?' What should I do? Drag them with a rope?" he questioned.

The pastor went on to highlight his close relationship with several secular artists, including Nigerian musician Zlatan, whom he referred to as his "son." "Zlatan is like a son to me; his kids are my kids, and his parents are in my house," he said.

A degboyega defended his relationships with these musicians, suggesting that the criticisms of his choices were misplaced.

He further emphasised that his personal friendships would always take precedence in his decisions regarding event performances. "My friends will always sing at my events, and the next one will be bigger because my circle of friends keeps growing," he stated.

Nigerians in S'Africa kick as killers of 37-yr-old national granted bail

Africa, under the aegis of the Nigerian Citizens Association in South Africa (NICASA) have expressed disappointment over the decision of a court to grant bail to South Africans arrested in connection with the killing of a 37-year-old Nigerian man identified as Julius Chukwunta.

According to SaharaReporters, the President General of NICASA, Frank Onyekwelu, on Sunday said that despite their objection to the court's decision on the grounds that the four suspects are a flight risk and might run away, the court ignored their objection and granted three of the suspects bail, while it asked the fourth suspect to officially apply for bail.

Onyekwelu dislosed that on Saturday, December 7 while the deceased, Chukwunta was returning to his residence in Protea Estate Midrand, some men blocked the driveway.

Onyekwelu said, "He approached them requesting to be allowed access to pass through but was met with strong resistance.

"He then left the guys and started approaching the security office in the complex to assist him in addressing the situation; it was at this instance that four guys pounced on him, attacked and left him bleeding with a heavy injury on his skull."

Onyekwelu said Chukwunta's partner, who was sitting in the car hurried towards the security office only to find him bleeding on the ground.

"She called for help both from the complex residents and the security office but none could offer any



assistance to help Mr Juluis, or to call the police or ambulance.

"She ended up calling her father after an hour of struggling without getting any help. Her father and other members of her family came and took him to the nearest hospital – Tembisa General Hospital where he was placed on oxygen life support due to excess loss of blood and severe injury on his head.

"On Tuesday 10th December 2024, Mr Juluis Friday Chukwunta (37yrs) succumbed to his injuries and died at Tembisa General Hospital. He hails from Aninri, Enugu State Nigeria."

He said that following Chukwunta's death, a case of murder was opened by his partner with case no. 262/12/2024 at Midrand Police Station and the investigation team worked on the case, leading to the arrest of four male suspects aged 20, 24,27 and 28.

He said, "Their first appearance in court was on Friday, 13th December 2024 where they were charged with murder at Alexandra Magistrate Court. The case was postponed to Wednesday, 18th December 2024.

"NICASA national executives visited the residence of late Mr Julius Chukwunta in Midrand on Sunday, 15th December 2024 where they met with the partner, her elder sister and mother.

"A condolence message was conveyed to the family, we received from the family first-hand information on what transpired on that fateful day as narrated above.

"NICASA leadership assured them of our commitment in ensuring that the bereaved family gets justice and the culprits will face the full might of the law.

"Furthermore, NICASA leadership called the family of the deceased in Nigeria to comfort them over their loss, we spoke to the brother of the deceased.

"NICASA learnt that the mother of late Juluis is still in hospital on health challenges and that the family is going through a traumatic moment.

"The leadership of NICASA assured them of full commitment over this matter and promised to bring it to the attention of our Consulate and High Commission."

Onyekwelu said on December 18, NICASA national executives were at Alexandra Magistrate Court to observe court proceedings as the four accused persons came to apply for bail.

Honda, Nissan enter merger talks to compete with Tesla, EV rivals

The two companies confirmed that they plan to list the newly established holding company on the Tokyo Stock Exchange by August 2026, a move that would give them a stronger financial foothold to rival their international competitors.

The listing will be a "technical listing," marking a significant milestone for the merger talks and the companies' broader goals in the automotive industry.

The merger comes at a time when both Honda and Nissan are striving to increase their presence in the electric vehicle sector, where they have faced intense competition from Tesla and Chinese automakers, which have been at the forefront of EV innovation.

This joint venture is expected to pool resources, technology, and production capabilities, enabling the companies to enhance their EV offerings and streamline operations.

The agreement signals a major shift in the Japanese auto industry's strategy as it seeks to adapt to the global rise of electric vehicles and maintain its competitiveness against Tesla, which has solidified its dominance in the EV space, and other fast-growing competitors from China.

As of now, further details of the potential merger and the structure of the joint holding company are still under consideration, with more announcements expected in the coming months.
