# Alleged Defamation: We can't debar Farotimi, LPDC tells Afe Babalola

he body responsible for sanctioning errant lawyers and maintain sanity and discipline among lawyers, the Legal Practitioners Disciplinary Committee, (LPDC), has adduced reasons why it cannot revoke the licence that allows the embattled. controversial author and activist, Dele Farotimi, to practice law in Nigeria.

The legal body held that it lacked the requisite jurisdiction to delve into issues relating to the allegation of criminal defamation and professional misconduct, which were brought against Farotimi by the law firm of Chief Afe Babalola, Emmanuel Chambers.

The law firm had, in its petition, urged the LPDC to debar Farotimi by removing his name from the roll of legal practitioners in the country.

In the 90-page petition dated December 6 and signed by a partner in the firm, Mr. Ola Faro, it was alleged that Farotimi violated certain provisions of the rules of professional conduct for lawyers in his contentious book titled "Nigeria And Its Criminal Justice System."

Specifically, Farotimi was accused of acting in breach of Rules 1, 15(1), 15(2b), 15(3a), 15(3g), 15(3i), 15(3j), 26(1), 27(1), 30, 31(1), (2) and (4) of the Rules of Professional Conduct 2023 "by bringing the entire judiciary in Nigeria into disrepute with his unfounded allegations of corruption against eminent justices of the Supreme Court of Nigeria, judges of the High Court of Lagos State, Aare Afe Babalola, SAN, Olu Deramola, SAN, and Ola Faro, Esq., and the entire chambers of Afe Babalola & Co. in his book."

Insisting that Farotimi engaged in conduct that was unbecoming of a legal practitioner by making false accusations against the Supreme Court and the legal profession, the petitioners further alleged that he participated in unlawful conduct by bribing judicial officers and gaining unlawful access to a judicial officer.

"He joined his clients in committing misconduct and breach of law with



reference to judicial officers by having unlawful access to a judicial officer. He gave service to his client, which he knows is capable of causing a breach of law and disrespect and corrupting a judicial officer. He knowingly made a false statement of law and facts with respect to a case already decided by the Supreme Court.

"He assisted his clients in a conduct that he knows to be illegal and fraudulent. Knowingly engaged in illegal conduct in the course of his practice as a legal practitioner. Treated his fellow lawyers without respect, fairness, consideration, and dignity, allowing ill feelings between opposing clients to influence his conduct and demeanour by distorting the facts of a case in the cause of his practice as a legal practitioner.

"Failed to observe good faith and fairness in dealing with other lawyers in respect to a case already decided by the Supreme Court. Conducted himself in a manner that obstructed, delayed, and adversely affected the administration of justice by taking steps to frustrate a decision of the Supreme Court for his personal benefit and the benefit of his client, who lost at the Supreme Court.

"Treated the court, particularly the Supreme Court, without respect, dignity, and honour by using uncouth, unprofessional, undignified, and offensive language against the Supreme Court and the justices of the Supreme Court. Made defamatory statements

against judicial officers rather than making a complaint to appropriate authorities."

It was the contention of the petitioners that the author "indicated that he discussed a pending case with a judge trying the case in the absence of an opposing lawyer. The contravention of these rules by the Respondent (Farotimi) prompted this petition to protect the dignity of the legal profession and the dignity of the court as the temple of justice and to uphold the standards of the legal profession."

They further noted that some statements in the book had the potential to inflame the legal profession and society, maintaining that the corruption allegations were made to discredit the Nigerian judiciary and to subject the law firm to ridicule so as to damage its hardearned reputation and financial standing.

However, the LPDC, in its report marked B8B/LPDC/1571/2024, said it was satisfied that all the offences that were listed by the petitioners occurred in Farotimi's capacity as an author and not during his practice as a legal professional.

The LPDC said it was bereft of the jurisdiction to address complaints about publications, even as it enjoined the aggrieved parties to seek redress in regular courts.

# FG distributes foods to less-privileged, women families in Abuja

he Federal Government has officially lifted the ban on mining exploration in Zamfara State, signaling a significant shift in its approach to economic development and security in the region.

This decision follows a comprehensive review of the security situation across the state, which has long grappled with issues of banditry and instability.

In a statement issued on Sunday by Segun Tomori, the Special Assistant on Media to the Minister of Solid Minerals, Dele Alake, the government announced that the prohibition on mining activities, which had been in place since 2019, has been rescinded.

This comes after an assessment by President Bola Tinubu and the National Security Adviser, who determined that the security environment in Zamfara has improved sufficiently to allow for the resumption of mining operations.

The ban on mining in Zamfara was first imposed in 2019 under former President Muhammadu Buhari's administration.

The measure was aimed at curbing the escalating insecurity in the state, as mining activities were believed to be fueling banditry and violent crime. Two years later, in 2021, the government declared Zamfara a "nofly zone," further restricting movement and economic activities in an effort to combat the crisis.

However, the latest evaluation by security agencies has led to the conclusion that conditions in the state have improved, prompting the Federal Government to reverse its earlier stance.

Dele Alake emphasized the economic



potential of Zamfara, describing the state as a treasure trove of mineral resources, including gold, lithium, and copper. The resumption of mining activities is expected to not only boost the local economy but also contribute significantly to Nigeria's overall revenue generation.

The statement read, "The Federal Government has lifted the ban on mining exploration activities in Zamfara State, citing significant improvements in the security situation across the state.

"This decision underscores the government's commitment to revitalizing economic activities in a state endowed with vast mineral wealth. The proper harnessing of these resources will provide jobs, stimulate local businesses, and increase the country's foreign exchange earnings."

Industry stakeholders and experts have welcomed the decision, describing it as a long-overdue step that could unlock the state's economic potential.

Many believe that Zamfara, with its abundant gold and other valuable minerals, could emerge as a key player in Nigeria's mining sector if the industry is properly regulated and

security challenges remain under control.

Nevertheless, concerns linger about the security implications of resuming mining in the state. Critics argue that unless strict monitoring and regulatory measures are implemented, mining activities could once again attract criminal elements, undermining the progress made.

In response, Alake assured that the Federal Government has devised a robust framework to ensure that mining in Zamfara is conducted safely and transparently. He stated that collaboration with local communities, security agencies, and stakeholders in the mining sector would be a cornerstone of the new approach.

The lifting of the ban represents a crucial test of Nigeria's ability to balance economic development with security concerns, especially in resource-rich regions like Zamfara. As the state prepares to welcome mining companies back, the hope is that this move will not only rejuvenate its economy but also sustain the hardwon stability that made it possible.

## Oyo residents face bleak Christmas as food prices soar

head of tomorrow's Christmas celebration, many residents of Oyo State are groaning under the weighty burden of escalating food prices in the state ,as many of them may end up having a bleak ceremony.

When The New Daily Prime visited some of the popular markets in the state today, it was discovered that prices of various products, including grains and staple food items have hit the roof top.

Many residents also lamented their inability to afford basic food items needed to celebrate Christmas with their families.

The prices of food items such as rice, beans, yams, garri, and noodles had actually quadrupled in the last few days.

At key markets like Oja Oba, Molete and Oje, a 50kg bag of foreign rice which previously sold for about N80,000, now costs between N90,000 and N100,000.

Similarly, a local measure of eight cups of beans now goes for N1,000 to N2,500, while a measure of garri, which was N1,200, has increased to about N1,400.

The price of chickens has also skyrocketed, with those previously sold for N4,000 to N5,000 now selling as much as N12,000, N15,000, or even N35,000.







The high inflationary trend has created palpable tension across many markets in the State.

When the New Daily Prime visited some of markets, the general mood was far from being festive and celebratory, as many stall owners were idling away for lack of consumers. Even those who had buyers, had a tough time convincing them to purchase their needed products.

Some residents who spoke with the New Daily Prime attributed the price hike to rising costs at storage depots, high transport fare, and other economic factors.

Sekinat Olajire, a chicken vendor, described this year's Christmas as the worst she had ever experienced. She lamented the poor patronage experienced, blaming it on the high cost of poultry products, which has deterred many families from purchasing the chicken for the festive season.

"Christmas is a pleasant

celebration, but the market is dull At this time, people should be trooping in to buy chickens, but that's not happening because many now rear chickens in their homes.

"We implore people to buy from us. We've even reduced the price from  $\aleph$ 25,000 to  $\aleph$ 15,000, yet people still complain that they are expensive. Our chickens are big. Last year, we sold one for  $\mathbb{N}4,000$ , but now it's  $\mathbb{N}8,000$ , №15,000, or more," Sekinat said.

She therefore urged the President Bola Tinubu - led Federal Government overnment to address the issue of rising cost of commodities, emphasising that Nigerians were dying of hunger.

"The government should help us. People want to buy and eat chicken, but they don't have money. If you want to cook a good pot of soup now, you need nothing less than N50,000. Fish is not cheap just like other ingredients", she added.

Fagbolade Jibola, the Secretary of the Park Management Service (PMS) under the Oyo state government, lamented that insecurity and the surge in petrol prices have significantly impacted negatively on the cost of foodstuffs and other essential items.

He stated that people can barely afford food, let alone the cost of boarding tricycles, leaving many to abandon such means of transport.

"People aren't moving, drivers are crying, and the cost of fuel is high. Right now, I can't send as much as I did last year, because I don't want a situation where chicken sellers and dealers in other products will be calling for their money.

Nothing is working. The government should reduce fuel price to N500 or N400," he added.

A cart pusher, Akilapa Moshood, also expressed frustration over the high cost of living, saying: Bringing Tinubu on board is very unfortunate, and Nigerians are suffering ,because the country is in grave problem. Those who traded their votes for money or rice are the ones responsible for this mess," he added.

"I bought a small chicken, but I can't afford rice or other foodstuffs. My wife insists I must return home with the remaining Christmas items, but I don't have the money."

A hustler in the same market, Ismaila Ayoade, remarked that the harsh economic condition in the country has forced many people to opt for fish, as the price of chicken has become exorbitantly high.

He also expressed concerns over the rising costs of rice, beans, and other foodstuffs, saying, "The country is in a terrible state. If it were in the past, the markets will be bustling withany people buying and selling chickens. Now, you can barely spot two or three buyers."

Ayoade echoed the urgent need for government's intervention, pointing out that many Nigerians struggle to afford basic foodstuff during the festive season, despite their hard work.

"People have nothing to eat as Christmas approaches," he lamented. Farooq Olalekan, a drink seller, revealed that his family has been unable to buy fish or anything else needed to celebrate Christmas tomorrow.

He explained that his family's inability to afford Christmas provisions forced him, his mother, and his brother to sell drinks.

"I'm preparing for Christmas and trying my best to get something to eat. I have no job other than selling drinks, which my mother and siblings also depend on. I'm tired we're all tired. I'm here today to try and make money to buy Christmas food."

Olayemi Oladosun, a fish seller, explained that despite the rise in chicken prices, people still avoid buying fish from her due to the economic hardship.

She also lamented the scarcity of naira, which she attributed as a major factor behind the decline in patronage.

"Christmas is not going well at all. There's no market. Even the fish I'm selling is not being demanded, because people don't have money to buy chickens.

Michael Alade, a rice vendorand other foodstuffs, lamented, saying "People still come, but not like before. They keep complaining about the high cost of rice, beans, and the other goods I sell. It's not my fault; everything has become more expensive.

"We even travel to Cotonou to purchase food items, but Customs officials demand money from us without any explanation. We borrow money to stock up, only for customs to seize the goods. We are exhausted. Prices keep rising, and now people can no longer afford food for Christmas."

Additionally, Victoria Adejimi, a vegetable seller, spoke about her experience, adding: "I haven't been able to buy any foodstuffs yet. There seems to be no way out for me unless God sends a helper to my family. I came to the market hoping to sell some vegetables, and buy food for Christmas, but the market is not moving.

"Although I have nothing now, I'll make do with whatever I have. Last year, I had enough and even gave food to those in need. But this year is a different situation."



# FG issues final six-month deadline for banks, telcos to settle N250bn USSD debt

he Federal Government, through the Central Bank of Nigeria (CBN) and the Nigerian Communications Commission (NCC), has issued a final ultimatum to Deposit Money Banks (DMBs) and Mobile Network Operators (MNOs) to resolve the long-standing N250 billion Unstructured Supplementary Service Data (USSD) debt dispute.

In a joint circular released on December 20, 2024, the regulatory bodies outlined a structured payment plan to clear the debt, alongside new operational guidelines for USSD services.

The circular was signed by Oladimeji Taiwo, the Acting Director of Payments System Management at the CBN, and Chizua Whyte, the Head of Legal and Regulatory Services at the NCC.

The directive mandates that 60 per cent of the debt accumulated prior to the implementation of Application Programming Interfaces (APIs) in February 2022 must be paid as full and final settlement.

A payment plan, either as a lump sum or in instalments, is to be agreed upon by January 2, 2025, with full settlement required by July 2, 2025.

For debts incurred after February 2022, banks are required to settle 85 per cent of outstanding invoices by December 31, 2024.

Moving forward, 85 per cent of future invoices must be settled within one month of issuance.

The CBN and NCC further directed that all ongoing litigation regarding the USSD debt be discontinued.









10 seconds are not billed.

Additionally, the circular allows banks using prepaid billing systems to transition to EUB, contingent upon regulatory approval.

In their joint statement, the CBN and NCC reiterated their commitment to resolving the debt impasse, stating that the new measures are aimed at stabilising both the financial and telecommunications sectors while safeguarding the continued availability of USSD services to Nigerians.

USSD remains an essential service for financial inclusion, particularly in rural areas of Nigeria, where smartphone penetration and internet access are limited.

The service is heavily relied upon by banks for mobile banking, as well as for other telecom services such as airtime top-ups and bill payments.

The USSD debt crisis has persisted for several years, with telecom operators previously threatening to suspend USSD services unless outstanding payments were made.

The circular explicitly warned that failure to comply with the payment terms would result in stringent sanctions.

"In view of the foregoing, the CBN and NCC hereby direct that all DMBs and MNOs adhere strictly to the outlined payment terms to ensure final resolution of this matter. Failure to comply will result in sanctions," the joint circular stated.

The deadline follows growing pressure from telecom operators, who have repeatedly called for a clear and definitive payment framework to address the mounting debt, which has created significant tension between the banking and telecommunications sectors.

The regulators also emphasised the importance of transitioning to enduser billing (EUB) for USSD services. However, this will only apply to banks and telecoms that meet the stipulated payment obligations.

Until this transition takes place, operators have been instructed to implement a "10-seconds rule," ensuring that sessions lasting less than

## "I've never lied against anyone" Dele Farotimi speaks out after regaining freedom

ele Farotimi, a prominent human rights advocate, has regained his freedom after meeting the stringent bail conditions set by an Ado-Ekiti magistrate court. Farotimi was released from the Ekiti State correctional facility on Tuesday morning, following his arrest on December 3 for alleged defamation against renowned legal luminary Afe Babalola.

The controversy surrounding Farotimi's arrest stems from his book, "Nigeria and Its Criminal Justice System," which was released on July 2. In the book, Farotimi accused Babalola and other Senior Advocates of Nigeria (SANs) of corrupting Justices of the Supreme Court. Babalola's team subsequently filed a petition against Farotimi, leading to his arrest and arraignment in court on charges of defamation and cyberbullying.

Farotimi's bail conditions included a N30 million bond, two sureties (one of whom must be a property owner), the submission of his passport, and a prohibition on granting media interviews once released. However, in a surprising move, Farotimi addressed the media after his release, asserting his integrity and stating that he had never lied against anyone in his life.



"It is not ever an easy journey when you are fighting evil, but some years back, before I started this work, God told me that the truth is enough. It is the only weapon with which you can slay the monster called Nigeria, which is the truth," Farotimi said.

Farotimi's release has been met with relief from his supporters, who have been advocating for his freedom. However, the case against him is far from over, as he still faces multiple charges in both the magistrate court and the federal high court.

The Inspector General of Police, Kayode Egbetokun, had filed 12 additional charges against Farotimi at the Ekiti Federal High Court on December 6. These charges are separate from the defamation charges initially brought against him by Babalola's team.

As the case against Farotimi continues to unfold, his supporters remain steadfast in their commitment to his cause. Omoyele Sowore, a prominent social activist, confirmed Farotimi's release on his X handle, stating, "I am pleased to report that Dele Farotimi is no longer being held at the prison yards in Ekiti State and is now returning home to Lagos. The struggle continues!".

## Ibadan Stampede: Court remands Ooni's ex-queen, others

Chief Magistrate Court in Iyaganku, Ibadan, Oyo State has remanded three prominent individuals in connection to the tragic stampede at Bashorun Islamic High School, Ibadan.

The remanded individuals are Abdullahi Fasasi, the school's principal; Oriyomi Hamzat, owner of Agidigbo FM; and Naomi Silekunola, the former wife of Oba Enitan Adeyeye Ogunwusi, the Ooni of Ife.

The New Daily Prime earlier reported that the police confirmed 35 children dead as well as the arrest of Naomi, the funfair organiser and seven others.



Chief Magistrate Olabisi Ogunkanmi presided over the case on Tuesday, as the trio was arraigned by the Oyo State Police Command.

The hearing, held amidst tight security, drew a large crowd of relatives and onlookers.

The defendants face a four-count charge, including allegations of violating Section 324 of the Criminal Code, Cap. 38, Vol. II, Laws of Oyo State, 2000.

Following the proceedings, the court ordered their remand at the Agodi Correctional Centre, pending further directives from the state prosecutor.

### NCAA sanctions five airlines for cancelled flights, others

he Nigeria Civil Aviation Authority (NCAA) has initiated enforcement action against five airlines (two international and three domestic operators) for various violations of Part 19 of the NCAA regulations.

The violations include the non-payment of refunds within the stipulated time frame, non-responsiveness to the NCAA's directives, missing luggage, manhandled luggage, short-landed baggage, delayed and cancelled flights, amongst others.

A spokesman for NCAA, Michael Achimugu, disclosed this to journalists at the corporate headquarters of the Authority in Abuja on Tuesday.

He said that although airlines are not always responsible for flight disruptions, NCAA regulations stipulate actions that airlines must take during disruptions. Failure to comply attracts various levels of sanctions.

Recall that the Authority recently warned that it will initiate sanctions if airlines fail to pay refunds within the stipulated time frame of 14 days for online ticket purchases and immediate cash refunds for tickets purchased by cash.

The incessant disruptions this yuletide has caused a surge in passengers' complaints about delays and cancellations. Achimugu defended the airlines for most of the cancellations.

"We all know that this is harmattan season, so there is poor visibility. Flights must get cancelled. This is force majeure, and the airlines do not owe passengers anything in those instances. The enforcement we are initiating today is on cases where the airline is deemed to have been at fault. More will come," the spokesman explained.

He also assured that the Authority will be summoning the chief executives of



all airlines this week to a meeting over flight disruptions and regulatory breaches.

While Achimugu did not disclose the airlines whose sanctions he signed Tuesday, sources close to the Authority disclosed that they are Ethiopian Airways, Royal Maroc Airways, Arik Air, Aero Contractors and Air Peace.

## Legal practitioner calls for prosecution of parents involved in stampede

legal practitioner, Oluwatobi Fatoki, has urged authorities to prosecute parents who threw their children over a fence to collect palliatives during a recent funfair tragedy in Ibadan, which resulted in the deaths of 35 children. Fatoki emphasized that such parents are culpable in the death of their children and should be held accountable.

The incident, which occurred at Islamic High School, Bashorun, Ibadan, has sparked widespread outrage and calls for greater accountability and safety measures at public events. According to eyewitnesses, parents threw their children over the fence in a desperate bid to collect palliatives, leading to a stampede that resulted in the tragic loss of life.

Fatoki, a former spokesperson of the Nigerian Bar Association (NBA), Ibadan Branch, condemned the act of throwing or aiding children over the fence to collect palliatives, describing it as "outrightly illegal and injurious." He stressed that parents and guardians have a responsibility to protect their wards and that the government should ensure that things are done in the right way.

"The paramount interest of a child should be the major concern of any parent," Fatoki said in an interview. "Such a parent should be held culpable



for the death of any child who dies in the process. We have lost national ethics according to the constitution."

Fatoki also called on governments at all levels to establish strict policies and protocols for organizers of mass gatherings, including the provision of adequate security, first aid, and medical emergency personnel. He emphasized the need for community orientation on how to behave during massive distribution or empowerment programs.

"Government should ensure that things are done in the right way," Fatoki said. "We have regulatory bodies and protocols that should be followed. Issues of charity should be regulated in all ways



to have a positive outcome."

The legal practitioner's comments come as the police investigate the circumstances surrounding the funfair stampede. The incident has raised questions about the safety and security measures in place at public events, particularly those involving large crowds and vulnerable populations such as children.

As the investigation continues, Fatoki's call for accountability and prosecution of parents involved in the incident has sparked a heated debate about parental responsibility and the need for greater safety measures at public events.

## Train collides with rice-laden car in Lagos, Dec 24

shocking incident was captured on ►Tuesday, showing a dramatic collision between a train and a car in the Iju-Fagba area of Lagos State.

The vehicle involved in the collision, a Toyota Sienna, was reportedly loaded with bags of rice at the time of the crash.

The video, which quickly gained attention on social media, shows the exact moment the train slammed into the car, causing panic among onlookers.

Fortunately, as of the latest update, no casualties have been confirmed in connection with the incident. The collision, while significant, appears to have been without fatal outcomes, though further details are still pending.

This accident comes nearly a year after another deadly collision between a Lagos State staff bus and a commercial train along Agege Motor Road.

The previous incident, which occurred in December 2023, tragically resulted in the deaths of at least three individuals, with many others sustaining various degrees of



injuries. Investigations into that crash revealed that the driver of the BRT bus had acted recklessly, attempting to beat a train traffic signal, which led to the moving train plowing into the bus.

The Lagos State government has since increased efforts to improve safety measures at railway crossings and has called for greater awareness and caution among drivers.

This recent incident in the Iju-Fagba area underscores the ongoing risks associated with railway crossings in the state, particularly as vehicles attempt to navigate busy roads and active train routes.

Authorities are currently investigating the circumstances surrounding Tuesday's collision to determine whether human error or technical failure contributed to the crash.

While no injuries have been reported so far, the potential for harm remains high in such situations, as the force of a train colliding with a vehicle can be devastating.

As the investigation continues, both the public and authorities are reminded of the importance of adhering to traffic signals and exercising caution at railway crossings.

The recent spate of accidents involving trains highlights the need for improved safety measures and stricter enforcement of traffic regulations to prevent further tragedies.

### Makinde signs N684bn 2025 budget into law

Governor Seyi Makinde of Oyo State has signed the N684 billion 2025 Appropriation Act, dubbed the "Budget of Economic Stabilisation," into law.

Makinde thanked all stakeholders for their support, reiterating his administration's dedication to fiscal discipline and ensuring that budgetary allocations translate into tangible benefits for the people of the state.

# Mutfwang: Plateau poised to lead Nigeria's livestock development

### NAPTIP successfully reunites 1,200 trafficked victims with families

he National Agency for the Prohibition of Trafficking in Persons (NAPTIP) has reported a remarkable achievement in reuniting approximately 1,200 victims of human trafficking with their families over the past year. This milestone was highlighted in a comprehensive threeyear performance review spanning from September 2021 to September 2024.

The report, released in November 2024, provides an in-depth look at the tenure of NAPTIP's immediate past Director-General, Prof. Fatima Waziri-Azi. According to the agency, a total of 1,198 trafficked victims were successfully reunited with their families across its nationwide offices between September 2023 and September 2024. Notably, the majority of these reunifications occurred in 2024, reflecting the agency's intensified efforts during the period.

Data from the report revealed monthly variations in the number of victims rescued. In September 2023, NAPTIP rescued 101 victims, a figure that slightly increased to 105 in October and 112 in November. However, December 2023 witnessed a significant drop, with only 81 victims rescued. The trend continued into the new year, with 88 victims rescued in January 2024.

This number climbed to 109 in February but saw a slight decline to 95 in March. April 2024 recorded the lowest monthly rescue figure during this period, with only 67 victims rescued. The numbers rebounded in May, with a significant increase to 160 victims rescued, followed by 116 in June. The peak was recorded in July 2024, with 164 victims rescued, marking the highest monthly figure within the reporting period.

Victims rescued by NAPTIP received comprehensive support, including shelter, legal assistance, mental health counseling, and reintegration services, before being reunited with their families. These services were critical in ensuring the victims' smooth transition back into society and their overall well-



being.

In addition to its rescue and reunification efforts, NAPTIP has made substantial strides in securing justice for victims of trafficking (VoTs) and survivors of gender-based violence. Between January 2022 and August 2024, the agency secured 190 convictions for human trafficking, representing 27.94% of all convictions achieved by the agency since its inception 21 years ago. Additionally, NAPTIP recorded 20 convictions for rape and domestic violence during the same period, accounting for 74.07% of all such convictions secured by the agency since 2015.

Among the high-profile cases highlighted in the report were life imprisonment sentences handed down to three offenders convicted of rape. Seven offenders received prison terms of 10 years or more, including the notable case of Felicia Osaigbovo, who was sentenced to 12 years in prison and fined N24 million for trafficking Nigerian girls to Belgium for sexual exploitation. Another case involved Patricia Igbinovia, who, in January 2024, was convicted of facilitating the trafficking of five victims to Spain and sentenced to seven years in prison along with a N1 million fine.

For less severe offences, 12 offenders

received sentences ranging from one to four years, often accompanied by fines or compensation payments. In some instances, fines alone were imposed, ranging from N250,000 to N24 million.

The report credited these achievements to enhanced collaboration with local and international partners. Prof. Waziri-Azi emphasized the importance of these partnerships, stating, "These convictions are a testament to the agency's unwavering commitment to justice and the resilience of survivors who courageously participated in the prosecution process."

The report also shed light on the nature of exploitation faced by VoTs. Forced labour and sexual exploitation emerged as the predominant forms of abuse. Additional insights from the International Organization for Migration (IOM) revealed that 1,114 victims, primarily females (82%), were subjected to forced labour and sex trade exploitation.

NAPTIP's achievements underscore its dedication to combating human trafficking, securing justice for victims, and fostering partnerships to enhance its effectiveness. The agency's continued efforts highlight the importance of collective action in addressing this global challenge.

### 15-Year-Old dies in Niger gang clash, arrests made

5-year-old suspected gang member, identified as Saidu - Udu, was killed during a violent confrontation between rival groups in Minna, the capital of Niger State. The deadly clash, which took place in the Gurgudu area of Maitumbi, has left the community in shock, with the local police confirming the death and the arrest of several suspects.

According to a statement from the Niger State Police Command, the altercation broke out around 11:30 a.m. when hoodlums from two rival factions, one from Gurgudu and the other from Kwari-Berger, clashed in a bloody confrontation. The clash reportedly involved more than 50 individuals, escalating into violence that resulted in the fatal stabbing of Saidu Udu, a 15-yearold resident of Gurgudu.

The police were swift to respond to the scene, dispatching a patrol team from the Maitumbi Division. However, by the time law enforcement arrived, the attackers had already dispersed, leaving behind only the victim's lifeless body. The injured young man was rushed to a nearby hospital, where he was later confirmed dead. His death has sparked outrage in the community, with many demanding justice for the senseless loss of a young life.

The police spokesperson, Wasiu Abiodun, provided further details in a WhatsApp message to NEW DAILY PRIME, confirming that the altercation was the result of a dispute between the rival groups. "On December 21, 2024, at approximately 11:30 a.m., miscreants from the Gurgudu area of Maitumbi and Kwari-Berger engaged in a violent confrontation



that led to the death of Saidu Udu, 15, from Gurgudu. A police patrol team was dispatched to the scene, but the hoodlums had already fled. The victim was taken to the hospital, where he was confirmed dead."

Following the tragic event, the police conducted a thorough follow-up operation in the area, which led to the arrest of five individuals who were attempting to flee the scene of the crime. These suspects are currently undergoing investigation, and the police are actively working to apprehend the other individuals involved in the violent clash. Authorities have assured the public that all necessary steps are being taken to bring the perpetrators to justice.

The violent confrontation is believed to have been sparked by a disagreement over the distribution of money, allegedly given to the gang members by an unidentified benefactor. Sources suggest that the gangs were fighting over their share of the Christmas funds, which may have triggered the deadly altercation. As the investigation continues, authorities are focusing on identifying the individuals behind the funding of the gangs, as well as tracking down any remaining suspects.

This tragic incident highlights the growing concerns over gangrelated violence in parts of Niger State, where clashes between rival groups have become more frequent in recent months. The death of Saidu Udu has raised alarm in the local community, with residents calling for stronger action to curb gang violence and protect the safety of young people.

As the investigation unfolds, the Niger State Police Command is urging members of the public to remain vigilant and report any information that could help in the apprehension of the remaining suspects. The authorities have also emphasized the need for greater community involvement in addressing the root causes of gang violence, particularly among the youth, who are often lured into criminal activities.

### Ogun Assembly approves N1.054trn budget, adjusts key agency allocations

he Ogun State House of Assembly has approved the 2025 Appropriation Bill, amounting to N1,054,542,020,147, which had been presented by the state governor, Dapo Abiodun 20 days prior.

The approval included minor adjustments to recurrent expenditures across 21 agencies, as well as slight modifications to the capital expenditures of five agencies and the revenue targets for two agencies.

The passage followed the presentation of the report by the House Committee on Finance and Appropriation, chaired by Hon. Musefiu Lamidi, who moved the motion for its adoption.

His motion was seconded by Hon. Wahab Haruna and supported unanimously by the House during the plenary session presided over by Speaker Oludaisi Elemide at the Assembly Complex in Oke-Mosan, Abeokuta.

The bill was meticulously reviewed and adopted clause by clause in the Committee of the Whole House.

The motion for its third reading was moved by Majority Leader Yusuf Sheriff, seconded by Minority Leader Lukman Adeleye, and endorsed by all lawmakers through a unanimous voice vote.



Subsequently, the Clerk and Head of Legislative Service, Mr. Sakiru Adebakin, read the bill for the third time before the lawmakers.

The Speaker directed that a clean copy of the bill be forwarded to Governor Dapo Abiodun for his assent.

Several agencies saw adjustments to their budgetary proposals. The Ministry of Budget and Planning's estimate rose from N1.475 billion to N1.902 billion, an increase of N427 million. The Ministry of Community Development and Cooperatives experienced a rise from N1.780 billion to N2.499 billion, representing an increment of N719 million.

Similarly, the Ministry of Health's budget increased from N3.806

billion to N4.116 billion. The State Teaching Service Commission's proposal rose from N34.412 billion to N35.912 billion. The budget for the State Traffic Compliance and Enforcement Corps (TRACE) moved from N1.347 billion to N1.372 billion, while the State Hospital, Sokenu, Abeokuta, received an adjustment from N3.208 billion to N3.348 billion.

Additionally, the Ogun State Security Network (Amotekun) had its budget proposal raised from N765 million to N1.575 billion. The State Environmental Protection Agency's allocation increased from N252 million to N262 million. The State Library Board's 2025 budget also rose from N147 million to N177 million.

## 75-yr-old cleric arrested in Zamfara for fortifying bandits By Dave Oludare Oso

lhaji Lambo Ilela, a 75year-old cleric has been Larrested by a local community watch group in Zamfara State for allegedly providing spiritual backing to bandits operating in Zamfara and Katsina states.

The cleric reportedly confessed to offering spiritual services to bandits for nearly six years during interrogation.

He disclosed that his clientele initially consisted of nine gang leaders, including a notorious bandit leader, Sani Gurugu, who commands multiple gangs terrorising communities in Safana.

Ilela further admitted to receiving a payment of N1.3 million from Gurugu in exchange for his spiritual services, which he claimed were meant to enhance the bandits' operations.

The arrest comes as local vigilantes intensify efforts to curb the activities of criminal groups and their collaborators in Zamfara State, a region plagued by banditry and insecurity.

Meanwhile, the Safana Local Government Area in Katsina State has been a hideout for bandits.

Reports noted that Safana and Faskari have become hubs for bandits, who use the routes to launch attacks because Faskari lies on the boundary between Katsina and Zamfara states.



In a video shared on X by security analyst and counter-insurgency expert Zagazola Makama on Tuesday,it was observed that the vigilante group handed the suspect over to security forces for further investigation.

Confessing to the crime, the cleric said, "I am Alhaji Lambo Ilela, and I will tell the Zamfara Local Community Watch group what I am involved in. I was arrested for offering spiritual support to the bandits.

"I am a spiritual guide for the bandits who operate in the bush. I have vowed to confess all my offences to the local vigilante group, and no one forced me to reveal my involvement with the bandits.

"I have been offering spiritual support to the bandits for almost six years. The first group I supported consisted of nine gang leaders. Among them is Sani Gurugu, who leads several gangs that operate in Safana.

"He came to me and gave me N500,000, telling me that they would return after their mission. I fortified them before they went to attack Dan-Sadau in Zamfara State."

He continued, "When they returned from their operation, Sani Gurugu gave me N800,000. The spiritual fortification I provided was successful. During the operation, they did not kidnap anyone, but they rustled cows and other animals. There were confrontations during the operation, but no one lost their

"For the second operation, Sani Gurugu did not give me anything, but he came to me and told me that they wanted to go to Faskari. After the attack in Faskari, some of his gang members were killed by security operatives.

"After he came back, he did not give me anything. He complained that their operation was not successful because I did not fortify them well.

"Meanwhile, after the failed operation, Sani Gurugu came back and told me that they wanted to launch an attack in Dubura, Zamfara State. I also offered them further spiritual support, but their operation was unsuccessful again. On their way, after rustling cattle, they had a confrontation with security forces and eleven of his members were killed."

### Controversy erupts over planned Sharia Court in Oyo State By Elizabeth Jenrola Oso

heated debate has emerged in Oyo State, Nigeria, as an Islamic group, the Supreme Council for Sharia in Nigeria, Oyo State chapter, prepares to launch a Sharia court in the state. The group has scheduled the inauguration ceremony for January 11, 2025, at the Muslim Community Islamic Centre in Oyo.

The planned launch has sparked widespread criticism, with many arguing that the South West, populated by Yoruba people, is not a suitable location for a Sharia court, given its dominance by Muslims in the North. Netizens have taken to social media to express their disapproval, with many warning that the implementation of Sharia law could lead to arbitrary arrests, oppression, and human rights violations, even for non-Muslims.

A flyer highlighting the event One social media user, #OurFavOnlineDoc, cautioned, "If sharia law gets implemented in your state, let me tell you ahead what will happen. You can be randomly arrested and imprisoned for 'indecent dressing'. EVEN IF you are not a Muslim, EVEN if you are a Christian, EVEN IF you are a traditionalist, EVEN IF you don't subscribe to Sharia, and EVEN IF you are an atheist."

Another user, #BabaAjisefa, emphasized, "If you're silent on this sharia law saga in the southwest, then you're enabling it. Even if we can't see the implications of the laws in other



nations, we can see it in the north. The question is 'what progress does it bring?' And those that claim it will be for Muslims only don't forget that was how they started in the north, and Hisbah can arrest anyone now. We reject Sharia law in its entirety. No to sharia law in Yorubaland."

The controversy highlights the complex and sensitive nature of religious and legal issues in Nigeria, a country with a diverse population and a complex system of laws. As the debate continues, it remains to be seen how the situation will unfold.

The activist is facing a 14-count charge of alleged defamation, stemming from claims made in his book "Nigeria and its Criminal Justice System", where he allegedly "criminally defamed" senior advocate Afe Babalola.



Farotimi pleaded not guilty to the charges and is concurrently facing trial in another court over related allegations.

On December 9, the Federal High Court in Ekiti had also granted him bail in a separate case, involving a 12-count cybercrime charge filed by the Inspector-General of Police.

This bail was set at N50 million with one

surety.

Speaking to supporters after his release, Farotimi reiterated his commitment to truth and integrity.

"In my public advocacy, I have never lied against anyone. If I don't know something, I will say I don't know. Truth remains the only weapon that can transform this country," he said.

# Biden commutes sentences of 37 death row inmates

nited States President, Joe Biden has granted clemency to 37 of the 40 federal inmates facing death sentences, commuting their sentences to life in prison without the possibility of parole.

The three inmates who didn't receive clemency are the convicted murderer in the Tree of Life Synagogue shooting, the gunman at Mother Emanuel Church in Charleston, and the surviving Boston Marathon bomber.

The announcement is sure to spark partisan debate, even though presidential commutation and pardon power are broad, constitutionally enshrined and irreversible.

The Justice Department instituted a moratorium on executions in 2021 so it could review policies and procedures.

Trump communications director, Steven Cheung said in a statement that those whose sentences were commuted "are among the worst killers in the world," adding, "this abhorrent decision by Joe Biden is a slap in the face to the victims, their families, and their loved ones."

President-elect, Donald Trump has said he would resume executions and perhaps attempt to expand the crimes that qualify for capital punishment.

On Truth Social Tuesday, Trump said that as soon as he is in office, he will "direct the Justice Department to vigorously pursue the death penalty to protect American families and



children from violent rapists, murderers, and monsters."

Biden appeared to allude to Trump's stated intention in a statement announcing the commutations when he said, "In good conscience, I cannot stand back and let a new administration resume executions that I halted."

He also said,"These commutations are consistent with the moratorium my Administration has imposed on federal executions, in cases other than terrorism and hate-motivated mass murder.

"Make no mistake: I condemn these murderers, grieve for the victims of their despicable acts, and ache for all the families who have suffered unimaginable and irreparable loss.

"But guided by my conscience and my experience as a public defender,

chairman of the Senate Judiciary Committee, Vice President, and now President, I am more convinced than ever that we must stop the use of the death penalty at the federal level."

American Civil Liberties Union Executive Director, Anthony D. Romero lauded Biden's move, saying in a statement that he "took a historic and courageous step in addressing the failed death penalty in the United States — bringing us much closer to outlawing the barbaric practice once again."

"President Biden has taken the most consequential step of any president in our history to address the immoral and unconstitutional harms of capital punishment," Romero said, adding, "This will undoubtedly be one of the seminal achievements of the Biden presidency."

# Former US president Clinton discharged from hospital By Dave Oludare Oso

8-year-old former president of the United States, Bill Clinton was discharged from the hospital early Tuesday, his office said, a day after he was admitted with a fever in the latest in a series of health scares for the veteran Democrat.

His deputy chief of staff, Angel Urena said on social media platform X, "President Clinton was discharged earlier today after being treated for the flu.

"He and his family are deeply grateful for the exceptional care provided by the team at MedStar Georgetown University Hospital and are touched by the kind messages and well wishes he received."



Clinton was previously hospitalized for five nights in October 2021 due to a blood infection.

In 2004, he underwent a quadruple bypass operation after doctors found

heart disease — motivating him to make lifestyle changes, including adopting a vegetarian diet, and he has since spoken publicly about his efforts.

Bill Clinton, who led the United States from 1993 to 2001, is the second-youngest living US president, after 63-year-old Barack Obama. Clinton's health last made headlines in November 2022 when he tested positive for Covid-19.

Though his prosperous time in office was marred by scandals, he has enjoyed a second life in the two decades after his presidency, which has seen him venture into numerous diplomatic and humanitarian causes.

# Biden vetoes 66 new federal judgeships

President Biden on Monday vetoed a once-bipartisan effort to add 66 federal district judgeships, saying "hurried action" by the House left important questions unanswered about the life-tenured positions.

The legislation would have spread the establishment of the new trial court judgeships over more than a decade to give three presidential administrations and six Congresses the chance to appoint the new judges. The bipartisan effort was carefully designed so that lawmakers wouldn't knowingly give an advantage to either political party in shaping the federal judiciary.

The Democratic-controlled Senate passed the measure unanimously in August. But the Republican-led House brought it to the floor only after Republican Donald Trump was reelected to a second term as president



in November, adding the veneer of political gamesmanship to the process.

The White House had said at the time that Biden would veto the bill.

"The House of Representative's hurried action fails to resolve key questions in the legislation, especially regarding

how the new judgeships are allocated, and neither the House of Representatives nor the Senate explored fully how the work of senior status judges and magistrate judges affects the need for new judgeships," the president said in a statement.

"The efficient and effective administration of justice requires that these questions about need and allocation be further studied and answered before we create permanent judgeships for life-tenured judges," Biden said.

He said the bill would also have created new judgeships in states where senators haven't filled existing judicial vacancies and that those efforts "suggest that concerns about judicial economy and caseload are not the true motivating force behind passage of this bill now.

# Fabio Ochoa deported to Colombia after serving 25 years in US prison

abio Ochoa, a notorious Colombian drug lord and key operator of the Medellin cartel, has been deported back to his home country after serving 25 years of a 30-year prison sentence in the United States.

Ochoa, 67, arrived at Bogota's El Dorado airport on a deportation flight on Monday, wearing a grey sweatshirt and carrying his personal belongings in a plastic bag. He was met by immigration officials in bulletproof vests, but there were no police on site to detain him.

Colombia's national immigration agency promptly released a statement on social media, saying Ochoa was "freed so that he could join his family" after immigration officials took his fingerprints and confirmed through a database that he is not wanted by Colombian authorities.

Ochoa's deportation marks the end of a long and tumultuous chapter in his life. Along with his older brothers, Juan David and Jorge Luis, Ochoa amassed a fortune in the late 1970s and early 1980s as cocaine flooded the US market. The brothers were included in Forbes Magazine's list of billionaires in 1987.

Ochoa was first indicted in the US for his alleged role in the 1986



killing of Barry Seal, an American pilot who flew cocaine flights for the Medellin cartel. He turned himself in to Colombian authorities in the early 1990s under a deal that allowed him to avoid extradition to the US.

However, Ochoa was arrested again in 1999 for drug trafficking and was extradited to the US in 2001. He was convicted and sentenced to 30 years in prison, with the option to reduce his sentence for good behavior.

Ochoa's name has faded from popular memory in recent years, but he was recently depicted in the Netflix series Griselda and Narcos. Richard Gregorie, a retired assistant US attorney who was on the prosecution team that convicted Ochoa, expects that the former mafia boss will have a welcome return home.

"He won't be retiring a poor man, that's for sure," Gregorie told The Associated Press earlier this month.

Ochoa's deportation has sparked mixed reactions in Colombia, with some welcoming his return and others expressing concern about his potential influence on the country's narcotics trade. As Ochoa begins his new life in Colombia, it remains to be seen how he will be received by the public and whether he will attempt to revive his former life as a major player in the Medellin cartel.

# Sacked in the morning?! Guardiola's flops sink to new low

anchester City's freefalling continued with a limp 2-1 loss at Aston Villa, signalling a third consecutive defeat in all competitions and a ninth reverse in their last 12 matches.

## I'm focused on improving Rashford **– Amorim** By Dave Oludare Oso

anchester United manager Ruben Amorim has questioned the "choices" of people close to forward Marcus Rashford.

Rashford, 27, said he was "ready for a new challenge" in an interview after being dropped for the 2-1 win at Manchester City on 15 December.

The England international subsequently missed the 4-3 Carabao Cup quarter-final defeat by Tottenham and was also left out as United lost 3-0 to Bournemouth on Sunday, adding to speculation he could leave Old Trafford in January.

"It is a hard situation," Amorim told Sky Sports.

"I understand these players have a lot of people around them, making choices that are not the first idea from the player.

"They chose to do the interview as it is not just Marcus."

Rashford has scored 138 goals in 426 appearances for the club since making his debut in 2016, having come through the United youth ranks.

However, while he managed 30 goals in all competitions in 2022-23, he has struggled for form in three of the previous four seasons and attracted criticism from pundits and fans for a number of laboured displays during that time.

Amorim said he can "separate" the decisions of those advising Rashford from his relationship



with the player.

"At the moment I'm focused on improving Marcus," he added. "We need a talented guy like Marcus. I forget the interview now and see what I see on the pitch."

Regarding Rashford's future, the Portuguese boss said it is for him and the club "to deal with that when the time comes."

Speaking to the wider media before United face Wolverhampton Wanderers on Thursday, Amorim denied the talk around Rashford was a distraction, adding: "Some guys have a big responsibility here because they have been here for a long time.

"If you have big talents, we need big performances, big responsibility, big engagement to push everybody forward in this moment. Like any other player, we want him to be the best he can be.

"This is maybe one of the lowest moments in our club. We have to face it and be strong."

United's humbling defeat by the Cherries means they head into Christmas in 13th place in the Premier League, after Wolves they host Newcastle on 30 December.

It will be their lowest position in the table at this stage since they were 15th in 1986, just over two months into Sir Alex Ferguson's reign as manager.

Amorim had to halt his post-match news conference on Sunday because of a leak in the ceiling of the press room.

Asked later how he intended to reverse fortunes at Old Trafford, the former Sporting coach pointed to the ceiling and said: "If I knew, I would solve all the problems of this club, even this.

"I know what I am going to do. That is so clear for me. I will not say I feel relaxed because I'm really frustrated. It's a very difficult moment but we will solve problems step by step and find answers for everything."
