## Gov Namadi loses son 24 hours after mother's death

ragedy has once again struck the family of Jigawa State Governor, Umar Namadi, following the death of his eldest son, Abdulwahab Umar Namadi, in a fatal car accident.


The incident occurred barely 24 hours after the governor lost his mother, Hajiya Maryam Namadi.

According to eyewitness accounts, Abdulwahab was returning from Kafin Hausa to Dutse with his friends when the vehicle he was driving lost control, causing it to somersault. While his friends sustained various degrees of injuries and are currently receiving treatment at Dutse General Hospital, Abdulwahab was pronounced dead at the scene.

A close family source, who spoke on condition of anonymity, described the incident as a "double tragedy that has deeply shaken the family."

"The governor is still mourning the loss of his mother, and now this. It is a very difficult time for the family," the source said.

Governor Namadi, who was seen at the funeral in Kafin Hausa, expressed his grief but called for prayers and patience.



"It is Allah's will, and we cannot question it. I urge everyone to remember us in their prayers during this challenging period," the governor said during a brief address after the burial.

Residents of Dutse and Kafin Hausa have been trooping to the governor's residence to offer their condolences.

A family friend, Alhaji Musa Ibrahim, described Abdulwahab as a "humble and responsible young man with a promising future."

"He was well-loved by many and always showed respect to elders. This is a huge loss not just for the family but for the entire state," Ibrahim added.

Meanwhile, hospital officials have

confirmed that Abdulwahab's friends are responding to treatment and remain in stable condition.

Jigawa State Information Commissioner, Malam Sagir Musa, released a statement expressing the government's condolences.

"We mourn with His Excellency and his family. This is indeed a painful moment for all of us in Jigawa State. May Allah grant the deceased Aljannah Firdaus," the statement read.

Funeral prayers for the late Abdulwahab were held at the Kafin Hausa Central Mosque, attended by top government officials, traditional rulers, and community leaders.

## FG denies collusion with France to destabilise Niger Republic

he Federal Government (FG) has denied allegations made by General Abdourahamane Tchiani, the military leader of Niger Republic, accusing Nigeria of conspiring with France to destabilize his country.

In a statement issued on Thursday, Nigeria's Minister of Information and National Orientation, Mohammed Idris, described the claims as baseless and existing only "in the realm of imagination."

He reaffirmed Nigeria's commitment to fostering peace, harmony, and historic diplomatic ties with Niger Republic despite its current political instability.

"Nigeria has never engaged in any overt or covert alliance with France—or any other country—to sponsor terrorist attacks or destabilize Niger Republic," the statement read.

The Minister highlighted President Bola Tinubu's efforts as Chairman of ECOWAS, emphasising his leadership in keeping diplomatic channels open with Niger to encourage re-engagement and cooperation within the sub-region.

Idris also refuted claims of Nigeria colluding to arm or support terror groups, noting that Nigeria's Armed Forces, alongside the Multinational Joint Task Force, have made significant strides in curbing



terrorism in the region.

He further dismissed allegations of ceding Nigerian territory for subversive activities, stating that the government remains steadfast in safeguarding the country's sovereignty and territorial integrity.

"Unlike some nations, Nigeria has never permitted foreign powers to establish military bases on its soil. This demonstrates our commitment to national independence and regional leadership," Idris added.

Addressing accusations of sabotaging Niger's pipelines and agriculture, Idris highlighted Nigeria's role in supporting Niger's economic growth through projects like the Trans-Saharan Gas Pipeline and the Kano-Maradi Railway.

"It is illogical to suggest that Nigeria would undermine initiatives it has actively promoted," he stated.

He also dismissed claims of

establishing a so-called Lakurawa terrorist headquarters in Sokoto State, pointing to Nigeria's active military efforts, including Operation Forest Sanity III, which targets such threats.

He urged the public to disregard the allegations and called on General Tchiani to provide credible evidence to substantiate his claims.

"Any attempt to blackmail Nigeria over ECOWAS's principled stance against unconstitutional power seizures in Niger is disingenuous and doomed to fail," the Minister said.

The Minister further encouraged Niger's leadership to focus on dialogue and collaboration rather than promoting unfounded accusations.

He reaffirmed Nigeria's commitment to regional stability and its role in addressing transnational challenges like terrorism.

### Atiku condemns Sokoto airstrike killings

ormer Vice President Atiku Abubakar has described devastating, Wednesday's airstrike in Sokoto State, which claimed about 10 lives and left several others injured.

The New Daily Prime gathered that a Nigerian Air Force airstrike, aimed at neutralising Lakurawa terrorists, accidentally targeted Gidan Sama and Rumtuwa communities in the Silame Local Government Area of the state.

Reacting to the incident in a post on his X handle today, Atiku tagged the airstrike as an outrageous act that must be denounced in the strongest terms.

He noted, "But this tragedy begs the question: What have we truly learnt from the heart-wrenching losses of the past? On December 3, 2023, tens of innocent lives were lost in a brutal airstrike on a religious gathering at Tudun Biri, near Kaduna. How many more lives must be lost before we take



action?

"While targeting terrorists is a legitimate goal, these strikes must be carried out with unmatched precision and based on irrefutable intelligence. The indiscriminate killing of innocent citizens — our brothers, our sisters, our neighbours—can never be justified. It is not only a failure but a gross violation of humanity itself."

The 2023 presidential candidate of the Peoples Democratic Party (PDP) criticized the Nigerian Airforce, stating that the ongoing killing of innocent citizens is fueling division and deepening public anger.

He further stated that the families of the innocent victims and others now struggle to distinguish between the Nigerian Air Force and terrorists.

"We must stop this tragic cycle of death. The only way forward is to learn from the past, to make sure that every life is valued, and to ensure no more families have to mourn the loss of loved ones due to senseless violence.

"To the grieving families and the people of Sokoto, my heart goes out to you. May the souls of the departed rest in eternal peace", said the Adamawa-born politician.

# Adeleke pardons man sentenced to death for stealing fowl

Olowookere was pardoned alongside his accomplice, Sunday Morakinyo, the governor disclosed in a statement on X on Thursday.

The claim that the duo got a death sentence for stealing a fowl went viral on social media. But the Osun State Judiciary has clarified that they were convicted for armed robbery, including robbing a poultry in 2010.

The governor said that 51 other inmates were also pardoned following recommendations of the State Advisory Council on Prerogative of Mercy.

"In line with the recommendations of the State Advisory Council on Prerogative of Mercy and in exercise of the power conferred on me by paragraph (a), (c) and (d) of subsection (i) of section 212 of the Constitution of the Federal Republic of Nigeria, 1999 (As Amended), I am pleased to extend my grace and mercy unto 53 convicts serving



various convictions within the Nigerian Correctional Service," Adeleke said.

"In the case of inmates convicted of simple offences, I have decided in accordance with the said recommendation to remit and forgive the remainder of the said sentences of the following 30 (thirty) inmates in whole.

"I have also decided in accordance with the said recommendation to grant outright pardon to the following 12 (twelve) inmates convicted of simple offences.

"In the case of the following 6 (six) convicts sentenced to death, I have approved the commutation of their sentence from death to outright release while Ojekunle Timothy has his sentence commuted from death

sentence to 15 (Fifteen) years imprisonment having spent at least 10 (ten) years in custody.

"The following 4 (four) convicts also have their sentences commuted from death sentence to outright pardon: Sunday M or a k i n y o, S e g u n Olowookere, Tunde Olapade, Demola Odeyemi."

Olowookere and his accomplice were arrested in 2010 for breaking into the homes of a police officer and another person.

In 2014, Justice Falola of the Osun State High Court sentenced the duo to death by hanging after they were found guilty of breaking into the officer's house and stealing his property.

Ibadan Stampede: Queen Naomi's mother begs Tinubu for daughter's release

rs. Funmilayo Ogunseyi, the mother of Naomi Silekunola, the former wife of the Ooni of Ife, has called on President Bola Tinubu and well-meaning Nigerians to intervene in her daughter's legal troubles following a tragic stampede in Ibadan that claimed the lives of 35 children.

Silekunola, along with two other individuals, was arraigned before the Iyaganku Magistrate Court in Ibadan in connection with the incident, which occurred during a funfair event last week.

The court ordered that the accused be remanded in prison, facing charges of conspiracy, negligent acts causing harm, and failure to provide adequate security and medical facilities for the event.

In an emotional video that has since gone viral, Mrs. Ogunseyi made an impassioned plea for mercy, stressing that her daughter's motives were entirely humanitarian.

She explained that Naomi had organised numerous outreach programmes over the past decade, aimed at assisting vulnerable groups, including the elderly, children, and pregnant women across Nigeria.

"I ask for mercy. Mothers, please have mercy. Come to my rescue. Don't let my life be destroyed. My daughter came to Ibadan to help the needy; this wasn't her first time. We've travelled across the country helping children and the vulnerable. I sympathise with the families who lost their children; it was never our intention. Please don't let Naomi be imprisoned, she is innocent. She only came to show compassion,"



Mrs. Ogunseyi said tearfully.

She recounted the chaotic events leading up to the tragedy, revealing that crowds had gathered long before the event's scheduled start time of 10 a.m.

According to her, the stampede began around 6:30 a.m., well before Naomi arrived at the venue.

"The programme was supposed to start at 10 a.m., but people began arriving the day before. By 6:30 a.m., the crowd became uncontrollable. Naomi wasn't even there yet. I got a call about the chaos while I was still asleep. My phone number was on the event flyer, so I was contacted. Naomi, her elder brother, and I immediately went to the police station to report the incident, but she was detained and later charged with murder," she explained, breaking down in tears.

Mrs. Ogunseyi also revealed that Naomi, who was reportedly unwell at the time, fainted during police questioning and remains in custody despite her fragile health.

She appealed directly to President Tinubu, asking for intervention in what she described as a case that was being manipulated by "powerful persons."

"They have taken my child to prison. The court was full of policemen. I don't know where else to turn. They say her ordeal is an 'order from above.' Please, I beg those in power to release her. She is not a killer; she came to help. Naomi is fragile and sick. President Tinubu, I beg you, come to our aid," she implored.

While expressing her heartfelt condolences to the families who lost their children in the stampede, Mrs. Ogunseyi insisted that the tragedy was an unfortunate accident and was never intended by Naomi or the organisers.

The incident has sparked widespread public attention, with many expressing sympathy for the families of the deceased, as well as concern over the legal proceedings involving Silekunola.

## EFCC arrests Delta Accountant General over diversion of N1.3trn by Okowa

he Accountant General of Delta State, Mrs. Joy Enwa, has been arrested by operatives of the Economic and Financial Crimes Commission (EFCC) amid the commission's ongoing investigation of former governor of the state, Ifeanyi Okowa.

Currently, the anti-crime agency is investigating the alleged diversion of N1.3 trillion state funds by Okowa.

EFCC arrested and detained the former governor in November this year for the alleged diversion of the funds, said to be part of the 13 percent derivation fund earmarked for oil-rich states.

Dele Oyewale, the EFCC spokesman, who confirmed the arrest and detention, stated that the former Delta governor and former vice presidential candidate of the Peoples Democratic Party (PDP) was taken into custody at the Port Harcourt division of the anti-graft office.

Okowa was alleged to have used his office as governor to loot and acquire assets up to N1.3 trillion. Some of the assets were shares in UTM Floating Liquefied Natural Gas Company, among other investments in the oil sector.

The National Bureau of Statistics had reported how the Federation Account Allocation Committee (FAAC) shared funds among the oil-rich states.

Amid the ongoing investigation of the former governor, the EFCC operatives last week arrested and detained the Accountant General of Delta State, Mrs. Joy Enwa for questioning.



According to SaharaReporters, one Ekeruche, former director of finance and administration (DFA) and the director of administration, Government House, were also arrested and detained for several days by the commission.

They made separate statements during the time.

In 2015, the former Delta State Accountant General, Cyril Agbele, his then deputy, Mrs. Joy Enwa, now current Accountant General, former Asaba branch manager of the First City Monument Bank (FCMB), Mabel Asaije, and a staff member of the Delta State Board of Internal Revenue, simply identified as "Prosper" were enmeshed in a N369 million fraud and arrested by operatives of the State Criminal Investigation Department (SCID) in Asaba.

One of the officers from the Delta State Criminal Investigation Department (CID), the crack team that arrested the FCMB manager and others, said the bank manager, the AG, deputy AG and some staffers of the internal revenue board connived to defraud the state government of the money a few days before the expiration of the tenure of the



then governor Emmanuel Uduaghan.

Agbele had debunked the allegation.

In April 2020, Okowa appointed Enwa as the new Accountant General of the state, taking over from Agbele.

However, when contacted for comments on her arrest and detention at the EFCC's facilities in Port Harcourt, Rivers State, Enwa declined comments and simply said, "I am not the right source to confirm such story from. Why don't you reach out to the commission to give you details of my arrest and detention if at all I was actually arrested and detained by the commission?"

When the EFCC spokesman, Dele Oyewale was contacted on Wednesday evening, he confirmed the arrest and detention of Enwa over the ongoing investigation of Okowa.

Oyewale stated, "Yes, the accountant general was arrested and detained by the commission for some days before she was released. We also arrested some officials of the state government but they have been released as well."

## Military Strike: Gov Aliyu consoles Sokoto residents, says incident unfortunate

overnor Ahmad Aliyu of Sokoto State has addressed residents of the state over the Christmas Day's military air strike in the state.

NEW DAILY PRIME reported that a fighter jet, in pursuit of Lakurawa terrorists mistakenly bombed two communities in the Silame Local Government Area of Sokoto State on Wednesday morning.

The incident left at least 10 innocent villagers dead and several others injured.

This heartbreaking event, caused by an accidental misfire from the Nigerian Army, has claimed the lives of innocent citizens and left



several others injured.

As your governor, I am deeply saddened by this avoidable loss of life. On behalf of the government and the people of Sokoto State, I extend my heartfelt condolences to the families who have lost their loved ones. We also pray for the swift recovery of those injured in this unfortunate incident.

I want to assure you that I am in direct communication with the leadership of the Nigerian Army to ensure a thorough investigation into the circumstances that led to this tragedy.

The state government will do everything within its power to support the affected families and engage with the relevant authorities to prevent such occurrences in the future. This is a time for us to stand united as a community.

I urge all residents to remain calm and pray for peace in our state and nation. May the Almighty comfort the bereaved families and grant eternal rest to the departed souls.

I visited the affected areas to assess the situation firsthand and have directed a donation of N20 million along with 100 bags of assorted food items to the families of the deceased.

This support is intended to alleviate their suffering and cover the medical bills of those hospitalized due to their injuries from the bombardment.

Together, we will overcome this difficult moment and work towards ensuring that such tragedies do not happen again.

## FG earmarks N3.6bn for Aviation College annexes

he Federal Government has outlined plans to set up annexes of the Nigerian College of Aviation Technology (NCAT) in five geopolitical zones of the country.

Towards this end, the government has made a budgetary provision of N3,680,000,000 towards the actualisation of the project.

NCAT is the foremost aviation training institution in Nigeria established in 1964 and it is a Regional Training Centre (RTC) designated by the International Civil Aviation Organisation (ICAO).

Since its establishment, the college only has an annex in Lagos, the country's commercial capital and the hub of aviation in Nigeria.

Sources said the plan to decentralise the operation of NCAT has been in the offing over the years.

But the federal government in the 2025 budget presented by President Bola Tinubu on Thursday last week, is planning to spend N3.6bn to establish NCAT annexes in five geopolitical zones including Akure (South-West), Osubi (South-South), Ebonyi (South-East), Ilorin (North Central) and Yola (North East).

It was classified as a new project in the budget of the Ministry of Aviation and Aerospace Development contained in the appropriation document.

Similarly, the federal government



plans to spend N1.6bn on consultancy services/transaction advisers for some projects in the ministry.

These include N800m for consultancy/transaction advisers for the concession of five airport terminals as well as another N800m for "Consultancy/transaction advisers for PPP projects; maintenance, repair and overhaul, aerotropolis, agro-allied/cargo terminals, FAAN headquarters and others."

NEW DAILY PRIME reports that the concession of airport terminals was a major programme of the immediate past administration when Senator Hadi Sirika held sway as the Minister of Aviation.

The former minister had a running battle with the aviation unions and some stakeholders in the industry over the airport concession programmes.

Despite the opposition, the immediate past administration announced at its twilight that it has

successfully concessioned the Murtala Muhammad International Airport (MMIA), Lagos and Nnamdi Azikiwe International Airport, Abuja.

The then Special Assistant on Public Affairs to the Minister of Aviation, James Odaudu, stated that the concessioning was approved by the Federal Executive Council (FEC).

He disclosed that the Corporacion American Airport Consortium emerged as the preferred bidder, which comprises the Corporation American Airports, Mota Engil Africa, and Mota Engil Nigeria.

Furthermore, the Corporacion American Airport Consortium will make upfront payments of \$7 million for NAIA and \$1.5 million for MAKIA.

But the new minister, Festus Keyamo on assumption of office suspended the projects but said the plan to concession the airports is still alive.

Obi expressed delight at the operational status of the Centre's skill acquisition facility, which equips inmates with various productive skills.

## Petrol price reduced in response to market forces – Dangote

liko Dangote, President of Dangote Industries Limited, has explained that the recent reduction in petrol prices was a direct response to the dynamics of market forces.

The price of Premium Motor Spirit (PMS), commonly known as petrol, was reduced to N899.50 per litre at Dangote's loading gantry, following a shift in the competitive landscape of the downstream sector.

In a candid interview featured in an Arise TV documentary, Dangote elaborated on the price reduction, noting that the move was primarily driven by the market.

He also emphasised that, as the owner of the multi-billion dollar refinery, it is his duty to protect the interests and investments of the company.

"The price reduction is a response to the market, let me just put it that way. It is a refinery where we invested over \$20bn, and I think we have to try and protect our interests and also our investments," Dangote said.

The price reduction came into effect on 19th December 2024, when Dangote's refinery lowered its ex-depot price of petrol from N970 to N899.50 per litre.

This prompted a chain reaction, forcing the Nigerian National Petroleum Corporation Limited (NNPCL) to lower its ex-depot price to N899 per litre as well. In addition, the Dangote refinery formed a partnership with MRS Petrol Stations to sell petrol nationwide at N935 per litre, a move that has been welcomed by Nigerians.

Dangote further discussed the significant impact of the Dangote Refinery, which has the capacity to refine 650,000 barrels per day, on the Nigerian economy.

He explained that by reducing the country's reliance on imported



petroleum products, Nigeria would ease pressure on its foreign exchange reserves.

"40 per cent of our demand on foreign exchange is through people dealing in petroleum products, and the more we allow imports to come in, the more we keep using most of our foreign exchange out of the country," Dangote said.

He also acknowledged the inevitability of criticism, stating that no matter the project, there would always be those who criticise. However, he expressed confidence that the Dangote Refinery will bring positive change to Nigeria's oil sector and overall economy.

"Criticism will not stop us from continuing with what we are doing. I did this project because of my love for my country and to make sure that I have a legacy project," Dangote remarked.

"If I invested this money in Google or Apple, my investment would be more, and I wouldn't be having the headache that I'm having today."

Dangote, who described his investments as a legacy project rather than a pursuit of personal wealth, also defended his position on the \$1bn investment by the NNPC in the refinery, calling it "a drop in the ocean" in comparison to the \$20bn refinery.

"When NNPC said, 'Give us one more year, we want to change the agreement, we would rather pay you cash,' we gave them one more year. So from June last year to June this year, I called NNPC, and they gave us a week," he explained.

"But when the payment was due, NNPC decided to back out of the transaction abruptly. I said, okay, fine. We just walked away and continued. But we still went ahead, we finished our refinery, and our refinery is operating."

In response to circulating rumours that NNPC had provided financial assistance to Dangote's refinery during a liquidity crisis, he dismissed these claims as "cheeky and nasty," insisting that they were false.

The Dangote Refinery is currently refining 350,000 barrels per day, with plans to reach its full capacity of 650,000 barrels per day as operations ramp up.

Devakumar Edwin, Vice President of Dangote Industries, revealed that the refinery has access to more crude oil than is required for its current operations.

"The Nigerian crude production is more than double our requirements, so there is more than enough crude within Nigeria," Edwin said.

### 'It's unfair' – celebrities condemn remand of Ooni's ex-queen, others

elebrities have weighed into the stampede in Ibadan, the Oyo State capital, which claimed the lives of 35 children and left several others injured.

The tragic incident occurred during an event at Islamic High School in the Bashorun area, organised by Naomi Silekunola, the ex-queen of the Ooni of Ife, Adeyeye Enitan Ogunwusi.

Originally planned for 5,000 attendees, the event attracted an overwhelming crowd after news of free entry, gifts, and scholarship opportunities spread rapidly.

The New Daily Prime earlier reported that hundreds of attendees camped around the school the night before the event to secure early access.

Following the stampede, authorities arrested, arraigned, and remanded Naomi; Oriyomi Hamzat, CEO of Agidigbo FM; and Fasasi Abdullahi, the principal of the school.

Addressing the situation, actor Femi Branch in a video posted on his Instagram page criticised the detention of the organisers, calling it unfair and a violation of their human rights.

Branch argued that the parents who smuggled their children into the venue were the true culprits.

He questioned why the police have not arrested or prosecuted those who allegedly threw their children over the school fence to gain entry, emphasising their role in the tragic outcome.

"I want to say quick things about an unfortunate incident that happened in Ibadan that led to the death of 35 children. I was sad when I heard that the organisers, Prophetess Naomi and Oriyomi have been arrested and later heard they were charged to court and be remanded which means they'll be detained until the next adjournment.

"I'm very curious to hear about the charges and I'm very sure that but on negligence and others but let's do a quick analysis. I want to believe they have very good lawyers because this case is nonsense and this is not me being insensitive to the plight of the children that died, it is very tragic,", he said.

The 54-year-old actor explained that the event







was scheduled for 10:00 a.m., with security personnel set to arrive by 8:00 a.m. However, he said parents began dropping off their children at the venue as early as midnight.

The Ogun-born actor revealed that when the organisers learned about parents smuggling their wards into the venue at midnight, they rushed to open the venue and began rescuing the children. He remarked, "By that time, there was already a stampede."

He asked, "Is it a crime to do good in a country like Nigeria, where people are struggling with hunger and so many other challenges?"

Branch, who also served as the producer, added: "But if the purpose is to punish those responsible for the death, how is it the organisers? Let's look at the facts on the ground. The event was supposed to start by 10am, the security personnel were supposed to arrive by 8. The venue was locked and wasn't meant to be open till the security personnel arrived by 8 for an event that was supposed to start by 10.

"From the reports we have, people came overnight, they started arriving overnight and started throwing their children over the fence and into the compound. I saw a very tragic one of the children that as the mum threw them over the fence, the child hit their head and died instantly. So how is this the fault of the organisers?

He called for the immediate release of Naomi and Oriyomi, emphasising that such an unfortunate incident could happen to anyone.

He attributed the root cause of the issue to the hunger and hardship people are enduring under President Bola Tinubu's administration.

The actor also pointed out that most of the parents who smuggled their children in were not entirely out of food supplies.

"And now the poor organisers who are trying to be a blessing are arrested, charged to court. What is going on? Don't tell me you're just trying to make an example of them. To what end exactly? We need to be careful because we're setting a very terrible precedent.

He condemned the actions of parents who smuggled their children into the venue by scaling the fence.

"I think people need to speak up about this. Why have the police not fished out those parents who threw their children over the fence and also charged them? Because as far as I am concerned, they are the offenders, not the organisers.

"The facts are clear. It is unfair for Oriyomi Hamzat and prophetess Naomi to be remanded on his matter. These people should be set free. The government needs to do better because they want to be better to the people and be proactive, so they violate the rights of citizens and abuse the rights of people who have done no wrong."

Meanwhile, controversial crossdresser Idris 'Bobrisky' Okuneye also criticised the remand of the organisers.

Bobrisky, who recently made headlines over allegations of bribing Nigerian Correctional Service (NoS) and Economic Financial Crimes Commission (EFCC) officials during his sixmonth jail term at the Kirikiri Correctional Centre in Lagos for naira mutilation, stated that the remand of Oriyomi and Naomi deeply saddened him.

### Troops kill notorious bandit, Al'jan in Zamfara, residents celebrate

roops of the Nigerian Army have neutralized a notorious bandit, "Al'jan," in the Tsafe Local Government Area of Zamfara State.

Al'jan's death has brought relief to the residents of the area.

The deceased had long been terrorizing communities in the local government area.

Originally from Niger Republic, "Al'jan," whose real name remains undisclosed, settled in Tsafe LGA after working as a motorcycle taxi operator.

Zagazola Makama, a Lake Chad Basin counterterrorism and insurgency expert, explained that working as a taxi operator connected Al'jan with Fulani herders, leading him down a path of criminality.



The publication stated: "Over time, he forged alliances with a bandit group led by Hassan Bamamu, becoming deeply entrenched in acts of banditry and terror throughout the region.

"Utilizing his extensive knowledge of Tsafe and its surroundings, Al'jan acted as a guide for criminal gangs, orchestrating numerous raids and kidnappings.'

He was implicated in several highprofile killings, including those of Anas Umar Dan Kanti, Alhaji Musa Ille, and an unnamed Navy officer. It

"The reign of terror that "Al'jan" inflicted on the community came to an end three weeks ago when security forces successfully neutralized him and several of his associates during a joint operation between Mada and Yandoton Daji in Tsafe LGA.

"This operation involved a coordinated effort by soldiers and local vigilantes, who ambushed the gang as they traversed the area.

"The elimination of "Al'jan" has brought new found hope to the people of Tsafe, particularly those residing along the Tsafe-Gusau road, which had suffered from frequent attacks.

"Residents of Bamamu village, his last known hideout, confirmed his death after viewing his remains."

### Edo man kills 4-yr-old son after 'falling into trance'

he Police have arrested a man, identified as Theophilus Osazuwa, who was alleged to have killed his four-year-old son while under the influence of hard drugs in Edo State.

He said, "Edo Police Command has arrested one Theophilus Osazuwa of Ogbeson Quarters off Benin-Agbor Road, Benin City, for the murder of his four-year-old son named Testimony Osazuwa.

"The suspect was said to have arrived at his home on 24/12/2024 at about 1230 hrs, went berserk screaming 'Holy Ghost fire,' then reached for the four-year-old boy and slammed him to the wall. The child was rushed to the hospital but was pronounced dead on arrival.

"Preliminary investigation revealed that the young man who is known for the consumption of illicit (colloquial, ice, etc.) substances must have acted under the influence of the same."

# UniAbuja refutes claims of bias in VC selection process

he University of Abuja has firmly denied allegations of bias and irregularities in its ongoing selection process for a new Vice-Chancellor, following protests by senior professors who criticised the procedure as "flawed."

Reports from PUNCH Online on Tuesday revealed that some senior academics at the university had raised concerns over the selection process, accusing the institution of favouritism. The controversy erupted following the exit of the university's former VC, Prof. Abdulrasheed Na'Allah, on July 1, 2024, after which the search for his successor commenced.

During Na'Allah's tenure, he had initiated the process to appoint a new VC before stepping down. Prof. Aisha Maikudi, the Deputy Vice-Chancellor, Academics, was appointed to serve as acting Vice-Chancellor after his departure.

However, some stakeholders have contested her appointment, questioning whether she possesses enough years of professorial experience to assume the role permanently.

In a statement issued on Wednesday by the Acting Director of Information and University Relations, Habib Yakoob, the university addressed these concerns, asserting that Prof. Maikudi is fully qualified for the position and has effectively managed the responsibilities of acting VC over the past six months.

The university insisted that Maikudi, along with all other candidates, had been considered under a merit-based selection process.

"These reports, which include claims of imposing a candidate—specifically



the Acting Vice-Chancellor, Professor Aisha Sani Maikudi—are misleading and exaggerated," the statement read.

"In fact, her remarkable accomplishments during this period have garnered widespread applause and commendation within and beyond the University."

The university also emphasised its commitment to a transparent and fair selection process, conducted in line with relevant laws and regulations.

"The university remains confident in the Council's ability to conduct a transparent, fair, and merit-based selection process, adhering strictly to the Universities (Miscellaneous Provisions) Act and other relevant statutes," Yakoob added.

Addressing reports of protests by some professors, the university acknowledged the right of staff members to express their concerns peacefully.

However, it categorically denied any allegations of coercion or confrontation during a recent Senate meeting. "No such meeting occurred," Yakoob clarified, while stressing that the university respects staff rights to peaceful protest.

The statement also responded to claims of harassment involving a Channels Television journalist, clarifying that the incident had been thoroughly investigated.

The findings revealed that the journalist's vehicle had been briefly i m m o b i l i s e d d u e t o a misunderstanding over their identity and purpose on campus. The university denied any allegations of assault, detention, or harm, confirming that no journalist who properly identified themselves had been denied access.

The University of Abuja reiterated its commitment to maintaining positive relationships with the media and safeguarding the safety and security of all individuals on campus.

It called on all stakeholders to allow the selection process to unfold without external interference or politicisation, assuring that the process will be concluded with integrity and in the best interests of the institution.

"The process will be concluded with the utmost integrity and in the best interests of the University," the statement concluded.

### Meet world's deadliest rat, which can kill elephant with one bite

redators beware! The world's deadliest rat carries enough toxin to kill an elephant

Did you know there's a rat poisonous enough to kill an elephant?

Lophiomys imhausi, also known as the crested rat, the maned rat, and the African crested rat, is a deadly rarity says Aoife Glass.

The crested rat is the only known poisonous rodent, and the only known mammal to sequester plant toxins for use as a defence mechanism. One bite is enough to kill.

What does the crested rat look like?

Adult crested rats grow to between 360mm and 530mm head to tail. The small head is covered in short, black fur, while the body and tail have a thick grey and white undercoat with longer guard hairs tipped white or black, together giving the impression of a small, fluffy skunk.

A mane of longer black and white banded hairs stretches the length of the rat from the head to the base of the tail, and this is the crest or mane from which the animal gets its name.

When it's threatened, this mane erects, exposing a band down each side of the body, bordered in white, with specially adapted hairs covering glandular skin.

This has two purposes. The first, like a skunk, is to display warning colouration. The second is to reveal those specially adapted hairs, which contain enough toxin to make any animal that decides to take a bite extremely ill, if not fatally poisoned.

Where does the crested rat live?

Sometimes called the African crested rat, this species lives in forests, savannah and shrubland, favouring rocky terrain, and nesting in hollow tree trunks, holes and hollows. Populations have been observed in Somalia, Ethiopia, Sudan, United Republic of Tanzania, Keny, Djibouti and Eritrea.

Crested rats seem to be mostly solitary, sometimes living within a small family group of male, female and offspring. Female crested rats have small litters of between one to three offspring.

What does the crested rat eat?



Despite its fearsome reputation, the crested rat's diet of choice mostly consists of plant material such as leaves and fruit, though it has been known to eat meat, insects and root vegetables.

Unusually, it has stomach physiology that's similar to ruminants such as cattle; a fourchambered stomach with plenty of digesting bacteria which allows it to process and breakdown the food it consumes. This fact makes it unique amongst Moroidea, the super family to which all rodents belong.

Why is the crested rat so deadly?

The other unique element of the crested rat is its killer abilities. It's the only known rodent that uses toxins from another species as a defence mechanism, and it does this via some incredible evolutionary adaptations.

First, Lophiomys imhausi feeds on the bark of the African poison arrow tree, Acokanthera schimperi. The bark, as well as the roots, stems, leaves and seeds of this tree, contain acovenoside A and ouabaine; these are heart stimulating chemicals, called cardenolides. In small doses, these types of chemicals can be used for medicinal purposes, but at larger doses can have catastrophic effects; vomiting, convultions, breathing difficulties and even cardiac arrest.

Next, L. imhausi licks the hairs along the glandular skill patches either side of its crest, depositing saliva infused with those cardiotonic glycosides from the African poison arrow tree. At a glance, these hairs look much like those on other areas of the crested rat, but they have a very particular structure; a honey-comb outer layer, with an inner layer of long vertical fibres. This makes them particularly suited to absorbing liquid, dispersing it along its interior, and storing or 'sequestering' it.

How does the crested rat kill?

If a would-be predator ignores the warning

colouration and tries to attack, the exposed hairs will release these toxic compounds into the mouth, and very quickly into the bloodstream. With natural predators including the honey badger, caracal, serval, hyena and leopard, an effective deterrent is a definite evolutionary advantage.

Just how toxic could the crested rat be?

Arrows treated with the same cardenolide toxins have floored full-grown elephants, so potentially very deadly indeed. However, it's not in the rat's interest to kill every predator that attacks; instead, it ideally needs to make them so poorly that they learn that crested rats aren't on the menu in the future.

Casualties do happen though, and dogs that have attacked crested rats have been known to die; those lucky enough to survive display, unsurprisingly, a strong fear response at any future encounters.

The crested rat also has a particularly thick dermis or skin, making it very resistant to bites, and a very long, strong and flexible spine with four extra vertebrae.

Why isn't the crested rat poisoned by its diet? The short answer is science doesn't exactly know the specific mechanism or adaptation that allows it to consume poison without succumbing itself.

However, it is known that rodents from the Moroidia super family have a slight biochemical variation that means they are more resistant to this type of chemical, so that may be why the crested rat is able to survive levels of the toxin that are fatal to its predators. Another theory is the bacteria contained in its chambered stomach may include a type that can break down cardenolides safely in the gut.

Is it endangered?

According to the IUCN Red List, the crested rat is listed as 'least concern'. However, researchers have concluded that due to low population density, low reproductive rates and a relatively long life-cycle, this might not be the full picture.

While populations exist in protected areas, the woodland and forest they live in are increasingly threatened by logging, and a loss of habitat is likely to impact the species' longterm success.



## World Bank suspends loan fees for poor nations By Ghenga Oluranti OLALEYE

he World Bank has announced the suspension of several loan fees to alleviate the financial burden on vulnerable nations, in a move aimed at making borrowing more accessible for countries facing significant economic challenges.

The decision is part of the Bank's broader efforts to bolster financial support and tackle urgent global issues such as climate change, inequality, and economic instability.

The announcement was made via a post on the Bank's official X handle on Tuesday, providing details about the measures taken to reduce costs for developing nations.

According to the post, the World Bank has removed the prepayment premium on loans provided through the International Bank for Reconstruction and Development (IBRD), introduced a grace period for commitment fees on undisbursed balances, and extended its lowest loan pricing to small, vulnerable countries.

"We are working hard to make it easier for countries to borrow and repay their loans by eliminating some fees on IBRD loans," the Bank stated in its announcement.

These changes are intended to relieve financial pressure on nations most in need of development financing.

The Bank's statement further explained that the reforms are in line with its vision to create a more efficient and expansive institution capable of addressing the complex global challenges facing today's world.

The suspension of these fees is part of a larger series of reforms aimed at increasing the World Bank's lending capacity by \$150 billion over the next decade. The measures include the introduction of innovative financial instruments, greater shareholder support, and an optimisation of available capital.



Despite these changes, the Bank assured that its Triple-A credit rating would remain unaffected. The reforms also involved a reduction in the IBRD's equity-to-loans ratio from 20 per cent to 18 per cent, which is expected to unlock an additional \$70 billion in lending over the next ten years.

The World Bank has also secured a further \$10 billion through bilateral guarantees and \$1 billion through a guarantee from the Asian Infrastructure Investment Bank.

"The adjustments to our capital framework reflect our commitment to scaling up resources while maintaining financial stability," the Bank said in its statement.

The institution stressed that these measures are essential in addressing the trillions of dollars required annually to tackle climate change, support fragile states, and promote digital inclusion.

Acknowledging the enormity of the financial challenges, the World Bank highlighted that governments and multilateral institutions alone cannot meet these demands.

To bridge the gap, the Bank introduced the Framework for Financial Incentives (FFI), which aims to encourage investments in global challenges such as biodiversity, water security, energy access, and pandemic prevention. Launched in April 2024, the FFI also introduced the Global Solutions Accelerator Platform and the Livable Planet Fund, with Japan pledging the first contribution. The Bank described the FFI as the first comprehensive framework among multilateral development banks to incentivise financing for projects with global benefits.

Additionally, the Bank is developing innovative financial tools to attract private sector investments. These include outcome bonds, catastrophe bonds, and climate-resilient debt clauses, which provide borrowers with flexible terms during natural disasters.

One notable example is the Wildlife Conservation Bond, which directed private investment toward Black Rhino conservation in South Africa. Another initiative, the plastic waste reduction-linked bond, mobilised funds for recycling projects in Ghana and Indonesia.

"We are discovering new ways to channel private investment into emerging markets and overcoming barriers to sustainable development," the Bank concluded.

Through these reforms, the World Bank continues to demonstrate its commitment to supporting vulnerable nations and fostering global financial stability amidst a rapidly changing world.

# Holiday chaos as 3 shot, 1 stabbed in horror airport fight

hree people were shot and another stabbed in a wild family fight at an Arizona airport on Christmas Day — with another man later busted for turning up with guns thinking there was an active shooting, according to cops.

The violence erupted at a presecurity restaurant in Terminal Four of Phoenix Sky Harbor International Airport around 9:45 p.m. when someone pulled out a gun during a fight and opened fire, according to ABC 15.

Three people were found with gunshot injuries, including a woman left fighting for her life, police said.

Phoenix police arrest a man on Dec. 25, 2024, who police said arrived at Sky Harbor with guns after he received a text falsely reporting an active shooter at the airport.

Cops then detained a man with at least one stab wound and an uninjured girl in the airport parking garage, CNN reported.

"I believe this was a family dispute that escalated," Sgt. Mayra Reeson told reporters early Thursday.

About two hours after the shooting, another man turned up



at the airport with several firearms after getting a false text alert that there was an active shooting, Reeson said, according to AZ Central.

"There was no active shooter; there never was," Reeson said.

The alleged gunman was arrested after an altercation with Phoenix police.

Photos showed a shirtless man being wrestled to the ground and then taken into custody, with officers carrying away at least two weapons, including a handgun, the outlet noted. He was not identified.

Four people were rushed to the hospital after the earlier shooting, including the shot woman in critical condition.

Two men who were also shot and the man who was stabbed are all stable, cops said. None of those involved have been identified, but officials emphasized that everyone involved knew each other. No one else was injured.

Police "believe it was a family dispute that escalated."

The shooting forced the terminal's security checkpoint and restaurants to shut down temporarily, airport officials and police told CNN.

No flights were affected and the investigation is ongoing.

Marvin Miller, who's worked at the airport as a cleaner for three years, told AZ Central he heard three gunshots ring out from Terminal 4.

"They were different from fireworks. Gunshots are a big difference," Miller told the outlet as he was getting off his shift.

## Azerbaijan confirms Russian missile shot down plane in Kazakhstan

he passenger plane of Azerbaijan Airlines which crashed near the Kazakh city of Aktau on Wednesday, was attacked by Russian air defence, Euronews reports.

According to Azerbaijani government sources, the Russians hit the plane with a surface-to-air missile.

Euronews' interlocutors clarify that the missile was fired at the plane while it was flying over Grozny, where drone activity was recorded. It exploded near the plane, and its fragments hit passengers and crew members.

Also, according to journalists' sources, the damaged plane was not allowed to land at Russian airports when the pilots requested an emergency landing. The plane was ordered to fly across the Caspian Sea toward Aktau.



Euronews found out that the plane's GPS navigation system was jammed throughout the flight over the sea.

Afterward, photos were posted online showing that the plane's skin was damaged by shrapnel.

Against this background, the head of the Center for Countering

Disinformation of the National Security and Defence Council of Ukraine, Andrii Kovalenko, emphasized that the plane was shot down by a Russian anti-aircraft missile system.

Kovalenko stressed that this happened because the Russians did not close the airspace over Grozny during the drone attack on the city.

347 skiers rescued by helicopter in French Alps By Elizabeth Jenrola Oso

undreds of skiers had to be rescued by helicopter on Christmas day after chairlifts at two different resorts in the French Alps broke down.

Dramatic video shows skiers at SuperDevoluy resort in Dévoluy hanging below a helicopter near a motionless chairlift.

One of the resort's chairlifts broke down around 1 p.m. local time Wednesday due to an electrical problem with one of its motors, reported Nouvelle Republique.

About 240 skiers were evacuated from the lift by around 5 p.m. local time at the resort in France's Southern Alps, where the elevation ranges from 6,000 to 8,200 feet above sea level. No one was hurt, reported Le Monde.



In Savoie, also in the French Alps, around 100 skiers were stuck on a lift Wednesday at the La Norma ski resort, reported TF1, in an unrelated incident. The resort in the Maurienne Valley rises from 4,500 to nearly 9,000 feet in elevation.

The rescues came a day after the death of a 26-year-old Olympic

snowboarder at a resort in the Swiss Alps.

Sophie Hediger, a member of Switzerland's snowboard cross team at the 2022 Beijing Winter Olympics, died in an avalanche at the Arosa resort, the country's ski federation announced Tuesday.

The match was marred by the early dismissal of captain Bruno Fernandes, who received his third red card of the season shortly after the break for a second bookable offence.

The defeat highlights the ongoing challenges facing United, as they continue to grapple with inconsistencies on the pitch.

With Fernandes' dismissal, the team not only lost a key player but also faced an uphill battle against a Wolves side eager to capitalize on their home advantage.

Wolves took full advantage to make it two wins in two games under new boss Vitor Pereira.

Matheus Cunha's goal direct from a corner opened the scoring before he teed up Hwang Heechan with virtually the last kick of the game.

United, who slipped to 14th, have won just twice in seven Premier League games since Ruben Amorim took charge last month and were insipid in attack even before Fernandes' dismissal.

Victory was enough to lift Wolves



out of the relegation zone at the expense of Leicester, who visit leaders Liverpool later.

The optimism that greeted Amorim's early days in charge already seem a distant memory as the Portuguese has been left in no doubt over the scale of the task he faces to turn around a fallen giant.

Amorim reacted to a 3-0 humbling at home to Bournemouth on Sunday by making just two changes.

Leny Yoro came into the defence, while Rasmus Hojlund replaced Joshua Zirkzee up front.

The Dane, though, struggled to whe make any impact as Cunha brar showed the value of a forward in red. form.

Wolves look set to lose their top scorer to suspension over a FA charge for misconduct for a clash with an Ipswich member of staff after a 2-1 defeat earlier this month that cost Gary O'Neil his job.

Only Mohamed Salah, Erling Haaland, Cole Palmer and Alexander Isak have scored more goals in the Premier League this season than the Brazilian international.

United, by contrast, were let down by their talisman.

Fernandes was walking a tightrope from a first-half booking when he recklessly dived in on his Portuguese international team-mate Nelson Semedo two minutes into the second period.

Even the normally argumentative Fernandes had few complaints when referee Tony Harrington brandished a second yellow and a red.

The 30-year-old's first red card of the campaign against Tottenham was overturned on appeal before he was also dismissed in a 3-3 draw at Porto in the Europa League.

### Chelsea 1 vs 2 Fulham: Late win frustrates Blues' Premier League title hopes

ulham grabbed a stoppage-time at Stamford Bridge to frustrate Chelsea's Premier League title aspirations.

Rodrigo Muniz's last-gasp finish sealed a 2-1 win and a first victory at Stamford Bridge for the Cottagers since 1979.

Muniz was in acres of space in the box when Sasa Lukic found him with a low cross to deliver a belated Christmas gift to the elated travelling support.

The Fulham bench emptied in celebration - Chelsea's subs, coaching staff and boss Enzo Maresca slumped back into their seats.

The Blues head coach has repeatedly tempered talk of a title challenge and, after drawing with Everton at the weekend, this Boxing Day derby defeat leaves them reeling.

Chelsea finish this round of matches seven points adrift of Liverpool, who won one of their two games in hand against Leicester later in the day.



Sub Harry Wilson - who had turned another west London derby against Brentford with heroics off the bench earlier this season - cancelled out Cole Palmer's wonderful opener with a closerange header and Fulham capitalised on the counter to score a historic victory over their neighbours.

For Fulham - who have taken points off Liverpool, Arsenal and Tottenham this season - this was another landmark moment of their progression under Marco Silva. Hit by injuries to their midfield, they switched to a back five and weren't at their usual ball-playing best for much of the contest. But when they

pushed forward after the break they showed the pace and precision to take a big scalp. They finish the day level on points with defending champions Man City and on the brink of the European qualification places.

The visitors should have been level well before Wilson's 83rd-minute intervention but Antonee Robinson's usually trusty touch let him down at the crucial moment and allowed Robert Sanchez to smother the shot. Meanwhile, Fulham 'keeper Bernd Leno also caught the eye with several key stops particularly late on when he denied Christopher Nkunku and then Jadon Sancho.
