### Creative economy key to economic diversification - Tinubu By Friday Omosola



resident Bola Tinubu has reaffirmed administration's commitment to harnessing Nigeria's creative economy as a pivotal driver of economic diversification and global influence.

Speaking through Vice President Kashim Shettima at the launch of the 2024 Abuja International Carnival, Tinubu emphasised the sector's growing contribution to Nigeria's non-oil GDP and its role in showcasing the nation's cultural richness.

## Year-end gift: Dangote refinery crashes petrol price

good news has come the way of Nigerians as the Dangote Petroleum Refinery announced on Sunday that it has reduced the price of its Premium Motor Spirit from N990 per litre to N970/litre.

According to a Punch report, this is the amount marketers would buy the product from the refinery.

The Group Chief Branding and Communications Officer of the Dangote Group, Anthony Chiejina, in a statement released on Sunday, said the reduction was to appreciate Nigerians as the year ends.

The statement read, "As the year comes to an end, this is our way of appreciating the good people of Nigeria for their unwavering support in making the refinery a dream come true. In addition, this is to thank the government for their support as this will complement the measures put in place to encourage domestic enterprise for our collective well-being."

Chiejina said the refinery would not compromise on the quality of its petroleum products while assuring Nigerians of the best quality products that are environmentally friendly and sustainable.

"We are determined to keep ramping up production to meet and surpass our domestic fuel consumption; thus, dispelling any fear of a shortfall in supply," the statement concluded.

The Major Energies Marketers Association of Nigeria said on Friday that the landing cost of imported petrol is now N971/litre.

Recently, both independent and major marketers confirmed that the pump prices of petrol had started reducing in many parts of the country due to the competition that the deregulation of the downstream sector has caused.



The spokesman, Independent Petroleum Marketers Association of Nigeria, Chinedu Ukadike, said the agreement between IPMAN and the Dangote refinery is gradually pushing down the price of PMS.

"By just the announcement that IPMAN and Dangote have met and are ready to transact business, the prices of products have crashed. You would have noticed the drop in prices by N10, N15, or so, and this is due to competition.

"Independent marketers are no longer buying from middlemen. We are going to be buying directly from the producer. So, the competition is setting in. I also want to tell you that before the end of this year, the price will not be as high as what you see now.

"You can see how our meeting with Dangote has significantly removed about N10 from the prices of refined petroleum products. It is a good development. We have not even started. Remember I once told you that prices would drop once IPMAN started lifting from Dangote," Ukadike stated.

Also confirming the drop in prices, a major oil marketer stated that this was due to the deregulation of the downstream oil sector.

"People are not noticing that prices are going down, primarily because there are no big announcements. Deregulation is in full swing and competition is the order of the day," the major oil marketer, who spoke in confidence due to lack of authorization to speak on the matter, stated.

### Removal of subsidies saved Nigeria \$20bn – F By Dave Oludare Oso

he Minister of Finance and Coordinating Minister of the Economy, Wale Edun, has said that the country has saved \$20bn by abolishing the petrol subsidy and adopting market-based foreign exchange pricing.

Edun said this at an event in Abuja marking the first 100 days in office of Esther Walso-Jack, Head of the Civil Service of the Federation.

President Bola Tinubu had in May last year announced the removal of fuel subsidy effective June. This led to an increase in petrol prices across states in the country.

Speaking on the development, Edun said that subsidies were costing the country about five per cent of Gross Domestic Product.

He said, "An amount of five per cent of GDP is what those two subsidies were costing. When there was a subsidy on PMS and on foreign exchange, they collectively cost five percent of GDP. Assuming GDP was \$400bn on average, five percent of that is \$20bn—funds that could now go into infrastructure, health, social services, and education."

He further explained that the savings are being redirected into developmental projects.

"The real change is that no one can wake up and target cheap funding or forex from the central bank to enrich themselves without adding value. Similarly, profiteering from the inefficient petrol subsidy regime is no longer possible," he added.

Fuel subsidies in Nigeria have been a significant and contentious issue for decades. The subsidies were introduced to make petroleum products, particularly petrol, more affordable for citizens by offsetting a



portion of the cost for consumers.

However, they have often been criticized for inefficiency, corruption, and straining government finances.

While the removal freed up government funds, it led to increased costs for transportation, goods, and services, worsening inflation.

The decision was met with protests and criticism due to its immediate impact on the cost of living, particularly for low-income households.

The government had proposed initiatives like cash transfers and investments in public transportation to cushion the effects of subsidy removal.

The debate on whether the removal will lead to long-term economic benefits remains ongoing. While it allows the government to save funds previously spent on subsidies, the success of the policy hinges on how effectively the savings are reinvested to benefit the population.

# Nigeria, Brazil sign agreement to boost agribusiness

n a major stride towards advancing agribusiness in Nigeria, the Federal Government has signed a Memorandum of Understanding (MoU) with Brazil's Fundação Getulio Vargas (FGV) to foster private-sector investment in fertiliser production, hybrid seed technology, and agricultural finance.

The MoU was signed by Nigeria's Permanent Secretary of the Ministry of Agriculture and Food Security (FMAFS), Temitope Fashedemi, and FGV President Professor Carlos Ivan Simonsen Leal during the G20 Leaders' Summit.

This collaboration builds on the Green Imperative Project (GIP), a \$1.2 billion agricultural modernization initiative launched in 2018 to leverage Brazil's expertise in tropical agriculture for Nigeria's benefit.

Over the next five years, the project will identify and support agribusinesses across Nigeria's 774 local government areas, providing technical and financial resources for sustainable development.



"This partnership paves the way for Brazil to engage with Nigeria's dynamic and rapidly growing agricultural sector," said Fashedemi. "Together with FGV, we are poised to unlock the potential of private-sector investment in critical areas for food security."

The project, supported by Deutsche Bank, aims to attract \$4.3 billion in private-sector investment and drive

transformative agricultural technologies and knowledge transfer.

Senior officials from Nigeria's presidency, FMAFS, and FGV leadership attended the signing ceremony, reinforcing the significance of this collaboration in strengthening Nigeria's agricultural landscape.

The oldest cleric in Nigeria, Thomas Oleghe, is dead.

Oleghe, a Catholic priest, died at the age of 104.

According to a statement by Gabriel Dunia, the Bishop of Auchi, Oleghe passed away at approximately 2:30 am on Sunday and will be buried on Wednesday, November 27, 2024.

The statement read: "With gratitude to God for a life well lived on earth, I hereby inform you of the passing of the Rt. Rev. MSGR Thomas Oleghe, the oldest Catholic priest in Nigeria

as of today, to the great beyond at approximately 2:30 am this morning, November 24, 2024.

"He was of the Diocese of Auchi. He died at the age of 104. May his lovely and gentle soul continue to rest in perfect peace. Amen.

"We have resolved to celebrate his funeral on Wednesday, November 27, 2024."

In his address, Dr Shehu emphasised the critical need for Nigeria to diversify its revenue base to ensure fiscal independence and enhance economic resilience.

#### FG audit exposes N197bn contract fraud in MDAs By Dave Oludare Oso

he Auditor-General of the Federation's 'Annual Report on Non-Compliance and Internal Control Weaknesses' has exposed irregular payments for contracts totalling over N197.72 billion across various ministries, departments, and agencies (MDAs), raising serious concerns about systemic lapses in financial compliance and procurement processes.

The report covers activities between 2020 and 2021.

They reveal violations of established financial regulations and procurement laws, with irregularities affecting multiple MDAs.

The report was released to assist stakeholders, including the Public Accounts Committees of the National Assembly, in addressing these lapses and recovering the lost funds.

One of the key findings in the report revealed irregularities in the award of contracts totalling N7.39 billion.

The breaches occurred in 32 MDAs and contravened Paragraph 2921(I) of the Financial Regulations (2009), which mandates open competitive bidding for all procurement processes.

The Rural Electrification Agency in Abuja recorded the highest irregularity in this category, amounting to N2.12bn, while the Nigerian Security Printing and Minting Company Plc had the least irregularity, at N11.72m.

The audit report read, "The sum of N7,386,551,051.09 (seven billion, three hundred and eighty-six million, five hundred and fifty-one thousand, fifty-one naira, nine kobo) was the amount of irregularities in the award of contracts by 32 ministries, departments and agencies.

"The Rural Electrification Agency, Abuja, has the highest amount of N2,117,143,168.09 (two billion, one hundred and seventeen million, one hundred and three thousand, one hundred and sixty-eight naira, nine kobo), while the Nigerian Security Printing and Minting Company Plc (NSPM) has the least amount of N11,720,000 (Eleven million, seven hundred and twenty thousand naira)."

Another alarming revelation in the report was the sum of N167.59bn paid for jobs or contracts that were either partially executed or not executed at

The Nigerian Bulk Electricity Trading Plc in Abuja accounted for N100bn of these irregular payments, making it the highest in this category.

The National Centre for Women Development recorded the lowest irregularity at N2.17m.

The report read, "The sum of

N167,592,177,559.40 (one hundred and sixty-seven billion, five hundred and ninety-two million, one hundred and seventy-seven thousand, five hundred and fifty-nine naira, forty kobo) was the amount of payments for jobs/contracts not executed by 31 ministries, departments and agencies.

"The Nigerian Bulk Electricity Trading Plc., Abuja, has the highest amount of N100,000,000,000.00 (one hundred billion naira), while the National Centre for Women Development has the least amount of N2,171,766.44 (two million, one hundred and seventy-one thousand,



seven hundred and sixty-six naira, forty-four kobo)."

The report also uncovered violations of due process in contract awards amounting to N20.33bn across 24 MDAs.

Section 16(21) of the Public Procurement Act (PPA) 2007 requires strict adherence to procurement plans and mandatory approvals before contract awards.

Chidimma Adetshina, whose father is Nigerian, was crowned Miss Universe Africa and Oceania and was runner-up to Denmark's Victoria Kjar Theilvig in Mexico on Saturday night.

The 23-year-old law student withdrew from the Miss South Africa competition in August, saying that she needed to protect herself and her family after the government alleged that her mother had stolen the identity of a South African woman.

The matter is being investigated by South African police.

"I have already decided that I want to relocate to Nigeria," Adetshina said, adding that she did not know whether she could go back to South Africa and that she would work with a lawyer in the hope of getting the situation resolved by the end of the year.

As Adetshina progressed through the Miss South Africa

competition, she faced relentless abuse from South Africans who questioned her citizenship because of her Nigerian name and father. She was then invited



to compete in Miss Universe Nigeria in August, and won.

### Ministry seeks EFCC's support in fighting illegal mining in Port Harcourt

he Ministry of Solid Minerals, under the aegis of the Federal Mines Officers, has called on the Economic and Financial Crimes Commission (EFCC) to join the fight against illegal mining activities in Port Harcourt and beyond.

The appeal was made during a courtesy visit to the EFCC's Port Harcourt Zonal Directorate.

Speaking on behalf of the delegation, the President of the ministry's Port Harcourt branch, Engr. Naku Romos highlighted the detrimental effects of illegal mining on the nation's economy and the already compromised Niger Delta environment.

Romos, who assumed office in September 2024, emphasised the need for collaboration between the Ministry and law enforcement agencies, noting that the ministry alone cannot combat the menace.

"Illegal mining constitutes economic crimes and causes significant damage to the ecosystem. The federal government is losing substantial resources due to these activities," he stated.

He further explained that the Ministry of Solid Minerals Development, tasked with regulating the mining sector, traditionally engages relevant agencies like the EFCC, Police, and DSS to strengthen efforts







Romos also stressed the importance of preventive measures and enforcement to safeguard the country's natural resources.

However, the Acting Director of the Port Harcourt Zonal Directorate, Adebayo Adeniyi, assured the delegation of the EFCC's readiness to collaborate on tackling illegal mining.

He noted that addressing the issue is a top priority for the Commission's Executive Chairman, Ola Olukoyede, who has established a Special Task Force across EFCC directorates for this purpose.

Adeniyi revealed that the Port Harcourt Directorate is already investigating several cases of illegal mining and encouraged the





enlightenment campaigns to educate miners about the legal requirements and environmental impacts of their activities.

"Enlightenment is key to ensuring that miners understand their responsibilities. For those who refuse to comply, submit a formal petition to us. We will take decisive action to stop the illegal exploitation of our natural resources and environmental degradation," Adeniyi assured.

He added that the EFCC would adopt an aggressive approach to curbing illegal mining in the Niger Delta, reiterating its commitment to preserving the region's resources and ecological balance.

### NDLEA nabs cocaine kingpin in Lagos

... Dismantles drug syndicate run by Chinese man

he head of a cocaine distribution cartel, Ndive Maxwell Obinna, has been arrested by operatives of the National Drug Law Enforcement Agency, NDLEA.

The 42-year-old was arrested with five of his associates at Ago Palace Way in Okota, Isolo, Lagos.

A total of 2.412 kilograms of cocaine were recovered from them.

Other members of the drug trafficking organization arrested along Obinna include: Okeke Gloria Ifeoma who is the syndicate's stash keeper; Ikechebelu Emmanuel Chibuzor; Okorie Onyedikachi; Okonkwo Nnabugo Prince; and Okafor Blessing Anita.

#### Chinese man's cartel dismantled

In a related development, another drug syndicate operated by a Chinese man, 58-year-old Tianzhen Yen (alias Jackie) has been dismantled by



NDLEA operatives.

The NDLEA operatives achieved their goals after arresting Jackie at his hotel in Ikeja area of Lagos.

Officers of the Seme Special Area Command of the Agency had on Thursday 21st November intercepted a 40-year-old suspect, Yakubu Emmanuel Mark in a commercial bus going to Ghana at the Gbaji checkpoint along Badagry-Seme expressway based on credible intelligence.

When he was searched, a total of 750grams of cocaine were found in his bag.

A swift follow up operation was organized to trace and arrest the kingpin behind the trans-border drug trafficking syndicate, who turned out to be a Chinese citizen, Tianzhen Yen.

#### 12 internet fraudsters jailed in Adamawa

he Adamawa State High Court has convicted and sentenced twelve internet fraudsters to various jail terms following their arraignment by the Gombe Zonal Directorate of the Economic and Financial Crimes Commission (EFCC).

The sentencing, delivered by Justices Kayanson Samuel Lawanson, Hammed Isha, Benjamin Manji Lawal, and Mohammed Ibrahim Tola, followed the defendants' guilty pleas to charges of cheating and impersonation.

The convicts include Oladele Pius, Emmanuel Bulus, Elijah Elisha, Alamin Mohammed Bappa, Jamilu Usman, Enoch Solomon, Emmanuel Anthony, Enebeli Samuel Israel, Dimas Hyellabulatin, Emmanuel Dike, Joshua Umoru, and Dan Eden Sunday. Each convict was arraigned

between November 6 and 7 on separate charges. One charge against Alamin Muhammad Bappa revealed he had created fake Gmail and Facebook accounts under the name "Jacob Sermon" to pose as a cybersecurity professional, defrauding unsuspecting foreign nationals of \$20 per service fee.

Another charge against Oladele Pius accused him of impersonating a foreign national, "Legit Hassan Abbadin," using WhatsApp for fraudulent financial transactions.

Upon arraignment, all defendants pleaded guilty. Prosecution counsels Saad H. Sa'ad and M.D. Aliyu urged the court to convict and sentence them accordingly. However, defence counsels pleaded for leniency.

Justice Lawanson sentenced Bulus. Elisha, Usman, and Israel to ten years imprisonment or a fine of  $\aleph$ 200,000 each. Hyellabulatin received five years imprisonment or a fine of ₩200,000.



#### Famous singer, Helen Ukpabio sues 'Bloody Civilian' By Elizabeth Jenrola Oso for N200bn in defamation suit

he President and founder of Liberty Foundation Gospel Ministries, Helen Ukpabio, has threatened to sue singer Emoseh Khamofu, popularly known as Bloody Civilian, for alleged defamation, demanding N200 billion in damages.

This was stated in a letter dated November 25, 2024, which Bloody Civilian retweeted on Saturday, November 23, 2025.

In the letter, the Akwa Ibom-born pastor, through her legal counsel—Victor Ukutt and Co. Legal Practitioners—issued the demand under the title, "Demand for Public Apology and Compensation for the Libel of Imaobong Elijah Ukpabio and Apostle Helen Ukpabio."

According to PUNCH Online on Sunday, the controversy began when an X (formerly Twitter) user identified as #OneJoblessBoy posted the pastor's photo on Friday with the caption, "Pastor Helen Ukpabio turns

60 today." The tweet garnered significant attention, amassing 4.6 million views and a flurry of reactions.

Bloody Civilian later retweeted the post with the claim, "She literally made people burn their children alive."

This comment sparked a response from the pastor's daughter, Imaobong Ukpabio, who tweeted under the handle #ima Elijah, demanding that Bloody Civilian delete the post within five hours or face legal action.

"I give you the next five hours to take this down, or I will educate you in court!" Imaobong warned.

In the letter, signed on behalf of the firm by its General Counsel, Victor Ukutt, Bloody Civilian's tweets were described as "reckless, satanic, and libellous."

The firm maintained that the allegations were "grossly false and

devoid of any iota of truth," accusing the singer of intending to "ridicule" their clients.

The letter partly read: "Our clients' attention has been drawn to your reckless, satanic, and libellous posts on X (formerly Twitter), one of the world's largest social media platforms. Using your verified account, #bloody\_\_civ, on 22 November 2024, you wrote: 'She

he president of the Actors Guild of Nigeria (AGN) Emeka Rollas, shed light on the guild's decision regarding potential legal action against actress and producer Adanma Luke in the wake of the tragic death of actor Junior Pope.

The incident, which shook the Nigerian film industry, occurred on April 10, 2024, when Junior Pope, alongside four crew members, lost their life after a boat capsized in the River Niger, near Asaba in Delta State.

The group was en route to a movie location for the film entitled "The Other Side of Life," which featured Junior Pope in a leading role, under the production of Adanma Luke.

Following the harrowing event, the AGN swiftly suspended Adanma Luke as part of their investigation into

the circumstances surrounding the accident.

However, Rollas has now revealed why the guild opted not to pursue legal action against the producer.

According to him, the keys to taking such a step were hindered by contractual obligations and membership requirements.

It has been confirmed that Junior Pope was not a dues-paying member of the AGN at the time of his unfortunate demise.

Instead, the guild's regulations stipulate that only direct family members or the spouse of the deceased have the standing to sue in cases like this.

During a candid discussion on Arise

TV, Rollas emphasized the importance of clear contractual guidelines, noting that the advisement of AGN's legal team pointed to a significant limitation in their ability to take legal action.

## Guardiola warns of title hopes dashing with defeat to Liverpool

anchester City manager, Pep Guardiola, has acknowledged that his side's aspirations to win a fifth consecutive Premier League title could be shattered if they suffer another defeat to tabletoppers Liverpool next Sunday.

Guardiola made the statement after watching his team endure a 4-0 loss to Tottenham Hotspur on Saturday, marking their fifth defeat across all competitions and their third consecutive league defeat.

The loss leaves City with a daunting 11-point deficit behind Liverpool, who can extend their lead to eight points if they secure a victory against Southampton on Sunday.

In an interview with ESPN, Guardiola conceded that an 11-point gap would be difficult to close, even with the majority of the season still to play. "Yeah, it's true," he said when asked if the gap would be insurmountable. "We're not thinking about winning or losing the title. We are not in the situation to think about what is going to happen at the end of the season."



The City boss continued, "If in the end we don't win it, it's because we don't deserve it. We won it in the past because we deserved it."

Guardiola's comments reflect the gravity of the situation for City, who, despite their past dominance, are now facing a significant challenge to retain their Premier League crown.

The defeat to Tottenham was another setback in a difficult stretch for City, raising concerns over their ability to maintain their competitive edge in the league.

As the pressure mounts, the upcoming match against Liverpool could prove crucial to Manchester City's title hopes this season.
