### Sunday Igboho: Ethnic groups should separate if Nigeria isn't working By Friday Omosola

oruba Nation advocate, Sunday Adeyemo, popularly known as Sunday Igboho, has renewed his call for the secession of the Yoruba people from Nigeria. Sunday Igboho gained prominence for his agitation for Yoruba independence

during the administration of former President Muhammadu Buhari, a movement that led to his imprisonment.

In October 2023, he regained his freedom in Benin Republic, where he had been detained following his escape from Nigerian authorities in 2021.

In February 2024, he returned to Nigeria after nearly three years in exile.

In a viral video online on Thursday he expressed concerns over the declining sense of patriotism among Nigerians,

# **Police nab human traffickers with 59** children in FCT By Elizabeth Jenrola Oso

he police command of the Disu said preliminary Federal Capital Territory (FCT) has intercepted a group of suspected human traffickers transporting 59 children.

The FCT police commissioner, Tunji Disu disclosed that operatives led by Deputy Superintendent of Police (DSP) Sarki Umar halted a white Peugeot 15-seater bus, commonly known as a J5 on January 6.

The vehicle was en route to Nasarawa State when it was intercepted.

According to Disu, the bus was carrying children aged between four and 12 years, allegedly trafficked from Kano.

He added that Ali Ibrahim, the driver, and Alhassan Ibrahim, his assistant, both Kano State residents, were arrested on the spot.

investigations showed that the children were being transported to Nasarawa under the guise of receiving training.

"On January 6, 2025, at about 1530 hours, a team led by deputy superintendent of police Sarki Umar intercepted a white Peugeot 15 bus with Reg. No. KMC 283 ZJ along the Abuja-Kano route," he said.

"The vehicle was driven by Ali Ibrahim, a male resident of Kano State, accompanied by his motor boy, Al-Hassan Ibrahim, also of Kano State.

"The bus was found to be transporting 59 male children aged between 4 and 12 vears.

Preliminary investigations revealed



that the children, who came from different families, were being transported by one Idris Usman, a male resident of Nasarawa State.

"He allegedly travelled to Kano State to convene the children en route to Nasarawa State under the pretext of training them."

# Court remands teacher for assault on 3-year-old in Lagos By Friday Omosola

The New Daily Prime earlier reported that the Lagos State Police Command arrested Nwadigo after the disturbing footage went viral.

Providing an update on Thursday, the Lagos State Domestic and Sexual Violence Agency (DSVA) confirmed that the teacher has been remanded in a correctional facility.

DSVA revealed that Nwadigo appeared before Magistrate M.O. Kusanu and was arraigned on two charges.

She pleaded not guilty to the allegations. Her defence counsel applied for bail, which the court

granted at №200,000 with two verifiable sureties.

### Jihadists kill 28 Beninese soldiers near Niger, Burkina border

ot less than 28 soldiers were killed in an attack in northern Benin as violence blamed on jihadists based in neighbouring countries increases, a security source told AFP on Thursday.

According to the high-ranking official, the strike took place on Wednesday evening near the border with insurgency-hit Burkina Faso and Niger.

Reports say attacks in northern Benin have increased in recent years with authorities accusing members of the Islamic State and Al-Qaeda groups based in neighbouring countries.

The military source said, "We are continuing cleaning-up operations. Forty assailants have been neutralised so far."

The violence has largely struck the border area with Burkina Faso.

Gunmen in December killed three soldiers and wounded four others who were guarding an oil pipeline in By Elizabeth Jenrola Oso

northeast Benin.

In June, seven Beninese troops were killed in an attack at the Pendjari National Park on the border with Burkina Faso.

Beninese authorities, who rarely comment on attacks, reported in April 2023 about 20 cross-border incursions since 2021.

A diplomatic source told AFP that 121 Beninese military

personnel had been killed between 2021 and December 2024.

"Currently, it is clear that the threat is intensifying, the more the situation in Niger and Burkina Faso deteriorates, the harder it gets for Benin," the diplomatic source said earlier this week.

The source added that the Beninese army was still "under construction"



and faced the challenge of training its forces while remaining operational.

"There are results, (the Beninese army) can kill terrorists but do not want to communicate about it so it is not always visible — especially so as not to inform the jihadists of their strategy and because it is anxietyinducing", the source also said.

Benin in January 2022 deployed nearly 3,000 troops to secure its borders as part of Operation Mirador.

# Lagos Commissioner, Toke Benson denies slapping allegation

• The Lagos State Commissioner for Tourism, Arts and Culture, Mrs. Toke Benson-Awoyinka has denied reports that she physically assaulted a man by slapping him for recording her on phone.

In a widely circulated video by Sahara Reporters, the Commissioner was seen asking a man recording her with his phone to leave the premises but the unidentified man responded that no one will leave the venue.

The commissioner who got up from her seat later approached the man and said 'Maa fo phone owo e' (literally translated as 'I will smash the phone you are recording with').

An unidentified man was heard shouting 'How dare you slap him?'.



Benson-Awoyinka said she never slapped or physically assaulted anyone.

"No, I slapped no one. Absolutely no one" she said.

The video has generated mixed reaction from netizens, as many are calling for a thorough investigation into the incident.

### NAFDAC DG reveals agency is severely understaffed By Gbenga Oluranti Olaleye

The Director-General of the National Agency for Food and Drug Administration and Control (NAFDAC), Professor MojisolaAdeyeye, has revealed that the agency is severely understaffed, with its current workforce falling far short of the necessary numbers to effectively carry out its duties.

In a news conference held on Thursday in Lagos, Adeyeye disclosed that the agency is operating with approximately 2,000 staff members, despite the fact that, based on Nigeria's population, NAFDAC should have a workforce of no less than 10,000.

She explained that the number of staff needed by any regulatory agency depends on the population size it serves. "It is easier to regulate a country with one million people than a country with 300 million people," she stated.

The NAFDAC Director-General expressed the strain the agency's current staff is under, emphasising that they are "burning candles at both ends" to safeguard the health of Nigerians. Adeyeye clarified, however, that the agency is not asking for the full complement of 10,000 staff immediately but instead is requesting an increase of "double or triple" the number currently employed.

Looking ahead to 2025, Adeyeye outlined five key strategic pillars that NAFDAC will focus on to strengthen its regulatory role and protect the nation's health.

These pillars are: strong governance and leadership, maternal, newborn, and child health, institutionalising best practices, ensuring the safety and quality of regulated products, and enhancing the monitoring of the supply chain.

Reflecting on the past seven years of leadership, Adeyeye expressed pride in NAFDAC's accomplishments, while also acknowledging that much more remains to be done. She highlighted the need to continually strengthen the regulatory system to ensure the protection of the public health.

"Reflection on the past seven years has brought into focus the many



accomplishments that have been achieved in NAFDAC, and so many others to be attained," she said. "This realisation has sharpened my focus on how to strategically work towards continued strengthening of the regulatory system."

In line with NAFDAC's vision for 2025, the agency will focus on improving access to quality regulated products. Strong governance and leadership will be central to ensuring that staff remain motivated and disciplined, with an emphasis on continuous training and development. A deyeye highlighted that the agency's focus would particularly centre on maternal, newborn, and child health, noting that the safety and quality of regulated products are critical in reducing maternal deaths and child morbidity.

She specifically mentioned the importance of paediatric antimalarials and antibiotics, emphasising that manufacturers would be encouraged to develop paediatric medicines and work towards achieving WHO prequalification.

As the agency prepares for the year ahead, NAFDAC remains committed to enhancing the safety of regulated products and contributing to the wellbeing of Nigerians, despite the significant challenges posed by its understaffing.

# Police restructure strategies to tackle kidnapping, rescue victims By Friday Omosola



o bolster internal security and ensure the safety of Nigerians, the Nigeria Police Force has reiterated its commitment to re-strategize operations to combat kidnapping and related crimes nationwide.

In a statement, police spokesperson Olumuyiwa Adejobi highlighted the force's determination, showcasing their operational expertise and coordination during a recent hostage rescue mission.

On December 31, 2024, operatives of the Nigeria Police carried out a successful rescue operation in Kwande Local Government Area (LGA) of Benue State. The operation resulted in the neutralization of three kidnappers.

Adejobi disclosed that officers from the Vandiekya Police Divisional Headquarters responded swiftly to a distress call reporting the abduction of one Tor Gajir by unidentified gunmen in Kwande LGA.

Upon receiving the report, the police immediately escalated their investigation, which led them to a suspect identified as Desmond Ahar. The suspect was apprehended and, under interrogation, admitted to being part of the kidnapping syndicate.

Ahar subsequently led the police to the location where the victim was being held in Adikpo, Benue State, enabling the successful rescue of Tor Gajir.

"Upon arrival at the kidnappers' den, the kidnappers spotted the police operatives and immediately engaged them in a gun duel. In the ensuing confrontation, officers were able to neutralize three of the suspects, while others fled with bullet wounds.

"The victim was rescued unhurt and immediately given medical attention to assess any physical or psychological impact. The success of the operation also led to the recovery of 2 AK-47s and 6 loaded magazines, with several live ammunition. Efforts are intensified to apprehend the fleeing member of the gang and recover other arms", he said.

Adejobi revealed that during a similar operation in Nasarawa State, police operatives from the state command discovered an abandoned Sienna vehicle on December 28, 2024, along the Keffi-Kaduna Highway in Angwan Wayo Village, suspected to have been involved in an attack.

He explained that the operatives followed the trail, uncovering and rescuing two hostages who had been abducted by kidnappers. The victims were rescued unharmed, while efforts to apprehend the fleeing kidnappers remain ongoing.

Adejobi further disclosed that on January 7, 2025, police operatives from the Bayelsa State Command intercepted a suspect, Usman Mohammed, while he was en route to Rivers State.

"A thoroughly conducted search led to the recovery of 1 AK-47 rifle, 1 Type 09 AR, 2 AK-47 Magazines, 2 Type 09 AR Magazines, and 120 rounds of ammunition of various calibres concealed in the vehicle. The suspect has been arrested, and the investigation is still ongoing."

He stated that Inspector-General of Police (IGP) Kayode Egbetokun praised the operatives for their remarkable achievements, both in the affected states and across the nation.

Adejobi mentioned that the IGP urged the operatives to maintain their momentum in achieving excellence in internal security and public safety across Nigeria.

Adejobi said, "The incidents highlight the bravery and dedication of our police officers to keep our communities safe. The IGP further encourages members of the community to remain vigilant and volunteer to play their role towards ensuring public safety and general security in Nigeria."

# Navy dismantles illegal refineries in Ondo

he Nigerian Navy's Forward Operating Base (FOB) in Igbokoda has dismantled nine illegal refinery sites and confiscated 20,000 litres of crude oil along with 15,000 litres of illegally refined diesel in the Obenla community, located in Ilaje Local Government Area of Ondo State.

Navy Captain Aliyu Usman, Commander of the Base, revealed this during a press briefing on Thursday.

According to him, the operation, conducted on January 6, 2025, was basedon credible intelligence.

Usman described the operation as a significant milestone in the Navy's commitment to combating illegal activities and protecting Nigeria's



environment.

He further urged residents of the Obenla community to desist from supporting or harbouring illegal activities, highlighting the environmental and economic dangers associated with crude oil theft and illegal refining. The Commander also advised those involved in such unlawful ventures to embrace legitimate means of livelihood, assuring that the Navy would not relent in its mission to uphold security and order.

However, the hike will fall short of the 100 percent increase requested by service providers, with the government seeking to balance sector growth and protecting Nigerians from excessive financial burdens.

Bosun Tijani, the minister of communications, innovation, and digital economy, disclosed this during an industry stakeholder forum in Abuja on Wednesday.

"The essence of this gathering is recognizing the critical role the telecom sector plays in driving Nigeria's economic development," Tijani said. it won't be by 100%. We need to ensure that as a sector, we put the right regulations in place that can ensure the growth of this sector, continue to contribute to job creation, but also enable other key sectors in the country as well."

He disclosed that the government had commissioned a study to evaluate the financial needs of the telecom sector while minimizing the potential impact on consumers.

Aminu Maida, Executive Vice C h a i r m a n , N i g e r i a n Telecommunications commission (NCC), noted that tariff adjustments will be accompanied by measures to simplify billing systems and increase transparency.

"We've revised our quality of service regulations, bringing the entire value chain into scope for compliance, from MNOs to tower codes and transmission companies. "So when we do see these tariff modifications, it's also going to come with simplification. So every MNO or every service provider must comply with a simplified template. To show Nigerians what you are charging per minute, per voice, per SMS, and per megabyte of data.

"We're moving away from a regime where you have a main rate, then a bonus at a different rate, which complicates understanding."

Maida emphasized the need for meaningful connectivity and highlighted the government's commitment to investing in infrastructure to ensure quality service across Nigeria.

He noted that while private sector investment had traditionally driven the sector, the government was stepping in to accelerate development.

# NCDC allays fears over HMPV, says no cause for alarm By Friday Omosola

The Nigeria Centre for Disease Control (NCDC) has assured Nigerians that the Human Metapneumovirus (HMPV) does not currently pose a significant threat to the country.

The New Daily Prime earlier reported about the HMPV, the virus outbreaks which has raised global concerns in some regions.

Speaking on Channels Television's Sunrise Daily on Thursday, NCDC Director-General Jide Idris stated that there is no need for alarm.

He added that HMPV is not a new virus but just not widely known, saying "Over the years, it has been linked to respiratory infections, particularly among children and the elderly."

Idris noted that HMPV is similar to other respiratory viruses, such as the flu and influenza, which are common causes of respiraory illnesses.

Idris emphasised that the NCDC is closely monitoring the global situation and remains on high alert, with no reported cases of HMPV in Nigeria.

"We are in a monitoring and alert phase, and that's why a g a in we t a k e instructions from WHO globally because every country is supposed to report cases like this, any case; any problem to WHO – those things that they consider might become global problems later so that they can alert every

other country to get prepared," he said. Drawing from Nigeria's experiences with past outbreaks like Ebola and COVID-19, Idris noted that the country has developed robust public health infrastructure and capabilities.

As precautionary measures, the NCDC advises Nigerians to avoid overcrowded areas, practice regular handwashing, and follow general hygiene protocols to reduce the risk of infection.

### Sanwo-Olu signs record-breaking N3.366trn Lagos

Lagos State Governor, Babajide Sanwo-Olu, has signed the 2025 Appropriation Bill into law, approving a record-breaking budget of N3.366 trillion. The budget, themed "Budget of Sustainability," aims to provide a blueprint for continuity, resilience, and prosperity for Lagos residents.

The governor presented the Appropriation Bill to the Lagos State House of Assembly on November 21, 2024, proposing a total budget size of N3.005 trillion, comprising a total revenue of N2.597 trillion and deficit financing of N408.902 billion. The assembly later increased the budget to N3.366 trillion, which was passed into law.

According to Sanwo-Olu, the budget has a recurrent expenditure of N1.239

trillion, representing 41% of the total budget, and a capital expenditure of N1.766 trillion, representing 59%. The deficit financing will be sourced from external and internal loans and bonds.

The sectoral allocation in the budget shows that Economic Affairs will receive N908.699 billion, Environment will get N233.176 billion, Health will receive N204.005 billion, Education will get N208.376 billion, Security, Safety, and

Public Order will receive N124.073 billion, and Social Protection will get N47.077 billion.

The approved budget is made up of N1.295 trillion as recurrent expenditure and N2.071 trillion as capital expenditure



for the year ending December 31, 2025. Sanwo-Olu stated that the budget is a blueprint for continuity, resilience, and prosperity for residents, and it will drive the state's development agenda.

# Umahi sets deadlines for contractors handling federal projects By Friday Omosola

The Minister of Works, David Umahi, has reiterated the federal government's (FG) commitment to completing critical infrastructure projects across Nigeria, setting strict expectations for contractors during his inspection of road projects in the South-East and South-South geopolitical zones.

During the tour, which began on January 7, 2025, Umahi visited several major projects, including the Enugu-Port Harcourt Expressway, the East-West Road, and the Bodo-Bonny Road.

While expressing satisfaction with some of the work done, the Minister also issued stern warnings to contractors lagging behind schedule, emphasising the need to meet deadlines.

insisted on faster progress.

He warned the contractor to deploy more resources or risk the re-scoping and re-award of the project if it is not delivered by the April 2025 deadline.

Inspecting the Enugu-Port Harcourt Expressway, Section III (Umuahia–Aba), Umahi praised Arab Contractors (Nig.) Ltd for their work but directed them to expand operations by deploying resources to two additional sites to meet the project timeline.

In Section IV (Aba-Port Harcourt),



managed by China Civil Engineering Construction Company (CCECC), the Minister expressed displeasure at the slow pace, citing the contractor's underutilization of the N21 billion allocated in 2024.

He instructed the Federal Controller of Works in Rivers State to issue a warning, with termination as a potential consequence if no improvements are made.

The Minister also visited the Bodo-Bonny Road, a crucial infrastructure project comprising a 2-lane road, 17 bridges totalling 3,200 meters, and reinforced concrete pavements.

Despite the contractor, Julius Berger Nigeria Plc (JBN), working through the holidays, Umahi was dissatisfied with the progress and urged an increase in manpower and materials deployment.

Throughout his visits, Engr. Umahi emphasised the FG "Renewed Hope Agenda" which prioritises infrastructure development as a driver of economic growth.

He instructed Federal Controllers of Works to ensure the commissioning of at least four completed projects each between February and May 2025.

"There is no room for delays", the Minister stated firmly. "Contractors failing to meet their obligations will face a 14-day termination notice. The Ministry will enforce strict measures to ensure timely delivery."

# Tinubu seeks enhanced currency swap between China, Nigeria By Friday Omosola

President Bola Tinubu has called on the Chinese government to increase its currency swap arrangement with Nigeria, emphasising the need for deeper economic collaboration to fast-track infrastructure development.

The president made this appeal on Thursday during a meeting with the Chinese Foreign Minister, Wang Yi, at the State House in Abuja.

Tinubu highlighted the inadequacy of the current \$2 billion currency swap deal, urging China to consider a significant increase.

"We still demand more in the area of currency swap. The level you have approved as a government for Nigeria is inadequate considering our programme. If you can increase that, it will be well appreciated. Our bond should grow stronger and become unbreakable," Tinubu said.

He also called for a review of the \$50 billion aid package pledged by Chinese President Xi Jinping to support Africa, stating that the continent's infrastructure needs surpass the current commitment.

He stressed the urgency of rapid development to ensure Africa keeps pace with other regions, adding, "Africa values the relationship with China, and we seek deeper collaboration for infrastructural development."

In a push for global influence, Tinubu requested China's support for Nigeria's bid for a permanent seat on the United Nations Security Council.



"You are a member of the UN Security Council. We want you to use your influence to ensure Nigeria secures the seat," the President said.

The president reflected on his visit to China during the Forum on China-Africa Cooperation (FOCAC), noting that several Memoranda of Understanding (MOUs) and action plans were signed.

To ensure their implementation, Tinubu appointed Joseph Tegbe as Director General and Global Liaison for the Nigeria-China Strategic Partnership.

He expressed optimism about advancing the bilateral relationship, adding, "We are ready to meet developmental goals and contribute counterpart project funding."

Tinubu also extended condolences to China over the recent earthquake in Tibet, commending the Chinese government for its swift response.

Meanwhile, Wang Yi expressed gratitude

for Nigeria's adherence to the "One-China" principle and pledged China's support for Nigeria's "Renewed Hope Agenda," regional security, and counterterrorism efforts.

The foreign minister revealed that Chinese investments in Nigeria would prioritize job creation and infrastructure, with funding for development projects already underway through the Chinese National Development Bank.

Yi also assured Nigeria of China's backing for its bid to join the BRICS group and its inclusion in the United Nations Security Council, describing the latter as "a historical injustice that should be corrected."

He further commended President Tinubu's leadership, stating, "You brought Renewed Hope to the people of Nigeria. Your economy has sustained sound momentum, and Nigeria's global influence has steadily increased. Under your leadership, Nigeria will achieve greater heights."

### Ganduje backs APC spokesman, dismisses Obi's threat-to-life claim By Friday Omosola

The National Chairman of the All Progressives Congress (APC), Abdullahi Ganduje, has dismissed allegations made by Peter Obi, former Anambra State governor, claiming the party Publicity Secretary, Felix Morka threatened his life.

The New Daily Prime earlier reported that the 2023 presidential candidate of the Labour Party (LP) on his X page claimed Morka said he would face consequences for crossing the line with President Bola Tinubu's led administration.

He further alleged that the statement led to threats to his life, family and associates.

According to Ganduje, the claims arose from a misinterpretation of remarks made by APC National Publicity Secretary Felix Morka during an interview on Arise TV's "ThisDay Live" on January 4, 2025.



He clarified that Morka's comments neither threatened Obi nor his family, but rather addressed criticism of government policies.

The APC Chairman stressed that as a public figure, Obi has a responsibility to disseminate accurate information, warning that spreading falsehood erodes public trust.

He defended Morka's remarks, stating they were part of his duties as APC spokesperson to hold opposition figures accountable, as expected in a democracy.

He further emphasised the importance of free speech, which he said applies equally to all Nigerians, including members of the ruling party.

Ganduje urged Obi to embrace constructive criticism as part of the democratic process, rather than resorting to misinformation.

"Does Mr Obi expect the APC to remain silent while the opposition spreads falsehoods unchecked?" Ganduje queried. He affirmed that the party would continue to counter baseless allegations with facts and defend the government of President Tinubu against disinformation.

Reiterating the APC's commitment to democracy, Ganduje highlighted the party's dedication to engaging constructively with opposition actors while upholding the principles of free speech and accountability.

# "We are not Igbo," Ikwerre Group spills

The apex umbrella body of Ikwerre ethnic, Ogbakor Ikwerre Cultural Organisation Worldwide (OICOW), has reaffirmed its ancestral root, declaring that they are not Igbos but purely Rivers people.

While speaking to journalists on Thursday at the Obiri Ikwerre Town Hall in Port Harcourt, Rivers State, the President General of Ogbakor Ikwerre Cultural Organisation Worldwide, Eze Barr. Godspower Onuekwa, made this declaration.

Clarifying this misconception of the ancestry root identification, the organisation said they remain an ethnic nationality and not a subgroup since the history of Nigeria.

Reminiscing over the peaceful coexistence enjoyed by the Ikwerre people, the President General warned against any gathering leading to division for the people of Ikwerre nationality.

Despite sharing cultural and traditional similarities with nearby states, PG-OICOW bemoans the attempt by some Igbo expansionists to incorporate Ikwerre as a subset or subgroup of any other ethnic group in all of Nigeria.

Ikwerre ethnicity is made of four Local Government Areas (LGA), which include Ikwerre (KELGA), Emohua (EMOLGA), Obio/Akpor (OBALGA), and Port Harcourt City (PHALGA).

# Burnham breaks ranks with Starmer to back grooming gang inquiry

ndy Burnham has defied Sir Keir Starmer to call for a national inquiry into grooming gangs.

The Labour Mayor of Greater Manchester said he believed there was a case for a "limited national inquiry" drawing on local reviews into historical child sexual exploitation.

Sir Keir ordered Labour MPs to vote to block a national inquiry into grooming gangs on Wednesday evening.

The Prime Minister did not take part in the vote and his spokesman said he would be "guided by the victims" on the issue, but Downing Street denied that this meant Sir Keir was wavering in his belief that a new inquiry was unnecessary.

It comes as Reform UK, which has led the calls for a national inquiry, came joint top of a national opinion poll for the first time.

A new survey by Find Out Now put the party on 25 per cent of the vote, joint top with Labour and five points ahead of the Conservatives.

Labour said that it blocked the Tory amendment backing a new inquiry because it would have derailed the entire Children's Wellbeing and Schools Bill.

'Case for a limited national inquiry'

Mr Burnham told BBC Radio Manchester on Thursday: "In my view, the Government was right to reject that form of opportunism. But I did hear last night coming out of the debate, ministers saying they are open to discussing issues now with survivors.

"And I will add my voice into this and say I do think there is the case for a limited national inquiry that draws on reviews like the one that I commissioned and the one we've seen in Rotherham, the one we've seen in Telford, to draw out some of these national issues, and compel people to give evidence who then may



have charges to answer and be held to account. That is something I couldn't do at my level."

Mr Burnham commissioned an independent review in 2017 to consider allegations made in a BBC documentary. It looked at grooming in Manchester, Oldham and Rochdale and concluded that authorities failed to protect children. Neil O'Brien, a shadow education minister, said that Mr Burnham's

minister, said that Mr Burnham's intervention showed that the Government's line on a fresh inquiry was "crumbling".

Khalid Mahmood, a former Labour MP for Birmingham Perry Barr, has also backed the calls.

He said: "What the Prime Minister is doing is looking at the wider issue of the inquiry which is already taking place, but I think we need to look at this from a different angle, which is looking at the lives of people who have suffered – and they need to be given closure on this. Also, if there are any people left in these gangs, we need to ensure that we get them and that there is no continuation of this cruel, barbaric activity."

Also on Thursday, a survivor of a grooming gang called on the Government to launch a national inquiry into the scandal.

The 38-year-old, who wrote a book about her ordeal under the pen name Gaia Cooper, demanded action in an exclusive interview with The Telegraph's Daily T podcast

There is mounting pressure on the Government over grooming gangs, with attention thrown back on the issue by Elon Musk. The US tech billionaire and key ally of Donald Trump has repeatedly posted on his social media site X criticising Sir Keir over the issue.

On Thursday, reports emerged that Mr Musk had even discussed with allies how the Prime Minister could be removed from office before the next general election.

### Starmer: Labour has deported record number of migrants by scrapping Rwanda scheme

Home Office says it has returned more than 16,400 illegal migrants and foreign criminals since election

Sir Keir Starmer has claimed Labour has deported a record number of foreign criminals and illegal migrants by scrapping the Rwanda scheme.

On Thursday, the Home Office said it had returned more than 16,400 illegal migrants and foreign criminals since the election – the highest six-month total since 2018.

Yvette Cooper, the Home Secretary, set the target of overtaking 2018's total after Labour ditched the Tories' Rwanda deportation scheme and switched hundreds of immigration staff to work on returning illegal migrants to their home countries.

Sir Keir suggested quick returns provided a deterrent to replace the "wasteful" Rwanda scheme, saying: "For the individuals that are being smuggled, the disincentive is you're wasting your money and if you get to the UK you're going to be returned to where you came from.

"I'm really pleased that the figures for the last six months show record numbers of people being returned – 16,400 people who should not be in the UK.

"It's the highest number now for six or seven years, because this Government has prioritised making sure that we are returning people who shouldn't be here, not wasting our time on things like the Rwanda scheme, which wasn't working."

The Home Office data showed the number of enforced returns of illegal migrants was up 24 per cent on the same period last year and the 2,580 foreign criminals deported was up 23 per cent on 2023.

It included four of the biggest removal flights, carrying more than 800 illegal migrants and foreign offenders.

However, the Tories claimed Sir Keir was being "deeply dishonest" as the Government was only returning a "tiny" five per cent of the migrants who had arrived since it came to office.

Chris Philp, the shadow home secretary, said Labour was instead allowing thousands of Channel migrants to claim asylum and remain in the UK.

"Letting 95 per cent of people who cross by small boat stay in the UK is not a deterrent," he said. "The Government is being deeply dishonest by claiming returns that mainly have nothing to do with small boat arrivals will act as a deterrent. The Rwanda scheme would have been a real deterrent, but Labour cancelled it before it even started."

It comes after the Government announced that people-smugglers would

be subject to financial sanctions like Russian oligarchs, terrorists and cyber-criminals. Suspected traffickers would be sanctioned by name, enabling UK investigators to freeze their assets in Britain and those of any individual or business supplying them with equipment or helping them financially

There are still some 12,000 foreign offenders in the UK who have been released from jail into the community and are liable for deportation. On Wednesday, the Telegraph revealed foreign offenders freed from prison in the UK were going on crime sprees after avoiding deportation.

Hundreds of foreign criminals freed from jail in the past four years have committed multiple offences after avoiding deportation or challenging their removal under the European Convention on Human Rights.

Meanwhile, David Lammy, the Foreign Secretary, said on Thursday that Shamima Begum would not be returning to the UK following calls from Donald Trump's incoming counterterrorism chief for the repatriation of British members of Islamic State being held in Syrian prison camps.

# US pledges \$500m weapons for Ukraine to fight Russia By Elizabeth Jenrola Oso

The US will send half a billion dollars in military aid to Ukraine ahead of US president-elect, Donald Trump's return to the White House, the country's top diplomat has announced.

Speaking during the 25th and possibly final meeting of Ukraine's western backers at the Ramstein air base in Germany, US Secretary of State Anthony Blinken said Washington would supply one more trove of military support.

The \$500m (£406m) package includes air defence missiles, air-toground munitions and support equipment for F-16 fighter jets. The US has sent roughly £50 billion in military aid to Ukraine since the fullscale invasion nearly three years ago. The announcement, however, suggests that the remaining \$3.8bn of the funds set aside for Ukraine by the Joe Biden administration will remain unused ahead of Mr Trump's return, despite previous commitments to use all the money.



Meanwhile, Russia launched dozens of glide bombs across Ukraine over the last 24 hours, Ukraine's military reported in its latest update, as the casualty toll from an attack on civilian-populated Zaporizhzhia reached 126.

The Ukrainian general staff said Russia had launched 62 glide bomb attacks on Wednesday. The munitions, nicknamed "building-destroyers," can carry warheads weighing up to 3 tonnes and blow holes deeper than bomb shelters. Ukrainian President, Volodymyr Zelenskyy and US Defence Secretary, Lloyd Austin used their final meeting in Germany to press the incoming Trump administration to not give up on Kyiv's fight, warning that to cease military support now "will only invite more aggression, chaos and war."

### **19 dead in attack on Chad's Presidential Palace** By Elizabeth Jenrola Oso

n attack on Chad's presidential palace left 18 assailants dead and six in custody, with one soldier killed and three wounded, state media reported Thursday.

The attack on Wednesday night occurred while Chadian President Mahamat Deby itno was inside the palace, but authorities said the situation was quickly brought under control.

"The situation is completely under control. There is no fear," Foreign Affairs Minister Abderaman Koulamallah said while surrounded by soldiers in a live Facebook broadcast filmed inside what appeared to be a quiet presidential palace late Wednesday.

In an interview with state TV, Koulamallah praised the vigilance of the palace guards, describing the attackers as disorganized and intoxicated by alcohol and drugs. When asked if the attack was terrorism, he said it was probably not, as the

attackers were local youths from the capital, N'Djamena.

The attack occurred the same day as a visit by Chinese Foreign Minister Wang Yi, who congratulated Deby Itno on reestablishing constitutional order.

In the immediate aftermath, rumors spread online that the attack was the work



of Islamic militant group Boko Haram.

Boko Haram, which launched an insurgency more than a decade ago against Western education, seeks to establish Islamic law in Nigeria's northeast. The insurgency has spread to neighboring West African countries including Cameroon,

### China detects 5 new cases of mpox strain

hina's Center For Disease Control and Prevention (CDC)said on Thursday that it has detected the new mutated pox, mpox, strain clade Ib as the viral infection spreads to more countries.

This is coming after the World Health Organization, WHO, declared pox a global public health emergency last year.

WHO maintains that Mpox spreads through close contact and causes flulike symptoms and pus-filled lesions on the body. Although usually mild, it can be fatal in rare cases.

Reportedly, the outbreak in DRC began with the spread of an endemic strain, known as clade I. But the clade Ib variant appears to spread more easily through routine close contact, including sexual contact.

The variant has spread from DRC to neighbouring countries, including Burundi, Kenya, Rwanda and Uganda, triggering the emergency declaration from the WHO.

In August last year, China said it would monitor people and goods entering the country for mpox. The country's National Health Commission said mpox would be managed as a Category B infectious disease, enabling officials to take emergency measures such as restricting gatherings, suspending work and school, and sealing off areas when there is an outbreak of a disease.

However, Chinese health authorities reported that it had found a cluster outbreak of the Ib subclade that started with the infection of a foreigner who has a history of travel and residence in the Democratic Republic of the Congo.

In its latest report, the China CDC said that human metapneumovirus (hMPV), a common respiratory infection, remains at high levels.

Flu activity across the country is expected to gradually decline in mid-to-late January, the report said.

#### monkey pox

The patients' symptoms are mild, including rashes and blisters, the CDC said. The patients and others who are at risk of infection are receiving medical treatment or are under observation.

The new strain has been spreading across several African countries, affecting mainly children and adolescents. Infections have spilled over from Africa to other continents, including Europe and North America.

The US reported its first case of clade I mpox in November, but reassured the public the risk remained "very low". In Asia, the variant has also been detected in countries like Thailand and India.

Unlike an earlier milder strain that erupted in 2022 and spread primarily through men who have sex with men, the current variant is spreading through all kinds of sexual activity and other close physical contact.

Asian countries from China to Indian and Pakistan — many of which are densely populated have beefed up surveillance of infections. Travelers from affected countries were being asked to selfreport symptoms and hospitals were on alert for suspected cases.

After the WHO raised the alert levels on mpox, China has begun asking travelers from affected regions, those who have been in contact with mpox patients or individuals experiencing symptoms to self-report to customs officials upon entry, where they may undergo testing.

Agbadou brings experience from his time in Ligue 1, where he made 76 appearances and scored three goals for Reims. His arrival is timely for Wolves, who have conceded a leaguehigh 45 goals this season and sit just above the relegation zone on goal difference.

Wolves face Bristol City in the FA Cup on Saturday before returning to Premier League action against Newcastle on 15 January.

### Barcelona's Olmo and Victor granted temporary playing permission By Timi-Zacchaeus Oluwaferanmi

B arcelona forwards Dani Olmo and Pau Victor have been granted provisional permission to play after an appeal to Spain's national sports council (CSD).

Both players, signed last summer, were initially registered for the first half of the season as Barcelona struggled to comply with La Liga's wage cap. A subsequent request to renew their registrations was rejected by La Liga and the Spanish Football Federation (RFEF).

On Wednesday, the CSD overruled these decisions, allowing the players to compete while a final ruling on Barcelona's appeal is pending.

The CSD stated this precautionary measure "suspends the cancellation" of their licenses and upholds their validity until the appeal is resolved.

The decision came too late for Olmo and

Victor to feature in Barcelona's 2-0 Spanish Supercopa semi-final win over Athletic Club but permits them to play in Sunday's final against Real Madrid or Mallorca.

Olmo, a £51m summer signing from RB Leipzig, was influential in Spain's Euro 2024 win. Barcelona's financial difficulties initially limited their ability to meet La Liga's financial fair play rules, delaying the renewal of his and Victor's licenses.

Barcelona reportedly raised  $\notin 100m$  (£83.42m) by selling VIP boxes in their under-construction stadium but missed La Liga's deadline to submit the paperwork.

La Liga expressed disagreement with the CSD decision, citing a lack of opportunity to respond to Barcelona's



appeal. The league is considering further legal action.

The ruling provides a temporary boost for Barcelona, who continue to navigate financial challenges while competing at the highest level.

# **Graham Potter: The right fit for West Ham?**

est Ham United have turned a new chapter, appointing Graham Potter as their head coach on a two-and-a-half-year contract. Potter, who has been out of management since leaving Chelsea in April 2023, arrives with a mixed reputation—heralded for his transformative stint at Brighton but shadowed by his challenging experience at Chelsea. Now, the question looms: is he the right man to steer the Hammers toward sustained success?

#### A Thoughtful and Adaptive Manager

Potter's journey in football management is as unconventional as it is impressive. Rising through the ranks with Ostersunds FK in Sweden, he achieved three promotions and a memorable Europa League run, including a win at Arsenal. His tactical fluidity and player-first approach earned him a move to Brighton, where he reshaped the Seagulls from perennial relegation candidates to a team capable of playing adventurous football.

Former Brighton forward Glenn Murray praised Potter's meticulous planning and collective management style, describing him as a "thought-provoking" leader capable of adapting tactics mid-game. Yet, his humility shines through. "It's hard to be a sexy name when you're called Potter," he once joked.

#### Lessons from Chelsea

Potter's tenure at Chelsea was turbulent. Despite high expectations, his seven months in charge saw the team flounder, leaving the Blues in 11th place at the time of his dismissal. Reflecting on the experience, Potter admitted the instability caused by Chelsea's extensive squad overhaul and rapid changes made the job particularly challenging.

"It was an overload situation," he confessed. "Maybe I joined too quickly,



but I believed in the project." The experience left Potter determined to choose his next role more carefully—a resolve that has led him to West Ham.

#### Why West Ham?

West Ham offers a mix of opportunity and risk. The club sits 14th in the Premier League, seven points above the relegation zone, but boasts a stable ownership structure and a history of allowing managers time to build. The squad, while not without its flaws, has potential to compete higher up the table. The club's recent silverware—the 2022-23 Europa C o n f e r e n c e L e a g u e trophy—indicates an appetite for success.

For Potter, this is a chance to reestablish himself in a club that shares his ambitions. West Ham fans, however, remain divided. Some doubt whether Potter's success at Brighton can be replicated without the recruitment genius of Tony Bloom and Dan Ashworth, while others see the potential for him to deliver "the West Ham way"—entertaining, progressive football.

#### The Ceiling for Potter and West Ham

Potter's immediate challenge will be avoiding relegation, but his long-term goals must align with the fans' European aspirations. With the January transfer window open, Potter faces the dual task of strengthening the squad and implementing his style of play.

West Ham's technical director Tim Steidten's role in recruitment could also test Potter's ability to integrate new talent. The fallout between Steidten and former manager David Moyes adds an extra layer of complexity, with Potter needing to navigate these dynamics carefully.

### Manchester City eye Omar as backup for Haaland

Anchester City is reportedly exploring a move to sign Egyptian forward Omar Marmoush from Eintracht Frankfurt, as a potential backup for Erling Haaland, whose goal-scoring form this season has yet to match his prolific performance from the previous campaign.

According to a report from Sky Sports on Thursday, the Bundesliga club is asking for around £67m (€80m) for the 25-year-old forward. However, negotiations between Manchester City and Eintracht Frankfurt have not yet taken place.

Sky Sports also highlighted that Marmoush does not have a release clause in his contract, meaning that offers below the £67m asking price would likely be rejected by Frankfurt, who are currently third in the German top flight. Despite the high asking price, reports suggest that Manchester City and Marmoush's representatives consider a more realistic transfer fee to be between  $\pounds 42m$  and  $\pounds 50m$  ( $\pounds 50m$ - $\pounds 60m$ ).

Marmoush, who is capable of playing across the front three, has been in scintillating form this season, scoring 13 goals in the Bundesliga, placing him behind only Bayern Munich's Harry Kane in the league's scoring chart.

Across all competitions, Marmoush has netted 18 goals and is second only to Liverpool's Mohamed Salah for goal involvements among players in the top five European leagues this season.

City has also reportedly made initial contact with Palmeiras regarding an 18year-old Brazilian centre-back, Vitor Reis. Discussions are said to be in the early stages, with Palmeiras hoping to secure a fee in the region of £33.5m to £40m for the highly-rated defender.

Reis made 22 appearances for Palmeiras last season, scoring two goals, and captained Brazil's U17 team at the 2023 U17 World Cup.

Manchester City's interest in both Marmoush and Reis reflects their proactive approach to strengthening their squad for the remainder of the season.

The Solihull-born Potter began his coaching career with university students before taking his first managerial role at Östersund in 2010. He led the Swedish club on an incredible run of three promotions in five seasons to the top-flight, won the Swedish Cup and reached the knockout stages of the UEFA Europa League, defeating Arsenal at Emirates Stadium.

Potter's exploits in Scandinavia prompted Swansea to appoint him in summer 2018. After an eye-catching year in South Wales, he took charge at Brighton a year later and led the Seagulls to a then record-high Premier League finish of ninth in 2020/21.
