Tragedy strikes Katsina: Bandits kill 21, burn corpses in Baure village By Eyitayo Jemimah Ajayi

devastating attack by suspected bandits has left 21 people dead and several others missing in Baure village, Safana Local Government Area of Katsina State. The village, notorious for being a bandits' den, witnessed a rampage by the hoodlums on Tuesday, with the attackers visiting house to house, leaving a trail of death and destruction in their wake.

According to eyewitnesses, about 15 people died on the spot, while others were burnt

beyond recognition. A resident, who spoke to Channels TV on condition of anonymity, revealed that the bandits also set some of the corpses ablaze, further exacerbating the horror of the situation.



The Katsina Police Command has confirmed the incident, with spokesperson DSP Abubakar Aliyu stating that the attack occurred on January 7, 2025, at around 4:30 p.m.

Shocking theft rocks EFCC: 10 officers arrested over missing N600 million

In a stunning turn of events, the Economic and Financial Crimes Commission (EFCC) has arrested 10 of its officers in connection with the disappearance of jewelry and cash valued at over N600 million from its Lagos office. The arrests, made last week on the orders of Executive Chairman Ola Olukoyede, are linked to the theft of operational items that the officers could not account for.

According to the EFCC, investigators are making progress, and those found culpable will face internal disciplinary action. While the EFCC has not disclosed the names of the officers involved or further details, sources indicate that between \$350,000 and \$400,000 has gone missing, along with expensive jewelry and other high-value items.

This incident comes on the heels of the dismissal of 27 EFCC officers for

misconduct and fraudulent behavior. The officers were fired after a review by the EFCC's Staff Disciplinary Committee, with the decision approved by Chairman Olukoyede. The dismissals have raised concerns about the agency's oversight and accountability, particularly in light of the latest incident.

The EFCC, renowned for its role in combating financial crimes in Nigeria, now faces intense scrutiny over potential weaknesses in its internal control systems. Despite launching an investigation into the missing funds and valuables, the agency's reputation has taken a hit.

As the investigation unfolds, questions are being raised about the measures the EFCC will take to prevent such incidents in the future and restore public trust in its ability to fight corruption. This scandal serves as a stark reminder of the ongoing



challenges the agency faces in maintaining its integrity and credibility in the fight against financial crimes.

Efforts to reach EFCC spokesperson Dele Oyewale for comment on this latest debacle have been unsuccessful. The agency's silence has only fueled speculation and concern among Nigerians, who demand accountability and transparency from the EFCC.

The incident has also sparked debate about the need for greater oversight and accountability within the EFCC. Many are calling for a comprehensive review of the agency's internal controls and procedures to prevent similar incidents in the future.

Makinde vows to tackle land grabbing, cattle grazing By Gbenga Oluranti Olaleye

Makinde, has issued a stern warning to individuals engaging in land grabbing and unlawful cattle grazing within the state. The Governor announced that anyone forcibly encroaching on land or property will now face the full force of the law, as stipulated under the Rule of Law Enforcement Authority and the newly established Anti-Land Grabbing Agency.

Makinde, who was represented by his Deputy, Adebayo Lawal, made this pronouncement on Wednesday at a one-day stakeholders' engagement hosted by the Oyo State Mobilisation Agency for Socio-Economic Development (OYMASED) at Omolayole Hall, University of Ibadan. The event was focused on reviving the core values of the Yoruba people, particularly the Omoluabi ethos, which has been diminishing in recent times.

"The era of forcefully taking possession of someone's land is over," Makinde declared, emphasising that land grabbers will now be treated as criminals under the new legislation. He also revealed that the Anti-Land Grabbing Agency has been set up to address the alarming increase in land encroachment incidents across the state.

In his speech, the Governor highlighted the ongoing socio-economic challenges within the state and expressed confidence that OYMASED, working alongside other government bodies, would help address these issues effectively. He also underscored the importance of not only infrastructure development but also institutional strengthening, with OYMASED playing a key role in socio-economic progress.

Makinde warned of severe consequences for those caught engaging in illegal cattle grazing, particularly in restricted areas such as government offices and public spaces. Offenders, he affirmed, would be prosecuted by the Rule of Law Enforcement Authority, which is led by retired Hon. Justice Aderonke Aderemi.



The Governor stated, "Forceful occupation of land is no longer acceptable. In the past, conquering land was seen as a triumph, but today it is a crime. Anyone attempting this must be prepared to face the consequences." In addition to land issues, Makinde stressed the need for adherence to environmental laws and public space regulations, citing the recent cases of cattle grazing in inappropriate locations, including the state secretariat.

During the event, the Director-General of OYMASED spoke about the importance of re-establishing the traditional values of integrity, respect for elders, and hospitality within the Yoruba community. These values, he pointed out, have been gradually eroded and require urgent revival.

Also speaking at the event, the Commissioner for Information and Orientation, Dotun Oyelade, commended OYMASED for its initiatives, revealing plans for public awareness campaigns to support the agency's goals.

Justice Aderemi also praised the Governor's commitment to restoring law and order in the state, particularly through the efforts of the Rule of Law Enforcement Authority and OYMASED. She emphasised the importance of upholding societal values and ensuring that regulations are adhered to by all.

Notable dignitaries at the event included former deputy governors, legal officials, traditional leaders, and representatives of various organisations. The gathering also featured experts such as Dr. Sybil Olufunmilayo Akinfenwa, Prof. Oludayo Tade, and Dr. (Mrs) Olukemi Akinyemi, who discussed pressing issues ranging from crowd control to drug abuse and traffic management.

Governor Makinde's administration remains committed to strengthening the legal and social frameworks necessary for the advancement of Oyo State, ensuring that all citizens respect the rule of law and the state's values.

Nigeria records 100 fire-related deaths in 2024 By Ghenga Oluranti Olaleye



he Federal Fire Service (FFS) has revealed that Nigeria suffered the loss of 100 lives and property worth a staggering N67.1 billion due to fire outbreaks in 2024. However, the service also highlighted its significant success in mitigating the damage, saving 30,890 lives and property valued at N1.94 trillion.

The Controller General of the Federal Fire Service, Abdulganiyu Jaji, made these disclosures during a press briefing held in Abuja on Friday. According to Jaji, the FFS's efforts have been pivotal in responding to fire outbreaks and other emergencies across the nation.

"In the year 2024, the Federal Fire Service successfully saved property worth N1.94 trillion and recorded an estimated property loss of N67.1 billion," Jaji stated.

He further noted that, despite the challenges, the FFS was able to save 30,890 lives, although it was also a year of mourning for 23 families who lost loved ones. Jaji extended his condolences

to the bereaved, emphasising that the service shares in their grief.

The Controller General attributed many of the fires to negligence and non-compliance with safety regulations, urging Nigerians to exercise greater caution, particularly during the ongoing harmattan season. The dry and dusty weather, coupled with low humidity, increases the risk of fire outbreaks.

"As we are currently in the harmattan season, the risk of fire outbreaks is heightened due to low humidity, which can lead to static sparks and even gas explosions," Jaji warned. He appealed to operators of fuel stations, gas refilling plants, and consumers of gas cylinders to adhere strictly to safety protocols, emphasising that small lapses could lead to significant disasters.

In light of these concerns, the FFS is committed to improving public safety in the coming year. Jaji outlined plans to enhance the agency's response capabilities through advanced

technology and public awareness initiatives. The introduction of the National Fire Detection and Alarm System, along with the Fire Alarm App, N-Alert, is expected to significantly boost operational efficiency and improve service delivery.

Looking ahead to 2025, Jaji reiterated the Federal Fire Service's dedication to saving lives, protecting property, and ensuring environmental safety. "As we begin 2025, our focus remains on enhancing our capacity to safeguard Nigerians. We will continue to prioritise public trust and ensure that investments in fire safety vield positive results," he affirmed.

The Federal Fire Service's commitment to public safety and its proactive stance in addressing fire hazards are crucial in mitigating the risks posed by fire outbreaks, especially as the country faces another year of potential challenges.

Raheem Okoya apologises over viral naira abuse video, police officer detained By Ghenga Oluranti Olaleye



aheem Okoya, son of billionaire businessman Chief Razaq Okoya, has issued a public apology to Nigerians following his involvement in a viral video that showed the abuse of naira

The video, which also featured his brother Wahab and an unidentified police officer, has sparked outrage across the country and led to the detention of the officer.

In a statement shared on Friday via X (formerly Twitter), Raheem expressed regret, saying, "To the Nigerian people, my actions were not to cause any trouble or harm.

My intentions were pure and naive. I ask for your forgiveness and support in this situation, as I had no intention to raise such an alarm. I wasn't fully aware of the consequences of my action."

The video, which quickly spread

across social media last week, shows Raheem and Wahab dressed in traditional agbada outfits, displaying stacks of crisp N1000 notes.

The brothers were promoting Raheem's new song "Credit Alert," while a mobile police officer in uniform can be seen holding bundles of cash, with the pair tossing the naira notes into the air as they danced.

The incident quickly drew widespread condemnation, with many Nigerians criticising the disrespect shown towards the national currency. The police officer involved in the video was subsequently detained by the Nigeria Police Force (NPF), who confirmed that disciplinary action was underway.

Force Public Relations Officer, Olumuyiwa Adejobi, addressed the situation on his X handle on Friday, stating, "The policeman captured in the recent viral video shared by the sons of Lagos businessman, Chief Okoya, where they were abusing the naira, has

been identified and detained for disciplinary action. The involvement of the policeman has been condemned, as it's unethical. We will always strive hard to uphold the sanctity, credibility, and core values of the police."

While the police have acted swiftly, there has been some public backlash, with many questioning whether the Okoya brothers will face any consequences for their role in the video. As of now, no further details have emerged regarding possible sanctions for the billionaire's sons.

The controversy has prompted a wider conversation about the abuse of naira notes and the need for more respect for the national currency, particularly by public figures.

As the matter unfolds, Nigerians await further updates on the disciplinary actions against the officer and any potential repercussions for the Okoya family.

Speaking to journalists, Governor Okpebholo expressed empathy for the students, stating, "I feel your pain as a father. I will invite the acting Vice Chancellor to discuss and resolve this matter promptly. Please be patient; everything will be fine."

The students' spokesperson,

Precious Omohegbele, appealed to the Governor for swift intervention, highlighting their plight.

"We graduated five months ago and should be halfway into o u r horsemanship by now. Spending 10 years in medical school is already a heavy burden. We

appeal to Your Excellency to help us," she said.

he victims of the tragic stampede that occurred during a Christmas rice distribution in Okija, Ihiala Local Government Area of Anambra State, have been laid to rest.

The incident, which took place on December 21, 2024, claimed the lives of at least 21 people, primarily women and children, during a palliative distribution organised by Chief Ernest Azudialu Obiejesi through his Obijackson Foundation.

An inter-denominational burial service was held on Friday at St. Mary's Field, Okija, with families of the victims, survivors, community members, and other dignitaries in attendance. NYSC: Why 200 corps members were queried- Oyo NYSC By Ifedamola Joseph Fayomi

YSC denies claims of issuing queries to 200 Oyo corps members, clarifying allegations about a Christmas carol are false and baseless.

The organization clarified that the accusations are baseless and unrelated to religious activities.

Adherence to NYSC bylaws Megwa emphasized that the scheme operates strictly within the boundaries of its bylaws. These rules guide corps members' conduct throughout their service year.

She explained that the queries issued by the Local Government Inspector were corrective measures intended to ensure compliance with the scheme's regulations. The organization does not discriminate against religious practices or beliefs.

"The NYSC respects the religious rights of all corps members and remains committed to fostering unity and tolerance," she added.

Mandatory service activities Megwa reiterated the importance of mandatory weekly and monthly CDS activities for corps members.


Participation in these activities is a critical requirement for obtaining the Certificate of National Service.

Nigeria Police Force detains officer in viral video, sparking outrage over double standards

he Nigeria Police Force (NPF) has identified and detained a police officer who appeared in a viral video with Wahab and Raheem Okoya, sons of billionaire businessman Razaq Okoya. The officer was seen holding stacks of naira notes as the Okoya brothers sprayed the currency, an offense under Section 21(3) of the Central Bank of Nigeria 2007.

The video, which sparked widespread outrage on social media, showed the Okoya brothers recklessly spraying naira notes, while the police officer stood by, holding the currency. The NPF, in a bid to address the controversy, detained the police officer, citing unethical behavior.

Force Public Relations Officer (FPRO), ACP Olumuyiwa Adejobi, disclosed the detention on X, stating that the policeman's involvement was "unethical" and would face disciplinary action. However, the move has sparked

outrage on social media, with many accusing the NPF of double standards.

Critics argue that the Okoya brothers, who actually committed the offense, have not been punished, while the police officer, who was seemingly pressured into participating, is facing disciplinary action. Many have taken to social media to express their frustration over the perceived leniency towards the wealthy and powerful.

Court orders Minister, AGF to justify expatriates tax policy By Friday Omosola



Justice Inyang Ekwo of the Federal High Court, Abuja, has summoned the Minister of Interior, Olubunmi Tunji-Ojo, and the Attorney-General of the Federation (AGF), Lateef Fagbemi, to explain why the implementation of a proposed expatriates taxation policy should not be halted.

The order followed an ex-parte motion filed by the plaintiff's counsel, Patrick Peter.

Justice Ekwo directed that the motion be served on the minister and AGF within three days and scheduled the hearing for January 16, 2024.

The plaintiff, who named the Interior Minister and the AGF as defendants, is seeking an interim injunction to prevent the implementation of the new taxation framework, called the "Expatriate Employment Levy (EEL)" until the substantive case is resolved.

According to an affidavit filed by the plaintiff's Programme Implementation Coordinator, the Federal Government unveiled the EEL on February 27, 2024.

Under this policy, companies employing

expatriates would be required to pay an annual tax of \$15,000 (N23 million) for directors and \$10,000 (N16 million) for non-directors.

The policy also prescribes penalties for non-compliance, including five years of imprisonment and/or ann N1 million fine for inaccurate reporting.

Corporate entities could face fines of N3 million for failing to file or renew EEL documentation or for providing false information.

The plaintiff argued that the EEL is detrimental to Nigeria's economic growth and violates constitutional provisions.

It noted that taxation matters require collaboration between the executive and legislative arms of government, as outlined in Section 59 of the 1999 Constitution (as amended).

The plaintiff further alleged that despite earlier suspending the policy to allow consultations with stakeholders like NACCIMA, the minister is now set to enforce the EEL fully.

If implemented, the group claims, the policy would harm the economy and undermine the nation's financial stability.

Justice Ekwo directed the defendants to justify why the court should not grant the plaintiff's request for an injunction.

The matter was adjourned to January 16, 2024, for further proceedings.

irdrops are a popular method in the cryptocurrency world where projects distribute tokens or coins for free to early adopters or community members.

How do Airdrops Work?

Crypto projects often use airdrops to majorly boost awareness. By so doing, they introduce their new token or platform to a wider audience.

It is also a way they reward early supporters by incentivizing users to engage with their platform, such as by holding other cryptocurrencies, participating in social media campaigns, or completing specific tasks.

All these and more when put together

helps them foster a strong community around their project by rewarding active members.

There is always an Eligibility Criteria by which crypto projects reward their community. Common requirements include: holding specific cryptocurrencies, that is, owning a certain amount of a related coin or token.

Also through social media engagement by following the project on X, joining their Telegram group, or retweeting their posts.

Another is by completing tasks which could involve participating in surveys, referring friends, or providing feedback.

Once you meet the eligibility criteria, you typically need to claim your airdrop by interacting with a smart contract on the blockchain.

This usually involves connecting your cryptocurrency wallet to the project's platform.


How to Make Money from them The most straightforward way to profit is to hold the airdropped tokens and hope their value appreciates significantly over time. But this can be a real test of patience only if you are really willing to wait.

Another option is to trade immediately when the airdrop token is listed on an exchange, you can sell it immediately for a profit, especially if there's high initial demand.

Some airdrops can also be staked or used in decentralized finance (DeFi) protocols to earn passive income. Always research the project thoroughly before participating in any airdrop.

Investigate the team, the project's roadmap, and the tokenomics. Be extremely cautious about providing your private keys or connecting your wallet to unknown sources.

Prostate cancer drug that shrinks advanced tumors discovered By New Daily Prime



groundbreaking new drug, NXP800, has shown promising results in shrinking prostate cancer tumors in men with advanced disease, offering hope for patients who no longer respond to existing treatments. The experimental medication, also being trialed for ovarian cancer, was hailed by experts as a potential gamechanger in overcoming treatment resistance.

How It Works

The drug targets the heat shock factor 1 (HSF1) pathway, a cellular mechanism that cancer cells hijack to support their growth. This pathway regulates heat shock proteins, which are overexpressed in many cancers to help them survive stressful conditions as tumors develop. NXP800 disrupts this process, slowing tumor growth and offering a new approach to tackling hormone-resistant prostate cancer.

Laboratory and animal trials conducted by a team from the Institute of Cancer Research (ICR) in London demonstrated the drug's effectiveness. Without treatment, tumors in test subjects doubled in size

within 38 days, but those receiving NXP800 showed significantly slower progression, with only about a third of tumors reaching that stage in the same timeframe.

Dr. Adam Sharp, leader of the Translational Therapeutics Group at the ICR and consultant oncologist at The Royal Marsden NHS Foundation Trust, emphasized the importance of this discovery. "Hormone therapies have extended the lives of many men with advanced prostate cancer, but drug resistance is inevitable. Targeting the heat shock response pathway offers a promising new angle for treatment."

Promising Results and Next Steps

The study, which analyzed 439 samples of advanced prostate cancer, found that higher levels of heat shock proteins were linked to increased androgen receptor signaling, which drives cancer growth. NXP800 was shown to slow tumor progression in lab-grown cells and mini tumors derived from patient samples.

Professor Kristian Helin, chief executive of the ICR, underscored the importance of tackling drug resistance in cancer treatment. "Finding drugs that can slow cancer growth when all other treatments fail is critical," he said.

Regius Professor Johann de Bono, a

senior researcher at the ICR, highlighted the potential impact for patients. "Higher levels of heat shock proteins are associated with worse outcomes in prostate cancer. If clinical trials prove successful, targeting these proteins could extend and improve the lives of men with advanced disease."

Backed by Leading Organizations
The research, published in Clinical
Cancer Research, was supported by
Prostate Cancer UK and the
Prostate Cancer Foundation. Simon
Grieveson, assistant director of
research at Prostate Cancer UK,
described the findings as a
"fantastic example" of innovative
approaches to prostate cancer
treatment. "This novel drug could
give men with hormone-resistant
prostate cancer more time with their
loved ones," he said.

While clinical trials are needed to confirm the drug's effectiveness, the findings mark an exciting step forward in addressing one of the most challenging aspects of a d v a n c e d p r o s t a t e cancer—treatment resistance.



Mohbad: Group urges case reopening as Mohbad's autopsy ready By Ifedamola Joseph Fayomi

he family of Mohbad has finalised a private autopsy and toxicology report, seeking answers about the true cause of the late singer's tragic death.

The Coroner's Court in Ikorodu, Lagos State, granted the family permission in June 2024 to conduct a private investigation.

√omedian Mr Macaroni condemned a viral video of a Nigerian commissioner threatening to break a citizen's phone during a public encounter on X.

This disturbing display of authority has sparked widespread condemnation and renewed debates about the abuse of power by public officials in Nigeria.

The incident occurred when Mrs. Toke Benson, a citizen, attempted to record a public meeting where the commissioner was speaking. What began as a routine recording quickly escalated into an alarming exchange that has drawn national attention.

In the viral video, Macaroni wrote: Dear Mrs Toke Benson, who do you think you are that you can't be recorded?? Ok. Commissioner? And so what?? You even have the temerity to ask "Who is paying your salary" Is it your money? A public servant moving like a Dictator. Saying you will break a citizen's phone and actually moving to do so?? Outrageous!!! And I heard another lady asking "Do you know who you are talking to" Who are you? Who is she? Who are all of you gangan??? My goodness!!! It seems once you hold a political office in Nigeria you become Lord and Master and all Citizens must become your slaves?? In a shocking display of aggression, the commissioner threatened to destroy Mrs. Benson's phone, demanding to know who was paying her salary and labeling the act of recording as unacceptable.

The commissioner's response, which many view as heavy-handed, raises critical questions about the growing disregard for transparency among public officials.

This situation echoes the behavior seen in dictatorial regimes, where the right of citizens to question or document officials' actions is stifled. Eyewitnesses confirm that Mrs. Benson was simply exercising her right to document public proceedings.

For her, recording the event was a legitimate attempt to ensure transparency. However, her efforts were met with hostility from the commissioner.

His actions prompted bystanders to question his motives and behavior, with many

criticizing his decision to use his position to intimidate and silence a citizen.

The call for accountability and transparency

Mrs. Benson's firm stance against the commissioner's threats has resonated with many Nigerians. She reportedly asked, "Who do you think you are that you can't be recorded?" This simple yet powerful question emphasized the need for accountability among public officials, reminding them that they are meant to serve the people, not rule over them.

Instead, they act as though they are untouchable. This incident has only intensified calls for reform in Nigeria's political system.

These online movements are calling for a reevaluation of the powers granted to public officials, urging lawmakers to enact legislative reforms that would ensure the protection of citizens' rights to free expression.



For many, this incident serves as a reminder of the culture of impunity that has long existed in Nigerian politics.

The phrase "Do you know who you are talking to?" uttered by another official during the confrontation, only deepened concerns about the state of politics in Nigeria. It suggests a troubling hierarchy, where officials feel their positions grant them immunity from criticism and scrutiny. This kind of thinking undermines the democratic process and alienates citizens who expect transparency from their leaders.

It's not just about one commissioner's conduct. This incident highlights a wider issue: when officials begin to see themselves as above the law, it weakens public trust and erodes democratic values. Citizens' voices become sidelined, and leaders no longer feel accountable to those they serve.

Calls for investigation and legislative change

US Judge declines to jail Trump despite hush money conviction By New Daily Prime

onald Trump has been given an unconditional discharge following his conviction in the Stormy Daniels hush money case. The decision means the incoming US president will not face jail time, probation, or a fine.

Manhattan Judge Juan M. Merchan, who had the authority to sentence Trump to up to four years in prison, announced the verdict. This sentencing occurs just days before the 78-year-old is set to be inaugurated for his second term as US president on January 20.

Trump appeared at the hearing via videolink, addressing the court before his sentencing. He described the case as a "very terrible experience" and claimed it was handled inappropriately by individuals with connections to his political opponents, specifically referring to Manhattan District Attorney Alvin Bragg.

"It was done to damage my reputation so I would lose the election," Trump stated. "This has been a political witch hunt. I am totally innocent. I did nothing wrong." Concluding his remarks, he added, "I was treated very unfairly, and I thank you very much."

Judge Merchan emphasized his responsibility to determine a just conclusion. Despite the guilty verdict, the judge opted for an unconditional discharge, a sentencing decision under New York law that imposes no imprisonment, fine, or probation supervision when the court determines no purpose would be served by imposing conditions.



Prosecutor Matthew Steinglass criticized Trump's conduct, stating, "He's been unrelenting in his attacks against this court, prosecutors, and their families. His dangerous rhetoric and unconstitutional conduct have been a direct attack on the rule of law, and he has publicly threatened to retaliate against the prosecutors." Steinglass further argued that Trump's actions were "designed to have a chilling effect and to intimidate."

Trump's legal team attempted a lastminute appeal to the US Supreme Court to delay sentencing, arguing that evidence used during the trial violated a prior ruling granting Trump broad immunity for acts committed as president. However, the Supreme Court rejected this appeal.

Trump's conviction in May 2024 made him the first person convicted of a felony to assume the US presidency. The charges included 34 counts of falsifying business records related to

payments made to Stormy Daniels before the 2016 presidential election. Prosecutors alleged Trump paid Daniels \$130,000 to prevent her from disclosing details of an alleged sexual relationship in 2006, a claim Trump has consistently denied.

Despite the conviction, the trial's outcome did not deter American voters, who elected him for a second term. Legal experts noted that the unconditional discharge resolves the hush money case without imposing any penalties that might impede Trump's ability to serve as president.

Unconditional discharges are not uncommon in New York for cases involving convictions of falsifying business records. The decision underscores the judge's view that imposing further penalties on Trump would serve no proper purpose under the circumstances.

UK Govt considers ending free prescriptions for over-60s By New Daily Prime



abour opens door to scrapping free prescriptions for over-60s

The government has left the door open to ending free prescriptions for people over 60, as part of efforts to raise additional funds for the NHS. Ministers have not ruled out a future change that could see the qualifying age increased to align with the state pension age of 66.

Critics have accused the government of targeting older people through cuts to winter fuel payments and the refusal to provide compensation to the Women Against State Pension Inequality (Waspi) campaigners.

Currently, in England, all individuals over 60 are exempt from prescription charges, which stand at £9.90 per item. Raising the age threshold to 66 could generate over £1 billion in additional revenue for the NHS over the next five years.

Ian Byrne, a former Labour MP now serving as an independent, questioned ministers about potential changes to the exemptions. In response, Karin Smyth, a health minister, stated: "There are no current plans to review the list of prescription charge exemptions."

The Conservative Party previously explored equalizing the age for free prescriptions with the state pension age in 2021 but abandoned the proposal after facing strong opposition from pensioners. An impact assessment conducted at the time suggested the move could generate £225 million annually for the NHS, totaling £2.23 billion over ten years. Officials also estimated that reinvesting this revenue in the health service could create benefits worth £8.45 billion over the same period.

However, the change would have imposed an average annual cost of £50 to £100 in prescription charges for those aged 60 to 65. Last year, Tory ministers decided to retain the current rules, citing the ongoing cost-of-living crisis as a key factor.

When asked about Labour's stance on the issue, a Department of Health spokesperson reiterated: "There are no plans to amend any of the prescription charge exemptions. Children, those aged 60 and over, pregnant women, and individuals with medical conditions like cancer, epilepsy, and diabetes remain exempt from charges, ensuring that

everyone can access the vital medicines they need."

Helen Morgan, the Liberal Democrat health spokesperson, expressed alarm over the government's refusal to rule out changes. She stated: "It's deeply concerning that the government will not guarantee free prescriptions for the over-60s. Pensioners cannot afford yet another financial burden, especially after being let down by the Conservative Party and facing additional challenges under the Labour government this year. The government must provide clarity and commit to retaining the free prescription policy."

The use of the phrase "no plans" has fueled speculation about potential policy changes. Labour previously assured the public it had "no plans" to alter winter fuel payments, yet the government later withdrew them from 10 million pensioners.

Similarly, Education Secretary Bridget Phillipson stated after the July election that there were no plans to increase university tuition fees, only to announce a £285 annual hike to £9,535 a few months later.

Tottenham's Bentancur 'all good' after collapse against Liverpool By Timi-Zacchaeus Oluwaferanmi

ottenham Hotspur midfielder Rodrigo Bentancur has reassured fans that he is "all good" after being stretchered off during Wednesday's Carabao Cup semi-final against Liverpool.

The 27-year-old Uruguay international fell unchallenged while attempting to head a ball from a corner just six minutes into the match. After receiving treatment on the pitch for about nine minutes and requiring oxygen, Bentancur was taken to hospital for further checks.

He took to Instagram in the early hours of Thursday morning, thanking fans for their messages and congratulating his teammates for the 1-0 victory. "All good, guys. Thank you for the messages. Congratulations for the victory, boys," he posted.

Spurs manager Ange Postecoglou also offered an update after the match, stating, "I don't have all the information, but he was conscious when he got to the dressing room. We took him to the hospital to get checked over."

The win at Tottenham Hotspur Stadium was secured by a late strike from Lucas Bergvall, giving Spurs a crucial advantage heading into the second leg of the semifinal.
