ike a bolt out of the blue, Governor Abdullahi Sule of Nasarawa State has sacked the Secretary to the State Government (SSG), Muhammad Aliyu-Ubamdoma, and dissolved the state executive council (SEC).

Also, the governor booted out the commissioners, senior special advisers, special advisers, and personal assistants.

According to Daily Trust, the announcement was made during an emergency executive meeting at Government House, Lafia, on Friday, following Vice President Kashim Shetima's departure after inaugurating state projects during a one-day visit.

Also, a top government official, speaking anonymously said, "Although the exact reasons for the dissolution are unclear, the governor is known for restructuring the state's



administration."

In 2021, Governor Sule similarly dissolved the executive council, citing the need for a more effective and efficient governance structure.

The source added, "As the situation unfolds, citizens of Nasarawa State await further clarification on the

implications of this decision and the future direction of the state's administration."

The reason for the governor's drastic action and follow-up happenings like the replacement of the dismissed officials are expected in coming days.

Delta woman beats son to death

over N200

mother has allegedly beaten her 15-year-old son to death for stealing N200 in Warri, Delta State.

The tragic incident reportedly occurred on Thursday at Obire Street, off Cemetery Road in the rustic town.

According to an eyewitness, who did not want to be named, the boy's hands and legs were tied by his brother, and his body was burned with a hot knife during the punishment.

The source said, "When she realized that her son was dying, she ran out and cried for assistance.

"Unfortunately, before they arrived at the hospital, her son died."

The source also disclosed that the woman was previously evicted from a nearby compound where she lived due to her hostile relationship with neighbours.

The source further disclosed that her late son hawked smoked fish for the mother before his death, after which

SP Bright Edafe, Delta Command Police Public Relations Officer, (PPRO), when contacted for confirmation, stated that no such incident has been reported to the police. This shocking act has left the community in disbelief, with many calling for justice for the deceased.

Authorities have yet to release an official statement, but residents are urging a thorough investigation to ensure accountability.

Again, Tinubu defends subsidy removal, says 'It was necessary' By Dave Oludare Oso



For the umpteenth time, President Bola Tinubu has defended his administration's decision to remove fuel subsidy, insisting that it was a "necessary" move to secure the country's future.

The president had, during his inauguration ceremony in May 2023, declared an end to the subsidy regime, an action that resulted in an instant hike in the cost of petrol and cost of living.

Also, the resultant hardship on the generality of the Nigerian people led to pockets of protests and condemnation of the move by critics and a large percentage of the people.

However, President Tinubu, during his visit to Enugu State on Saturday, defended the bold action and said it was needed for a better Nigeria.

The president said, "You are all a member of one big, huge family called Nigeria but living in different rooms in the same house. This house, we must build it. Build it to satisfy our immediate need which is not going to be enough yet but for tomorrow too.

"That is why the removal of the first subsidy was necessary," Tinubu said at a stakeholders meeting held at the Government House in Enugu on Saturday.

"You cannot spend the future of generations yet unborn in advance. Don't bankrupt the nation before they are born. I know people will fight, grumble, abuse me, and everything but I asked for the job. I know what it takes. I believe in myself and I believe I can gather a very good team and build a nation."

President Bola Tinubu touched down at the Enugu airport on a working visit to commission various projects by the state government. He was received by Governor Peter Mbah.

Tinubu called on Nigerians to show

love for the country and shun negative comments about it.

"It is our country. We have to work really hard for it; to build a nation that we can be proud of. Change the narrative; negative comment about Nigeria? I'm not taking that! I'm very proud of Nigeria. You all should be proud of Nigeria," he told the gathering which included Governor Peter Mbah of Enugu State, government functionaries, and other dignitaries present at the event.

Some of the projects the president commissioned during the visit to the Coal State are the multi-auditorium and multi-functional Enugu International Conference Centre; state-of-the-art command and control Centre/150 patrol vehicles fitted with AI-embedded surveillance cameras at the Government House.

Information Officer of the Kano State Censorship Board, Abdullahi Sani Sulaiman in a statement revealed that Samha had been warned multiple times about her "crude dressing, vulgar displays, and language in her some videos."

The board emphasised that the actress' conduct had violated cultural and moral standards.

In addition to the suspension, the board has revoked Samha's licence and ceased censoring any films in which she appears.



"Kano State Censorship Board is empowered by law to ensure that all videos, writings, and other forms of expression align with the state's religion, culture, norms, and values," the statement explained. The board claimed that the suspension is part of the board's ongoing efforts to uphold moral standards in the Kannywood film industry and enforce the board's regulations.

Nobody made me governor, I grabbed power – Wike By Dave Oludare Oso

he Federal Capital Territory (FCT) Minister, Nyesom Wike, has declared that nobody enthroned him as governor of Rivers State, contrary to claims that some political leaders in the state made him governor.

The minister, who made the remarks during a civic reception he held in honour of some Rivers State politicians loyal to him on Friday in Port Harcourt, however, admitted that he received political support from certain leaders, but maintained that he ultimately fought his way to power.

The former governor was quick to contrast his rise politically to that of the current Governor, Siminalayi Fubara, whom he claimed he made governor of Rivers State.

Wike's statement comes on the heels of the resurfacing of old videos circulating on social media, where former First Lady of Nigeria, Patience Jonathan, appeared to present Wike to former governor Peter Odili and some political leaders in Rivers State as the preferred successor to then-Governor Rotimi Amaechi.

The unfolding drama follows an ongoing verbal war between Wike and one of his predecessors, Dr Peter Odili.

The verbal spat between Wike and Odili arose from the political crisis in the state that has placed the FCT Minister at loggerheads with his successor, Fubara.

Odili had publicly shown support for Governor Fubara, which infuriated Wike, who believes the former governor should have refrained from taking sides and instead played the role of a father figure by addressing the political crisis in the state.

The minster said, "You didn't give me. To be governor of Rivers State 2014, I fought for the party structure. I took it from Magnus Abe, yes, I did.

"So you can't say you made me governor. Nobody, I don't want to make comments about certain people, I won't do that.



"You Magnus, all of you, Victor Giadom, I fought you people, took the party structure.

"So, nobody can say I brought Wike, I dashed you. Nobody can say that. But it would be unfair to me, to Almighty God, for me to say nobody supported me.

"No, you can't say that. You need people's support, but not to say you gave me."

However, former President Goodluck Jonathan, his wife, Patience and Odili were said to have played major roles in Wike's emergence as governor of Rivers State in 2015. 6

Tinubu pledges completion of Eastern rail line, lauds Enugu's devt strides

resident Bola Tinubu has reaffirmed his administration's commitment to completing the \$3 billion Eastern Rail Line, connecting Port Harcourt in the Niger Delta to Maiduguri in Northeast Nigeria.

Speaking during an interactive session with South-East leaders in Enugu on Saturday, the President assured the audience of his determination to address the delays plaguing the project.

The rail line, initiated by former President Muhammadu Buhari in 2021, spans 1,443 kilometers and is being reconstructed and expanded to 2,044 kilometers with additional branches to Owerri and Damaturu.

Tinubu acknowledged its potential to boost transportation infrastructure and stimulate economic activities along the corridor.

During the session, Tinubu also pledged to support the development of the Anambra Basin, which is estimated to hold 1 billion barrels of oil and 30 billion cubic feet of gas, positioning it as a significant energy reserve for the region. Former Minister of Power, Prof. Chinedu Nebo, and Enugu indigene Chris Ugoh

appealed to the President for support, highlighting the rail line's economic importance and the Anambra Basin's potential for power generation and industrial feedstock.

The President also addressed security concerns in the Southeast, endorsing modern solutions such as CCTV systems and AI-enabled patrol vehicles to ensure safety while discouraging reliance on roadblocks and checkpoints.

Earlier, Tinubu inaugurated several projects executed by Governor Peter Mbah's administration, including the GTC Smart Green School, the International Conference Center, and the Command-and-Control Center.

He commended the governor for his innovative development philosophy and commitment to human capital growth.

Governor Mbah, in his remarks, praised Tinubu for liberalizing the electricity sector through the amended Electricity Act and for establishing the South East Development Commission.

He outlined his vision to grow Enugu's economy from \$4.4 billion to \$30 billion within four years, Tinuburesponded with a commitment leveraging improved security, modern education, and upgraded healthcare.

n January 2, 2025, during a media chat in Abuja, Peter Obi, former governor of Anambra State and 2023 presidential candidate of the Labour Party, criticized President Bola Tinubu's extensive international travel since assuming office on May 29, 2023. Obi claimed that Tinubu had spent over 30% of his time—approximately 180 out of 580 days-on more than 30 publicly recorded overseas trips. He urged the President to allocate at least 20% of 2025, roughly 72 days, to visiting each of Nigeria's 36 states for two days each, to better understand the nation's economic and security challenges.

An investigation by the New Daily Prime sought to verify Obi's claims. Findings revealed that, as of January 4, 2025, President Tinubu had visited more than 26 countries, spending an average 180 days abroad. This aligns with the Punch report dated on October 20, 2024, which outlined that Tinubu had undertaken 29 journeys, spending 124 days abroad and visiting 16 countries, accumulating over 127 flight hours.

Since taking office, President Tinubu has also taken at least one official private holiday. On October 2, 2024,

he departed Abuja for the United Kingdom to begin a two-week vacation, described as a "working vacation" to reflect on his administration's economic reforms. However, the frequent traveling has raised public concern, with many labelling Tinubu as a "globetrotting president." In terms of cost, reports indicate that during the first six months of his presidency, Tinubu spent at least N3.4 billion (\$2.2 million) on domestic and foreign travel, exceeding the budgeted amount for 2023 by 36%.

Despite the criticism, the President's travels have reportedly attracted foreign investors and promoted Nigeria's image internationally. Under his administration, more than $\mathbb{N}4.2$ trillion in Memorandums of Understanding (MoUs) have been signed. His first international trip as President was to Paris on June 21, 2023, to attend the New Global Financing Pact Summit, marking his initial foray into international diplomacy. Subsequent travels included visits to the United States, United Kingdom, India, Kenya, Equatorial Guinea, Guinea-Bissau, Benin Republic, Netherlands, South Africa, Ghana, United Arab Emirates, Saudi Arabia, Germany, Ethiopia,

Senegal, and Qatar, among others. These visits align with the President's constitutional duties. Section 5(1)(a) of the Nigerian Constitution grants the President executive powers to execute and maintain the Constitution and all laws made by the National Assembly, encompassing the conduct of foreign affairs and international relations. This includes the promotion and protection of national interest, African integration, international law, and the settlement of international disputes.

For instance, on July 8, 2023, President Tinubu visited Guinea-Bissau to participate in the 63rd Ordinary Session of the Authority of Heads of State and Government of the Economic Community of West African States (ECOWAS), where he was unanimously elected as chairman of the West African bloc. On August 28, 2024, he visited China to seek economic cooperation in areas such as the economy, agriculture, and satellite technology. During this visit, Nigeria signed an MoU with China for infrastructure development worth about \$2 billion. Additionally, on December 9, 2023, an MoU was signed to establish a \$150 million Lithium-Ion battery manufacturing and processing factory in Nigeria.

Gulma, said a security meeting was underway and that security agents had been directed by the state government to recover the stolen cows.

Confirming the report tonewsmen, SP Nafiu Abubakar, the police command public relations officer, said, "It is true, two of our men died during an encounter with them."

PETROAN calls for refinery privatization

he Petroleum Products Retail Outlets Owners Association of Nigeria (PETROAN) has urged the federal government (FG) to privatize state-owned refineries.

PETROAN further requested a N100 billion grant from President Bola Tinubu to sustain oil marketers amid economic challenges.

In a statement titled "PETROAN's Retrospect of Nigeria's Oil and Gas Downstream Sector 2024", the association highlighted significant developments in the sector over the past year while recommending key reforms.

It called for the privatization of refineries like those in Warri and Kaduna, proposing their transfer to reputable private companies to enhance operational efficiency and reduce government expenditure.

Signed by PETROAN President Billy Gillis-Harry, National Secretary Adedibu Aderibigbe, and Spokesman Joseph Obele, the statement emphasised that the N100 billion grant would prevent the collapse of over 10,000 oil



marketers' businesses and mitigate job losses triggered by the removal of fuel PETROAN also advocated for tighter border security to curb smuggling and suggested the adoption of digital tracking systems to monitor the movement of petroleum products from refineries to retail outlets.

The removal of fuel subsidies in May

2023 saw petrol prices surge from N170 to around N1,000 per liter in many parts of the country.

To address this, PETROAN urged the FG to foster a competitive market, encourage new entrants, and maintain fair pricing by preventing monopolies in the sector.

Zulum introduces fuel subsidy for farmers

n a rare display of empathy, Governor Babagana Zulum, has introduced petrol subsidy for farmers in communities impacted by the Boko Haram insurgency, reducing the price to N600 per litre.

He announced this yesterday during the flag-off of farm input distribution in Bama town, benefiting over 5,000 displaced farmers.

Abdulrahman Bundi, the governor's Senior Special Assistant on New Media, revealed the details in a statement today.

Governor Zulum highlighted the financial struggles faced by farming communities due to the high cost of fuel.

In Maiduguri, petrol currently sells for N1,000 to N1,200 per litre, but under this subsidy, irrigation farmers will purchase it at N600 per litre.

He said this measure aims to ease the financial burden on farmers in areas



devastated by years of conflict.

Zulum further directed the Commissioner for Agriculture and the Brigade Commander to ensure swift delivery of subsidised petrol to farmers in Bama.

In addition to the subsidy, Zulum distributed some essential farming inputs to the farmers.

These included 2,000 bags of blended NPK fertilizer, 1,000 water pumps, and 620 gasoline pumps.

He also provided 380 solar water pumps, 1,000 sprayers, and 800 rolls of flexible hoses.

Furthermore, the distribution included 1,000 litres of pesticides, improved seeds, and other critical farming materials to support agricultural activities in the region.

The governor also commended the federal government for supporting efforts to rebuild and resettle communities affected by insurgency.

Hush money case: Trump to be sentenced Jan 10, avoids jail time By Dave Oludare Oso

Incoming US President Donald Trump will be sentenced on 10 January in his hush-money case in New York – less than two weeks before he is set to be sworn in as president, a judge has ordered.

On Friday, New York Justice Juan Merchan signalled he would not sentence Trump to jail time, probation or a fine, but instead give him an "unconditional discharge", and wrote in his order that the president-elect could appear in person or virtually for the hearing.

The president-elect had vigorously attempted countless times, to use his presidential election victory to

have the case against him dismissed, but his efforts have been fruitless.

Trump has posted on social media dismissing the judge's order as an "illegitimate political attack" and calling the case "nothing but a rigged charade".

He was convicted in May of 34 felony counts of falsifying business records related to a $$130,000 \ (\pounds 105,000)$ payment to adult-film star Stormy Daniels.

The charges related to attempts to cover up reimbursements to his exlawyer, Michael Cohen, who in the final days of the 2016 election campaign paid off the adult-film star to remain silent about an alleged sexual encounter with Trump.

The president-elect has denied all wrongdoing and pleaded not guilty, arguing the case was an attempt to harm his 2024 presidential campaign. In the post on his Truth Social platform on Saturday Trump said the judge's sentencing order "goes against our Constitution and, if allowed to stand, would be the end of the Presidency as we know it".

Trump's spokesperson Steven Cheung earlier called the order part of a "witch hunt".

"President Trump must be allowed to continue the presidential transition process and to execute the vital duties of the presidency, unobstructed by the remains of this or any remnants of the witch hunts," Cheung said.

"There should be no sentencing, and President Trump will continue fighting against these hoaxes until they are all dead."

In his latest motion against the case, Trump had argued the case would hang over him during his presidency and impede his ability to govern.

Justice Merchan said he had been advised of several measures he could employ that could assuage Trump's concerns about being distracted by a criminal case while serving as president that fell short of the "extreme remedy" of overturning the jury's verdict.

His options included delaying the sentencing until Trump, 78, leaves the White House in 2029, or guaranteeing a sentence that would not involve prison time.

Trump had initially, and unsuccessfully, argued the case against him ran afoul of a Supreme Court ruling on presidential immunity.

In July, the country's top court ruled that presidents have broad immunity from criminal prosecution for "official actions" they take while in office. However, last month Justice Merchan ruled Trump's hush money conviction was valid.

Trump is currently set to be the first convicted felon to serve in the White House.

He may attempt to appeal against the conviction after the sentencing.

While falsifying business records is punishable by up to four years in prison in the US, there is no minimum sentence and incarceration is not required.

Even before his election victory, legal experts thought it was unlikely Trump would face jail time given his age and his legal record.

Trump has also been charged in three other state and federal criminal cases: one involving classified documents and two relating to his alleged efforts to overturn his loss in the election of 2020.

The president-elect was initially scheduled to be sentenced on 26 November, but Justice Merchan pushed the date back after Trump won the presidential election.

Severe weather alert: Heavy snow, freezing rain, power cuts expected across UK By Dr. Olaoluwa Vincent Ajayi

D p to 30cm of snowfall is predicted, risking significant disruption to travel, power supplies, and rural communities disruption across UK

Large swathes of the UK are preparing for significant disruption this weekend as the Met Office issues amber weather warnings for heavy snow and freezing rain. The severe conditions are expected to bring stranded vehicles, power outages, and delays or cancellations to rail and air travel.

Forecasters have warned of up to 30cm of snow in some areas, with rural communities facing a "good chance" of being cut off. Temperatures plummeted overnight to minus 5°C in parts of Cheshire and Somerset, just shy of predictions of minus 8°C.

The icy conditions have already had tragic consequences. A seven-monthold baby died in a collision on a Lincolnshire dual carriageway on Thursday night, with police investigating the role of icy roads in the crash.

As temperatures fell well below freezing, Health Secretary Wes Streeting sparked controversy by advising people to turn their heating on, despite government cuts to winter fuel payments for pensioners.



Streeting remarked that it was "definitely a weekend to turn the heating on," prompting backlash from campaigners. Dennis Reed, director of the pensioner advocacy group Silver Voices, criticized the government for being "in denial" about the impact of its policies. Overnight lows of -8.6°C were recorded in Aberdeenshire, with sub-zero temperatures also reported across Monmouthshire, Dorset, and County Down.

National Highways has urged motorists to travel only if necessary and to pack essential winter supplies, including food, warm clothing, blankets, and a snow shovel. Drivers are advised to plan their journeys carefully, as freezing rain and black ice could create hazardous road conditions.

The UK is also set to experience freezing

rain, a rare and disruptive weather phenomenon described as liquid precipitation that freezes on contact with cold surfaces. Professor Liz B e n t l e y of t h e R o y a l Meteorological Society warned of significant disruptions, including black ice on roads and weighty ice coatings on trees, power lines, and aircraft.

"It's like a glazing of ice that can cause serious problems," Bentley explained. The ice could impact airport runways and even prevent planes from taking off, adding to the weekend's expected disruptions.

As the UK braces for the bitter weather, authorities are urging vigilance and preparation to minimize the risks posed by these rare and extreme conditions.



World's oldest person, Tomiko Itooka dies at 116 By Elizabeth Jenrola Oso



miko Itooka, a Japanese woman, who was the world's oldest person according to Guinness World Records, has died, an Ashiya city official said Saturday. She was 116.

Yoshitsugu Nagata, an official in charge of elderly policies, said Itooka died on Dec. 29 at a care home in Ashiya, Hyogo Prefecture, central Japan.

Itooka, who loved bananas and a yogurt-flavored Japanese drink called Calpis, was born on May 23, 1908.

She became the oldest person last year following the death of 117-

year-old Maria Branyas, according to the Gerontology Research Group.

When she was told she was at the top of the World Supercentenarian Rankings List, she simply replied, "Thank you."

When Itooka celebrated her birthday last year, she received flowers, a cake and a card from the mayor.

Born in Osaka, Itooka was a volleyball player in high school, and long had a reputation for a sprightly spirit, Nagata said. She climbed the 3,067-meter (10,062-foot) Mount Ontake twice.

She married at 20, and had two daughters and two sons, according to Guinness.

Itooka managed the office of her husband's textile factory during World War II. She lived alone in Nara after her husband died in 1979.

She is survived by one son, one daughter and five grandchildren. A funeral service was held with family and friends, according to Nagata.

According to the Gerontology Research Group, the world's oldest person is now 116-yearold Brazilian nun Inah Canabarro Lucas, who was born 16 days after Itooa.

No love lost between Trump, Biden as inauguration looms By Dave Oludare Oso

hings could be a little frosty inside the president's armored limo on the morning of January 20.

President Joe Biden and Donald Trump, his predecessor and successor, have never been friendly. The current commander in chief thinks the president-elect is a mortal threat to America's soul. Trump has long insulted "Sleepy Joe" Biden and claims he ordered his multiple indictments, despite a lack of evidence

The atmosphere between the two men is worsening by the day as the inauguration nears.

Biden keeps landing jabs seemingly calculated to get under Trump's skin. And the president-elect has been taking his lumps on social media.

On Wednesday, Biden warned that no one should "jump to conclusions" about the terror attack in New Orleans — hours after Trump had done exactly that by implying on social media that the suspect was a foreign terrorist who recently crossed over the southern border. In fact, he was from Texas and a natural-born US citizen.

The president-elect appeared to be basing his claim on an erroneous media report.

On Sunday, Biden was asked what Trump should take away from the life of Jimmy Carter after the 39th president's passing. "Decency. Decency, "he replied.

"Can you imagine Jimmy Carter, walking by someone who needs something and just keep walking?" Biden asked. "Can you imagine Jimmy Carter referring to someone by the way they look or the way they talk? I can't."

In what appeared to be an implicit criticism of Trump's character and leadership style, Biden said this of Carter: "The rest of the world looks to us ... and he was worth looking to."

In another repudiation of Trump, Biden on Thursday awarded one of America's highest civilian honors to Liz Cheney, the former Republican congresswoman from Wyoming who split with Trump over his refusal to accept the result of the 2020 election.

She was the vice chair of the bipartisan congressional committee that investigated the January 6, 2021, mob attack on Congress. Cheney, who lost her

House seat to a Trump-backed primary challenger, got a prolonged standing ovation at the White House when she received the Presidential Citizens Medal for "putting the American people over

party." Capitol Hill Republicans are threatening to investigate Cheney over her role in probing Trump. And there is speculation that Biden could offer her a preemptive pardon to shield her from criminal prosecution by the incoming Justice Department — even though there is no indication that she broke the law.

The next day, Trump bashed Cheney and Democratic Rep. Bennie Thompson, who chaired the January 6 committee and also received the award from Biden.

"The people of Wyoming understood how bad for our country she was, but Biden rewarded her only because she hated 'TRUMP," the president-elect wrote of the former congresswoman on Truth Social, calling her "totally corrupt."

Trump isn't holding back on other issues either.

After praising Carter after his death on Sunday, the president-elect soon injected himself and his upcoming inauguration into the national mourning of the 39th president, complaining that American flags will still be lowered when he's sworn in on January 20.

"Because of the death of President Jimmy Carter, the Flag may, for the first time ever during an Inauguration of a future President, be at half mast. Nobody wants to see this, and no American can be happy about it. Let's see how it plays out. MAKE AMERICA GREAT AGAIN!"



Trump posted on Truth Social on Friday while waiting for the House to elect a speaker.

Asked if the Biden administration was reconsidering lowering the flags, White House press secretary Karine Jean-Pierre said no.

And despite Biden's implicit rebuke, Trump again sought to blur the truth about the New Orleans truck terror attack in which 14 people were killed.

"With the Biden 'Open Border's Policy' I said, many times during rallies, and elsewhere, that Radical Islamic Terrorism, and other forms of violent crime, will become so bad in America that it will become hard to even imagine or believe,"

Trump wrote on his Truth Social network. "That time has come, only worse than ever imagined. Joe Biden is the WORST PRESIDENT IN THE HISTORY OF AMERICA, A COMPLETE AND TOTAL DISASTER.

Trump isn't wrong to raise the possibility that terrorists could infiltrate the US over the southern border.

Biden's own Homeland Security Department warned of this exact scenario earlier this year. But the president-elect is also misleadingly implying that the attack on New Orleans is such an example.

In fact, it's a sign of something that worries the FBI even more — an attack carried out by an American citizen who appears to have been inspired by ISIS to carry out carnage of his own volition.

10 million face food insecurity in UK

s the holiday season turns our attention to festive meals like turkey and mince pies, the pressing issue of food security takes center stage. In the UK, an alarming 10 million people face food insecurity, meaning they lack consistent access to affordable, nutritious food. Compounding this crisis, the government recently warned that the climate crisis poses a serious threat to the nation's food security. At the same time, farmers have been protesting in Westminster, arguing that a weakened agricultural sector undermines the UK's ability to produce its own food.

FareShare, a network of 8,300 charities, 34 regional centers, and 26,000 volunteers, reaches a million people annually, supporting children's breakfast clubs, lunch groups for older adults, and grassroots initiatives tackling isolation and hardship. Despite these efforts, the organization struggles to meet growing demand.

This challenge is especially frustrating given that the UK wastes 12.8 million tonnes of surplus food every year, contributing 6-7% of the nation's greenhouse gas emissions. Shockingly, 3 million tonnes of this waste occurs before food even leaves the farm. Yet, less than 20% of farmers donate their surplus to charities.

Recent progress offers a glimmer of hope. After years of advocacy by FareShare and The Felix Project, the government announced £15 million for farm-level surplus redistribution — an acknowledgment of the potential in repurposing surplus food. This initiative underscores that surplus food isn't just a problem; it's an opportunity.

Redistributing surplus food has profound social benefits. Last year, FareShare provided 135 million



meals to over 8,300 charities, including Wigan Youth Zone, which combines meals with enriching activities like basketball and drama. A forthcoming University of Hertfordshire report highlights that for every £1 spent on surplus food redistribution, the UK sees £13 in social return on investment. However, realizing this potential requires scaling up food redistribution efforts.

Contrary to popular belief, retail accounts for only 2.34% of food waste. While retailers are reducing their waste, redistributors must shift their focus further up the supply chain to sectors like hospitality (8.59%), manufacturing (11.72%), and farming (25%) to capture more surplus food.

The US offers valuable lessons in creating a policy environment that supports surplus food redistribution. Tax incentives there encourage businesses to donate surplus food by offsetting redistribution costs. These measures balance compensation with safeguards against misuse, demonstrating the potential impact of small policy changes.

The UK could adopt similar measures, including mandatory food waste reporting, clear guidance for businesses on food donation, and policies that designate food redistribution as a "public good" under Environmental Land Management schemes. Technology platforms to coordinate redistribution and strategies to reduce reliance on charitable food aid by addressing poverty at its root are also essential.

The UK government's recent strategies on food, the circular economy, and child poverty show promise. Steve Reed, Secretary of State for Defra, has expressed urgency in tackling food insecurity. Furthermore, reducing food waste is critical to combating climate change, as it produces five times the emissions of the aviation sector. Globally, food waste ranks as the third-largest emitter after the US and China, prompting international commitments to halve food waste and reduce related emissions.

Addressing food waste unites diverse stakeholders, bridging rural and urban divides while strengthening communities. By improving the food system, the UK can simultaneously reduce hunger, lower emissions, and create a healthier, fairer society. As we celebrate the holidays, it's vital to remember that food security isn't just about what's on our plates it's about creating a sustainable future for all.

UK mortgage approvals unexpectedly





UK mortgage approvals dropped unexpectedly in November, signaling caution among households post-Budget. Consumer credit growth hit a 29month low as borrowing costs and stamp duty changes impacted the housing market.

UK mortgage approvals unexpectedly fell in November, interrupting the gradual recovery in housing market activity. Data released by the Bank of England on Friday revealed a decline in net mortgage approvals — approvals net of cancellations — to 65,700 in November, down from 68,100 in October and below the 68,500 forecast by economists polled by Reuters.

The figures indicate growing caution among households following the Autumn Budget, as borrowing costs remain elevated. Consumer credit growth also slowed, with a £0.9 billion rise in November compared to the £1.0 billion increase in October and an average monthly gain of £1.2 billion over the prior six months. The annual growth rate for consumer credit dropped to 6.6 percent, its lowest in 29 months.

Elias Hilmer, economist at Capital Economics, attributed the cautious behavior to ongoing financial uncertainties. "Households' caution

with their

borrowing and saving ahead of the Budget hasn't gone away," he said, warning that the data adds to the risk of economic contraction in the final quarter of 2024. The UK economy stagnated over the three months to September and contracted in October.

Despite the dip, some experts see the data as a return to normal activity levels after a volatile October. Elliott Jordan-Doak of Pantheon Macroeconomics noted that pre-Budget fluctuations had created temporary distortions in the market.

While mortgage approvals fell sharply over 2022 and remained subdued in 2023 due to rising borrowing costs, approvals have rebounded by 13,000 so far in 2024 as rates eased. However, November saw a slight uptick in mortgage rates, dampening demand. "November was an average month, possibly due to the Autumn Budget taking the steam out of the market and hitting sentiment," said Charles Yuille, managing director at Willow Brook Mortgages. He added that demand remained strong, fueled in part by the impending end of the stamp duty holiday.

Chancellor Rachel Reeves confirmed in the Budget that the temporary stamp duty holiday, which raised the threshold for first-time buyers from £300,000 to £425,000, will end in March. From April, first-time buyers will face higher stamp duty costs on properties worth more than £300,000.

Tomer Aboody of MT Finance expects further interest rate cuts in 2024 to help stabilize the housing market. "Lower borrowing costs should help boost mortgage approvals and get them back on track," he said.

In November, the Bank of England reported a drop in the effective interest rate on new mortgages to 4.5 percent, the lowest since April 2023. However, the rate on outstanding mortgages rose to 3.8 percent, the highest since the series began in 2016, reflecting the impact of rising borrowing costs since 2021.

On a more positive note, house prices continued to climb. Data from Nationwide showed a 4.7 percent annual increase in December, marking the fastest pace of growth since October 2022.

As the housing market grapples with shifting conditions, experts suggest that cautious optimism may be warranted. The combination of interest rate adjustments and policy changes in early 2024 will likely shape the trajectory of mortgage approvals and overall market activity in the months ahead.

Postecoglou supports Maddison's darts outing despite illness

Postecoglou emphasized the

importance of managing Maddison's fitness amid a congested fixture list: "Keeping Madders fit and sharp is crucial. He's made a strong impact when he's played, and we want him to keep doing so."

Miami Heat suspend Jimmy Butler, explore trade options

The Miami Heat have suspended six-time NBA All-Star Jimmy Butler for seven games due to "conduct detrimental to the team" and confirmed they are open to trade offers for the star forward.

In a statement released by the team, the Heat cited multiple incidents over the season, particularly in recent weeks, as the reason for their decision. "Through his actions and statements, Jimmy has shown he no longer wants to be part of this team," the statement read.

Butler, 35, has publicly expressed dissatisfaction with his position at the Heat, stating he would "probably" not want to continue playing for the team.

The suspension marks a significant shift from comments made by Heat team president Pat Riley just last week,



asserting there was no intention to trade Butler.

Since joining the Heat in 2019, Butler has made 377 appearances and has been a pivotal player in their campaigns. This season, he has averaged 17.6 points, 5.5 rebounds, and 4.7 assists per game.

Butler's last outing was a 128-115 loss to the Indiana Pacers, where he

contributed nine points, four assists, and two rebounds.

The Heat's willingness to entertain trade discussions signals the potential end of Butler's tenure in Miami. With previous stints at the Chicago Bulls, Minnesota Timberwolves, and Philadelphia 76ers, Butler remains one of the league's most sought-after talents.
