Tinubu lauds governors for endorsing tax reform bills By Dave Oludare Oso

he President, Asiwaju Bola Tinubu has lavished praises on state governors under the platform, Nigeria Governors' Forum (NGF) following their unanimous endorsement of the Tax Reform Bills currently being deliberated upon by lawmakers at the national assembly.

The president, in a statement by his Special Adviser on Information and Strategy, Bayo Onanuga on Friday, commended the governors for "their bold leadership and commitment to fostering unity among leaders nationwide."

The statement is titled 'President Tinubu commends Nigeria governors for supporting tax reform initiatives.'

Tinubu said the consensus transcends regional, ethnic and political barriers to advance Nigeria's development.

NEW DAILY PRIME reports that the governors on Thursday endorsed Tinubu's proposed tax reform bills, including the contentious shift to a derivation-based VAT model.

The President described Thursday's consultation between the Nigeria Governors' Forum and the Presidential Committee on Tax and Fiscal Policy as "a commendable example of cooperation between the Federal and State governments."

He extended special commendations to the Chairman of the Governors' Forum, the Kwara State Governor, Abdulrahman AbdulRazaq, for successfully galvanising support C among his peers for these R transformative tax bills to rejuvenate c the national economy and enhance re Nigeria's investment climate.

He also commended the Progressive Governors Forum, the Northern Governors Forum, and all other groups that made the bipartisan resolution of the controversy stirred by the tax bills possible.

Tinubu noted that the primary aim of the Tax Reform Bills, which is propoor, is to promote national interests, improve the competitiveness of Nigeria's economy, and attract both local and foreign investments.

He argued that updating the country's outdated tax laws is essential to this endeavour.

"The President notes that the dialogue between the NGF and the Presidential Committee on Tax and Fiscal Policy Reform highlights the power of constructive conversation in resolving differences.

"President Tinubu regards the governors as vital contributors to nation-building and affirms his commitment to partnering with them to promote economic growth, national harmony, peace, and stability," the statement read.

The President also encouraged other stakeholders with ideas and suggestions for refining the Tax Bills to engage with the ongoing legislative process at the National Assembly.

Tinubu urged the National Assembly to expedite the legislative process for these crucial bills so that the country can swiftly reap the benefits of the reforms.

No plans to increase petrol price – Oil marketers By Dave Oludare Oso

The Independent Petroleum Marketers Association of Nigeria (IPMAN) has refuted rumours of an impending increase in petrol prices nationwide.

News

The association assured the public that local refineries are now operational, a development that will contribute to a reduction in fuel prices.

Recall that there have been fresh concerns over a potential increase in the pump prices of petrol after the cost of Brent, the global benchmark for crude, crossed \$80 per barrel.

On Monday, private depots increased the loading cost of petrol and other refined petroleum products to N950 per litre.

However, in an interview with the Voice of America on Friday, Bashir Salisu Tahir, Chairman of IPMAN's Northwest Chapter, dismissed claims of any plans to hike petrol prices.

He emphasized that none of their members had increased the price of petrol across the country.

Tahir explained, "The market now determines prices, and there is no truth to the rumors of an increase in petrol prices. While diesel prices have risen recently due to market dynamics, they will naturally fall when market conditions improve."

He added that the resumption of operations at the nation's refineries is expected to further stabilize and reduce petrol prices.

Similarly, the Minister of State Petroleum Resources (Oil), Heineken Lokpobiri, has said the price of crude oil in the international



market remains a major force in driving the fluctuations in the pump prices of petrol.

He said the downstream sector is now fully deregulated with the government no longer involved in setting prices.

The minister said these at the inaugural meeting of the Petroleum Industry Stakeholders Forum, held on Thursday in Abuja.

Lokpobiri, speaking to journalists after the meeting, pointed out that deregulation ended all malfeasance associated with the petrol subsidy policy.

According to him, the government is now more interested in quality control as petrol prices are not controlled or predicted by an individual but by market forces.

He said, "The whole essence of deregulation is for price to find its level. Before now you will agree with me that every day you are hearing negative news about petrol subsidies. Today, you journalists have no negative news about petrol subsidies because it is completely regulated, and the price will find its level.

"As oil price goes up, petrol price will go up, and as oil price comes down, the price will come up. During the Christmas season, I was in Bayelsa, and I tried to go around different filling stations. Some filling stations were selling N1,020, others were selling N999, while others were selling N1,015.

"What we are concerned about, and I've always had that discussion with you, with the Authority Chief Executive of the Nigerian Midstream and Downstream Petroleum Regulatory Authority, is that the government is more interested in quality control. The government is more interested in availability, and what the government is particularly interested in is the dispensation of the right quantity.

"If you are buying 10 litres of PMS, let it be that you are not shortchanged by the retail filling station. That is where we have issues. And once there is competition, people have a choice, and that's why you don't see any queues." 5

Truck rams into building, kills 9 family members in Benue

Umahi: N800bn budget inadequate for fixing Nigeria's roads By Friday Omosola


a v i d U m a h i , Nigeria's Minister of Works, has stated that the N800 billion allocated to his ministry in the 2025 budget proposal is insufficient to address the country's road infrastructure needs.

Speaking at the 2025 budget defence session organised by the House Committee on Works on Friday, Umahi, a former two-time governor of Ebonyi State, urged the committee to increase the ministry's funding for the upcoming fiscal year.

"We are pleading for your help. N800 billion is inadequate—it cannot meet our road requirements. We appeal for your assistance," he said.

The Minister emphasised that the current budget would not be enough to complete ongoing projects or start new ones, highlighting the need for adequate funding to address the nation's infrastructure demands.



He also pointed out the challenges posed by the funding shortfall, noting that numerous unfinished road projects cannot be completed with such a "meagre budget."

He suggested borrowing as a practical solution to bridge the gap and tackle Nigeria's infrastructure deficit.

"When the nation is in recession, borrowing for infrastructure investment is crucial. It's the path to recovery. Infrastructure spurs economic activity, helping sectors like food vendors, sand suppliers, and gravel suppliers. Supporting this initiative will pave the way for Nigeria's greatness," Umahi added.

During the session, he responded to queries from committee members about the state of national roads and reiterated the government's commitment to completing ongoing projects.

In response, committee chairman Akin Alabi promised to call on Finance Minister Wale Edun and Budget Office Head Tanimu Yakub to justify the ministry's budget allocation.

Dangote hikes petrol price to N955/litre from N899

he Dangote Refinery has raised the price of Premium Motor Spirit (PMS) for bulk buyers from N899 to N955 per litre.

The refinery disclosed this development in a notice issued, which read, The notice titled, "Communication on PMS Price Review".

"Dear Esteemed Customer, Trust this email finds you well.

"Kindly be advised that effective from 5:30pm today, an upward adjustment has been implemented on the gantry price of Premium Motor Spirit. on Friday, January 17,2025."

The statement added that marketers buying between 2 million – 4.99 million litres will now buy at N955 per litre while five million litres & above will buy at N950 per litre.

The amount marks an increase of N55.5 or 6.17 per cent from N899.50 per litre announced as a holiday discount for Nigerians last year December.

This adjustment applies to all stock balances yet to be lifted by the stated time while pending stock as of the effective time will also be repriced at the updated



rates.

The statement added that the new price regime will take effect from 5:30pm, today (Friday).

The price increase is expected to have widespread effects on the downstream petroleum sector, particularly private depots and retail markets.

An oil and gas expert, Olatide Jeremiah, said depots are poised to increase the loading price of refined petroleum products because of the heavy influence of the refinery.

Jeremiah, who is the Chief Executive Officer of petroleum price.ng, said, "Dangote Refinery's influence on Fuel price has become unmatched; private depots, Major marketers, and independent Marketers will compete with this new price. Therefore, Nigerians should expect an increase in Petrol Pump Price.

"Brent Crude oil as of today is \$81.84, highest in 2025, its one major factor for the increase."

Court of Appeal affirms Abure as LP Chairman By Friday Omosola

The Court of Appeal in Abuja has reaffirmed that Julius Abure is the National Chairman of the Labour Party (LP).

A three-member panel of the appellate court, led by Justice Hamma Barka, declared that its previous ruling on November 13, 2024, which recognized Abure's position as the national chairman, stands and has not been overturned by any other court.

Justice Barka delivered this ruling while resolving two separate appeals filed by Senator Esther Nenadi Usman, the Labour Party caretaker committee, and the Independent National Electoral Commission (INEC).

In both appeals, the appellate court clarified that it did not address the issue of Labour leadership, as such matters are not subject to judicial review.

The court further explained that any action taken outside the court's jurisdiction is void, and therefore, the Federal High Court's ruling on October 8, 2024, delivered by Justice Emeka Nwite, holds no legal effect, as it was issued without jurisdiction.

In dismissing the suit due to lack of jurisdiction, the appellate court reaffirmed its November 13, 2024, judgment, confirming that "Abure remains National Chairman of the Labour Party."

Background of Abure and Labour Party legal battle



In February 2023, Oluchi Oparah, the party's national treasurer, accused Abure of misappropriating N3.5 billion, a claim the LP chairman denied while threatening legal action.

The allegation led to calls from party members for Abure's removal.

In April 2023, the FCT high court issued an order restraining Abure from parading himself as the national chairman of the LP.

While ruling on an ex parte application, Hamza Muazu, the presiding judge, also restrained Farouk Ibrahim, national secretary; Clement Ojukwu, national organising secretary; and Opara; from parading themselves as national officers of the party.

On September 4, Usman, a former senator representing Kaduna south, was appointed to chair a 29-member caretaker committee after Alex Otti, governor of Abia state, convened a stakeholders meeting of the party in Umuahia.

Peter Obi, LP's presidential candidate in 2023, and Datti Baba-Ahmed, the running mate, were among the top party members that attended the meeting.

INEC had also invalidated Abure's leadership, saying the national convention violated the constitution and Electoral Act.

The electoral body said the party failed to meet legal requirements for holding the convention, insisting that Abure's tenure as LP national chair expired in June 2024.

But in a judgment on October 8, the federal high court affirmed the Abureled leadership and the March 2024 Nnewi convention that produced the party executives.

Nwite ordered INEC to recognise Abure as the legitimate chairman of the party.

The influencer pointed out that that Seyi's purported governorship ambition is gaining momentum, as those backing the campaign are still testing the waters.

VDM said in a video shared via his Instagram page that even though had a l w a y s c a n v a s s e d y o u t h inclusiveness in Nigerian politics, he had stayed clear of the political scene, but he is ready to throw himself into it to support Seyi.

He said, "If Seyi Tinubu decides to run for governorship, I'll campaign for him. Though I don't involve myself in politics, I'll do it because of him.

"Based on my calculation, Seyi Tinubu is a bridge to achieving something I believe will make Nigeria work.

"I've been studying Seyi Tinubu's pattern; he seems to have his father's political mentality."

The social commentator, however, noted that the president's son might



face challenges in his 'unconfirmed' interest in becoming governor, due to older politicians who may feel threatened.

VDM said, "The problem is these older men know that if Seyi Tinubu becomes governor, they'll be kicked out of power. They've seen the traits of his father in him, so it'll be a problem.

"So, if he decides, which I believe won't work, especially when his father is in office, it might be hard for him to become governor."

He, however, noted that the possibility of Seyi becoming governor cannot be ruled out, as he cautioned that politics is a "game of interest."

In November 2024, the Lagos State

chapter of the Peoples Democratic Party declared that citizens would resist any attempts to impose Seyi as the next governor of the state.

This statement follows recent endorsements of Seyi as a potential successor to Governor Babajide Sanwo-Olu in 2027 by some groups.

EFCC arraigns former AGF, Nwabuoku for laundering N1.96bn By Elizabeth Jenrola Oso

The Economic and Financial Crimes Commission (EFCC) has charged Anamekwe Nwabuoku, the former acting Accountant-General of the Federation (AGF), with laundering N1.96 billion.

The EFCC took Nwabuoku and Felix Nweke, who used to be a deputy director at the Ministry of Defence, to a federal high court in Abuja in July 2024.

The case took a turn in October 2024 when both men asked for a plea bargain – where they would admit guilt in exchange for a lighter sentence. They also requested more time to return the money they



allegedly took.

At Wednesday's court session, EFCC lawyer Martha Babatunde asked the court to read the revised charges to Nwabuoku. He responded by pleading not guilty to all nine charges. Judge James Omotosho decided to grant Nwabuoku bail despite objections from the prosecution. The judge set bail at N500 million and required two guarantors to match this amount.

Judge Omotosho also set several other conditions: each guarantor must own property in Abuja worth at least N250 million. They must also swear to their financial status, show their bank statements, and provide proof of paying taxes for the past three years. The court's registrar will check all these documents.

The trial will begin at the next court date.

2025 Budget: Typo error caused Lagos- Calabar highway omission – Umahi By Dave Oludare Oso

he Federal Government has addressed concerns over the exclusion of the Lagos-Calabar Highway from the 2025 budget.

The coastal road, one of the signature projects of President Bola Tinubu which has generated a lot of controversy since its commencement last year, is expected to gulp around N16 trillion.

Questions have been raised about the funding of the project which the federal government hitherto stated would be through a public-private partnership (PPP) arrangement.

In February of last year, the Federal Executive Council (FEC) approved a N1.07 trillion contract for the construction of the first phase of the project.

The Minister of Works, Engr. David Umahi disclosed that the pilot phase covers a 47.47-kilometre dual carriageway of five lanes on each side and a train track in the middle.

The minister disclosed that FEC at its October 30 meeting approved the procurement of the project under the EPC+F (Engineering, Procurement, Construction and Financing) and in favour of High Tech Construction African Limited.

Umahi said, "They already have started searching for the funding, but hitches here and there. And so, the ministry had to go back to Mr President to ask for two things, and that was on January 18. We asked, Can we fast-track this?

"Since this project was going to be procured in two phases and multiple sections, can we get the federal government to fund phase one, which is what is 47.47 kilometres running from Ahmadu Bello in Lagos down to Lekki Deep Seaport? Mr President graciously approved.

"Today, we have procured the first section, which is 47.47 kilometres, under 10 lanes and FEC graciously approved the contract for N1.067tn with no objection."

In December, last year, Umahi further

disclosed that some sections of the highway and the Sokoto-Badagry Superhighway would be commissioned by May 2025.

However, the source of funding of the project remains unclear as there was no mention of the project in the 2025 budget.

The Federal Ministry of Works has a total capital allocation of N1,065,171,466,605 in the 2025 budget proposal.

Recently, a review by BudgIT, a civic tech foundation, said the proposed 2025 budget breakdown submitted to the National Assembly for review and



approval made no provision for the Lagos-Calabar Coastal Road, a capital-intensive infrastructure project.

It explained that the omission of funding for the coastal road implies that if funding for the project materialises, it will likely necessitate reallocating funds from other critical projects, potentially hindering their implementation and impacting the budget's credibility.

The organisation further observed that the budget omitted the breakdown of some MDAs, commissions, and councils, such as the National Judicial Council (N341.63 billion), and TETFUND (N940.5 billion).

According to the group, some of the projections in the budget were unrealistic even as it faulted the failure of government to provide a breakdown of the budget of some ministries, departments and agencies.

BudgIT noted that in previous years, it identified several budgetary insertions

made by the National Assembly that deviated from the federal government's constitutional mandate and priorities while such projects were assigned to MDAs "that have neither the capacity nor the mandate to implement the inserted projects."

The group noted that in 2021, it observed that 5,601 capital projects were added to the Appropriation Bill during the review process by the National Assembly. In 2022, it increased to 6,462 projects across 37 mother ministries and 340 MDAs, while in 2024, 7,447 insertions amounting to a staggering N2.24 trillion were found in the budget.

"While the constitution grants the National Assembly the authority to appropriate funds, it often modifies the executive's proposed budget to distort its original intent and disconnect it from the nation's long-term development agenda.

"Many inserted projects usually lack proper conceptualisation, design, and cost estimation, undermining their effectiveness and feasibility. We believe that the legislature must exercise this power with the utmost responsibility. This responsibility, which cannot be overstated, entails ensuring resource efficiency, eliminating waste, and aligning budgetary decisions with the nation's long-term economic development goals,"BudgIT said.

Minister clarifies omission

However, breaking silence of the issue for the first time, Minister of Works, Engr. David Umahi during a visit to the project site of Section 1 (Abuja-Kaduna) of the Abuja-Kaduna-Zaria-Kano Road Project, said the Lagos-Calabar Coastal High was included in the 2025 budget against the reports making round.

In a viral video sighted by Intel Region on Friday, the minister said; ""The Lagos-Calabar Coast Road will be funded, it was a typographical error, they wrote Lagos – Port Harcourt Coastal Road instead of Lagos-Calabar Coastal Road in the budget."

Direct federal allocations to LGs begins January – FG By Dave Oludare Oso

he Presidency has confirmed that local government areas across Nigeria will begin receiving their allocations directly from the Federal Allocation Account Committee (FAAC) starting from the end of January.

Special Adviser to the President on Media and Public Communications, Sunday Dare confirmed the development in an interview on Arise News on Thursday night.

The spokesman said the move is a testament to President Bola Tinubu's commitment to implementing the Supreme Court's landmark judgment in July 2024.

The judgment declared state control over local government funds unconstitutional, paving the way for direct federal allocations to local governments.

The Supreme Court's ruling, delivered by Justice Emmanuel Agbim, mandated that allocations to local governments should be paid directly, rather than through state governments.



This decision followed a suit filed by the Attorney General of the Federation, Lateef Fagbemi (SAN), advocating for the financial autonomy of N i g e r i a 's 774 local government areas.

Dare said the move is expected to boost the financial autonomy of local governments, enabling them to execute projects and programs more effectively.

He said, "We have a President who ensures local government autonomy.

"I spoke to a local government chairman, who said, 'Oh, I will be getting N2.9bn instead of the N200m I was getting before'." The Presidency has also called for greater scrutiny of state and local government financial management.

Dare noted that while the Federal Government often faces criticism, attention must also shift to how states and local governments utilize their resources.

He said, "One state collected N499 billion last year—nearly four times its previous allocation—yet there's little to show for it.

"The framers of our constitution created the three tiers of government for a reason. It's time to hold states and local governments accountable."

49 MAPOLY final-year students face expulsion for forgery By Olamilekan Botti

o s h o o d A b i o l a Polytechnic (MAPOLY), Abeokuta, Ogun State is facing a major academic integrity crisis as no fewer than 49 final-year Higher National Diploma (HND) students are at risk of expulsion after a recent result verification exercise uncovered the alleged use of forged National Diploma (ND) certificates.

According to findings by NEW DAILY PRIME on Thursday, the institution revealed through an official verification update that these students submitted fraudulent ND results to gain admission into various HND programmes.

The affected students are spread across multiple departments, including Mass Communication, Pharmaceutical Technology, Marketing, Science Laboratory Technology, Computer Science, Computer Engineering, and Accountancy, among others.

Investigations showed that several of the forged certificates were purportedly obtained from reputable institutions such as The Polytechnic, Ibadan; The Federal Polytechnic, Ilaro; Adeseun Ogundoyin Polytechnic, Eruwa; and Ibarapa Polytechnic, Eruwa in Oyo State.

In a related development, MAPOLY had earlier announced an indefinite shutdown of the campus on Monday to preempt a planned protest by students over these allegations.

Addressing the situation, the institution's Public Relations Officer,



Yemi Ajibola, explained to NEW DAILY PRIME that the verification exercise was a routine procedure aimed at authenticating documents submitted by students.

He attributed the delay in releasing some results to the extensive verification process, which ultimately uncovered the fraudulent submissions.

"We have established internal systems for thoroughly verifying the results submitted by our students," Ajibola stated. "Some results remain unverified because their issuing institutions have yet to confirm them, while others have been confirmed as fake. Administrative delays caused a backlog in verification, but we are working diligently to resolve these issues."

Ajibola clarified that the accused students would not face immediate expulsion. Instead, the institution will formally invite each of them to defend the authenticity of their credentials.

"They will be given the opportunity to clarify discrepancies. If any errors are found on our part, they will be corrected. However, students who cannot validate their results will face expulsion," he warned.

Meanwhile, tensions on campus have intensified following reports of a clash between students and Ogun State's Deputy Governor, Mrs. Noimot Salako-Oyedele.

The state government claimed the deputy governor narrowly escaped an attack by protesting students, while the students alleged that her security team fired gunshots during the confrontation.

This growing controversy has placed MAPOLY under scrutiny, raising urgent concerns over academic fraud and campus security.

Rivers Crisis: PDP rejects court ruling, disavows Ologunagba's statement

The crisis within the People's Democratic Party (PDP) intensified as acting National Chairman, Umar Damagum, clarified that the National Working Committee (NWC) had not yet convened to address the court ruling concerning the Rivers State Executives.

This statement came in response to claims made by the party's National Publicity Secretary, Debo Ologunagba, which were refuted by the Deputy National Publicity Secretary, Ibrahim Abdullahi, at a press conference in Abuja on Friday.

Abdullahi expressed concern over Ologunagba's recent actions, accusing him of acting out of personal interest.

The ongoing conflict between Rivers State Governor Siminalayi Fubara and his predecessor, Nyesom Wike, over the control of the PDP structure in Rivers State has further exacerbated tensions within the party.

Despite several unsuccessful reconciliation attempts, Wike's faction won the Ward, Local Government, and State Congresses in July and August 2024, with Fubara's allies boycotting these elections due to a court order.



On January 13, 2025, the Rivers State High Court issued a restraining order that prevented the executive committees led by Aaron Chukwuemeka, aligned with Wike, from functioning.

The court also granted an injunction prohibiting these executives from holding positions in the party.

Following this, Ologunagba issued a statement on Thursday claiming that the PDP had accepted the court's verdict and recognised the faction led by Hon. Nname Robinson Ewor, aligned with Governor Fubara, as the legitimate executives of the Rivers State PDP.

However, Abdullahi vehemently denied Ologunagba's claims, stating that the NWC had not met since September of the previous year and, therefore, could not have a c c e p t e d t h e j u d g m e n t recognising Ewor's group.

He further accused Ologunagba of acting independently and without proper authority, particularly in reference to statements made about judgments in Imo and Ebonyi States.

Abdullahi stressed that the National Publicity Secretary was not authorised to speak on behalf of the NWC without prior clearance, criticising Ologunagba for undermining party protocols.

He also stated that personal sentiment appeared to be influencing Ologunagba's actions, which were having a detrimental effect on his role within the party.

Itua remarked that the ongoing governorship election tribunal has effectively become the focal point of political discourse in the State and beyond, with analysts and citizens keenly observing the developments.

"At the heart of the proceedings is Governor Monday Okpebholo of the All Progressives Congress (APC), whose victory was declared by the Independent National Electoral Commission (INEC), in the September 21 election is being challenged by the Peoples Democratic Party (PDP) candidate, Asue Akintunde Ighodalo.

"Interestingly, despite the opposition's claims, proceedings so far suggest that Governor Okpebholo's position remains unshaken. The evidence presented by the PDP revolves around alleged irregularities.

"The tribunal's scrutiny of evidence has also favoured Governor Okpebholo. A significant turning point was the forensic audit of the BVAS machines used during the election. The audit, requested by the PDP, ironically affirmed the authenticity of the results, showing that votes recorded were tallied with the electoral commission's figures. This revelation has weakened the opposition's case and reinforced the legitimacy of Okpebholo's victory.

"Another critical factor working in favour of Governor Okpebholo is the perceived overreach by the PDP's legal team. Their strategy of contesting results in all 18 local government areas has been criticized as overly ambitious and lacking in focus.

"The tribunal's insistence on concrete evidence for each claim has exposed weaknesses in the PDP arguments, further tilting the scale toward Governor Okpebholo.

Nigerian scientist raises alarm over misuse of drug among girls

n addressing the issue of contraceptive drugs among Nigerian young girls, Dr. Stella Babatope, a Nigerian scientist, said that despite having health significance on consumers, abusing it leads to health consequences.

She made this known in a press release disclosed on Thursday while emphasizing on the alarming rate of pharmaceutical drugs abuse young Nigerians.

Due to the lack of knowledge on the effect while misused, Dr. Babatope urges for educational reform to tackle this rising issue.

"Without proper education and regulation, the unregulated use of COCs can lead to severe health complications such as diabetes, obesity, insulin resistance, and increased risk of cardiovascular diseases. We must raise awareness and ensure that contraceptives are used safely and responsibly." Groundbreaking Research on Health Solutions

Beyond highlighting the dangers of contraceptive misuse, Babatope's research, titled "Ameliorating Effect of Ganoderma lucidum on Combined Oral Contraceptive-induced Cardiometabolic Syndrome in Female Guinea Pigs," explored possible remedies to mitigate the adverse effects of COCs on women's health.

As a scientist with expertise in pharmaceutical and biomedical sciences, Babatope currently serves as a Research Assistant at the University of Georgia, USA. Her work spans several critical areas, including cardiometabolic research, diabetic wound healing, and menopause.

Fans and collaborators are already mourning his loss. Social media platforms are filled with tributes celebrating his artistry and his influence. Many have quoted one of Lynch's famous sayings: "Keep your eye on the donut and not on the hole."

Though Lynch is no longer with us, his work continues to captivate and challenge. From the eerie streets of Blue Velvet to the haunting mysteries of Twin Peaks, his stories remain vivid in the minds of those who experienced them.

As the world says goodbye to this visionary artist, one thing is clear: David Lynch's unique perspective and creative brilliance will never be forgotten.

US Supreme Court upholds TikTok ban law

The US Supreme Court has upheld a law that bans TikTok nationwide unless its China-based parent company ByteDance sells the platform by this Sunday.

TikTok had challenged the law, arguing it would violate free speech protections for the app's more than 170 million users it says it has in the US.

But that argument was rejected by the nation's highest court, meaning TikTok must now find an approved buyer for the US version of the app or face being removed from app stores and web hosting services.

However, the outgoing Biden administration and incoming President Donald Trump have been trying to work out a reprieve for the platform, which US authorities have warned poses a national security risk.

Can Trump still intervene?

Trump may once have sought to ban TikTok – but is now firmly against this law.

He asked the Supreme Court to delay its implementation while he seeks a "political solution," but has been unsuccessful in this bid.

He has been bullish about finding a solution though.

On Friday, just before the court released its ruling, he said he spoke to Chinese President Xi Jinping about TikTok, as well as issues around trade.



"It is my expectation that we will solve many problems together, and starting immediately," he posted on social media.

And on Thursday Trump's incoming national security advised Mike Waltz told Fox News the president-elect was looking for ways to "preserve" TikTok, saying Americans' access to the platform and their data would be preserved.

"I don't want to get ahead of our executive orders, but we're going to create the space to put that deal in place," Mr Waltz said.

Another option would be for Trump to allow the law to stand but tell the Department of Justice not to enforce it.

The government would be effectively telling Apple and Google that they won't be punished for continuing to allow people to download TikTok onto their devices, meaning the law would remain in place but would essentially be redundant.

Obviously, the firms might be

uncomfortable about breaking the law even if they've been told it's fine – as it would be effectively requiring them to take the president's word for it that they won't face punishment.

Can people still use TikTok even if it's banned?

If Trump can't unban TikTok, then what happens?

The most likely way the US would enforce the ban is to order app stores to make it unavailable for download in that region.

If people can no longer use a legitimate means to access TikTok through digital storefronts it won't impact those who've already got it on their phones.

But because the app most likely won't be publicly available anymore, new updates will no longer be delivered to users in the US – which will make the app buggier and, eventually, unusable.

Trump inauguration moved inside the Capitol due to freezing temperatures

onday's inauguration ceremony for Presidentelect Donald Trump and Vice President-elect JD Vance will take place inside the Capitol due to dangerously low temperatures, Trump announced on social media on Friday.

"There is an Arctic blast sweeping the Country," Trump wrote on Truth Social. "I don't want to see people hurt, or injured, in any way. ... Therefore, I have ordered the Inauguration Address, in addition to prayers and other speeches, to be delivered in the United States Capitol Rotunda, as was used by Ronald Reagan in 1985, also because of very cold weather."

Temperatures are expected to be in the teens and low 20s on Monday with heavy winds. Weather forecasters are also predicting snow the day before.

The Rotunda is under the Capitol dome and is typically used for congressional ceremonies and celebrations.

Trump said Capital One arena in downtown D.C. would be open for supporters to watch the ceremony live, and he will join the crowd after he is sworn in.

The arena will also host the presidential parade. The space can fit about 20,000 people, a fraction of those who are expected to visit Washington for the inauguration.

Dignitaries and other VIP guests will be brought into the Rotunda, Trump said, but space will be extremely limited.

"This will be a very beautiful experience for all, and especially for



the large TV audience!" Trump wrote in his post.

The Joint Congressional Committee on Inaugural Ceremonies, which is responsible for planning the event, said in a statement that "the vast majority of ticketed guests will not be able to attend the ceremonies in person."

"At this time we know that those with tickets for the Presidential Platform and members of Congress will be able to attend in person," the statement said.

"While we know this is difficult for many attendees, we strongly suggest people who are in Washington for the event attend other indoor events at indoor venues of their choice to watch the inauguration."

A senior inaugural official in Washington previously told CBS News that moving the ceremony indoors was "the president-elect's call."

Two law enforcement sources told CBS News earlier that a "Rotunda plan" for the swearing-in was "under consideration" and had been a contingency for months. CNN first reported that the inauguration would be moved indoors.

When Reagan took the oath of office in the Capitol Rotunda in 1985, it was 7 degrees outside, according to the National Weather Service, with wind chills making it feel far colder than 0 degrees.

Those conditions forced organizers to move the ceremony indoors. The Capitol Rotunda was packed, according to images from that day, with standing-room-only available for VIPs.

Reagan was actually sworn in one day before the Jan. 21 inaugural festivities, on Jan. 20, since Jan. 20 fell on a Sunday. Chief Justice Warren Burger administered the oath of office to Reagan on both days.

"There are no words adequate to express my thanks for the great honor that you have bestowed on me," Reagan said in his second inaugural address. "I will do my utmost to be deserving of your trust."

Biden sets record, pardons 2,500 non-violent drug offenders

President Joe Biden on Friday announced he would commute the sentences of nearly 2,500 people convicted of non-violent drug offences as one of his last major moves just days before leaving office.

Biden said the individuals receiving commutations are "serving disproportionately long sentences compared to the sentences they would receive today under current law, policy, and practice" in a Friday statement.

"Today's clemency action provides relief for individuals who received lengthy sentences based on discredited distinctions between crack and powder cocaine, as well as outdated sentencing enhancements for drug crimes," Biden said.

The move makes him the president who has issued more pardons and commutations than any other U.S. president, Biden said.

The president noted that Congress in recent years has passed the Fair Sentencing Act in 2010, which ended the five-year mandatory minimum sentencing for possessing crack cocaine, and the First Step Act in 2018, which aimed to decrease the federal prison population. "As Congress recognized through the Fair Sentencing Act and the First Step Act, it is time that we equalize these sentencing disparities,"

Biden said. "This action is an important step toward righting historic wrongs, correcting sentencing disparities, and providing deserving individuals the opportunity to return to their families and communities after spending far too much time behind bars."

He said he is proud of his record on clemency and will "continue to review additional commutations and pardons" before he leaves office on Monday.

Israeli minister threatens to collapse Netanyahu govt if truce succeeds

etanyahu needs the support of both parties to keep his coalition from collapsing and costing him his position as prime minister.

Israeli National Security Minister, Itamar Ben-Gvir said Friday that his party would resign and collapse Prime Minister Benjamin Netanyahu's hold on power if the current cease-fire and hostage deal goes through.

Gvir, a member of the far-right Otzma Yehudit (Jewish Power) party slammed the peace deal as unacceptable as he called on other members of Israel's government to join his protest.

"This deal teaches them (Hamas) that they can take hostages and attack, and at the end of the day, they can get what they want," Gvir said at a news conference, according to a CNN translation.

Gvir has previously boasted about derailing previous cease-fire deals, demanding the Jewish state stick to negotiating the release of every hostage at once and continuing the war effort afterwards.

Gvir, who has also called for Israel to annex sections of the Gaza Strip, called on fellow right-wing Finance Minister Bezalel Smotrich, the head of the Religious Zionism Party who has expressed his own disdain in the deal, to join him in threatening his resignation.

Smotrich posted on X late Wednesday that he was demanding "absolute certainty" that Israel can resume the war later, calling the current deal "bad and dangerous" for Israel.

While Smortrich has yet to signal that he would join the protest, one of Netanyahu's own ministers in the Likud Party, Amichai Chikli, also threatened his resignation on Thursday over the deal.

Chikli, who oversees the Ministry of Diaspora and Combating Antisemitism, said he could not support a deal that would include Israel's withdrawal from the Philadelphi corridor, along the Egypt-Gaza border.

"I hereby undertake that if, God forbid, there is a withdrawal from the Philadelphia Axis (before the war goals are achieved), or if we do not return to fighting in order to complete the war goals - I will resign from my position as a government minister," Chikli wrote on X.

Following the ministers' threats, the ruling Likud party warned that those who try to derail the cease-fire deal would live on in infamy.

"Anyone who dissolves the rightwing government will be remembered as a world scoundrel," the party said in a joint statement.

Despite the blow from his allies, Netanyahu will still have the votes he needs to keep the government going after Opposition Leader, Yair Lapid announced he would support the embattled prime minister through the negotiations.

"I say to Benjamin Netanyahu, don't be afraid or intimidated, you will get every safety net you need to make the hostage deal," Lapid said in a statement. "This is more important than any disagreement we've ever had."

While the deal would still remain intact to begin on Sunday to begin the truce and release of 33 hostages, it would effectively mark the end of Netanyahu's majority in government and allow Lapid to issue new elections whenever he chooses.

WHO warns of Marburg virus outbreak in Tanzania, eight dead By Friday Omosola

he World Health Organization (WHO) has issued a warning over a possible outbreak of the deadly Marburg virus in north-western Tanzania, where at least eight people have died.

WHO said over the last five days, nine suspected cases of Marburg virus were identified in the Kagera region.

WHO chief Tedros Adhanom Ghebreyesus on Tuesday via X stated, "We expect more cases in the coming days as disease surveillance improves.

"Marburg virus disease is an infectious, severe, and often fatal disease caused by a filovirus."

Among affected patients are the healthcare workers who are closely monitored.



Rapid response teams have been deployed in north-western Tanzania to trace suspected Marburg virus cases and contain the outbreak, as concerns grow over its potential spread.

The World Health Organization (WHO) has warned that the risk of regional transmission remains "high" due to Kagera's role as a key transit hub with frequent cross-border movement to the Democratic Republic of the Congo, Uganda, Burundi, and Rwanda.

Despite the outbreak, WHO chief Dr. Tedros clarified that no travel or trade restrictions with Tanzania are currently recommended.

On a global scale, the risk remains "low," with no evidence of international spread.

This comes after Rwanda, Tanzania's neighbour, declared its own Marburg outbreak over in December 2024, following 66 infections and 15 deaths.

According to WHO data, the Marburg virus has an average fatality rate of 50%. It originates from fruit bats and spreads to humans through direct contact, with further transmission occurring via bodily fluids of infected individuals.

Corruption: Imprisoned former Prime Minister, Khan, bags 14 years jail term By Michael Damilola

Iready-imprisoned former Pakistan Prime Minister Imran Khan has been sentenced to 14 years in jail by a Pakistani court after finding him guilty of corruption.

The case centres on the misuse of authority and corruption involving Khan's Al-Qadir University project trust.

He had faced charges of bribery involving land in return for a $\pounds 190$ million money laundering favour to Malik Riaz, a real estate tycoon, marking the fourth major case the former PM has been convicted for.



In January 2023, three previous convictions bothered on selling state gifts, leaking state secrets, and unlawful marriage, among other pending cases.

Khan's wife, Bushra Bibi, was also sentenced to seven years jail by the court as an alleged accomplice.

While the former PM was fined 1 million Pakistani rupees (\$3,500) aside from jail term bagged, his wife was fined half 500 Pakistani rupees.

The Pakistan PM between 2018 and 2022 is also banned from politics for five years.

What you need to know about Donald Trump's inauguration **By Friday Omosola**

t is no longer news that the U.S. President-elect, Donald Trump, will be inaugurated on Monday, January 20, as the 47th president of the country.

Trump will assume office in the White House following the expiration of the tenure of the incumbent President Joe Biden and Vice President Kamala Harris, who lost to Trump in the election.

As the inauguration approaches with every passing second, minute, hour, and day, there remains limited information about the swearing-in, particularly among individuals outside the U.S.

Vice President-elect J.D. Vance will be sworn in before Trump.

Trump's wife, Melania will hold the Bible during the oath, as she did eight years ago.

The ceremony will mark only the second time an inauguration falls on Martin Luther King Jr. Day (celebrated on the third Monday of January each year).

The weather forecast predicts a sunny but windy day with highs in the mid-20s.

Trump's inaugural address is expected to follow the tradition of past speeches, with his previous one in 2017 lasting 17 minutes.

Trump will recite the following: "I do solemnly swear (or affirm) that I will faithfully execute the office of president of the United States, and will, to the best of my ability, preserve, protect and defend the Constitution of the United States."

Trump will hold up his right hand and place his left on a Bible

More than 220,000 tickets will be sold for the inauguration ceremony.

The presidential oath of office is written into the U.S. Constitution.

Trump will be only the fortieth person to give an inaugural address.

Trump may or may not wear a top hat to the inauguration as John F. Kennedy was the last president to wear it.

The inauguration ceremony was moved from March to January 20.

Thirty-seven inaugurations have been held in March.

George Washington was the only elected president not to be inaugurated in either January or March.

Haaland signs new Man City deal until 2034 By Dave Oludare Oso

anchester City striker, Erling Haaland has signed a new long-term deal with the club that will keep him at the Etihad until 2034.

The Norwegian joined City from Dortmund in 2022 and has scored 111 goals in 126 games for the club since.

The striker's previous deal, which reportedly included a release clause, had been due to expire in 2027.

Haaland's new deal would see the striker remain with City until his 34th birthday should he stay at the club until its expiry in nine-and-a-half years' time.

The length of Haaland's deal is the longest in the Premier League, eclipsing the nine-year deal Cole Palmer signed with Chelsea last August.

"I am really happy to have signed my new contract and to be able to look forward to spending even more time at this great club," said Haaland.

"Manchester City is a special club, full of fantastic people with amazing supporters and it's the type of environment that helps bring the best out of everybody.

"I also want to thank (manager) Pep [Guardiola], his coaching staff, my team-mates and everyone at the club as they have all helped me so much in the past couple of years."

Txiki Begiristain, City's director of football, said: "The fact he (Haaland) is signed for so long demonstrates our commitment to him as a player and his



love for the club."

Haaland's contract renewal comes two months after Pep Guardiola's decision to sign a new two-year deal of his own.

Since moving to the club from Germany, the Norway forward has won two Premier League titles, the FA Cup, the Champions League and the Super Cup.

The defending champions are 12 points behind leaders Liverpool in the Premier League table, having played an extra game than the Reds.

The striker's renewal comes as City await the outcome of their disciplinary case against the Premier League.

The club, which could face a huge sanction if found guilty, have denied the 115 charges levelled against them.

'Smart business from City'

Haaland's new deal at City is an "expensive" but "smart" decision from the club, according to football-finance expert, Kieran Maguire.

Liverpool trio Trent Alexander-Arnold, Virgil van Dijk and Mohamed Salah are all out of contract at the end of the season and could leave the club for free.

"He (Haaland) is half way through his original five-year contract and once you get into that last two years the balance of power starts to shift towards the player more than the club, as City would have observed at Liverpool," Maguire told BBC Sport.

"What they (City) have here is a longterm commitment which protects Haaland's value in the market.

"I think it's a smart business decision from City. It's an expensive decision but it's one they could afford."

Real reason I chose Barca over Real Madrid – Neymar Jnr

Football icon, and Brazil's highest goal scorer, Neymar Jnr has disclosed that his decision to join Barcelona instead of Real Madrid was guided by his heart rather than logic.

In an exclusive interview with another Brazilian football legend, Romário, published on Friday, Neymar opened up about the pivotal days leading to his career-defining move. He expressed his deep affection for Barcelona and the emotional connection that ultimately influenced his choice.

"I don't regret my choice to pick Barcelona over Real Madrid. I went with my heart there," Neymar said.

The forward explained that he had been a long-time admirer of the Catalan club, dating back to Ronaldinho's era.

"Barça was the team I loved. I always watched, and I always said: I want to play there. It happened."

According to him, the transfer saga was anything but straightforward, with both clubs vying for Neymar's signature.

"Those were intense days. It was two or three days where I wasn't even training, just going from my house to the office to resolve this," Neymar revealed.

He recounted being torn between the two Spanish giants, with representatives from both clubs persistently contacting him.

"Real Madrid's people were calling



me from one side, and Barcelona's people were calling me from the other. Both presidents were talking to me. I couldn't rationalise. I imagined myself playing for both."

In the end, Neymar said his heart "spoke louder," leading him to choose Barcelona over Real Madrid.

Neymar further revealed that a significant influence on his decision was the opportunity to play alongside Lionel Messi, who he had admired for years.

"I obviously wanted to play with Messi!" Neymar said.

The camaraderie between the two stars proved instrumental in shaping Neymar's time at Barcelona.

However, according to him, his initial months at the club were anything but easy. Neymar struggled to adapt, often doubting himself.

"I spent the first six months at Barça with butterflies in my stomach. I was like..., I can't dribble anyone, I can't get by anyone, I'm doing everything all wrong."

Neymar recounted one low point that came during a match against Athletic Bilbao, where he broke down in tears at halftime.

"I went into the washroom crying by myself, thinking, 'What am I doing?" Then Messi knocked on the door," he recalled.

Messi, along with Dani Alves, reassured Neymar and encouraged him to play without pressure.

He noted that their support helped Neymar regain his confidence and become one of the world's top players during his time at Barcelona.

Looking back, Neymar said he has no regrets about his career choices.

"All of the mistakes I had in my career, in my life choices were to help me grow, help me mature. So I don't regret anything," he told Romário.
