ASUU warns of potential confrontation with FG in 2025 over unresolved issues in education sector <u>By Gbenga Oluranti Olaleye</u>

The Academic Staff Union of Universities (ASUU) has issued a stern warning that 2025 could witness a prolonged confrontation between the union and the Federal Government unless concrete actions are taken to address longstanding issues in the university system.



The union, led by Prof. Ayo Akinwole of the Ibadan chapter, criticised the federal government's efforts in 2024 as insufficient, claiming that no significant changes were made in the university sector.

In a statement on Wednesday, January 1, ASUU lambasted the government for neglecting the education system and failing to address critical issues outlined in past agreements.

These include the non-release of withheld salaries, failure to fund the revitalisation of public universities, and the continued proliferation of public universities without proper funding or infrastructure support.

Akinwole further criticized the government for policy inconsistencies, particularly concerning the 18-year benchmark for tertiary education admission and the ongoing lack of implementation of the Integrated Payroll and Personnel Information System (IPPIS) in favor of the proposed UTAS (University Transparency and Accountability Solution).



One of the union's significant concerns is the government's proposal to replace the education tax with a "development levy," which would severely impact the Tertiary Education Trust Fund (TETFund).

This funding body, established in 2011, has been crucial for the infrastructure development of public universities, but ASUU fears that the new levy system will undermine its role, with TETFund's share dwindling over time, eventually ceasing by 2030.

The union described this move as an attempt to "commodify" university education in Nigeria and undermine public institutions' ability to develop.

ASUU also rejected the 2025 budget allocation to education, which is roughly 7% of the total budget, well below the international benchmark of 15%-20% for developing countries as recommended by UNESCO and the United Nations.

The union stressed that this underfunding, alongside unresolved issues like unpaid allowances and overdue salary payments, could lead to further disruption in the academic calendar and a renewed struggle for the improvement of the university system.

The statement concludes with a call to ASUU members to remain vigilant and prepared for potential unrest, urging the government to prioritize the sector and fulfill its promises to safeguard the future of Nigerian students and academic staff.

If the government fails to meet ASUU's expectations in 2025, the union predicts that another round of crisis and disruption in the university system is inevitable.

We'll take Nigeria to promise land, Tinubu assures By Friday Omosola

President Bola Tinubu has reiterated his administration's commitment to transforming Nigeria, pledging to lead the nation to the "Promised Land" through bold reforms and collaborative governance.

He expressed his gratitude for the unwavering support of the National Assembly, which he said has been pivotal to the administration's progress over the past 19 months.

The President made these remarks yesterday while receiving Vice President Kashim Shettima, Senate President Godswill Akpabio, Speaker of the House of Representatives Tajudeen Abbas, and former principal officers of the National Assembly at his Lagos residence.

How over \$2bn was squandered on non-functional refineries – Obasanjo

Former President Olusegun Obasanjo has disclosed that subsequent administrations squandered over \$2 billion on Nigeria's refineries, yet none of them became operational.

In an interview with Channels Television, Obasanjo revealed that during his tenure, he sought to make the refineries functional by involving Shell, but the company declined.

According to him, Shell Petroleum Development Company of Nigeria Limited (SPDC), a pioneer in the country's petroleum industry, outlined four reasons why the refineries could not be made operational, with corruption being a significant factor.

This revelation comes shortly after President Bola Tinubu's administration announced that the Port Harcourt and Warri refineries have resumed operations.

He said, "I said, when I was president, I wanted to do something about the three refineries we have. Port Harcourt, Warri, and Kaduna. After I asked Shell to come and run it for us, Shell said they wouldn't. I said, please, come and take equity. They said, no, all right, don't take equity, come and run it. They said, no.

"Later on, I called them. I called the boss of Shell then. Come and tell me what is it. And he gave me four or five reasons. He said, well, first of all, we make a major profit from upstream, not from downstream. Downstream, we run just to keep our heads above water.

"Two, our refineries are too small. 60,000 barrels, 100,000 barrels, and I



think 120,000 barrels. He said, at that time, the average refinery was going for 250,000 barrels. Three, he said, our refineries are not well maintained. Four, he said, there was too much corruption around the activities of our refinery, and they would not want to get involved in that."

The Ogun-born politician further recounted that in 2007, the Nigerian National Petroleum Corporation (NNPC) rejected a \$750 million offer from billionaire business tycoon Aliko Dangote to manage the Port Harcourt and Kaduna refineries.

"And when anybody tells you a thing like that, what will you do? And it was after that, Aliko Dangote got a team together, and they paid \$750 million to take part in PPP, running the refinery. My successor refunded their money, and I went to my successor. I said, do you know? I told him what I transferred. He said NNPC said they wanted the refinery, and they could run it", Obasanjo added.

He stated that the NNPC, now rebranded as the Nigerian National Petroleum Company Limited (NNPCL), was aware of its inability to manage the national refineries but still refused Dangote's offer.

The former President noted, "And I said, but you know they cannot run it. As I was told not too long ago, since that time, more than \$2 billion have been squandered on the refineries, and they still will not work. Anybody can tell you.

"If a company like Shell tells me what they told me, I will believe them. If anybody tells you now that it is working, well, are they now with Aliko? And Aliko will make its refinery work. Not only will it make it work, it will make it deliver.

"Announce whether our government refinery is working or not. Look, it is like they say in Yoruba, the man who plants 100 heaps of yam, and says he has planted 200 heaps, they say after he has harvested 100 heaps of yam, he will also harvest 100 heaps of lie. You know what that means?"

Obasanjo served as Nigeria's democratically elected President from May 1999 to May 2007.

He also held the position of Nigeria's military Head of State from February 1976 to October 1979.



TUC criticises Tinubu's optimism in New Year address, questions president's policies

Festus Osifo, President of the Trade Union Congress (TUC), has expressed concern that the optimism conveyed in President Bola Tinubu's New Year speech does not align with the current state of Nigeria's economy.

Appearing on Channels Television's Politics Today programme on Wednesday, January 1, evening, Osifo was critical of the President's optimistic outlook, particularly the promises made to combat inflation, stabilise the naira, and foster economic growth.

In his address, President Tinubu outlined ambitious plans for the nation's economic recovery, including strategies to boost local food production, increase the manufacturing of essential medicines, and improve access to credit through the establishment of the National Credit Guarantee Company.

However, Osifo argued that while the President's speech may be intended to inspire hope, it fails to reflect the harsh realities of the nation's economic challenges.

He stated, "The president of a country is the chief salesman of a country, his own primary responsibility is to lay out the message that he has laid out. To paint a very bright picture, to paint a picture of a lot of goodies that could come in 2025. So he has done what any president in the world could do."



Despite acknowledging the President's intention to inspire hope, Osifo suggested that the message of optimism clashes with the struggles Nigerians currently face.

He continued, "So in reality, what the president has said is trying to inspire hope, but that hope that he's trying to inspire, is not really in tandem with what we have currently in our economy."

The TUC President also pointed out that both economic analysts and financial experts have identified the administration's policies as key contributors to the nation's economic difficulties.

According to Osifo, these policies have significantly worsened the situation, citing the depreciation of the naira and rising inflation as direct results of the current government's actions. He added, "Nigerians know clearly that a lot of these policies have brought about challenges, and have brought about difficulties that we are facing today. Today our exchange rate is about 1,600, depending on the parallel market or The Nigerian Autonomous Foreign Exchange Fixing. It is also these policies that have also brought about the inflation that we have today."

Osifo also criticised the optimistic projections outlined by the President, such as the expected reduction in inflation to 15% by 2025 and a rise in crude oil production to 2.06 million barrels per day.

He questioned the feasibility of these targets, stating, "When you now analyse them, what are the parameters that have been put in place? What are those details that have been put in place that we can see that truly it is not just talkism, that truly what the president is saying, there are actions to match them?"

2027: Obi denies merger talks with PDP, others

head of the 2027 polls, the former g o v e r n o r o f Anambra State, Peter Obi, has clarified that no merger agreement has been reached with the Peoples Democratic Party (PDP), the New Nigeria People's Party (NNPP), or any other political group.

Speaking at a press conference in Abuja today, the 2023 presidential candidate of the Labour Party (LP) addressed national issues while urging all patriotic Nigerians in the political space to unite against the All Progressives Congress (APC) in the next election.

He accused the APC of mismanaging Nigeria's resources and called for collective action to bring about a change in leadership.

Obi expressed concern over the worsening security situation, citing widespread deaths caused by banditry, terrorism, and kidnapping. He described the current level of corruption as alarming and criticized the high cost of governance, which, according to him, has driven Nigeria's public debt to unprecedented l e v e l s u n d e r t h e administration of President Bola Tinubu.

He also condemned the frequent foreign travels by government officials in 2024, which he said amounted to reckless misuse of public funds.

Reflecting on the 2023 presidential election, Obi noted that Tinubu emerged victorious in 12 of Nigeria's 36 states, securing 8,794,726 votes—nearly two million more than his closest rival, Atiku Abubakar of the PDP, who garnered 6,984,520 votes.

Obi himself, a first-time presidential contender, made history with 6,101,533 votes, while Rabiu Kwankwaso of the NNPP placed fourth, winning in Kano State with 1,496,687 votes.

Interestingly, both Obi and Kwankwaso were PDP members before the 2023 elections but left the party, citing irreconcilable differences.

"Together, we are setting the pace for a prosperous year ahead, focusing on education, healthcare, agriculture, and infrastructure. Let me, on this note, thank everyone and once again wish you a happy and prosperous New Year ahead as we continue the journey of making Rivers State great again."

Governor Fubara, in 2024, presented the budget to the three-member Rivers Assembly led by Victor Oko-Jumbo.

The governor's signing of the 2025 budget mirrored the events of the previous year, where he presented the N800 billion 2024 budget to a fourmember assembly and assented to it within 24 hours.

Kano gov opposes Tinubu's tax reforms, calls them "Inimical to Unity" By Gbenga Oluranti Olaleye

Abia gov pledges focus on education, health, others in 2025 By Friday Omosola

bia State Governor, Alex Otti, has assured citizens that his administration will prioritise education, health, agriculture, and other critical sectors to advance the state's development in 2025.

In a statement shared on his X page today, Otti emphasised that 2025 holds significant promise for the state, urging citizens to prepare for robust government interventions in education and health.

He explained that in 2024, his administration allocated 35 per cent of the state's budget to these sectors, demonstrating his commitment to their transformation.

The governor also revealed plans to hold the ground-breaking ceremony for the Abia Medical City Project in the coming weeks.

He described the project as a gamechanger for the healthcare ecosystem, aimed at reducing medical tourism, enhancing healthcare delivery, and attracting top medical professionals to the state.

Furthermore, Otti announced that the ongoing renovation of 200 primary healthcare centres will be completed by the first quarter of 2025.

2024: Nigeria's year of economic uncertainties, woes By Emmanuel Nwagboniwe

o a large extent, the year 2024 was one of visible economic hardship in Nigeria.

Undoubtedly too, the same year, majority of Nigerians witnessed as their living standards plummeted to ignoble and pitiable levels.

It was truly a year of visible economic deprivation and hunger, occasioned by the two major policies of the President Bola Ahmed Tinubu-led administration: Removal of oil subsidy and the unification of the foreign exchange market.

The two policies also triggered remarkable negative multiplier effects on the nation's economy in terms of depreciating value of the Naira, price hike, inflation, low productivity, unemployment, poor power supply/ high electricity tariff ,high cost of living, among others.

Also, the issue of insecurity across the country, especially in the Northern parts of Nigeria, took the shine off 2024.

It need be affirmed that, barely a month after President Ahmed Bola Tinubu was sworn in on May 29,2023, Nigeria's inflation rate rose sharply from 22.41% to 31.70% by February 2024, marking the highest rise ever experienced in nine months since 1999.

More worrisome, as at November 2024, the same inflation peaked to 34.6%, with food inflation alone hitting 39.93%, worsening the cost-of-living crisis in the country.

This unbearable situation made living costs high and led to ceaseless upward price review of goods and services across all sectors of the economy.

Even the Central Bank of Nigeria (CBN) did not help matters, as it raised interest rate about six times in 2024,all in a bid to stabilise the economy in the face of naira devaluation and rising fuel costs.

With increased CBN interest rates, the cost of doing business and production



skyrocketed .Many businesses had to source for funds under high interest rates by banks and other lending organisations.

Power Supply

Last year, low and inadequate electricity generation and distribution led to high cost of production, as factories and companies generated their own electricity, leading to high costs of goods and services.

Nigeria's power supply in the last quarters of 2024 from its 23 power generating plants connected to national grid ,with their total capacity of 11,165.4MWs hovered around 4,433.71 and 4,194.20MWs

Fuel pricing

Again, the issue of fuel pricing in the country has remained a major problem even with the emergence of Dangote Refinery. In May 2023, petrol prices rose; initially priced at N195 per litre, prices rose to N540 in June and N617 in July. By September 2023, prices changed between N626.21 and N671.86 by December. In May 2024, petrol prices soared between N1,200 to N1,500 on the black market.

As of late December 2024, the Dangote Refinery reduced its petrol price to \aleph 899.50 per litre, leading to competitive pricing among marketers. However, there are fears that the December 2024 fuel price slash may be short-lived considering the ongoing hard economic situations

Even ,many Nigerians are not deceived by the recent disclosure that the Port-Harcourt and Warri refineries are back on stream.

Likewise, many stakeholders in the oil and gas sector still believe that the revival of these hitherto moribund refineries may not translate into increased fuel production given the often exaggerated production capacities of those facilities.

Therefore, the bottom line is that as long as Nigeria can't produce enough fuel for local consumption, the price of the product will continue to go higher.

Security challenges

Insecurity remains rampant with multiple incidents reported; including kidnappings and attacks by insurgents. The World Food Programme also reports that conflict has displaced many people, escalating food insecurity and malnutrition.

The hunger situation led to nationwide protests from August 1-10, 2024

The widespread protests were against rising living costs and government corruption, organised under the #EndBadGovernance banner. Demonstrations occurred in major cities including Abuja, Lagos, Kano, Benin City, Gombe, and Jos.

Various pro-democracy groups championed the protests. The protests voiced frustrations over issues such as insecurity, food shortages, and poor governance while demanding the reinstatement of fuel subsidies and wider reforms.

Apparently in its bid to rijig, the Federal Government in the last two months initiated

Tax Reform Bill which has become thorny and controversial issue in the polity.

Nigerians Speak

According to Dayo Olusanya, a building materials dealer in Ogunpa market in Ibadan, he had one goal—to give his children a better life than he had. Olusanya, in his early 40s, wakes up every morning with a dream that seems farther from reality with each passing day. He continues:"For years, 1 poured my energy into building this business, hoping a better life would come.

But in 2024, that dream began to crumble under the weight of skyrocketing fuel prices and restrictive government policies.

"I wanted to give my kids a better life," he said with a weary voice. "But now, I'm just trying to survive each day: when we heard at the beginning of this year that fuel prices increased, this year's challenge is higher than I have ever witnessed.

"This was not how the shop was some years back, it's big, well stocked with goodies, but blame fuel prices because I buy goods from Lagos, and transportation costs have increased daily. I had no choice but to raise the prices of my goods, but customers complained."

Despite Olusanya's rough 2024, he expressed optimism that 2025 will get better.

He echoes: "I hope fuel prices will be reduced and reforms are implemented, because a bunch of keys that cost N4,500–N5,000 before now costs N10,000 or more."

Like Olusanya, many small business owners are struggling to survive in an economy that seems to be failing them. As they plead for government intervention in 2025, hope for a brighter future dwindles.

Mudinat Akintunde, an electronics seller since 1999, shares her story. "pray we don't experience such hardship again," she lamented, describing how the prices of items like extension boxes and fans have doubled or even tripled."

In the same vein, Aderemi Joshua, a bed seller, lamented the rising costs of factory goods. "A bed that used to cost N14,000now costs N20,000," he said, highlighting the significant price increase. "Taxes, fuel prices, and customs fees have severely impacted my business."

He also recalled the more prosperous times under President Goodluck Jonathan -led administration, stating, "during that era, I consistently turned a profit. Now, customers struggle to afford even essential items."

Joshua Gabriel, a meat seller in Port Harcourt, and father of four, described 2024 as a year of survival. "If not for God, my business would have collapsed," he said,

He adds:"The price of a healthy cow has nearly doubled from N700,000 in January 2024 to over N1.2 million or N1.3 million, recalling the loss he has incurred in his business as a butcher.

Struggling to cover cooling room fees, he avoids customers who delay payments, describing them as "business killers."

"Just imagine sending 20kg of cow meat to a cool room, it is a very big problem for me. The cool room charges N300 for 1kg, how will I be able to pay? Because I will be running at a lost."

Amarachi Clement, a trader who lives in a Port- Harcourt suburb, sells chemical soap, spoke about the implication of the unstable dollar exchange rate to her business. "Chemicals sold for as low as N1,500 last year now sell for N3,000 or more," she revealed.

To retain her customers, she adds bonuses like extra fragrance but admits the burden of high vendor prices causes mental stress. Which way forward for Nigeria in 2025?

As Nigerians step into 2025, the tax reform bill will dominate debates and discourses in both the corporate and private circles.

Many argue that the tax reform bill is ill timed given the fact that agricultural and industrial reforms ought to be front burner.

According to a report by Prime Business Africa:"The proposed tax reforms aim to overhaul the existing tax system by doing away with outdated laws and introducing new measures to boost revenue collection. Key features include a gradual increase in Value Added Tax (VAT) rates and a reduction in corporate income tax for medium and large companies."

Meanwhile, the Northern Governors forum, the Nigeria Labour Congress (NLC) and other corporate bodies have unequivocally rejected the bill.

However, many other notable professional bodies like NBA, corporate organisations and scholars have urged caution and dialogue over the passing of the bill into law.

However, Federal Government officials, including ministers, the ruling APC bigwigs, have been canvassing support for the tax reforms bill, echoing that it remains the magic wand taxation policy that will Nigeria to its enviable financial independence.

However, while tax reform is essential for improving fiscal stability, does it address the pressing needs of the agricultural and industrial sectors, crucial for economic growth and job creation?

Also, Nigeria's current debt to the World Bank stands at about \$17.1 billion, having risen from \$16.5 billion in June 2024; a rise reflecting a \$600 million increase over three months.

I had a great time with Lagos State last night, but please, don't jump on my stage like that. I have PTSD, and I love you all. Happy New Year."

Terrorist attack on New Orleans' bourbon street leaves 15 dead, dozens injured

horrific terrorist attack occurred on New Orleans' iconic Bourbon Street in the early hours of New Year's Day, resulting in the deaths of at least 15 people and injuring dozens more. The attacker, identified as Shamsud-Din Jabbar, intentionally drove a rented electric Ford pickup truck into a crowd of revelers, avoiding police barricades and opening fire on officers before being fatally shot.

The Federal Bureau of Investigation (FBI) has confirmed that the attack is being investigated as an act of terrorism, with a black ISIS flag found flying from the truck's rear bumper. According to FBI special agent Alethea Duncan, investigators believe Jabbar may have had help carrying out the attack and are looking into potential affiliations with terrorist associations.

As the investigation continues, authorities have been searching for clues at an Airbnb in the St. Roch area of New Orleans, where Jabbar was staying while in the city. The building caught fire on Wednesday, and the investigation into that fire is ongoing. Investigators from the FBI, Homeland Security, and bomb squad have all been on the scene.

Duncan has asked that anyone with information about Jabbar contact the FBI. A U.S. official has confirmed that Jabbar had previously served in the U.S. military.

The attack occurred at approximately 3:15 a.m. local time, with witnesses



describing the scene as chaotic and horrific. Two police officers were injured during the exchange of gunfire with Jabbar, but are reported to be in stable condition.

In addition to the fatalities and injuries, law enforcement officials discovered multiple improvised explosive devices (IEDs) in the vehicle and nearby areas. One IED was detonated by law enforcement, while others were safely disposed of.

President Biden addressed the nation, stating that his "heart goes out to the victims and their families who were simply trying to celebrate the holiday".

The attack impacted the city's tourism industry, which had not yet fully recovered from the COVID-19 pandemic. Many hotels in the area were evacuated, and hospitality and service workers reporting for work later that morning were turned away from the area. The 2025 Sugar Bowl, which was scheduled to take place at the Caesars Superdome later that day, was postponed to the following day due to ongoing security sweeps.

The FBI is leading the investigation and has opened a tip line.

The Bureau of Alcohol, Tobacco, Firearms and Explosives, the Department of Homeland Security, and prosecutors for the National Security Division and the local federal prosecutor's office are assisting in the investigation.

As the investigation continues, authorities are urging anyone with information to come forward.

The city of New Orleans remains in shock, with residents and visitors alike mourning the loss of life and condemning the senseless act of terrorism.

UK Schools may close as Met Office warns of -10°C Freeze across Britain By Dr. Olaoluwa Vincent Ajayi

S chools May Close and Elderly at Risk as Met Office Warns of -10°C Temperatures Across Britain

Britain is set to endure an intense cold snap this weekend, with temperatures plunging as low as -10°C (14°F) and heavy snow forecast to blanket much of the country. Forecasters warn that the severe weather could cut off rural communities, disrupt schools, and paralyze travel infrastructure.

The Met Office has issued a 45-hour yellow weather warning, effective from midday Saturday through 9 a.m. Monday, as a powerful Arctic system moves in. The UK Health Security Agency has also activated a yellow cold health alert, citing risks to vulnerable populations, including the elderly and those with preexisting health conditions.

Temperatures are set to begin dropping sharply on Thursday, with Scotland bearing the brunt of the freeze. Parts of the Highlands could see lows of -10°C, while major cities like Glasgow, Birmingham, Manchester, and even London may record temperatures between -5°C $(23^{\circ}F)$ and $-7^{\circ}C$ $(19^{\circ}F)$. Snow is expected to arrive in northern Scotland by Thursday, accompanied by icy conditions in northern England. By Saturday, widespread snowfall is predicted, with accumulations of 5 centimeters (2 inches) across the Midlands, Wales, and northern England, and up to 30 centimeters (12 inches) in higher elevations, particularly in the Pennines.

The Met Office has cautioned that heavy snow could cause power outages, disrupt mobile networks, and isolate rural residents. Forecaster Tom Morgan explained that the evolving nature of the storm system could lead to frequent updates to weather



warnings, urging people to monitor conditions closely. "It's definitely going to start off as snow in many places," Morgan said. "But how quickly it melts into rain will vary, particularly in southern England. If you've got travel plans on Sunday or Monday, stay tuned into the forecast."

The UK Health Security Agency has echoed these concerns, warning of "significant impacts" on health and social care services. Officials predict an increase in cold-related illnesses and fatalities and are advising the public to check on vulnerable neighbors and relatives.

The country is already grappling with the aftermath of heavy rains that have battered the north of England, causing widespread flooding. Greater Manchester declared a major incident on Wednesday after roads were submerged, vehicles stranded, and hundreds of residents evacuated. Mountain rescue teams and fire services were deployed to assist local authorities. Parts of England saw nearly 100 millimeters (4 inches) of rain in 48 hours-nearly a month's worth-leading to flooding that disrupted homes, businesses, and transportation. Major airports, including Gatwick and Manchester,

experienced delays and cancellations, leaving holiday travelers stranded.

The Environment Agency issued more than 60 flood warnings and 87 alerts on Wednesday night. River levels in northern England are expected to remain dangerously high through Thursday. Ben Lukey, flood duty manager at the Environment Agency, emphasized the risks. "Environment Agency teams will be on the ground, operating flood defenses and supporting affected communities. We urge people to stay away from swollen rivers and avoid driving through floodwater, as just 30 centimeters [1 foot] offlowing water can move a car."

The severe weather has already taken a toll on New Year's festivities. Edinburgh's iconic Hogmanay street party and fireworks display were canceled due to safety concerns, with similar disruptions affecting events across the UK. As Britain braces for a weekend of bitter cold and heavy snow, officials are urging residents to prepare for potential disruptions and prioritize safety. The combination of freezing temperatures and lingering floodwaters underscores the challenges of navigating a turbulent start to the new year.

Tesla cybertruck explosion near Trump hotel kills one, injures seven in Las Vegas

Tesla Cybertruck exploded outside the Trump International Hotel in Las Vegas, killing at least one person and injuring seven others. Authorities are investigating if the blast is linked to an earlier truck attack in New Orleans that killed 15.

US President Joe Biden mentioned the ongoing investigation into any possible connections between the two incidents, though no links have been found so far.

The FBI is treating the Las Vegas explosion as an isolated event but is investigating whether it was an act of terrorism.

Las Vegas Sheriff Kevin McMahill reported that the truck had been parked outside the hotel before it exploded. Video footage from the scene showed the vehicle bursting into flames, followed by smaller explosions resembling fireworks.

It was revealed that the truck contained gasoline, camping fuel canisters, and large firework mortars in the back, which contributed to the severity of the blast.

Despite the explosion, the hotel's glass doors remained intact, largely due to the Cybertruck's design, which directed most of the blast upwards. McMahill confirmed that the explosion caused one fatality and minor injuries to seven individuals.

FBI agent Jeremy Schwartz stated that the investigation focused on confirming the identity of the person involved and determining whether the incident was connected to terrorism. Authorities have found no indication linking the attack to Islamic State, but the incident is under close scrutiny due to the involvement of Tesla, a company backed by Elon Musk, who also supports President-elect Trump.

Musk addressed the explosion, noting that it was "unrelated to the vehicle itself" and promised that Tesla's senior team was investigating the matter.

The truck had been rented through the Turo app, which was also used to rent the vehicle in the New Orleans attack. However, no criminal backgrounds were found for the renters, and authorities are continuing to probe this potential coincidence.

The incident remains under investigation as law enforcement examines all possible angles
