MIRACULOUS: Boy survives 5 nights among lions, hippos, elephants

surviving five days in a game park full of lions and elephants in Zimbabwe, a lawmaker in the east African country said on Wednesday.

Mutsa Murombedzi, a member of Zimbabwe's parliament, said in a Wednesday post on social media that Tinotenda Pudu had strayed into the Matusadona Game Park and ended up "sleeping on a rocky perch, amidst roaring lions, passing elephants... and just the unforgiving wild," before he was eventually found by rangers.

According to BBC News, Zimbabwe's National Parks & Wildlife Management Authority had confirmed the incident and said Pudu was just 7 years old.

The BBC cited the parks authority as saying the young boy had wandered about 30 miles from where he lives.

young boy was rescued after Murombedzi said Pudu survived thanks to his knowledge of the wild and survival skills, eating fruit and digging down into dry riverbeds to find water.

> She said members of the local Nyaminyami community launched their own search and beat drums daily in hopes that Pudu would find his way back home, but in the end it was rangers who spotted "fresh little human footprints" and managed to track him

> Matusadona Game Park covers about 570 square miles and is home to elephants, hippos and lions, all of which can present a threat to humans. According to the BBC, it is currently home to about 40 lions.

n a day that is supposed to be her happiest, a bride in Jigawa State enacted a horror show by allegedly poisoning the food served at the reception.

Her action, which took place in the Jahun Local Government Area, has left at least one guest dead and her would-be husband (groom) critically ill and hospitalised.

Sharing their thoughts, eyewitnesses suggested that the bride's actions might have been fueled by a longnursed bitterness and personal

Confirming the incident, the state Police Public Relations Officer, Shi'isu Adam assured that an investigation was underway.

The PPRO said, "We received a report that the bride had tainted the food served at the wedding reception, leaving the groom critically ill.

connection with the alleged food poisoning incident that occurred during a wedding ceremony in the state."

He revealed that the two suspects are the bride and another female, adding that they are in custody and being interrogated by the Criminal Investigation Department of the command.

The police spokesperson added, "We will do everything in our power to ensure that justice is served."

According to him, all the wedding attendants who consumed the poisoned food have been discharged from the hospital, except for the one person who was confirmed dead.

"The command is currently investigating the circumstances surrounding the incident, and we will provide more details as soon as

"For now, we can confirm that the "Police have arrested two suspects in incident occurred, and we are working



tirelessly to unravel the facts. We urge the public to remain calm and assured that justice will be served," he concluded.

The identities of the deceased, the groom, and other victims have not been disclosed by the authorities.

The shocking event has left the community in disbelief, as authorities try to unravel the motive behind the tragic incident.

Jealous husband stabs Bishop to death in Osun

he Police has confirmed the death of Bishop Shina Olaribigbe, the founder of Rapture Empowerment International in Osogbo, Osun State, the state capital.

The spokesperson of the Osun State Police Command, Yemisi Opalola, said Bishop Olaribigbe was stabbed while mediating in the domestic dispute between a couple.

The PPRO disclosed that the killer husband believed that the pastor was having an affair with his wife, leading to the action.

Opalola said, "The couple were not living together, though they were not legally separated.

"The pastor had been intervening in their quarrels, and on this occasion, he was at the wife's house when the estranged husband arrived.

"We were told that the husband stabbed the pastor multiple times, killing him.

There is suspicion that the husband

It was gathered that Bishop Olaribigbe was stabbed to death in the early hours of Thursday.

A source who proffered anonymity revealed that the wife was an interpreter at Olaribigbe's church located around the BCGA area in Osogbo.

He said the couple, although not officially divorced, had a history of frequent altercations that led to them living apart.

The source said the deceased cleric, who was known for intervening in their disputes, had gone to visit the wife, who had been ill for some time.

It was while the cleric was there that the husband arrived at the residence early on Thursday morning and found the clergyman in the room.

"Enraged by the situation, the husband allegedly attacked Olaribigbe.

"A heated argument ensued, and in a fit

of anger, the man took a knife and stabbed the pastor in the chest. Olaribigbe died on the spot," the source who is close to the church said. Following the stabbing incident, the couple were arrested and taken into custody at Nigeria Police, Dugbe Division, Osogbo.

Tinubu to commission key projects in Enugu tomorrow By Friday Omosola

MTN, others plan 100% tariff hike in Nigeria By Dave Oludare Oso



ubscribers of MTN and other telecommunication companies (TELCOs) will face hard times as the operators move to increase their service tariffs in the country.

This comes after the Chief Executive of MTN Nigeria, Karl Toriola, disclosed that the telecommunications firms have sent a proposal to the Nigerian Communications Commission (NCC) for a 100 percent service tariff increase.

Toriola spoke during an interview on Arise TV on Thursday, where he said the proposal aims to address rising operational costs, including inflation and increased service delivery expenses.

According to Toriola, the proposed tariff hike is necessary for the sustainability of the industry, which has been facing significant financial pressures due to rising operational costs.

The good news, however, is that the CEO said it remains uncertain whether the Nigerian Communications Commission, the telecom regulator, will approve the proposal owing to existing economic hardship in the country.

Toriola stated, "We've put forward requests of approximately 100 percent tariff increases to regulators.

"I doubt they're going to approve that quantum of increases because they are very, very sensitive to the current economic situation in the country."

Despite the challenges, Toriola expressed optimism that regulators would make the right decision, taking into account the realities of the sector. The CEO emphasised that the focus is on ensuring the long-term sustainability of the industry, rather than short-term profitability.

"I believe we're all on the same side, the policymakers, the regulators, our Chairman of ALTON, Gbenga Adebayo, and the industry. We're united because we share concerns about a few fundamental issues. First. human rights, are critical to driving any economy. Without a sustainable industry, the broader economy and the well-being of the people will be negatively impacted."

The proposal comes amid rising costs for telecom companies, driven by factors such as inflation, exchange rate fluctuations, and the increasing price of key operational inputs like diesel, power generation, and raw materials.

Toriola highlighted the pressure these rising costs have put on telecom businesses, making it difficult for many companies to maintain profitable operations.

Earlier this week, operators issued a statement warning that service disruptions are imminent unless tariffs are adjusted to account for escalating operational costs.

This comes amid heightened speculation of an imminent telecom service tariff hike in Nigeria, this

The Chairman of the Association of Licenced Telecommunications Operators of Nigeria (ALTON), Gbenga Adebayo, recently threatened a shutdown of operations without a tariff hike.

Adebayo described the telecom sector as being "under siege," citing soaring operational costs driven by inflation, volatile exchange rates, and rising energy prices.

He noted that despite these challenges, tariffs have remained unchanged, leaving operators struggling to maintain quality service and expand their networks.

Wanted female gangster trafficking girls to Dubai for prostitution nabbed By Dave Oludare Oso

wanted convicted leader of an international human trafficking network, Uadiale Christiana Jacob, aka Christy Evan Osagie, has been arrested by the Nigeria Immigration Service (NIS) at the Nnamdi Azikiwe International Airport in Abuja.

According to reports, the socialite, whose network operates across the Middle Eastern countries with an operational base in the United Arab Emirates (UAE), was arrested on December 31, 2024, on arrival from Dubai for new year celebration.

National Agency for the Prohibition of Trafficking in Persons (NAPTIP) Press Officer, Vincent Adekoye, who disclosed this in a statement on Friday, said the suspect, who is also called Christy Gold by her gang members, has been on the wanted list of NAPTIP for the past five years.

Adekoye noted that luck ran out on her on December 31, 2024, as NIS officers acting in respect of NAPTIP's request to put her on watchlist on February 22, 2023, nabbed her upon her arrival in Nigeria.

The statement reads, "Her suspected other accomplices, one Michael Nduka, Osas Wiseman, Vivian, and a certain Prophet John in Lagos along with others who are field officers who assist in the recruitment and subsequent transfer of victims to Christy Gold, are still on the run.

"It would be recalled that on the 18th March 2020, the Nigeria Immigration Service (NIS), Ikeja Airport Command shared intelligence with NAPTIP Joint Border Task Force/Benin Satellite Office (JBTF/BSO) in respect of one Uadiale Christiana Jacob, aka Christy Evan Osagie, aka Christy Gold of No 15 Osagie Street, off 2nd Power Line, Egbon Estate, Benin City, Edo State.

"Uadiale Christiana Jacob popularly known as Christy Gold is a senior member of an organized human trafficking syndicate notorious for the recruitment, trafficking and sexually exploiting of underage Nigerian girls in Dubai, United Arab Emirates.

"Following the Agency's investigation into the alleged offence to establish culpability, Christiana Uadiale Jacob was arrested by NAPTIP in Ikpoba Hill area, Benin City on the 13th of October 2020 for her involvement in the trafficking of aged Nigerian girls to Dubai, United Arab Emirates for forced prostitution.

"She was charged to the Federal High Court,

Asaba, Delta State on the 25th of November 2020, where she was granted bail.

"While on Court bail, Christiana Uadiale Jacob violated the terms of the bail and absconded to Dubai. After failing severally to appear before the Court, a Bench Warrant was therefore issued by the sitting Judge on the 3rd of November 2021 for her arrest.

"To get Christiana Uadiale Jacob to face justice for her crimes, NAPTIP sought the assistance and collaboration of the Honourable Minister of Justice and Attorney General of the Federation, National Central Bureau (NCB), INTERPOL Nigeria, National Intelligence Agency (NIA), Nigeria Immigration Service (NIS) and the United Arab Emirates Police for her arrest and extraction to Nigeria.



"Even while she tried to evade justice, NAPTIP did not relent and as a result of our diligent prosecution of the case, Christiana Uadiale Jacob was convicted for human trafficking in absentia by Honourable Justice F. A. Olubanjo of the Federal High Court, Asaba, Delta State on the 21st of March 2024 with sentencing being awaited whenever she is rearrested and brought before the Honourable Court.

"Luck however ran out on her on the 31st of December 2024, as Officers Nigeria Immigration Service acting in respect of NAPTIP's request for watchlisting dated 22nd February 2023, nabbed her on arrival to Nigeria."

atima Dzuma, a 27-year-old woman, has been arrested for the alleged murder of her 25year-old husband, Baba Aliyu, in Lafiyagi Dzwafu village, located in the Katcha Local Government Area of Niger State.

According to reports, Dzuma, who married Baba three years ago as his second wife, had not borne any children, while Baba's first wife recently gave birth and preparations were underway for the naming ceremony.

Eyewitnesses said the couple was known to have frequent disputes, and that tensions escalated the night before the incident when Baba reportedly assaulted Dzuma during an argument.

The sources said, after the altercation, Baba left the house.

Confessing to killing him, Dzuma later recounted the events leading up to the crime.

She said, "When he came back, he went to bed. I used a rope to tie his neck, and he could not struggle. I hit him with a pestle three times, twice on his head and once on his hand. I took advantage of his sleeping because his sleep is always deep.

"After I killed him, I put him inside a mat, threw him over the fence and dragged him to the bush in the backyard before coming back to wash the blood and excreta that came out of his body when I killed him."

When asked why she killed him, she said they had a misunderstanding where she told him that she did not love him anymore, and he beat her

When the family of Baba was looking for him, she claimed she had not seen him but confessed to the crime three days after she killed him.

According to her, she carried out the act without the help of anybody.

Speaking on the incident, the Niger State Police Public Relations Officer, DSP Abiodun Wasiu, said the body of Baba Aliyu was found in a bush close to the house, adding that the suspect is currently in police custody.

Abiodun said, "She confessed that she



used a pestle to hit her husband when he was asleep and she later tied the deceased with clothes and rope and rolled the corpse to a nearby bush with

"The corpse was taken to general hospital Bida for post-mortem while the suspect was taken to custody. She will soon be transferred to SCID Minna for further investigation and prosecution."

The incident highlights ongoing concerns about domestic violence and its tragic consequences.

A source said, "We received information that a body was floating and got stuck somewhere on the River Forcados in Delta State.

"Some youths were dispatched to the scene where they discovered it was that of the victim. The body was without a head and they brought it for burial. He was

contesting to be the traditional ruler.

"The deceased was a good man, who had been doing good from the beginning. I am sad and the community is in mourning over the sad incident."

Also speaking, another indigene of the community, said, "Social media had been awash with news of the incident surrounding the kidnap, beheading and



subsequent recovery of the headless corpse of our kinsman which had shaken Agbere community to its roots."

Contacted, Spokesman of the state police command, Musa Mohammed, said he was aware of the incident and that investigations were ongoing.

Catholic priest who killed boy in Imo arrested

The PPRO disclosed that a detailed investigation has been put in place to ascertain the immediate and remote factors surrounding the ugly incident.


He said, "The police investigation is expected to throw more light on the events leading up to the incident."

Obasanjo invited to tour P'Harcourt, Warri

he Nigerian National Petroleum Company Limited (NNPCL) on Thursday invited former president, Chief Olusegun Obasanjo to a tour of the Port Harcourt and Warri refineries to confirm their operational status.

This move by NNPCL is to assure the former president that the days of inefficiency were gone and that the one-time corporation is now a profit-driven company.

The company was reacting to an interview Obasanjo granted Channels Television, in which he said Shell Petroleum Development Company (SPDC) told him that the NNPCL could not run a refinery.

In the interview, the former president said SPDC was invited to buy equity in the plant but complained that corruption would never allow it to function.

Obasanjo expressed the view that NNPCL had been very deceptive about the functionality of the refineries.

The Port Harcourt Refinery started working in November, while Warri began operation last month.

Reacting to Obasanjo, NNPCL Chief Corporate Communications Officer, Mr. Olufemi Soneye, extended the company's invitation to the former president for a tour of the refineries.

He said, "We extend an open invitation to President Obasanjo for a tour of the rehabilitated refineries to witness firsthand the progress made under the new NNPC Limited.

"We invite our esteemed former president to join us in this effort as we continue to deliver energy security for our nation and provide tangible benefits to Nigerians.

"His wisdom and experience are invaluable, and we assure him that his advice will always be welcomed and appreciated."

According to Soneye, NNPCL did not merely carry out turnaround maintenance but did a complete overhaul of the refineries.

He said: "As part of this transformation, NNPC Limited has

g o n e beyond oil and gas to become an integrated e n e r g y company.

"One of our n o t a b l e achievemen ts is the

complete rehabilitation of the Port Harcourt Refining Company (PhRC) and Warri Refinery.

"This process was not merely the Turnaround Maintenance (TAM) of the past but a full-scale overhaul designed to meet world-class standards.

"Similarly, we are currently conducting the same comprehensive rehabilitation of the old Port Harcourt Refinery and Kaduna Refinery."

The spokesman said NNPCL has also moved on from being a loss-making organisation to profit -driven international energy firm.

The new NNPC Limited, Soneye said, is committed not only to enhancing the refineries but also to maintaining them to global standards.

He said: "The NNPC has undergone a transformative journey, evolving from a government corporation into a private entity—NNPC Limited.

"This transition has marked a significant shift from being a loss-making organisation to a profit-oriented global energy company.

"We deeply respect and hold President Obasanjo in the highest regard as a distinguished statesman who has contributed significantly to the progress of our nation.

"He has every right to share his perspectives on national issues, and we value his insights and counsel.

Obasanjo said his successor, the late President Umaru Musa Yar'Adua rejected a \$750 million offer from Aliko



Dangote to manage the Port Harcourt and Kaduna refineries in 2007

Speaking on the television programme, the former president said he sought external help to rehabilitate and manage the facilities but faced resistance.

"When I was president, I wanted to do something about the three refineries: Port Harcourt, Warri, and Kaduna.

"Aliko got a team together after I asked Shell to come and run it for us. And Shell said they wouldn't.

"Later on, I called them. I called the boss of Shell to come and tell me what the problem was and he gave me four or five reasons.

"He (Shell boss) said, first of all, they make a major profit from upstream, not from downstream. He said they run downstream just to keep their head above water.

"Two, our refineries were too small: 60,000 barrels, 100,000 barrels and I think 120,000 barrels. He said that at that time, the average refinery was going for 250,000 barrels.

"Three, he said our refineries were not well maintained. Four, he said there was too much corruption around the activities of our refinery and they would not want to get involved in that.

"After that, Aliko got a team together and they paid \$750 million to take part in PPP (Public Private Partnership) in running the refineries.

NELFUND disburses N23bn to students,

128 schools

he official federal government agency in charge of student loans in Nigeria, the Nigerian Education Loan Fund (NELFUND), has disbursed a total of N23 billion to several individuals and 128 tertiary institutions in Nigeria.

Speaking to senior journalists in Lagos during the week, managing director, NELFUND, Akintunde Sawyerr, disclosed that N18 billion has been channelled to the institutions while about N5 billion has been disbursed for students' upkeep.

He said, "So far, we have had 326,000 individuals apply for the loan.

"A total of about N23 billion has left our account and gone to the accounts of the institutions and the accounts of individuals."

NELFUND was set up by the federal government to ensure that students who are in school do not drop out due to lack of funds.

Students register for the loans online, and all the approval process happen online.

"NELFUND is saddled with the responsibility of providing loans to Nigerian citizens who are able to gain admission, or already have admission into tertiary institutions owned by the government, both at federal and state ownership levels.

"So, students who are Nigerian citizens, who are either already in those institutions or in future gain admission into institutions, can apply for loans. And we can provide those loans for their tuition or their institutional charges, and we are also able to provide them with stipends, or pocket money, if you like," he disclosed.

He said applications occur only once a year, noting that once accepted, NELFUND pays monthly upkeep to the students directly to their bank accounts.

"We're also saddled with the additional responsibility of vocational and skills training to Nigerians who are interested or have the capacity to go and take on By Dave Oludare Oso



education on the skills side and handcrafts. So, we can also provide loans for those sorts of candidates at government-approved institutions," he said.

On sources of funding, the NELFUND chief noted that the law stipulates that the agency will be funded by receiving 1 percent of the Federal Inland Revenue Service (FIRS)'s collections.

"So, we think that will end up being something like N19 billion or so. This agency should receive about N194 billion."

He further said that the law allows the agency to solicit for funds from other sources.

"One is to solicit for funds from other sources. So, it may be those who want to invest in education in Nigeria, not necessarily for a financial return, or those who want to donate either to the Fund across the board or for specific types of applicants.

"We also have the power to invest the funds that we have for return. So there are many opportunities for us to grow the funds and to try to make it sustainable.

"We already have certain interventions that have been made. The Economic and Financial Crimes Commission (EFCC), for example, donated N50 billion in proceeds of crime. We also have had a directive to TETFund to provide us with N141 billion, of which they've given us N71 billion.

"We've had an appropriation of N60 billion, of which we've received N10

billion, and we are expecting another N50 billion. And, then, I believe there's a bill going through the National Assembly at the moment where we'll be receiving, I think, 20 percent of TETFund's proceeds. So there are funding sources.

He noted that NELFUND will not put pressure on graduates to repay the loans unless they get jobs.

"There's no obligation on the loanees to repay the loans until two years after they have completed their NYSC. And even after two years, there's no obligation to repay the loans unless a person has a job.

"Two years after NYSC, there's a reporting requirement for us to know what the status of the individual is. If they don't get jobs for the next 10 years, which is not the plan, then they don't pay the NELFUND any money. Additionally, the obligation to repay is on the employer who is obliged by law to give us a proportion of the funds that they are paying as a salary to the employee.

"Our guidelines have determined that to be 10 percent. So, even after this two-year moratorium, it's designed to ensure that the employer, who's really benefiting from the intervention of NELFUND, is the one obliged to take 10 percent and repay the fund."

After 35 years service, retired police chief decries N1.7m gratuity By Friday Omosola

retired Deputy Superintendent of Police (DSP), Esther Marcos, has expressed frustration over the meagre monthly pension she receives from the Federal Government each month. Marcos shared her pension ordeal in a video posted today on X (formerly Twitter) by Omoyele Sowore, the 2023 presidential candidate of the African Action Congress (AAC).

In the video, the retired DSP shed light on the challenges faced by Nigerian police retirees under the controversial contributory pension scheme.

Marcos disclosed that she retired on November 1,2018, after 35 years of service, receiving a gratuity of just N1.7 million and a monthly pension of only N40,000.

She further revealed that since her retirement, she has attended numerous meetings concerning her pension, questioning the necessity of the process.

She said, "My name is Esther Marcos, a retired DSP in the Nigerian Police Force. I retired on November 1, 2018. I just want to use myself as a case

study and it applies to every other police officer under this d i r t y contributory pension scheme. So, I'm using myself as a case study. After serving for 35 years, I joined the Nigerian Police

Force at a very young age.

"I didn't go there to join, I led my friend there but unfortunately she's not taken I was recruited due to my height because I was tall, but I was not up to sixteen years of age when I joined and when I retired in 2018, I waited for like a year plus, and I was given N1.7m after 35 years. After waiting for another three months or so, they started paying me 40,000 as my monthly pension."

Reacting to the video, Sowore questioned the government's decision to pay Marcos such an amount after 35 years of service.

The Ondo-born politician highlighted that Senators are paid N29 million

monthly, while the police, who risk their lives, receive a mere pittance.

monthly, while the police, who risk their lives, receive a mere pittance. He tweeted, "How on earth is anyone who worked for 35 years paid N1.7m (\$1,100) as gratuity? This is a retired DSP of Police speaking about her pension and gratuity after retiring from the Nigerian Police Force, this is so

"Nigeria does nothing but evil to its workers. It is the same country where a Senator takes home N29 million per month, but the irony is that these Police officers will kill you in a heartbeat for fighting the system that oppresses us all!"

Ghana to implement visa-free travel for all African passport holders By Friday Omosola

hanaian President Nana Akufo-Addo announced on Friday that, starting from the beginning of this year, all African passport holders will enjoy visa-free travel to Ghana.

This move is a significant step towards greater economic integration across the continent.

The announcement was made during Akufo-Addo's final State of the Nation address, as he prepares to step down on January 6 after completing two terms in office.

He expressed pride in the decision, noting that it would contribute to the goals of the African Continental Free Trade Area (AfCFTA), the world's largest trading bloc.

"I am proud to have approved visa-

free travel to Ghana for all African passport holders, with effect from the beginning of this year," President Akufo-Addo declared during his speech to parliament.

He emphasised that the policy would further cement Ghana's role as a key player in fostering continental unity and cooperation.

In a candid interview with Pulse, the comedian outlined his ambitious plans, expressing a desire to take music more seriously by releasing EPs and collaborating with other artists.

Additionally, he emphasized his longstanding passion for filmmaking, describing it as his "first love."

Music: A new beginning

Basketmouth's venture into music is not entirely new, as he had initially pursued a career in music before transitioning into comedy.

Basketmouth's upcoming plans for 2025 reflect a commitment to authenticity. By focusing on music and filmmaking, he hopes to explore new creative frontiers and expand his artistic endeavors.

Looking ahead

As Basketmouth prepares to launch his music and filmmaking career, he remains optimistic about the future. His journey is far from over, and the comedian believes that these creative pursuits will complement rather than replace his successful comedy career.

In his own words, "I'm not leaving comedy behind. It has paved the way for me, and I'll always be grateful for that. But music and movies are my first loves, and I'm ready to dive deeper into those areas."

Mike Johnson reelected US House Speaker after tense vote By Dave Oludare Oso

Incumbent Mike Johnson was reelected House Speaker on January 3 after a tense roll call, overcoming opposition from hard-right Republicans. Despite Trump's support, his narrow majority and past struggles signal ongoing challenges as Congress prepares for key tasks.

Republican Mike Johnson won reelection to the House speakership on a first ballot Friday, pushing past GOP hard-right holdouts and buoyed with a nod of support from President-elect Donald Trump.

A collection of hardline Republicans convened in the back of the House chamber during a tense roll call on the first day of the new Congress, one by one declining to vote or choosing another lawmaker.

The standoff sparked fresh turmoil signaling trouble ahead under unified GOP control of Washington.

In the end, however, Johnson was able to flip two remaining holdouts who switched to support him, drawing applause from Republicans. As the most recent speaker, Johnson's weak grip on the gavel threatens not only his own survival but President-elect Trump's ambitious agenda of tax cuts and mass deportations as Republicans sweep to power

Newly-elected House lawmakers started casting votes as Johnson's name was put forward for nomination by the GOP Conference Chair Rep. Lisa McClain, R-Mich.

"No speaker's perfect," she said. But the goal is to make progress toward shared priorities for the country, she said. "None of us will get exactly what we want."

Democrats put forward their own leader, Hakeem Jeffries of New York,

as the only one with a track record of compromise and achievement in the face of "chaos and dysfunction" under the GOP majority.

"House Democrats are united behind the most powerful legislative leader in this chamber," said Rep. Pete Aguilar, D-Calif., of Jeffries,

recounting the many times their votes bailed out Johnson to ensure passage of important legislation.

With opposition from his own GOP colleagues, Johnson arrived with outward confidence after working into the night to sway hardline holdouts. A flop by Johnson could throw Monday's congressional certification of Trump's 2024 election victory into turmoil without a House speaker. Even backing from Trump himself, usually a sure bet for Republicans, was no guarantee Johnson will stay in power.

"We don't have time for drama," Johnson said as he walked into the Capitol.

The Louisiana Republican received a renewed nod of support from Trump. "A win for Mike today will be a big win for the Republican Party," Trump posted on social media.

What was once a ceremonial day with newly elected lawmakers arriving to be sworn into office, often with family, friends and children in tow, has evolved into a high-stakes vote for the office of House speaker, among the most powerful elected positions in Washington. Vice President Kamala Harris was swearing in the senators.

While the Senate is able to convene on its own and has already elected party leaders — Sen. John Thune as the Republican majority leader and Sen. Chuck Schumer for the Democratic minority — the House must first elect its speaker, a role required by the Constitution, second in the line of succession to the president.

Congress has been here before, when it took Republicans nearly a week and 15



rounds of voting to elect Kevin McCarthy as speaker in 2023, a spectacle unseen in modern times. McCarthy was then dumped by his party, a historic first, but he was also part of a long list of GOP speakers chased to early exits.

The stakes are higher this year as Trump prepares to return to the White House with the House and Senate in GOP control and promising to deliver big on a 100-day agenda.

Johnson has been working diligently to prevent defeat, spending New Year's Day at Mara-Lago as he positions himself alongside Trump. The speaker often portrays himself as the "quarterback" who will be executing the political plays called by the "coach," the president-elect. But Johnson also warned that without a House speaker there would be a "constitutional crisis" heading into Jan. 6, when Congress by law is required to count the electoral votes for president, weeks

"We don't have any time to waste, and I think that everybody recognizes that," he said.

before Trump is set to be

inaugurated Jan. 20.

Johnson commands one of the slimmest majorities in modern times, having lost seats in the November election. With the sudden resignation of Rep. Matt Gaetz, R-Fla., the tally dropped to 219-215. That leaves Johnson relying on almost every Republican

Badenoch demands national inquiry into UK rape gangs scandals **By Elizabeth Jenrola Oso**

onservative leader, Kemi Badenoch has called for a full national public inquiry into the UK's "rape gangs scandal."

It comes after Home Office Minister, Jess Phillips rejected Oldham Council's request for a governmentled inquiry into historical child sexual exploitation — saying the council should lead it instead.

Her decision, taken in October, was reported by GB News on Wednesday, then picked up by Elon Musk on his social media platform X and several senior Tories.

The Home Office has been approached for comment.

A Labour spokesperson said: "The Home Office supports police investigations and independent inquiries to get truth and justice for victims."

They said Labour had supported the 2022 national inquiry into child sexual abuse under Professor Alexis Jay, adding the government was "working at pace" to implement its recommendations.

Posting on X, Badenoch said: "Trials have taken place all over the country in recent years but no one in authority has joined the dots. 2025 must be the year that the victims start to get justice."


There have been numerous investigations into the systematic rape of young women by organised gangs, including in Rotherham, Cornwall, Derbyshire, Rochdale and Bristol

The sexual abuse of young girls by grooming gangs has fuelled a number of far-right campaigns which have focused on cases of large-scale abuse carried out mainly by men of Pakistani descent.

An inquiry into abuse in Rotherham found 1,400 children had been

sexually abused over a 16-year period, predominantly by British Pakistani men.

An investigation in Telford found that up to 1,000 girls had been abused over 40 years – and that some cases had not been investigated be cause of "nervousness about race."



The report found there was no evidence of "widespread" child sex abuse in those settings, or of a cover-up by the council, but the review did point out other serious failings among safeguarding services in the area.

The Independent Inquiry into Child Sex Abuse (IICSA), which published its final report in 2022, knitted several of these inquiries together alongside its own investigations.

Professor Alexis Jay, who led the inquiry, said in November she felt "frustrated" that none of its 20 recommendations to tackle abuse had been implemented more than two years later.

She said: "It's a difficult subject matter, but it is essential that there's some public understanding of it.

"But we can only do what we can to press the government to look at the delivery of all of this.

"It doesn't need more consultation, it does not need more research or discussion, it just needs to be done."

Philp told Radio 4's World at One programme he supported Oldham Council's call for a government-led inquiry, despite the previous Conservative government rejecting a similar request from an Oldham



councillor in 2022.

But, he added, "rape gangs" were "a bigger question than just Oldham."

Asked why the Tory government had not conducted a national public inquiry into such gangs, Philp pointed to IICSA but added "I don't think it was, frankly, as comprehensive on this topic as it should have been."

Philp said: "We need a proper national inquiry to look at all of these issues across all of the towns affected. And I'm afraid to say there are something like 15 to 25 different towns involved, covering thousands and thousands of victims."

Questions about the conduct of local authorities, the police and social care needed answering on a national scale, he argued. Philp also did not rule out the inquiry looking at the role of Sir Keir Starmer, who was director of public prosecutions from 2008 to 2013.

He said an inquiry should examine why perpetrators in "grooming gangs and rape gangs" appeared to be "overwhelmingly of South Asian background."

Responding to Badenoch, Reform UK leader Nigel Farage said: "Talk is cheap. The Conservatives had 14 years in government to launch an inquiry.

Two killed, 18 injured as plane crashes in California

t least two people were killed and 18 injured after a small **L**plane crashed into a commercial building in California, United States on Thursday, the police

The crash took place early in the afternoon near Fullerton Municipal Airport, 25 miles (40 kilometres) southeast of Los Angeles. The cause remains unknown.

"There are two confirmed fatalities," Fullerton police said on X.

Additionally, 10 people were hospitalized and eight others were treated at the scene.

Investigators do not yet know if the deceased were plane passengers or if they were workers at the building where it crashed, a police officer told local station KTLA.

Television footage showed a gaping hole in the roof of the building, with smoke pouring out.

"All we hear is like a loud noise, boom, and that's it. Then we started running out of the building," Jerome Cruz, one of the workers who witnessed said.

The plane was a single-engine Van's RV-10, a small model with four seats, according to the Federal Aviation Administration,

which has opened an investigations.

This incident comes few days on the heels of Jeju Air flight from Seoul on Monday, which was forced to return after encountering a landing gear problem.

Earlier, South Korea's most deadly plane crash killed 179 people after coming down without its landing gear engaged on Sunday.

Jeju Air Flight 7C101, which departed



Seoul's Gimpo International Airport for Jeju island "at around 6:37 am, returned to Gimpo at 7:25 am" after a landing gear issue was detected shortly after takeoff, the South Korean airline said.

"Shortly after takeoff, a signal indicating a landing gear issue was detected on the aircraft's monitoring system."

Biden set to block \$14.9b US steel acquisition by Japan's Nippon steel By Gbenga Oluranti Olaleye

S President Joe Biden has decided to block the proposed \$14.9 billion acquisition of US Steel by Japan's Nippon Steel, according to sources close to the administration.

The Washington Post reported on Thursday that a formal announcement of the presidential decision is expected as soon as Friday, unless Biden has a last-minute change of heart, which officials do not foresee.

Despite pressure from senior advisers who cautioned that blocking such a significant investment could harm relations with Japan, Biden is poised to reject the deal.

The transaction was brought to Biden after the Committee on Foreign

Investment in the United States (CFIUS) was unable to reach a consensus in late December on whether the acquisition posed a national security risk.

Biden has voiced opposition to the deal for several months, aligning with critics, including President-elect Donald Trump and incoming Vice President JD Vance, who have condemned the acquisition.

The controversy intensified when the deal became a focal point in the 2024 US presidential campaign, especially in Pennsylvania, where the steelworkers' union strongly opposed it.

While Nippon Steel has argued that the acquisition could revive Pennsylvania's struggling steel industry, US Steel and Nippon Steel have signalled plans to pursue legal action against the government, accusing it of not adhering



to proper procedures during the review process.

There was no immediate comment from the White House on Thursday evening.

Trump to attend Jimmy Carter's funeral despite years of mutual criticism

S President-elect, Donald Trump has said he will attend former President Jimmy Carter's funeral despite a history of mutual criticism.

Carter, who died on December 29 at the age of 100, will be honoured with a state funeral at Washington National Cathedral on Thursday, January 9.

President Joe Biden is expected to deliver the eulogy.

"I'll be there. We were invited," Trump told reporters on Thursday night, though he declined to say if he'd spoken with any members of the Carter family.

Trump's attendance at the funeral will come after years of public sniping between Trump and Carter, including Trump's recent jabs at Carter on the 2024 campaign trail.

Though after the 39th president's passing, Trump issued a statement praising Carter's service to the country.

"The challenges Jimmy faced as President came at a pivotal time for our country and he did everything in his power to improve the lives of all Americans. For that, we all owe him a debt of gratitude," Trump wrote. "Melania and I are thinking warmly of the Carter Family and their loved ones during this difficult time. We urge everyone to keep them in their hearts and prayers."

In another post, Trump commended Carter as a "truly good man" and praised his humanitarian work postpresidency.

"While I strongly disagreed with him philosophically and politically, I also realized that he truly loved and respected our country, and all it stands for. He worked hard to make America a better place, and for that I give him my highest respect," Trump wrote of Carter. "He was a truly good man and, of course, will be greatly missed. He was also very consequential, far more than most Presidents, after he left the Oval Office."





But previously, Trump had labelled Carter as the country's "worst president."

Trump also repeatedly criticized Carter as he lashed out at President Joe Biden when the two were opponents in the 2024 race before Biden dropped out.

"Crooked Joe Biden is the worst president in the history of our country. He's the most incompetent and he's the most corrupt president in the history of our country," Trump said last January as he ramped up campaign events. "And it's not even close. In fact, I said the happiest person alive today is Jimmy Carter because his presidency looks brilliant. Brilliant by comparison."

Carter, who had been in hospice care since early 2023, was out of the public eye during the presidential race but his family said he was trying to live until he could cast his ballot for Vice President Kamala Harris, which he did in mid-October.

During the presidential transition, Trump's denounced a signature achievement of Carter's presidency—the Panama Canal Treaty that gave the Central American nation eventual control of the critical waterway.

Trump recently said the U.S. "foolishly"

ceded the Panama Canal and suggested his incoming administration might try to regain control of it.

During Trump's first term, Carter didn't mince words when discussing what he thought about his presidency.

Carter told the Washington Post in 2018, "I think he's a disaster."

"In human rights and taking care of people and treating people equal," Carter said of Trump.

Carter also cast doubt at one point on Trump's 2016 victory, suggesting that a full investigation into Russian election interference would show Trump "didn't actually win." Trump hit back to those comments by saying Carter was "a nice man" but "a terrible president" who was "trashed" by his own party.

Though notably the two men spoke in 2019 when Trump called Carter to discuss China and trade negotiations. Prior to the call, Carter had sent a "beautiful" letter to Trump sharing some advice on the diplomatic relationship between the U.S. and Beijing, Trump's White House said at the time.

Meghan Markle hits major Instagram milestone just 1 day after unveiling account

eghan Markle's namesake Instagram account has attracted one million followers in the first 24 hours since she published her first post.

On Jan. 2, the Duchess of Sussex, 43, garnered one million followers on her @meghan Instagram page that she launched on New Year's Day.

A click into the page's "About this account" tab revealed that the verified account was created in June 2022, though Meghan didn't post for the first time until Jan. 1.

The Duchess of Sussex kicked off the new year in a major way by posting on a public Instagram account for the first time in years. The first post on the page was a video of Meghan shot by Prince Harry and showed her running on the beach to write "2025" in the sand.

PEOPLE understands the video was captured at a beach by Harry near their Montecito, California home, where the couple lives with their children Prince Archie, 5, and Princess Lilibet, 3.

The reports also said the Duchess of Sussex is excited to return to social media as a way to reconnect with communities worldwide and share updates about what she's working on, eager to lead by example in using social media to spark joy and positive connection.

While she hinted at an Instagram return by launching the American Riviera Orchard profile (and website) in March 2024, the account has not published any posts yet and both landing pages remain the same.

A close look showed that Meghan's debut post included a relatable social media move — a little practice for the perfect shot! The video opened with footage of Meghan running on the beach towards the sea, and a lookalike "2025" to the one she wrote with her hand in the sand later in the snippet was spotted to the side.

The subtle detail hinted that she had

attempted at least two takes to get it just right, with her careful handwriting calling back to her previous job as a calligrapher.

On Jan. 2, the Duchess of Sussex surprised with a second post on her @meghan account and shared the official trailer for her upcoming Netflix series titled With Love, Meghan. Meghan served as both host and executive producer for the lifestyle show, which will premiere in eight episodes on Jan.

"I have been so excited to share this with you! I hope you love the show as much as I loved making it," Meghan wrote below the video. "Wishing you all a fantastic new year! Thanks to our amazing crew and the team @netflix. Beyond grateful for the support — and fun! As ever, Meghan."

Set to the song "Do You Believe in Magic" by The Lovin' Spoonful, the trailer showed Meghan cooking, gardening, flower shopping, beekeeping and baking with friends including Mindy Kaling, Abigail Spencer (her former Suits costar) and Delfina Blaquier. Prince Harry, 40, also appeared in the video and wrapped his wife in a hug as they stood with champagne glasses on a sunny patio.

In a statement shared with PEOPLE, Netflix described the show (filmed in Montecito) as an "inspiring series, produced by Meghan, Duchess of Sussex, that reimagines the genre of lifestyle programming, blending practical how-to's and candid conversation with friends, new and old."

"Meghan shares personal tips and tricks, embracing playfulness over perfection and highlights how easy it can be to create beauty, even in the unexpected," it continued. "She and her guests roll up their sleeves in the kitchen, the garden and beyond, and invite you to do the



same."

The Duchess of Sussex is ringing in the new year on a high by revealing the series and going live with her eponymous Instagram profile. The themes highlighted in With Love, Meghan are reminiscent of the lifestyle content she spotlighted on her blog The Tig, which she ran from 2014 to 2017 while starring on Suits.

She shuttered the blog in April 2017 and closed down her Instagram page the following January, shortly after her engagement to Prince Harry was publicly announced and she geared up for her royal role.

Shortly after splitting offices with Prince William and Kate Middleton in March 2019, Prince Harry and Meghan launched the Instagram profile @SussexRoyal to showcase their royal work with a personal feel.

The account stopped being updated after Harry and Meghan stepped back from their royal roles in 2020, and the couple has been logged offline since.

While Meghan's new Instagram page is not following any other accounts and comments are so far disabled, her inner circle is celebrating her fresh start on social media.

Grooming gangs: You're misinformed, UK minister tells Musk

lon Musk's attack on the government's handling of grooming gangs is "misjudged and certainly misinformed," Health Secretary, Wes Streeting has said.

Tech multi-billionaire, Musk has posted a series of messages on his social media site X, accusing Sir Keir Starmer of failing to prosecute gangs that systematically groomed and raped young girls, and calling for safeguarding minister Jess Phillips to be jailed.

Asked about his comments, Streeting said, "This government takes the issue of child sexual exploitation incredibly seriously."

He invited Musk to "roll up his sleeves and work with us" against rape gangs.

The Tories have also criticised Musk for "sharing things that are factually inaccurate."

While visiting a care home in Carlisle on Friday, Streeting said Labour was getting "on with the job" of implementing the recommendations of the independent inquiry into child sexual abuse led by Professor Alexis Jay "in full."


He told reporters: "Some of the criticisms Elon Musk has made I think are misjudged and certainly misinformed.

"But we're willing to work with Elon Musk who I think has got a big role to play with his social media platform to help us and other countries tackle these serious issues.

"If he wants to work with us and roll his sleeves up, we'd welcome that."

Musk, a key adviser to US Presidentelect Donald Trump, has accused Sir Keir Starmer of failing to properly prosecute rape gangs while he was Director of Public Prosecutions (DPP), and has repeatedly retweeted Reform UK and Conservative MPs calling for a national inquiry.

He also suggested safeguarding minister, Jess Phillips "deserves to be in prison" after she rejected a request for the Home Office to order a p u b l i c inquiry into child sexual exploitation in Oldham. She s a i d t h e council should commission a local inquiry instead, as



The decision was criticised by several senior Tories, despite the previous Conservative government turning down a similar request in 2022.

Tory leader, Kemi Badenoch has also called for a full national public inquiry into what she called the UK's "rape gangs scandal."

But the party has also criticised Musk for "sharing things that are factually inaccurate" and distanced itself from his call for Phillips to be jailed.

Alicia Kearns – who shadows Phillips as the Conservative spokesperson on safeguarding – told BBC Radio 5 Live Musk had "fallen prone" to sharing things on his X platform "without critically assessing them."

She accused Musk of "drawing away attention from the survivors and from the victims" of rape gangs, and "lionising people like (far-right activist) Tommy Robinson—which is frankly dangerous." Reform UK leader, Nigel Farage has told the BBC that Musk, the world's richest man, is in talks about making a donation to the party. The two men met at Trump's Florida retreat last month.

Barcelona in crisis: Dani Olmo saga highlights financial, leadership turmoil By Timi-Zacchaeus Oluwaferanmi

ani Olmo, a marquee £51 million summer signing and a key figure in Spain's Euro 2024 triumph, finds himself sidelined from La Liga, embroiled in Barcelona's ongoing financial and administrative crisis. As of 1 January, Olmo and Pau Víctor were removed from Barcelona's official list of registered players due to the club's failure to meet La Liga's stringent wage cap regulations. This debacle has further tarnished the reputation of the Catalan giants and their president, Joan Laporta.

A Sporting Setback

Olmo, who has scored six goals in 15 appearances this season, was registered temporarily for the first half of the campaign under special exemptions. However, the courts twice rejected Barcelona's appeal to extend this arrangement. La Liga's governing body cited a lack of necessary conditions to grant the precautionary registration.

The failure to secure Olmo's registration leaves Barcelona without one of their most valuable assets on the pitch, forcing head coach Hansi Flick to navigate the remainder of the season without the influential forward. Meanwhile, the club must still honor the full payment of Olmo's transfer fee to RB Leipzig and his long-term contract, which runs until 2030, creating a financial liability of approximately €120 million (£100 million).

Financial Turmoil

Barcelona's financial struggles are at the core of this crisis. Accumulating over $\in 1$ billion in debt, the club has been unable to meet La Liga's financial controls. Additionally, the ongoing renovation of the Spotify Camp Nou has added approximately $\in 1.5$ billion in debt, further straining the club's resources.

A failed attempt to generate revenue through the sale of VIP seats at the future

stadium highlighted B a r c e l o n a 's desperation. While the funds from this deal reportedly arrived after La Liga's deadline, the governing body has refused to consider the late payment. The inability to meet these financial deadlines has forced Barcelona to

explore controversial measures, including selling off parts of its identity and renegotiating player contracts.

Leadership Under Fire

The crisis has intensified scrutiny of Laporta's leadership. Since assuming the presidency in 2021, Laporta's tenure has been marked by financial instability, failed promises, and controversial decisions. From the departure of Lionel Messi to delays in the Camp Nou's reopening, critics argue Laporta's populist rhetoric has failed to translate into effective governance.

Compounding the issue is Laporta's decision to leave critical executive roles unfilled following the resignations of Ferran Reverter and Eduard Romeu. This vacuum of leadership has left Laporta solely accountable for the fallout. Legal defeats in the courts and the lack of support from the Spanish Football Federation have left Barcelona isolated and exposed.

The Road Ahead

Barcelona's immediate options are limited. The club has explored agreements to terminate the contracts of deregistered players like Olmo and Víctor, allowing them to leave for free and potentially



return in the summer. However, this depends on player consent, and Olmo, despite his contract clause permitting him to leave without compensation, remains committed to the club for now The possibility of seeking provisional measures in a civil court offers a glimmer of hope but risks further legal entanglements. Meanwhile, opposition groups within the club are calling for drastic changes in leadership and strategy, warning that Barcelona's future hangs in the balance.

A Crisis of Identity

This debacle transcends financial and sporting issues, striking at the heart of Barcelona's identity. Once a symbol of footballing excellence, the club now faces questions about its values and direction. Fans and stakeholders are left grappling with the reality that years of mismanagement and short-term fixes have left Barcelona vulnerable to external pressures and internal discord.

For Olmo, the uncertainty mirrors the chaos surrounding his registration. Initially a sensation, his recent form has dipped, reflecting the instability at the club. For Barcelona, resolving this crisis will require more than temporary fixes; it demands a fundamental shift in leadership and strategy to restore the club's standing as one of football's most iconic institutions.

Rashford set to miss Liverpool match with illness

Celtic in pre-contract talks with Arsenal's Kieran Tierney By Timi-Zacchaeus Oluwaferanmi

eltic have initiated discussions to bring back former defender Kieran Tierney on a pre-contract agreement from Arsenal. The 27-year-old, who departed Celtic in 2019 for £25m, has struggled with injuries throughout his time in English football.

Tierney's Arsenal career has been marked by 125 appearances and several injury setbacks, including shoulder, knee, and hamstring issues. Despite his challenges, the Scotland international remains highly regarded for his professionalism and work ethic.

Amid interest from multiple European clubs, it is unclear if Arsenal will sanction a loan move for Tierney in January ahead



of a potential permanent transfer in the summer. A return to Celtic would mark a significant homecoming for the talented defender, whose last appearance for Arsenal came in a Carabao Cup win over Crystal

Palace in December.

As talks progress, fans in both north London and Glasgow await clarity on Tierney's next move, hoping the gifted left-back can revive his career.
