n New Year's Day, President in three consecutive Bola Tinubu assured Nigerians that all their sacrifices since he took over as the country's leader would not be in vain.

In his New Year message, the president, who promised to continue to serve every Nigerian diligently and wholeheartedly also listed some of his achievements in the year that just ended, despite the challenges his government faced.

Nigeria moves to extradite Simon Ekpa, approaches Finnish Govt **By Dave Oludare Oso**

The Federal Government has launched moves for the extradition of self-professed Prime Minister of Biafra in ExileSimon Ekpa by formally submitting the necessary requirements to Finnish authorities.

News

Disclosing this on Channels Television on Tuesday,

the Chief of Defence Staff, General Christopher Musa, said, "Well, I'm sure he's cooling off somewhere. Legal action will be taken accordingly. I don't want to say too much, but I'm glad he's been arrested.

"The Federal Government has provided most of the required documentation to the Finnish Government, so I'm confident the right steps will be taken."

The Finnish authorities arrested Ekpa along with four others, on suspicion of involvement in terror-related activities, including incitement to violence and financing terrorism in November 2024.

The Lahti District Court in Finland ordered Ekpa's remand based on probable cause for public incitement to commit a crime with terrorist intent in Nigeria.

The separatist leader was accused of using social media to promote separatist propaganda and violently advocating for

the secession of southeastern Nigeria. There are reports that he is been kept in one of the toughest prisons housing the most deadly criminals and felons in Finland, but many Nigerians still see his deportation to Nigeria as unlikely going by the fact that he is a



Finnish citizen.

However, the coming months will unveil answers as the Biafran agitator has his first day in court in Finland in May.

In fulfilment of its promise, the government of Oyo State, led by the governor, Engineer Seyi Makinde, has paid a 13th-month salary to workers in the state civil service.

NEW DAILY PRIME learnt that the workers received the payment alert on their phones on the evening of Monday, December 30, 2024.

Confirming the payment, the state's commissioner for Information and Orientation, Prince Dotun Oyelade, said this was despite the cumulative payment of N77 billion, which the government spends yearly for salaries and wages of Oyo State workers.

The commissioner recalled that only two weeks ago, Governor Makinde approved the payment of N80,000 minimum wages for government workers after the negotiating council resolved the issue of the consequential adjustment.

Oyelade said that starting January 1, 2025, the government will pay a total of $\mathbb{N}143$ billion on salaries and wages

annually by the approval of the new minimum wage.

The commissioner stressed that this represents a whopping 86 per cent increase in salaries and wages.

According to him, this puts Oyo State as having one of the three highest workers' packages in the federation. Some of the workers spoken to by NEW DAILY PRIME, also confirmed the development, commending the governor for what they call an unprecedented kindness in the ancient state.

Tolu Onifade, who works in the state ministry of agriculture, said, "God bless our kind-hearted governor for this gesture. When he made the promise, we did not believe him; we thought it was his usual political talk. But receiving the alert yesterday, I



was so happy I started praying for him (Gov Makinde). He has done what nobody has ever done before. May God bless him and his government."

Terrorists kidnap six, raze vehicle in Zamfara By Elizabeth Jenrola Oso

A rmed bandits on Tuesday, attacked travellers on the Shinkafi road near Kwanar Jalaf village under the Shinkafi Local Government Area of Zamfara State, abducting no fewer than six passengers.

The assailants abducted six passengers travelling in a Golf car and set the vehicle ablaze, in the early morning of Tuesday, further heightening fears among residents and commuters in the area.

The attack comes barely a week after notorious bandit leader Bello Turji issued threats to unleash violence on innocent citizens in Shinkafi and Zurmi communities in Zamfara State, as well as Isah and other local communities in Sokoto State in the New Year 2025.

According to Channels Television, residents of the area said the armed men blocked the road, forcing the vehicle to stop before carrying out the abductions and torching the car.

"Six travellers were abducted and their vehicle was set ablaze, we don't know if it was Turji group because he had recently threatened residents of Shinkafi and other local communities



around," a resident, who pleaded anonymity for security reasons said.

Residents of Shinkafi and other areas threatened by the terrorist kingpin have expressed growing concerns over the threat and are calling on the government to take decisive action against the escalating activities of bandit groups in the region.

Efforts to reach the spokesperson of the Zamfara State Police Command, ASP Yazid Abubakar for further details have so far been unsuccessful.

Nigeria tax spat opens country's smouldering north-south divide <u>By New Daily Prime</u>

ritics warn President Bola Tinubu's proposed changes to VAT distribution will help wealthier southern states

Nigeria's government is facing stiff opposition to a controversial tax reform bill that northern leaders say favours more productive southern states, reawakening a historic regional divide in Africa's most populous country.

Nigeria's parliament late last month began deliberating on four bills proposed by President Bola Tinubu's administration, including the socalled "Nigeria Tax Bill", to streamline tax codes and generate more revenue for a government whose tax collection lags behind its African counterparts.

But the proposal on how VAT should be shared among Nigeria's 36 states and capital city Abuja has become the subject of vociferous debate.

The reforms would allow states that generate more VAT — the largest line item Nigeria's federal government distributes — to receive a larger share of total revenue while reducing the amount allocated by population.

Northern states, which are typically more populous, say this will disadvantage them and exacerbate inequality. Inuwa Yahaya, chair of the Northern Governors Forum, which represents the 19 governors across Nigeria's vast north, said it "could jeopardise the wellbeing of our people".

"The economic hardship faced by many Nigerians today is undeniable and given the north-south disparity in economic inequality, it is even more pronounced in northern Nigeria," Yahaya, who is governor of Gombe State in the north-east, said.

Nigeria's north-south divide has long

been a bitter element of the country's politics. The predominantly Muslim north and Christian south, with their varied ethnic groups, were fused together as one country by British colonialists more than a century ago, leaving mutual suspicion that still reverberates.

After Tinubu — who is from Lagos in the south threatened military intervention in Niger following a coup last year, he was forced to back down by northern elites whose states share a long border with the country.

Poverty and illiteracy rates are higher in Nigeria's north. Annual GDP per capita is about \$292, less than half of the south's, and 65 per cent of the country's poorest people live in the north.

Currently, 50 per cent of the total VAT distributed to states is shared equally, while 30 per cent is allocated based on population size and 20 per cent by their tax contribution, or derivation. Tinubu now wants 60 per cent to be allocated based on contribution, while cutting the population quota to 20 per cent.

Northern lawmakers, including some from Tinubu's All Progressives Congress, have stalled the bills in parliament amid calls for further dialogue. But Senate president Godswill Akpabio, a staunch Tinubu ally, said in late December the bills would eventually pass and claimed critics had not taken the time to understand them.

Waziri Adio, executive director at Agora Policy, an Abuja-based think-tank which published an analysis of Nigeria's VAT system, said all parties involved had mishandled what were otherwise important reforms. The federal government tried to rush through the



proposal and northern leaders were misguided in labelling it "antinorth" in a country with longstanding ethnic tensions, he said.

"The arguments in favour of reforming Nigeria's tax system cannot be over-made," Adio said. "But reforms are as political as they are technical. You need the buy-in of the various stakeholders . . . Just because it seems like the right thing to do doesn't mean you don't have to consult."

Nigeria lags behind most other African nations in tax collection

While there have long been arguments that the current arrangement benefits lower productivity states with higher populations, opponents of the new proposal argue it risks misstating Nigeria's true economic picture.

Because the largest taxpaying companies are in the south, particularly in states such as Lagos and Rivers, critics say they could be benefiting from "headquarters effect" as VAT derivation is calculated based on where revenues are collected and not necessarily where goods and services are consumed.

US Senator's son jailed 28 years for deadly

Car chase By Dr. Olaoluwa Vincent Ajayi

3-year-old son of Senator Kevin Cramer, Republican of North Dakota, was at the center of a high-speed highway pursuit that tragically resulted in the death of a sheriff's deputy.

Ian Cramer, the 43-year-old son of Senator Kevin Cramer, Republican of North Dakota, was sentenced on Monday to 28 years in prison following a high-speed chase that ended in a crash and the tragic death of a sheriff's deputy. The incident occurred in December 2023 and has drawn national attention due to its devastating consequences and the mental health crisis that precipitated it.

The chase began on December 6, 2023, when Ian Cramer fled from a hospital in Bismarck, N.D., where his mother had taken him for treatment of what authorities later described as a severe mental health crisis. After speeding away in the family's vehicle, he was located roughly 70 miles away in Hazen, N.D., by law enforcement. The pursuit ended violently after Mr. Cramer crashed into an unoccupied patrol car parked on the side of a highway. The impact fatally struck Mercer County Sheriff's Deputy Paul Martin, 53, who was standing nearby preparing to deploy tire deflation devices. Deputy Martin, a respected member of the Mercer County Sheriff's Office for 18 years, was pronounced dead at the scene.

In September, Mr. Cramer pleaded guilty to all nine charges against him, including homicide while fleeing a peace officer, reckless endangerment, and multiple drug- and drivingrelated offenses. During sentencing, Judge Bobbi Weiler of the South Central Judicial District of North Dakota addressed Mr. Cramer directly, emphasizing that he had significant resources available to seek help. "You had more support than 99 percent of the people I've seen," She



sentenced Mr. Cramer to 38 years, with 10 years suspended, and credited him for the time already served. He will also serve three years of probation following his release. It is likely that Mr. Cramer may not serve the full 28 years due to the absence of mandatory minimum sentences for the charges and the North Dakota Department of Corrections' policies on sentence reduction.

At the sentencing, Ian Cramer expressed remorse, addressing the family of Deputy Martin. "I had no intention to do any of this. It was an accident, and I just hope that someday they can forgive me," he said. He also acknowledged his need for further treatment, stating, "I think the best thing for me is to go to a hospital and get more help." His mother, Kris Cramer, also spoke at the hearing, offering a heartfelt apology and acknowledging her son's long-standing struggles with mental illness. "I really do feel responsible for what happened," she said, referring to the events that led to her son's flight from the hospital.

Senator Kevin Cramer, who has publicly addressed his son's mental health issues in the past, did not respond to requests for comment. In a 2023 statement following Ian's arrest, the senator described his son's mental health challenges as "serious mental disorders which manifest in severe paranoia and hallucinations." The senator detailed how his wife, Kris, had driven Ian to the hospital for treatment on the day of the incident. After arriving, Ian fled in the family's vehicle, leaving his mother's phone behind. Authorities tracked the vehicle using the phone's location.

Deputy Paul Martin, who lost his life in the collision, was honored for his nearly two decades of service to Mercer County. The North Dakota State Highway Patrol reported that he was struck while working to stop Mr. Cramer's vehicle using tire deflation devices. Judge Weiler acknowledged Mr. Cramer's ongoing struggles with addiction and mental health during sentencing and recommended treatment as part of his incarceration. For Deputy Martin's family and the Mercer County community, however, the loss remains a painful reminder of the risks law enforcement officers face daily.

Ivory Coast announces withdrawal of French troops By New Daily Prime



Reduction of military presence is latest sign of weakening western influence in region French troops will begin to withdraw from Ivory Coast in west Africa this month, marking the latest reduction of France's military presence and a further weakening of western influence in the region.

Ivorian president Alassane Ouattara made the announcement in a new year's address that French troops would pull out from a base in the capital Abidjan this month.

"We can be proud of our army, which has now been effectively modernised. It is in this context that we have decided the concerted and organised withdrawal of French forces from Ivory Coast," he said.

France has around 600 troops in the country, one of its former colonies. The withdrawal will involve the handover of a military infantry battalion to Ivorian troops.

The announcement comes after Chad and Senegal have also sought to loosen their ties with France in recent months, and is the latest indication of a reduction of the long-standing French military presence on the continent.

Ouattara is considered one of France's strongest allies in west Africa and has formed a close alliance with French President Emmanuel Macron. He has previously condemned countries such as Mali for turning to Russian private military contractors such as the Wagner group.

But Ouattara, who is expected to run for a contentious fourth term in the October elections, may be calculating that announcing a symbolic break with France could benefit him politically in a region where growing anti-French sentiment has taken hold, particularly among young voters.

France's armed forces did not respond immediately to a request for comment, but Macron has previously acknowledged that France is reducing its military footprint across Africa.

"We are not shirking our responsibilities, but building a humble, demanding and long-term partnership," he said in a July speech on French defence policy.

In Senegal, President Bassirou Diomaye Faye said in his new year's message that the country would end the presence of all foreign military powers in the country in the year ahead. Faye had already announced the closure of French military bases in the country in November.

Chad's president abruptly ended the Sahel country's military agreement with France in November, and last week France handed over its first military base to the country.

French forces fighting jihadist groups in the Sahel region have also been forced out of Mali, Burkina Faso and Niger by military governments that are hostile to France, amid rising anti-French sentiment in the population.

The departures have marked a significant reduction in France's presence in the Sahel region, where several governments have turned towards Russia in recent years.

In all, France is withdrawing 1,000 troops from Ivory Coast and Senegal. After the French were kicked out of Niger, the US was also forced last year to withdraw about 1,000 troops there and give up its \$100mn drone base near Agadez on the southern edge of the Sahara.

West Ham's Michail Antonio discharged from hospital after car accident

West Ham United striker Michail Antonio has been discharged from the hospital after more than three weeks of recovery following a serious car accident on December 7.

The 34-year-old, who is West Ham's alltime leading scorer in the Premier League with 68 goals in 268 appearances, sustained a broken leg in the crash, requiring surgery to treat a lower limb fracture. Antonio was trapped in his vehicle after the accident, which occurred in Epping, Essex, and had to be freed by emergency responders before being rushed to a central London hospital. Antonio's recovery has been nothing short of remarkable, with West Ham manager Julen Lopetegui calling it a "miracle" that the Jamaican international is now stable. Despite his injury, Antonio remained connected with his teammates via a video call, offering support before West Ham's vital 2-1 victory over Wolverhampton Wanderers on December 9. The players honored Antonio by wearing "Antonio 9" shirts before kick-off. In a show of appreciation for the emergency services and medical staff who supported Antonio West

staff who supported Antonio, West Ham United announced they would donate nearly £60,000 to the NHS and Air Ambulances UK charities, the proceeds coming from the auction of the commemorative shirts.

"Everyone at the club would like to reiterate their heartfelt thanks to the first responders, emergency services, air ambulance staff, and the NHS for the incredible support given to Michail in the wake of the accident," a West Ham statement read.

The club has been buoyed by the outpouring of support from fans and fellow players alike, and Antonio's recovery continues to inspire hope as he begins the next chapter of his healing process.
