FG unveils emergency helplines to tackle kidnapping, terrorism

s part of efforts to tackle the growing menace of insecurity, especially ransom-driven abductions, the Federal Government has activated the toll-free 112 emergency number for Nigerians to report kidnappings and other security threats.


Nigerians, on Thursday, woke to the sad news of the gruesome murder of a member of the Anambra State House of Assembly, Hon. Justice Azuka, who, despite paying a ransom sum of N100 million, was killed by his abductors.

Disclosing this fresh initiative during a press briefing on the activities of the Multi-Agency Anti-Kidnap Fusion Cell under the Office of the National Security Adviser in Abuja on Thursday, the National Coordinator of the National Counter Terrorism Centre, Major General Adamu Laka said, "The Nigerian Communications Commission has facilitated an emergency response number, 112.

"The NCTC calls on all Nigerians to report suspicious activities, crimes, and kidnappings by calling the toll-free number 112, including the Multi-Agency Anti-Kidnap Fusion Cell's designated numbers that will be provided to the public.

"Kidnapping for ransom remains a critical challenge requiring collective and intensified efforts by all stakeholders. While significant progress was achieved in 2024, sustained commitment and innovative approaches are imperative to mitigate the menace in 2025."

Laka stated that Nigeria recorded a 16.3% decrease in kidnapping-forransom incidents in 2024 compared to 2023, although the number of victims



increased slightly by 0.27%.

He noted that Kaduna, Katsina, and Zamfara states in the North-West accounted for the highest prevalence, with 13.8% of total incidents and 61.1% of victims nationwide.

He explained that bandits, terrorists, cultists, militants, and secessionist groups continued to exploit kidnapping for financial gain and to fund illicit activities.

"Trends in 2024 showed that kidnappings occurred in both rural and urban areas, targeting villages, schools, highways, and residential areas.

"Despite efforts to curb the menace, mass abductions persisted, leading to deserted agrarian communities, disruptions in food production, and rising food prices. The sustained payment of ransom continued to fuel the crime, as perpetrators exploited families' fears to demand exorbitant sums." Laka said the government implemented both kinetic and non-kinetic measures to combat the menace, achieving significant results, including rescuing hostages, neutralising and arresting kidnapping kingpins, and destroying kidnappers'hideouts.

In 2025, he said the government would strengthen and expand counterkidnapping initiatives across all geopolitical zones.

"The government projects that kidnapping for ransom will persist in 2025 due to its financial incentives. To counter this, authorities aim to strengthen counter-kidnapping initiatives, expand efforts to all six geopolitical regions, improve collaboration with the 36 state governments, reinforce public confidence in government protection to discourage ransom payments, and engage state governments to address unemployment and economic vulnerabilities that drive individuals to crime," Laka stated.

FG begins payment of N50k monthly stipends to 10,000 youths By Elizabeth Jenrola Oso

he Federal Government, through Niger Delta Development Commission (NDDC) has started the payment of N50,000 monthly stipends to 10,000 indigenous youths from the Niger Delta under its Youths Internship Scheme.

The Director of Corporate Affairs at the NDDC, Mrs Seledi-Thompson-Wakama, disclosed this to journalists in Port Harcourt, Rivers State capital on Thursday.

She explained that the beneficiaries would undergo practical, hands-on training across the various organisations for 12 months to develop critical skills.

During the inauguration of the scheme on July 31, 2024, Senate President, Godswill Akpabio, announced the Federal Government's approval of a N50,000 monthly stipend for the trainees.

According to Thompson-Wakama, the commission has successfully completed the selection process and has begun placing trainees in organisations to gain practical experience.

"Consequently, with the completion of these phases, the payment of the monthly stipends has also



commenced," she announced.

She revealed that the 10,000 beneficiaries were transparently selected from over 3.2 million youths who registered for the empowerment programme.

"This unprecedented response highlights the immense potential and aspirations of our youths to improve themselves.

"NDDC remains steadfast in ensuring this life-changing opportunity reaches the most deserving candidates, creating a lasting impact and paving the way for a brighter future," she stated.

Thompson-Wakama explained that the scheme had enabled the commission to collate essential data, including the qualifications, skills, interests, needs, and employment status of the youths in the region.

The data, she explained, would guide the commission in designing programmes tailored to address the unique challenges faced by young people.

She disclosed that the NDDC partnered with KPMG, a global audit and consultancy firm to enhance the commission's corporate governance framework.

"KPMG has produced a Governance Advisory Report that will serve as a tool to support the commission's transition from a transaction-based to a transformation-focussed policy," Thompson-Wakama added.

The director commended the youths for their patience and cooperation during the selection process for the scheme.

NIS expands contactless passport renewal system to Europe after launch in Canada

Obi questions 2025 budget increase, demands expenditure breakdown By Friday Omosola

Peter Obi, the Labour Party (LP) presidential candidate in the 2023 election, has criticised the increase in the 2025 budget, stating that there is no corresponding breakdown of expenditures to justify it.



The New Daily Prime earlier reported that President Bola Tinubu raised the proposed 2025 budget from N49.7 trillion to N54.2 trillion, citing additional revenues from key government agencies as the reason for the increase.

The revised figures were conveyed in separate letters to the Senate and the House of Representatives.

Reacting in a statement on his X page on Friday, the former Anambra State governor noted that Nigerians are still awaiting a detailed account of the execution and expenditures of the Renewed Hope budget, passed in December 2023.

He emphasised that citizens must be informed to ensure the funds have been properly utilized for the country's development and the well-being of its people.



"Yesterday, I read about the increase in the Budget of Restoration to $\mathbb{N}54$ trillion due to increased revenue. While the sources of this revenue were detailed, there is no corresponding breakdown of expenditures to justify the increase.

"For transparency and accountability sake Nigerians need to know how the resources generated from them are being allocated to ensure that they are judiciously spent on the country's development and the well-being of the people", he added.

The 63-year-old stated that such expenditures should be allocated to critical areas of development, including education, healthcare, security, and poverty alleviation.

He urged the National Assembly to obtain and disclose the full details of the 2024 Renewed Hope budget.

Obi stressed that transparency in this matter is essential for ensuring accountability, learning from past budgets, and making informed decisions for the nation's progress.

"As we work towards passing the Budget of Restoration for 2025, let u s u p h o l d o p e n n e s s, accountability, and the welfare of the Nigerian people. We owe it to ourselves, our children, and the future of our great nation."

Ortom, Anyanwu, others face PDP axe over anti-party activities By Dave Oludare Oso

former governor of Benue State, Samuel Ortom, and Peoples Democratic Party (PDP), National Secretary, Senator Samuel Anyanwu, are among the first high-ranking members scheduled to appear before the party's Disciplinary Committee.

Disclosing this In a statement issued in Abuja on Thursday, the party's Chairman, Tom Ikimi said the party's disciplinary committee had relocated from the PDP national secretariat in Wuse and now operates from Legacy House, a party-owned facility in Maitama, Abuja.

According to Ikimi: "The National Disciplinary Committee of the Peoples Democratic party met on Wednesday, 5th February 2025 at the Legacy House, Maitama, Abuja in line with its mandate under Section 57(1) of the Constitution of the Peoples Democratic Party (as amended in 2017) relating to party discipline.

"The National Disciplinary Committee considered five (5) petitions received so far; and following a detailed review of the petitions, noted that the first set of petitions were against some key members of the National Working Committee (NWC).

"The Committee came to the conclusion that in order not to



jeopardize the ongoing reconciliatory efforts of the Governors' Forum and the Board of Trustees, took a decision to step down those three (3) of the petitions against the top NWC members.

"The second set of petitions which were set down for inquiry are those against former governor of Benue State, His Excellency Dr. Samuel Ortom and 10 others and the petition against Distinguished Senator Samuel Anyanwu.

"Accordingly, The National Disciplinary Committee resolved to invite the affected persons to appear before the Committee on Wednesday, 12th February 2025 at the Legacy House, Maitama, Abuja.

"Those expected to attend are the

petitioners and their witnesses on the one hand and the affected party members and their witnesses on the other hand; the required notices have been issued accordingly."

While emphasizing the PDP disciplinary committee derives its authority from the party's constitution, he assured that the committee is firmly committed to ensuring discipline within the PDP and restoring its integrity.

"Therefore, all those with genuine grievances against any member of the Party should take advantage of this Standing Committee and follow due process in bringing up their complaints" Ikimi said. 8

INEC calls for special court to handle electoral offences

he Independent National Electoral Commission (INEC) has renewed its push for the establishment of a special tribunal dedicated to electoral offences.

INEC Chairman, Mahmood Yakubu, emphasised the need for such a tribunal due to the growing backlog of electoral offence cases.

Speaking in Abuja on Friday during the commission's first quarterly consultative meeting with the media, Yakubu highlighted the challenges posed by the current judicial process.

"A major challenge to the swift resolution of electoral offences is the lack of a time-bound framework, unlike post-election disputes handled by tribunals.

"Currently, these cases fall under the jurisdiction of Magistrate and State High Courts in the locations where the offences occurred," he noted.

He explained that electoral offence cases often receive little



priority because courts are burdened with various other matters.

As a result, unresolved cases spill over from one election cycle to another, complicating prosecution efforts.

"To address this, we must push for the creation of an Electoral Offences Tribunal with a defined jurisdiction and strict timelines for handling cases efficiently," Yakubu stated.

Citing delays in the justice system, he pointed to a case in Akwa Ibom, where it took nearly six years to secure the conviction of a returning officer for offences committed during the 2019 general elections.

Yakubu also provided updates on INEC's ongoing legal efforts.

"Through our partnership with the Nigerian Bar Association (NBA), we are prosecuting 774 suspects from the 2023 elections.

"So far, we have secured convictions in Kebbi and Kogi States, while our collaboration with the Economic and Financial Crimes Commission (EFCC) on vote-buying has led to successful prosecutions in Lagos, Kwara, and Gombe States. However, many cases remain unresolved," he added.

Deji Adeyanju petitions Western countries for visa ban on Nigeria's police spokesperson

Human rights activist, Deji Adeyanju, and his law firm have filed a petition requesting the United States, United Kingdom, Canada, and the European Union to impose a visa ban on the Force Public Relations Officer (FPRO), Olumuyiwa Adejobi.

The petition, dated February 4, 2025, accuses Adejobi of suppressing free speech and using his position to intimidate Nigerians critical of the government.

The petition highlights multiple instances where Adejobi allegedly ordered the unlawful arrest and detention of individuals for expressing their opinions online. It accuses him of defending police brutality and weaponising the law against dissenters.

"We urgently appeal to the United States of America to impose a visa restriction on Assistant Commissioner of Police (ACP) Olumuyiwa Adejobi, the current Force Public Relations Officer of the Nigeria Police Force," the petition stated.

The petition claims that Adejobi has shown a blatant disregard for fundamental human rights, especially freedom of speech. One instance cited was Adejobi's statement on March 29, 2023, when he claimed that insulting police officers is a criminal offence in Nigeria.

This statement followed a viral incident involving musician Habeeb Okikiola (Portable), in which Adejobi labelled his actions as "unruly" and inciting violence against police officers.

Adejobi reiterated this stance in a Facebook post, stating that attacking or insulting police officers is disrespectful to



Nigeria itself. Human rights advocates and legal experts widely condemned this position, noting that it infringes on citizens' right to freedom of expression.

The petition also cited the arrest of nurse Olamide Thomas in December 2024. She was allegedly detained after posting a video critical of President Bola Tinubu, Inspector-General of Police, Kayode Egbetokun, and Adejobi himself. The petition described this as a direct assault on freedom of expression.

Another case referenced in the petition involved TikToker Destiny Ekhorutomwem, who was reportedly arrested on Adejobi's orders for cyberbullying and cyberstalking.

The law firm said Ekhorutomwem was given an impossible bail condition and collapsed in police custody, requiring medical attention.

Further, the petition pointed to the unlawful arrest of Charles Uche Ihedioha, who was detained for making a comment on Twitter.

The law firm noted that when Ihedioha's father visited the police station to see his

son, Adejobi allegedly ordered the officers who granted him access to be locked up.

The petition also accused Adejobi of justifying police brutality.

"In a recent report, he justified excessive force used by officers and dismissed calls for accountability, further proving his complicity in the continued abuse of Nigerian citizens," the firm stated.

Adeyanju's law firm called on the US, UK, Canada, and the European Union to take strong action against Adejobi, arguing that it would send a clear message to those who suppress freedom of speech and undermine democratic values.

The petition concluded, "We believe such action would send a strong message that individuals who suppress freedom of speech and undermine democratic principles will not be welcomed in the United States."

The petition has sparked significant discussion on human rights, police conduct, and the protection of free speech in Nigeria.

Oyo lawmakers propose paternity leave for male workers By Dave Oludare Oso

embers of the Oyo State House of Assembly have proposed the adoption of paternity leave for male workers in the state's public and private sectors, to enhance family bond and provision of additional care for the newborn and their spouses by men.

The lawmaker representing Oyo East/West State Constituency, Hon. Olorunpoto Rahman, who moved the motion, explained that a newborn relies on the strong bond with caregivers, especially parents who influence their emotion, social and cognitive growth.

Rahman also argued at the plenary presided over by the Deputy Speaker of the House, Hon. Abiodun Fadeyi, that introducing paternity leave in the state will enable fathers to support their partners during the recovery period after childbirth.

He added that this will, in turn, promote gender equality and shared responsibility in parenting among childbearing families.

The lawmaker noted that many countries, including some states in Nigeria, have adopted the policy as a measure to improve productivity in



their societies.

He said, "Many countries and states have adopted the paternity leave policy, and it has helped in boosting morale and improved productivity, while at the same time fostering family cohesion and stability."

He further revealed that the leave is already being implemented by the Federal Government through the Federal Civil Service as well as in Lagos and Enugu states.

The lawmaker emphasised that the absence of paternity leave for fathers in Oyo State may hinder their ability to provide necessary emotional and practical support to their families during postnatal period.

After the adoption of the motion, the Assembly recommended a minimum of 10-day duration for paternity leave with beneficiaries entitled to such leave thrice only throughout their service year.

The House further recommended that such leave should only be taken within the first month of childbirth or adoption of a child, to ensure that fathers have adequate time to bond with their newborns and offer support for their families.

Lagos govt deploys speed monitoring system, introduces fines By Friday Omosola

he Lagos State Government has announced the deployment of four new Intelligent Transport System (ITS) sites to monitor speed and traffic violations across the state.

Speaking at a press briefing yesterday, the Commissioner for Transportation, Oluwaseun Osiyemi, revealed that the initiative is a collaboration with Huawei Technologies.

The new installations will complement existing Automatic Number Plate Recognition c a m e r a s a n d T r a ffi c Management Solution devices.

"These checkpoints are strategically placed to detect overspeeding. One is located at Alapere, Ogudu Road, with an 80km/h speed limit, while another is at Nitel, Mobolaji Bank Anthony Way, with a 60km/h limit," Osiyemi stated.

He emphasised that overspeeding remains a major cause of road accidents, making this initiative crucial for road



safety.

In addition to speed monitoring, two e-police sites have been installed at Allen Avenue Road Junction and Nurudeen Olowopopo Road to track various traffic offences, including running red lights, lane indiscipline, illegal U-turns, and reversing on highways.

Osiyemi urged motorists to comply with the regulations, noting that a red-light violation attracts a N20,000 fine, while exceeding the speed limit incurs a N50,000 penalty.

"Enforcement begins

immediately. Offenders will receive SMS notifications from the Vehicle Inspection Service, detailing the violation and the applicable fine. This initiative is not meant to punish but to promote responsible driving, reduce accidents, and ensure safer roads," he added.

The press briefing was attended by Commissioner for Innovation, Science, and Technology Olatunbosun Alake, Permanent Secretary of the Ministry of Transportation Olawale Musa, representatives from Huawei Technologies, and key ministry officials.

2027: El-Rufai's N423bn indictment, battle with presidency lingers

For sometime now, the former governor of Kaduna State, Nasir El-Rufai has been having a running battle both with the Kaduna State House of Assembly over his indictment by the lawmakers ,and same for the presidency for his recent criticisms of the APC -led administration.

In this analysis, Damilola Olufemi examines the possible links between the ongoing imbroglio and the 2027 presidential race.

Nasir El-Rufai, the former governor of Kaduna State, has been embroiled in a controversy surrounding a \aleph 423 billion indictment by the Kaduna State House of Assembly.

The lawmakers had in 2024 accused El-Rufai's eight years- led administration of misappropriating funds, leading to significant financial liabilities for the state.

The Assembly maintained that the indictment was based on credible evidence, and that El-Rufai's filed lawsuit is an attempt to intimidate and silence them.

El-Rufai has since filed a lawsuit through his lawyer, Abdulhakeem Mustapha, challenging the allegations of the lawmakers, noting that the indictment was a nullity and against his fundamental human rights.

However, the question in the minds of many is: whether loyalists of President Bola Tinubu are fighting back, following



claims that it may be connected to El-Rufai's frosty relationship with the president.

It would be recalled that in June 2024, the ad hoc committee set up by the Kaduna State House of Assembly to probe all finances, loans and contracts awarded under the El-Rufai-led administration presented its report to the House.

While presenting the report, the House committee chairman, Henry Zacharia, disclosed that a large part of the loans collected under El-Rufai's administration were siphoned while others did not follow due process.

The issue has since taken a political image as many Nigerians are wondering what happens if the former governor's lawsuit turns out in his favour and his indictment nullified. They further ask: where will be the aftermath of the alleged involvement of the presidency in the indictment issue, and what will be the implications of the crisis as regards the 2027 presidential race.? However, El-Rufai's supporters argue that the indictment is a politically motivated action against the former governor. They further explained that the assembly's report was based on incomplete and inaccurate information, and that El-Rufai's administration had actually made significant progress in addressing the state's financial challenges.

The road to 2027

Trouble started in 2023 after the emergence of Asiwaju Bola Ahmed Tinubu as president when the National Assembly dropped El-Rufai's name as a ministerial nominee by the president.

El-Rufai possibly nursing the wounds of his disqualification, has lately became more critical of the Tinubu- led administration.

He also recently slammed the All Progressive Congress (APC) over its excessive centralization of power and shift from the party's core values and principles.

However, not to be seen as being docile in his role as a presidential spokesman, Daniel Bwala fired back at the former governor, echoing that El-Rufai's criticism wouldn't have come if he was part of the current administration.

"My senior brother, if you were in this government and cabinet, would you have held and expressed the same position? It is a government you participated in its formation, that you now want to unseat. Haba Mallam, a Ji soron Allah mana," the media aide posted on his X handle.

Bwala's insinuation, implying that El-Rufai's snide remarks were driven by personal grievances, was also corroborated by a group in Kaduna State.

The group further alleged that the former governor plans to destabilise the current administration in the state ahead of 2027 governorship and general elections.

In his response, El-Rufai said, "I have always spoken my mind, whether inside or outside government. My track record in public service speaks for itself. I have never been one to shy away from the truth, and I will not start now."

In the same vein, a political analyst in Abuja, Mojisola Akande, while speaking to New Daily Prime, affirmed that the ongoing crisis between El-Rufai and the presidency centres on the 2027 election.

Nasir El-rufai. Photo credit: Google She noted that the president may not be directly involved, but was aware and could intervene as the election year draws nearer.

She added: "This is an issue known across all the states in Nigeria. So, the president surely should be aware of it However, this can be resolved in no time when the 2027 election gets closer. Every state matters and among these states is Kaduna. Though the opposition party may lure the former governor."

Although, El-Rufai has stated that he has no plans to quit the APC.

Prior to that assurance, in July 2024, El-Rufai had filed a petition praying that the Chief Judge of the Federal High Court transfer the case handled by Justice Aikawa to another judge. Giving his reason for the request, the former governor cited in the "interest of justice and a fair hearing" in the $\mathbb{N}423$ billion case.

More ex-officials defend El-Rufai

On Tuesday, February 4, 2025, some ex-officials of the former governor, in a statement, faulted the indictment report which claimed that the El-Rufai led administration could not account for $\mathbb{N}423$ billion in eight years spent in office.

They added, "Only those inclined to fiction can believe that 40% of Kaduna's earnings over eight years simply vanished," adding that the claims was politically motivated by enemies of the past administration.

Earlier in 2024, some commissioners who served under the former governor ,also countered the report, noting that the committee set up could not provide how it arrived at the sum claimed to have been mismanaged.

"The Report begs the question as to where the Ad-hoc Committee obtained its figures for revenue, loans, and other "findings," separate from the published accounts of the Kaduna State Government that were duly tabled before the House of Assembly as required by the Constitution," the ex-commissioners added.

The El-Rufai saga has further called for the need for greater transparency and accountability in governance in Nigeria, as citizens deserve to know how public funds are being spent. They also deserve to have confidence in the institutions that are supposed to hold those leaders accountable.

The boiling questions remain: Will El-Rufai's lawsuit be successful? Will the Kaduna State House of Assembly's indictment stand?As the controversies continue to unfold, it's clear that the stakes are high. The outcome of El-Rufai's lawsuit and the assembly's indictment ahead of the 2027 election, will have significant implications for Nigeria's politics and governance.

However, one thing is certain: Nigerians are watching closely to see how this drama unfolds.

12 missing, 9 rescued after sea pirate attack in Rivers By Helen Okechukwu

welve passengers have reportedly gone missing after a suspected sea pirate attack along Isaka in Okrika Local Government Area (LGA) of Rivers State.

According to reports, out of the twenty passengers that boarded the boat on Thursday, nine were rescued by security personnel and transported to the state capital.

Meanwhile, reports indicate that the boat driver passed through Kilometer 10, a prohibited channel for commercial boat operators, which has been described as an act of disobedience.

The Chief Press Officer, Boma Waribo, confirmed in a signed statement that the



boat was en route from Bonny LGA. The Bonny LGA Chairman, Hon. Anengi Claude-Wilcox, has been informed about the incident.

He further disclosed that, in collaboration with neighboring LGAs and security agencies, the rescue team has intensified their search efforts to save the missing passengers.

Residents and relatives of the victims have been urged to remain calm. Waribo affirmed that security measures are being put in place to strengthen safety in the region.

"However, it should be noted that nine persons have been found and returned to Port Harcourt through the timely intervention of government security operatives, who are currently active and have intensified efforts to rescue the remaining 12 passengers," Waribo noted.

Internal Security: IGP appoints Shogunle to head SIS By Friday Omosola

In a strategic move to bolster internal security and enhance swift responses to violent crimes, the Inspector-General of Police (IGP), Kayode Egbetokun, has appointed Commissioner of Police Abayomi Shogunle to lead the Special Intervention Squad (SIS), Elections Planning, Monitoring & Evaluation, and the Safe School Protection Squad.

Police spokesperson Olumuyiwa Adejobi, in a statement on Friday, announced that as part of the IGP's initiatives to improve security and combat crime along inland waterways, Chima Ogarashi has been appointed as the new Force Marine Officer (FMO).

Adejobi described Shogunle as a



highly experienced officer with expertise in operations, public relations, and various other specialized fields.

According to him, Shogunle will spearhead the SIS in addressing critical security challenges while efficiently overseeing Elections Planning, Monitoring & Evaluation, as well as the Safe School Protection Squad. Adejobi further stated that Ogarashi, in his new role as FMO, will leverage his extensive experience in maritime security and law enforcement to manage one of the police force's critical divisions.

He noted that these appointments come at a crucial time, as the police prepare to deploy 25 newly acquired gunboats and advance efforts to procure additional maritime safety equipment aimed at enhancing security operations on the nation's waterways.

Adejobi emphasized that this strategic asset acquisition is a proactive measure by the police to safeguard lives and property while boosting public confidence in maritime security.

Killers of Anambra lawmaker arrested

The kidnappers responsible for the abduction and murder of Hon. Justice Azuka after collecting a \$100 million ransom has been arrested.

This was revealed in a viral post by an X, formerly known as Twitter user, Olaudah Equiano.

NEW DAILY PRIME reported that the lawmaker representing Onitsha North state constituency was kidnapped on December 26, 2024, and later killed despite the ransom payment. He was reportedly shot twice in the head.

Reports said that it was one of the culprits that led law enforcement agents to the dump site of the corpse of the late legislator.

Further details indicate that several accomplices involved in the crime have been identified and apprehended.

The viral update reads:

"The kidnappers who killed Hon. Justice Azuka withdrew \$100 million from his account before murdering him on December 26, 2024.

"They shot him twice in the head. A nurse residing in Asaba assisted in withdrawing the money, while a native doctor in Asaba prepared charms for them.

"The gang leader (kingpin) was living with the native doctor inside his shrine in Asaba. All six suspects have been arrested—none of them was above 30 years old. The nurse has also been apprehended, and her pharmacy sealed.

"The native doctor has been arrested



as well. All the suspects were living in Asaba, except one who resided in Oba. Over three additional bodies were found alongside Hon. Justice Azuka's remains. The suspects confessed that they typically kill their victims after collecting ransom."

As the post spread online, concerned individuals flooded the comment section to express their reactions.

NCYP urges EFCC to monitor local govt funds By Friday Omosola

he National Christian Youth Professionals (NCYP) has called on the Economic and Financial Crimes Commission (EFCC) to intensify its oversight of funds allocated to local governments across Nigeria, following the financial autonomy recently granted to them.

The appeal was made yesterday during a courtesy visit to the EFCC headquarters in Abuja.

NCYP Chairman, Isaac Abrak, led the delegation and emphasized the urgent need for stricter financial monitoring to ensure that resources reaching local governments are effectively utilized.

"We come from the grassroots and understand the realities on the ground. We commend the President for granting local government autonomy, but proper oversight is necessary.

"If local governments can effectively use even 40 per cent of their allocated resources, we will witness significant development," Abrak stated.

He further expressed the group's willingness to collaborate with the EFCC in ensuring accountability at



the grassroots level.

Abrak also lauded EFCC Chairman, Ola Olukoyede, for his leadership, describing him as a model of integrity.

"We are proud of your achievements, especially your role in securing Nigeria's victory in the P&ID case in 2023. Your tenure has set a remarkable standard," he added.

Expressing concern over the rising involvement of youths in cybercrime in Northern Nigeria, Abrak urged the EFCC to intensify its crackdown on internet fraud in the region. In response, Olukoyede welcomed the group's support and emphasized the need for unity in tackling corruption.

"Doing the right thing is not about religion—it's about integrity. Let's work together to build a society b a s e d o n h o n e s t y a n d accountability," he said.

He assured the delegation that the EFCC had already begun monitoring local government allocations through its Fraud Risk Assessment and Control department, which tracks payments, contracts, and expenditures to prevent financial mismanagement.

Wike's ministerial appointment crippled PDP's opposition strength – Okonkwo By New Daily Prime

Former Labour Party spokesperson Kenneth Okonkwo has blamed the Peoples Democratic Party (PDP) for its internal crisis, accusing its leaders of becoming subservient to the ruling All Progressives Congress (APC).

Okonkwo argued that President Bola Tinubu's appointment of Nyesom Wike as a minister significantly weakened the PDP's position as an opposition party.

In 2023, Wike, a former Rivers State governor and prominent PDP figure, accepted a ministerial role under Tinubu after openly opposing his party's presidential candidate, Atiku Abubakar.

Speaking on Sunrise Daily, a Channels Television program, on Friday, Okonkwo contended that the PDP leadership effectively surrendered to Wike, who, in his view, now operates in the interest of the APC.

"The PDP allowed some members, like the G5, to work against the party's interests openly. Instead of holding them accountable, the party made excuses for them. Now, they are attempting to take over the party, and with Wike's appointment, they have even more influence," Okonkwo said.

He further argued that Wike's position in the APC-led



government left PDP leaders in a subordinate role.

"When the party's supposed leader is serving in the APC, it means those under him are also indirectly serving the ruling party. The PDP is no longer an independent force—it has become a servant to a servant," he added.

Reacting to Atiku's recent claim that the APC is bribing opposition parties to weaken them ahead of the 2027 elections, he dismissed the allegation, insisting that such claims only expose the opposition's weaknesses rather than indict the ruling party.

He argued that it was the responsibility of opposition parties to resist any attempts at manipulation.

"I will never blame the ruling party for what is happening in the opposition. Excuses and success do not go hand in hand. Atiku said the APC offered N50 million to destabilize the opposition, but that statement only proves that the opposition is corrupt. If there were no willing receivers, there would be no givers," Okonkwo stated.

He described political sabotage as a legitimate strategy, emphasizing that opposition parties must stay united and resist external interference.

"The ruling party will naturally seek to weaken its opponents—it's in their political interest. But if the opposition allows itself to be destabilized, then it is incompetent and corrupt," he added.

Okonkwo called on opposition parties to take responsibility for their failures, urging them to reject any inducements and focus on strengthening their structures.

Nine Chinese nationals, firm arraigned over cyber terrorism, fraud By Gbenga Oluranti Olaleye

The Economic and Financial Crimes Commission (EFCC) on Thursday, arraigned nine Chinese nationals and a company, Genting International Co. Ltd., in connection with allegations of cyber terrorism and internet fraud.

The defendants, who appeared before Justice Chukwujekwu Aneke at the Federal High Court in Lagos, pleaded not guilty to the charges. The individuals named in the case include Su Dong Fu, Zheng Xian Tao, Wang Shi Long, Pan Cai Qi, Ting Liao, Fan Jia, Feng Li Cani, Lu Yong Yao, and Yang Chen Cheng.

According to the EFCC, the accused are part of a syndicate involved in cryptocurrency investment and romance fraud. This group was arrested on December 10, 2024, during an operation dubbed "Eagle Flush Operation" by EFCC operatives in Lagos. The crackdown led to the arrest of 792 individuals, all of whom are alleged to have been part of similar fraudulent activities.



The charges against the defendants include cybercrimes, cyber-terrorism, possession of fraudulent documents, and identity theft, among other offences. The EFCC has been actively pursuing such crimes, which have had significant financial implications on victims both within Nigeria and internationally.

During today's court proceedings, the prosecution counsel, M.K. Bashir, requested trial dates and urged that the defendants be remanded in the correctional centre pending the hearing. Following the proceedings, Justice Aneke adjourned the case to February 21 and March 7, 2025, for trial. In the meantime, the defendants have been remanded at the Ikoyi Correctional Centre.

This case follows closely on the heels of a similar prosecution earlier this week, in which 11 other Chinese nationals were arraigned before the same court for alleged involvement in cybercrimes aimed at destabilising Nigeria's economy.

The EFCC's efforts to combat cybercrime continue to intensify as they seek to hold individuals and organisations accountable for activities that threaten the financial stability of the nation.

Tears, panic as Trump's foreign aid cuts devastate HIV patients in Africa

The impact of President Donald Trump's foreign aid freeze is causing panic across Africa countries, leaving millions of lives in jeopardy. In South Africa, where the world's largest HIV epidemic continues to claim lives, the abrupt shutdown of PEPFAR-funded clinics has left thousands without medical support.

Outside a recently closed USAID-funded sexual health clinic in Johannesburg, a woman stands in shock. "It's only been two months since my last visit," she says, her voice trembling with distress. Now, she is left scrambling to find another facility for Pre-Exposure Prophylaxis (PrEP) and routine HIV screenings, as reported by MSN. For many sex workers, these clinics were their only access to safe and reliable healthcare.



A HIV-positive patient from the same closed clinic showed her patient transfer letter, revealing that she has yet to be registered at another facility. South Africa, home to 8.5 million HIVpositive individuals—a quarter of the world's HIV cases—relied heavily on U.S. aid for treatment. Now, thousands are at risk of losing access to medication.

"In the early 2000s, we had no medication. The government told us to take beetroot and garlic," recalls Nelly Zulu, an activist and mother living with HIV in Soweto. "We fought hard to win this battle, and now, we are being pushed back into that struggle." Zulu, who has been on lifesaving ARV treatment for more than two decades, fears for the most vulnerable: pregnant women and children. "I don't want them to go through what I went through. If PEPFAR disappears, millions will suffer."

Civil society organizations across South Africa have issued a joint open letter to the government, urging an immediate response to the healthcare crisis triggered by Trump's foreign aid freeze.

he letter warns that nearly one million HIV patients have been directly affected by the stop-work orders stemming from the funding suspension.

Nigeria Faces Uncertain Future as PEPFAR Suspension Hits Hard

Nigeria, home to the highest HIV burden in West and Central Africa, is also grappling with the effects of the PEPFAR freeze. With nearly two million Nigerians living with HIV and 1.7 million children orphaned by AIDS, the country has depended heavily on U.S. funding, which has contributed over \$6 billion to HIV/AIDS programs.

The funding suspension has set off alarms among Nigerian health officials, who fear a looming public health disaster.

"This suspension is devastating. It will put millions of lives at risk," warns Dr. Abdullahi Balogun, a medical doctor at Obafemi Awolowo University Teaching Hospital (OAUTH).

"Without access to ARVs, we will see an increase in HIV-related deaths. The situation is dire."

Doctors warn that hospitals may be forced to introduce user fees, making lifesaving treatment unaffordable for many patients. In Lagos, 42-year-old Stephen Enoch, an HIV-positive patient, expressed his deep concern. "I don't want to die," he said, his voice shaking. "I rely on these drugs to stay alive. Without them, what happens to me?"

Another patient, speaking anonymously due to stigma, echoed his fears: "I never imagined this could happen. If nothing urgent is done, Nigeria will see a surge in new infections."

For many Nigerians, the cost of ARV treatment is prohibitive. A recent study estimated that treatment could cost between \$100 (\$149,248) and \$1,000 (\$1,492,480) per month, putting it out of reach for most patients.

Nigeria Allocates №4.8 Billion for Emergency HIV Treatment

In response to the crisis, the Nigerian government has approved \$5 billion (over \$3 million) for the procurement of 150,000 HIV treatment packs, offering a temporary solution for the next four months.

"This allocation ensures that those on ARVs will continue to receive treatment without interruption," said Minister of Health and Social Welfare Ali Pate after the Federal Executive Council (FEC) meeting.

The government has also formed a high-level task force, including officials from Finance, Budget, Defence, Environment, and the Nigeria Governors Forum, to develop a long-term HIV/AIDS sustainability strategy. This approach also includes: strengthening domestic HIV/AIDS budgets, expanding local pharmaceutical production of ARVs and Securing additional funding from European donors and private sector partners.



NAFDAC proposes death penalty for drug peddlers By Gbenga Oluranti Olaleye

The Director-General of the National Agency for Food and Drug Administration and Control (NAFDAC), Mojisola Adeyeye, has called for the death penalty for drug peddlers, particularly those involved in selling counterfeit medicines that result in the deaths of children.

Speaking on Channels Television's The Morning Brief on Friday, February 7, Adeyeye emphasised that only strict and severe penalties could effectively deter drug peddlers. She cited a recent incident in which children's medicine, bought for about N13,000 and resold for N3,000, was found to contain no active ingredients when tested in NAFDAC's Kaduna lab.

"That raised an alarm. Guess what? When we tested the medicine, there was nothing inside. So, I want the death penalty," Adeyeye said.

She further argued that selling substandard medicine could be just as deadly as directly harming a child, stating, "You don't need to put a gun to a child's head to kill them. Just give them bad medicine."

Adeyeye also highlighted the need for stronger cooperation with the judiciary and the National



Assembly to make the proposal a reality. She explained that while NAFDAC has been doing its part to tackle the issue of substandard drugs, the lack of stringent penalties has hindered the agency's efforts.

"Someone brought in 225mg of Tramadol, which can kill a person or fry their brain, and the punishment is just five years in prison or a fine of N250,000," she said, pointing out that such a fine is often negligible compared to the severity of the crime. "Who doesn't know that a person can simply withdraw N250,000 from an ATM?"

According to Adeyeye, the lack of sufficient deterrents leads to repeat offences, as offenders face little to no consequences for their actions.



She stressed that NAFDAC's ability to combat the problem is limited without stronger legal measures and a firm judicial stance.

The NAFDAC boss reiterated her call for stricter laws and penalties, saying, "If our laws are not strong enough or the judiciary is not firm in its stance, we will continue to face this challenge. We are working with the National Assembly to make our penalties much stiffer. But if you kill a child with bad medicine, you deserve to die."

This bold proposal has sparked widespread discussion about the effectiveness of current penalties and the urgent need for stricter laws to combat the growing issue of counterfeit and substandard medicines in Nigeria.

NAFDAC destroys N4.7bn fake drugs in Rivers By Helen Okechukwu

o protect public health in Rivers State, the National Agency for Food, Drug Administration and Control (NAFDAC) destroyed fake, expired, and substandard drugs worth N4.7 billion on Thursday.

The destruction took place at the Rivers State Waste Management Authority (RIWAMA) Dumpsite in Aluu, Ikwerre Local Government Area, where the harmful substances were set ablaze.

This exercise, which began yesterday, is part of ongoing efforts to combat contraband drugs across six South-South states.

Speaking on behalf of the Director-General, the South-South Director of NAFDAC, Chukwuemeka Oligbu, reaffirmed the agency's commitment to tackling the menace of fake drugs.

"The products being destroyed during this exercise are made up of Substandard and falsified medical



products, unwholesome processed food products and food additives, unsafe cosmetics, counterfeits, and other expired NAFDAC regulated products seized by the agency from manufacturers, importers, and distributors.

"Also, up for destruction today are damaged and expired products voluntarily handed over by compliant companies, nongovernmental organizations (NGOs), Association of Community Pharmacists (ACPN), and trade unions, to the agency," he added. Oligbu urged the public to report suspicious pharmaceutical activities and unsafe products, emphasizing the need for collaboration between NAFDAC, pharmacists, law enforcement, and industry stakeholders.

The destruction exercise was carried out in partnership with other agencies and security operatives.

NAFDAC reiterated its commitment to safeguarding Nigerians from substandard and falsified medical products.

Enioluwa, where she was welcomed by her daughter and in-laws.



In another, West tagged President Trump and begged, "PLEASE FREE MY **BROTHER PUFF.**"


Kanye and Trump have had a close relationship in the past with the pair growing close in the run-up to the Republican's first election win in 2016.

West showed he is now selling a series of Sean John shirts in red, white, blue, black and grey for just £17 each.

Sean John is a fashion lifestyle company created by Combs back in 1988.

West described it as a business arrangement between the rapper duo which he alleges was agreed to prior to Combs' spell behind bars.

A social media post from West said, "YEEZY SEAN JOHN COLLAB AVAILABLE @ YEEZY.COM ME AND PUFF SPLITTING THIS 50/50 LIKE WE DISCUSSED BEFORE THEY LOCKED HIM UP."

Combs' Instagram account – believed to be run by his family - shared a screenshot of West's X post alongside the caption, "Thank you to my brother @Ye."

The post is just one of nine uploaded to Diddy's Instagram with almost all of them coming in the past six months.

The messages continued late into the night with many of them going on to reference unfounded claims about Combs' case.

He accused the criminal justice system of trying to "make an example out of Puff" and said he wanted to find out who was "after" the hip-hop icon.

One of his final messages read, "PUFF WELOVEYOU."

Combs was first arrested on September 16 in Manhattan by Homeland Security on charges of racketeering and sex trafficking.

He has been holed up in Brooklyn's Metropolitan Detention Center ever since.

Combs has constantly pleaded not guilty to the sex trafficking charges placed against him.

"On January 28, 2025, he was apprehended at his residence in Megamound Estate, Ajah, Lagos, and the exhibits involved in this crime were recovered."

According to the court, Portable and his boys beat up the planning officers—Abidemi Onabanjo, Ramon Lateef, and Akinpelumi Oyero.

The singer and his boys were allegedly armed with guns and cutlasses when they clashed with the officials of government.

Portable is currently on the run while his boys have been granted a N50 million bail by the court.

79 countries reject Trump administration sanctions on ICC

ozens of countries, including Germany, South Africa, and Mexico, said Friday that US President Donald Trump's decision to sanction the International Criminal Court (ICC) would "erode the international rule of law."

The joint statement by 79 countries came hours after Trump signed an executive order slapping financial sanctions and visa restrictions against ICC staff and their family members, alleging the court has improperly targeted the United States and Israel.

"Such measures increase the risk of impunity for the most serious crimes and threaten to erode the international rule of law, which is crucial for promoting global order and security," the 79 countries, including Canada and France, said in a statement publicly released by numerous governments.

The statement added that "sanctions could jeopardize the confidentiality of sensitive information and the safety of those involved—including victims, witnesses, and court officials, many of whom are our nationals."

The signatories said the sanctions may result in the ICC having to close its field offices.

"We regret any attempts to undermine the court's independence, integrity and impartiality," they said, crediting the "ICC's indispensable role in ending impunity, promoting the rule of law, and fostering lasting respect for international law and human rights."



The United States and Israel are among a minority of around 40 countries that never signed up to the ICC, an international court based in the Netherlands that seeks to hold to account the perpetrators of war crimes, like genocide.

But after some historic cooperation between Washington and the ICC, Trump's executive order Thursday accused the world body of "illegitimate and baseless actions targeting America and our close ally Israel."

In November, the ICC issued arrest warrants for Israeli Prime Minister Benjamin Netanyahu and former Israeli Defense Minister Yoav Gallant, as well as for Hamas leaders Yahya Sinwar, Mohammad Deif and Ismail Haniyeh.

The warrants relate to events on and since Oct. 7, 2023, when Hamas-led terrorist attacks killed 1,200 people and saw around 250 others taken hostage, according to Israeli officials. Since, then Israel has launched a military offensive that has killed more than 47,500 people in the Gaza Strip, according to local health officials.

The court said there was reason to believe Netanyahu and Gallant used "starvation as a method of warfare" by restricting humanitarian aid and intentionally targeting civilians in Israel's campaign in Gaza. Israel, which also does not recognize the ICC, dismissed those charges as false and antisemitic.

The court's "recent actions against Israel and the United States set a dangerous precedent, directly endangering current and former United States personnel, including active service members of the Armed Forces, by exposing them to harassment, abuse, and possible arrest," the executive order said.

Its signing appeared timed to coincide with Netanyahu's visit to Washington, in which Trump made the surprise announcement that he wanted the U.S. to take control of the Gaza Strip, shocking and outraging many officials, activists and experts around the world.

Ukraine, Russia exchange 300 prisoners of war By Elizabeth Jenrola Oso

kraine carried out a prisoner swap with Russia on Wednesday that saw 150 of its fighters returning home, President Volodymyr Zelenskyy said on his Telegram page.

Footage posted by Zelenskyy showed jubilant prisoners, many wrapped in Ukrainian flags, getting off buses and being reunited with loved ones at a location that was not disclosed for security reasons.

"And today, for them and their loved ones, this day means more than years of waiting. It is true h a p p i n e s s to see them h o m e—alive and free," Zelenskyy wrote. Some of them had spent more than two years in captivity, he added.

Zelenskyy thanked "the partners, especially the UAE," and everyone who works to return Ukrainians home.

The deal was brokered by the United Arab Emirates, which has been behind numerous other prisoner exchanges.

Russia's defence ministry said



its troops were undergoing medical checks in allied Belarus before returning to Russia, while also acknowledging the UAE's mediation efforts.

Meanwhile, hundreds of mourners gathered Wednesday in Poltava, Ukraine, to attend the funerals of some of the 14 victims of a Russian attack last Saturday.

Solemn services were held for the Zapishnyi and Yavorskyi families, who lost both adults and children in the attack.

The Zapishnyi family lost Serhii, 40, his wife Kateryna, 38, and their children, 8-year-old Danyil and 12-year-old Diana.

The Yavorskyi family lost both parents and their 9-year-old daughter.

Seven coffins were placed near the cathedral and emotional mourners paid their respects. They also left toys to honour the children.

"Today, a whole family was buried, which was taken away by an insatiable enemy. This is a family that can rightly be called an elite family," said Oleh Semko, a friend of the family.

Trump announces executive order to eradicate anti-Christian bias

President Donald Trump has announced an executive order to protect religious liberty, and 'eradicate anti-Christian bias'

Trump announced Thursday he is creating a task force led by the Department of Justice (DOJ) to "eradicate anti-Christian bias" within the federal government.

The President made the announcement at a private event following the 73rd annual National Prayer Breakfast-his second prayer breakfast speech of the morning.

Attorney General Pam Bondi will lead the effort and immediately halt "all forms of anti-Christian targeting and discrimination within the federal government" including at DOJ, IRS, and FBI, Trump said.

He said Bondi would also work to "fully prosecute anti-Christian violence and vandalism in our society and to move heaven and earth to defend the rights of Christians and religious believers nationwide."

Trump says he plans to launch the initiative with an executive order he intends to sign latest on Friday afternoon.

Faith groups are commending the President for creating a



commission to protect religious liberty.

Ralph Reed, president of the Faith & Freedom Coalition, said in a statement,"In the aftermath of the Biden Justice Department targeting parents attending school board meetings for possible prosecution and the FBI targeting faithful Catholics as a possible domestic threat, it has never been more important to eradicate all forms of targeting, bias, and discrimination based on faith at the federal level.

"Faith & Freedom Coalition's three million members and supporters strongly support President Trump in his defence of religious freedom and the rights of Christian Americans," the statement continued.

Addressing lawmakers at the 73rd National Prayer Breakfast on

Capitol Hill highlighting the importance of faith, Trump said, "From the very beginning of our Republic, America has always been a nation founded by people of faith and strengthened by the power of prayer, united by four simple but beautiful words. 'In God We Trust'."

Trump said he believes people "can't be happy without religion, without that belief. Let's bring religion back. Let's bring God back into our lives."

The 47th president added he is also forming a White House faith office led by Rev. Paula White, who served as a faith adviser during his first term.

Faith groups are commending the president for creating a commission to protect religious liberty.

Train carrying 350 passengers catches fire in Pennsylvania By Elizabeth Jenrola Oso



bout 350 passengers were safely evacuated after a S o u t h e a s t e r n Pennsylvania Transportation Authority (SEPTA) train caught fire.

Extraordinary images captured the moment a train carrying 350 passengers burst into flames, sparking mass evacuations en route to Delaware.

New York Post reports that the sixcar SEPTA train was traveling from Philadelphia when flames tore through a carriage near Crum Lynne, Pennsylvania about 6.15pm on Thursday.

Pictures of the incident show thick, grey plumes of smoke billowing from the train, which is lit up with orange flames within. Passenger Dnasia Buckner told Fox News that she began smelling smoke about 15 minutes into the journey.

'We had to get up and relocate to another car and then we had to get up and relocate again and that's when I started to see smoke coming from the side of the train,' she said.

'As people were walking by, they said the train's on fire, but the conductors aren't saying anything.'

Eventually, conductors opened the train doors and instructed all passengers to disembark, a process which Buckner said took about 15 minutes itself.

Firefighters were called to the scene to extinguish the blaze.

Service to Wilmington has been halted and Amtrak service along the Northeast Corridor is also impacted.

No injuries were reported.

The cause of the fire remains under investigation, but SEPTA spokesperson Andrew Busch credited quick-thinking staff for keeping passengers safe.

'Very quick action by our crews that that helped allow this to be a safe outcome,'he said.

'We don't know where this started, just that it was in the area underneath the train and then obviously engulfed the train in flames,'Andrew Busch said.

Outrage as 100 Indians shackled aboard 40-hour migrant flight By Elizabeth Jenrola Oso

S officials kept around 100 deported Indian migrants in shackles for their 40-hour flight home, including during bathroom breaks, in the latest incident to spark anger overseas at President Donald Trump's migration crackdown.

Indian lawmakers demonstrated outside parliament on Thursday, some wearing shackles and others mocking the muchtouted friendship between Trump and Indian Prime Minister Narendra Modi.

Elsewhere in New Delhi, members of the youth wing of India's main opposition party burned an effigy of Trump.

Last month, the spectacle of Colombian deportees being shackled as they boarded a US deportation flight sparked a bitter dispute between the two countries, with Colombian president Gustavo Petro initially refusing the military plane permission to land.

The anger in India comes days ahead of an expected visit by Modi to meet Trump – whom he has called a "true friend" – at the White House.

S. Kuldeep Singh Dhaliwal, a government minister in the western state of Punjab, where the deportation flight landed, urged Modi to "now use his friendship to resolve the issue."

Dhaliwal also questioned "the usefulness of this friendship if it cannot help Indian citizens in need," his office said in a statement.

The flight to India was the longest in distance since the Trump administration began deploying military aircraft for migrant deportations, according to a US official.

"Our hands were cuffed and ankles tied with chains before we took the flight," said 23-year-old Akashdeep Singh, who arrived in Punjab on Wednesday with 103 other deportees.



"We requested the military officials to take it off to eat or go to the bathroom but they treated us horribly and without any regard whatsoever," Singh added.

"The way they looked at us, I'll never forget it... We went to the bathroom with the shackles on. Right before landing, they removed (the shackles) for the women. We saw it. For us, they were removed after we landed by the local police officials."

US Border Patrol Chief Michael W. Banks posted a video of the Indian deportees being put onto a plane on X. In the video, shackles are seen on the wrists and ankles of several men who shuffle slowly up the ramp.

CNN has reached out to the Pentagon and US Customs and Border Protection for comment on whether the deportees were held in shackles for the duration of the flight.

Deportee Sukhpal Singh, 35, also said the shackles were kept on throughout the flight, including during a refueling stopover on the Pacific island of Guam.

"They treated us like criminals," he said. "If we would try to stand because our legs were swelling due to the handcuffs they would yell at us to sit down."

Young Indians looking for work opportunities have made up a sizeable portion of undocumented migrants in the US, many after making the dangerous trek through Latin America to reach the US southern border.

Many say they see no future at home where a jobs crisis is stifling young hopes in the world's most populous country.

In just four years, the number of Indian citizens entering the US illegally has surged dramatically — from 8,027 in the 2018-19 fiscal year to 96,917 during 2022-23, government data showed.

Families have previously told CNN how they sold off land to raise the tens of thousands of dollars charged by "travel agents" to take migrants on the risky journey to the US.

"I had gone for work, for better life, for a better future," said Sukhpal Singh, who has a son and daughter and hoped to better provide for them by getting a job in the US.

"You see it in movies and you hear from people around you that there's work there and people are successful there so that's why I also wanted to go."

Elon Musk barred from accessing US Treasury payments data By By Joe Miller in Washington

Ion Musk's crusade to slash US government spending suffered setbacks on Thursday after a federal judge barred the Treasury department from handing data from its payments system to outsiders and one of the billionaire's staffers was forced to resign over racist social media posts.

Judge Colleen Kollar-Kotelly put the temporary order in place after Musk boasted that his team at the "Department of Government Efficiency" (Doge) was "rapidly shutting down" Treasury remittances. They apparently gained access to the system that disburses trillions of dollars, including social security payments and Medicare, each year.

Hours after the judge's decision, 25year-old coder Marko Elez, who was working for Doge at the Treasury, abruptly resigned after apparently racist comments from a dormant social media account were unearthed. The Wall Street Journal first reported on the social media posts.

Elez was one of a handful of young engineers recruited by Musk's Doge and installed in various government agencies. When asked about their roles this week, President Donald Trump called the coders "very smart" and defended their work.

Representatives of government employees and retirees earlier this week had sued to stop the sensitive data — accessed by Elez — being shared with Musk and others at Doge, arguing that such moves were "depriving them of privacy protections guaranteed to them by federal law".

Although the US government reassured the court that only two of Doge's emissaries, Cloud Software Group's chief executive Tom Krause and Elez,



had access to the sensitive system, Kollar-Kotelly issued an order preventing any information being shared outside the Treasury while she considers a more permanent injunction.

As a result, Musk himself will not be able to review data pulled from the payments system.

Anti-Musk protesters outside the US Department of Labor in Washington on Wednesday © Jose Luis Magana/AP The legal challenge comes as Treasury officials and the White House have sought to quell fears over Musk's and Doge's purported access to the system, and his broader authority, after the entrepreneur suggested his team was unilaterally cancelling "illegal" payments.

On Monday, Trump said Musk, who has been made a special government employee, "can't do— and won't do anything without our approval".

Press secretary Karoline Leavitt also confirmed that Musk would extricate himself from any situations where he might have a conflict. "If Elon Musk comes across a conflict of interest with [his companies'] contracts and the funding that Doge is overseeing, then Elon will excuse himself from those contracts . . . he has abided by all applicable laws," she said.

Doge, whose emissaries have infiltrated the networks of various government agencies, including the US Agency for International Development, the Department of Health and Human Services and the Department of Transportation, has been sued multiple times by groups claiming the body is circumventing various legal protections.

Separately on Thursday, a judge in Massachusetts ordered a deadline for federal employees to accept or reject a buyout package — part of a personnel reduction effort spearheaded by Musk — to be extended at least until Monday.

The White House also confirmed that only 40,000 workers had thus far accepted the offer, well short of the hundreds of thousands it had previously forecast.

Rubio accuses South Africa of 'anti-Americanism,' snubs G20 meeting By Dave Oludare Oso

The US secretary of state, Marco Rubio, has accused South Africa of "anti-Americanism" and refused to attend a G20 meeting in Johannesburg later this month, as diplomatic ties sour between the two countries under Donald Trump's administration.

Rubio made the announcement on X, where he repeated the US president's unfounded claim that South Africa was expropriating private property.

"South Africa is doing very bad things. Expropriating private property. Using G20 to promote 'solidarity, equality, & sustainability.' In other words: DEI (diversity, equity and inclusion) and climate change," Rubio said in a post on X. "My job is to advance America's national interests, not waste taxpayer money or coddle anti-Americanism."

Elon Musk, the South African-born billionaire and Trump adviser tasked with scrutinising US government spending and staffing, including on foreign aid, replied with two American flag emojis.

South Africa's president, Cyril Ramaphosa, appeared to rebuke Trump and Rubio in his annual State of the Nation address on Thursday: "We are witnessing the rise of nationalism, protectionism, the pursuit of narrow interests and the decline of common cause ... We will not be bullied."

Rubio's snub of South Africa, which this year is chairing the G20 forum of large economies, the EU and African Union, comes after Trump said on Sunday that South Africa was "confiscating land" and that he was stopping US funding pending an investigation. South Africa's president, Cyril Ramaphosa, last month signed a law allowing for land expropriation with no compensation in limited circumstances. Politicians have said it is similar to countries including the US, where expropriating land with "just compensation" is allowed for public projects such as road building.

More than three decades after apartheid ended, land ownership remains concentrated in South Africa's white minority. The government has bought and redistributed 7.8m hectares (19m acres), while courts have ordered a limited number of returns of land to people displaced by apartheid.

"There is no arbitrary dispossession of land/private property," South Africa's foreign minister, Ronald Lamola, said on X. "Our G20 Presidency, is not confined to just climate change but also equitable treatment for nations of the Global South, ensuring equal global system for all. We remain committed to engaging the government of the USA." The US relationship with South Africa deteriorated under the previous US president, Joe Biden, when South Africa refused to take sides in the Russia-Ukraine war but continued to play an active part in the BRICS bloc, originally made up of Brazil, Russia, India and China.

The US also said South Africa's international court of justice case against US ally Israel, accusing it of committing genocide against Palestinians in Gaza, was "meritless". The case is yet to be decided.

Musk, who like other former PayPal executives and wealthy Trump allies Peter Thiel and David Sacks spent at least part of their childhood in apartheid-ruled South Africa, has accused South Africa of having "openly racist laws."

While Musk's Starlink internet provider operates or is due to launch in 16 African countries, it is not available in South Africa, where foreign investors must cede 30% of equity to Black shareholders to get a telecoms licence.



Man Utd have become worse under Ruben Amorim – Gary Neville

lub legend, Gary Neville believes Manchester United have become worse under Ruben Amorim and warned the Portuguese: "It can't keep going on like this."

Sunday's 2-0 home defeat to Crystal Palace put Amorim's United back to square one after three straight wins over Rangers, Fulham and Steaua Bucharest.

It was the 39-year-old's fifth league defeat in seven matches at Old Trafford since taking over – the quickest any Manchester United manager has reached that number of home top-flight losses in Premier League history.

And Neville believes the pain is only going to continue for Amorim, his players and the United fans between now and the end of the season.

"I thought it would get better when Ruben Amorim came in, the enthusiasm of him and the new system, the players would buy into and we'd see a bounce," he told the Gary Neville Podcast.

"But we've seen the absolute opposite and it's got a lot worse – and that's surprising.

"There's going to be a lot more pain towards the end of the season and it's going to be damaging – because they're obviously going to stick with Amorim. But the more you lose, the more difficult it is for the manager to convince the players of his idea.

"In the very early days he said, 'I will not change my idea' and you need the players to buy into that. If they keep losing and they keep getting criticised and the spotlight comes on them more and the fans are leaving unhappy, you know it creates a feeling and you can't keep losing.



"You just can't. It will depress the thoughts of the players to a point whereby they'll start to lose faith in the idea and it'll damage you.

"He can't change his approach now because he's died in the ditch on it and rightly so. But he's lost more games at Manchester United than he lost in the last 75 at Sporting Lisbon which is just absolutely alarming, so he will not be enjoying this.

"It can't keep going on as it is and they somehow have to start playing better – because at this moment in time it's a very sorry situation when you watch United play."

United's latest defeat came in bizarre circumstances as Amorim chose midfielder Kobbie Mainoo has his centreforward option, leaving recognised strikers Rasmus Hojlund and Joshua Zirkzee on the bench.

Amorim's side struggled in front of goal once again and in a further twist of irony, Palace's recognised forward Jean-Philippe Mateta got both goals in the 2-0 victory. Neville believes Amorim's team selection gave Palace a lot of confidence to pick up that win and said while United's head coach cannot change his style of play now, he must make some tweaks.

"The only thing I can think he's doing is one of two things – experiment to the point whereby he's just trying to find a solution that works in the system he wants to play, or he doesn't like the strikers he's got," said Neville about Mainoo's centreforward selection.

"I thought Bruno Fernandes was going to play in that position or Alejandro Garnacho might play up front and Fernandes to the right; when I saw Mainoo as a centre-forward or dropping in to that position, I thought it's okay, you'll get control in the game and you can get decent football. And it can con you, it can kid you.

"It's about putting the ball in the back of the net, it's about getting bodies in the box, it's about getting bodies across defenders and making sure that you're really creating chances and that's not going to happen that much with Mainoo up front as everything has to be perfect.

Nico Gonzalez helps Man City fill void left by Rodri's absence – Guardiola

anchester City's new midfield signing Nico Gonzalez will help them plug the gap caused by the absence of injured key player Rodri, manager Pep Guardiola said on Friday.

Spanish midfielder Gonzalez arrived from Porto on the final day of the transfer window earlier this week for a reported 60-millioneuro fee (\pounds 50 million, \$62 million).

The 23-year-old's father Fran previously worked as a coach at City's academy and Guardiola was also aware of the player's abilities as he began his career at his former club Barcelona.

Ballon d'Or winner Rodri, who has been out since rupturing his anterior cruciate ligament in September, is included in City's squad for the Champions League's knockout stages despite being ruled out for the season by Guardiola.

"It's a position where we were weak after the absence from Rodri," Guardiola said about Gonzalez, who joined from Porto on Monday on a four-and-a-halfyear deal after City paid €60 million for the 23-year-old.

"I know him from the Barcelona academy and his father was working here. I'm really pleased



from the effort of the club to bring him here for the next years."

Last season's beaten finalists City visit third-tier Leyton Orient in an FA Cup fourth round clash on Saturday, and Guardiola said he expected a tough game.

"Always we've had problems away in this competition... away to teams in the Championship or League One or even League Two," he said.

"Always we struggle. But we are ready for the challenge. Every game is a new opportunity."

City have struggled without Rodri, who suffered a serious knee injury in September.

A run of four consecutive Premier League titles is almost certain to come to an end as they sit 15 points off runaway leaders Liverpool.

City did sneak into the Champions League group stage but now faces the might of holders Real Madrid in the play-off round later this month.

When asked about City women's team striker Khadija Shaw facing racist abuse, the manager said he stood by her.

"We would be lucky if this was just in world football. Unfortunately it's in the whole entire world," he said.

"It's really more difficult for me to understand that people can defend these stupid things. I support her, like I support all people who receive abuse in terms of racism, gender."
