### IPOB remains banned as terrorist group - Appeal Court By Dave Oludare Oso

he Court of Appeal sitting in Abuja, has upheld the proscription of the Indigenous People of Biafra (IPOB), as a terrorist organisation.

In a unanimous decision by a threemember panel led by Justice Hamma Barka on Thursday, January 30, 2025, the appellate court affirmed the judgement of the Federal High Court in Abuja, which outlawed IPOB.

The court held that it found no reason to set aside the order the Federal Government got against the group.

According to the court, the government acted lawfully by proscribing the organization whose activities threatend the nation's security and continued existence.

It resolved all the issues against IPOB and dismissed its appeal for want of merit.

It will be recalled that the late former Chief Judge of the Federal High Court, Justice Abdul Abdu-Kafarati, had in a ruling he delivered on September 15, 2017, outlawed the activities of the IPOB in Nigeria.

The proscription order followed an ex-parte motion the former Attorney-General of Federation and Minister of Justice, Mr.



Abubakar Malami, SAN, filed on behalf of the Federal Government.

Specifically, Justice Kafafati declared as illegal, all activities of the group, particularly in the South-east and South-South regions of the country.

He further restrained "any person or group of persons from participating in any of the group's activities."

The Judge directed the AGF to ensure that he published the proscription order in the official gazette, as well as in two national dailies.

In a follow-up ruling on January 22, 2018, the court dismissed a motion IPOB filed to challenge the legal validity of the proscription order which it said was surreptitiously obtained by the AGF.

Dissatisfied with the decisions, IPOB approached the appellate court to set them aside.

The organization, in its appeal marked: FHC/CA/A/214/2018, which it filed through its team of lawyers led by a Senior Advocate of Nigeria, SAN, Mr. Chukwuma-Machukwu Umeh, urged the appellate court to set aside in its entirety, the ruling/final decision of the high court.

It alleged that the then AGF suppressed and misrepresented facts in the affidavit evidence he tendered before the court. maintaining that the proscription order was tantamount to declaring over 30 million Nigerians of Igbo extraction as terrorists.

## Tinubu mourns US plane crash victims, says Nigeria stands with America

resident Bola Ahmed Tinubu has expressed sadness over the death of at least 18 persons in an air accident in Washington DC, United States.

President Tinubu, in a statement on Thursday, said he is deeply saddened by the incident which occurred in Washington D.C.

Intel Region that a tragic mid-air collision that occurred near Washington, D.C., involving an American Airlines commercial jet and a U.S. Army Black Hawk helicopter, left 67 people unaccounted for.


The American Eagle Flight 5342, carrying 60 passengers and four crew members, was approaching Ronald Reagan Washington National Airport on Wednesday night when it collided with the military helicopter, which had three crew members onboard.

In a post via his verified X handle on Thursday, Tinubu commiserated with the families of the victims, the people of the United States, and all affected by the sad incident.

He added that Nigeria stands in solidarity with the USA in their time of grief.

"I am deeply saddened by the tragic incident in Washington, D.C.

"On behalf of Nigeria, I extend our heartfelt condolences to the families



of the victims, the people of the United States, and all affected by this profound loss. I commend the courageous efforts of first responders and emergency teams for their selfless work in harsh conditions.

"Nigeria stands in solidarity with the United States Government and its People, united in grief and hopeful for a new day," the statement read.

Meanwhile, US Donald Trump believes the crash between an American Airlines regional passenger jet and a military helicopter 'should have been prevented.'

The president initially delivered a statement hoping that God would bless the souls of the victims as emergency services search the Potomac River near the airport for survivors following the incident.

In a post to the Trump-owned Truth

Social later in the evening, Trump raised several questions about the crash, which took place at 8.48pm on Wednesday.

'The airplane was on a perfect and routine line of approach to the airport. The helicopter was going straight at the airplane for an extended period of time. It is a CLEAR NIGHT, the lights on the plane were blazing, why didn't the helicopter go up or down, or turn,' he asked.

Trump continued: 'Why didn't the control tower tell the helicopter what to do instead of asking if they saw the plane. This is a bad situation that looks like it should have been prevented. NOT GOOD!!!'

He wrote a short follow-up post on Truth Social saying: 'What a terrible night this has been. God bless you all!'

## Shettima launches project #SheIsIncluded to bridge gender gaps By Friday Omosola

ice President Kashim Shettima has reaffirmed Nigeria's commitment to gender equality, declaring that women will lead Africa's projected \$29 trillion economic transformation.

He made this statement while launching Project #SheIsIncluded during the opening of the 2025 Gender Inclusion Conference in Abuja on Thursday.

The initiative aims to bridge gender gaps in finance and the economy, further emphasizing Nigeria's dedication to achieving Sustainable Development Goal 5: gender equality and the empowerment of all women and girls.

"This is not a cosmetic performance to placate progressives; it is a fundamental pillar of our national development agenda," Shettima emphasised.

The project will be led by the Presidential Committee on Economic and Financial Inclusion in collaboration with the



Ministry of Women's Affairs.

Shettima urged both public and private sector stakeholders to use the conference as a platform for outlining actionable steps towards gender inclusion.

Chief Justice of Nigeria, Justice Kudirat Kekere-Ekun, underscored the importance of gender inclusion in sustainable development, emphasising its role in addressing poverty and fostering economic growth.

She affirmed that the judiciary would collaborate with stakeholders to protect women's rights, ensuring they have access to economic resources and property ownership.

# Nigeria unveils \$23.2bn energy access programme to close power gap

In a bold move to address Nigeria's significant electricity shortfall, the Federal Government has launched a transformative energy access programme aimed at revolutionising the nation's power sector.

The ambitious initiative, which has a target funding of \$23.2 billion, seeks to drastically improve electricity access across the country and boost the share of renewable energy in the national power mix.

According to a statement from the spokesman for the Minister of Power, Bolaji Tunji, the programme, led by Minister Adebayo Adelabu, is designed to tackle Nigeria's energy challenges and bring about sector-wide reforms.

A significant portion of the funds—\$15.5 billion—will be sourced from private sector investments, marking a crucial step towards collaborative development in the energy sector.

Tunji explained that the programme, named the National Energy Compact, aligns with the objectives of the recently concluded Mission 300 Africa Energy Summit held in Dar es Salaam, Tanzania.

The summit, attended by African leaders, business executives, and international development partners, focused on accelerating energy access for 300 million Africans by 2030.

The National Energy Compact aims to achieve several key goals, including increasing electricity access from 4% to 9% annually, boosting access to clean cooking solutions from 22% to 25%, and expanding renewable energy's share in power generation from 22% to 50%.

The programme will also mobilise \$15.5 billion in private investment for last-mile electrification efforts, contributing to the



global drive for universal access to modern energy services under the UN's Sustainable Development Goal 7.

Unveiling the programme, Minister Adelabu emphasised that the government remains committed to achieving universal energy access by 2030.

He pointed out that while 150 million Nigerians are currently electrified, the path to nationwide access will require overcoming numerous challenges, including the persistent issue of infrastructure vandalism.

Adelabu expressed particular concern over the increasing attacks on transmission towers, pipelines, and distribution equipment, which have severely disrupted power supply and discouraged potential investors.

To combat this, the government is ramping up efforts to secure power assets, including enhanced security measures, stricter penalties for vandals, and the adoption of advanced surveillance technologies.

"Protecting power assets is essential to ensuring a steady electricity supply and fostering investor confidence," Adelabu said, underscoring the importance of security in maintaining the momentum of Nigeria's electrification efforts.

The programme also calls for substantial investment in expanding power generation capacity, fortifying transmission and distribution networks, and incorporating renewable energy solutions across the country.

The \$23.2 billion funding target will play a critical role in strengthening Nigeria's energy infrastructure and accelerating the country's transition to cleaner, more sustainable power sources.

Recognising the scale of the challenge, the government is appealing to development partners, philanthropies, and private sector stakeholders to join the initiative and contribute to the nation's energy transformation.

"By implementing the National Energy Compact, Nigeria is positioning itself as a leader in Africa's energy transition, creating opportunities for economic growth, job creation, and industrialisation," Adelabu stated.

# Tinubu urges unified approach to Lake Chad security crisis **By Friday Omosola**

t the opening of the 5th meeting of the Lake Chad Basin Governors' Forum in Maiduguri yesterday President Bola Tinubu called for a multifaceted approach to the growing security challenges in the region, which has been plagued by terrorism, insurgency, and poverty.

Represented by Vice President Kashim Shettima, the Nigerian leader emphasised the need for not just military action.

He also addressed the root causes of insecurity, including poverty, inequality, and the lack of opportunities for young people in the region.

"While military power is indispensable, it must be complemented by strategies that tackle poverty, inequality, and unemployment," President Tinubu said.

"We must transform our demographic dividend into a force for good, not allow our youth to become cannon fodder for destructive ideologies."

The meeting, hosted by the Yobe State government, brought together eight governors from Nigeria, Cameroon, Chad, and Niger, as well as various international and local stakeholders.

The forum aimed to address the myriad challenges facing the Lake Chad Basin region and explore sustainable solutions for peace and stability.

President Tinubu stressed the importance of diplomacy and cooperation among the nations of the Lake Chad Basin, noting that hard power if detached from diplomacy and justice, risks widening the divide it seeks to bridge.

He also warned against allowing global geopolitical tensions to divide the region and urged leaders to remain committed to their shared goals for peace and development.

Yobe State Governor Mala Buni, the host of the event, reflected on the progress made since the inception of the Regional Strategy for Stabilization, Recovery, and



Resilience six years ago.

Governor Borno State, Babagana Zulum, praised the collaborative efforts of the forum's strategic partners, emphasizing that the platform serves as a vital tool for fostering political cohesion and regional development.

The forum also highlighted the environmental challenges facing the region.

Governor of Adamawa State, Umaru Fintri, pointed to the dramatic shrinkage of Lake Chad, which has decreased by 90 per cent over the past six years due to climate change, population growth, and agricultural activities.

During the meeting, the Executive Secretary of the Lake Chad Basin Commission, Ambassador Mamman Nuhu, emphasised that the forum's theme, "Rebuilding the Lake Chad Basin: Consolidating Gains, Commitment to Peace, Cross-Border Cooperation, Security, and Sustainable Development for a Resilient Community," reflects the region's progress as well as the significant work

still required.

Representatives from international organizations, including the British High Commission's Development Director Cynthia Rowe, also pledged continued support to the region, highlighting the return of displaced people to their homes as a sign of hope, though challenges like poverty, climate change, and complex crises persist.

The meeting was attended by several dignitaries, including the Chair of the Lake Chad Basin Governors' Forum, Ildjima Abdraman, and key Nigerian government officials, such as Senate President Ahmad Lawan, as well as military leaders and traditional rulers.

At the forum, participants were urged to enhance cooperation, continue supporting peace-building efforts, and tackle the region's challenges through collective action.

n a show of appreciation, the Federal Government on Thursday -donated N30 million to the family of the designer of Nigeria's national flag, late Taiwo Akinkunmi.

The Director General of the National Orientation Agency (NOA), Lanre Issa-Onilu, along with the Oyo State Director of the agency, Olukemi Afolayan presented the donation to the family at his residence in Elebu, Ibadan, on Thursday.

Issa-Onilu clarified that the N30 million donation was not intended to compensate for the late Akinkunmi's services but to support his family in recognition of his monumental contributions to Nigeria.

"I am aware, even though I wasn't appointed Director General of the NOA at that time, that the President gave a directive that this place should be visited and that the government must commiserate with this great Nigerian, and the Minister of Information with the then Director General of NOA came to commiserate with the family.

"The transition which led to my appointment and resumption, delayed the process of finalising the effort at showing appreciation to the family.

"Donation of N30m to the family of the renowned national flag designer was not to pay for the services of the late legend but to support his family in appreciation of his contributions to the country," Issa-Onilu said.

One of the patriot's sons, Akinwunmi Akinkunmi, expressed deep gratitude to President Bola Tinubu for the gesture.

The late flag designer, Akinkunmi

died on August 29, 2023, at the age of 87.

Following his death, President Tinubu sent a government delegation, led by the Minister of Information and National Orientation, Mohammed Malagi, to offer condolences.

Akinkunmi was buried in Ibadan, Oyo State capital in September 2024 after one year of waiting for the government to organise a befitting burial.

The funeral service was held at the Obafemi Awolowo Stadium, Liberty Road, Ibadan.

Akinwunmi, while speaking at the service, said the family was open to any manner the Federal Government deemed fit to immortalise the flag designer.

# Oluremi Tinubu donates N350m for movie promoting Kwara's culture

## Nigerian politicians steal, kill to remain in power - Amaechi By Friday Omosola

ormer Minister of Transport, Rotimi Amaechi, has cautioned Nigerians that political leaders will not easily relinquish power, warning that many are willing to go to extreme lengths to remain in office.

Speaking at a national conference on strengthening democracy in Nigeria—organised by the African Centre for Leadership, Strategy, and Development in Abuja—Amaechi stated that President Bola Tinubu would not hand over power to the younger generation without a struggle.

The former Rivers State Governor stressed that Nigerian politicians are deeply entrenched in power and will do whatever it takes to hold onto it, regardless of public demand for change.

Citing historical examples from Nigeria and Ghana, the emphasised that true political transitions have often come at a high cost, urging citizens to remain vigilant in the fight for democratic governance.

He said: "None of you here can defend the votes. If you have complained, complain, Nigerians have been clapping for you. The only way Ibrahim Shekarau became governor was because people lined up.

"It happened in Ghana before the election of the last president. Two days, many of us were called to intervene. Why? Because the people were ready to die. You are talking and abusing everybody. Nobody has power and will give it to you—not even me. If you want a pastor as president, go and get one.

"The politician in Nigeria is there to steal, maim, and kill to remain in power. If you



think Tinubu will give it to you, you are wasting your time."

Amaechi also shared his experience during the 2015 presidential election.

He attributed the APC's victory to the party leaders' unwavering determination to go above and beyond.

Amaechi, a lawyer further explained that President Goodluck Jonathan accepted defeat because the APC was fully prepared to defend its mandate.

This newspaper learned that this isn't the first time Amaechi has spoken harshly about politicians, particularly the administration of President Bola Tinubu.

In October 2024, Amaechi, who was one of the aspirants vying for the APC presidential ticket, expressed his disappointment with Nigerians for not taking action as the economic hardship deepened under Tinubu's leadership.

He criticised citizens for remaining passive as the country endured soaring fuel prices and escalating food inflation.

He urged Nigerians not to have allowed politicians to continue their electioneering campaigns while the nation suffered.

In an interview published by ABN TV, the former governor lamented the high cost of living in Nigeria, noting that even he could no longer afford diesel due to the prevailing economic struggles.

"I'm angry with the citizens. I've said it several times. You can see a group of people stealing your money, impoverishing you, and you cannot even buy fuel. The people should be angry. There should be protests—not against anyone specifically, but against the politicians, saying 'we won't vote."

Amaechi emphasised the dire situation, noting that if people like him couldn't afford basic necessities, the hardships faced by others without children would be unimaginable.

## 'Obidients' executed #EndSARS protest to stop Tinubu - Bisi Akande By Dave Oludare Oso

Former national chairman of the All Progressives Congress (APC), Chief Bisi Akande, has declared that the #EndSARS protest of 2020 was "manufactured" by the 'Obidient' movement to stop the presidential ambition of Bola Tinubu

'Obidients' are supporters of Peter Obi, presidential candidate of the Labour Party (LP) in the 2023 election.

A former governor of Osun State, Akande spoke in an interview with Edmund Obilo, which was posted on YouTube.

Chief Akande also claimed that the #EndSARS protest was conceived in and funded from the United States.

The former governor said, "EndSARS was aimed and designed to be the end of Tinubu. Those behind the EndSARS knew what they were doing.

"The Obidients were behind the EndSARS. It was manufactured from America just to stop Tinubu.

"The Obidients came from America to do EndSARS, which later became a movement. They could not form a party so they joined whichever party.

"It was well-planned and



organised with a lot of money from America."

The APC chieftain narrated how he persuaded Tinubu to contest the 2023 presidential election amid a paucity of funds.

He said Tinubu was reluctant to join the race ab initio.

"They called me and said, 'come, there is trouble. Anybody that talks to him about the presidency, he was quarrelling with them.'

"I was in Lagos so I met him. He said, 'Baba, do you have money? If I had the kind of money that people have to be president, I would rank with Dangote'."

The former governor said he told

Tinubu that he would not be running for the presidency for himself but for the Yoruba ethnic group.

In October 2020, Nigerians protested against police brutality —under the #EndSARS banner.

The #EndSARS protest sprung from decades-old brutality and extortion of young Nigerians at the hands of a notorious police unit called SARS — an acronym for the Special Anti-Robbery Squad.

SARS was disbanded as the protest gained momentum across the country.

## 5,000 repentant Boko Haram fighters reunite with families By Dave Oludare Oso



bout 5,000 repentant Boko Haram fighters have reunited with their families.

Disclosing this at the second-day session of the Lake Chad Basin Governors' Forum on Thursday, Head of Preventing and Countering Violent Extremism (PCVE), Amb. Mairo Musa Abbas stated that none of the former combatants returned to the battleground after six months of the deradicalisation programme.

Mairo, who spoke at the Third Penal with the theme, "Managing Boko Haram Exits and Demobilisation of Armed Groups," said harmonised strategy would help the governors of Lake Chad region to address their common issues.

She said deradicalisation, rehabilitation and reintegration

programme for ex-Boko Haram fighters, known as Operation Safe Corridor, had reintegrated over 5,000 repented Boko Haram into the society.

"Under Operation Safe Corridor programme, we have deradicalised over 5,000 ex-combatants of Boko Haram and reunited them with their families.

"They are using the skills they have acquired in the six months of deradicalisation programme in the camp to sustain themselves within the communities.

"Our collaborators from the National Orientation Agency (NOA) are within 774 local governments in Nigeria and traditional and religious leaders within the community they have monitoring mechanism where are able to monitor this mechanism and see

their progress after the reintegration within the community," she said.

Amb. Abbas added that the "Borno Model" a state-led strategy, which aimed at reintegrating individuals who left extremist groups like Boko Haram, had complemented the efforts of the federal government to promote peace in the country.

"We always said 'Borno Model' is a model of necessity but we have recorded a lot of success with the Model because many repented fighters, have been reunited with families," she added.

She, however, called on the governors in the Lake Chad region and stakeholders to harmonise their strategy to ensure that they work on the same level.

## Vicious kidnapper, Evans begs for mercy, says I've repented By Dave Oludare Oso

he most murderous kidnapper, who instilled fear into millions of Nigerians during his threeyear reign of terror, Chukwudimeme Onwuamadike, popularly known as Evans, made a passionate appeal for leniency to the Lagos State High Court in Ikeja, stressing that he has repented from his criminal activities.

The merciless and most vicious scoundrel, who was known to collect foreign currencies as ransom from his captives, told the court on Thursday, that he has applied to the Lagos State Government for mercy.

Evans, who addressed the court through his lawyer, Emefo Etudo, stated this after taking his plea on the amended five counts bordering on murder, attempt to murder, and conspiracy to commit kidnapping preferred against him by the Lagos State Government.

When the matter was called, the state prosecuting counsel, Sule Yusuf, informed the court that the matter was starting de novo and prayed the court to re-arraign the defendants.

Counsel who appeared on his behalf, Etudo, and his co-defendants, C.N Udeh, did not object to the request.

The prosecution alleged that on or about August 27, 2013, at about 10pm, along 3rd Avenue, FESTAC Town, in Lagos, Evans and Joseph Emeka killed one Peter Nweke.

They were also accused of allegedly killing one Chijioke Ngozi on the same day.



Evans and his co-defendant, Emeka, pleaded not guilty to the charges against them.

Following their not-guilty plea, Sule asked the court to further remand the defendants.

However, he informed the court that the first defendant (Evans) had applied for plea bargaining through Etudo, while the second defendant did the same through his counsel.

Etufo told Justice Adenike Coker that despite the amended charge and the plea of his client, he has applied to the Lagos State Government through the Attorney-General's office for a plea bargain.

He said: "Our focus in this matter is the plea bargain which we have submitted to the state government.

"My client is now a repentant person. He was a young man consumed by crime, but he is now remorseful. Presently, he is a 200-level student of the National Open

University.

"In fact, he made A1 in all his papers in NECO while in prison. All this was made possible through a scholarship given to him by the Federal Government.

"My Lord, we have asked the Lagos State Government to give him the opportunity to go around schools in the state to talk to youths about the dangers of crime."

Sule confirmed Evans' application for a plea bargain, saying that the appropriate committee will consider it.

He said, "My Lord, I can confirm that the first defendant ( Evans) has indeed applied for a plea bargain, and it was served on us. We shall be examining it. The second defendant has also made a similar application."

Following the submission of the lawyer, Justice Coker adjourned the matter to March 20, 2025, for possible trial.

international passport, but that too they will never have!"

The accompanying pictures and video showed that Sowore briefly joined the demonstrators, singing and holding a "Egbetokun Must Go" placard, before leaving.

## Okpebholo signs anti-cultism law, imposes stiffer penalties **By Friday Omosola**

do State Governor, Monday Okpebholo, has taken a firm and uncompromising stance against cultism with the passage and signing of the Secret Cult and Similar Activities (Prohibition) Law, 2025.

In a statement issued on Thursday by his Chief Press Secretary, Fred Itua, the governor emphasised that this move underscores his administration's commitment to restoring peace, security, and order in Edo State.

He stated that cultism has held communities hostage for too long. He noted that what was once confined to academic institutions has escalated into a dangerous social menace, threatening lives, disrupting businesses, and undermining the state's progress.

The governor explained that after studying the devastating impact of cultrelated violence, his administration took urgent and necessary steps to enact a law that imposes stiffer penalties on anyone involved in, sponsoring, or facilitating cult activities.

According to him, the new law prescribes 21 years imprisonment for individuals who financially or materially sponsor cultism. It also provides for 10 years of imprisonment and property demolition for those who harbour cultists or allow their property to be used for cult-related activities.

Additionally, the law stipulates 21 years imprisonment for cultists involved in assault, injury, or property destruction.

It further imposes the death penalty for those responsible for killings in furtherance of cult activities.

Okpebholo stressed that these measures are not intended to intimidate law-abiding citizens but rather to serve as a strong deterrent to those who threaten the peace and security of Edo State.

"This law is not just about



punishment—it is about protecting lives and securing the future of Edo State. Cult activities have robbed many young people of their potential, turning them into instruments of violence rather than contributors to society.

"With this legislation, Edo people are taking Edo State back from the hands of criminals and ensuring that families, businesses, and communities can thrive without fear", he noted.

He stated that the demolition and confiscation of properties linked to cult activities are deliberate measures to ensure that crime does not pay.

He further emphasised that those who aid and abet cultism will no longer find refuge in Edo State, declaring that the government is sending a clear message: "Edo State is for law-abiding citizens, not for criminals."

According to him, the success of the law depends not only on enforcement but also on public cooperation.

He urged all residents to report cultrelated activities to law enforcement agencies and to discourage youth involvement in cultism by promoting positive alternatives such as education,

#### GOVERNMENT SPECIAL ANNOUNCEMENT

It is hereby announced for the information of the General Public that the Edo State Secret Cult (Prohibition Law) 2018 has been repealed by the Edo State House of Assembly.

By virtue of the repeal, the Secret Cult and Similar Activities (Prohibition) Law, 2025 has been passed by the Edo State House of Assembly and signed into Law by the Governor of the State, His Excellency, Senator Monday Okpebbolo effective from 24th January, 2025.

Please, be informed that in the new Law, there is provision for stiffer penalties for anyone found guilty of secret cult related offences in the State.

Section 5 of the Law provides for twenty-one (21) years imprisonment for financial and material sponsors of secret cults.

Section 6 of the Law provides for ten (10) years imprisonment for those who knowingly habour members of a secret cult or permit a secret cult meeting or activities to be held in house building or place over which they have control. In addition to the ten (10) years imprisonment such persons will have their properties confiscated and demolished by the State Government.

Section 12 of the Law clearly states that, "Any person being a cultist under Section 4, who assaults, injures, maims, or kills any person (s) or destroy any property in furtherance of the activities of any Secret Cult, is guilty of an offence and is liable to Twenty-One (21) years imprisonment without an option of fine and in the case of any fatality, the perpetrator (s) shall be liable to death upon conviction and any properties in his name as

skills acquisition, and legitimate career paths.

"While the Government will deal decisively with criminal elements, we also recognize the need for rehabilitation and social reintegration for those willing to renounce cultism. Now, it is up to all of us—Government agencies, security operatives, community leaders, parents, and citizens—to work together to ensure the full implementation of this new law.

"Alhaji Rilwanu Yahaya, who also served as Councillor in charge of Health Related Matters, passed away while attending a program alongside His Highness, the Emir of Zazzau, Malam Ahmed Nuhu Bamalli, CFR, at Hajiya Gambo Sawaba General Hospital, Kofan Gayan, Zaria this morning." The statement added.

The remains of the late Sarkin Yakin Zazzau, Alhaji Rilwan Yahaya Pate has since been buried at Rimin Dodo later in the evening, Thursday.

In his condolence message, the Emir of Zazzau, Mallam Ahmed Nuhu Bamalli described the death as "the will of Allah" stating that "death is inevitable and can come whenever Allah destined."

The Emir who consoled the family of the deceased described the late Sarkin Yakin Zazzau as hardworking, dedicated and very religious whose vacuum will not easily be replaced.

He prayed for the soul to have an eternal life rest.

# Suspected herdsmen kill five farmers in Ondo community By Elizabeth Jenrola Oso

unmen suspected to be herdsmen have killed five people in the Ajegunle-powerline community, Akure North LGA of Ondo State.

According to an eyewitness and a member of the community, Akin Olowolafe, the suspected herders attacked a farm in the community with guns.

Olowolafe identified the victims of the attack as farm labourers hired from Plateau and Kaduna states, saying, "The incident happened around 3pm on Tuesday. They shot sporadically, killing five of our workers. This is how they usually come to disturb and destroy our crops.

"On several occasions, we've reported



them to the state government and even to security agencies but no positive actions were taken to curb their illegality."

Olowolafe said the incessant attacks in the area have made life unbearable for members of the community. He added that many farmers have deserted their farms for fear of being killed.

Funmilayo Odunlami-Omisanya, spokesperson of the police command in Ondo, confirmed the incident, disclosing that the police have commenced an investigation.

"There was an attack on the community, and police are still investigating. But I cannot confirm the number of people that were killed," she said.

Men of the hunters and vigilantes association in Akure north LGA have deposited the bodies of the victims at the morgue of the University of Medical Sciences Teaching Hospital (UNIMETH) in Akure.

# Makinde mandates Oyo workers to wear Aso Oke every Thursday

overnor Seyi Makinde of Oyo State has directed all civil and public servants in the state to wear native attires with a touch of traditional 'Aso Oke' every Thursday, in addition to the existing native Friday tradition.

The announcement of the approval of the new dress code was contained in a circular issued by the Office of the Head of Service to heads of ministries and agencies on January 27, 2025.

The directive stated, "Every Thursday and Friday, our workforce will become ambassadors of tradition and catalysts for economic transformation."

According to the circular, the policy "is not just about dressing; it's a strategic effort to validate our cultural identity while uplifting grassroots economies."

It is also aimed at preserving the Yoruba culture, empowering local artisans, boosting the informal economy, as well as showcasing and preserving the state's vibrant cultural heritage.

The governor also stated that the directive will support local weavers, dyers, and tailors, thereby "sustaining livelihoods, reducing



unemployment, and increasing income streams for artisans."

He stated that his administration projects that the directive will increase demand for the fabrics, enhance growth in the informal sector, bolster tourism, and foster inclusive development.

Aso-Oke, meaning "top cloth" in Yoruba, has long been a symbol of prestige, traditionally woven from cotton or silk and worn for significant ceremonies such as weddings and chieftaincy titles. However, in recent years, it has gained global recognition, with luxury fashion designers incorporating it into highend clothing lines and accessories.

Beyond its cultural significance, Aso-Oke is also a sustainable fabric, made from natural materials with minimal industrial waste.

The Aso-Oke industry currently supports over 50,000 artisans across key weaving hubs like Iseyin, Oyo, and Ilorin. The intricate handwoven process, which can take up to three weeks depending on the design's complexity, continues to drive economic growth.

In 2023 alone, Aso-Oke exports rose by 15%, generating approximately \$120 million in foreign exchange revenue.

As the sustainable fashion industry is projected to reach \$12 billion by 2028, Aso-Oke has the potential to become Nigeria's next major export success.

# Naira climbs up against dollar with 0.78% at official market

he Nigerian Naira experienced a notable appreciation against the US dollar in official trading on Wednesday.

#### Naira against dollar

The currency closed at N1,510.72 to \$1, a gain of N11.96, or 0.78%, compared to Tuesday's closing rate of N1,522.68. Data from the FMDQ Security Exchange, the official platform for forex trading, confirmed this positive movement.

Within the Investors and Exporters (I&E) forex window, trading fluctuated between a high of N1,514.00 and a low of N1,504.00 throughout the day.

This strengthening of the Naira builds upon a period of relative stability observed since December 2024. This period of steadiness followed the implementation of a series of sweeping reforms by the Central Bank of Nigeria (CBN).

The CBN has continued its efforts to bolster the local currency. The financial institution also introduced further measures on Tuesday in Abuja. Among the newly introduced initiatives are waivers on the 2025 annual license renewal fees for all existing Bureau De Change (BDC) operators.



This move is intended to ease the operational burden on these businesses. Furthermore, the CBN unveiled the Nigeria Foreign Exchange (FX) Code.

This code is a key component of the CBN's ongoing reform efforts and is designed to instill greater transparency and ethical conduct within the banking industry, bringing practices in line with international standards.

Dr. Aminu Gwadabe, President of the Association of Bureau De Change Operators of Nigeria (ABCON), expressed his appreciation for the CBN's recent actions. He also specifically highlighted the positive impact of the license fee waiver for BDC operators.

He emphasized the importance of

collective support and adherence to the CBN's ongoing reforms to ensure the continued stability of the Naira.

Gwadabe also lauded the introduction of the Nigeria FX Code, believing it will be instrumental in addressing persistent challenges in the forex market.

He pointed out that the code has the potential to mitigate issues such as a lack of transparency in transactions, destabilizing rate wars among market participants, and delays in the submission of required reports on spot transactions.

He anticipates that these measures will contribute to a more orderly and efficient foreign exchange market.

## US plane crash: No survivors found, 30 bodies recovered By Dave Oludare Oso

bout 30 bodies have been removed from the wreckage caused by a mid-air crash between a passenger plane and a helicopter in Washington.

The American Airlines regional jetliner was carrying 60 passengers and four crew when it collided with a US Army Black Hawk helicopter near Reagan Washington National Airport, plunging the aircraft into the Potomac River, Press TV reported.

Washington, DC Fire and EMS Chief, John Donnelly said at a press conference on Thursday that a huge rescue operation had been launched, but no survivors are expected from the crash.

He said first responders worked throughout the night to recover bodies and search for survivors despite the tough working conditions due to the plane falling into the Potomac River.

However, till now the rescue workers had not found any survivors and were able to only recover 30 dead bodies, one of which was from the helicopter.

He said the responders' operation moved from "rescue" to "recovery" as it became clear that "no one onboard the plane was likely to survive the crash."

"At this point, we don't believe there are any survivors from this accident."

News agencies reported that a renowned Russian figure skating couple, who worked as coaches in the US and were traveling with a group of young skaters, had been aboard the American Airlines plane.

The US authorities said the plane broke into three pieces and fell into about 7ft of



water in the river alongside the helicopter.

Trump furious, says US in mourning

In his reaction, President Donald Trump said the mid-air collision could have been prevented.

Speculating the cause of the crash, he said, "The helicopter was going straight at the airplane for an extended period of time."

According to him, the passenger aeroplane had been on a perfect and routine line of approach to the airport before the crash.

"It is a CLEAR NIGHT, the lights on the plane were blazing, why didn't the helicopter go up or down, or turn? Why didn't the control tower tell the helicopter what to do instead of asking if they saw the plane? This is a bad situation that looks like it should have been prevented. NOT GOOD!!!" Trump posted on Truth Social early Thursday morning.

However, American Airlines' chief executive, Robert Eisen, said the cause of the collision is still unknown.

"At this point we do not know why the military aircraft came into the path of the PSA aircraft," he said, adding that the pilot was "experienced", with six years at the airline.

The Ronald Reagan airport was closed following the crash.

Meanwhile, experts say numerous safety defects leading to crashes in Americanmade airliners indicate a decline in production standards in US airplane manufacturing plants.

Boeing, the flagship American manufacturer of commercial airliners, posted a fourth-quarter loss of \$3.8 billion on Tuesday amid continued machinists' strikes and other problems at its plants.

Whistle-blowers' mysterious deaths

Two Boeing whistle-blowers, who warned about manufacturing defects in its planes, have been found dead in the US after making their revelations.

## Trump freezes \$50m approved by Biden for 'condoms in Gaza' By Dave Oludare Oso

he Trump Donald administration has put a freeze on federal funding, including \$50 million originally earmarked for condom distribution in Gaza.

White House Press Secretary, Karoline Leavitt said the expenditure was discovered in Trump's first week, including by the new Department of Government Efficiency (DOGE) led by tech billionaire, Elon Musk.

Musk's initiative and the budget office "found that there was about to be 50 million taxpayer dollars that went out the door to fund condoms in Gaza," Leavitt told her debut press conference.

That is a preposterous waste of taxpayer money," she said.

She did not provide more details and it was not immediately possible to verify the account independently.

Condoms generally cost less than one dollar each in the United States and much less in bulk. Just over two million people live in Gaza, nearly all of which has been heavily damaged in the 15-month war with Israel.

Leavitt also said that the United States was about to dispense \$37 million to the World Health Organization (WHO) before Trump announced a pullout from the UN body.



Quickly after taking office, Trump ordered a 90-day freeze in foreign assistance.

He has vowed a review to ensure that aid conforms with policies of his administration, which opposes abortion, transgender rights and diversity programmes.

Unfortunately, what Leavitt said about the alleged condom shipment doesn't match what the government has said about its aid efforts in Gaza.

A September 2024 U.S. Agency for International Development report says not one dollar of the \$60.8 million used to fund condoms and contraceptives distributed by the agency worldwide was allocated to the Palestinian territory.

The same report shows that the only contraceptives sent to the Middle East were distributed to the Jordanian government in the form of \$45,680 worth of oral and

injectable medications — not condoms.

Andrew Miller, the ex-Biden administration State Department official who served as deputy assistant secretary for Israeli-Palestinian affairs, told The Times of Israel on Wednesday that Leavitt's claim was "outlandish" and "a feverish dream" on the part of the new administration.

"It's possible that \$50 million is put aside for sexual health or something of that nature, which would include gynecology and many other services, but definitely not condoms alone," he said.

Musk, who is also the owner of X, posted that the false condom expenditure was the "tip of the iceberg" for waste and claimed that "a lot of that money ended up in the pockets of Hamas."

There is no evidence to support either of those assertions.

# American Airlines jet, Army helicopter collide, crash into Potomac River

tragic mid-air collision between an American Airlines regional passenger jet and a U.S. Army Black Hawk helicopter sent both aircraft crashing into the Potomac River near Reagan Washington National Airport late Wednesday night, officials confirmed.

According to The Washington Post, multiple bodies have been recovered from the river. Reuter reported that Senator Ted Cruz of Texas stated on social media that "we know there are fatalities," but the exact number remains undisclosed.

The PSA Airlines regional jet, operating as American Eagle Flight 5342, was en route from Wichita, Kansas (ICT) to Washington Reagan National Airport (DCA) when it collided with the helicopter mid-air. The U.S. Federal Aviation Administration (FAA) confirmed that the collision occurred as the jet was making its approach to the airport.

The passenger jet had 60 passengers, along with two pilots and two crew members on board, an American Airlines source told Reuters. Meanwhile, the Black Hawk helicopter was carrying three soldiers, according to a U.S. defense official.

Emergency response teams swiftly mobilized as multiple agencies launched a search and rescue operation in the Potomac River. Live TV footage showed dozens of police, ambulance, and rescue boats with flashing lights combing the river for survivors.

According to Reuter, at least four people have been pulled alive from the wreckage. However, there is no official confirmation regarding their conditions.

A webcam shot from the Kennedy Center in Washington captured the moment of impact, showing a mid-air explosion at



8:47 PM ET, followed by a fireball as one of the aircraft plunged into the river according to the Reuter.

Reagan National Airport temporarily suspended all takeoffs and landings as emergency personnel responded to the crisis. The National Transportation Safety Board (NTSB) stated that it is gathering further details on the crash.

American Airlines released a statement acknowledging reports of the incident and assured the public that it would provide updates as more information became available.

This incident adds to a growing list of aviation accidents and near-miss events that have raised concerns about global air safety. Over the past 30 days alone, several major incidents have occurred worldwide:

United Airlines Flight 613 Incident (January 27, 2025) – A Boeing 787 experienced severe turbulence over Ivory Coast airspace, injuring several passengers and crew.

Jeju Air Flight 2216 Crash (December 29, 2024) – A Boeing 737-800 overran the runway in South Korea, killing 179 out of 181 passengers.

Azerbaijan Airlines Flight 8243 Crash (December 25, 2024) – An Embraer 190 crashed during an emergency landing in Kazakhstan, with reports suggesting it was hit by a Russian air defense system.

Swiss International Air Lines Flight 1885 Diversion (December 23, 2024) – A Bucharest-Zurich Airbus A220 made an emergency landing after cabin smoke filled the aircraft; one crew member later died from injuries.

Piper PA-42 Cheyenne Crash in Brazil (December 22, 2024) – A small aircraft crashed after takeoff from Canela Airport, killing 10 people and injuring 17 on the ground.

20 killed in South Sudan plane crash on Wednesday 29, January 2025

Authorities are now working to determine what caused the mid-air collision near Reagan Airport and whether air traffic control errors, mechanical failure, or pilot miscommunication played a role in the accident.

This developing story continues to highlight urgent concerns in aviation safety, reinforcing the need for rigorous maintenance, stricter safety protocols, and improved air traffic control measures to prevent future tragedies.

## Trump says U.S. will hold migrants at Guantánamo By Erica L. Green contributed reporting from Washington

he president suggested 30,000 migrants could be housed on the base. It is unclear how the plan will take shape.

President Trump on Wednesday ordered his administration to prepare to house tens of thousands of "criminal aliens" at the Navy base at Guantánamo Bay, the latest prong in his widening crackdown on immigration.

Mr. Trump did not offer details on how the plan would take shape, but he instructed the Departments of Defense and Homeland Security to get the site ready.

"We have 30,000 beds in Guantánamo to detain the worst criminal illegal aliens threatening the American people," he said. "Some of them are so bad we don't even trust the countries to hold them, because we don't want them coming back, so we're going to send them out to Guantánamo."

He said the move would "double our capacity immediately," adding that Guantánamo was a "tough place to get out of."

In recent weeks, about 40,000 immigrants have been held in private detention centers and local jails around the country as funding constraints have limited the number of detention sites.

Adding 30,000 beds would dramatically expand the government's detention capacity. A site on the 45-square-mile base could hold those 30,000 deportees. That site is on the opposite side of the body of water called Guantánamo Bay from the Pentagon's prison for terrorism suspects.

Successive administrations have prepared fields on a remote section, near the airfield but far from the population center, to accommodate tens of thousands of migrants in a sprawling tent city.



The infrastructure was set up starting in the mid-2000s to shelter Cubans and others from the region who had been intercepted while fleeing their country. The Clinton administration had tasked Guantánamo with the role in the 1990s. It was designed as a humanitarian relief operation.

It was not immediately clear how such an operation under Mr. Trump would be staffed, secured and what rights, if any, the deportees would have at Guantánamo Bay. Civil liberties groups expressed concerns.

Vincent Warren, executive director of the Center for Constitutional Rights, said Mr. Trump's order sent a dark message that "migrants and asylum seekers are being cast as the new terrorist threat, deserving to be discarded in an island prison, removed from legal and social services and supports."

Mr. Trump's memo called for expanding the Migrant Operations Center, which currently occupies a small former barracks that has had capacity for up to 120 migrants but in recent years held at most dozens at a time. It is near empty fields that could be transformed into a tent city.

Tom Homan, Mr. Trump's border czar, told reporters outside the White House on Wednesday that certain migrants could

be flown to the island, and that the operation would be run by Immigration and Customs Enforcement, known as ICE.

"The worst of the worst, the significant public safety threats we can fly them," he said.

U.S. military and Homeland Security forces have periodically rehearsed how to handle a migrant crisis at the site.

In the 1990s, the base was overwhelmed by more than 45,000 people fleeing crises in both Haiti and Cuba. They were housed in crude tent cities on the populated side of the base, including on the current site of the Pentagon's detention facility for detainees in the war against terrorism. Today, that facility houses 15 prisoners and is staffed by 800 troops and civilians.

Starting with the George W. Bush administration, the government created a new footprint for a future humanitarian relief operation on the mostly empty side of the base.

During semiannual drills for a humanitarian relief operation, the Southern Command typically flew in a few hundred soldiers from Fort Sam Houston in San Antonio to play different roles.

## Porn star plunges to death while filming threesome with 2 men By Elizabeth Jenrola Oso

porn star has plunged to her death from a Brazilian hotel balcony after she invited two men to take part in a filmed threesome.

Brazilian adult content creator, Anna Beatriz Pereira Alves, known online as Anna Polly, was found lifeless in a courtyard at an aparthotel in Nova Iguacu, roughly 25 miles northwest of Rio de Janeiro.

The OnlyFans model, whom local media reports was 23, is believed to have fallen as she was filming X-rated scenes with the two men for the adult content site.

Authorities have launched an investigation to determine the circumstances of Alves' death.

Reports indicate that the two individuals



present with her at the time provided conflicting accounts, and no arrests have been made.

Police are reviewing security footage from the hotel and have interviewed staff as part of their inquiries.

Alves' phone has been collected as evidence, and a post-mortem examination is underway to provide further clarity. Investigators are considering all possibilities, from an accidental fall to potential foul play.

A spokesperson for the Baixada Fluminense Homicide Unit emphasised the complexity of the case, stating, "We are conducting a thorough investigation to clarify what happened. All possibilities remain open at this stage."

Pedro Henrique, Alves' partner, expressed deep sorrow over her loss, stating, "She died in the fall. There was no time to save her. If someone is to blame, they will be held accountable."

In a social media post, Henrique shared his grief, writing, "It's so difficult without

Around 1,000 women are killed in Pakistan by close relatives, fathers,

brothers, and sons on the pretext of saving family honour, according to the Human Rights Commission of Pakistan (HRCP).

Human rights body, Amnesty International lamented that the killers in most cases, escape prosecution because of a controversial Islamic clause in laws that allows relatives of victims to pardon the perpetrator.

Pakistan approved a law in 2016 to partially do away with the controversial clause, but that has not proved enough to stop the practice, according to the HRCP.

# Meta to pay \$25m for Trump's Facebook, X ban By Elizabeth Jenrola Oso

ark Zuckerberg, the owner of Meta, formerly called Facebook and X has agreed to pay \$25 million in settlement of a lawsuit filed by President Donald Trump challenging the suspension of his (Trump) Facebook and X accounts.

Meta and X (then called Twitter) both banned Trump from both platforms following the January 6, 2021, Capitol riot.

Protesters had turned out in support of Trump at the US Capitol, to overturn former President Joe Biden's victory in the elections.

Meta banned him for at least two years, citing his posts as a catalyst for violence and a threat to public safety.

Likewise, X, formerly Twitter, barred Trump for similar reasons.

In response, Trump sued Meta and X in 2022, claiming their actions c on stituted "illegal, unconstitutional censorship" and violated his First Amendment rights.

He also sought to overturn Section 230 of the Communications







Decency Act, which shields social media companies from liability for content posted by users.

Prior to his ban, he had frequently criticised Meta as an "anti-Trump" platform.

Trump returned to Twitter in 2022 and regained access to Facebook in 2023.

In July 2024, Meta lifted the final restrictions on his accounts in the lead-up to the US presidential election.

According to The Wall Street Journal, a Meta spokesperson confirmed the \$25 million settlement, out of which \$22 million was allocated to Trump's presidential library and the remaining sum covering legal fees and going to other plaintiffs who signed on to the lawsuit.

Trump's win in November 2024 seemed to mark the beginning of a more cooperative relationship between him and Mark Zuckerberg, the owner of Meta.

After the president's victory, Zuckerberg visited Mar-a-Lago, Trump's Florida resort.

Shortly after, Meta announced a policy shift, easing restrictions on political content across its platforms.

The company also donated \$1 million to Trump's inauguration fund, and Zuckerberg attended the ceremony on January 20.

# Trump blames diversity hiring for Washington DC Plane crash

resident Donald Trump has linked the fatal mid-air collision between a military helicopter and a passenger jet in Washington, D.C., to what he called a diversity hiring spree in the aviation industry. The crash, which occurred near Ronald Reagan National Airport on Wednesday evening, resulted in 67 deaths, with no survivors.

During a press briefing, Trump criticized the Biden administration, alleging that FAA diversity hiring policies had compromised safety standards. He claimed that the agency had reduced qualification requirements in an effort to increase diversity, hiring employees with "severe intellectual and psychiatric disabilities" as air traffic controllers.

"I put safety first," Trump stated. "Obama, Biden, and the Democrats put politics ahead of policy, and this was the lowest level of decision-making we've seen."

The UH-60 Black Hawk helicopter collided with American Airlines Flight 5342, which was on final approach to Runway 33 at Reagan National Airport around 8:47 PM (local time). The passenger jet, which had departed from Wichita, Kansas, and the military aircraft both plunged into the icy Potomac River, killing all 67 people on board. Recovery teams have since been working to retrieve the bodies of the victims, with no survivors found.

Apreliminary FAA report obtained by The New York Times indicated that staffing at the air traffic control tower was "not normal" at the time of the crash. The report revealed that the controller



responsible for helicopters in the airport's vicinity was also handling landing and departing planes, a task typically assigned to two separate controllers. This revelation has raised questions about whether controller workload and air traffic mismanagement played a role in the tragedy.

When asked why he linked the crash to diversity hiring, Trump responded: "Because I have common sense, and unfortunately, a lot of people don't."

The crash claimed the lives of all crew members and passengers on both aircraft. Among the victims were highly trained pilots and military personnel with years of aviation experience.

American Airlines Flight 5342 was piloted by Captain Jonathan Campos, 34, a seasoned pilot born in New York and raised in Florida. Campos was certified as an instructor in 2017 and became a commercial airline pilot in 2018 after attending the Epic Flight Academy. His first officer was Samuel Lilley, 29, a Savannah, Georgia native, who had

recently gotten engaged and was just months away from a promotion to captain. His father, Timothy Lilley, a former military pilot, confirmed his background and expressed deep grief over his loss.

The U.S. Army Black Hawk Helicopter was piloted by Andrew Eaves, a U.S. Army pilot with extensive military flight experience. Crew Chief Ryan O'Hara, a Georgia native, was also among the victims. Authorities have not publicly disclosed specific details regarding the ethnic or diversity backgrounds of the pilots involved.

Trump cited an FAA special emphasis recruitment program, which promoted the hiring of individuals with hearing and vision impairments, missing extremities, paralysis, epilepsy, intellectual disabilities, psychiatric conditions, and dwarfism. Reports indicate that these guidelines were updated in March 2022 under the Biden administration. Last week, Trump signed an executive order banning Diversity, Equity, and Inclusion (DEI) policies and ordering a return to merit-based hiring within the FAA.

Trump announced that a "systematic and comprehensive investigation" into the crash would be conducted by the FAA, the National Transportation Safety Board (NTSB), and the U.S. military. He also suggested that pilot error from the military helicopter may have played a role in the collision, stating that the Black Hawk had done "the opposite of what it was told" and questioning why both aircraft were at the same altitude. He praised the American Airlines pilot, saying they had followed all protocols.

# Steven Gerrard departs Al-Ettifaq after 18 months in charge By Timi-Zacchaeus Oluwaferanmi

teven Gerrard has stepped down as head coach of Al-Ettifaq by mutual consent after 18 months at the helm. The former Rangers and Aston Villa manager, who took over the Saudi Pro League side in July 2023, departs following a string of disappointing results that have left the team hovering five points above the relegation zone.

Despite signing a two-year contract extension in January 2024, which was set to keep him at the club until 2027, Gerrard's tenure has been cut short after managing only five wins in 17 league matches this season. Al-Ettifaq currently sits in 12th place in the 16-team league.

Reflecting on his departure, Gerrard expressed gratitude for the opportunity to work in Saudi Arabia.

"Football is unpredictable, and sometimes things don't go the way we want," he said. "However, I leave with great respect for the club and the country. I have no doubt that the work being done will bring success in the future, and I wish the team the very best for the rest of the season."

Gerrard also acknowledged the warm welcome he received and the learning experience he gained. "From the first day, I was warmly welcomed, and I have enjoyed the chance to work in a new country with a different culture. Overall, I have learned a lot, and it's



been a positive experience personally and for my family as well."

Club President Pays Tribute

Al-Ettifaq's club president, Same Al Misehal, praised Gerrard's impact on the team despite the challenges.

"Sometimes things don't go as planned, but the firm foundations he helped build will guarantee a bright future in the long term," Al Misehal stated. "He changed the club for the better, and that will never be forgotten. This decision, made with mutual respect and in agreement, is in the best interest of both Steven and the club as we move forward."

A Mixed Managerial Journey

Gerrard, 44, began his managerial career with Rangers in 2018, leading the club to its first Scottish Premiership title in a decade in the

2020-21 season. His success in Scotland earned him a move to Aston Villa in November 2021, but he was dismissed after just 11 months, securing only 13 wins in 40 matches.

In his first season with Al-Ettifaq, Gerrard guided the team to a respectable sixth-place finish. However, results have faltered this term, with only five victories from 17 matches. His overall record with the club stands at 23 wins in 59 games.

Gerrard was reportedly one of the highest-paid managers in the world during his stint in Saudi Arabia, earning an estimated £15 million per year.

As Al-Ettifaq seeks a new managerial direction, Gerrard now finds himself at a crossroads in his coaching career, with speculation likely to grow over his next move in football management.

Player representatives from Fifpro have met with Fifa to address growing concerns over fixture congestion, which has led to the threat of strike action from players.

The discussions centered on the expanded 32-team Club World Cup set to take place in 2025. While Fifa President Gianni Infantino expressed a willingness to collaborate, sources indicate that mounting pressure from players and unions pushed Fifa into negotiations.

Manchester City midfielder Rodri and other leading players have been vocal about the strain caused by the packed schedule. With clubs like Chelsea and Manchester City set to participate in the tournament, concerns over adequate rest periods and the ability to prepare for the 2025-26 season remain key issues.

The increased number of matches and tighter scheduling have raised fears over player welfare. Many top footballers already face a grueling season, competing in



domestic leagues, cup competitions, and international tournaments. The additional burden of a lengthened Club World Cup further limits opportunities for recovery and training, potentially impacting player performance and increasing injury risks.

Additionally, financial considerations play a crucial role in the dispute. Exact prize money for the Club World Cup has yet to be disclosed, but European clubs are expected to demand significant sums to compensate for their inability to conduct lucrative preseason tours. Some club executives have expressed concerns that the tournament will

negatively affect their commercial revenue streams and preseason marketing opportunities.

Furthermore, the scheduling conflicts with domestic leagues have prompted questions regarding fixture rescheduling and workload management. Clubs are particularly concerned about the overlap with early domestic competitions, such as England's Community Shield, which is set to take place in early August 2025.

Fifpro has reiterated its stance that players should be granted adequate rest periods between seasons. Under current Fifa regulations, players are entitled to a minimum three-week break, yet the congested schedule may make that difficult to enforce.

Further talks are expected as players seek guarantees on scheduling reforms and compensation for additional commitments. The outcome of these discussions could have significant implications for the future of international club competitions and player welfare.

### Hamilton crashes Ferrari in pre-season testing By Timi-Zacchaeus Oluwaferanmi

ewis Hamilton has crashed his Ferrari during the team's preseason testing in Spain. The seven-time world champion lost control of the 2023 car at the Circuit de Barcelona-Catalunya but emerged unscathed.

Ferrari declined to comment on the incident, which occurred during Hamilton's second day of testing alongside teammate Charles Leclerc. The team views the crash as a normal part of Hamilton's adaptation process after 12 years with Mercedes.



With F1's strict testing restrictions,

Hamilton is limited to running older cars. He completed 30 laps at Fiorano before moving to Barcelona for a three-day session. Ferrari's priority is integrating Hamilton into their systems before the season opener at the Australian Grand Prix in March.

Ferrari will launch their 2025 car on 19 February at Fiorano, following a Pirelli-run tyre test next week. Hamilton will receive further testing miles to refine his understanding of the car and the team's operations.
