## Tinubu departs Abuja for France ahead of AU summit in Ethiopia

resident Bola Tinubu will depart Abuja on Wednesday for Paris, France, on a private visit before proceeding to Addis Ababa, the Ethiopian capital.

Bayo Onanuga, Tinubu's Special Adviser on Information and Strategy, confirmed this in a statement today.

In Addis Ababa, the President will join African leaders at the 46th Ordinary Session of the Executive Council and the 38th Ordinary Session of the Assembly of the AU Heads of State, scheduled for February 12th to 16th, 2025.



The president is expected to arrive in Addis Ababa early next week for the African Union summit.

While in France, he will meet with his French counterpart, President Emmanuel Macron.

### Alake secures funding for critical minerals study facility in Nigeria By Friday Omosola

he Minister of Solid Minerals, Dele Alake, has secured funding for a study facility aimed at developing a comprehensive roadmap for Nigeria's critical minerals value chain, from extraction to beneficiation.

The Minister made the announcement on his X page on Wednesday, revealing that the funding was secured during the prestigious Mining Indaba event in Cape Town, South Africa.

Alake emphasised that the initiative will be supported by the Global Council for Critical Minerals, a specialized body within Sustainable Energy for All, a United Nations agency dedicated to advancing the Agenda for Sustainable Development.



He said the collaboration is expected to boost Nigeria's position in the global mining sector while driving sustainable growth and development.

"While discussing this initiative with Mr Divyam Nagpal, the Principal Specialist in Renewable Energy at Sustainable Energy for All, I thanked him for their support and highlighted how it will enhance Nigeria's solar power policy.

"I also reviewed the progress made by President Bola Tinubu's administration in the mining sector, assuring them that the investment climate in Nigeria is positive and welcoming", Alake said.

Furthermore, he emphasised that if investors could operate in an unrestricted environment, their profit margins would increase, enabling them to meet their obligations to the government, including paying royalties.

## Tinubu increases 2025 budget to N54.2trn By Friday Omosola

resident Bola Tinubu has increased the proposed 2025 budget from N49.7 trillion to N54.2 trillion, attributing the rise to additional revenues from key government agencies.

The revised figures were communicated in separate letters sent to both the Senate and the House of Representatives.

Senate President Godswill Akpabio read the letters aloud during today's plenary session.

According to President Tinubu, the budget adjustment reflects an extra N1.4 trillion from the Federal Inland Revenue Service (FIRS), N1.2 trillion from the Nigeria Customs Service (NCS), and N1.8 trillion from other government-owned agencies.

Following the announcement, the Senate President referred the proposal to the Senate Committee on Appropriations for urgent review.

He assured lawmakers that the final budget would be approved before the end of February, prompting expectations that the National Assembly will expedite deliberations for the timely implementation of the 2025 budget.

Tinubu minister explains budget increment

Minister of Budget and National Planning, Senator Atiku Bagudu, explained that the increment was to allow for the approval of more revenue to strengthen the Bank of Agriculture



and Bank of Industry.

Bagudu said the increase was also to support the administration's diversification programme by putting more money in the solid minerals sector as well as infrastructure projects.

However, a member of the House of Representatives, Hon. Kingsley Chinda, faulted the procedure for the increment.

Chinda said the presentation from the executive should not have come in the form of a letter.

Tinubu's letter was read during plenary in the Senate by Senate President Godswill Akpabio, and in the House of Representatives by Speaker Tajudeen Abbas.

Tinubu attributed the N4.53 trillion added to the appropriation bill to an increment in revenues recorded by some revenue-generating agencies of the federal government.

He said the increase arose from N1.4

trillion additional revenues made by the Federal Inland Revenue Service (FIRS); N1.2 trillion made by the Nigeria Customs Service; and N1.8 trillion generated by some other Government-owned Agencies (GOEs).

The Ministry of Solid Minerals Development was the highest beneficiary of the additional revenues, as it got N1 trillion.

The ministry, which has Mr. Dele Alake as minister, initially had N6 billion envelope from the Budget Office for the 2025 fiscal year before the National Assembly joint committee on Solid Minerals increased it to N9 billion.

The president of the senate after, reading the letter, consequently, directed the request to the Senate Committee on Appropriations for expeditious consideration.

Akpabio also declared that the budget consideration would be concluded and passed before the end of February.

### Shettima says Nigeria must transform debt into economic asset By Friday Omosola

ice President Kashim Shettima has emphasised the importance of transforming Nigeria's public debt into an asset for economic growth, infrastructure development, and poverty reduction.

The Vice President made this statement while inaugurating the Supervisory Board of the Debt Management Office (DMO) at the Presidential Villa on Wednesday.

The inauguration marks a significant step in the Federal Government's ongoing efforts to strengthen fiscal and monetary policy coordination and ensure long-term debt sustainability, in line with President Bola Tinubu's Renewed Hope Agenda.

Shettima, who also serves as Chairman of the newly inaugurated Board, urged its members to devise more strategic approaches to public debt management.

Shettima highlighted the critical role of debt in supporting national development.

He stressed that Nigeria must continue to use public debt as a tool for advancing key infrastructure projects and stimulating economic growth.

"With prudent management, debt can be transformed into an asset for economic growth and poverty reduction," he stated.

"Our goal must be to formulate policies, regulations, and guidelines for the DMO, to achieve sustainability for our country."

This approach, according to Shettima, aligns with President Tinubu's commitment to fiscal discipline, economic stability, and sustainable development.

He stressed that when borrowing is carefully managed, it can serve as a catalyst for growth, rather than a financial burden.

"As you all know, public debt, if prudently applied, becomes an asset for economic growth and poverty reduction. However, recent realities in our economy call for stronger coordination between our fiscal and monetary policies," he added.



The Vice President commended President Tinubu for his unwavering efforts in economic reforms, acknowledging the strides made in reshaping Nigeria's economic landscape.

He also praised the leadership of the Ministry of Finance and Coordinating Minister of the Economy, as well as the DMO, for their continuous commitment to managing Nigeria's sovereign debt portfolio.

"I want to commend the dedication of our leader, President Bola Ahmed Tinubu, GCFR, in his dogged efforts towards reforming our economy," Shettima said.

"I applaud the Honourable Minister of Finance Coordinating Minister of the Economy, and the DMO Management, for their untiring efforts in the day-to-day management of our sovereign debt portfolio."

Shettima also celebrated Nigeria's recent achievement in the global financial markets, specifically the successful issuance of a \$2.2 billion double-tranche Eurobond.

The over-subscription of the bonds, he noted, demonstrated the strong investor confidence in Nigeria's financial outlook.

"I also use this opportunity to congratulate them and other members of the Nigerian delegation for a successful outing in the recent \$2.2 billion double-tranche Eurobond issuance. The over-subscription rate of the bonds showed an impressive appetite for our country's sovereign instruments in the global capital market," he said.

The Supervisory Board includes notable figures such as Wale Edun, Minister of Finance and Coordinating Minister for the Economy, who serves as Vice Chairman; Attorney General of the Federation and Minister of Justice, Lateef Fagbemi.

Others are Special Adviser to the President on Economic Matters, DrTope Fasua; Governor of the Central Bank of Nigeria, Olayemi Cardoso; Accountant-General of the Federation, DrOluwatoyin Sakirat Madein; and Director-General of the DMO, Patience Oniha, who serves as Secretary.

## Tinubu raises retirement age for healthcare workers to 65 By Friday Omosola

resident Bola Tinubu has approved increasing the retirement age for doctors and other healthcare professionals from 60 to 65 years.

This decision was announced in a statement on Wednesday in Lagos by Mannir Bature, the National Publicity Secretary of the Nigerian Medical Association (NMA).

Bature explained that the Coordinating Minister of Health and Social Welfare, Muhammad Pate, has been instructed to formally submit the approval to the Council on Establishment via the Office of the Head of Service for finalization.

During a high-level meeting with NMA President Bala Audu and other key health sector stakeholders, Professor Pate outlined the policy shift.

The meeting also included representatives from the Medical and Dental Consultants Association of Nigeria, the National Association of Nigerian Nurses and Midwives, and the Joint Health Sector Unions.

Discussions during the meeting focused on recent progress made to improve the welfare of doctors and other healthcare workers in Nigeria.

Pate also confirmed that arrears resulting from the adjustment of the Consolidated Medical Salary Structure will soon be paid, with the necessary funds already secured for disbursement.

In addition, the minister noted that President Tinubu has approved



corrective measures for both the Consolidated Medical Salary Structure (CONMESS) and the Consolidated Health Salary Structure (CONHESS), adjustments that arose following the implementation of the new minimum wage.

"The process to effect this correction is at an advanced stage, promising much-needed relief for doctors and healthcare workers," Pate stated.

Following an extensive review initiated by the NMA, the approval for new tariffs for healthcare service providers was also granted.

This initiative is expected to benefit members of the Association of Nigerian Private Medical Practitioners and Nurses (ANPMPN), ensuring improved financial remuneration and the sustainability of healthcare services nationwide.

Pate expressed his appreciation for the patience and collaboration of all stakeholders and reaffirmed the Federal Government's commitment to enhancing the welfare of healthcare workers.

He emphasised that continued collaboration is crucial for strengthening Nigeria's health sector.


Attendees at the meeting reaffirmed their commitment to advocate for the welfare of healthcare workers and to ensure the full implementation of these key reforms.

The NMA has long championed raising the retirement age from 60 to 65 as a strategy to address brain drain, facilitate knowledge transfer, and enhance the quality of healthcare delivery.

Meanwhile, various health associations have declared nationwide strikes over the non-implementation of CONMESS and CONHESS for doctors and healthcare workers.

## FG approves N452bn for major road construction, rehabilitation projects

has approved N452 billion for the construction and rehabilitation of 14 major roads nationwide, under the Renewed Hope Administration's infrastructure initiative.

Announced by the Minister of Works, Dave Umahi, following the 23rd Federal Executive Council (FEC) meeting, the funding will expedite the completion of these projects and enhance connectivity across various states.

Among the approved projects is

the N22 billion Agaie-Katcha-Baro Road in Niger State, set to be handled by GR Building Construction Limited.

Other key projects include the N26.335 billion rehabilitation of the Odukpani Junction section of the Calabar–Ikom–Ogoja Road in Cross River State, the N10.89 billion Ajaokuta-Ajibo/Iyana-Mosa Road in Ogun State, and the N14.37 billion Umuahia Ituano-Ikot Ekpene Road.

Additionally, the Federal Government allocated N30 billion for the Lagos-Ibadan Road to

complete the Lagos-bound section and approved N7 billion for the AK Bypass rescoping, which will be managed by Ghitto Construction Limited.

The government also green-lit several water supply infrastructure projects in Abuja and surrounding areas, as part of its broader commitment to improving national infrastructure.

Umahi reassured that all ongoing projects would be closely monitored for timely completion.

### Marketers drop NNPCL logos amid price competition from Dangote refinery By Gbenga Oluranti Olaleye

n a significant shift within Nigeria's downstream oil sector, several oil marketers have begun removing the Nigerian National Petroleum Company Limited (NNPCL) logo from their filling stations.

This comes as independent dealers move away from franchise agreements with the state-owned oil giant, citing fierce price competition following a recent reduction in refined product prices by the Dangote Petroleum Refinery.

Sources indicate that many marketers, particularly those based in Lagos, are rebranding their stations in response to a recent price drop by the Dangote refinery, which slashed its ex-depot price for Premium Motor Spirit (PMS) from N950 to N890 per litre, effective from 1st February 2025.

This price reduction, attributed to a favourable outlook in global energy markets and a drop in international crude oil prices, has had a profound impact on the competitive landscape.

Independent marketers, who previously relied on NNPCL for their supply of refined products, are now seeking to secure cheaper alternatives from Dangote and other importers.

This change follows the deregulation of the downstream oil sector, which has opened up new opportunities for independent players to source cheaper products and gain a competitive edge.

Some filling stations previously affiliated with NNPCL, particularly along the Lagos-Ibadan Expressway in areas like Wawa and Ibafo, have already removed the NNPCL logo in favour of private brands.

Marketers are now rebranding their stations under other brands, such as MRS, which are offering more competitive pricing.

Chinedu Ukadike, the National Publicity Secretary of the Independent Petroleum Marketers Association of Nigeria (IPMAN), confirmed this trend, explaining that the shift is a strategic move as NNPCL is no longer the sole importer and



distributor of refined products.

Marketers now have the option to purchase directly from Dangote, whose prices are lower than the landed costs of imported petrol, leaving the national oil company struggling to maintain its influence in the market.

"The deregulation of the sector has levelled the playing field, Marketers are changing and rebranding because, in the past, NNPCL was the exclusive distributor, but now other players, especially Dangote, offer cheaper products, and marketers are looking for better alternatives." Ukadike said in an interview.

Oil and gas expert Olatide Jeremiah further explained that the emergence of the Dangote refinery has disrupted the business model that allowed marketers to profit from NNPCL's price control mechanisms. Previously, some marketers had paid millions for a franchise licence to access NNPCL's products at a cheaper rate, but with Dangote now selling at lower prices, many are opting out of their agreements with the state-owned oil firm.

"NNPCL was the primary source of cheaper petrol for many marketers before Dangote entered the scene, However, since Dangote's prices are now more competitive, the franchise model that once worked for marketers is no longer as attractive." said Jeremiah, who is the CEO of petroleumprice.ng.

Akinola Ogunyolemi, Chairman of the Petroleum Tanker Drivers Association in Lagos State, highlighted that many of the filling stations rebranding are not owned by NNPCL but are operated by independent marketers under franchise agreements.

These agreements, which are renewable, are often abandoned when the terms are no longer favourable.

While NNPCL did not respond to requests for comment on the growing trend of rebranding, experts believe that the continued reduction in prices by Dangote is likely to lead to more marketers abandoning their affiliations with the national oil company.

According to recent data, the landed cost of imported petrol now exceeds the price of petrol from Dangote, making it less appealing for marketers to continue sourcing products from NNPCL.

### Lagos lawmakers may write Tinubu over Obasa's removal as speaker By Ghenga Oluranti Olaleye

Lawmakers at the Lagos State House of Assembly are considering writing a letter to President Bola Tinubu regarding the removal of Mudashiru Obasa as Speaker.

The decision follows a marathon meeting between members of the Governance Advisory Council (GAC) and lawmakers on Monday at the Governor's Lodge in Marina, Lagos.

Sources say the GAC believes Obasa's removal on January 13, 2025, was illegal and disrespectful to the leadership of the All Progressives Congress (APC) in Lagos.

A GAC member, Chief Muraina Taiwo, confirmed that lawmakers were advised to write to the President to communicate their grievances.

He added that the lawmakers had firmly decided to retain Mojisola Meranda, who was elected as Speaker after Obasa's removal, despite the party's leadership counsel.



Taiwo suggested that Obasa may return to the House and be allowed to voluntarily resign, rather than being forced to step down.

He stated, "The lawmakers should allow Obasa to return and consider resigning by himself. The decision to resign is his own, not one they should force upon him."

It was reported that GAC had directed the lawmakers to send two apology letters to President Tinubu, acknowledging their failure to consult party leaders before removing Obasa.

The lawmakers are expected to express regret over the move and seek the reversal of Obasa's removal.

"That you, Abdul-Semiu 'm' and others now at large, on the same date,

time, and place in the aforementioned Magisterial District, did unlawfully assault one Areola Abraham by slapping him on the face and ear, thereby committing an offence contrary to and punishable under Section 351 of the Criminal Code Laws of Ogun State of Nigeria, 2006"

The charges include conspiracy, assault, and actions deemed likely to

### Fire engulfs Islamic school, kills 17 children, injures 16 By Helen Okechukwu

In an interview with Channels Television on Wednesday, Mannir Haidara, the chairperson of Kaura-Namoda Local Government, confirmed the incident, stating that more details would be shared later.

Speaking to a TV station, a resident of the community, Abdul Bello, said the tragic incident occurred at the study



center of Mallam Ghali.

The fire, which started late Tuesday

night, raged for four hours and became more severe due to corn and millet stalks stored on the school premises.

He confirmed that 17 bodies were recovered and buried on Wednesday.

"There were about 100 students in the house. After they evacuated the students, they thought none were left inside. It was only after the fire was extinguished that they started seeing legs and hands. The victims were burned beyond recognition," Mr. Bello explained.

### Motor accident claims one, injured six in Ogun By Helen Okechukwu

he Ogun State Police Command says it has commenced an investigation into a tragic accident that claimed the life of one person and injured six others on February 4.

The accident involved a Lexus ES 350 and a Zafira 1.8 Space Wagon after both vehicles collided.

Omolola Odutola, the spokesperson of the command, said in document shared on Wednesday, the incident occurred along the Abeokuta/Ibadan highway, near Ajobo village, at about 14:30 hours.

Narrating further, an eyewitness explained that the tragic incident was a result of reckless driving by Abiodun Michael, 26, who drove the Lexus ES 350, and Popoola Kayode, 55, who drove the Zafira car.

Odutola noted in the document, "While negotiating a sharp bend, the Lexus driver reportedly failed to slow down,



lost control, and veered off his lane, colliding head-on with the Zafira car on the driver's side. Tragically, Mr. Popoola Ishola Kayode died on the spot, while six of his passengers sustained varying degrees of injuries."

Immediately after the report was received, the DPO of Odeda Division responded swiftly, and a team arrived at the scene to secure the area, while the affected victims were taken to the hospital for medical attention.

"The injured victims were transported to General Hospital, Odeda, for urgent medical attention. Those with fractures were later transferred to FMC Idi-Aba, Abeokuta, for specialized treatment."

Meanwhile, the body of the deceased has been retrieved for burial rites according to Islamic law.

According to the spokesperson, the vehicles have been towed to the police for forensic investigation, while the occupants of the Lexus ES 350 have been declared wanted after fleeing the scene.

The command calls on anyone with useful information to assist in the apprehension of the fleeing suspects.

"The Command reaffirms its commitment to enforcing road safety regulations and ensuring that reckless drivers face the full weight of the law."

### Ex-wife of Dr. Erinne breaks silence, denies links to husband's death By Helen Okechukwu

fter the death of Dr. Ikenna Erinne, a Canada-based Nigerian doctor, on 26 January, his ex-wife Suzzette Chibuogu has broken her silence, called for a change of narrative as she denied a link to her husband death.

The NEW DAILY PRIME reported on 2 February that the 36-year-old cardiologist, Dr. Erinne, who hailed from Anambra, allegedly committed suicide.

A Facebook influencer, Clayton Udoh, claimed that the late cardiologist committed suicide after he was ordered by the court to pay \$15,000 monthly for child support fees.

To this end, the ex-wife of the late Dr. Erinne took to her Instagram page on Tuesday to clarify the issue surrounding her exhusband's death with a claim that she and her kids were battling domestic violence.

"We are already living through the result of years of anger and ignorance. Let's move forward with love," she narrated.

Chibuogu claimed that she and her children had been trying to



heal since the incident occurred, describing the encounter as a near-death experience as they begged to live for three hours.

In her post, she narrated that despite having a child with a disability undergoing 40 hours of therapy a week, she remained the primary carer while her exhusband lived in a different state with no close relationship.

"Those who know me know that I have always taken care of my kids 100% of the time since their respective births," Chibuogu noted

After the ugly incident, she revealed she was receiving multiple threats via calls and texts and acknowledged she had a lot of evidence, including pictures and videos, including police documentation.

"Nobody knows someone like their partner. I respect the experiences and memories you had of him, and I do not seek to tarnish them. I know the truth. People that know me know the truth. What you think of me is not my business.

### Embrace proper waste mgt disposal to prevent disease outbreak – health officer

o prevent the emergence of disease outbreaks in Ondo State, the state Chairman of the Environmental Health Officers Association of Nigeria, Sanitarian Funke Babajide, has called for proper waste disposal among residents.

This call was made during a one-day sensitization workshop held on Wednesday, centered on the socio-economic implications of indiscriminate waste dumping along motorway and key areas in Akure.

During the program, the Chairman of the Ondo State Waste Management Authority (OSWMA), Mrs. Yinka Alabi, sought collective collaboration from stakeholders to achieve a conducive environment.

She highlighted the effects of improper waste disposal in the state, which include an increase in flooding and erosion, traffic congestion, and accidents, among others.

Explaining further, Mrs. Alabi stated that the state has witnessed rampant dumping in strategic locations due to a lack of a dequate waste management infrastructure, posing environmental, health, and economic hazards.

While calling for the urgent use of trash bags in allocated waste stations, she pushed for creating awareness of best waste practices and the development and implementation of proper waste management strategies.

The Hope Newspaper reported that to enforce waste management strategies, Alabi underscored the importance of active participation in monthly cleanup exercises and monitoring market women



weekly.

"Special and regular clean-up exercises should be embraced, promoted, and executed while collaborating with state government-registered and identified Private Sector Partners (PSPs) to achieve efficient waste collection services," she noted.

She praised Governor Lucky Aiyedatiwa for his involvement in keeping the environment clean and warned of disciplinary action against environmental violators.

To advert the spread of Lassa fever in the state, the Administrative Secretary of the Ministry of Environment, Mr. Olumide Kinga, urged residents to maintain a healthy environment, particularly in Shasha Market and Oke-Aro, where illegal dumping sites are located.

Continuing the call, the State Chairman of the Association of Waste Managers of Nigeria, Mr. Wahab Olokungboye, asked residents to package their waste properly during evacuation and also appealed for a good management structure.

The Iyaloja of NEPA Market, Chief (Mrs.) Kemi Aisida, urged the

government to deploy additional waste trucks to facilitate the timely evacuation of refuse, ensuring a healthier marketplace.

Speaking at a public lecture, Sanitarian Abiodun David, Head of the Environmental Health Department at Ondo State College of Health Technology, Akure, addressed the socioeconomic impact of indiscriminate waste dumping.

He defined waste as any discarded material and categorized it into various types, including hazardous, electronic, medical, and biodegradable waste.

David outlined key waste management methods such as recycling, incineration, landfilling, and sea dumping.

He stressed the dangers of unchecked waste disposal, highlighting the need for stringent policies, sustainable practices, and increased public awareness to mitigate environmental and health hazards.

He urged the government to enact and enforce regulations to curb indiscriminate dumping, ensuring a cleaner and safer environment for all.

## Banning phones in classrooms 'does not improve marks **By Laura Donnelly**

tudy finds link between using the devices and worse performance but suggests the answer does not lie in school bans alone

Banning phones in schools does not improve children's marks or mental health, a study has found. The University of Birmingham found that students' sleep, exercise and academic record did not differ between schools with and without phone bans in place.

Evidence also showed restrictive phone policies did not lower the overall time young people spent on their phones throughout the day.

The findings, from the first study of its kind, compared 1,227 students at 30 different secondary schools in England.

"There is no evidence to support [the view] that restrictive school phone policies, in their current forms, have a beneficial effect on adolescents' mental health and wellbeing or related outcomes," researchers concluded.

However, the study did find that more time on phones and social media overall was linked to worse mental health, poorer sleep, less physical activity, lower grades and more disruptive classroom behaviour.

Researchers said school phone bans in isolation were not enough to tackle the negative impacts of overusing phones.

Last month, the Education Secretary rejected calls for a new law to ban phones in classrooms and branded the Conservative party's proposal a "headline-grabbing gimmick".

Bridget Phillipson said she agreed that



mobile phones should not be in lessons, but added the Opposition was wrong to say it could only be done by introducing legislation.

The Conservative party said last week that it would table an amendment to the Children's Wellbeing and Schools Bill that would require the Government to ban phones in classrooms.

Researchers call for holistic approach Victoria Goodyear, the study's lead author, said: "This is the first worldwide study of its kind to evaluate the impact of school phone policies on adolescent mental health and wellbeing, and other health and educational outcomes.

"We did find a link between more time spent on phones and social media and worse outcomes, with worse mental wellbeing and mental health outcomes, less physical activity and poorer sleep, lower educational attainment and a greater level of disruptive classroom behaviour.

"This suggests that reducing this time spent on phones is an important focus.

But we need to do more than focus on schools alone, and consider phone use within and outside of school, across a whole day and the whole week."

The study called for a more "holistic" approach to lowering phone use among students.

"This approach does not necessarily preclude restrictive school mobile phone policies," the study concluded.

"But these policies would be linked with a wider holistic approach to adolescent mobile phone and social media use."

Data from students was collected over a 12-month period ending in November 2023 from 20 schools with restrictive phone policies and 10 schools with permissive policies, where a phone could be used at breaks, lunch or in certain zones, such as outside areas.

The schools were chosen from a sample of 1,341 mainstream state schools in England.

## Donald Trump's dangerous plan to take over Gaza By Andrew England

S president's outlandish idea has dramatically raised stakes and would create another catastrophe for Palestinians

For weeks, Arab leaders have been waiting anxiously to gauge how US President Donald Trump would respond to the Middle East's biggest crisis in decades, wary of his unpredictability, his lack of understanding of a complex region and his unabashed pro-Israel bias.

But none in their wildest dreams would have expected the extraordinary, surreal proposal that he unveiled to a stunned world when he took the podium at the White House alongside Israeli Prime Minister Benjamin Netanyahu on Tuesday.

Not satisfied with advocating the forced permanent resettlement of more than 2mn Palestinians in Gaza, Trump dramatically upped the stakes by announcing that the US planned to take over the besieged strip — and that he would use American military might if necessary.

The idea is so outlandish that there will be a temptation to dismiss it as yet more Trumpian folly. It would be in violation of international laws the US has long sought to champion and uphold. It would risk drawing American troops back into combat in the Middle East—something Trump had pledged to avoid.

It would outrage Washington's Arab allies, its European partners and the global south. The US's battered credibility would take another dive. It would overturn the chances of Trump's dream of securing a grand bargain — and his desire to secure a Nobel Peace Prize — with a deal that would lead to Saudi Arabia and other Muslim states normalising relations with Israel.

And it would create another catastrophe for the long-suffering Palestinians that have for generations called Gaza home. Where would they go? Nobody knows. No Arab country would dare accept them and be seen to be complicit with the forcible displacement of their Palestinian brethren.

Nobody in the region — with the exception of Israel's far right — can countenance a repeat.



Yet this is Trump, the real estate mogul and former reality game show host, who has already threatened to seize the Panama Canal and take over Greenland.

He has long appeared to view the Middle East through his own prism of dealmaking and real estate projects, egged on by staunchly pro-Israel acolytes he has surrounded himself with in his new administration, and Netanyahu, who presides over the most farright government in Israel's history.

A year ago, Jared Kushner, Trump's son-inlaw and former Middle East White House adviser, was talking about Gaza's "waterfront property" saying it could be "very valuable".

On Tuesday, it was the president saying that he imagined the impoverished, war-shattered, densely populated, narrow Mediterranean strip could be "the Riviera of the Middle East".

"We're going to develop it, we're going to create thousands of thousands of jobs and it'll be something that the entire Middle East can be very proud of."

Netanyahu could barely conceal a smirk as he stood beside Trump, praising the most pro-Israel president in the US's history for "thinking outside the box".

"I think it's something that could change history," Netanyahu said.

Ever since Israel launched its thunderous offensive in Gaza in response to Hamas's October 7 2023 attack, Palestinians and their Arab neighbours have feared that Netanyahu's ultimate aim was to make the strip uninhabitable and drive the Gazans from their land.

Far-right ministers in his government openly talk about the need to resettle the strip Israel withdrew from two decades ago. Now they appear to have the world's most powerful leader in their corner.

Rattled Arab leaders will hope that Trump's proposal is all part of some opening gambit or negotiating chip in his plans to broker a wider deal that would lead to Saudi Arabia agreeing formal diplomatic ties with Israel.

In his first term, Trump brokered the so-called Abraham Accords, transactional deals that led to the United Arab Emirates and three other Arab states normalising ties with Israel. And he has made clear he wants to expand on that foreign policy success.

But Saudi Crown Prince Mohammed bin Salman has repeatedly said that can only happen if there is the establishment of a Palestinian state, that includes Gaza and the occupied West Bank.

Many in the Arab world are hoping Prince Mohammed can lean on his relationship with Trump and the leverage Saudi Arabia could hold in delivering the "grand bargain" to rein in his wildest policies.

## Assisted dying bill sparks controversy over mental health inclusion

proposed amendment to a landmark assisted dying bill in England and Wales has ignited fierce debate over the inclusion of mentally ill and disabled individuals who have a terminal prognosis of six months or less.

Labour MP Kim Leadbeater, who has represented Spen Valley since 2021, introduced the private member's bill aiming to grant terminally ill patients the right to medically assisted death. On Wednesday, she proposed an amendment to clarify that having a mental disorder or disability does not automatically disqualify individuals from accessing assisted dying, provided they meet all other eligibility criteria.

Concerns Over Mental Health Implications Opponents of the amendment warn that the change could lead to unintended consequences, including allowing individuals with severe mental illnesses, such as anorexia, to qualify for assisted dying. Critics argue that this could fail to protect vulnerable individuals whose conditions lead to self-neglect and chronic low mood.

A source within the bill's committee raised concerns that the amendment does not adequately address risks for people with eating disorders, emphasizing that in previous UK legal cases, courts have classified severe anorexia as a terminal condition.

"This amendment does not ensure that mental illness or disability is not influencing a patient's decision to seek assisted death," the source stated. "It could enable patients with conditions like anorexia to qualify, as their illness could be framed as a terminal condition leading to death within six months."

Ms. Leadbeater has repeatedly denied claims that the bill was ever designed to include mentally ill or disabled individuals who are not terminally ill. Speaking to The Telegraph, she emphasized that the bill



"makes clear that a mental disorder alone would not make a person eligible."

Her amendment now explicitly states: "For the avoidance of doubt, a person is not to be considered to be terminally ill only because they are a person with a disability or mental disorder (or both)."

However, legal experts argue that this does not eliminate the possibility of eligibility for patients whose mental health conditions result in life-threatening physical effects. Barrister James Kirby explained that the bill's definition of terminal illness includes individuals with a progressive condition expected to cause death within six months, which could, in some cases, apply to those suffering from the physical impacts of mental disorders.

The medical community remains divided on the bill's potential implications. Researcher Chelsea Roff, who testified before the committee last week, warned that some UK court rulings have already categorized late-stage anorexia as a terminal condition, leading to the withdrawal of life-sustaining treatment.

"In the US, we have seen cases where physicians cite 'terminal malnutrition' rather than anorexia itself to justify assisted death," Roff stated. "This amendment does not entirely prevent similar interpretations in the UK."

The debate continues to spark broader ethical and legal discussions, with opponents warning of a potential 'slippery slope' and proponents advocating for personal autonomy and dignity in end-of-life decisions.

Conservative lawmakers have expressed staunch opposition to the bill, citing concerns over the potential for coercion, lack of safeguards for vulnerable individuals, and the ethical implications of expanding assisted dying laws. Many argue that prioritizing palliative care should be the government's focus rather than broadening access to assisted death.

Internationally, seven European countries—including the Netherlands, Belgium, and Spain—have legalized some form of assisted dying, each with varying safeguards and eligibility criteria. The debate in the UK echoes broader global discussions on the ethical, medical, and legal ramifications of such legislation.

As the bill progresses through Parliament, the issue remains deeply polarizing, with significant implications for the future of end-of-life care in the UK.

## Trump's Gaza occupation plan sparks global condemnation By Dr. Olaoluwa Vincent Ajayi

resident Donald Trump's proposal to seize control of Gaza and permanently relocate its Palestinian population has triggered strong global condemnation, with critics warning of chaos and instability in the Middle East.

Speaking during a joint press conference at the White House alongside Israeli Prime Minister Benjamin Netanyahu, Trump suggested that two million Palestinians should be relocated to Egypt and Jordan, citing the devastation caused by Israel's military operations following the October 7, 2023 Hamas attack on Israel.

"The U.S. will take over the Gaza Strip, and we will do a great job with it," Trump said. "All Palestinians should be resettled because Gaza is now a demolition site. We will rebuild it into the 'Riviera of the Middle East."

The announcement was met with swift and harsh reactions from world leaders, with several countries rejecting Trump's proposal as a violation of Palestinian sovereignty.

Saudi Arabia, a key U.S. ally, issued a strongly worded statement reaffirming its long-standing support for an independent Palestinian state.



"The Kingdom of Saudi Arabia stresses its absolute rejection of any infringement on the legitimate rights of the Palestinian people, including Israeli settlement policies, annexation of Palestinian lands, or efforts to displace Palestinians from their land," the statement read.

Australian Prime Minister Anthony Albanese echoed this stance, telling reporters in Canberra that his government remains committed to a two-state solution.

"Australia's position is the same as it was this morning, as it was last year, as it was 10 years ago," Albanese said, reinforcing his country's unchanged policy toward the Israeli-Palestinian conflict.

Hamas, the militant group that launched the October 7 attack on Israel, denounced Trump's suggestion of forced displacement, warning that the move would destabilize the region.

"Trump's proposal is a recipe for chaos and long-term conflict in the Middle East," Hamas said in a statement.

With growing opposition from key U.S. allies and international organizations, Trump's controversial Gaza occupation plan is expected to face further scrutiny, raising questions about America's role in the Middle East under his leadership.

# America to take over Gaza? Trump says all Palestinians must leave – What happens next? By Dr. Olaoluwa Vincent Ajayi

n a highly controversial statement, President Donald Trump declared on Tuesday that the United States should seize control of Gaza and permanently relocate its Palestinian population to other Middle Eastern nations.

Speaking during a joint press conference at the White House alongside Israeli Prime Minister Benjamin Netanyahu, Trump suggested that the two million residents of Gaza be relocated to Egypt and Jordan, citing the destruction caused by Israel's ongoing military operations following the Hamas-led October 7, 2023 attack on Israel.

"The U.S. will take over the Gaza Strip, and we will do a great job with it," Trump said. "We will be responsible for clearing the devastation and rebuilding Gaza into a global hub for tourism and economic growth."

Tapping into his real estate background, Trump envisioned turning Gaza into "the Riviera of the Middle East," emphasizing economic revival and job creation as key priorities.

While Trump framed his plan as a humanitarian effort and economic opportunity, his remarks reignite geopolitical tensions that have shaped the Israeli-Palestinian conflict for decades. Control over Gaza has been a major flashpoint, and any effort to forcibly relocate its Palestinian population evokes historical instances when Western powers redrew borders and displaced communities without regard for local sovereignty.

During his first term as president (2017–2021), Trump implemented policies that heavily favored Israel, leading to heightened tensions in Gaza. In December 2017, Trump officially recognized Jerusalem as Israel's capital, moving the



U.S. Embassy from Tel Aviv to Jerusalem. The decision triggered widespread protests in Gaza and the West Bank, as Palestinians view East Jerusalem as the capital of their future state.

In 2018, Trump cut all U.S. funding to the United Nations Relief and Works Agency for Palestine Refugees (UNRWA), which provides healthcare, education, and food aid to millions of Palestinian refugees, including those in Gaza. The U.S. was previously UNRWA's largest donor, contributing close to \$500 million annually. The funding cut significantly worsened the humanitarian crisis in Gaza.

Trump consistently backed Israel's military responses to Hamas and other Gaza-based militant groups. His administration defended Israel's right to conduct airstrikes in response to rocket attacks from Gaza, deepening Palestinian resentment toward U.S. foreign policy.

As part of his Middle East peace plan, Trump proposed economic investments to improve living conditions in Gaza and the West Bank. However, Palestinian leaders rejected the initiative, arguing that economic incentives could not replace the need for political sovereignty and territorial rights. The Gaza Strip is one of the most densely populated areas in the world, covering just 365 square kilometers (141 square miles) but home to approximately 2.3 million people. Gaza was part of British-controlled Palestine before coming under Egyptian administration (1948–1967). Israel captured Gaza in the 1967 Six-Day War, establishing Jewish settlements that were fully withdrawn in 2005. Since Hamas took control in 2007, Israel and Egypt have enforced a strict blockade, severely restricting the movement of goods and people.

Years of conflict, blockade, and political instability have created a dire humanitarian situation in Gaza. Over 50% of Gaza's workforce is unemployed, among the highest rates globally, and more than 80% of residents depend on international food aid. Gaza experiences daily power cuts, receiving electricity for only 4-8 hours a day, while 97% of its water supply is undrinkable due to pollution and overuse. Hospitals lack critical medicines, medical equipment, and emergency care capacity. Frequent Israeli airstrikes destroy key infrastructure, displacing thousands, while border restrictions and funding shortages make rebuilding efforts extremely difficult.

### Newcastle United beat Arsenal to reach Carabao Cup final By Oluwatosin Ologun

ewcastle United defeated Mikel Arteta's Arsenal 2-0 in the second leg of the semi-final encounter of the Carabao Cup on Wednesday at the St James' Park.

Newcastle United moved a giant step closer to ending a 56-year wait to win a major trophy as they secured a place in the Carabao Cup final with victory over Arsenal after an emotional night on Tyneside.

Eddie Howe's side, who held a 2-0 advantage from the semi-final first leg, completed the second part of the assignment, and will now face Liverpool or Tottenham Hotspur at Wembley as they stand one victory away from ending a sequence without major success stretching back to the 1969 triumph in the Inter-Cities Fairs Cup.

Newcastle United's last domestic trophy was the FA Cup in 1955, while the club's last major silverware came in the Inter-Cities Fairs Cup in 1969, a competition that then had the guise of the Uefa Cup and is now the Europa League.

Now, after a comprehensive 4-0 win over two legs against Arsenal that sealed a Carabao Cup final appearance against either Liverpool or Tottenham Hotspur on 16 March, Eddie Howe and his Newcastle players have the opportunity to end



the barren years.

And what a night it was on Tyneside as Newcastle's supporters started in a state of gut-wrenching tension, but then ended high on emotion and elation after reaching Wembley once more.

Newcastle made a flying start, with Alexander Isak having a goal ruled out for offside before Jacob Murphy turned home a rebound in the 19th minute after the Sweden striker's shot hit the post.

The goal came seconds after Martin Odegaard missed what turned out to be Arsenal's best chance of turning this semi-final around, glancing the post with only keeper Martin Dubravka to beat.

In a tumultuous atmosphere, with the Toon Army urging their side on at deafening volume, Newcastle delivered the decisive blow after 52 minutes following a nightmare moment for Arsenal keeper David Raya.

Raya inexplicably tried to find Declan Rice, who was shadowed by Fabian Schar. He stole possession away from Rice, leaving Anthony Gordon with a simple finish to send Newcastle back to Wembley.

Alexander Isak had already had one crisp strike ruled out for a marginal offside before he escaped the attentions of Arsenal defender William Saliba. His shot struck the frame of the goal, but Jacob Murphy was on hand to steer in the rebound.

If Newcastle United win the Carabao Cup, Howe and his players will assume legendary status forever. Forget the fact this competition may not top the list of some priorities. It means everything to this football club and this fans.

### Real Madrid snatch late Leganes win to reach Copa del Rey semi-final

oung Real Madrid striker Gonzalo Garcia headed home a 93rd minute winner to put his side into the Copa del Rey semifinals with a 3-2 victory at Leganes on Wednesday.

Juan Cruz's brace for the hosts pulled back early strikes by Luka Modric and Endrick for the European champions at Leganes' Butarque stadium.

With extra-time beckoning 20year-old forward Gonzalo headed home at the near post after fine work by Brahim Diaz to help Madrid snatch a derby victory and keep their legs fresh ahead of big upcoming games against Atletico Madrid and Manchester City.

Madrid were without Kylian Mbappe and Jude Bellingham after minor knocks, and started with youngsters Jacobo Ramon and Raul Asencio at the heart of their back-line because of their defensive injury crisis.

Madrid started well and were soon ahead, with Modric slotting home in the 18th minute after good work by in-form winger Rodrygo.

Teenage striker Endrick doubled Los Blancos' lead with a poacher's



finish after the ball broke loose to him in the box.

It seemed to be plain sailing for Carlo Ancelotti's side until Jacobo conceded a penalty for handling Cruz's shot.

The Leganes playmaker dispatched the spot kick low to Andriy Lunin's left, with the Ukrainian goalkeeper inches away from reaching it.

Ancelotti sent on Vinicius Junior for Rodrygo for the second half, and the winger missed two good chances straight away.

Leganes goalkeeper Juan Soriano saved well to deny the Brazilian, who also headed over from close range.

Madrid paid the price for their profligacy when Cruz netted his second, with the aid of a deflection off Ferland Mendy.

With stoppage time almost over, Diaz produced a fine dribble to break free on the right, before crossing to the near post to create his side's late winner.

Gonzalo was on hand to head home with one of the final touches of the game and book Madrid's ticket to the semifinal.

Atletico thrashed Getafe 5-0 on Tuesday to progress, while record 31-time winners Barcelona visit Valencia on Thursday, and Real Sociedad host Osasuna.
